DESCRIPTION

FIG. 1 is a front perspective view of the shoe upper showing our new design;
FIG. 2 is a side view thereof;

FIG. 5 is a rear view thereof; and,
FIG. 6 is a top view thereof.

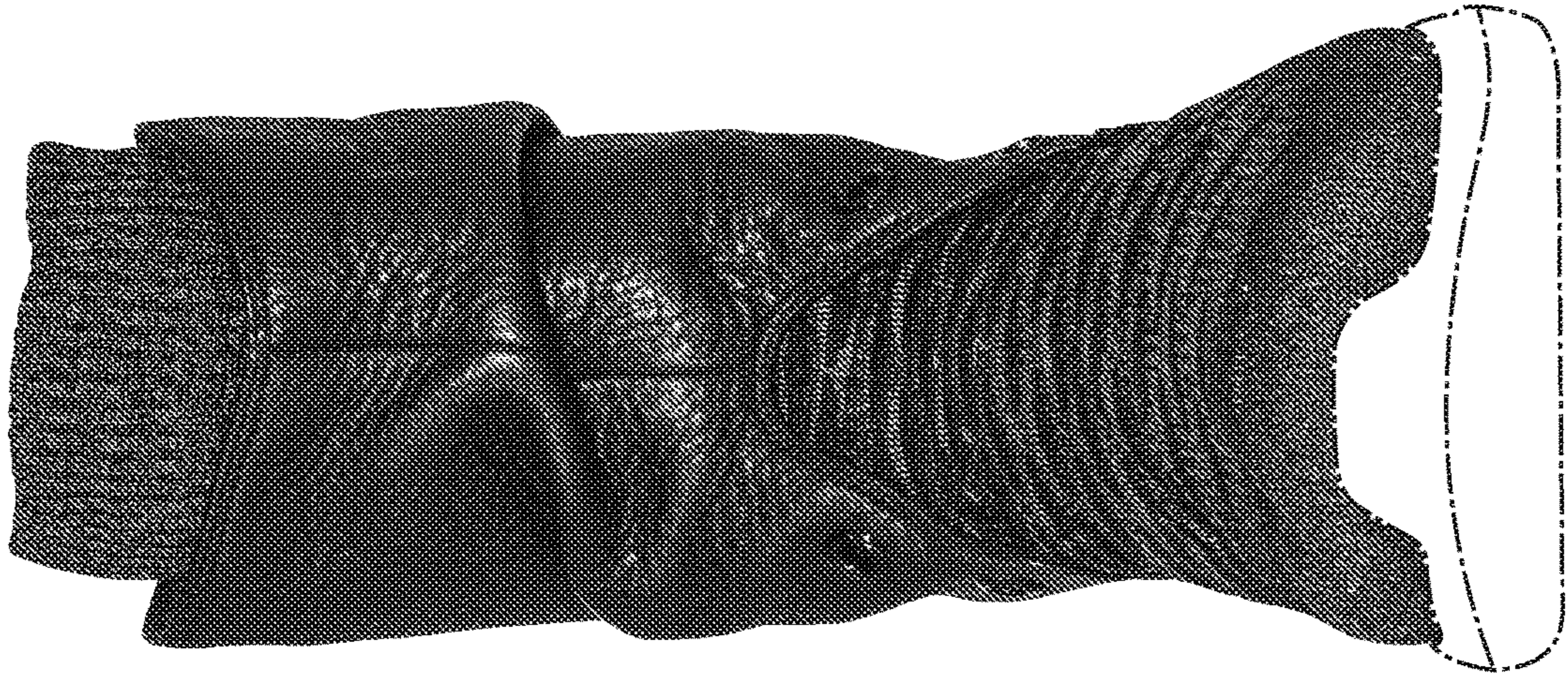

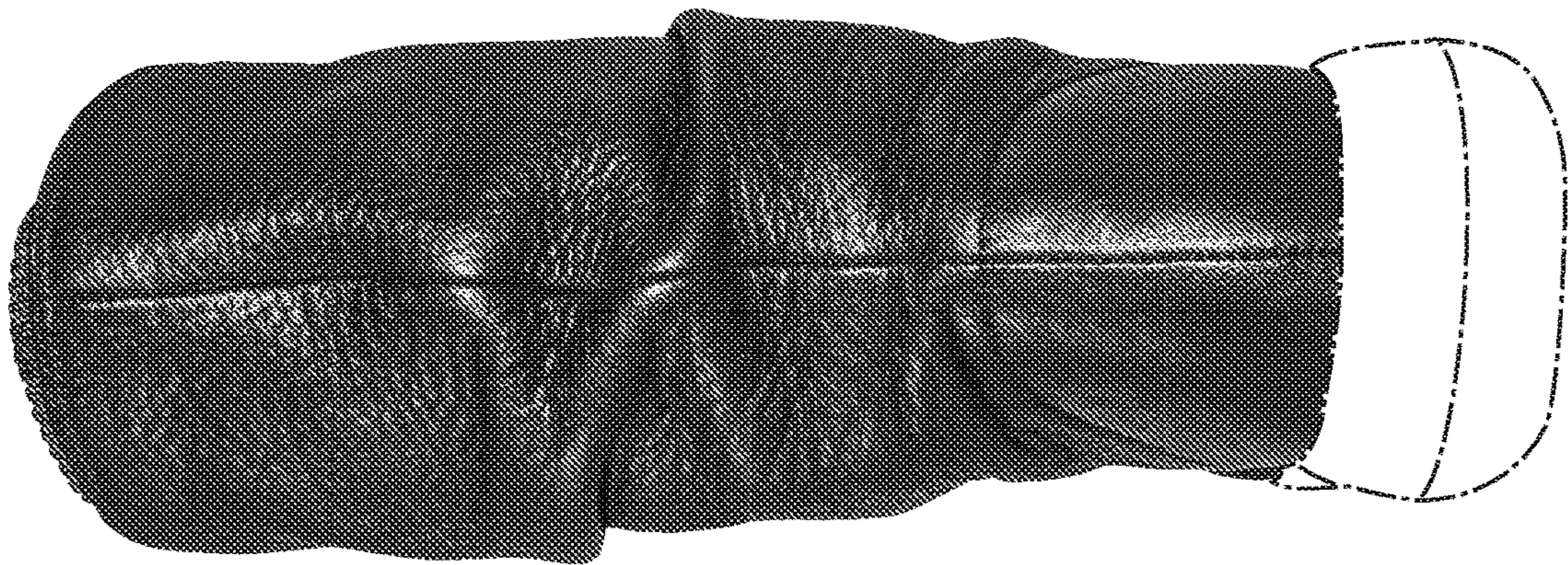
