(57) **CLAIM**

The ornamental design shoe sole, as shown and described.

**DESCRIPTION**

This application is related to co-pending U.S. patent application Ser. No. 29/578,932, filed Sep. 26, 2016. All disclosure and subject matter, including all figures and the appendix, of the co-pending application are specifically incorporated by reference in this application in their entirety as if set forth fully herein.

FIG. 1 is a bottom perspective view of a shoe sole showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a bottom plan view thereof;

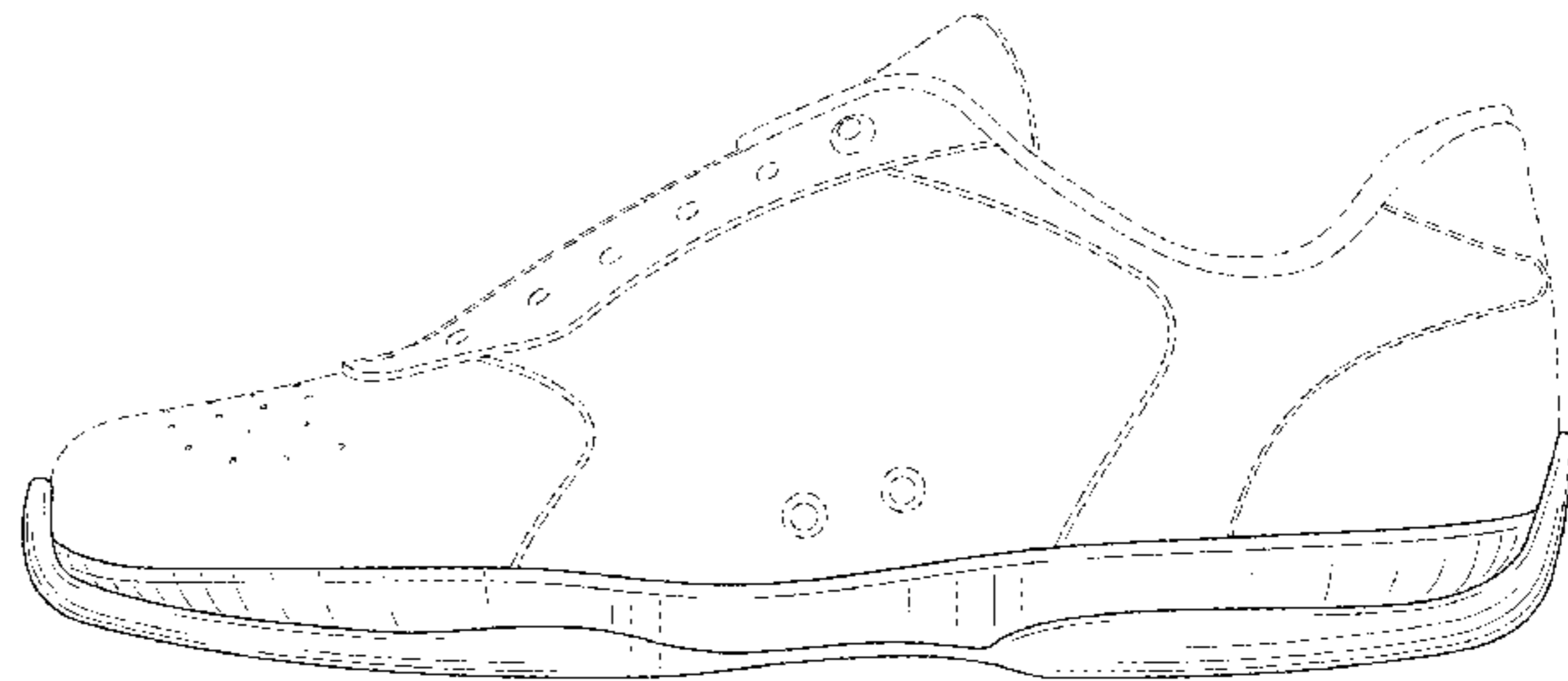
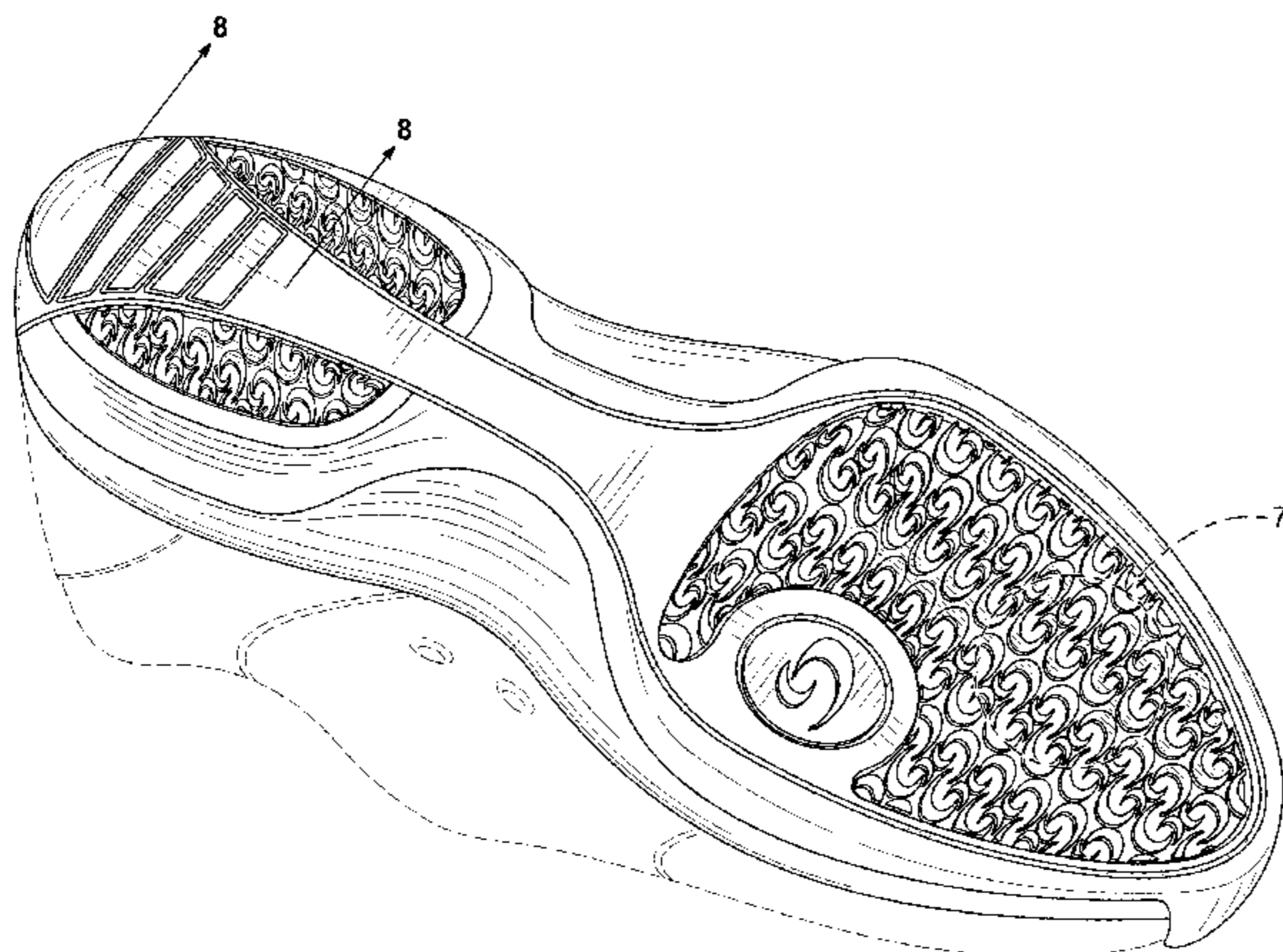
FIG. 7 is an enlarged view of the portion encircled in FIG. 1; and,

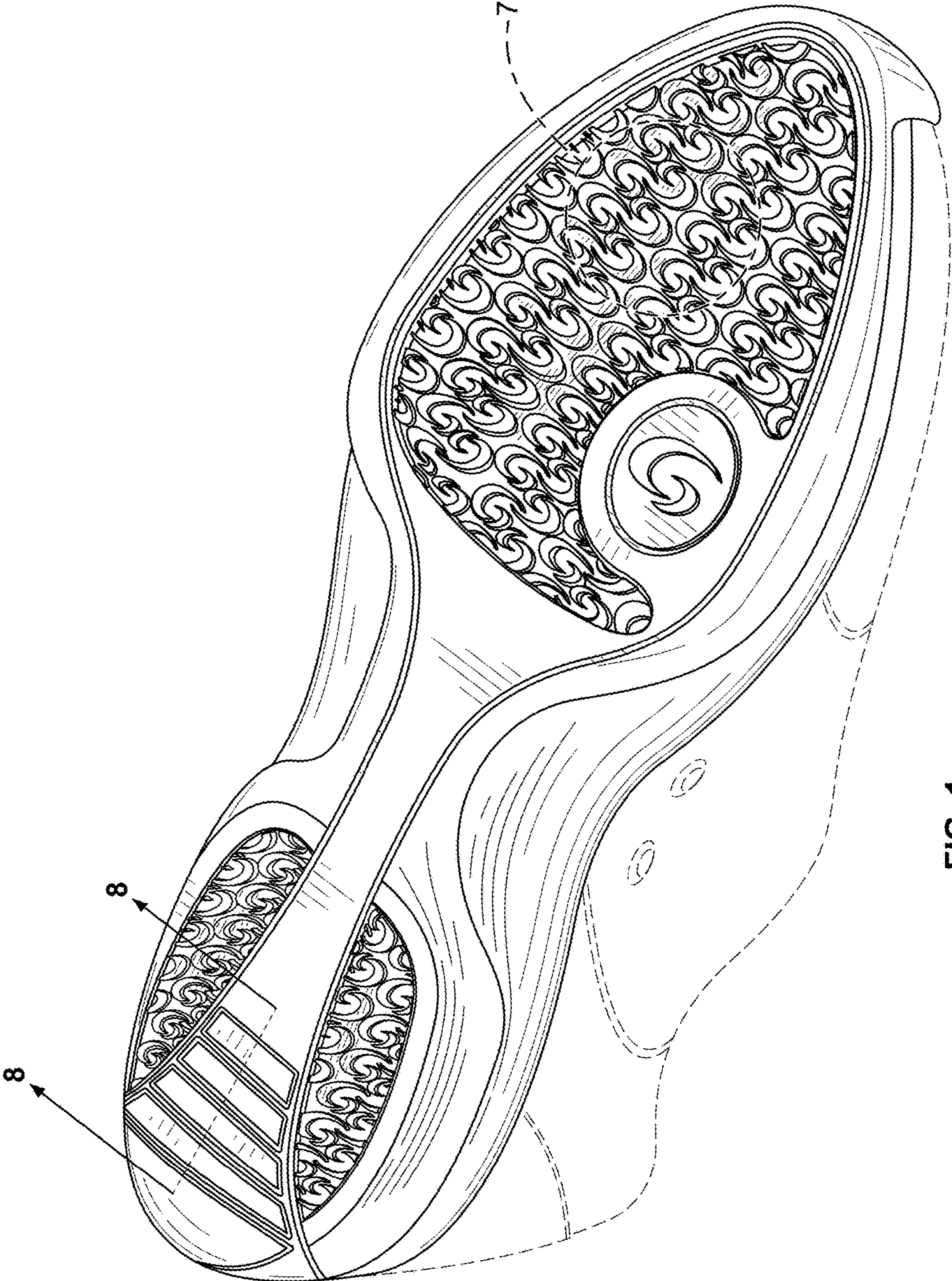

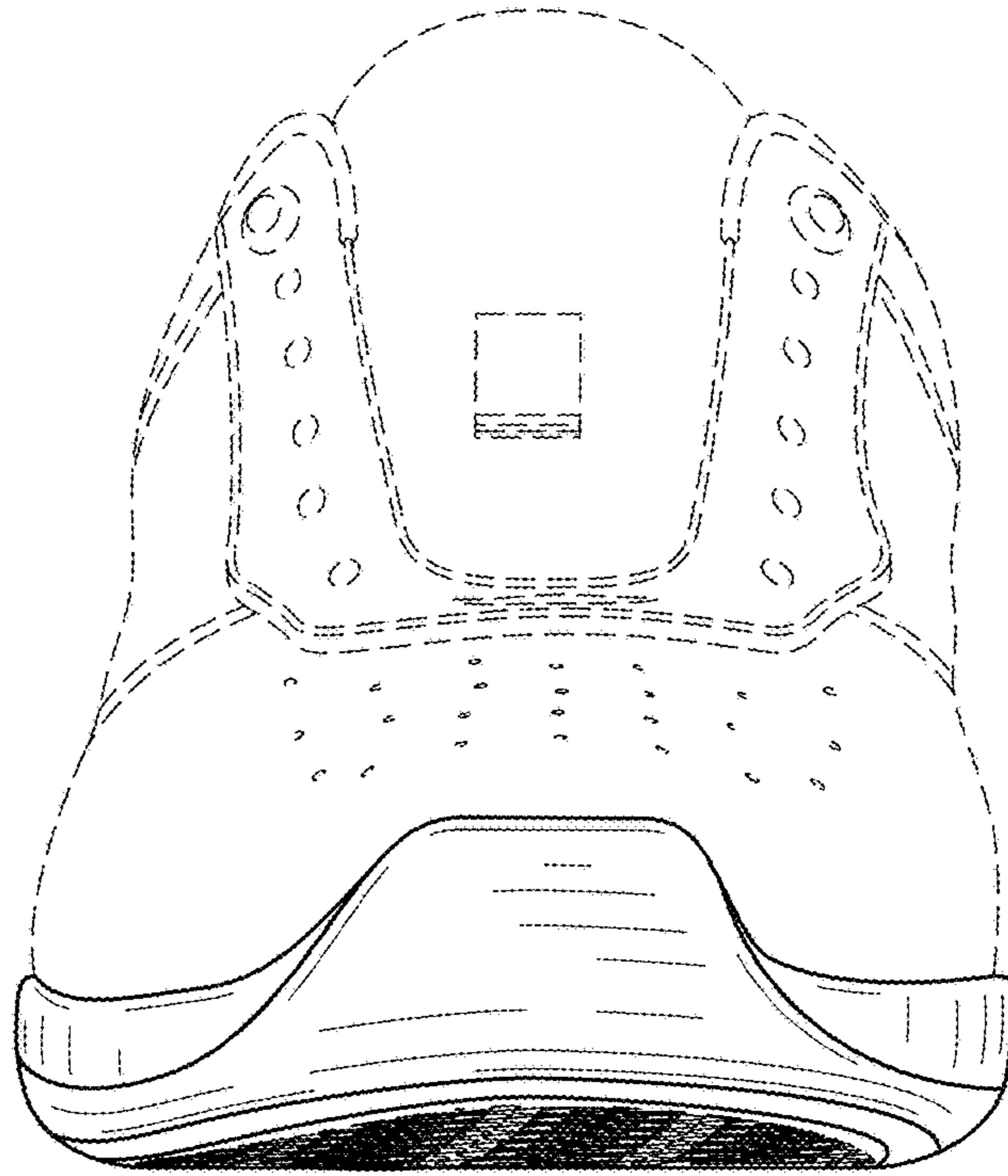

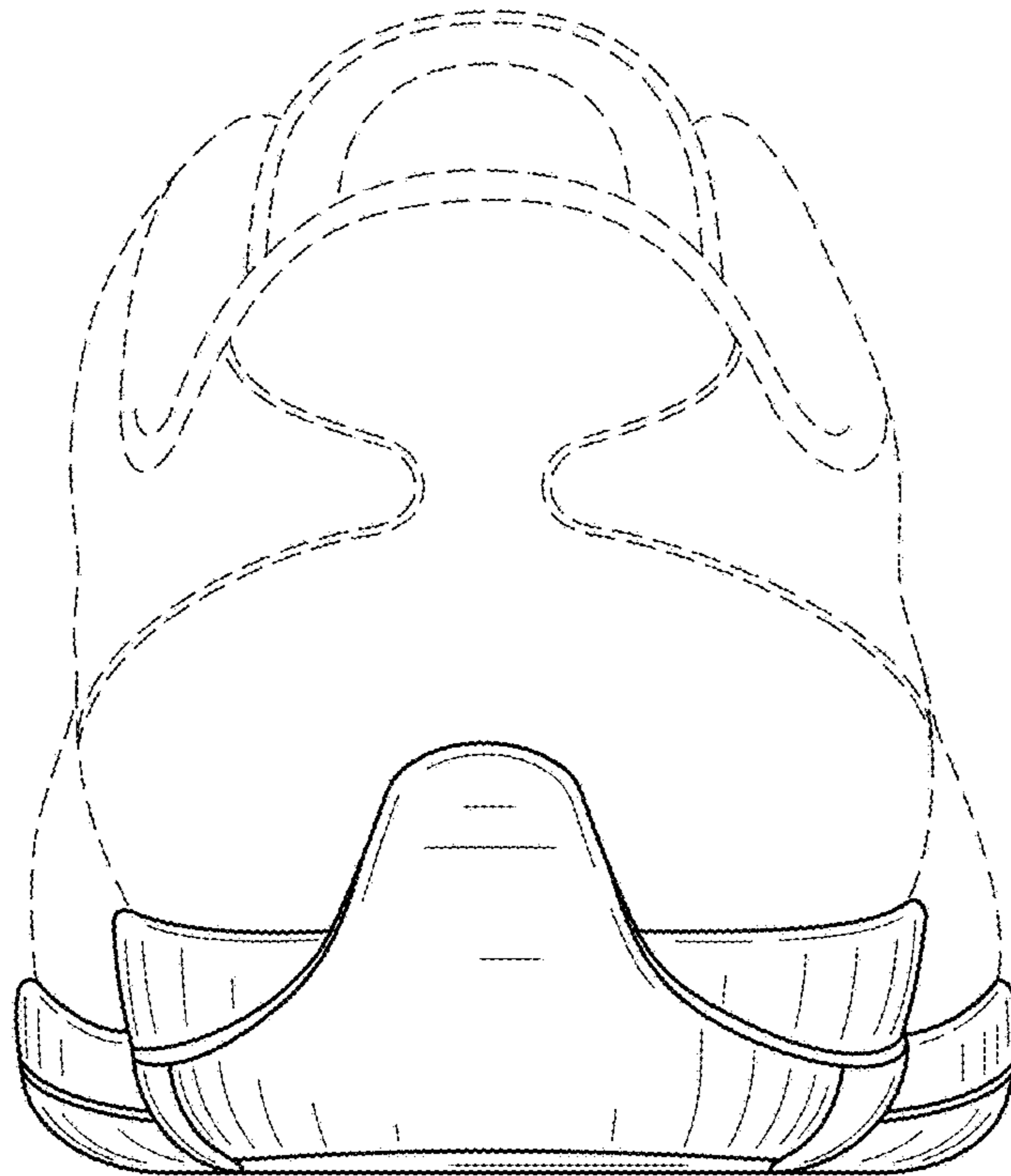

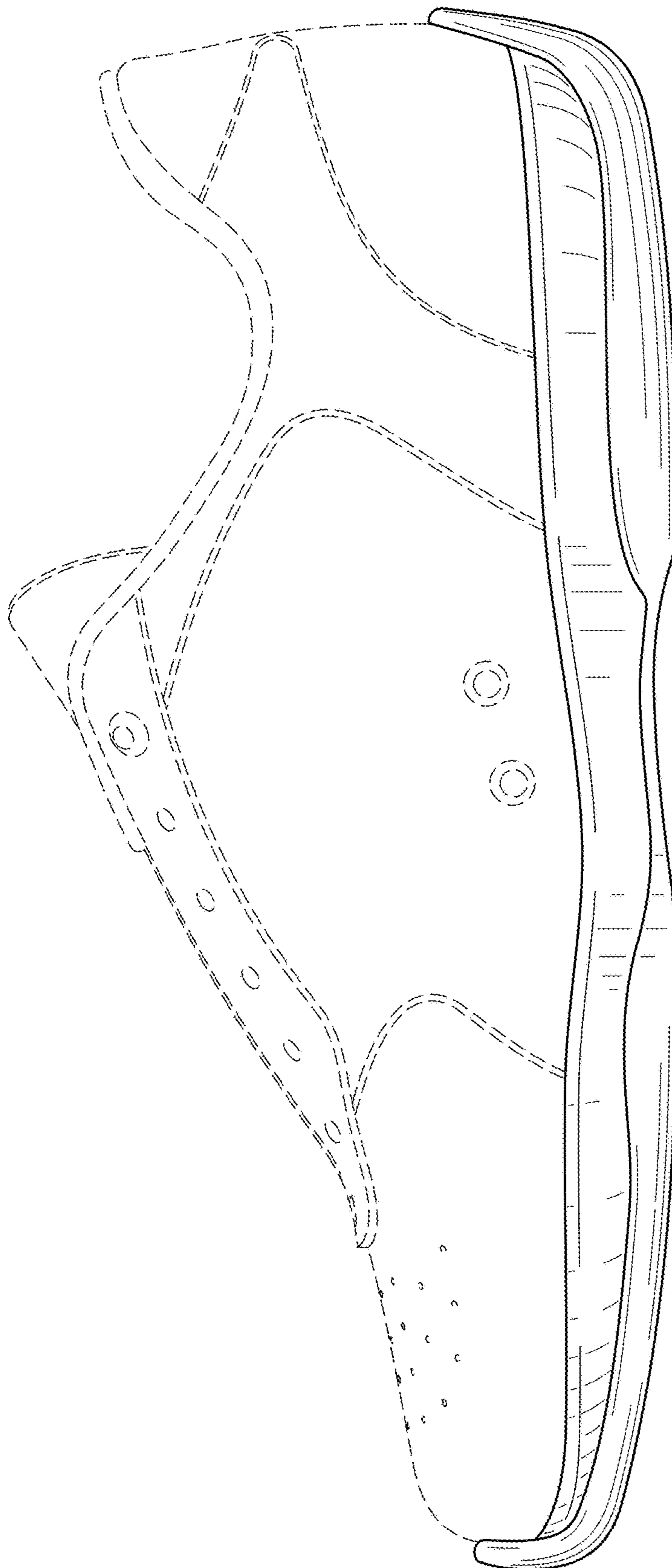

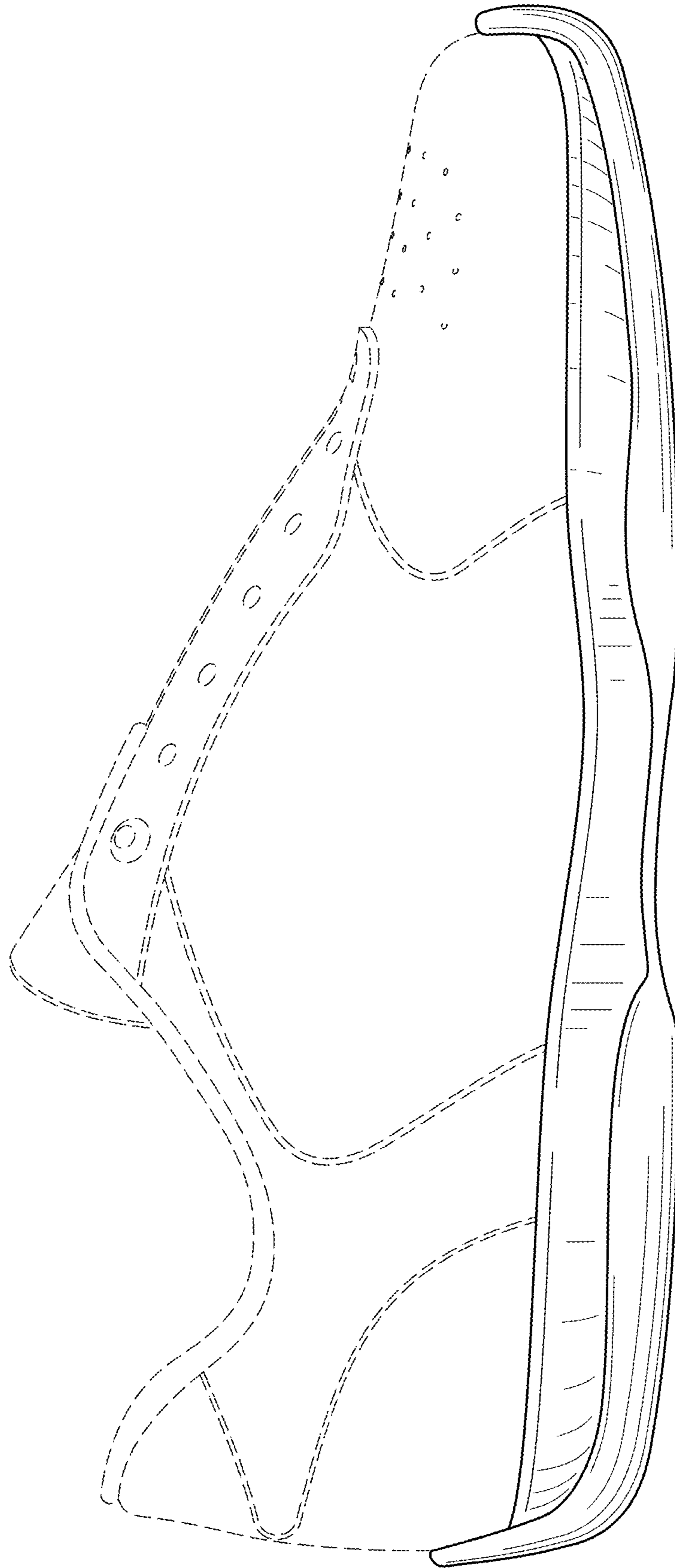

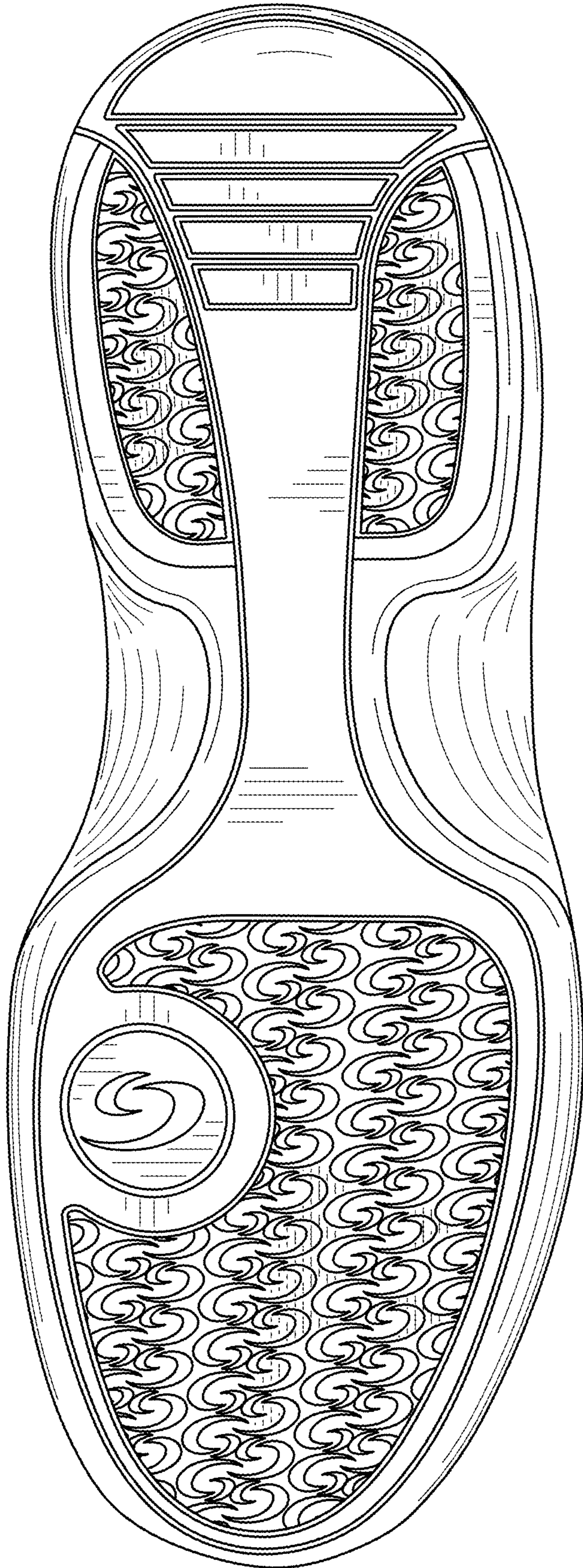

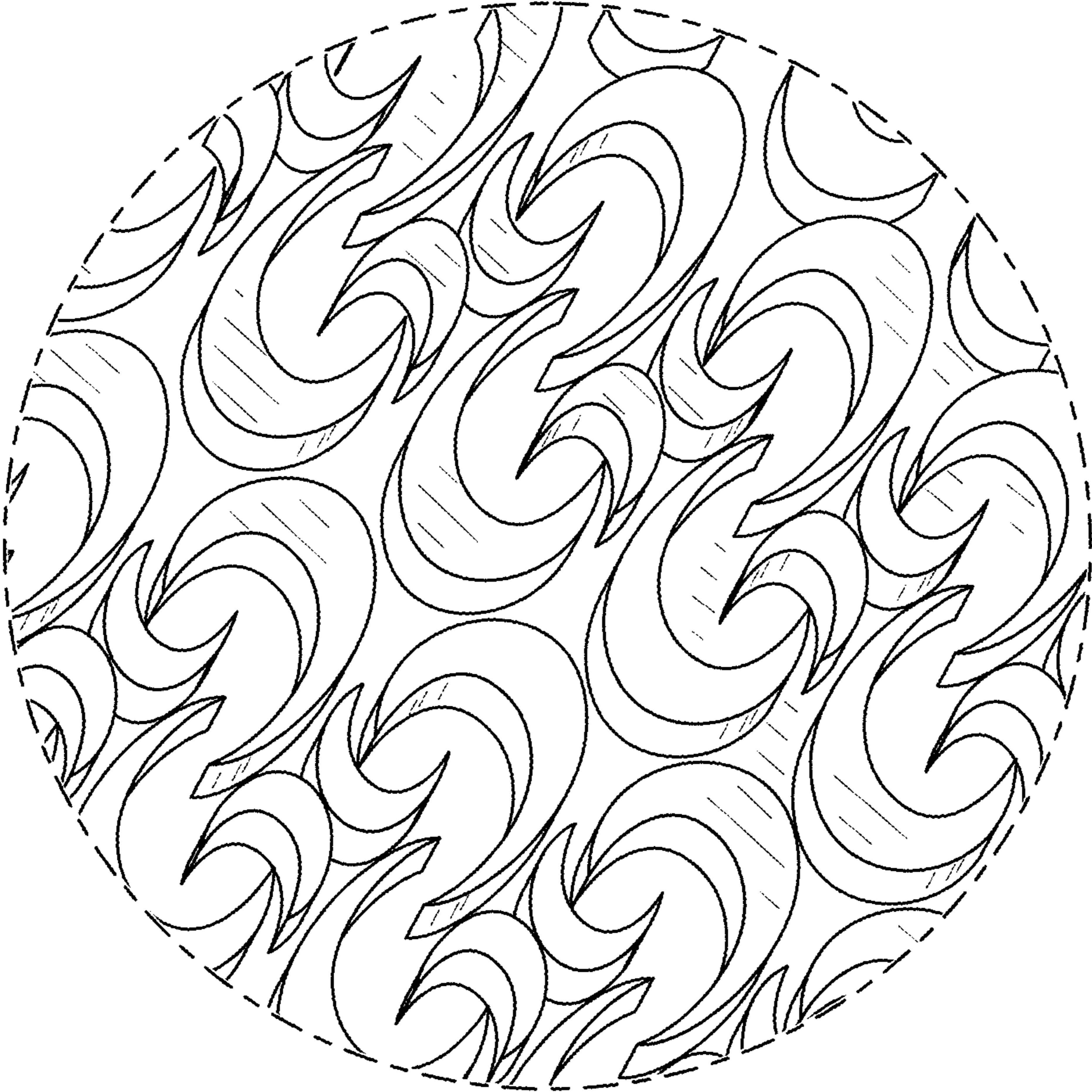

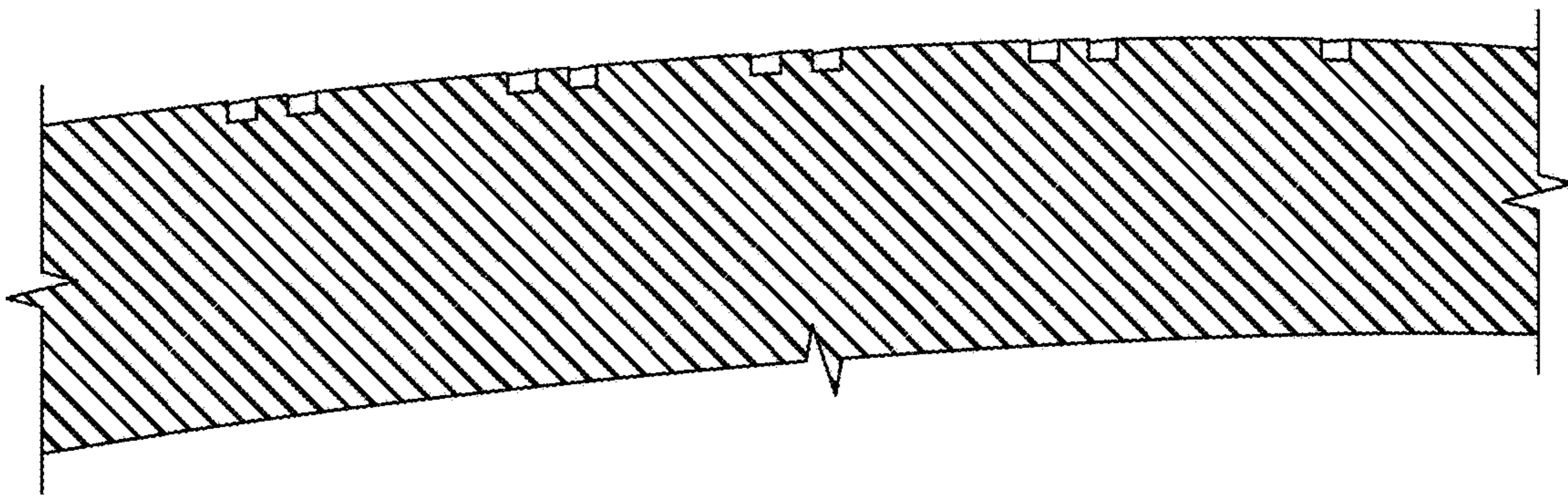
