DESCRIPTION

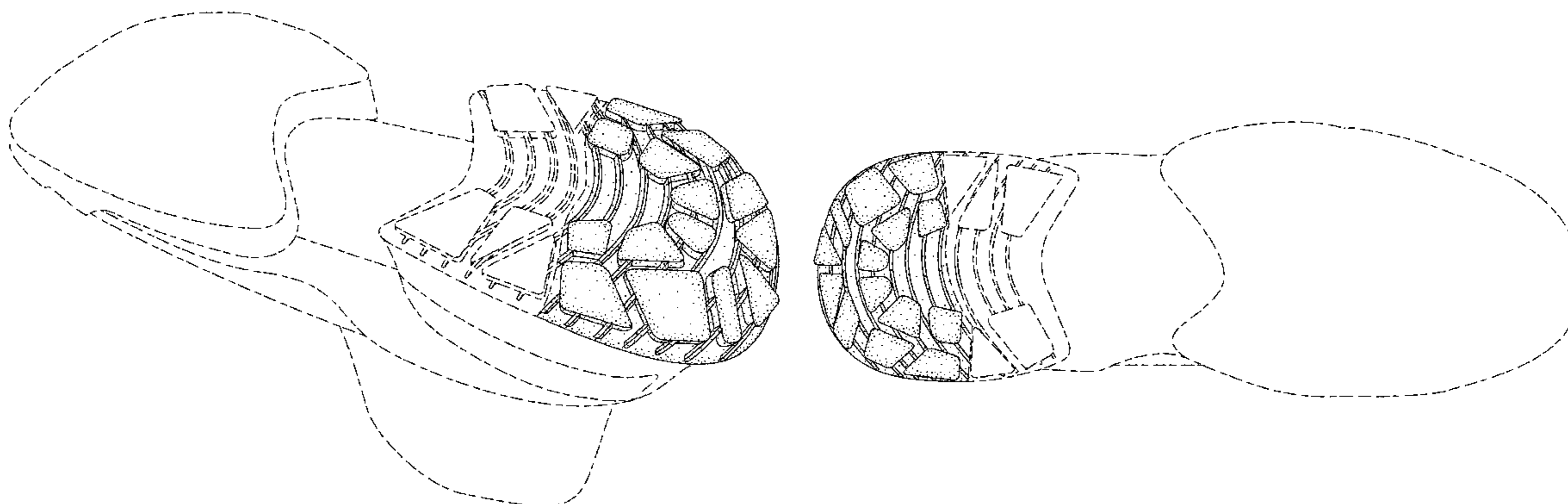
FIG. 1 is a side and rear perspective view of a shoe outsole showing my new design;

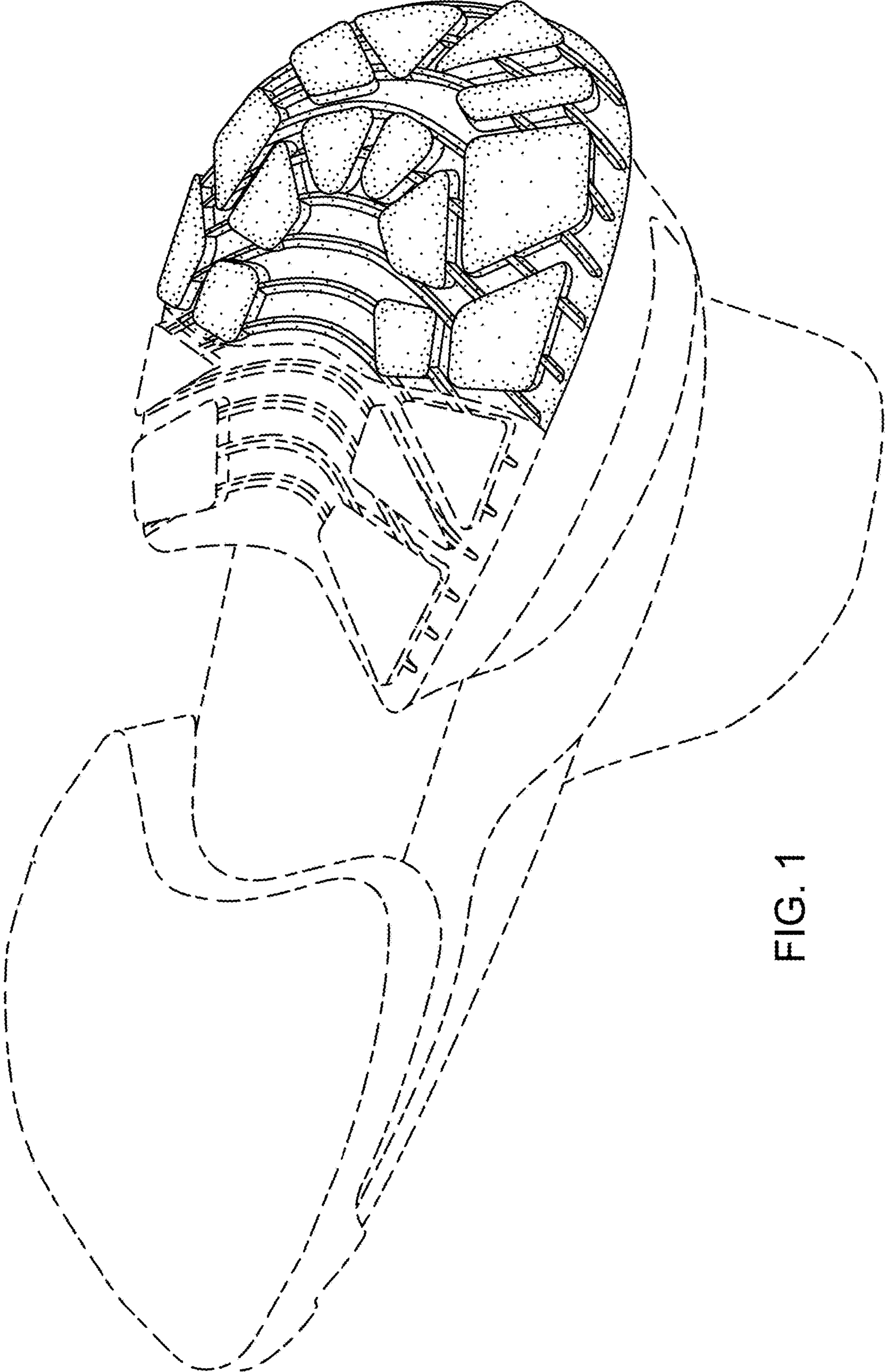

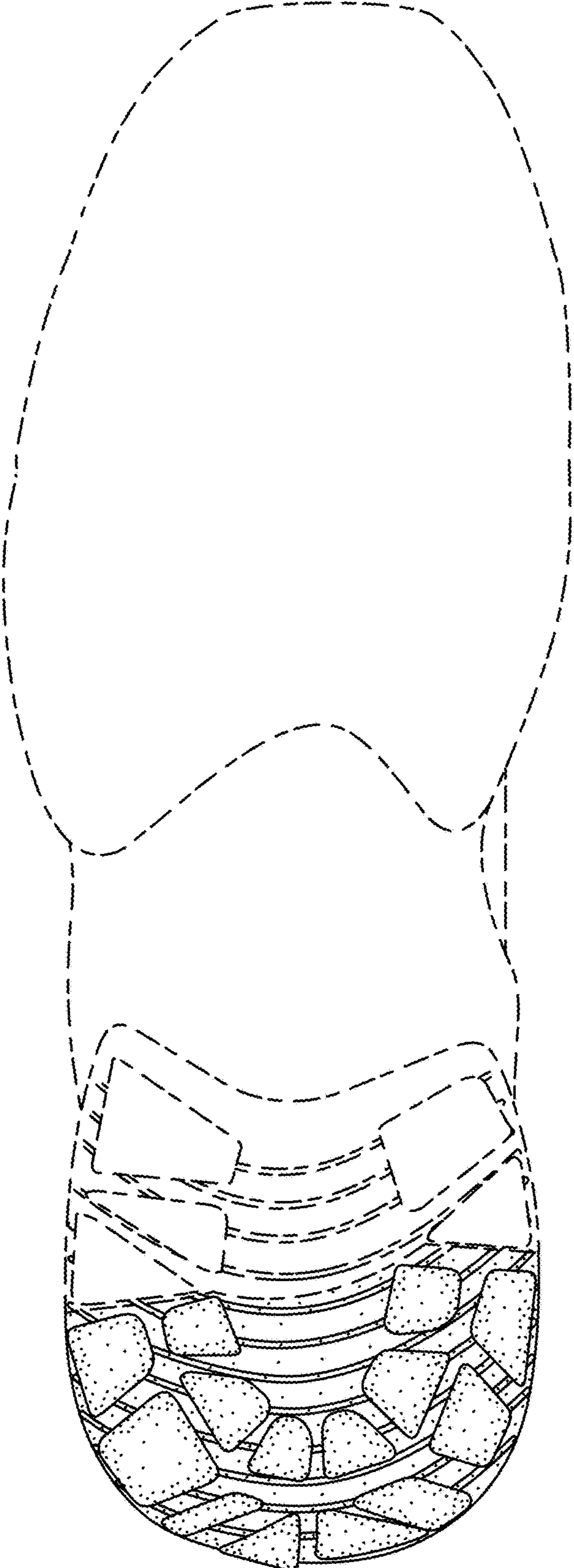

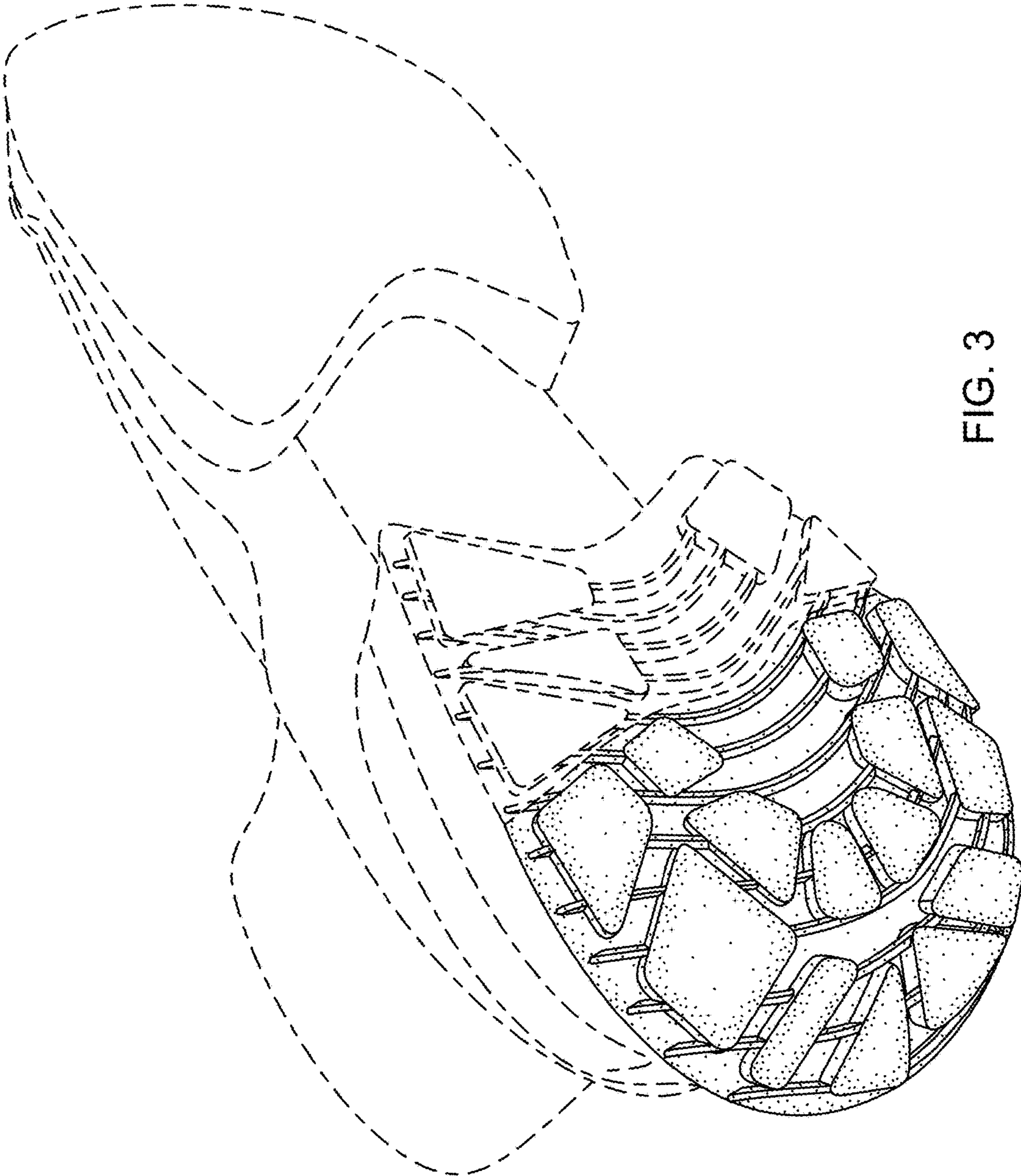
