DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;

FIG. 2 is a side view thereof;

FIG. 3 is a rear perspective view thereof;

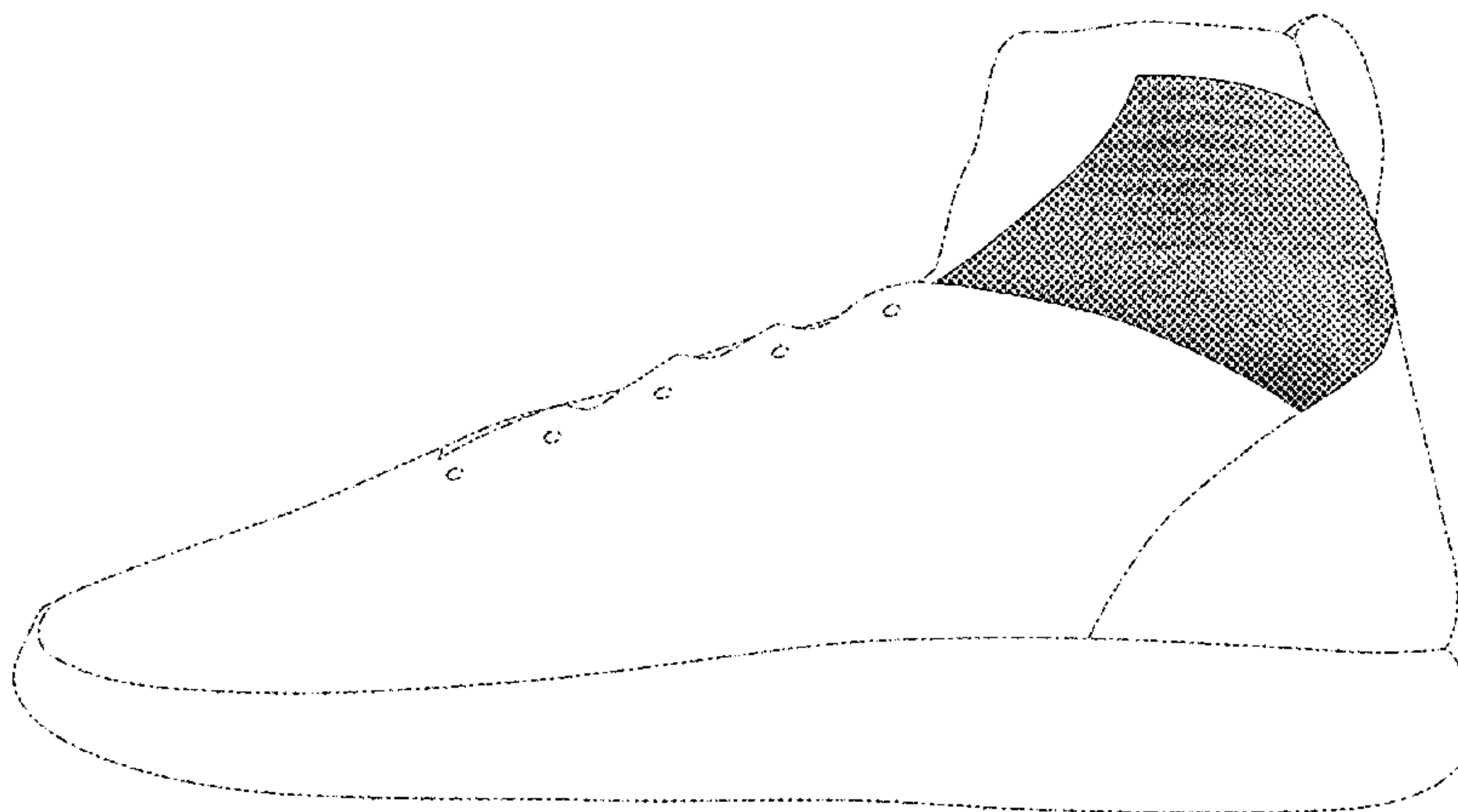
FIG. 4 is an enlarged view of FIG. 1, shown isolated from the environment.

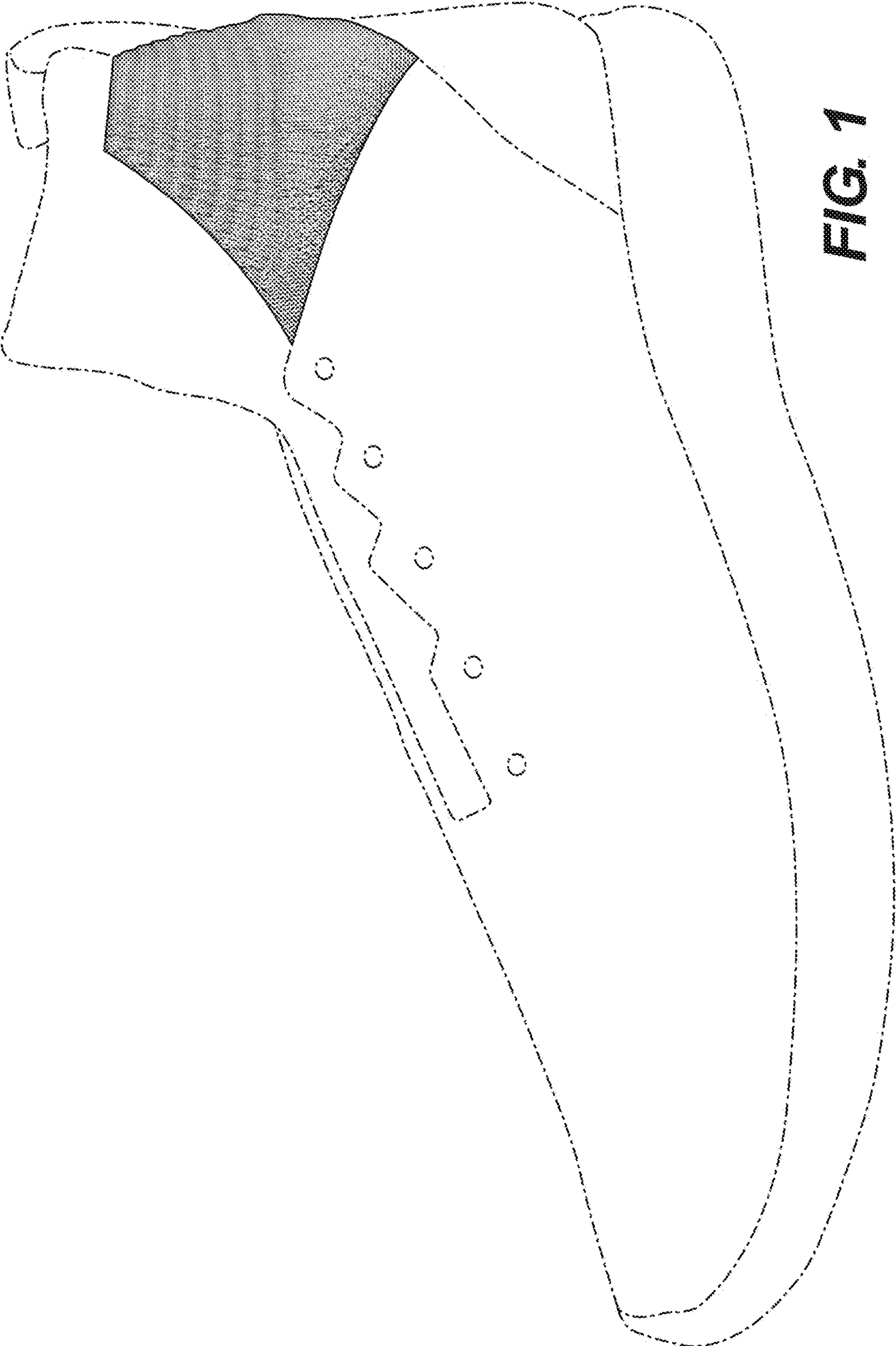

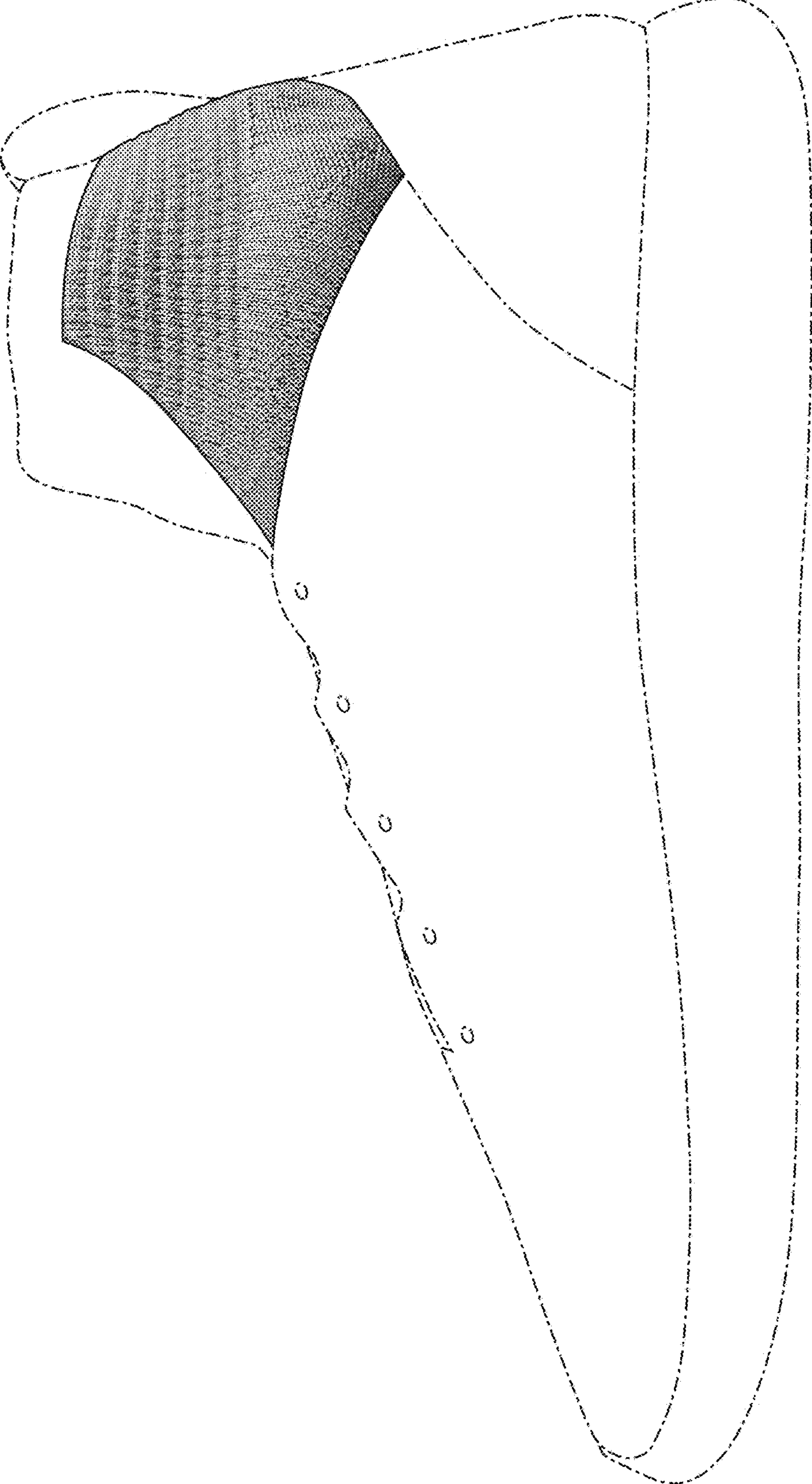

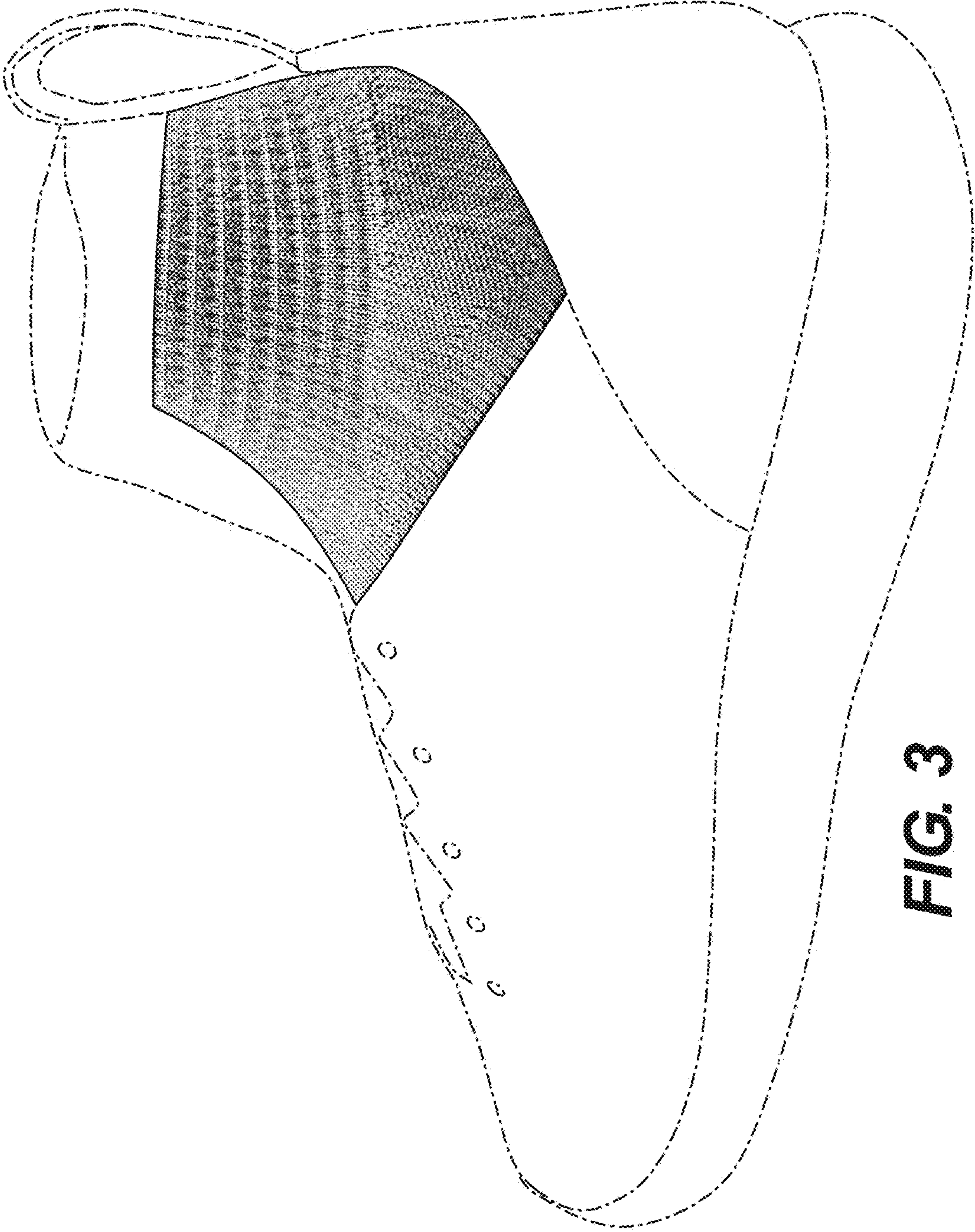

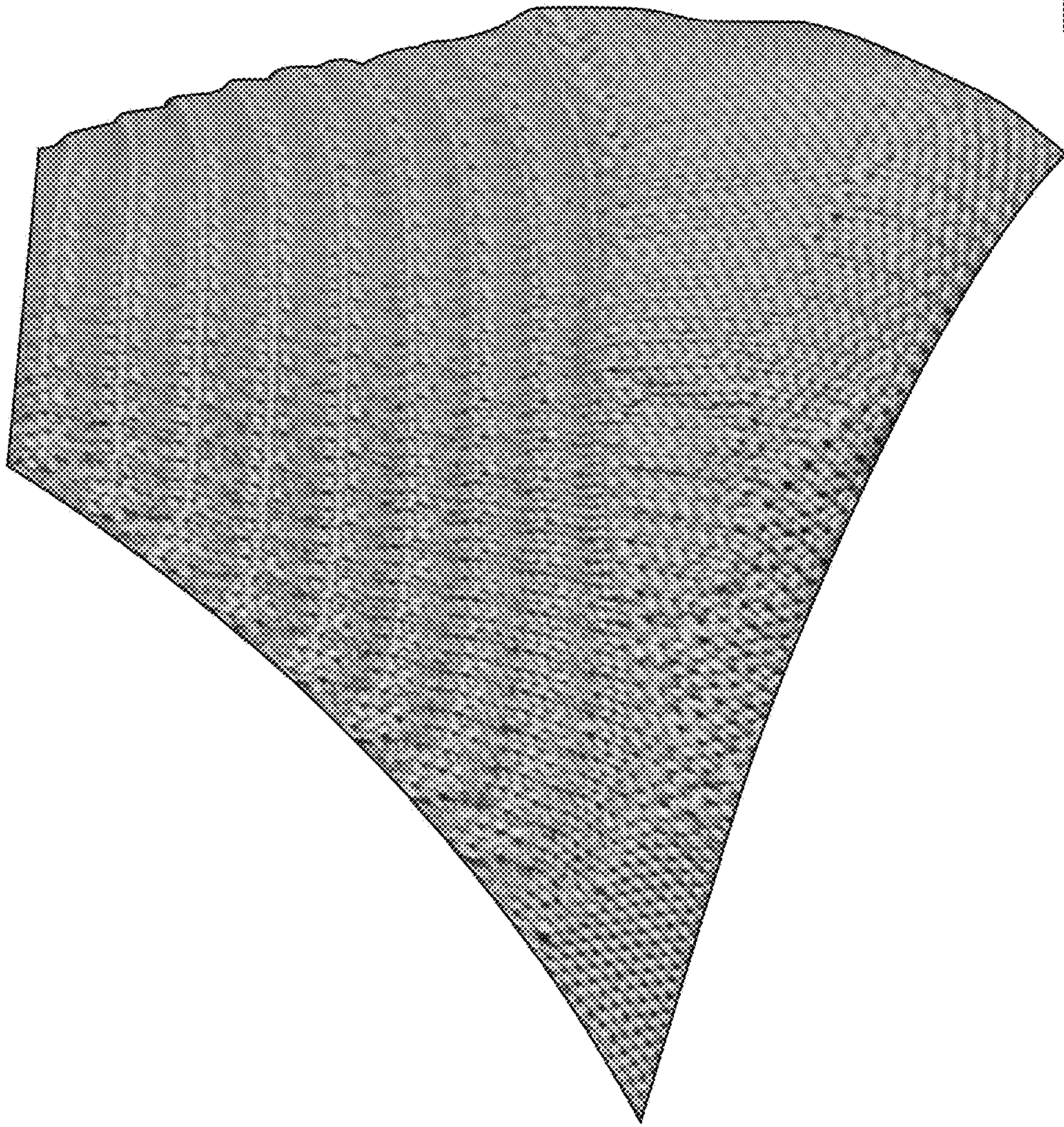

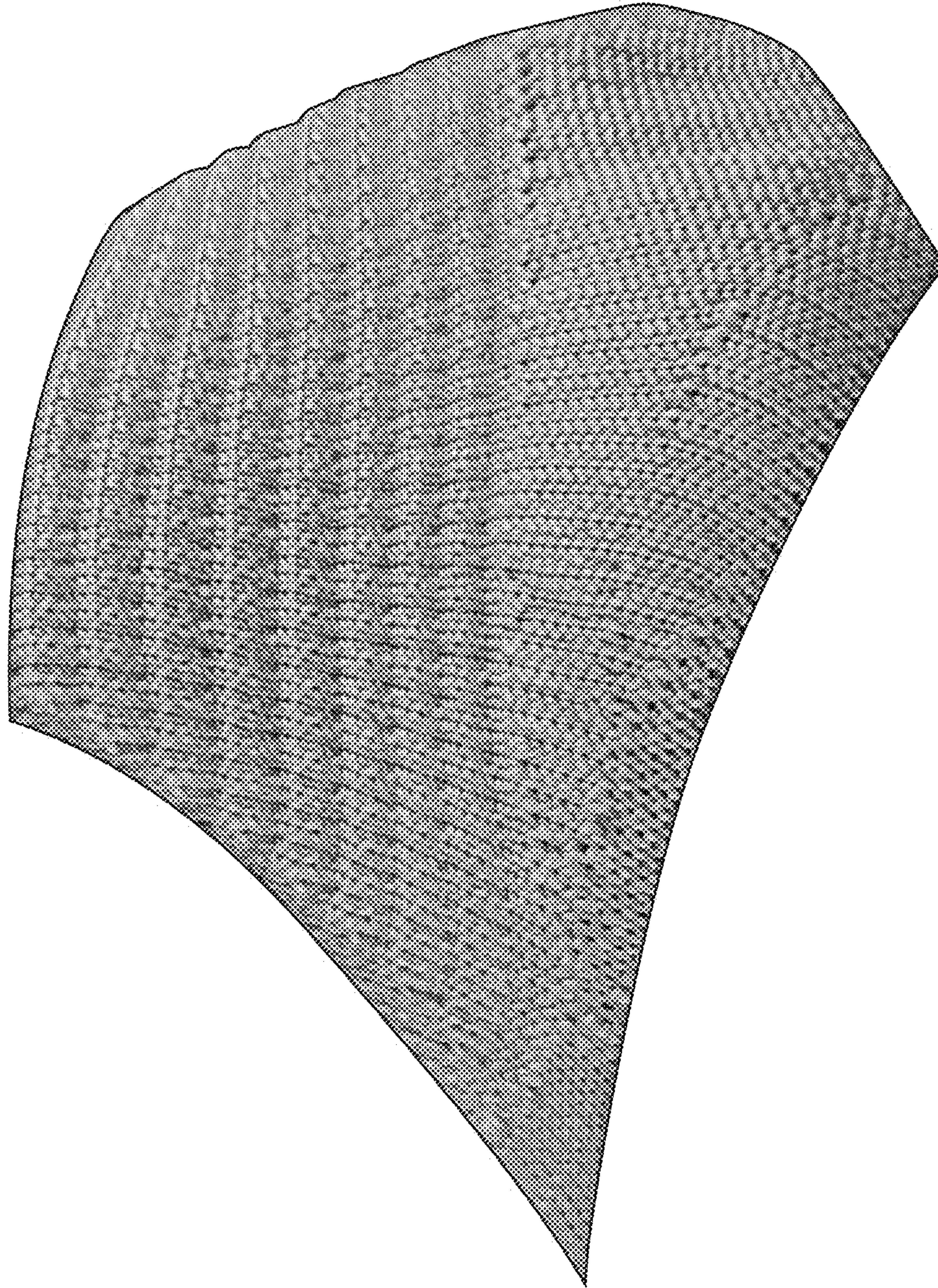

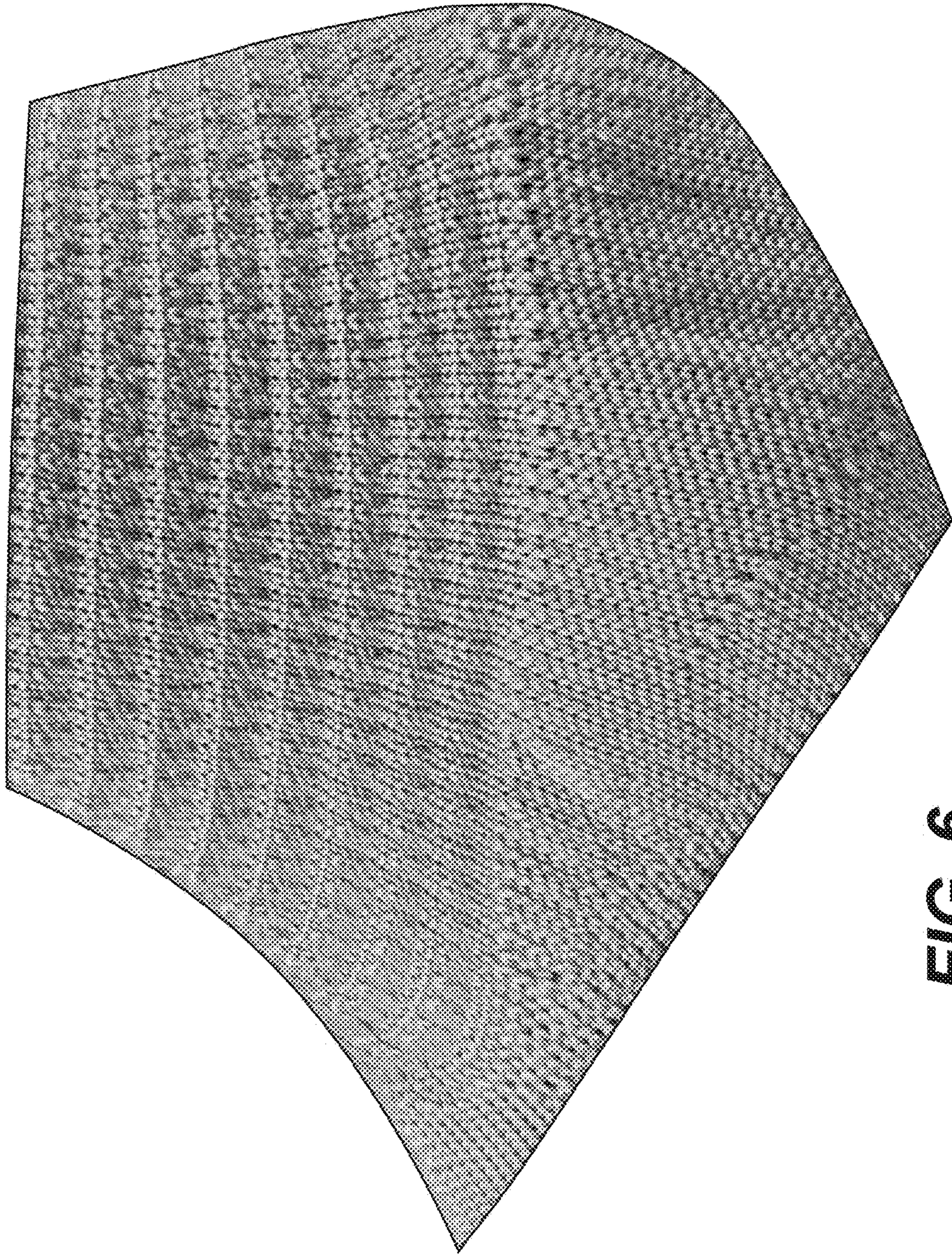
