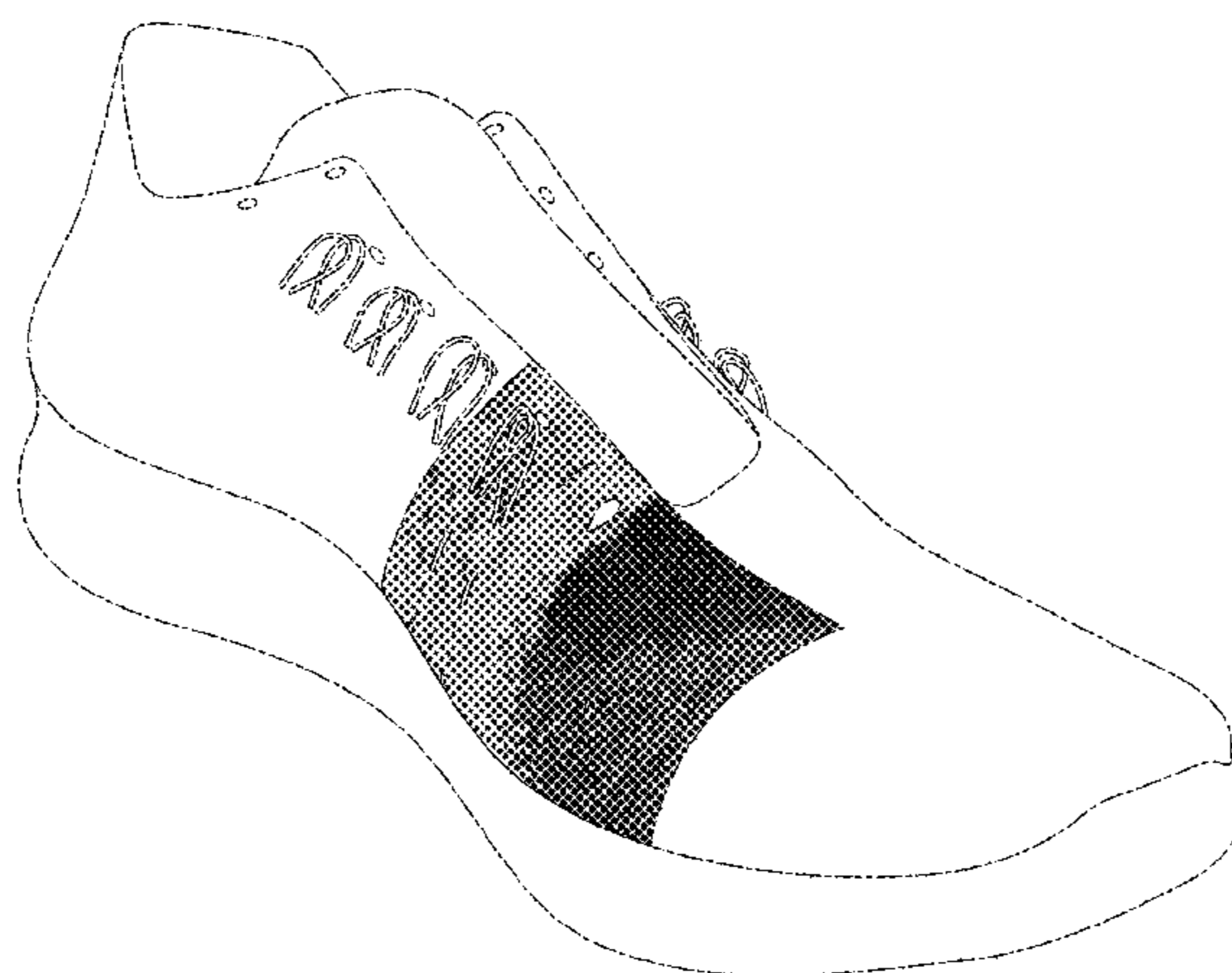
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design; and, FIG. 2 is a side view thereof. The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The unshaded regions within the shaded area that are demarcated by broken lines form no part of the

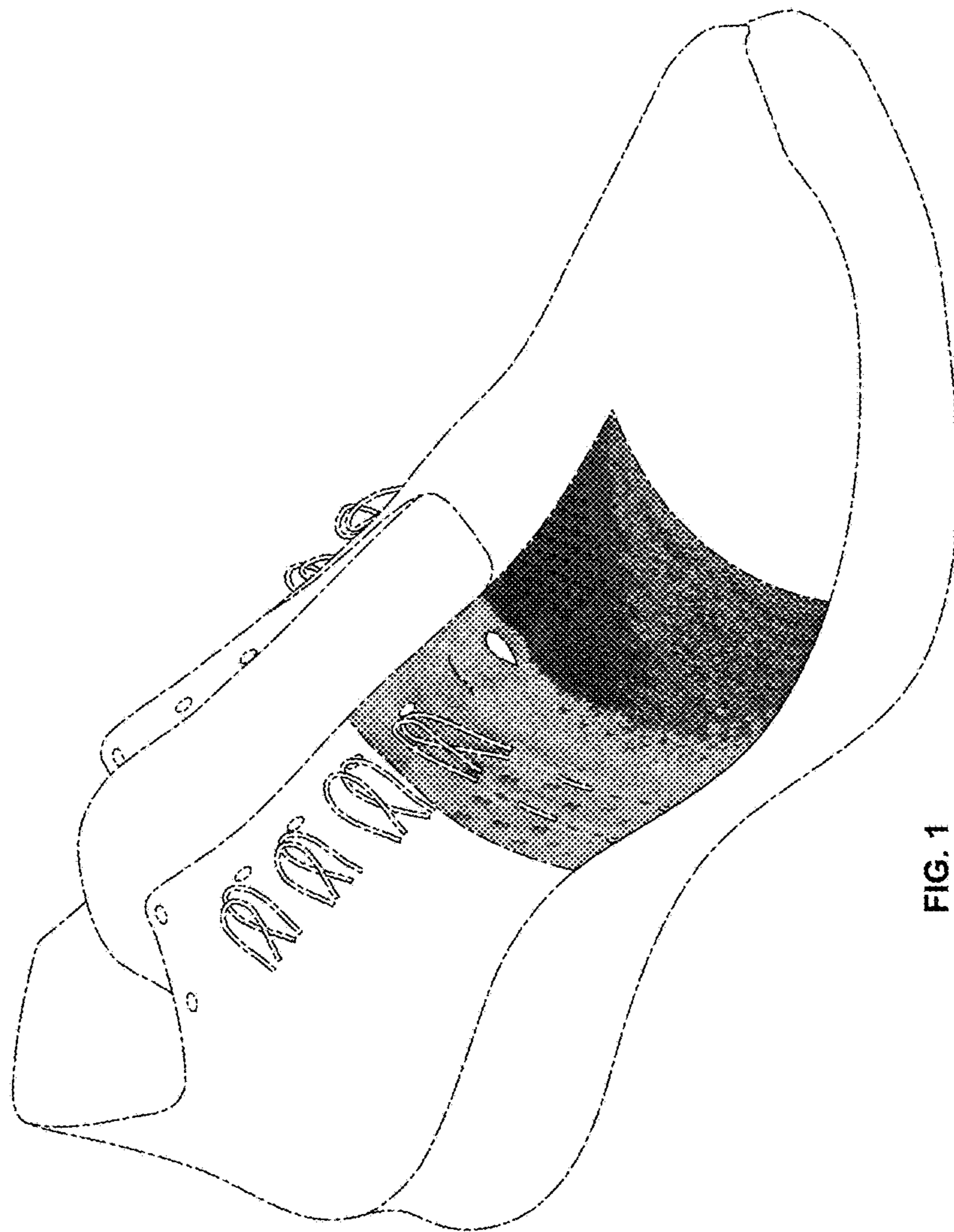

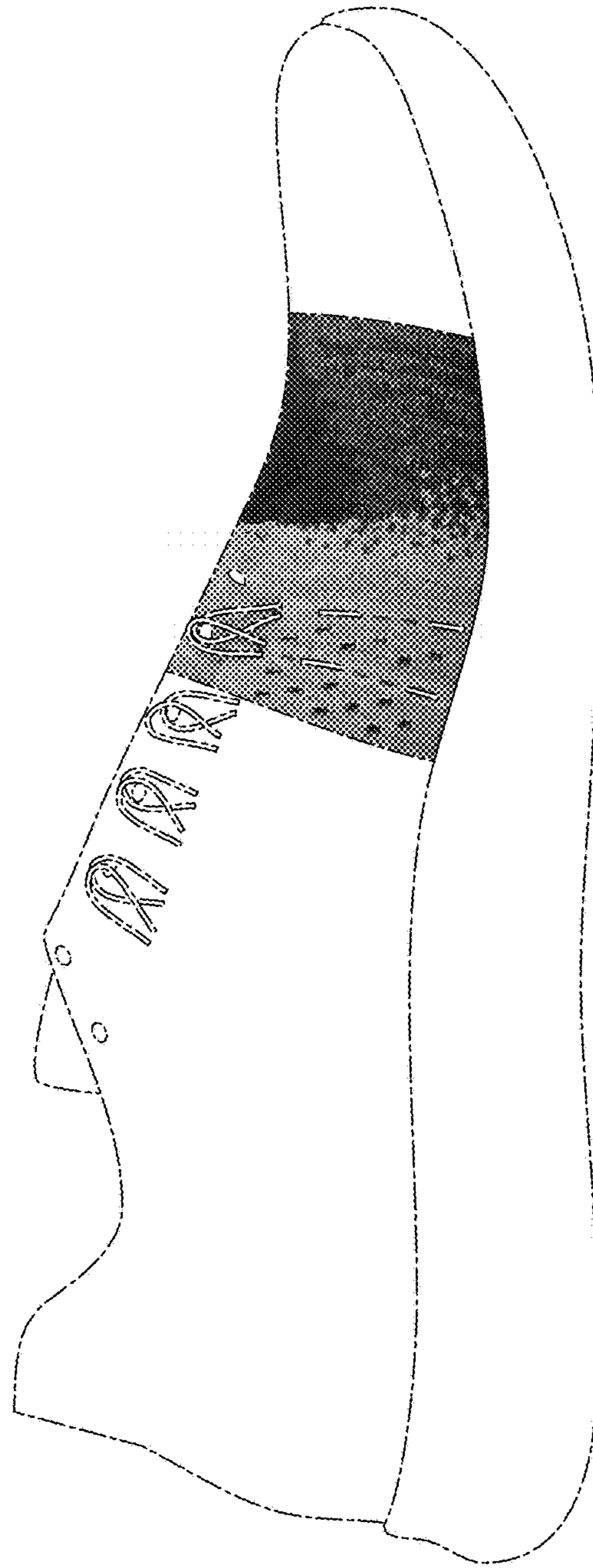
