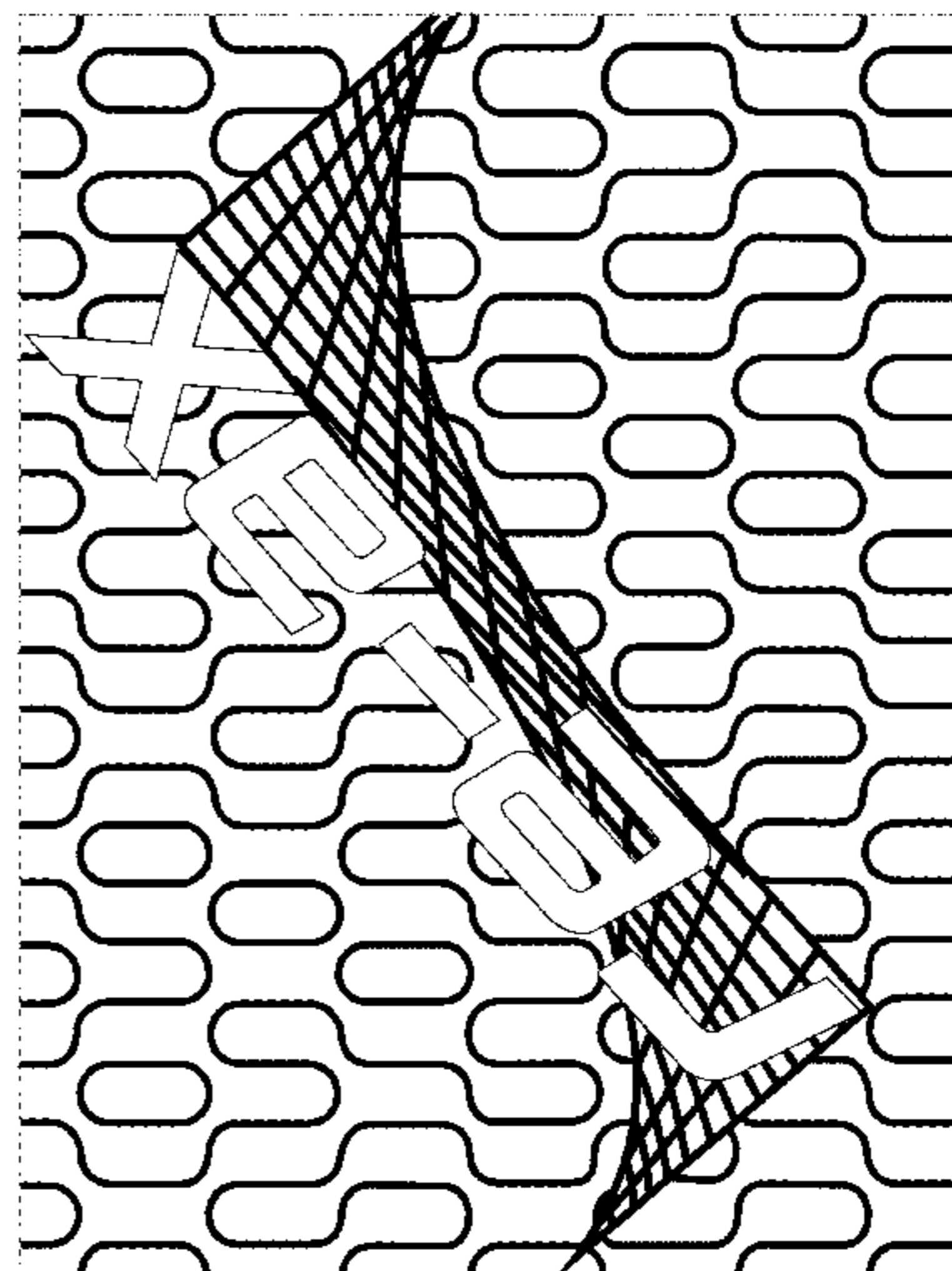
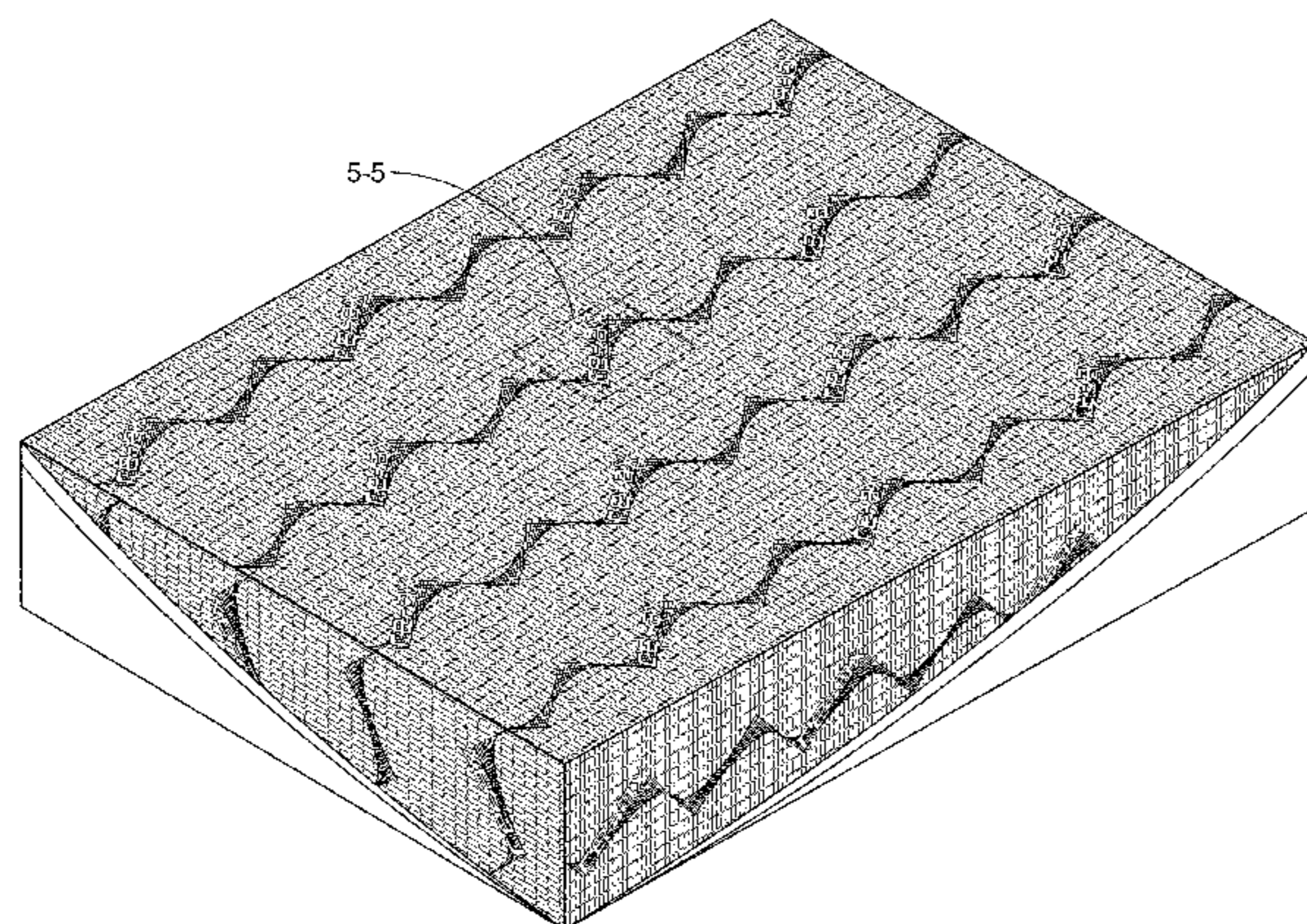
(57) **CLAIM**

The ornamental design for a mattress, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a mattress showing our  
new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right side elevation view thereof; and also is the  
left side elevation view thereof;  
FIG. 4 is a front elevation view thereof; and is also the rear  
elevation view thereof;  
FIG. 5 is a detail view of a portion of FIG. 1 taken from  
detail section 5-5;  
FIG. 6 is a detail view of a portion of FIG. 2 taken from  
detail section 6-6;  
FIG. 7 is an enlarged fragmentary view of a portion of the  
corner of the mattress of FIG. 1; and,  
FIG. 8 is a bottom plan view of the mattress of FIG. 1.  
In FIGS. 1, 2, 5, and 6, the dot-dot-dash broken lines  
encircling a portion of the claimed design are illustrating a  
boundary of an enlarged detail view and form no part of the  
claimed design.

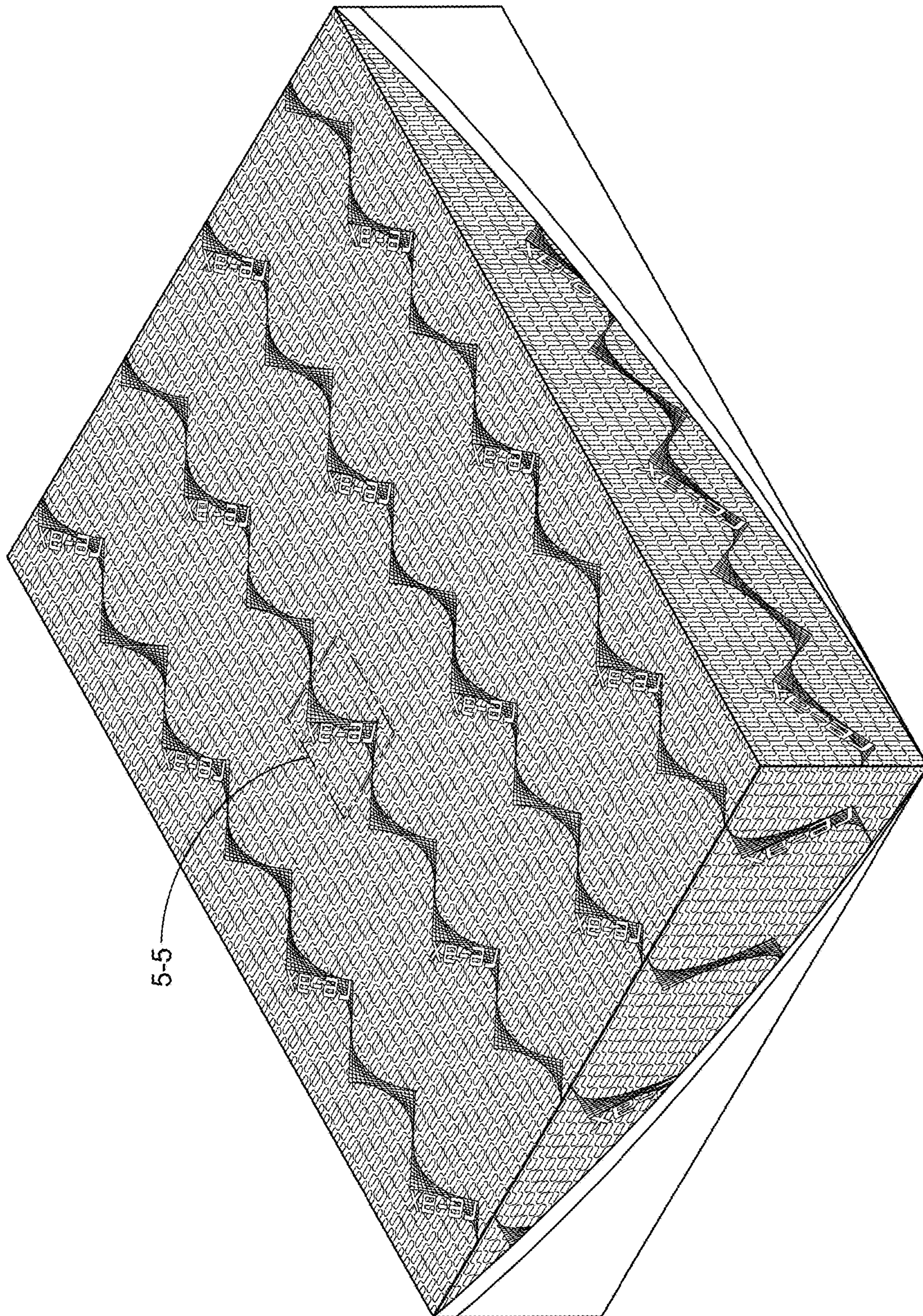

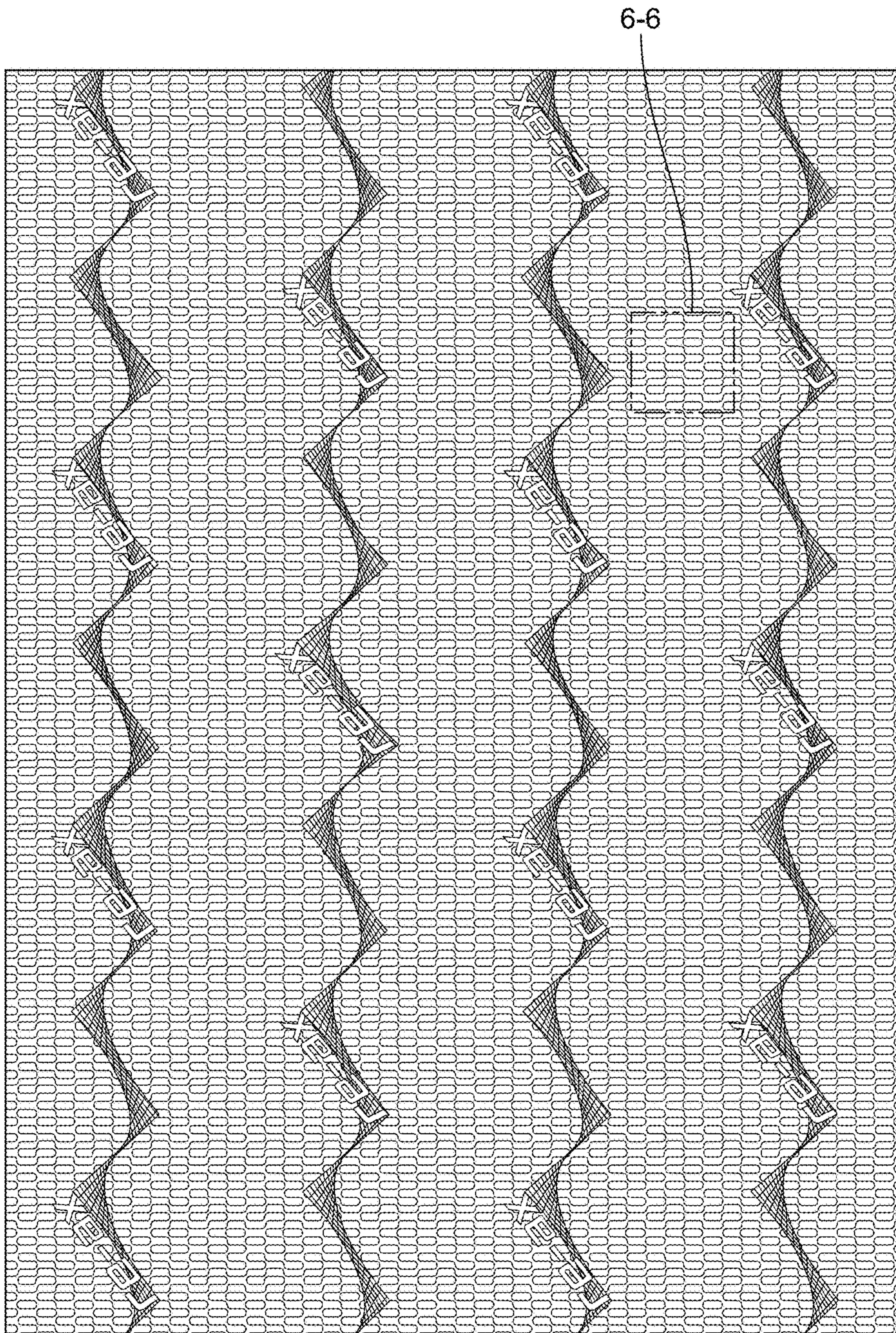

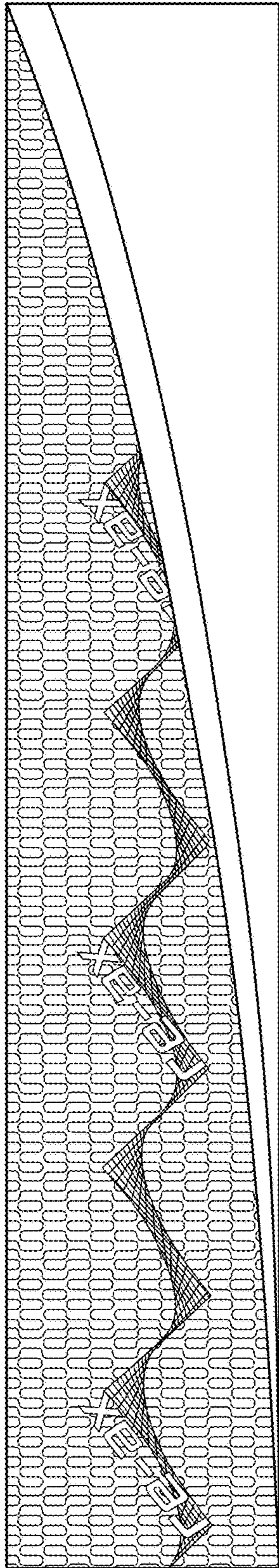

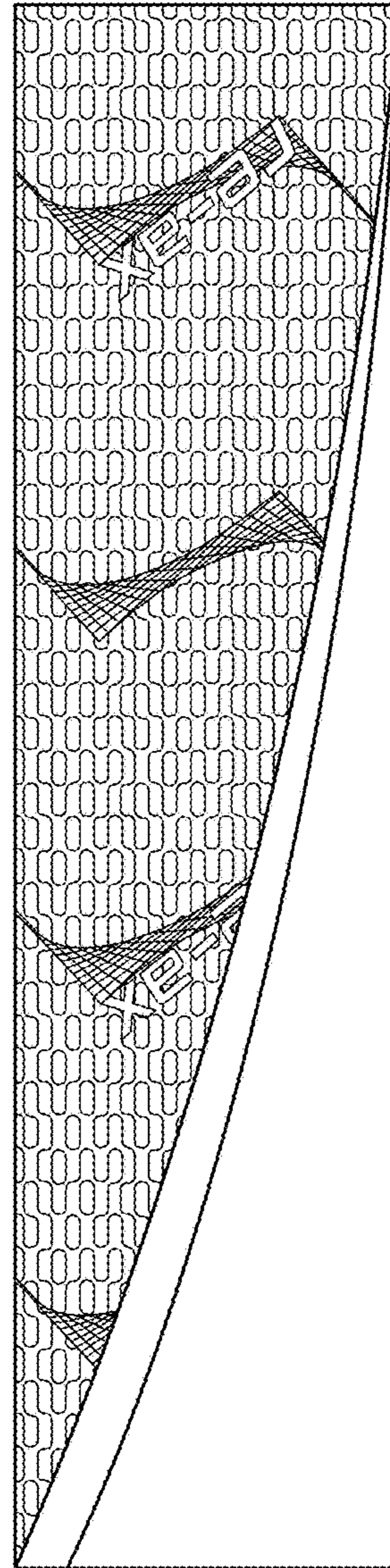

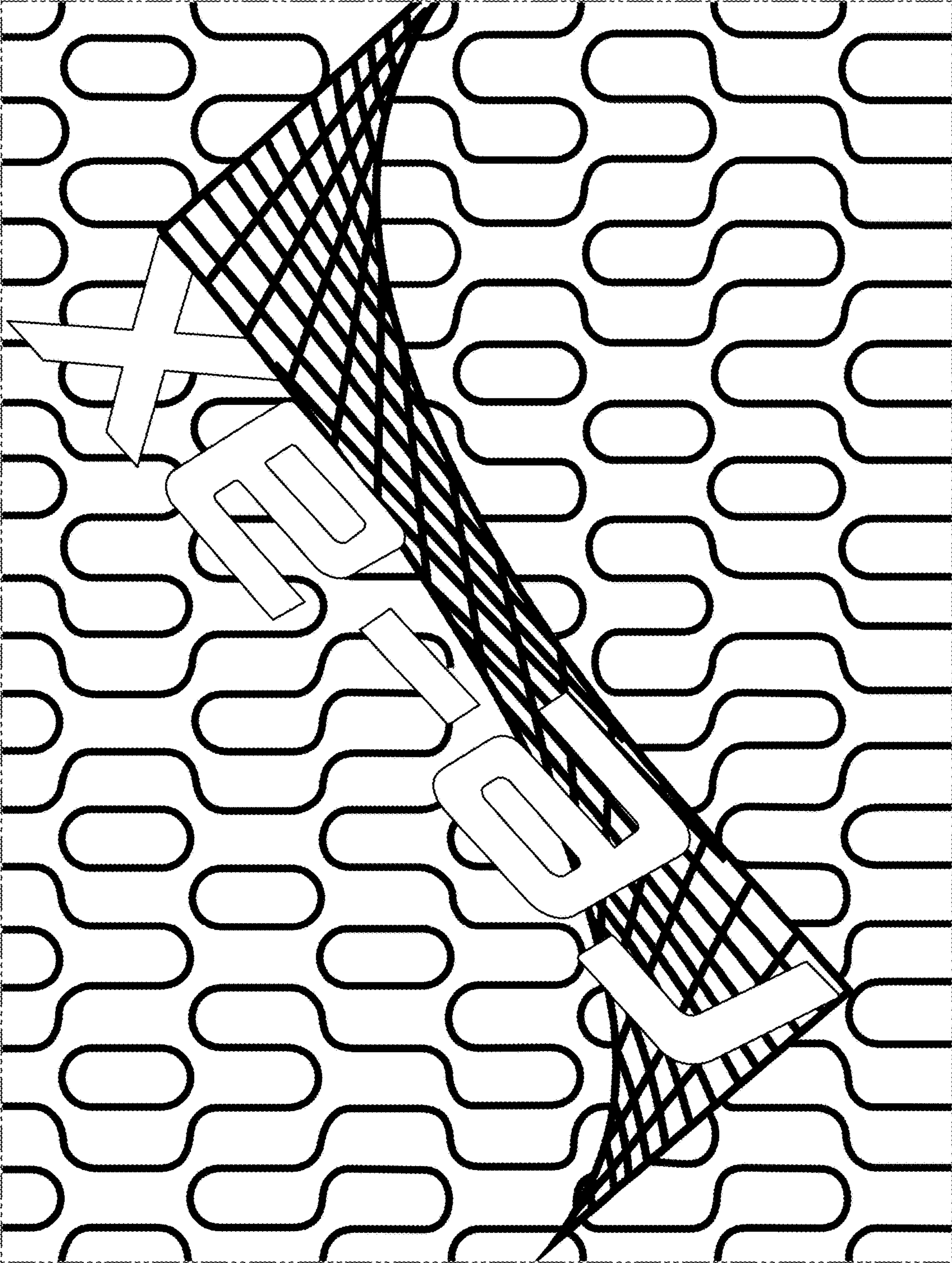

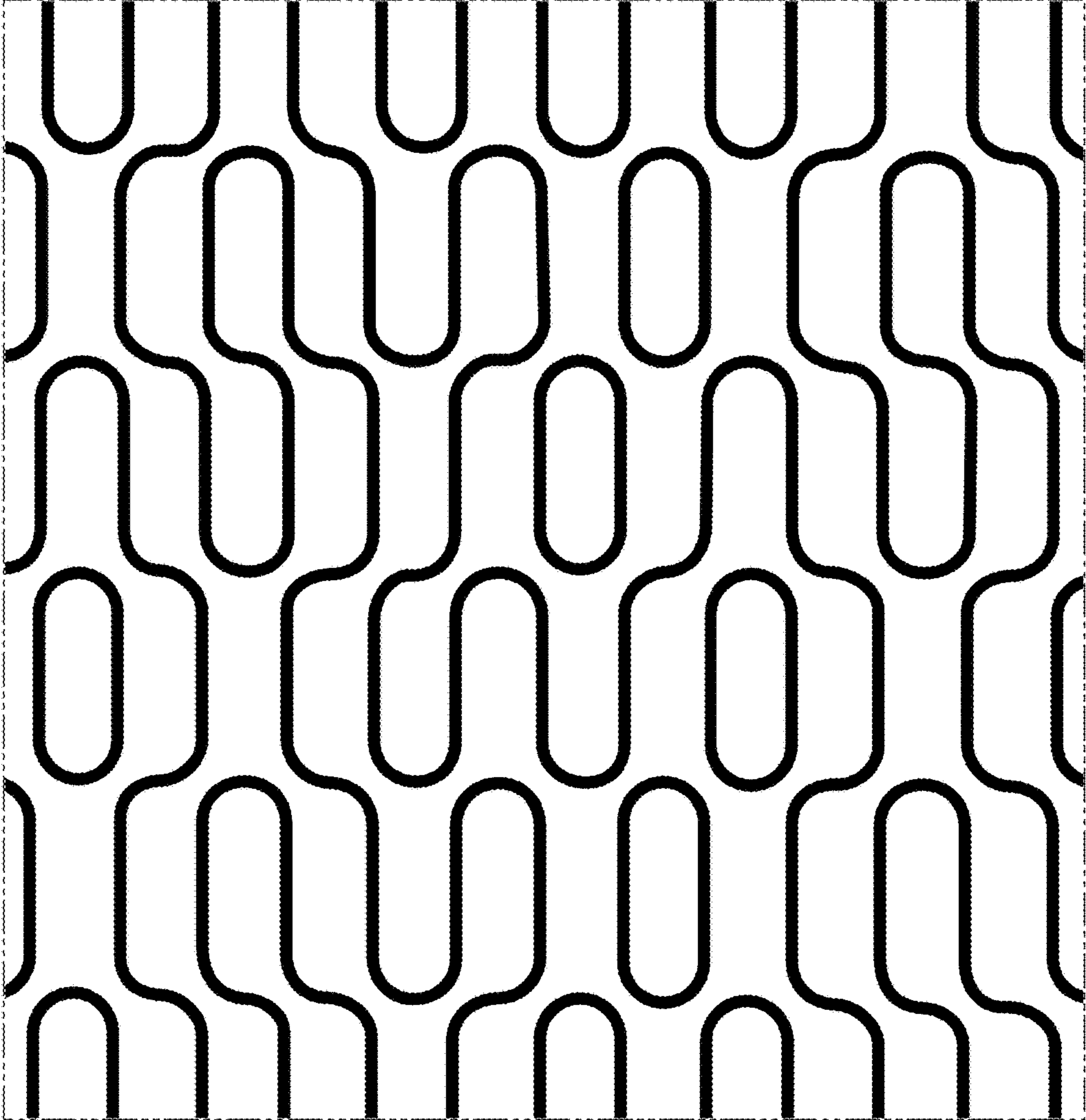

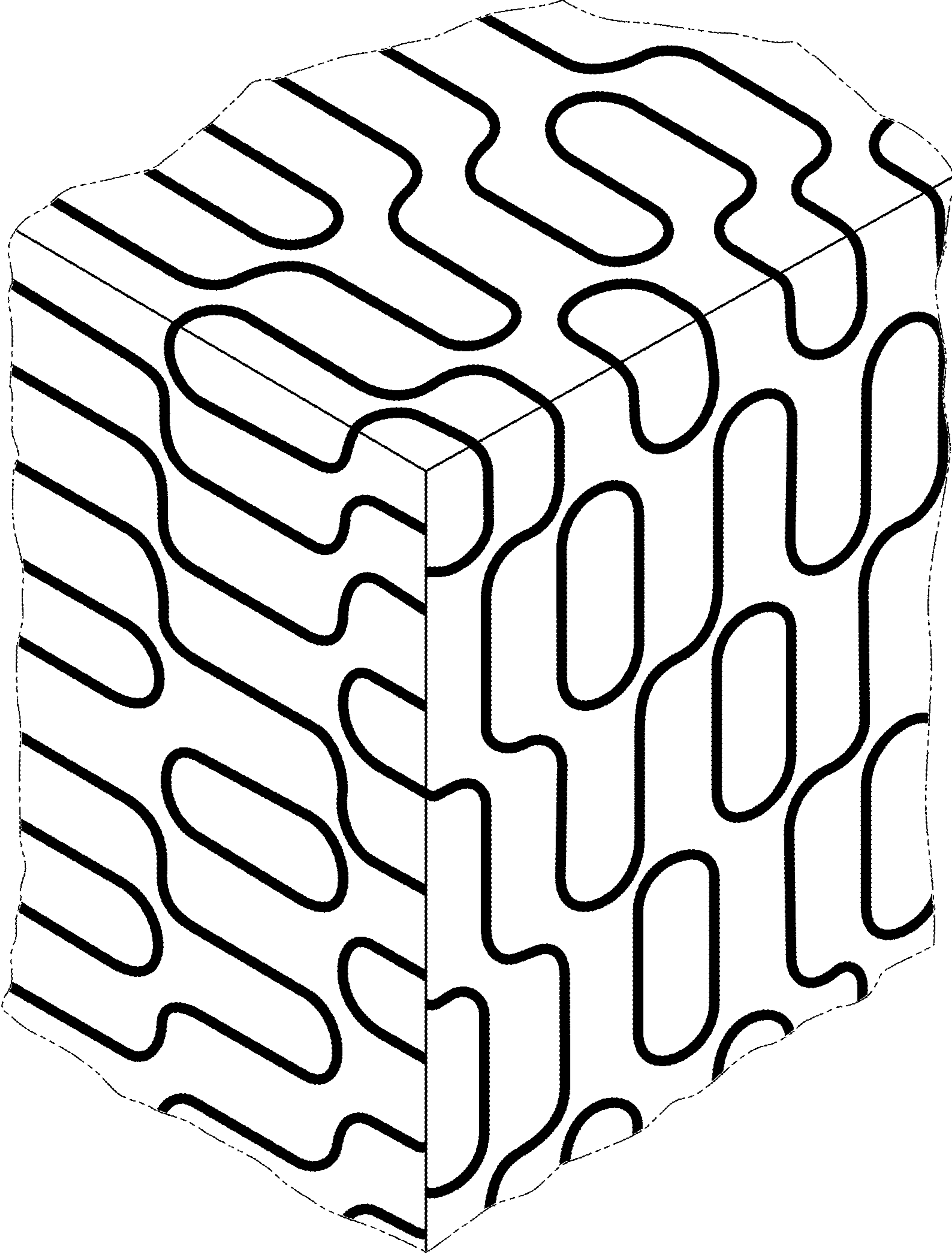

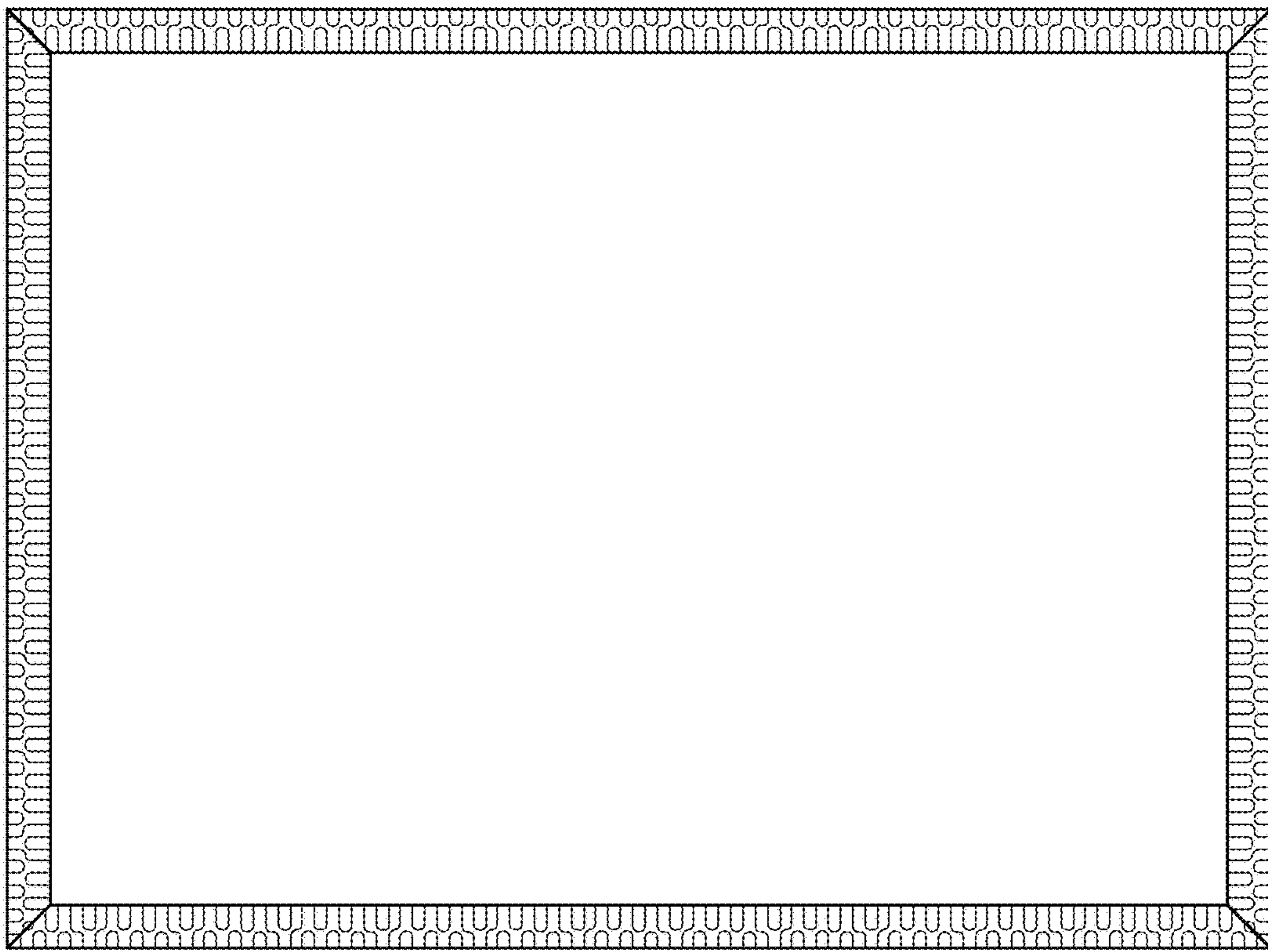
