FIG. 4 is a left-side elevation view of the sandwich maker.

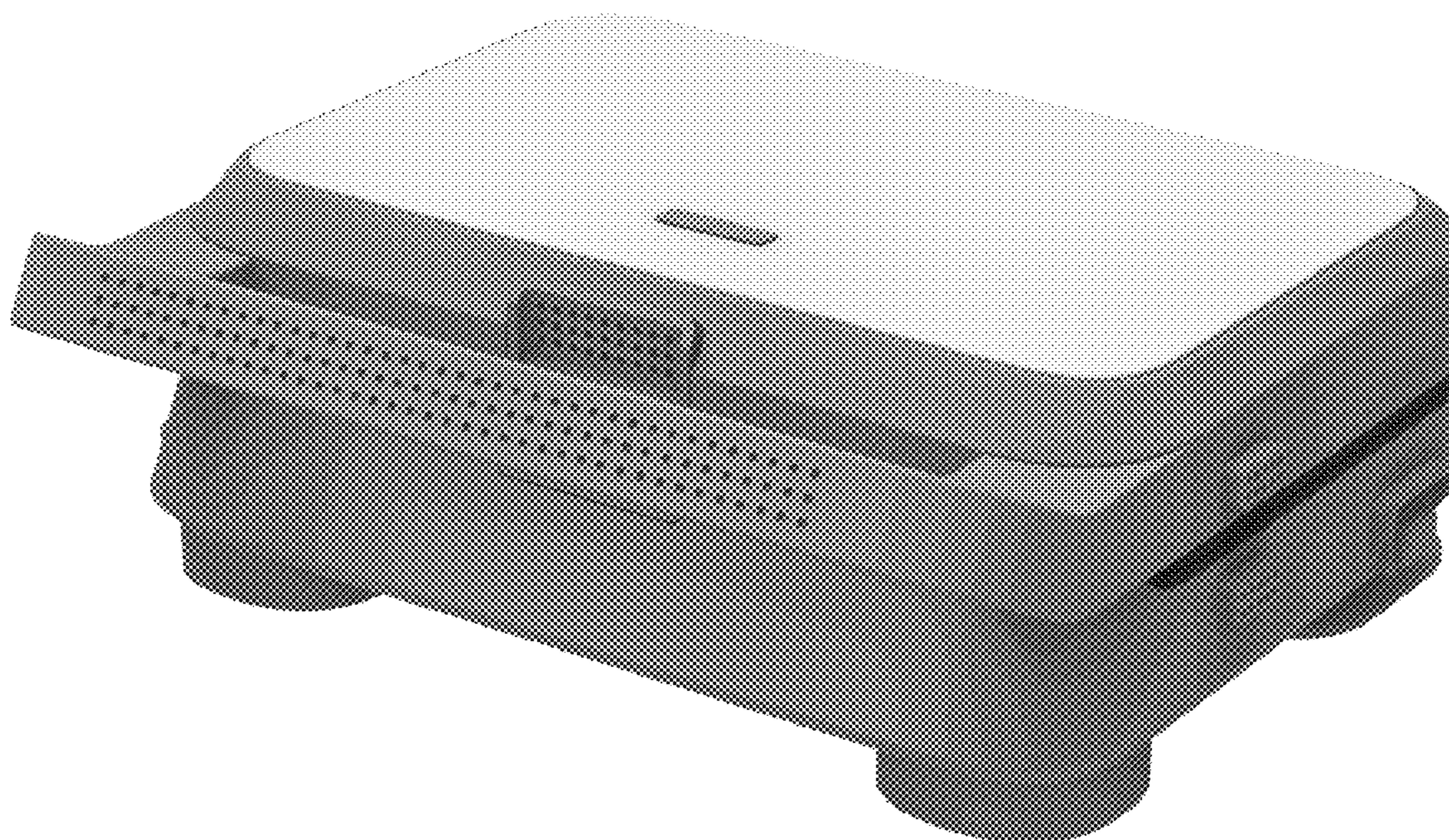
FIG. 5 is a right-side elevation view of the sandwich maker.

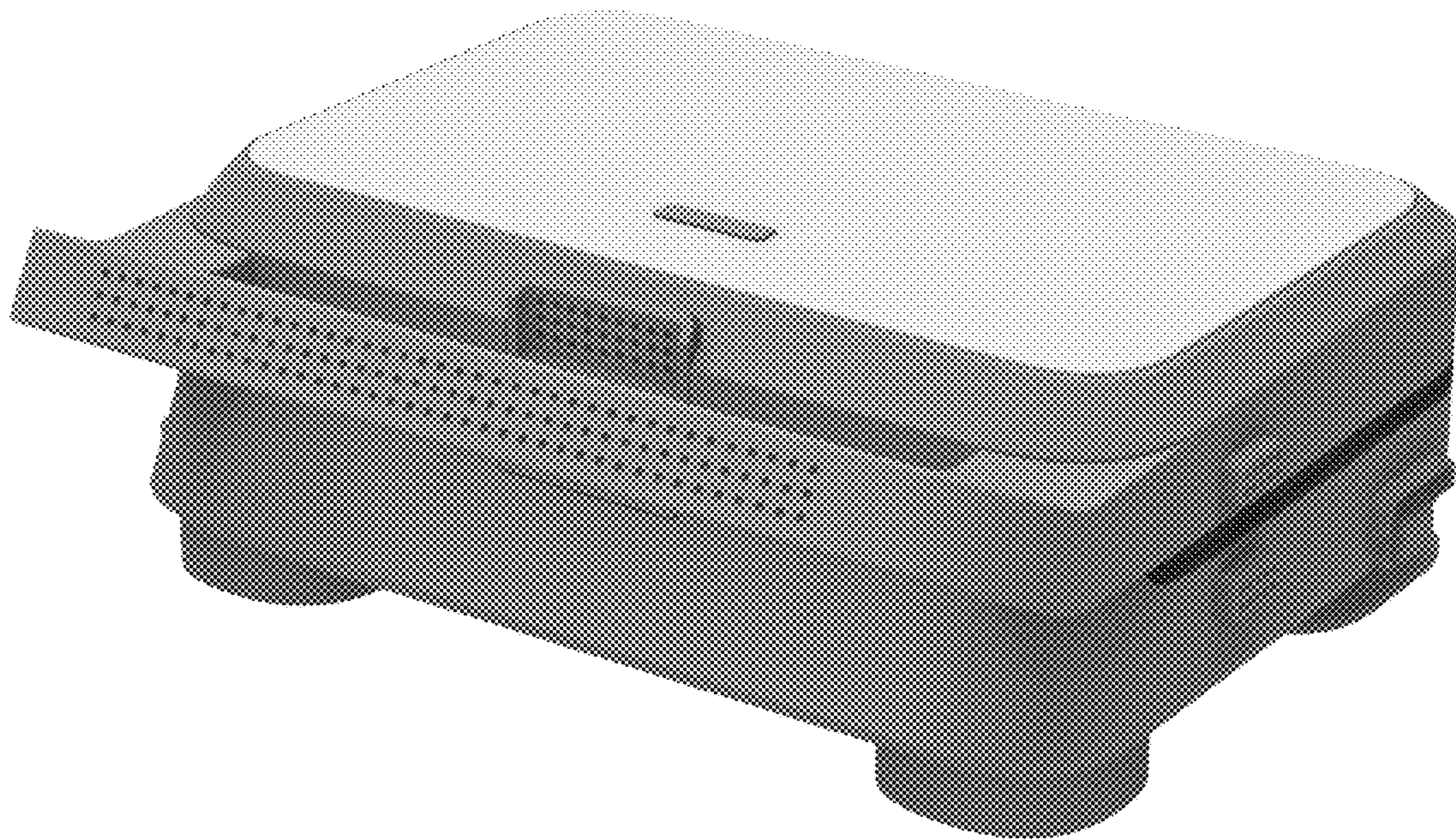

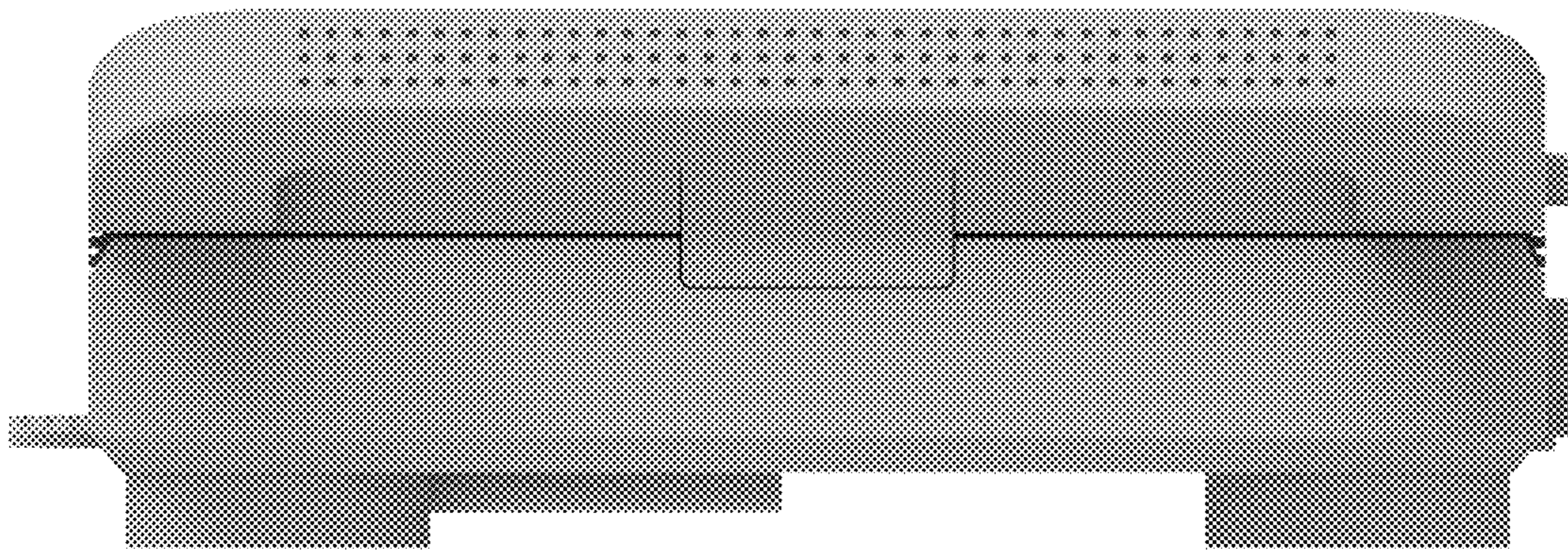

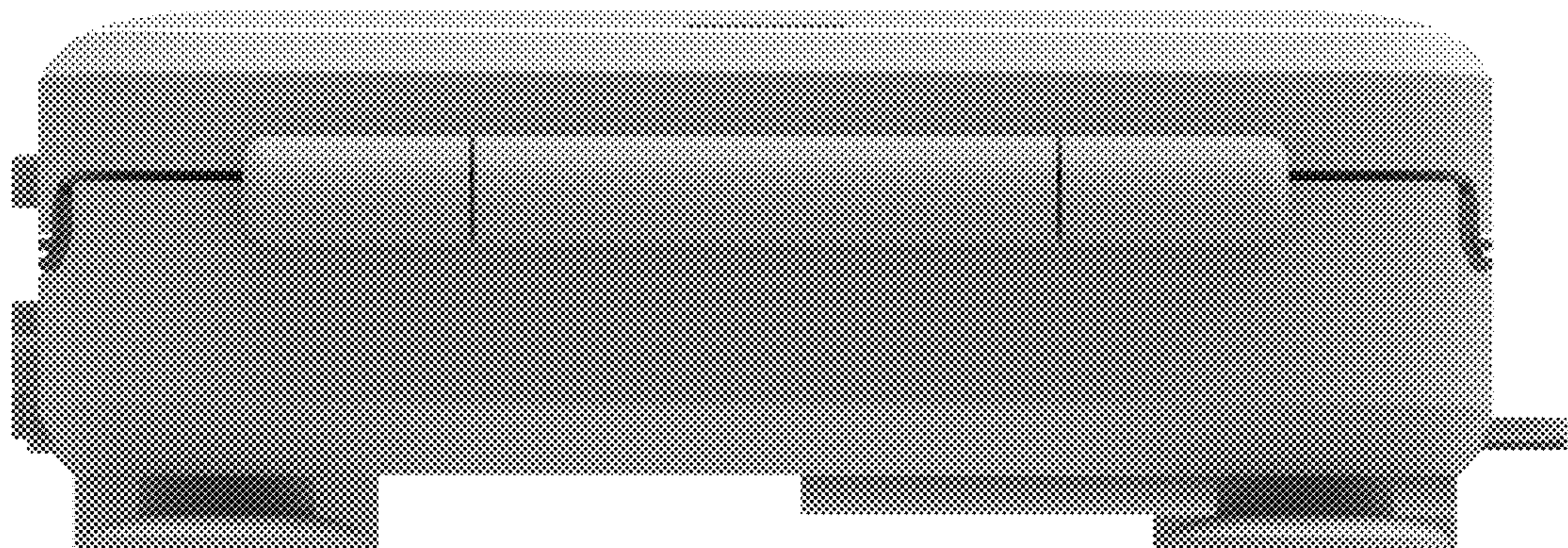

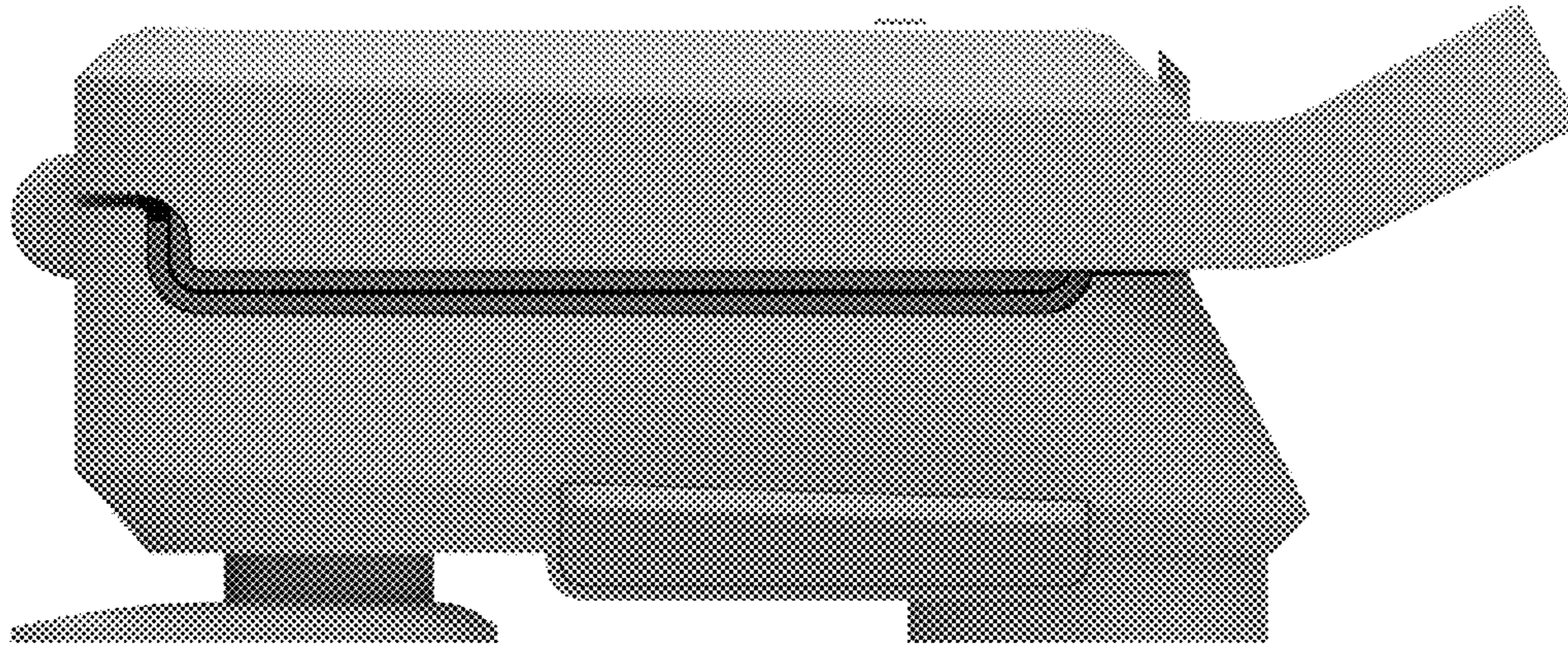

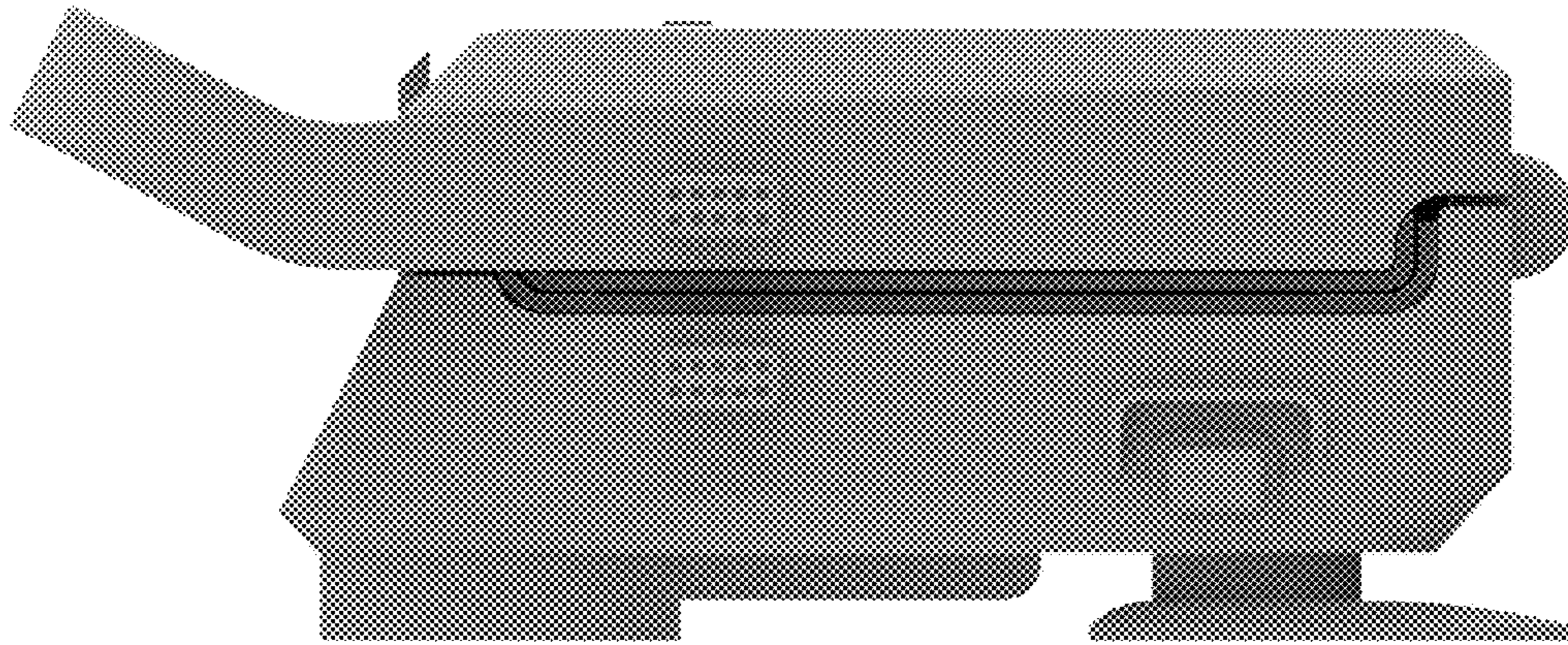

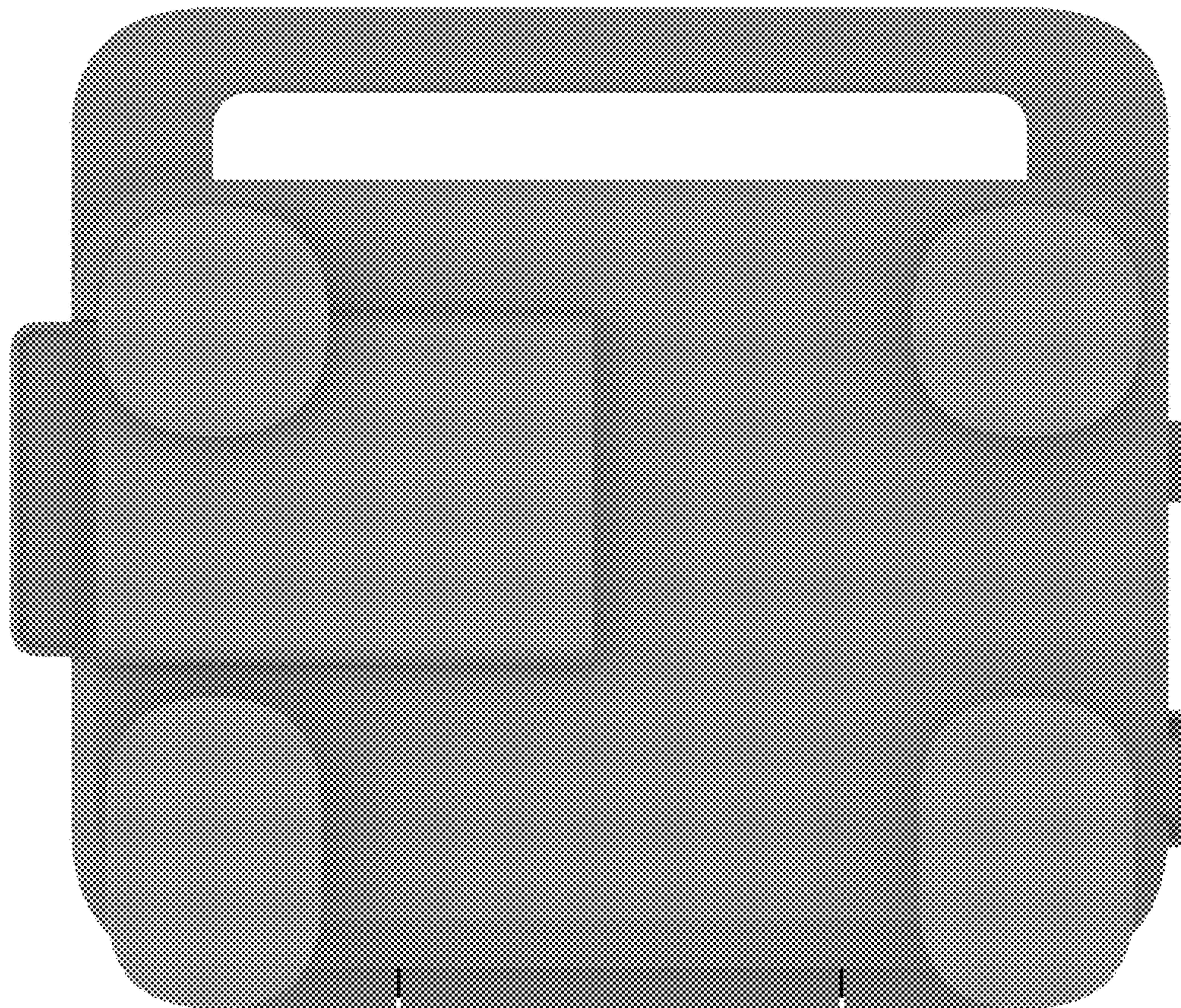

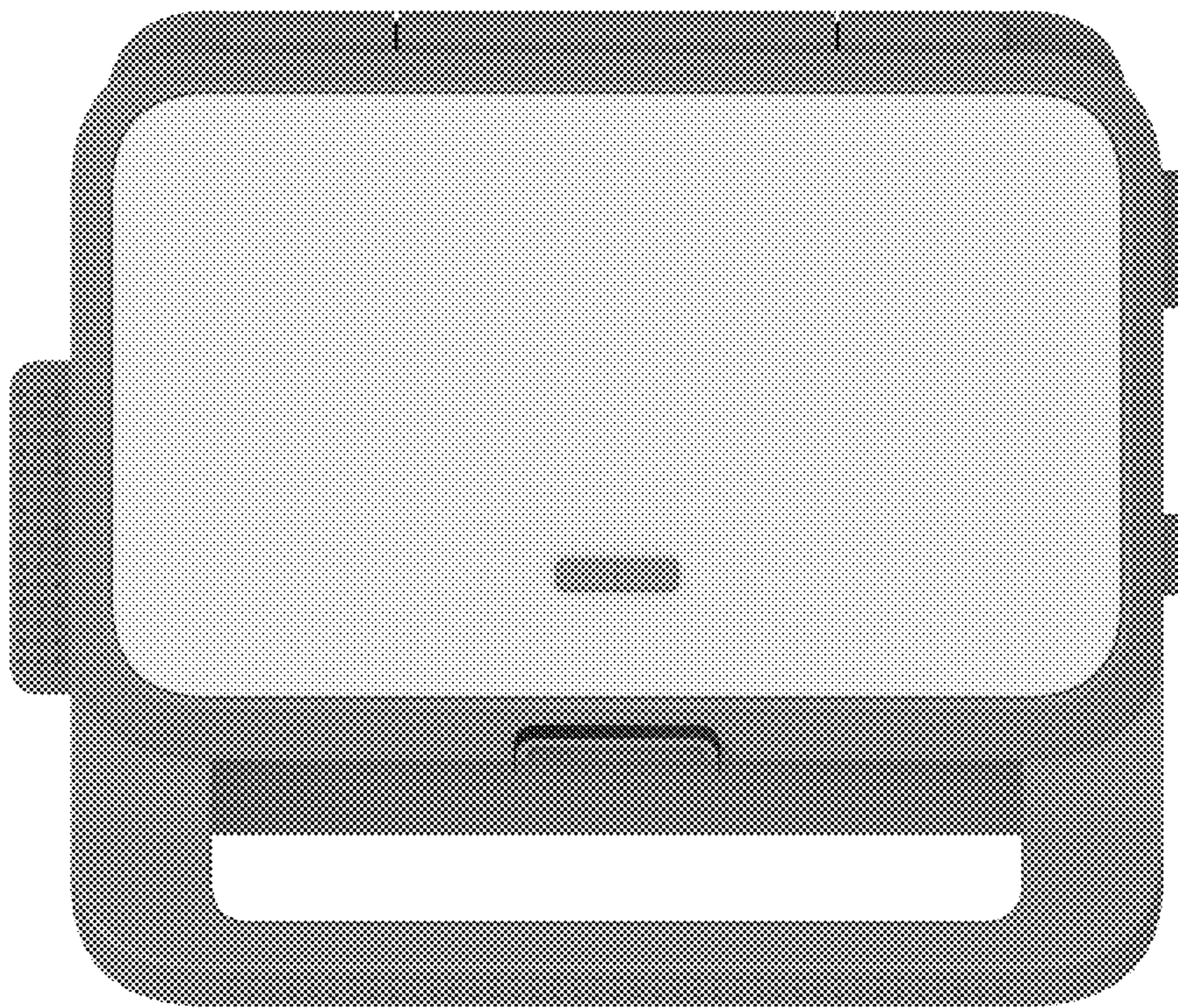
