(57) **CLAIM**

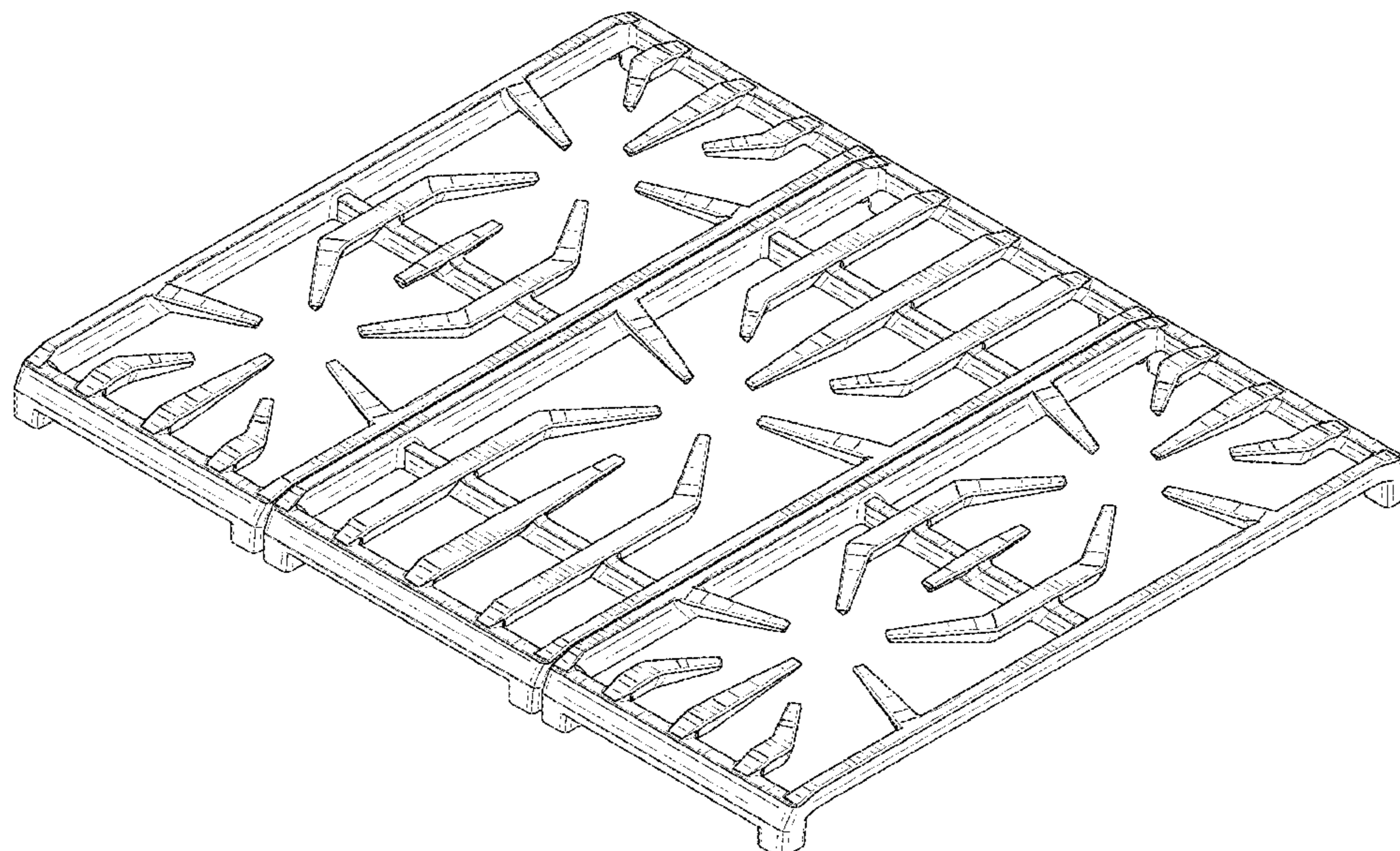
The ornamental design for a gas cooktop grating, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gas cooktop grating showing an embodiment of my new ornamental design; FIG. 2 is a front view thereof; FIG. 3 is a top view thereof; FIG. 4 is a left side view thereof, with the right side view being a mirror image thereof; FIG. 5 is a perspective view of a gas cooktop grating showing a second embodiment of my new ornamental design; FIG. 6 is a front view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a left side view thereof, with the right side view being a mirror image thereof.

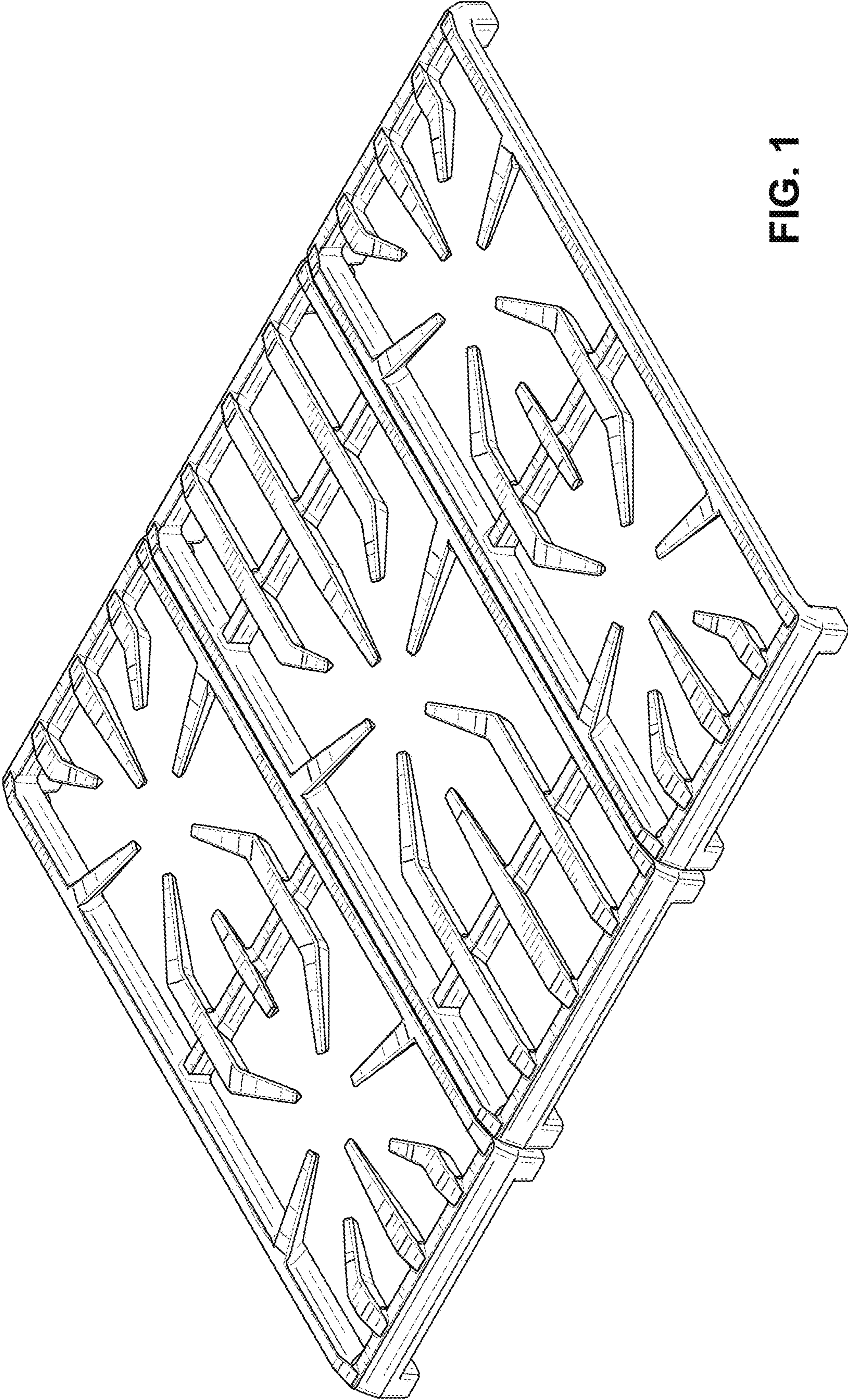

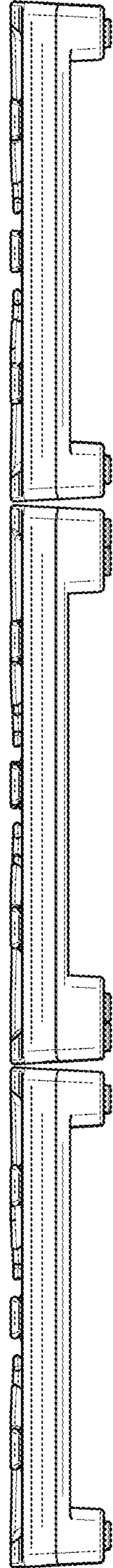
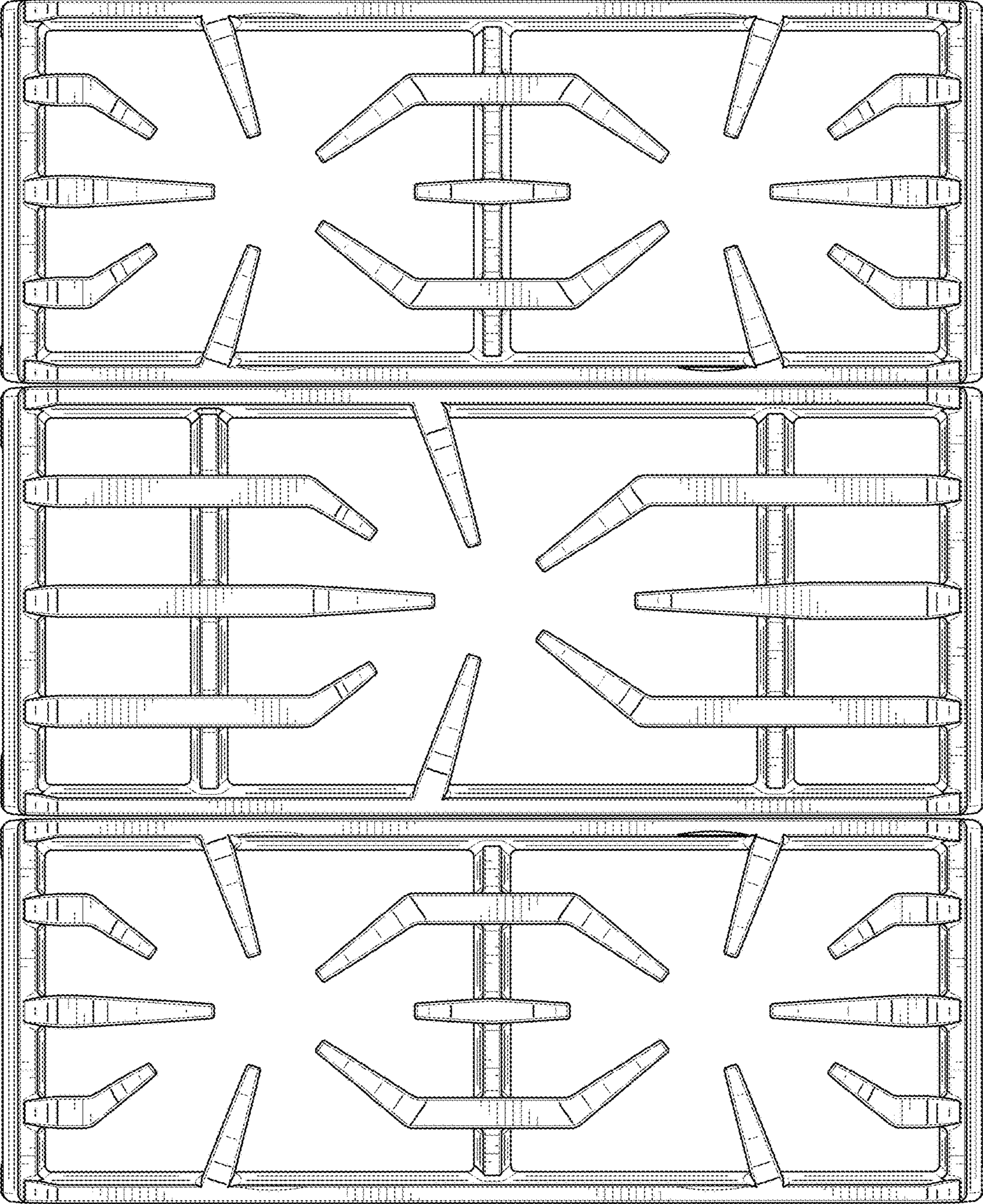

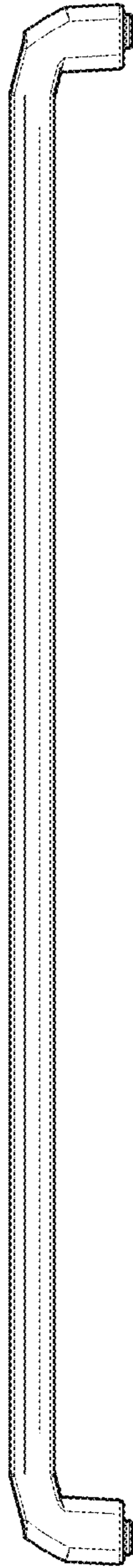

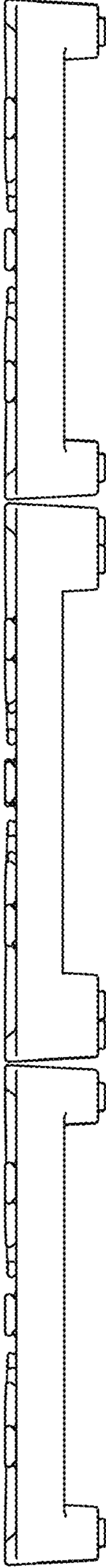

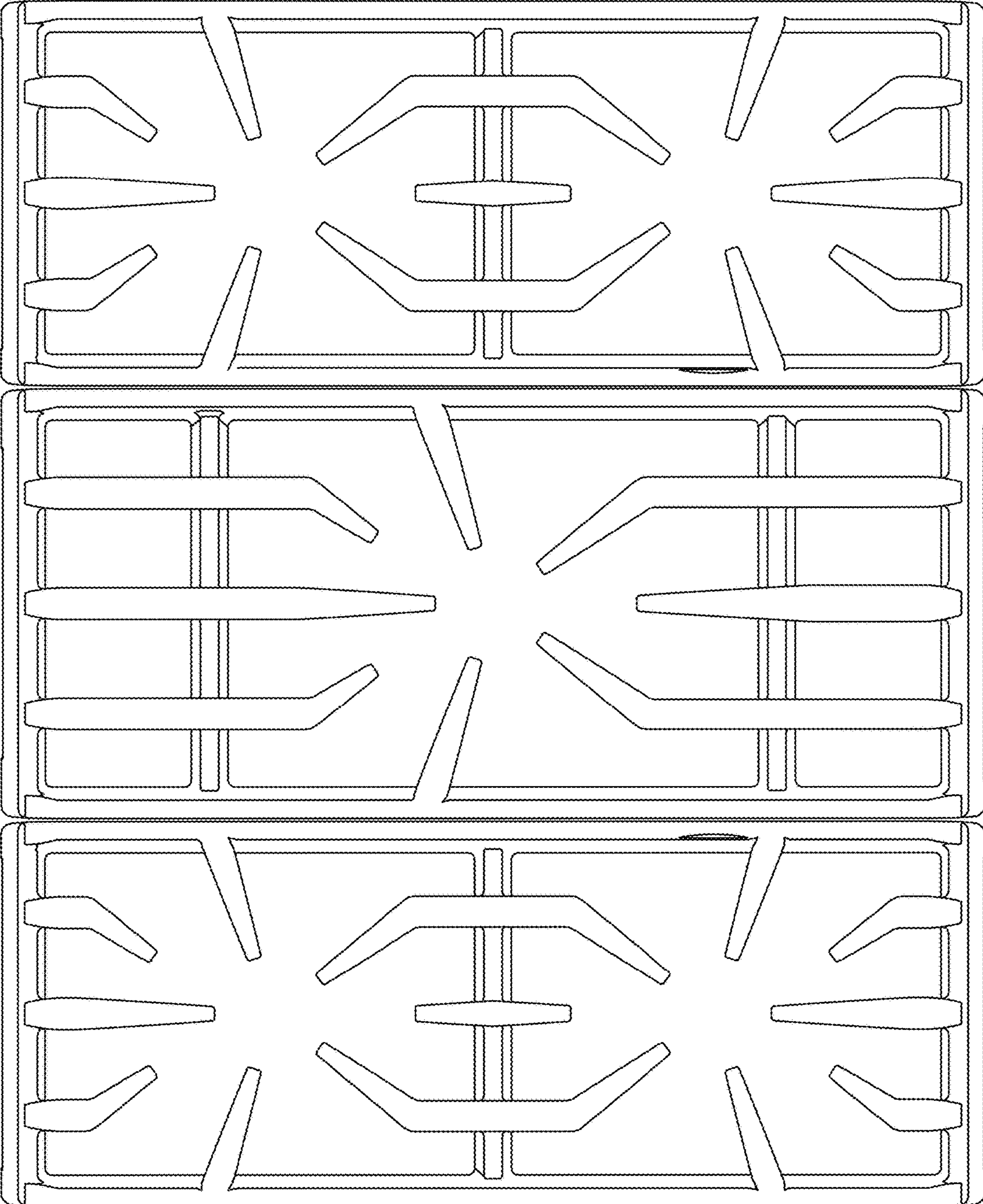

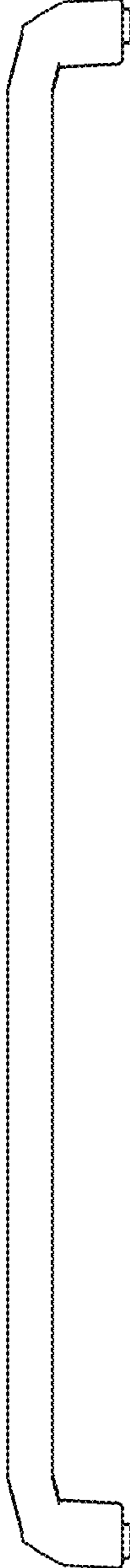
