FIG. 7 is a flat unfolded view of thereof.

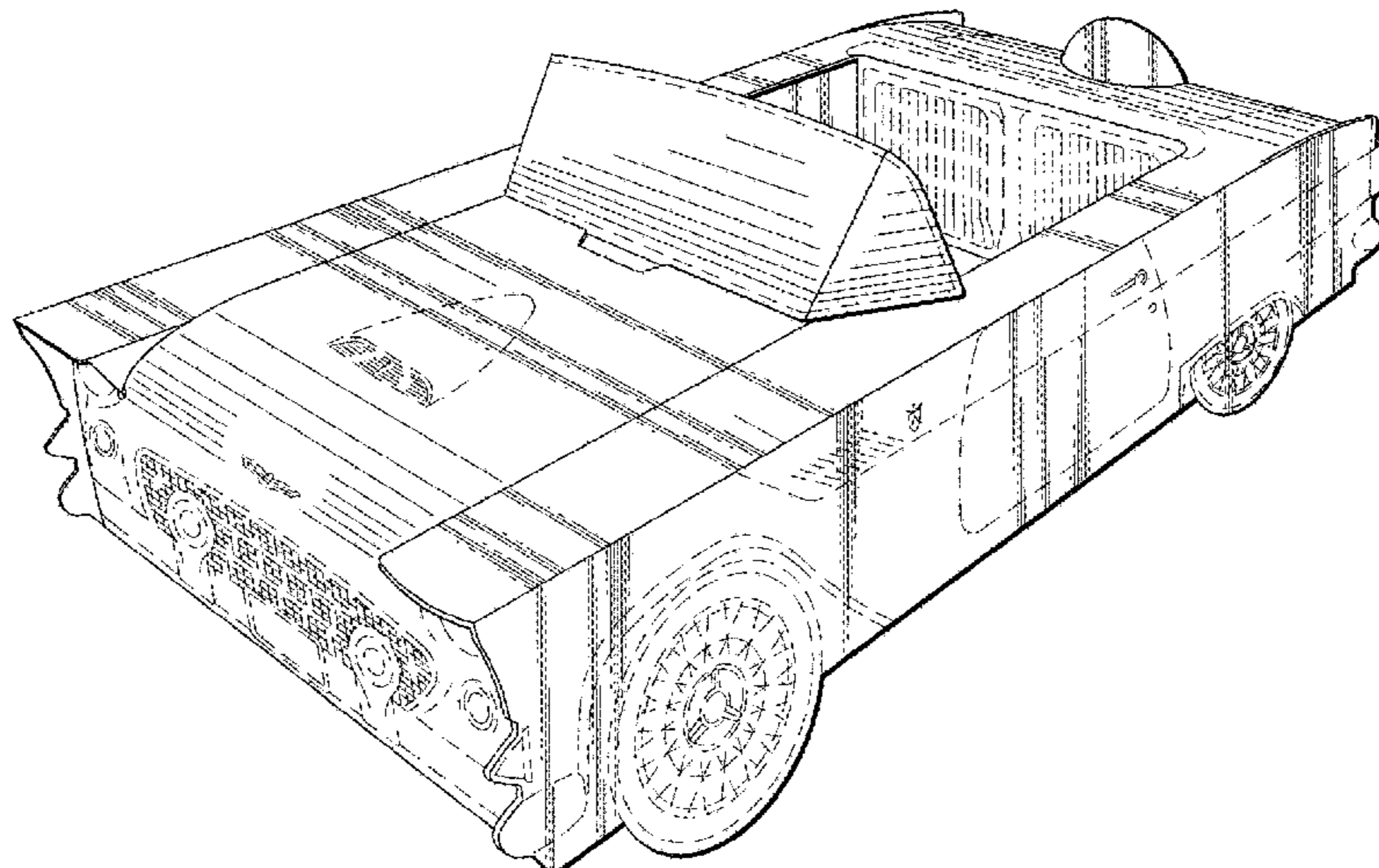
The broken lines in FIGS. 1-6 are for illustrative purposes only and form no part of the design. The broken lines in FIG. 7 depict fold lines.

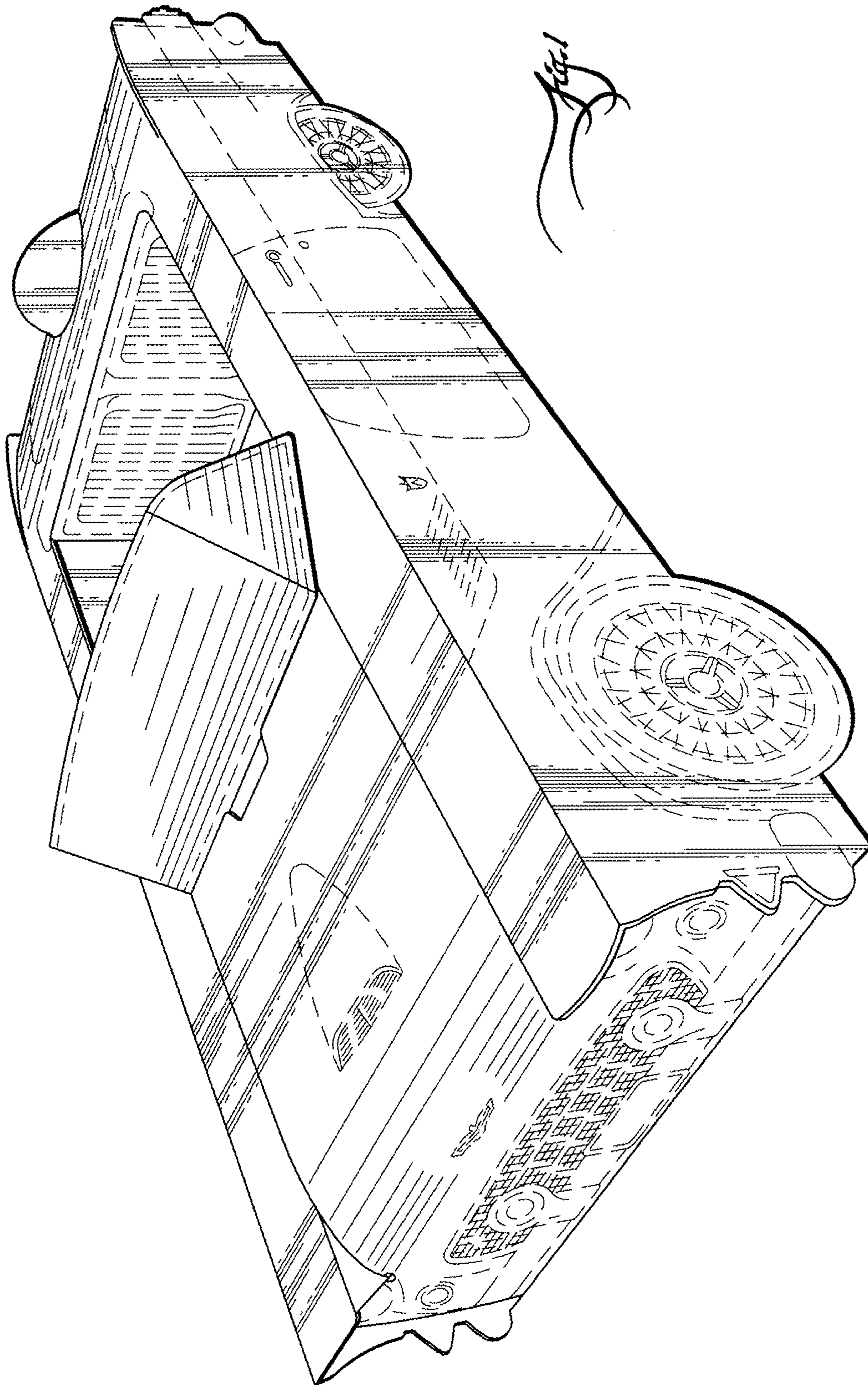

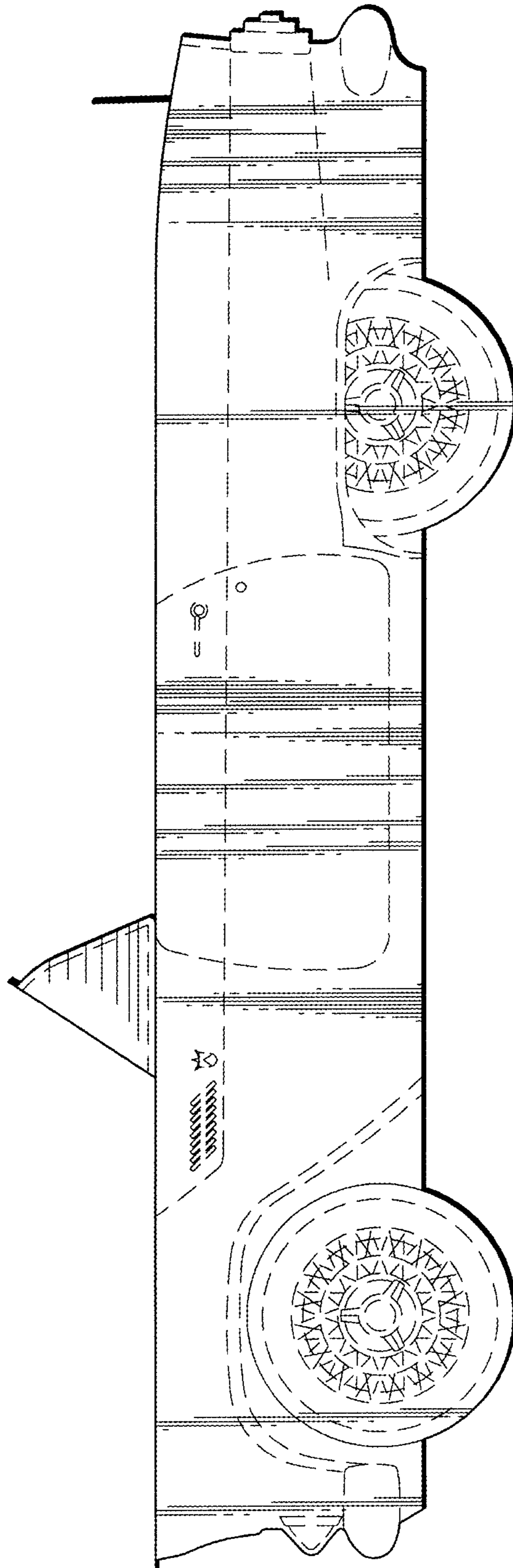

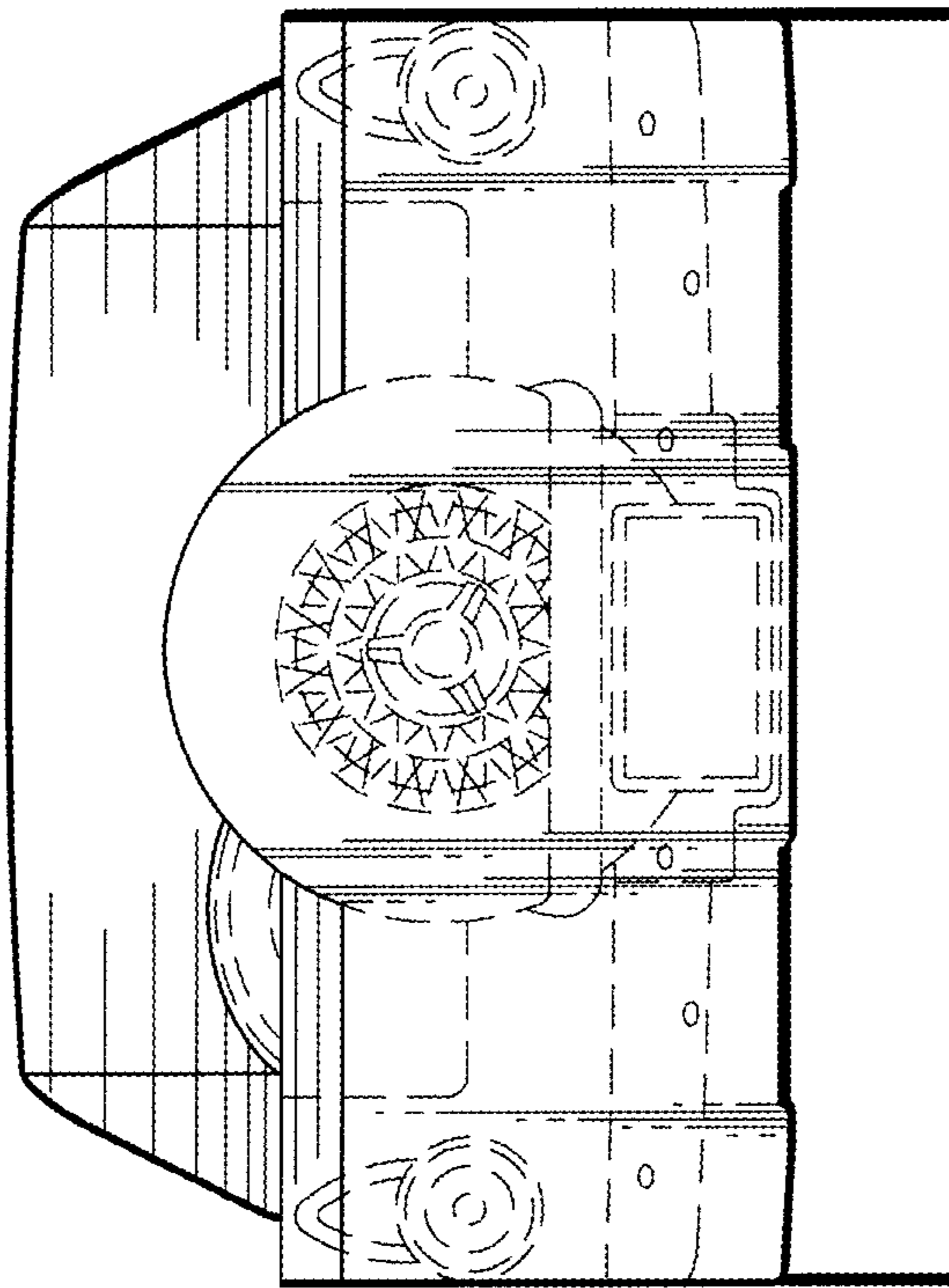

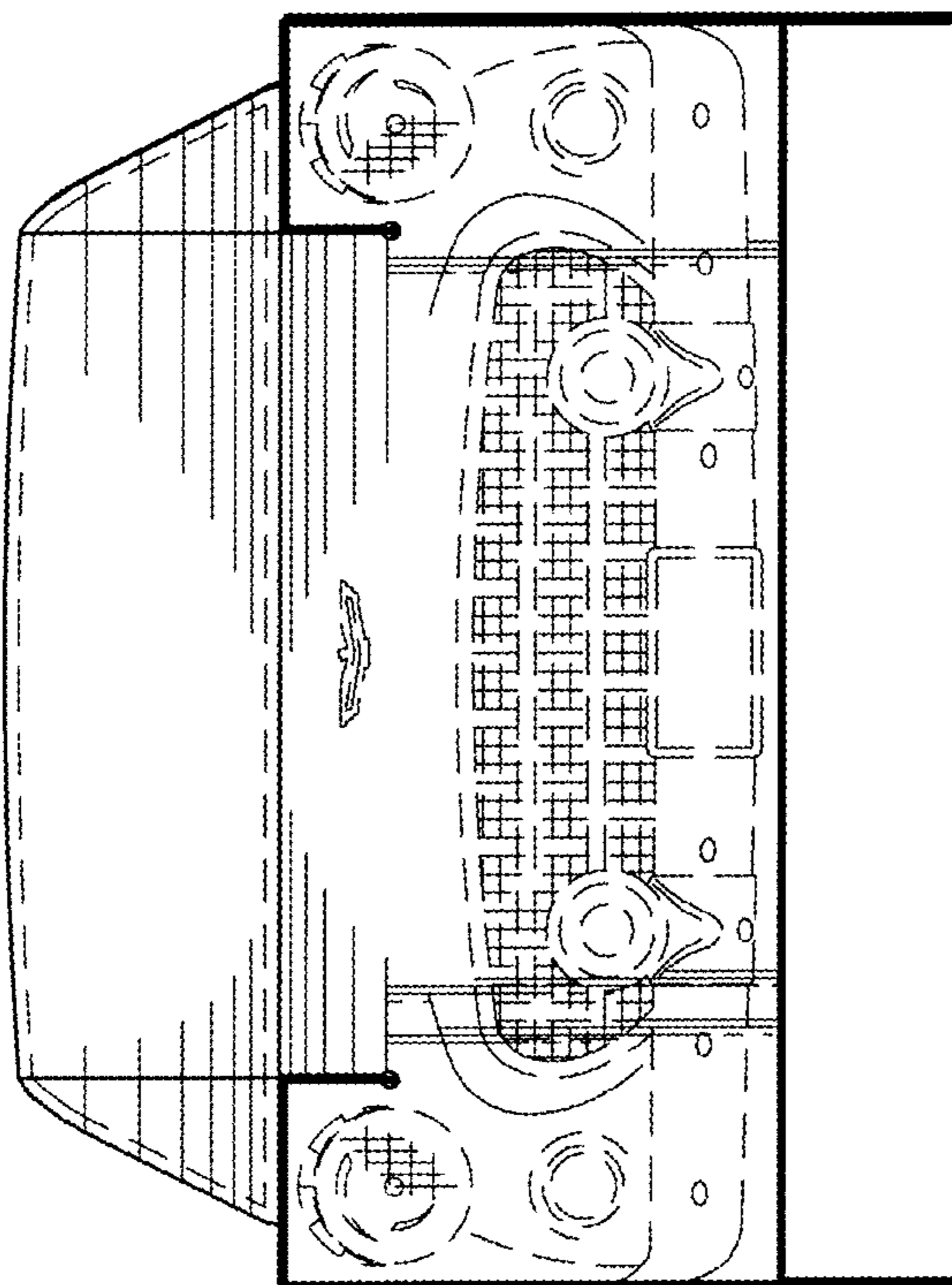

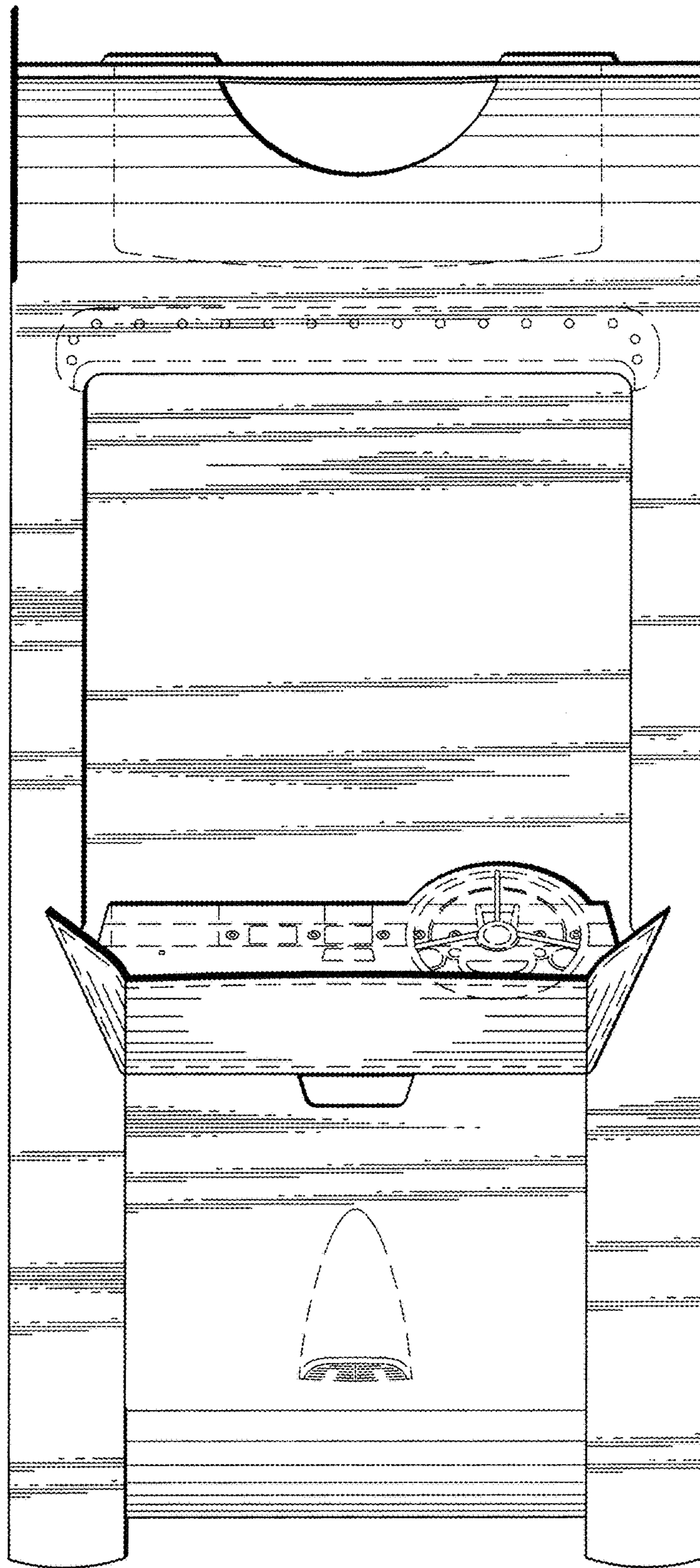

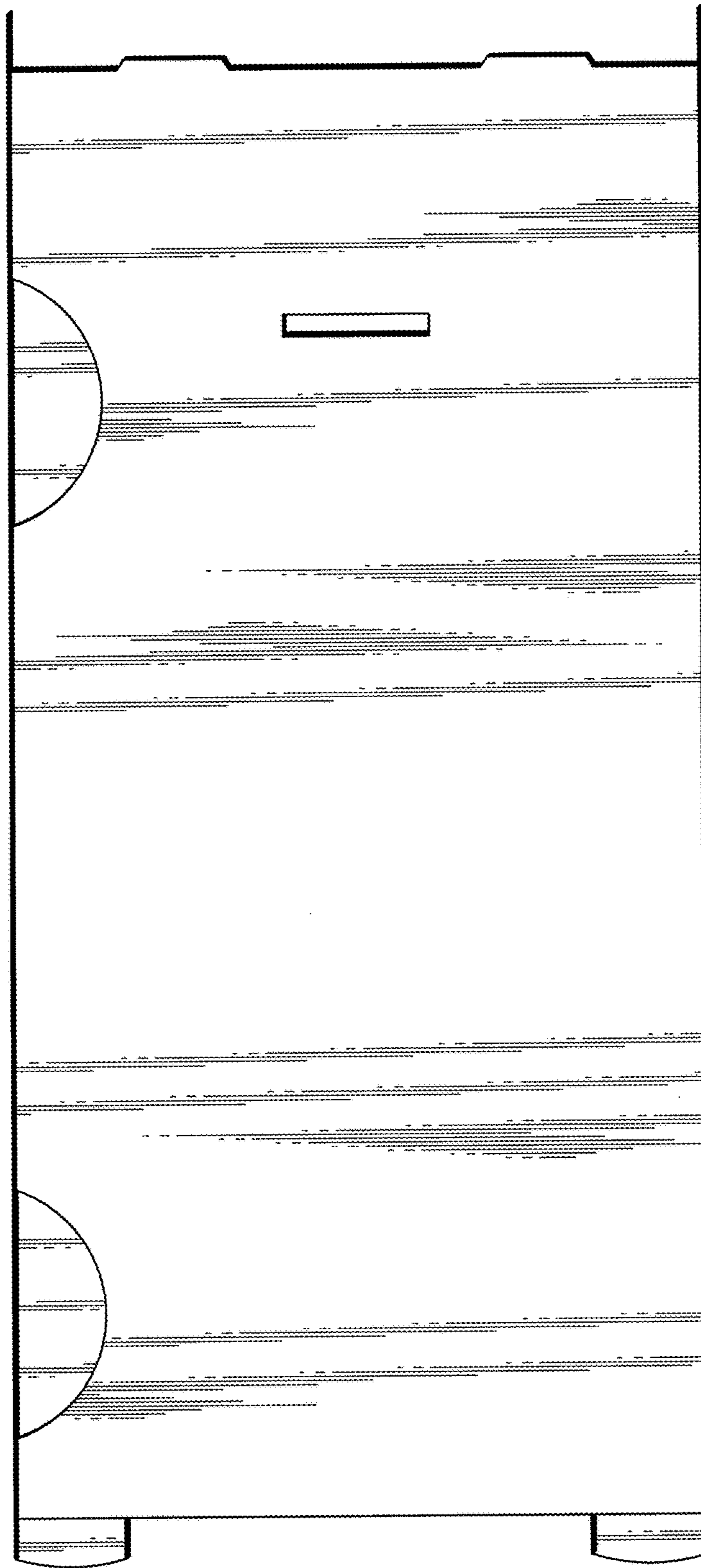
