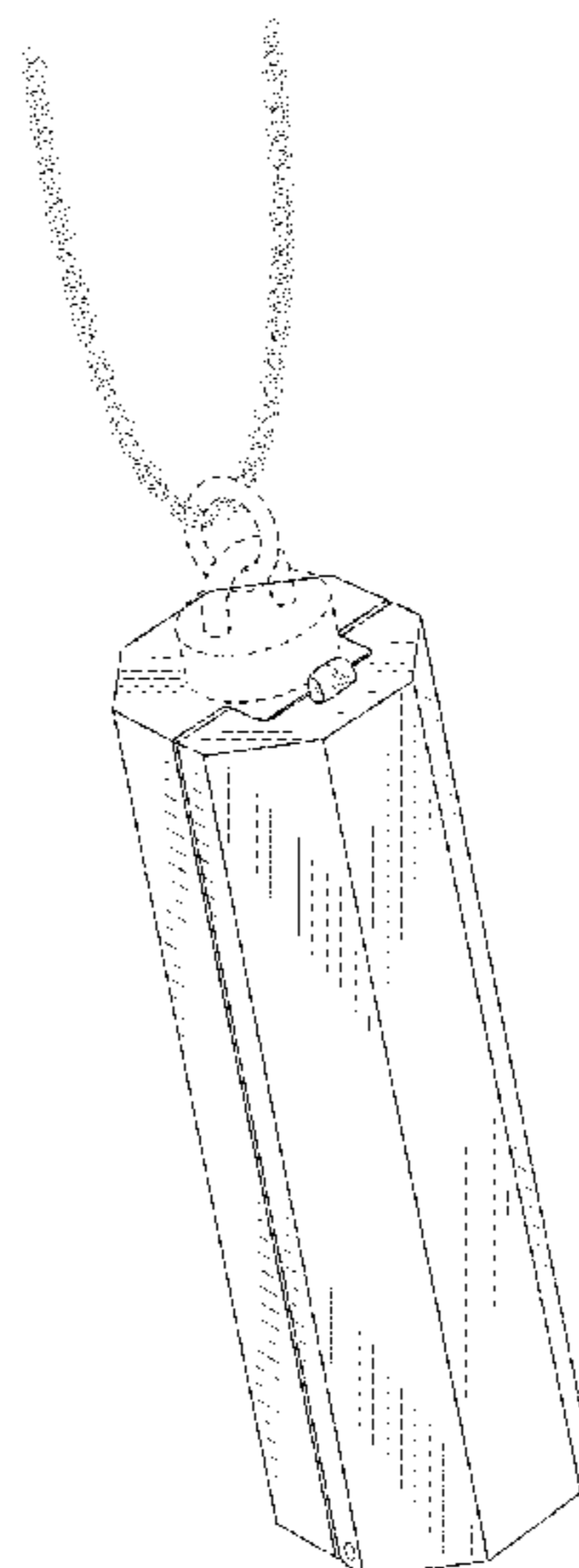

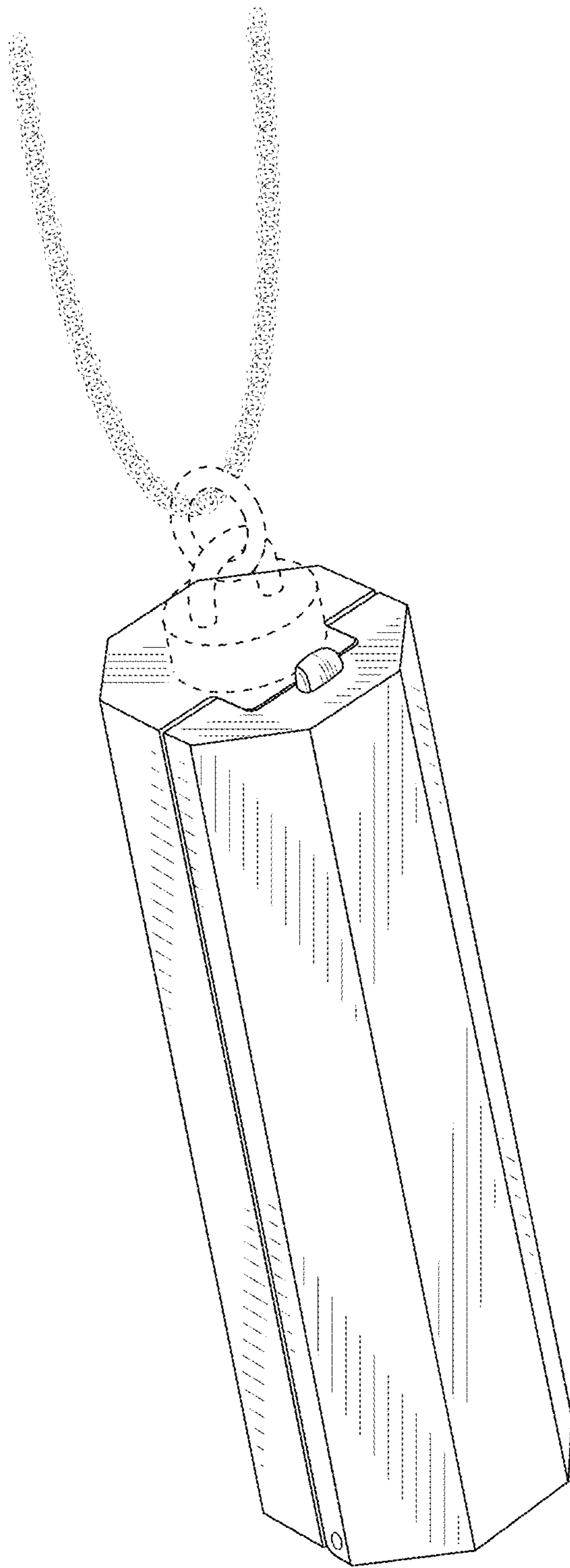
The ornamental design for a pendant necklace, as shown and described.

**DESCRIPTION**

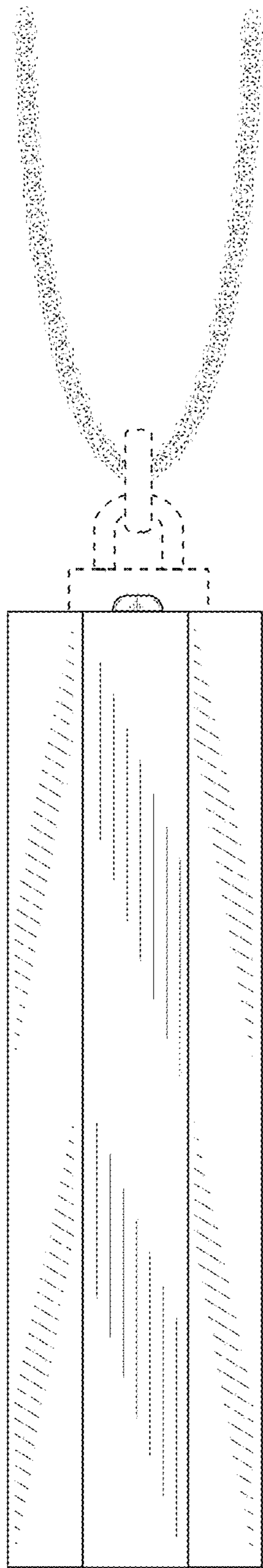
FIG. 1 is a front perspective view of a pendant necklace according to my design;

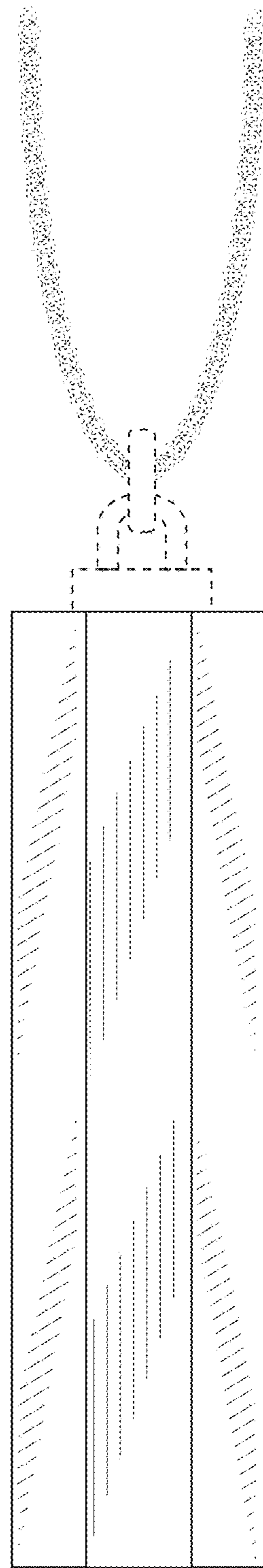




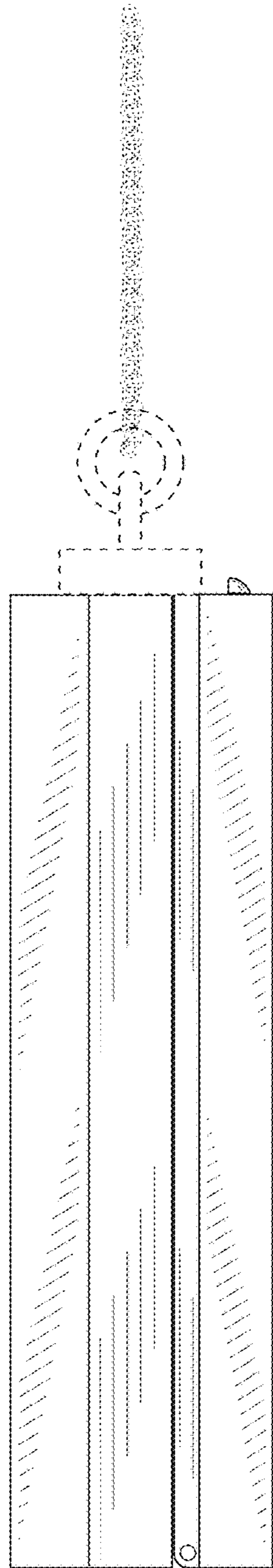

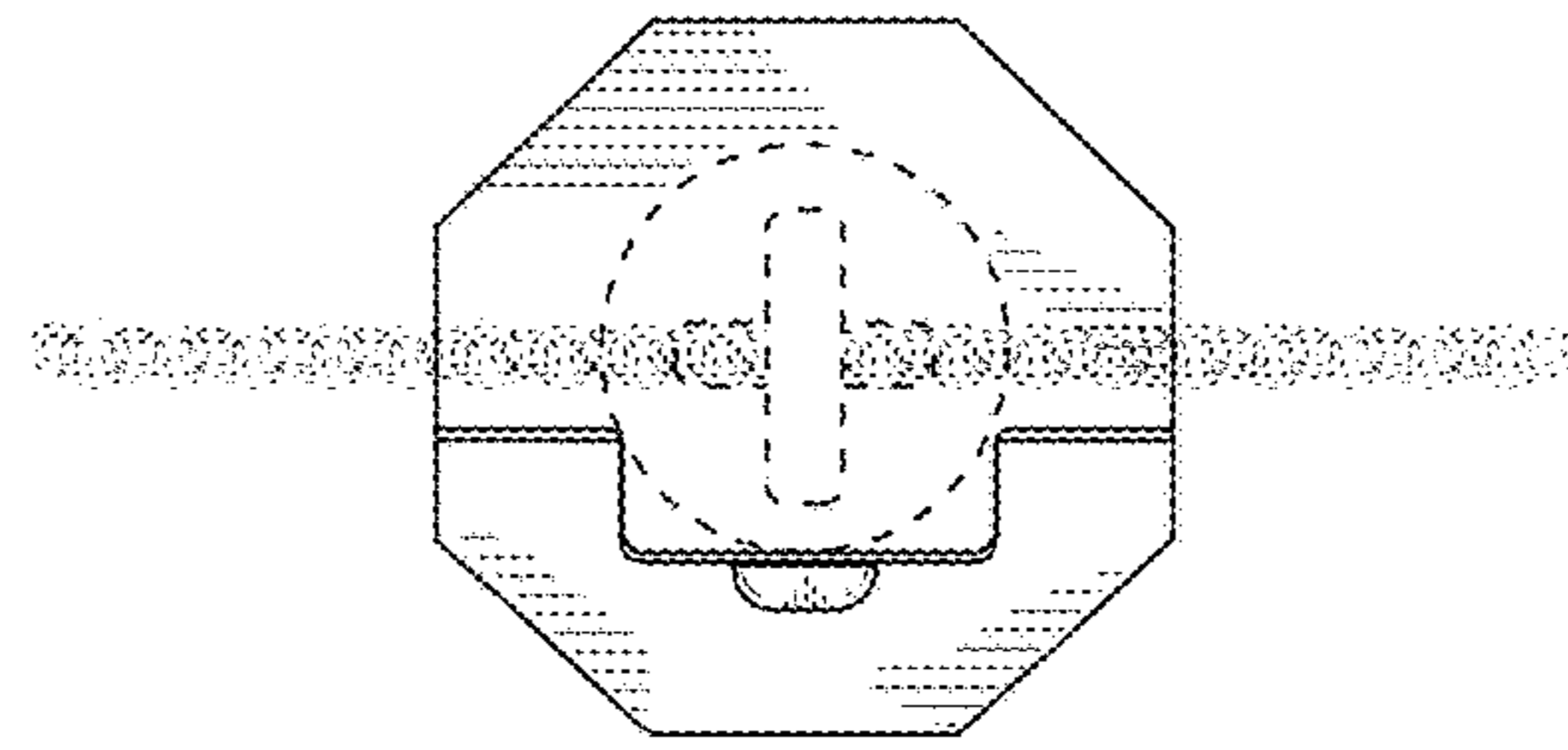

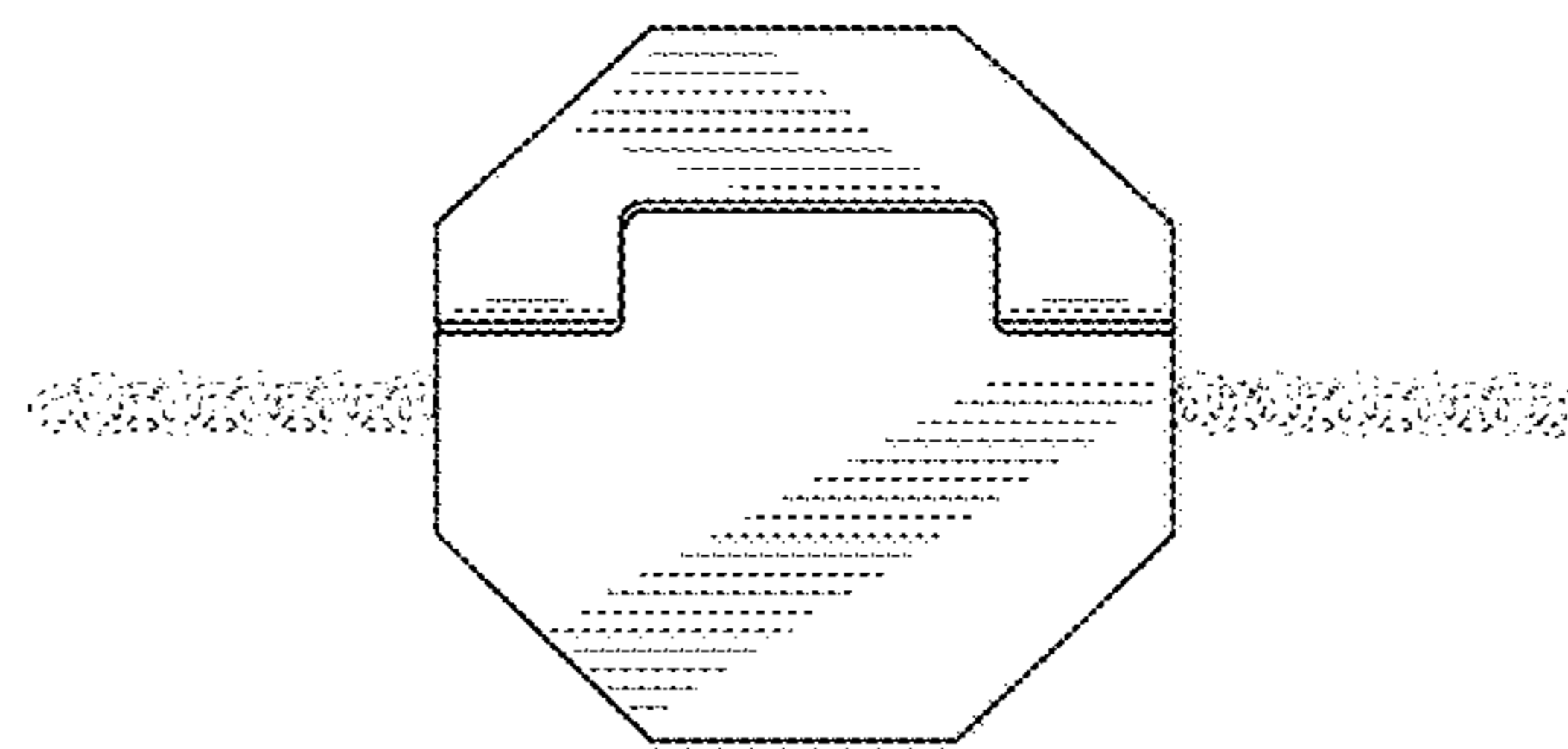
