(57) **CLAIM**

The ornamental design for a front bumper for automobiles, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a front bumper for automobiles showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view thereof; and, FIG. 5 is front and left side perspective view thereof. The broken lines in the drawings illustrate portions of the front bumper for automobiles that forms no part of the claimed design.

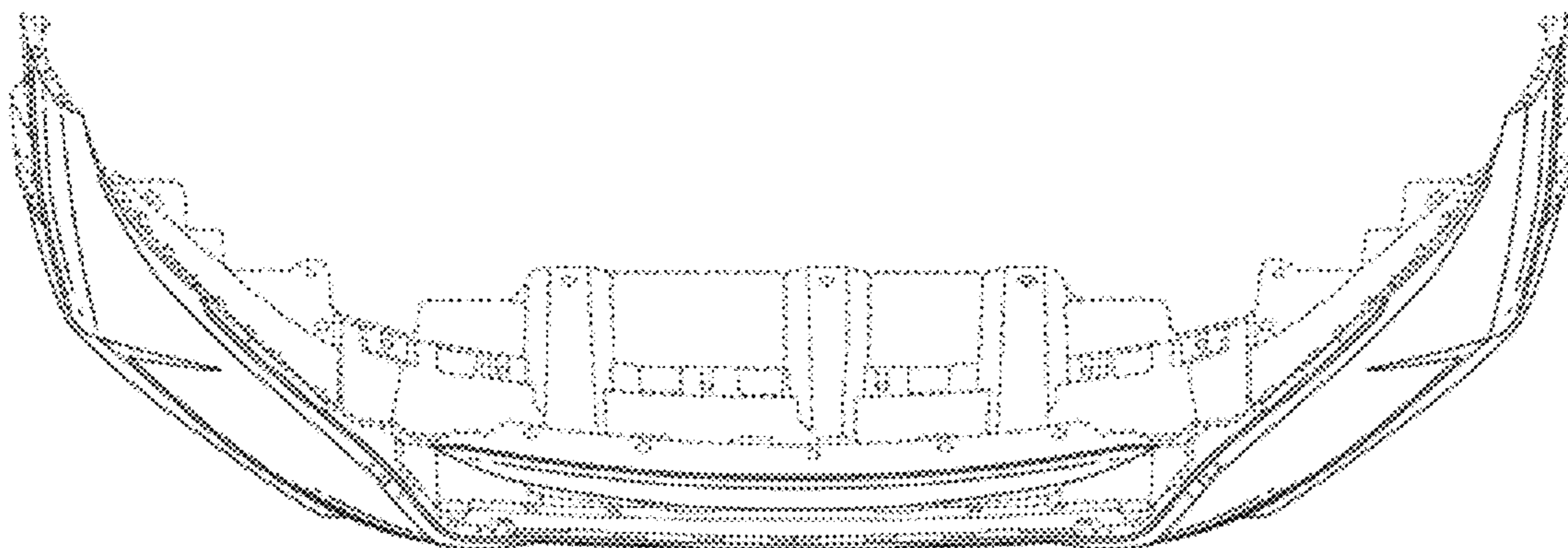

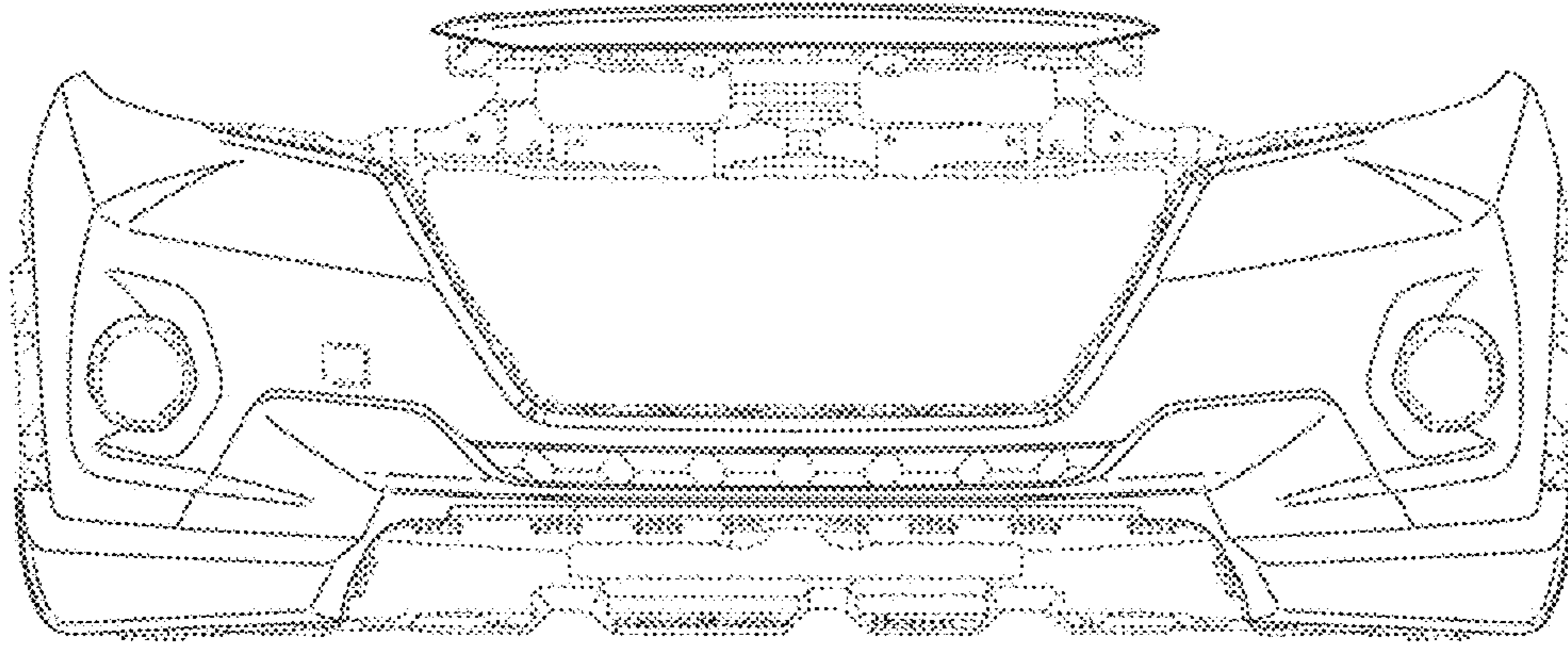

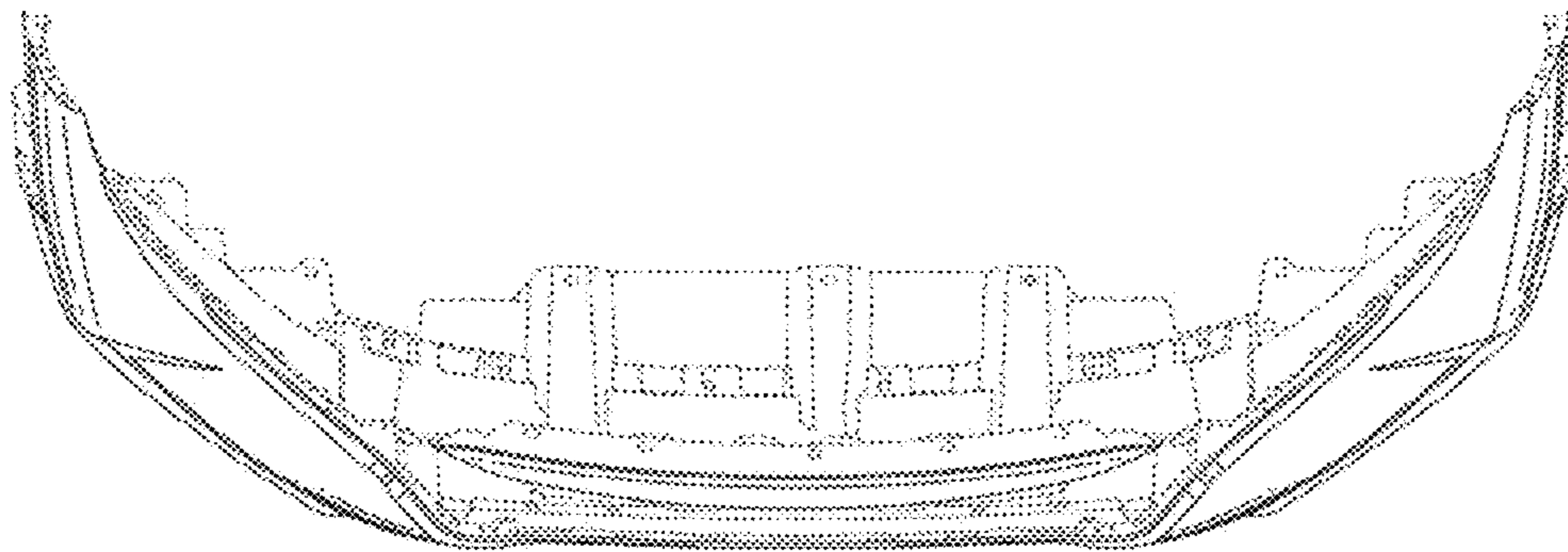

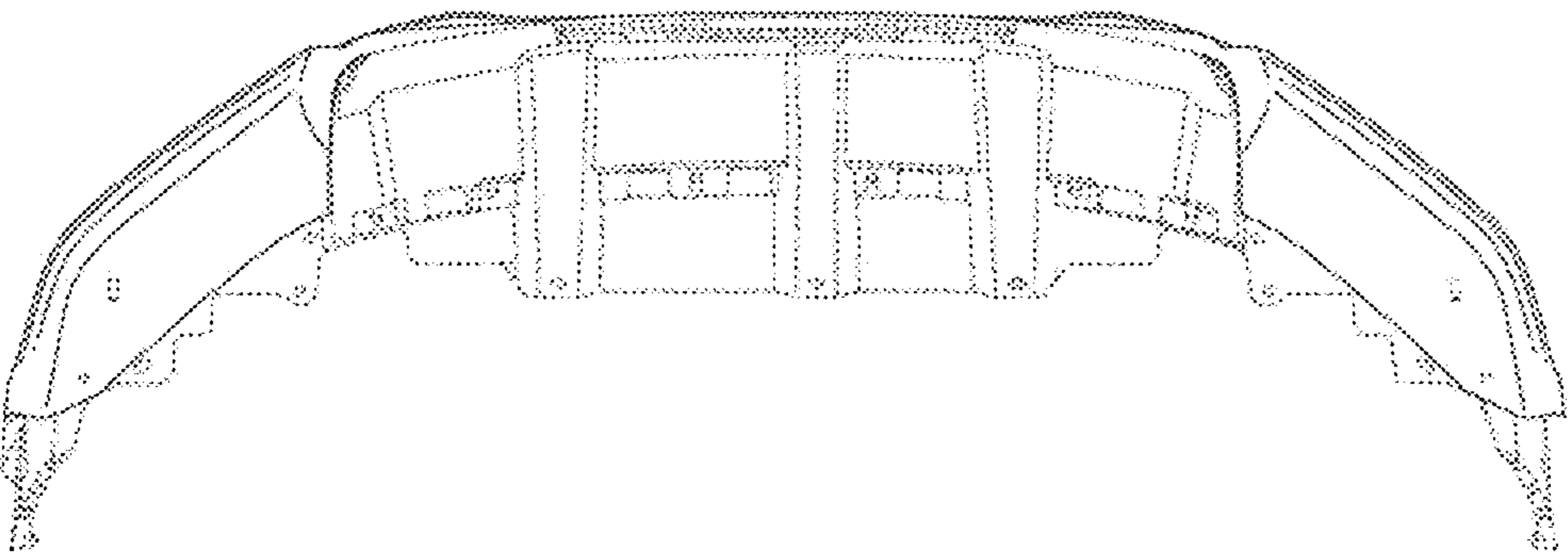

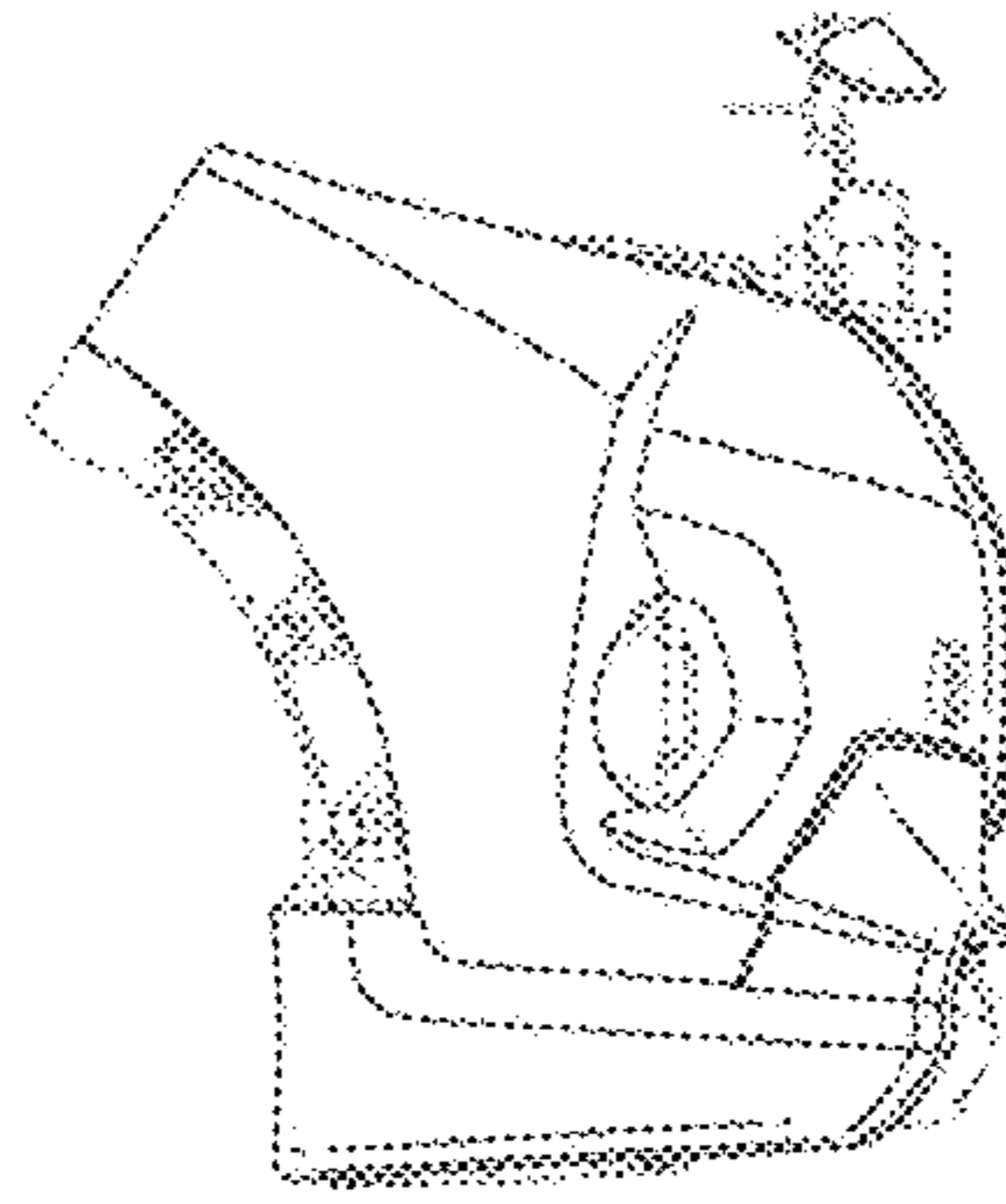
