The ornamental design for a device for control of electric power, as shown and described.

**DESCRIPTION**

FIG. 1 illustrates a right side perspective view of a device for control of electric power of the present invention. FIG. 2 is a top, right side view of the device shown in FIG. 1. 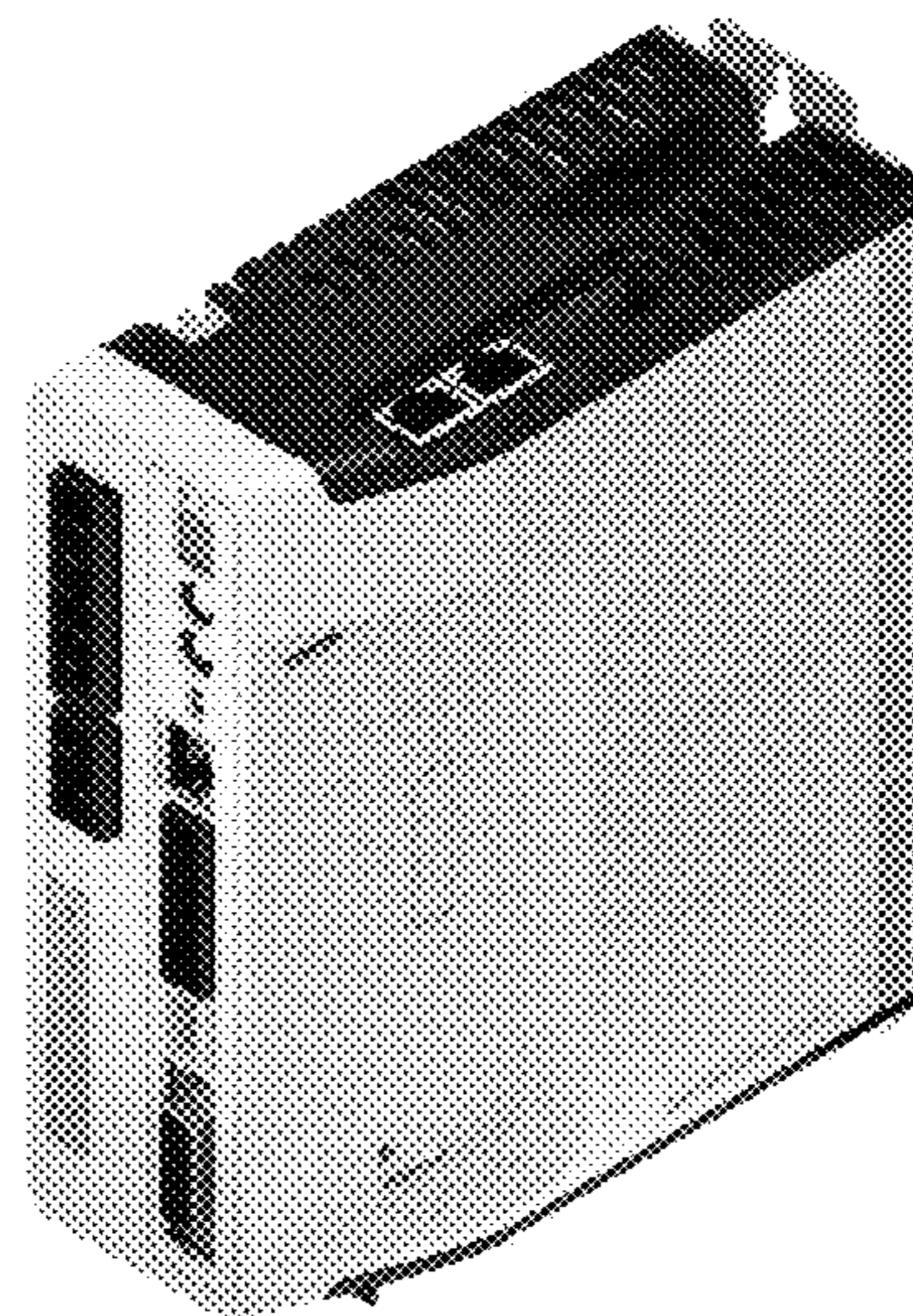

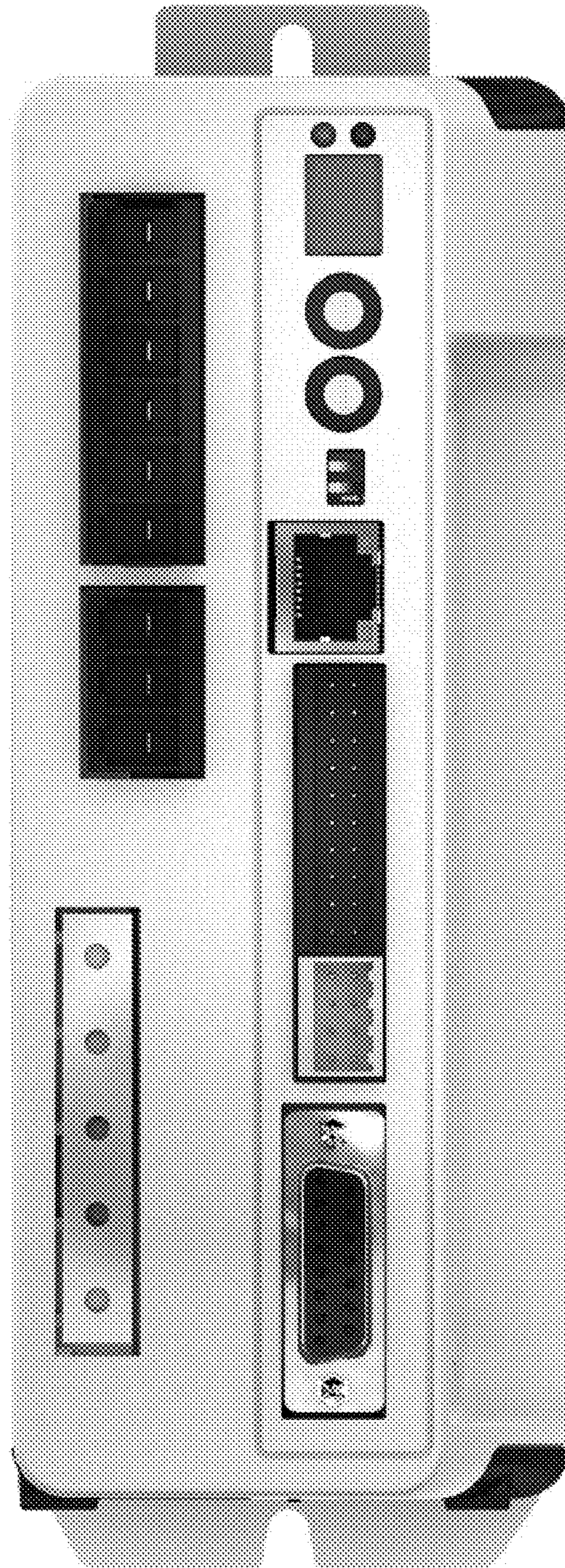

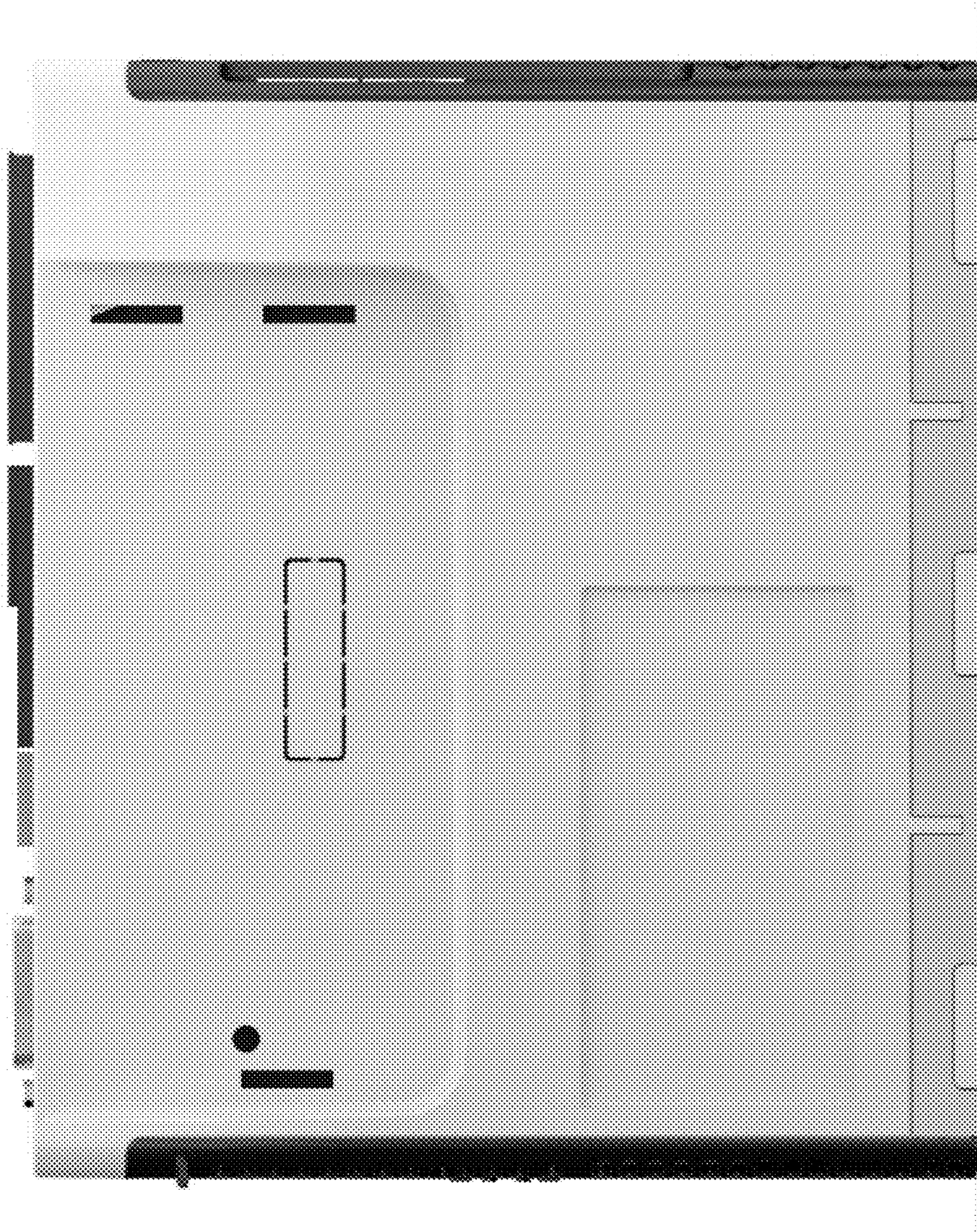

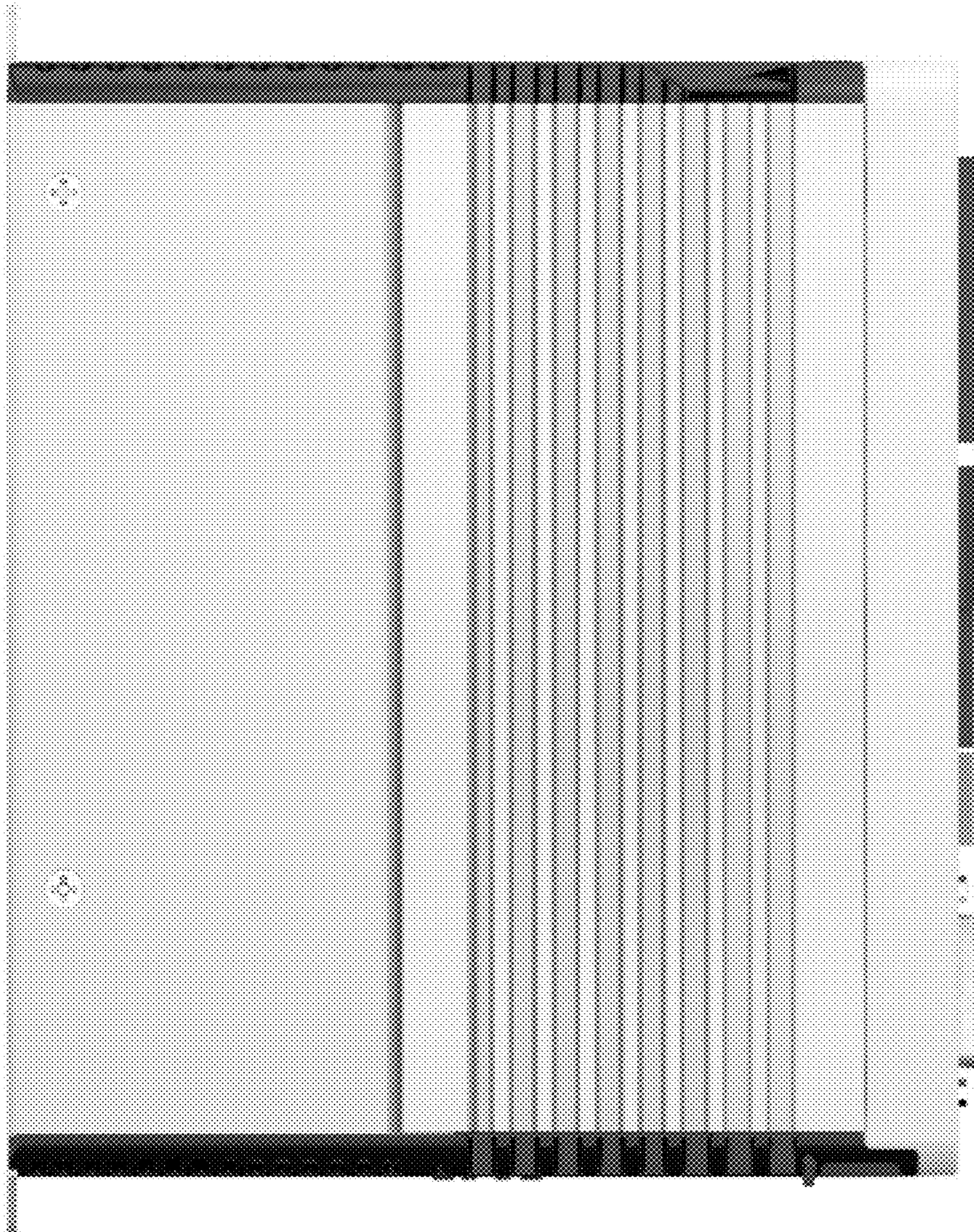

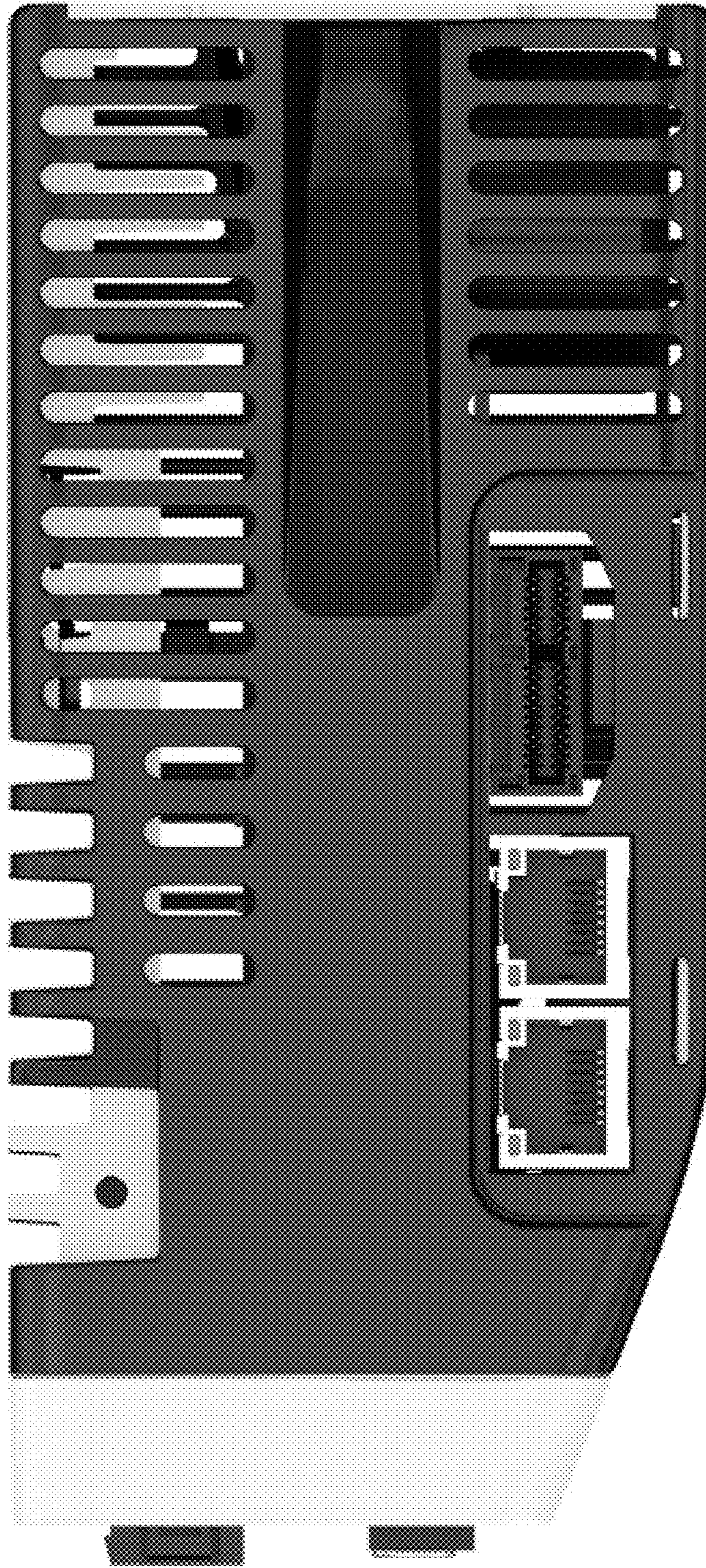

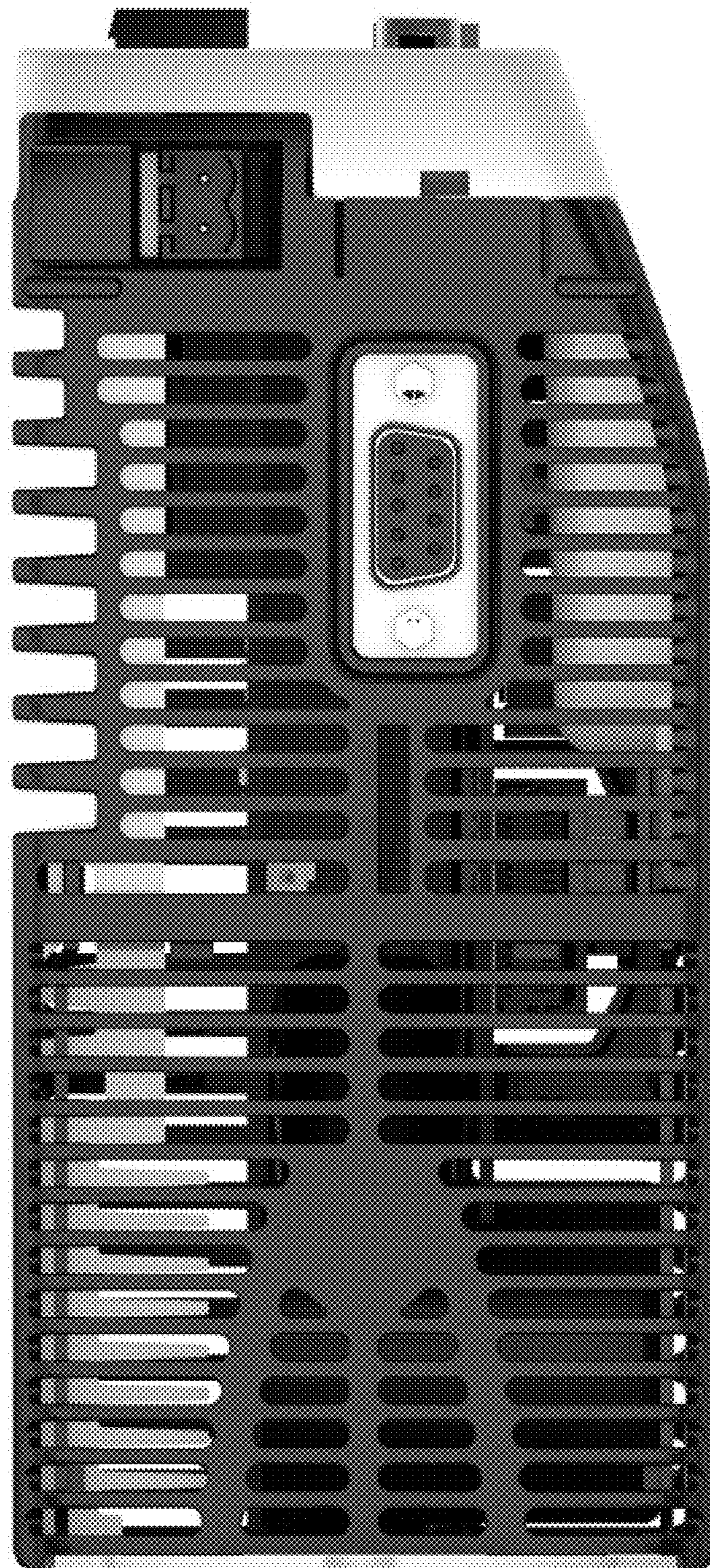

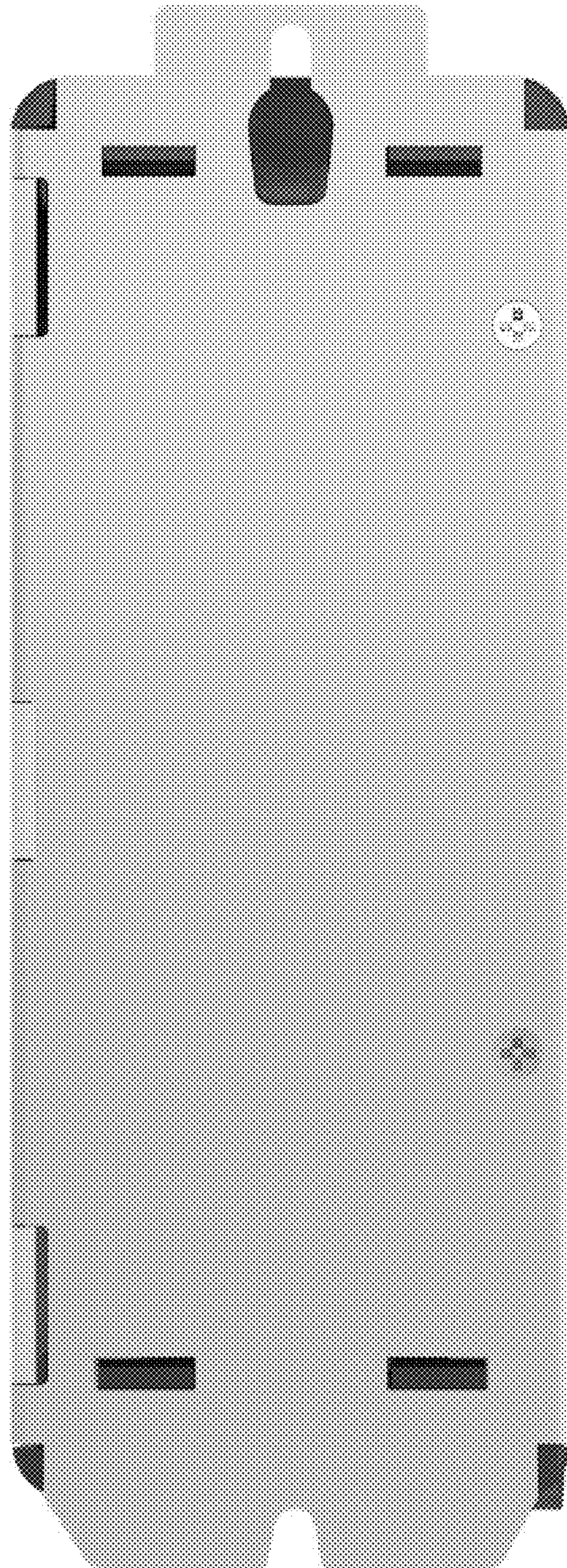
