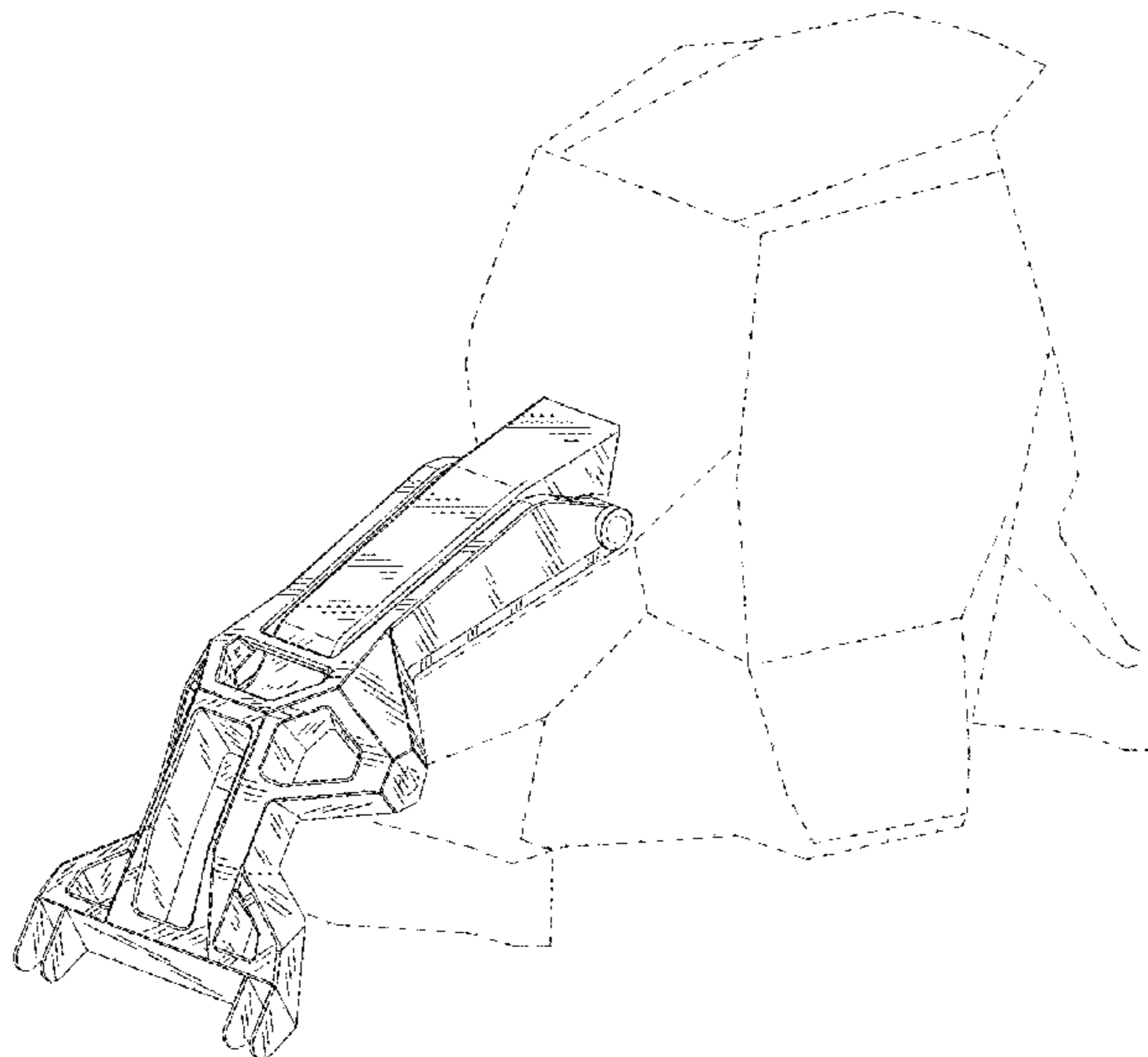
(57) **CLAIM**

The ornamental design for a loader arm for a work vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side and top perspective view of a loader arm for a work vehicle showing in our new design. FIG. 2 is a left side elevation view thereof. FIG. 3 is a right side elevation view thereof. FIG. 4 is a front elevation view thereof. FIG. 5 is a rear elevation view thereof. FIG. 6 is a top elevation view thereof; and, FIG. 7 is a bottom elevation view thereof. The broken line representations of environmental structure in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

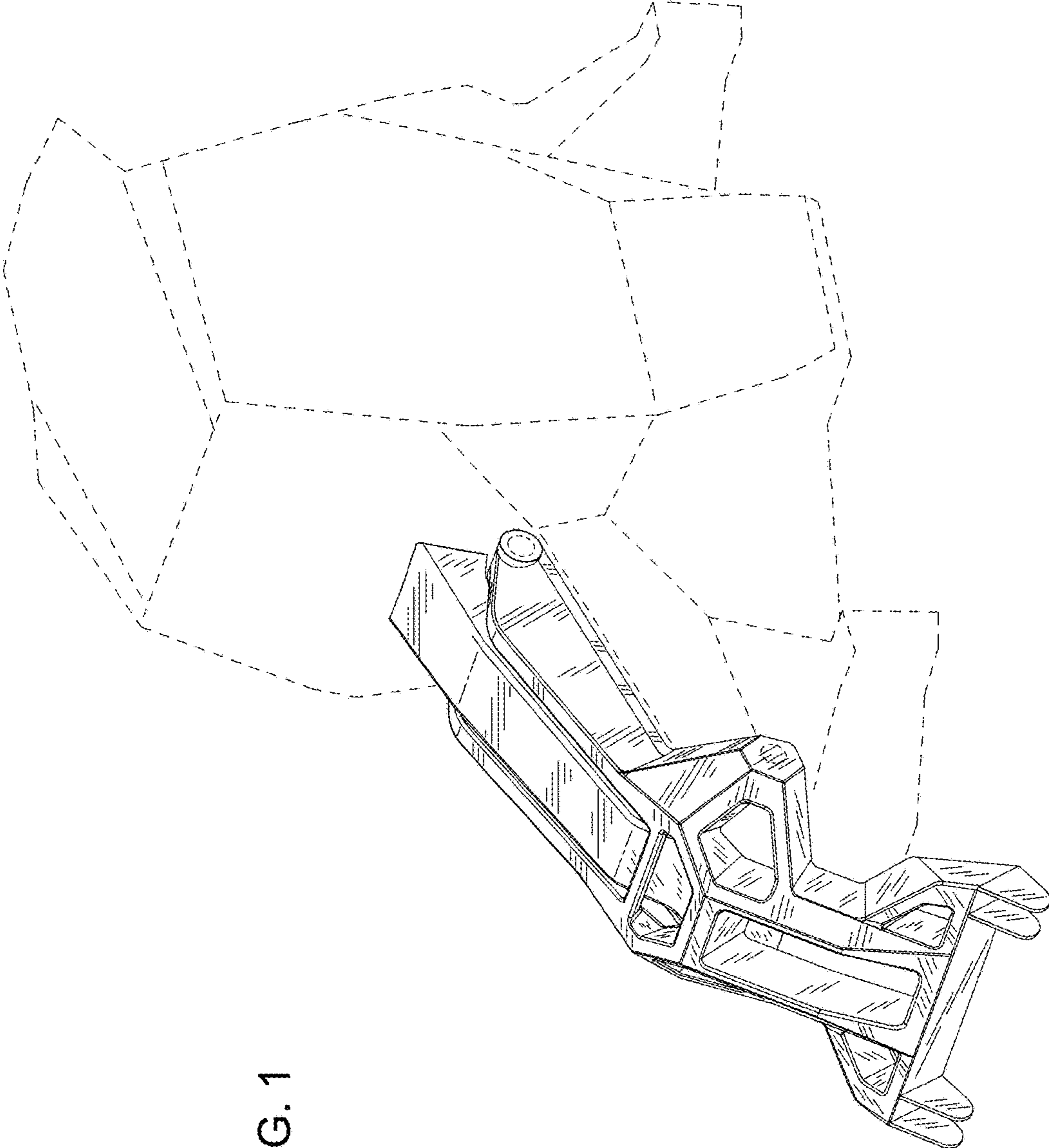

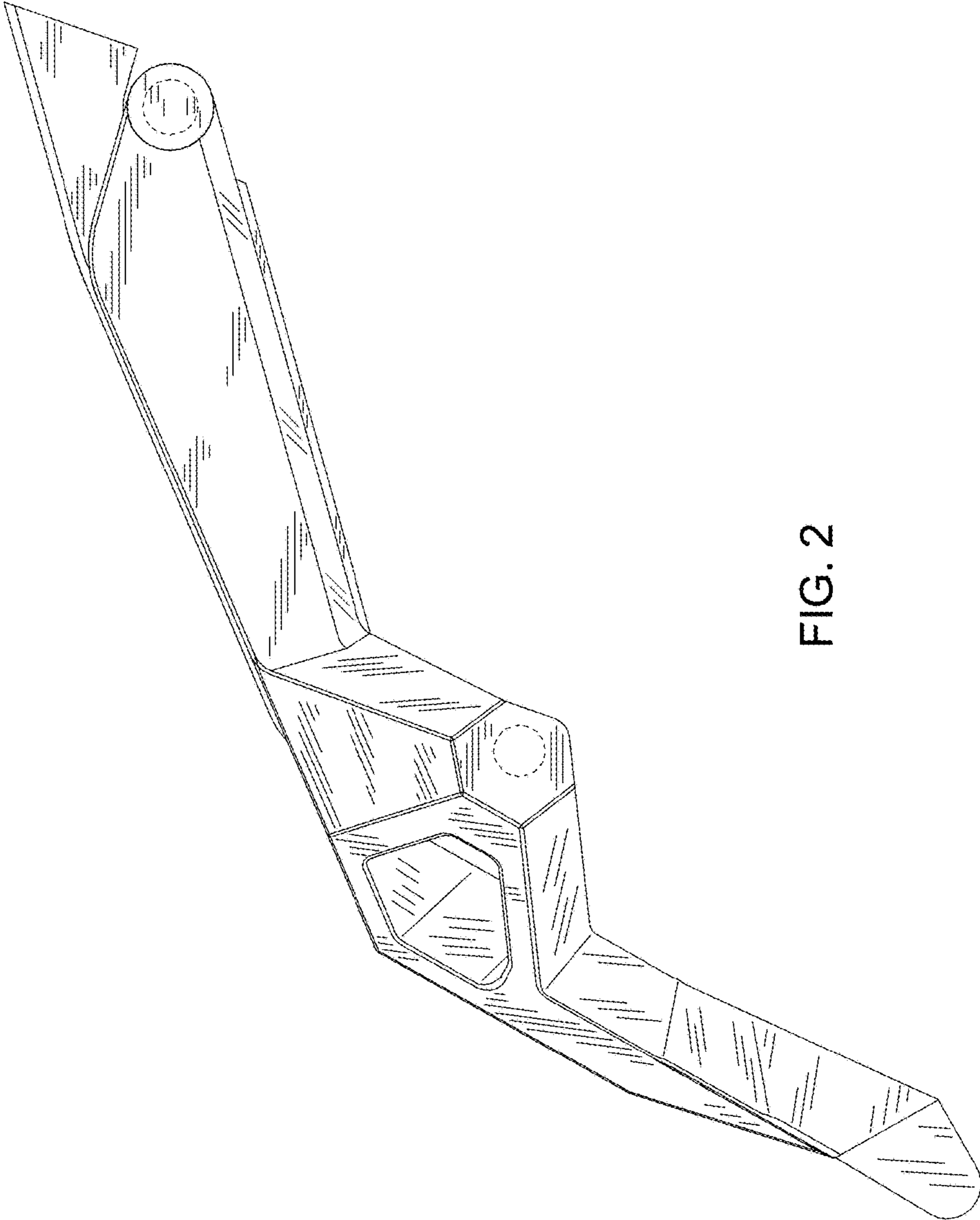

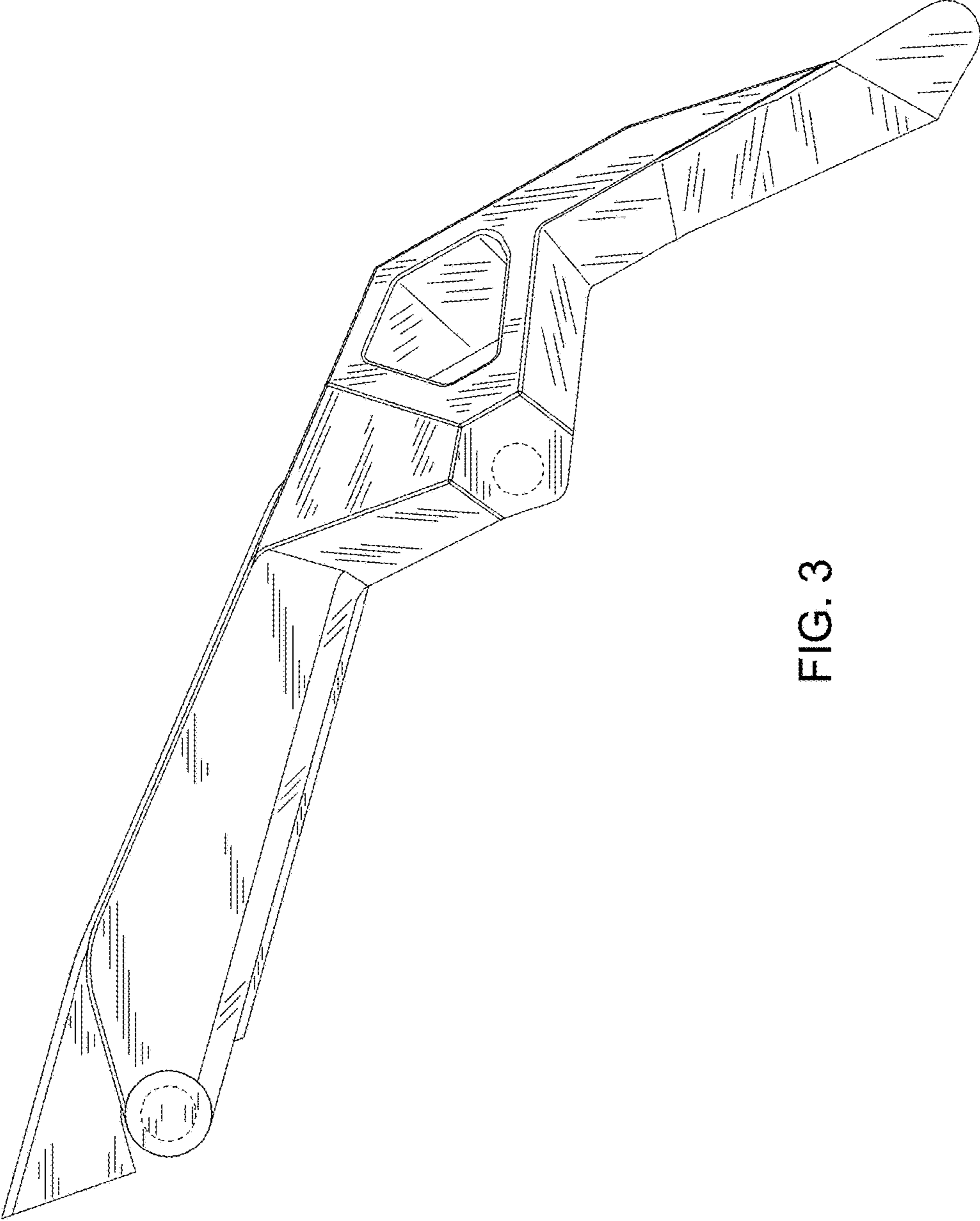

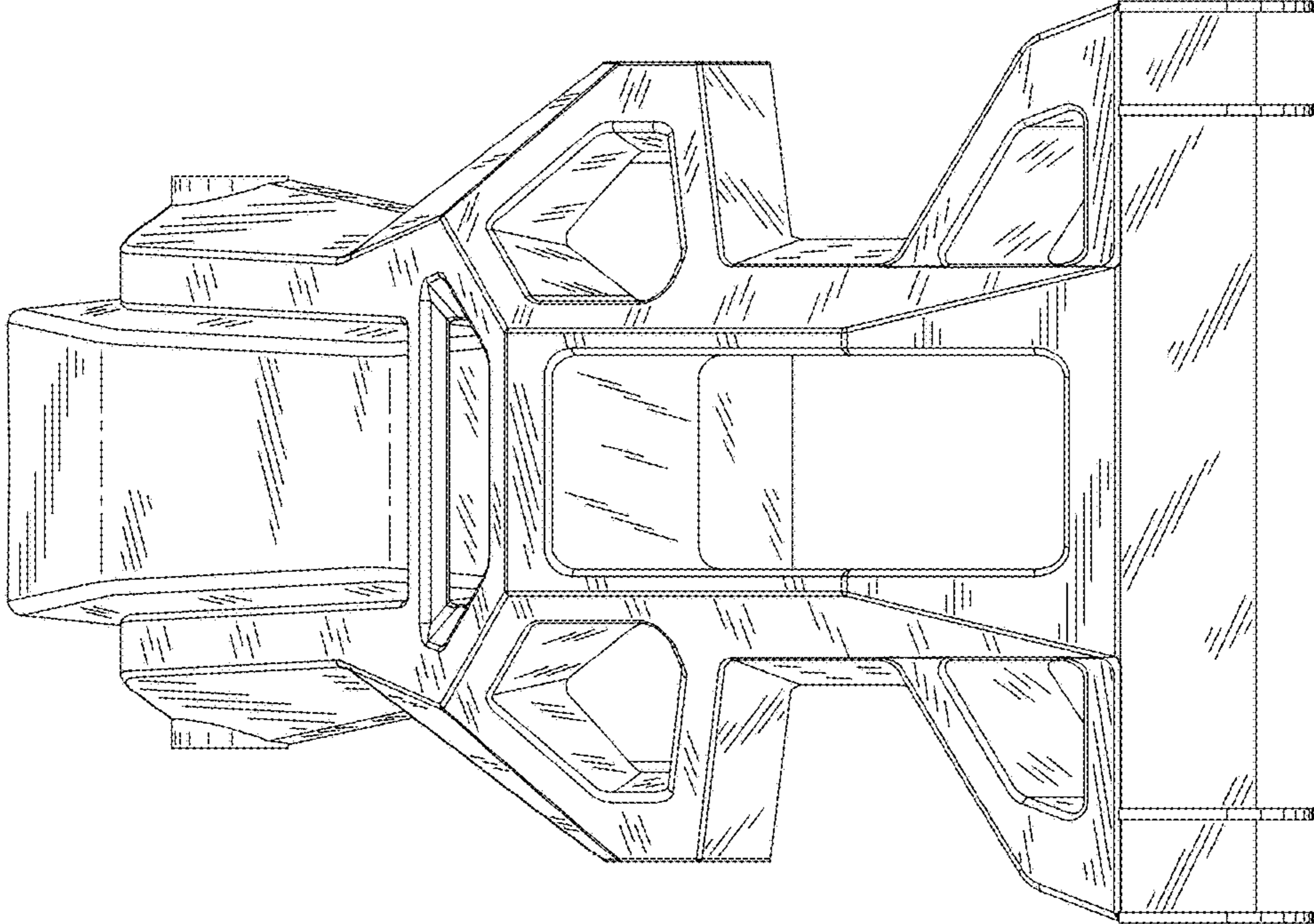

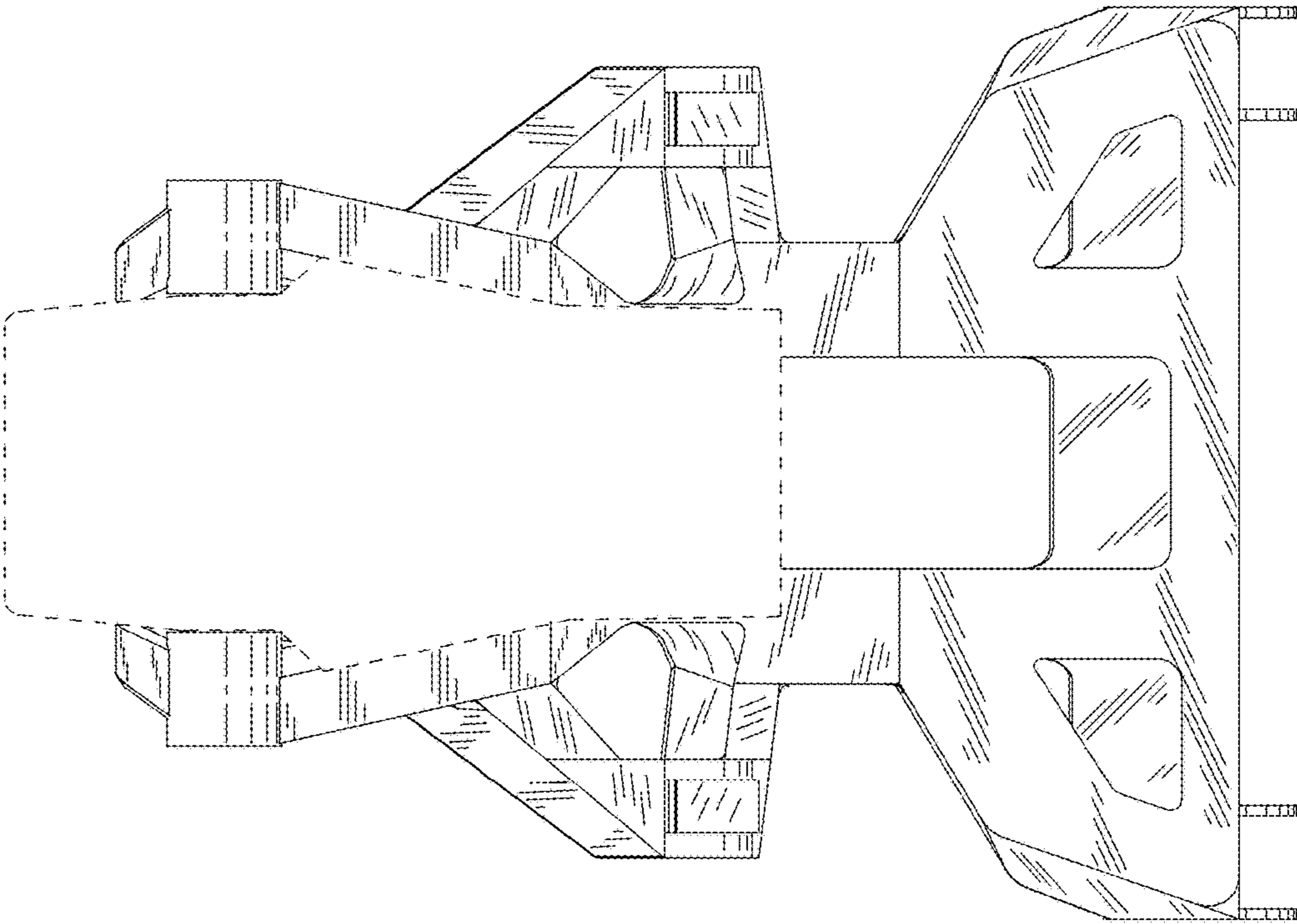

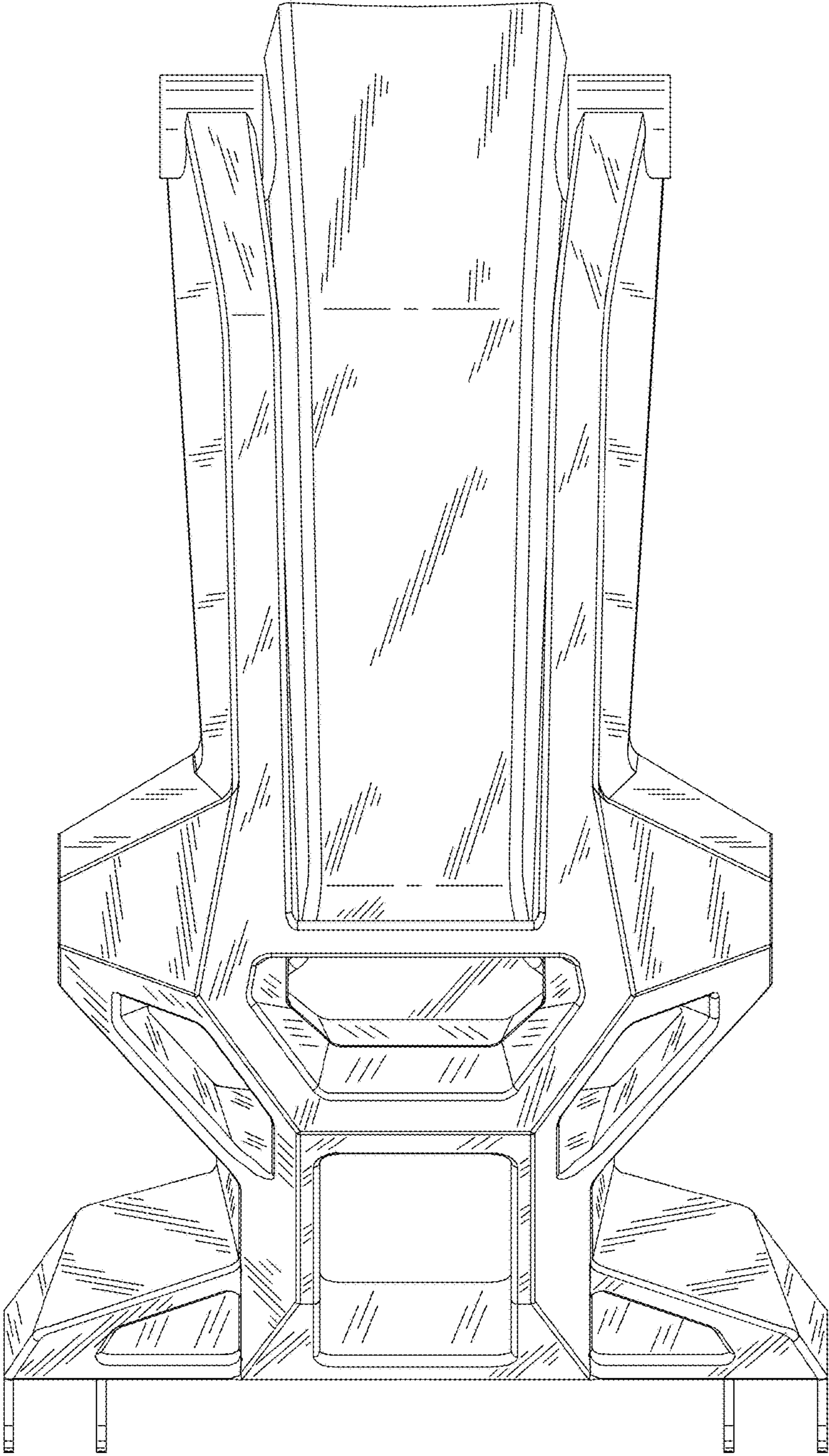

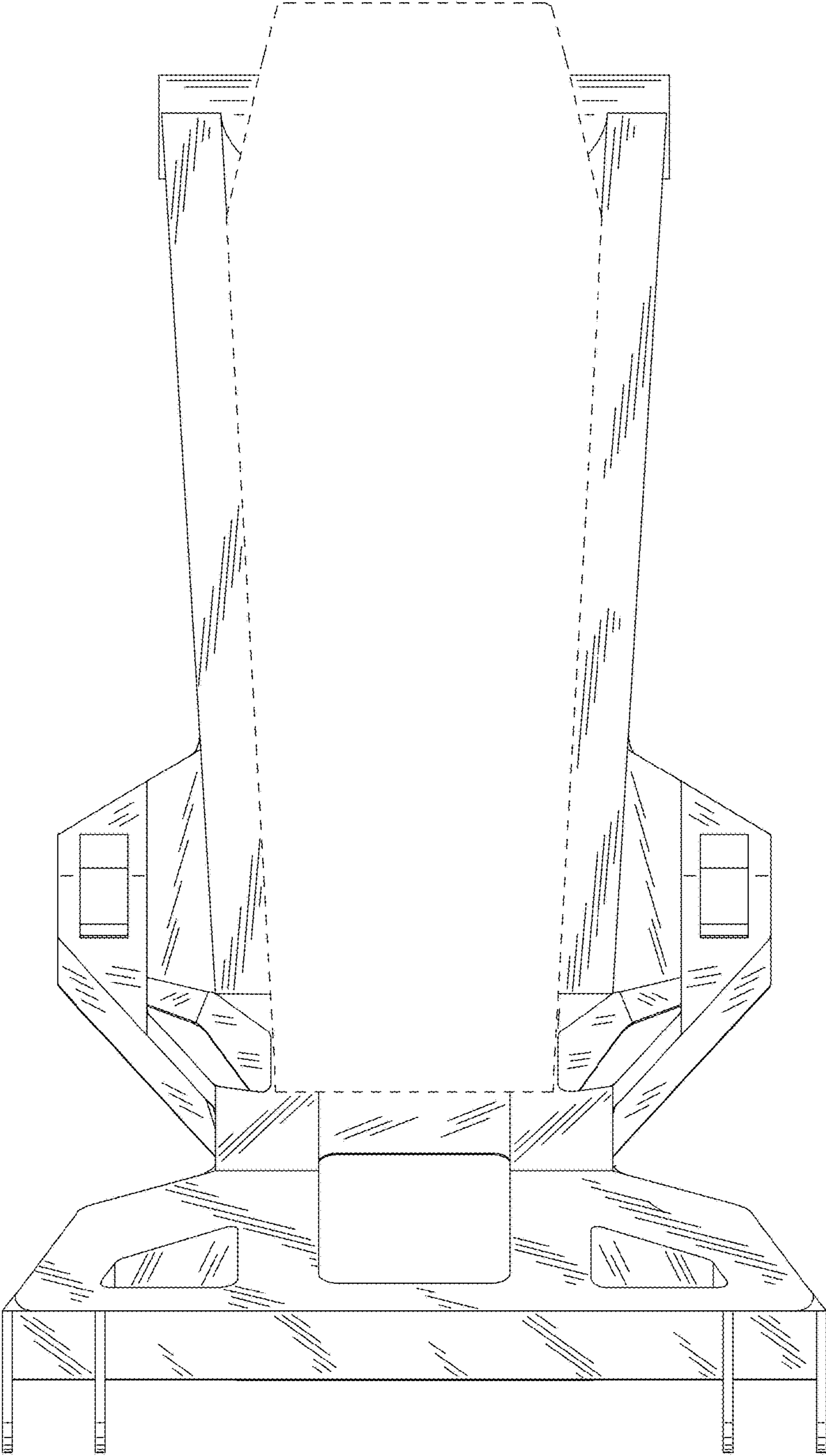
