(57) **CLAIM**

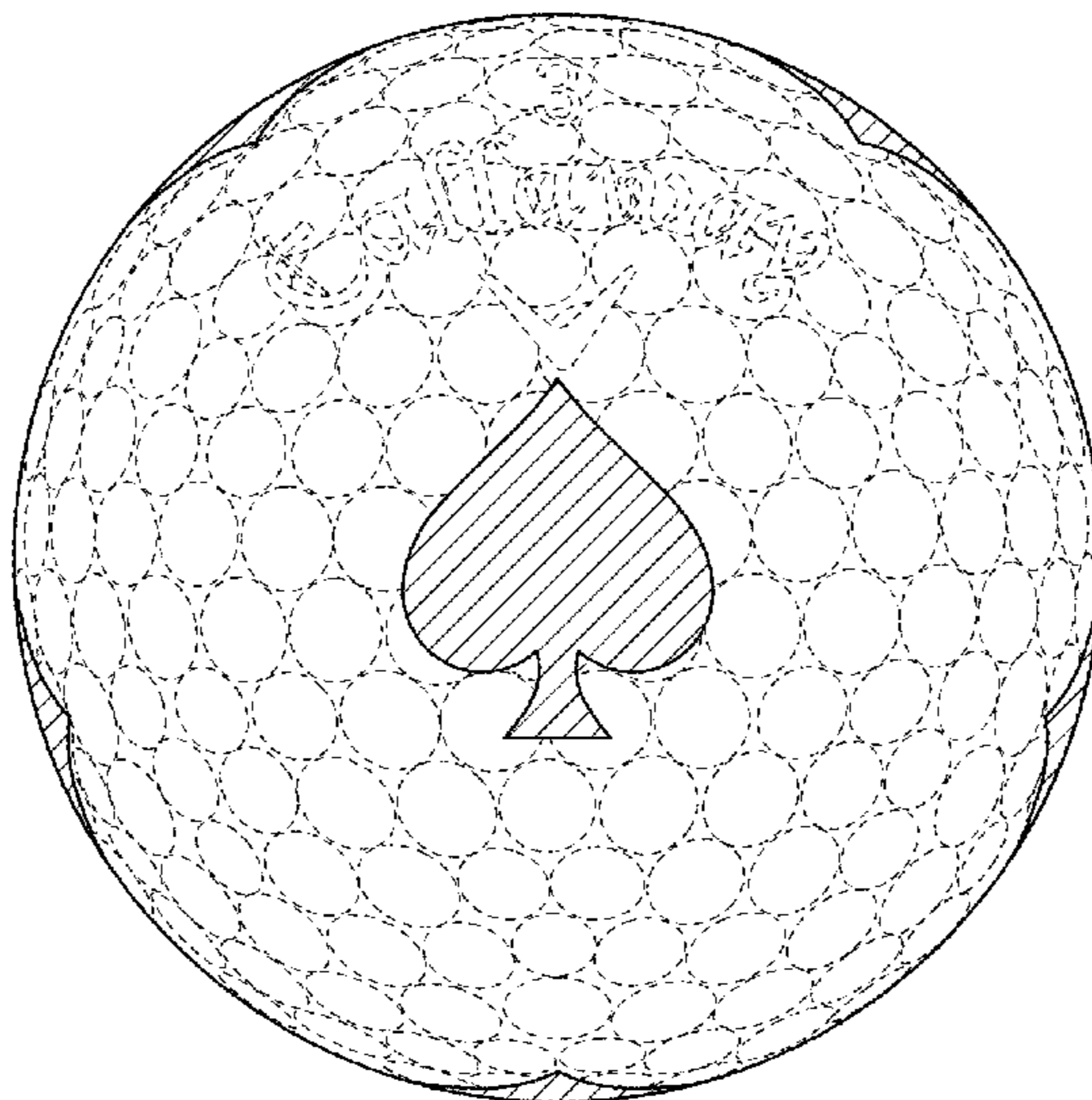
The ornamental design for a golf ball, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a golf ball showing our new design;
 FIG. 2 is bottom plan view of FIG. 1;
 FIG. 3 is a front elevation view of FIG. 1;
 FIG. 4 is a rear elevation view of FIG. 1; and,
 FIG. 5 is a side elevation view of FIG. 1.
 The broken lines depict portions of a golf ball which form no part of the claimed design. The trademark "Callaway V" logo is a trademark of the Callaway Golf Company.

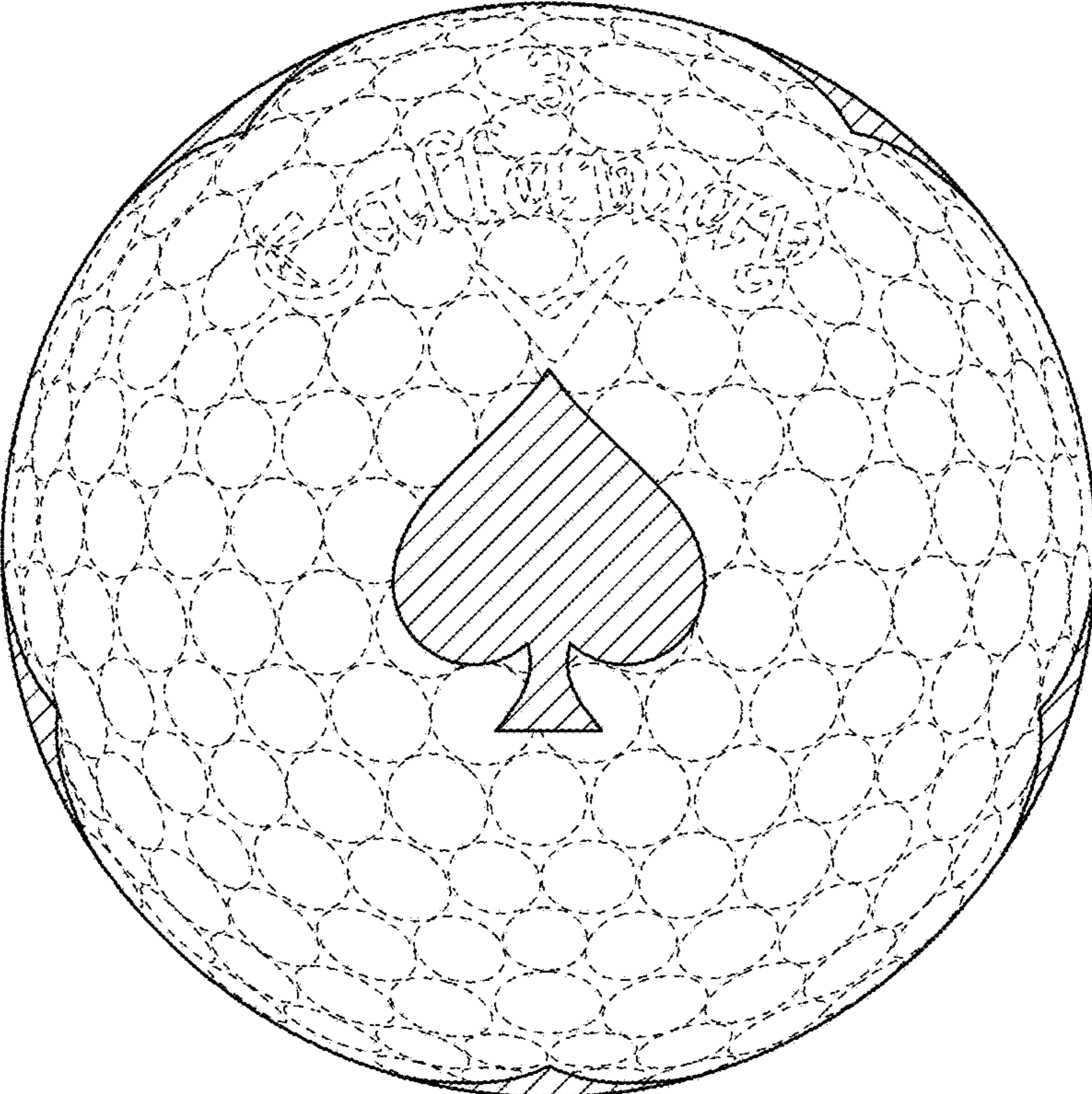

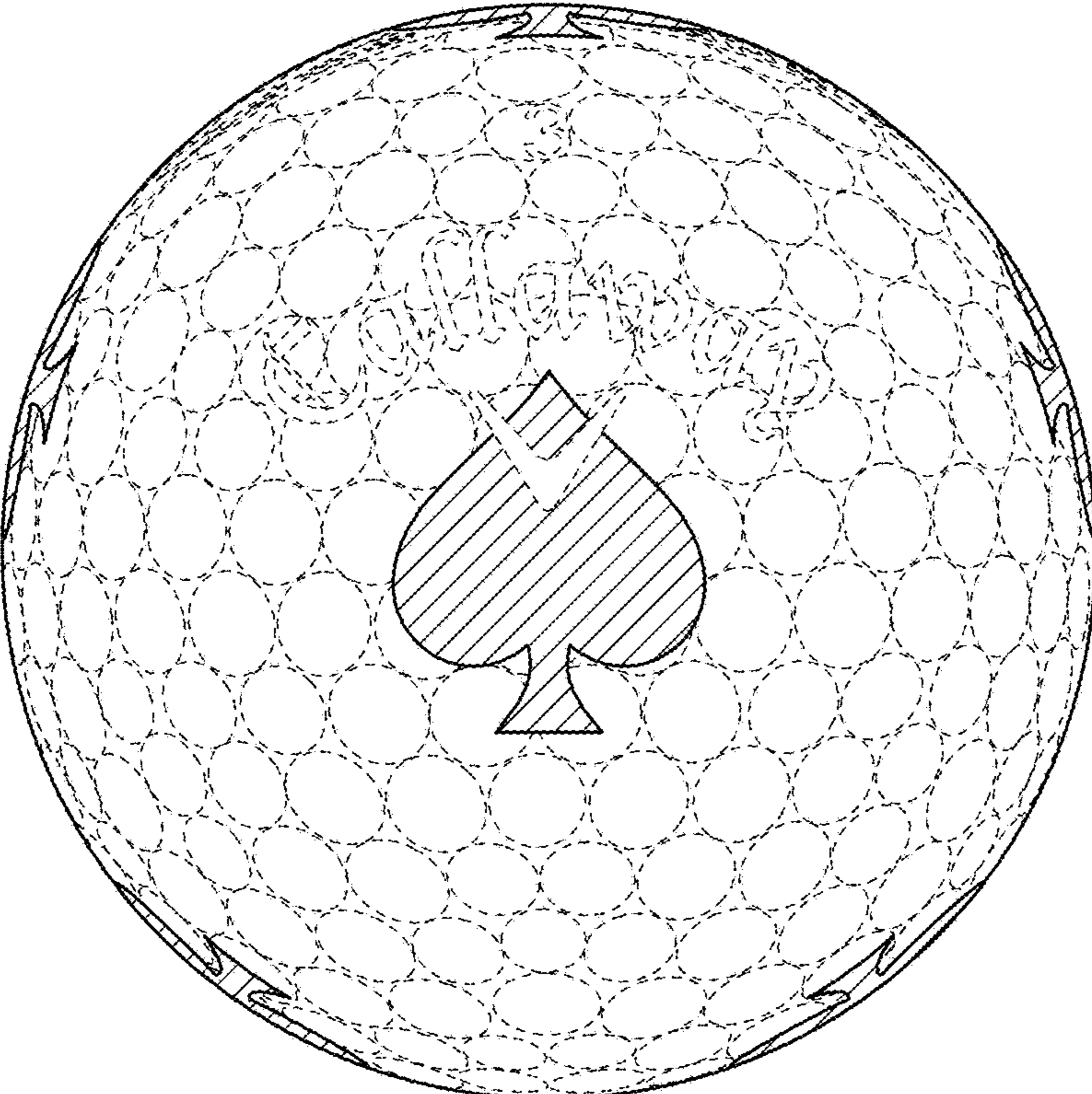

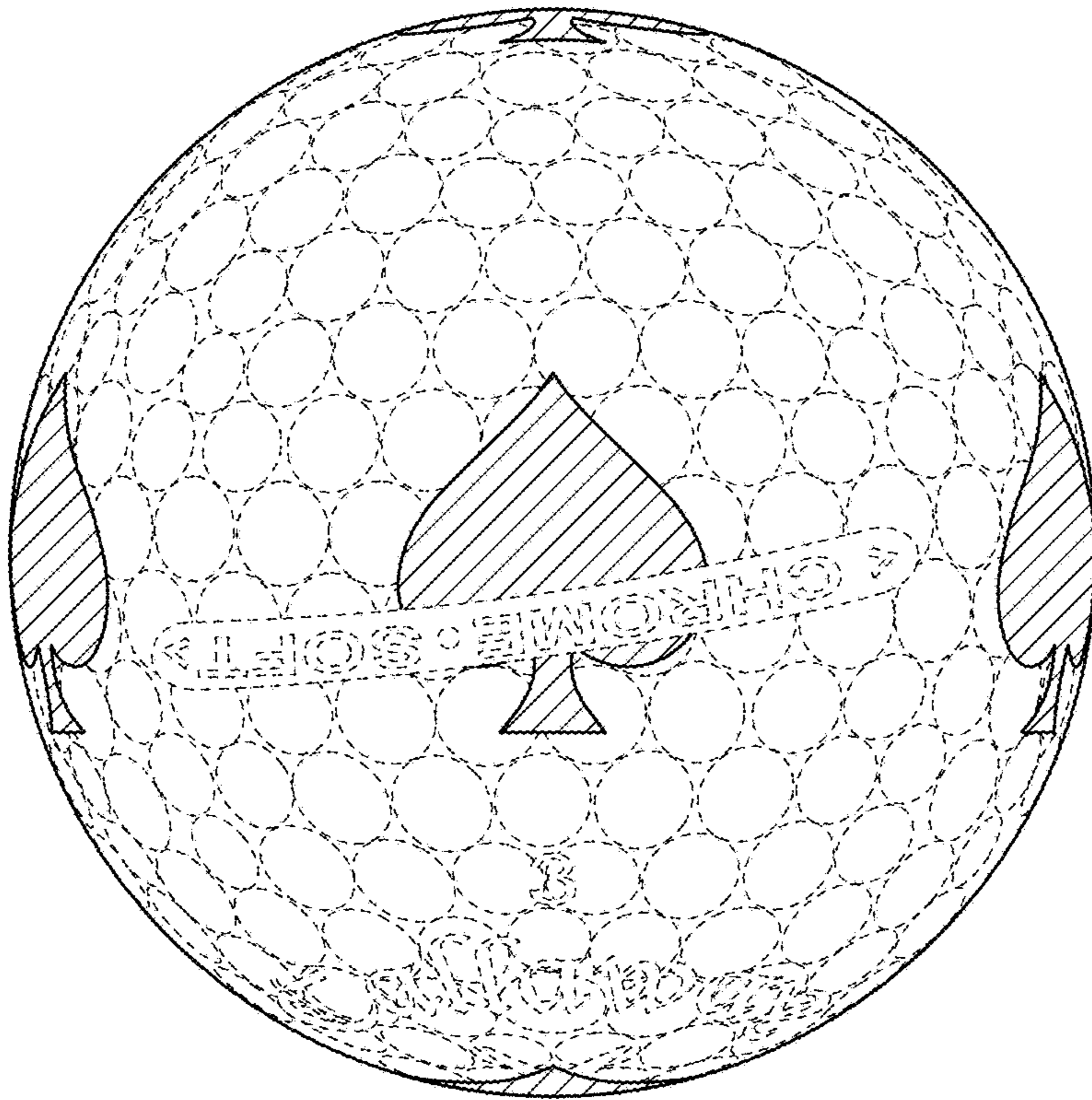

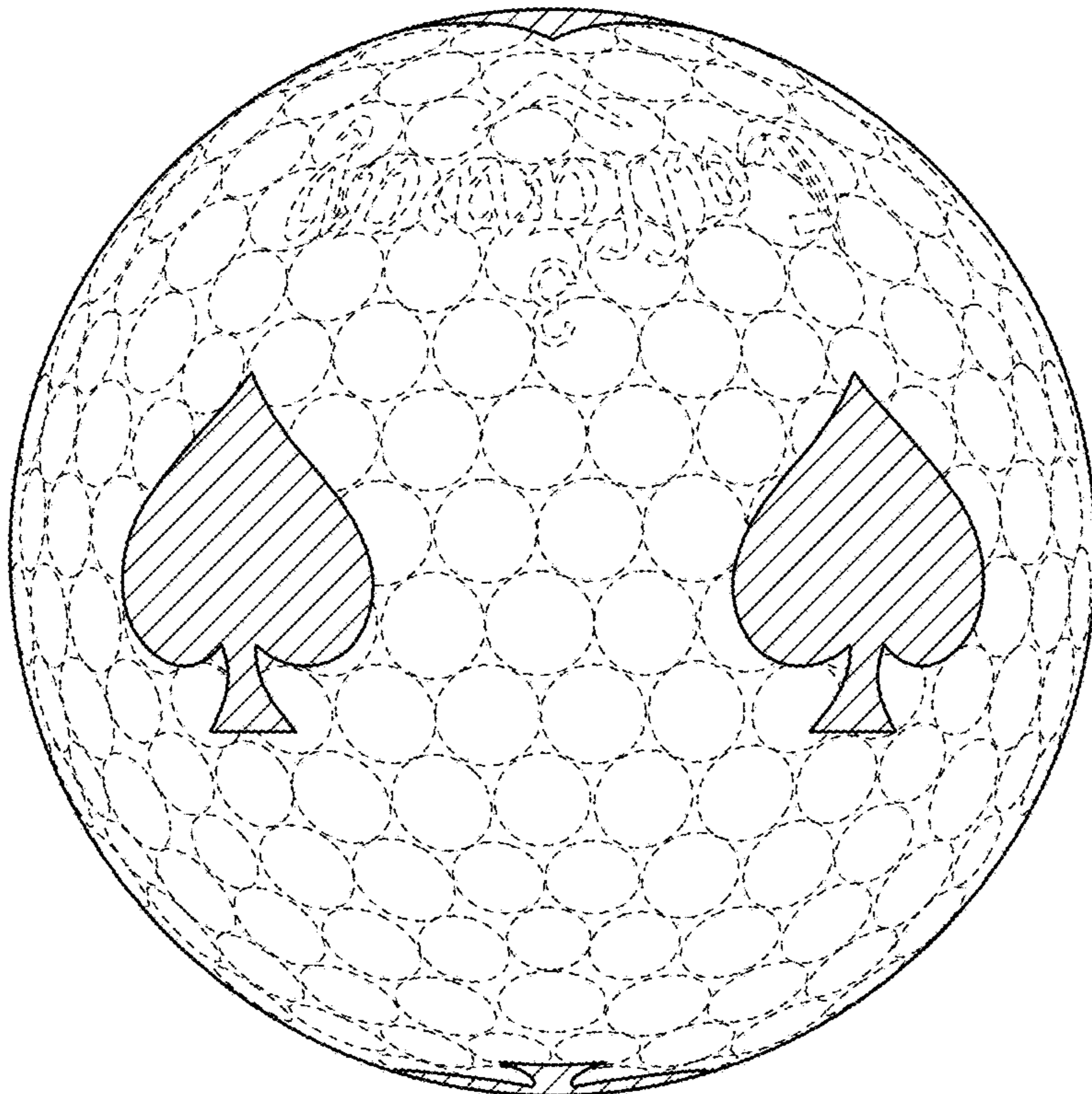

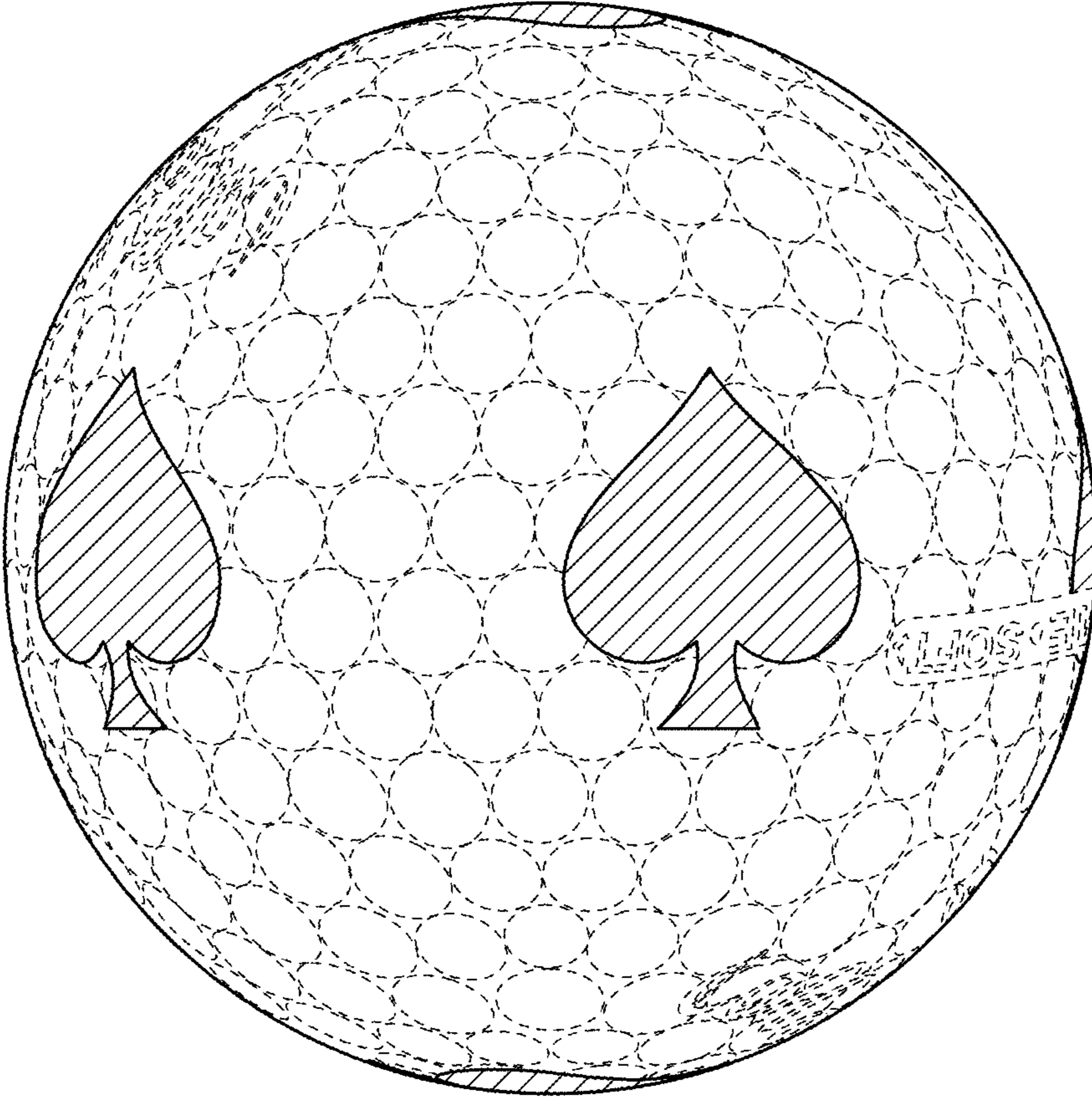
