DESCRIPTION

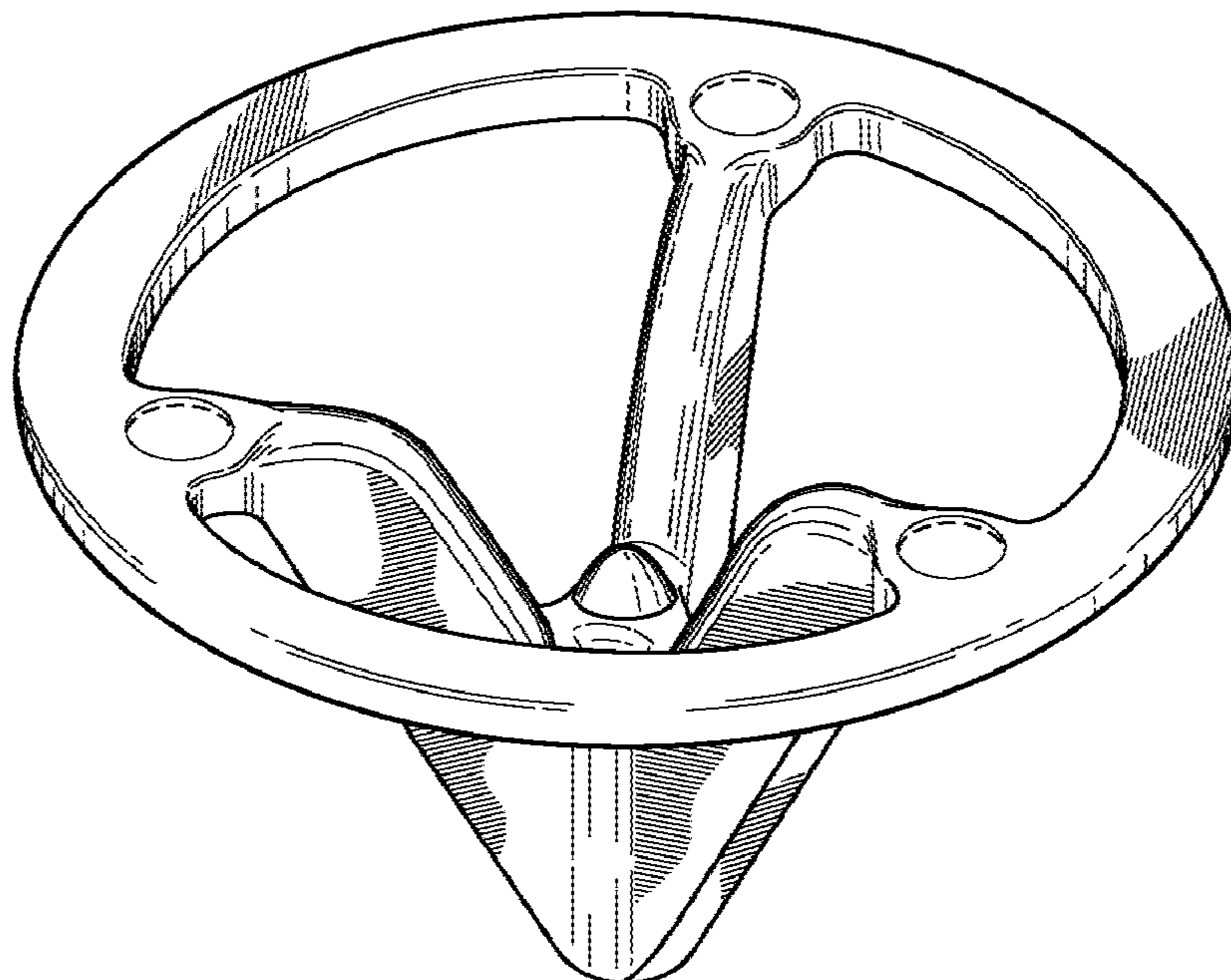
FIG. 1 is a top perspective view of a baffle showing our new design;

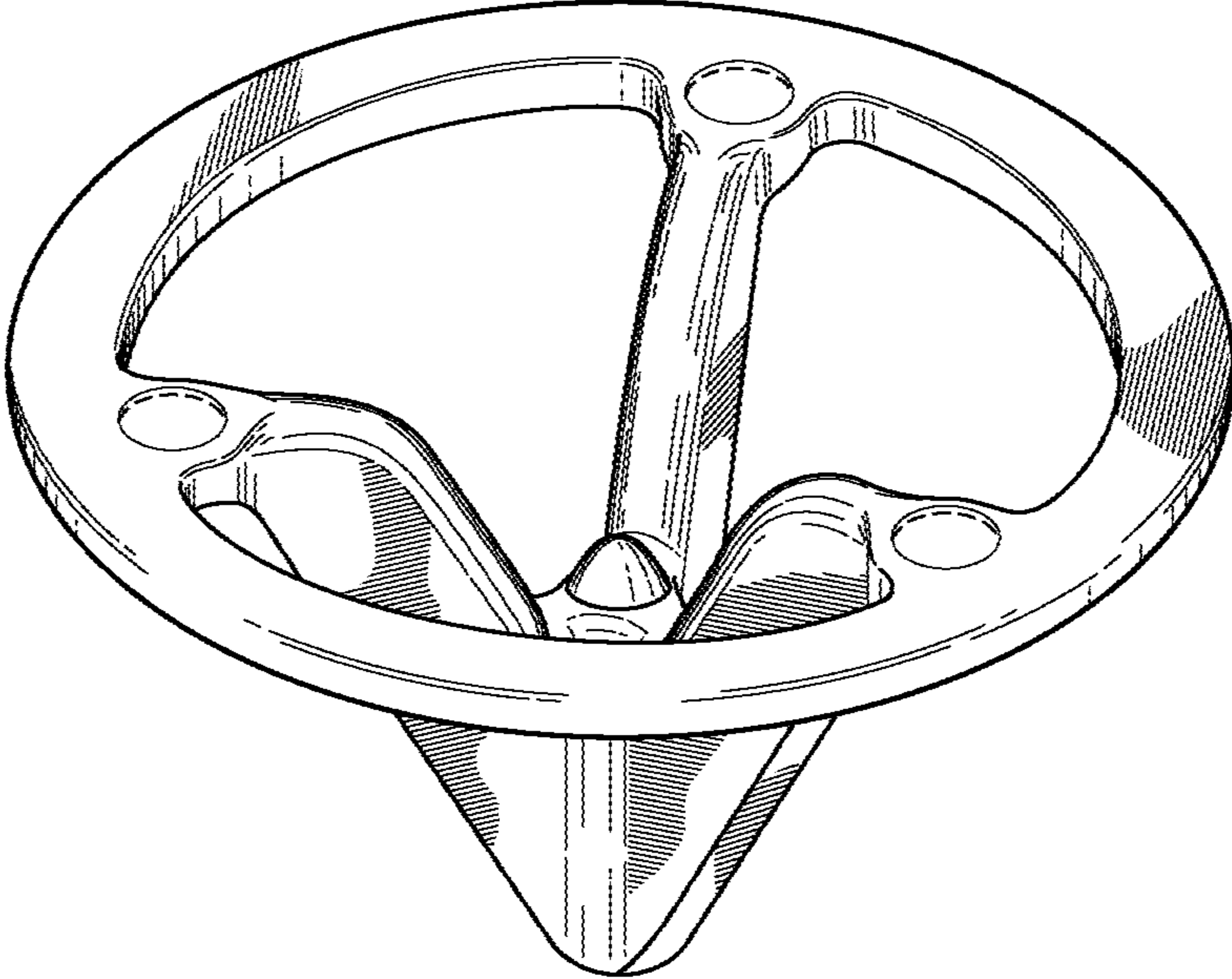

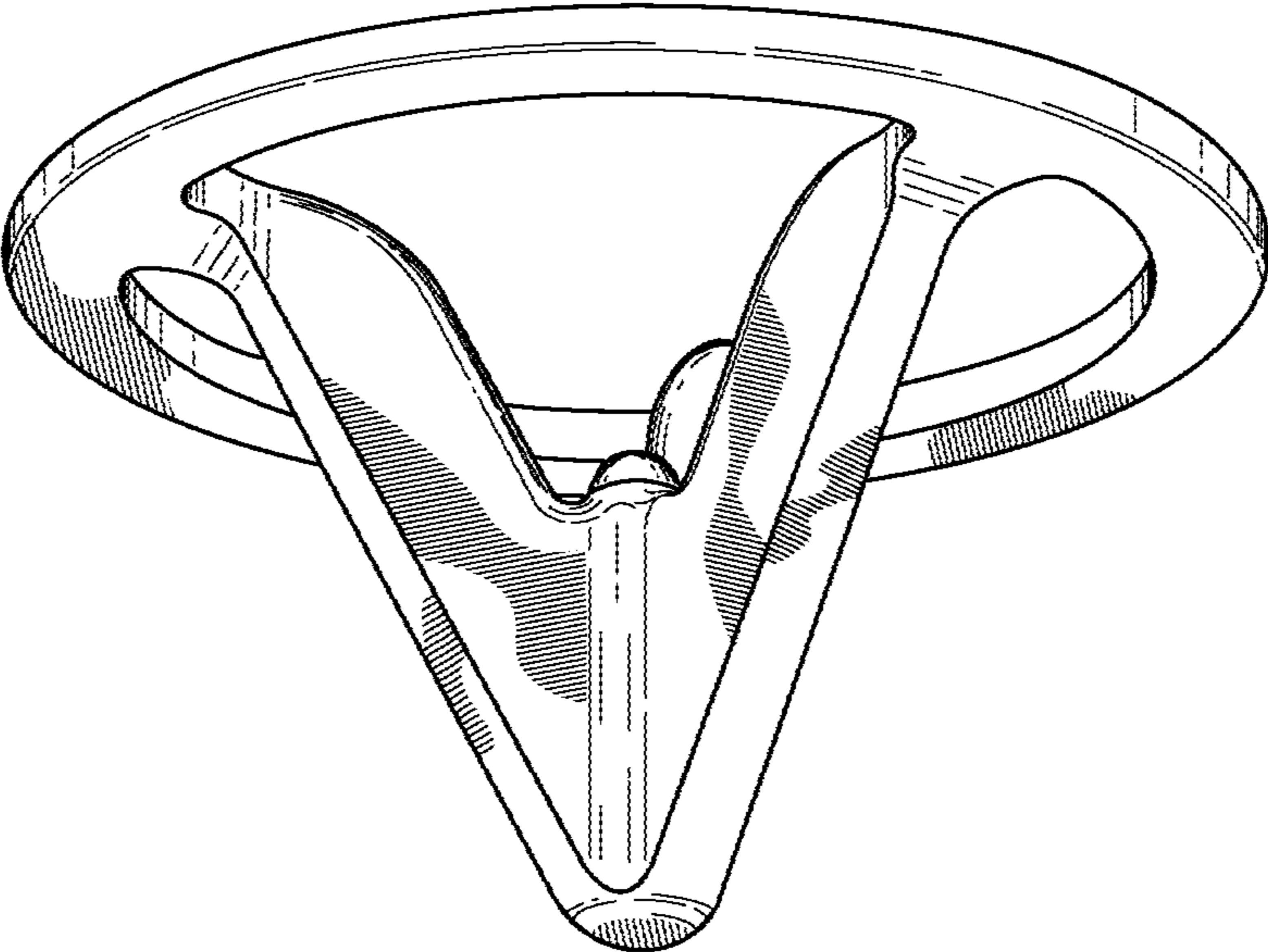

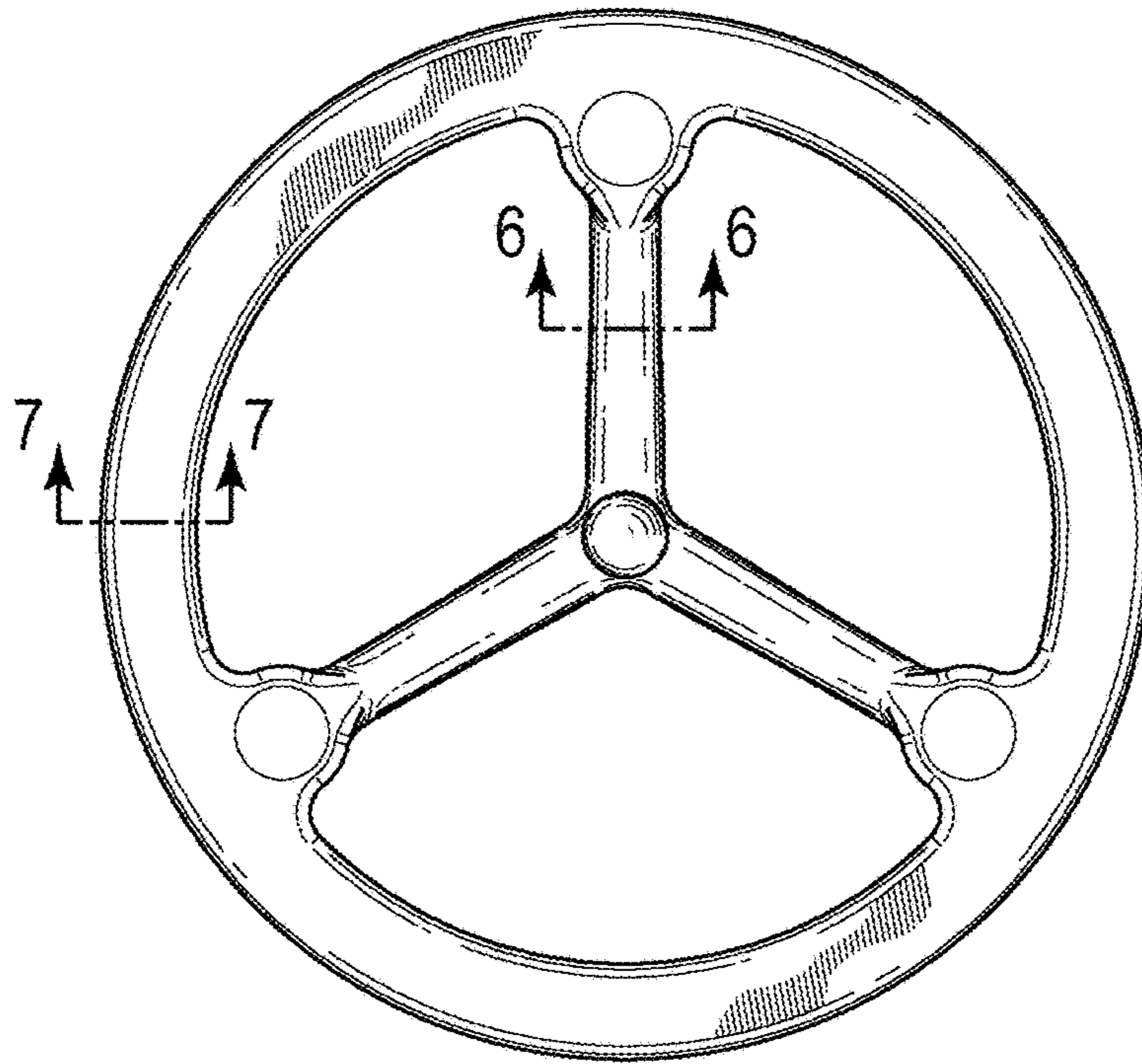

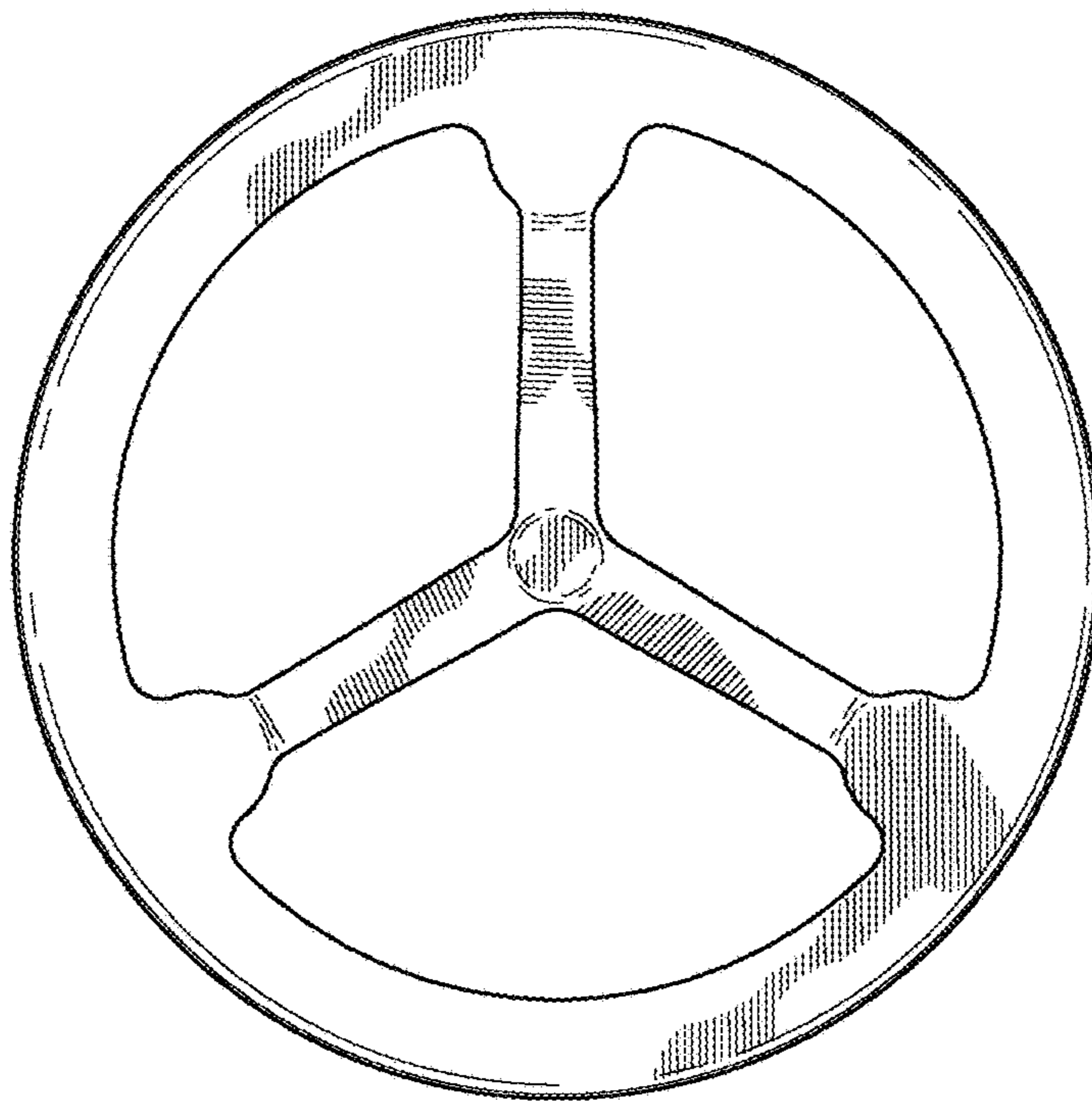

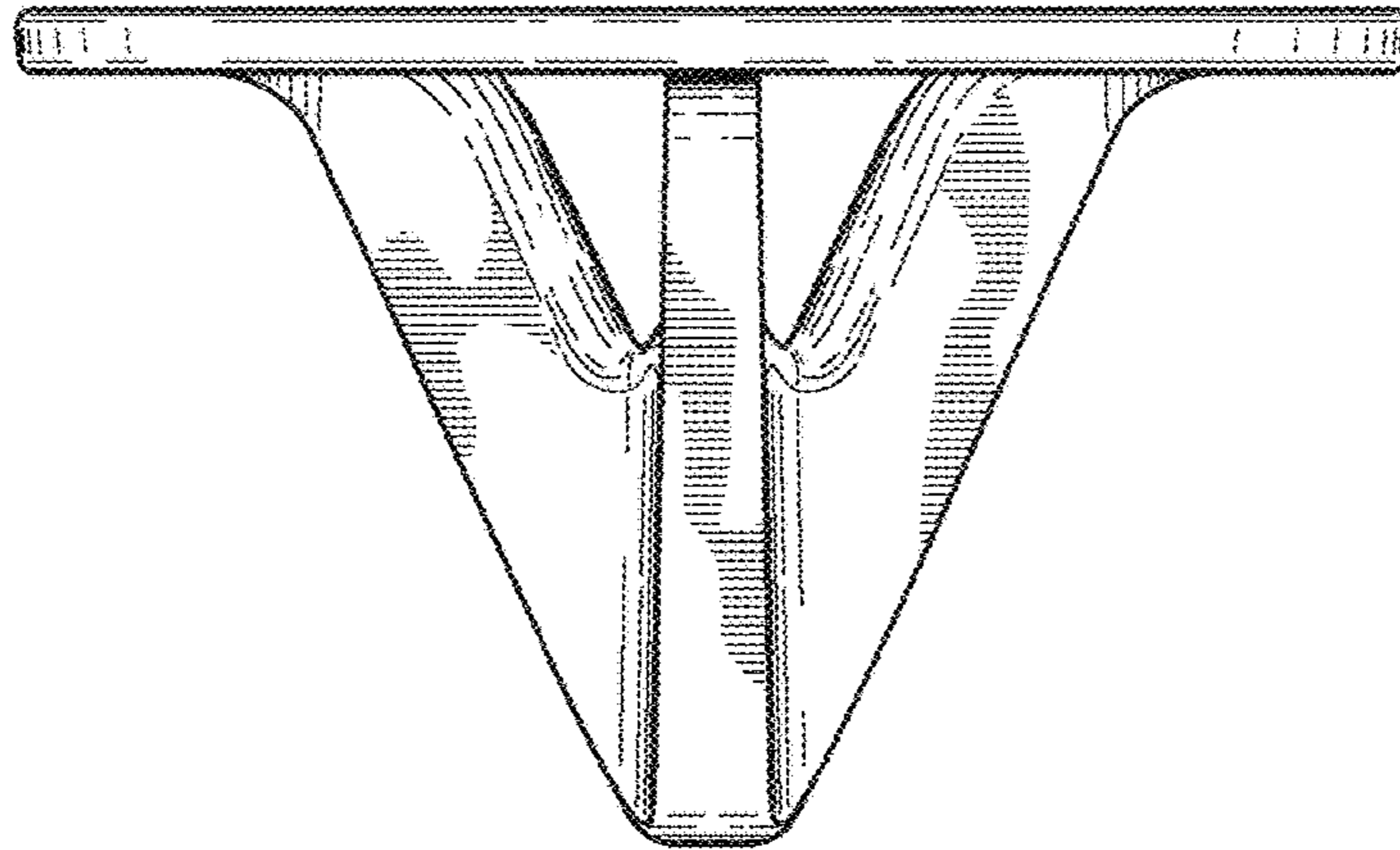

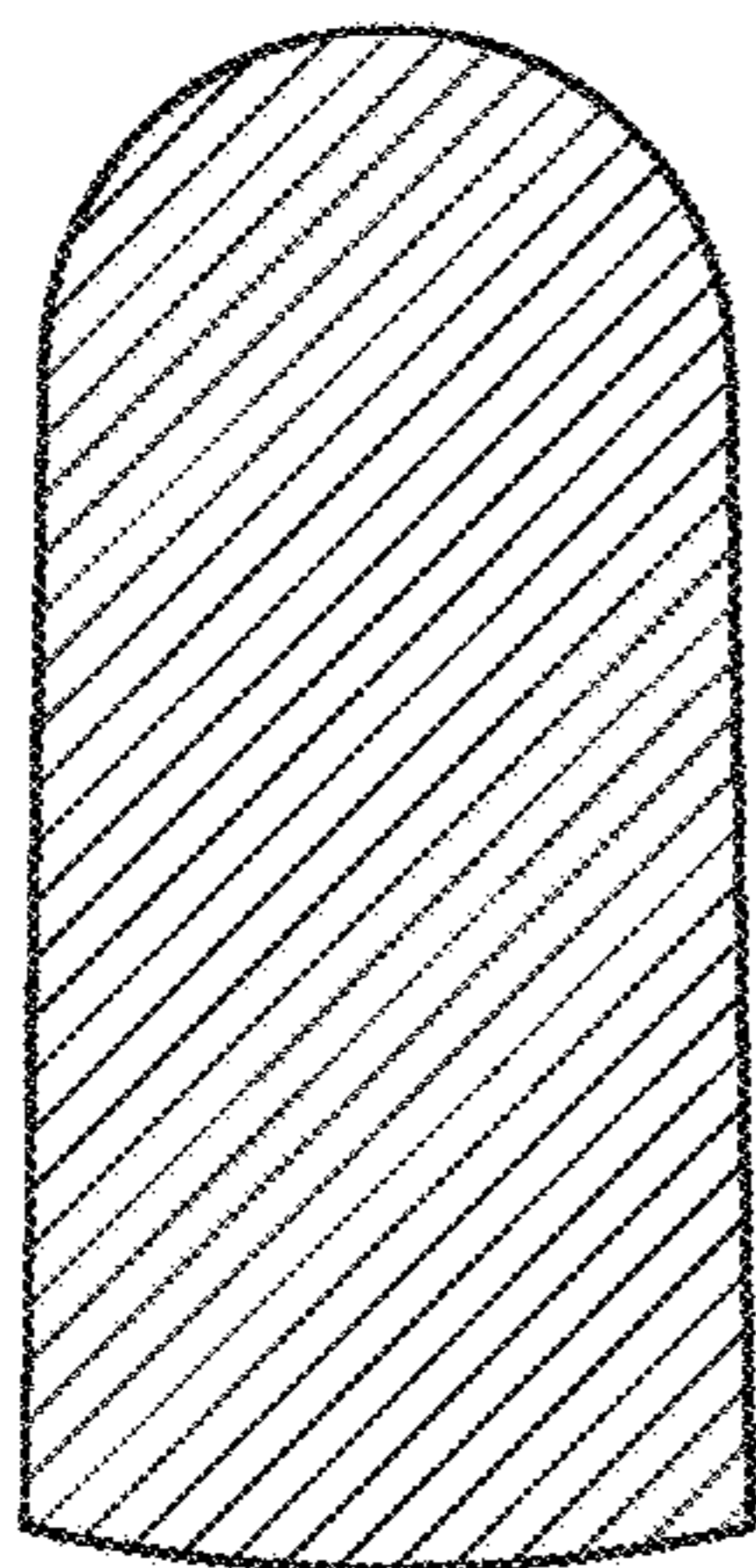

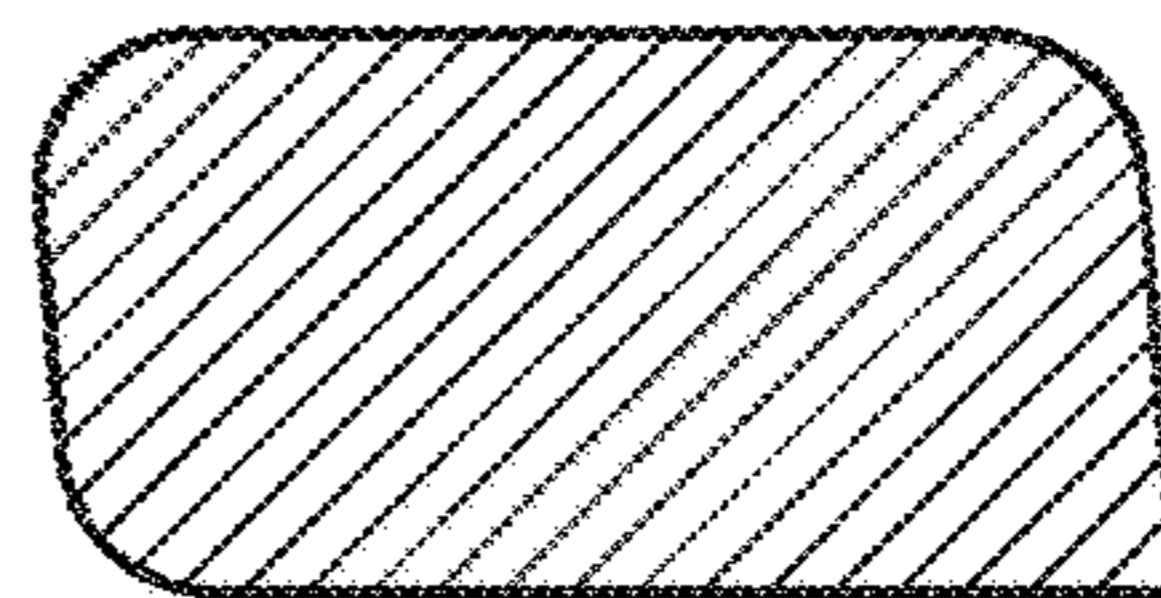
