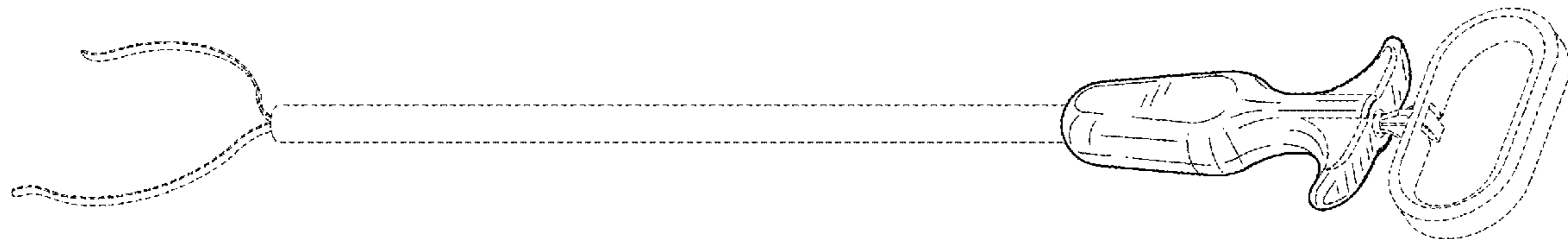
(57) **CLAIM**

The ornamental design for a handle for use with a medical retrieval instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for use with a medical retrieval instrument showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a front elevational view thereof; FIG. 7 is a rear elevational view thereof; and, FIG. 8 is another perspective view thereof. 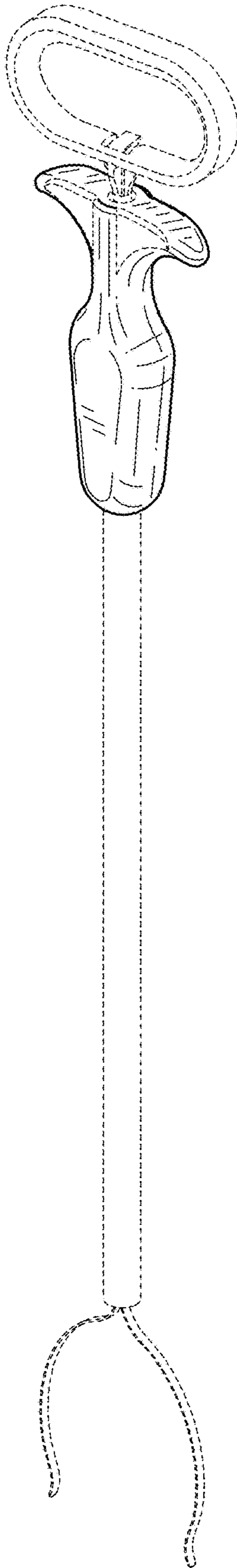

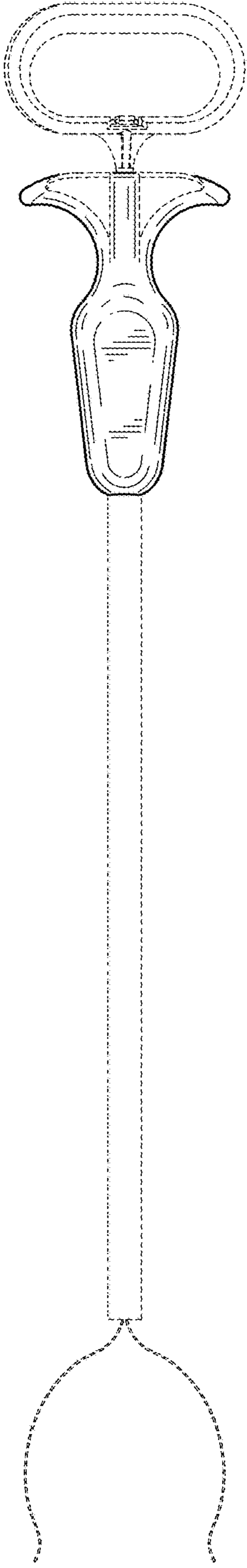

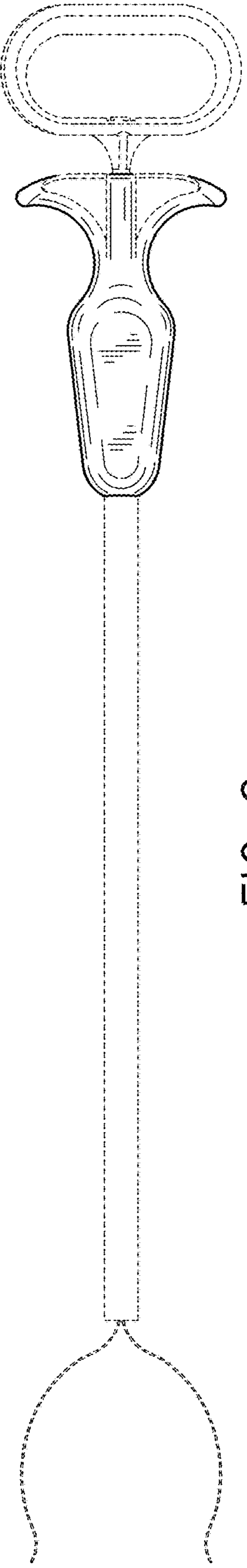

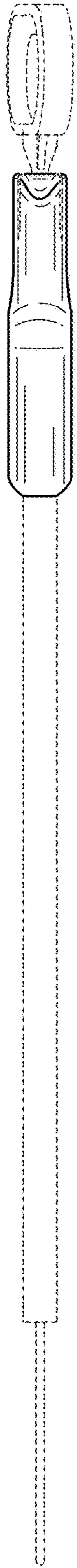

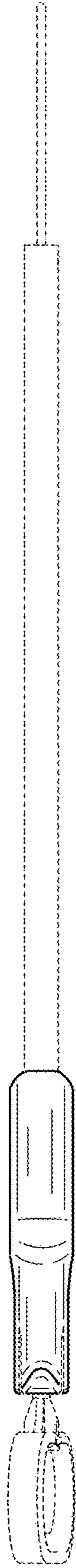

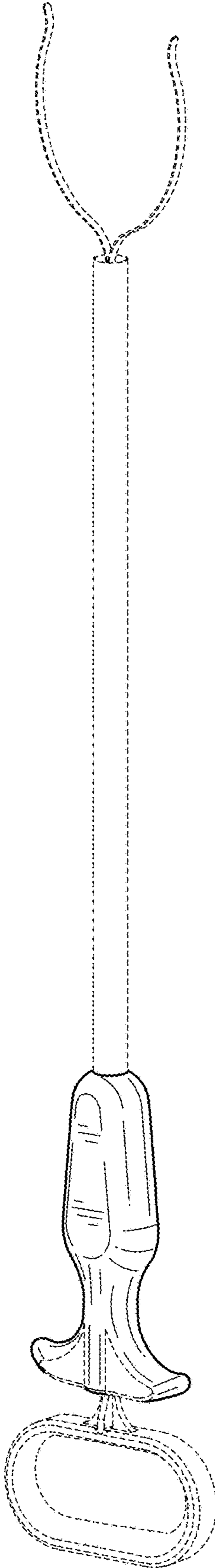
