The ornamental design for a probe for an ultrasonic diagnosis apparatus, as shown and described.

DESCRIPTION

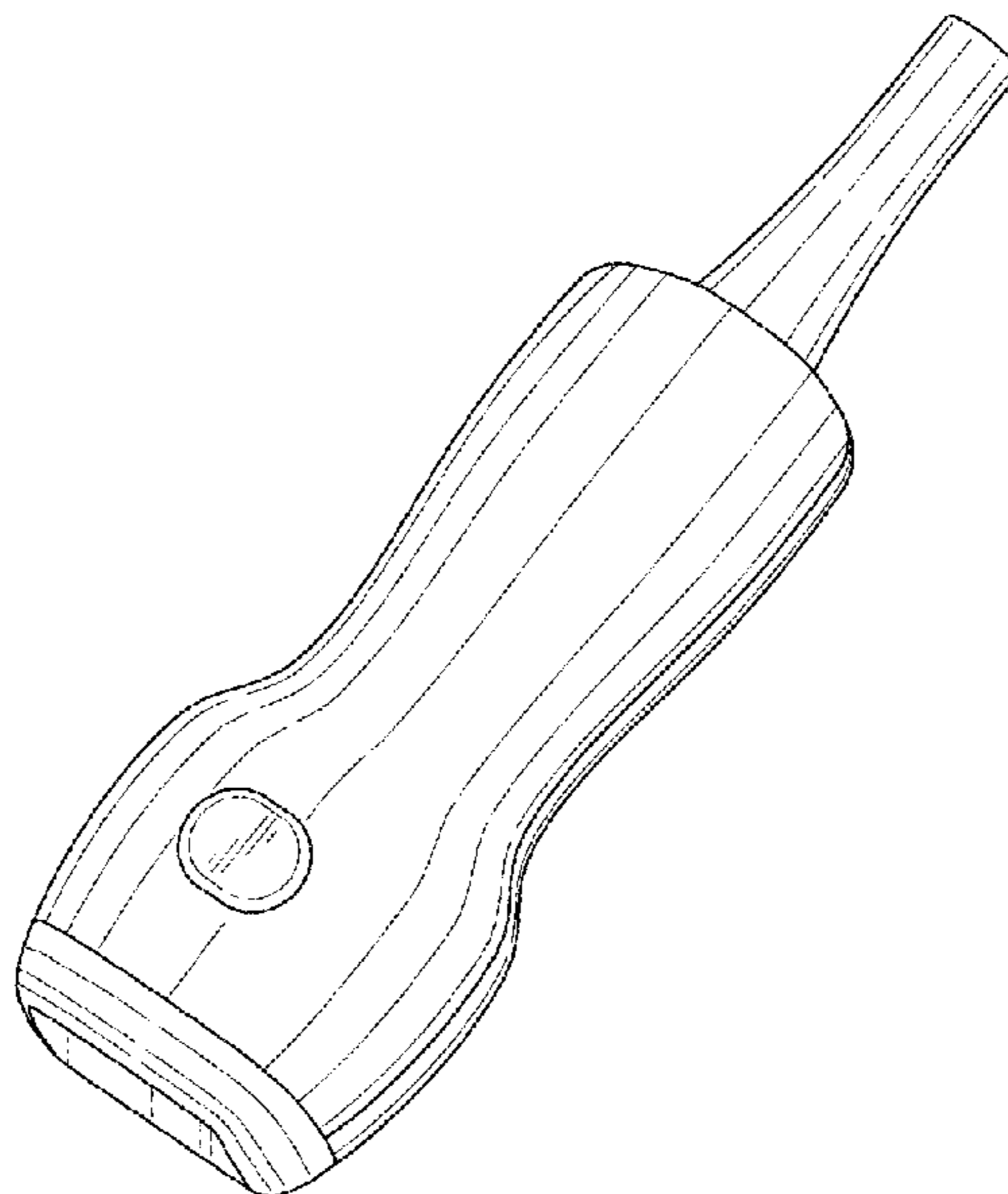

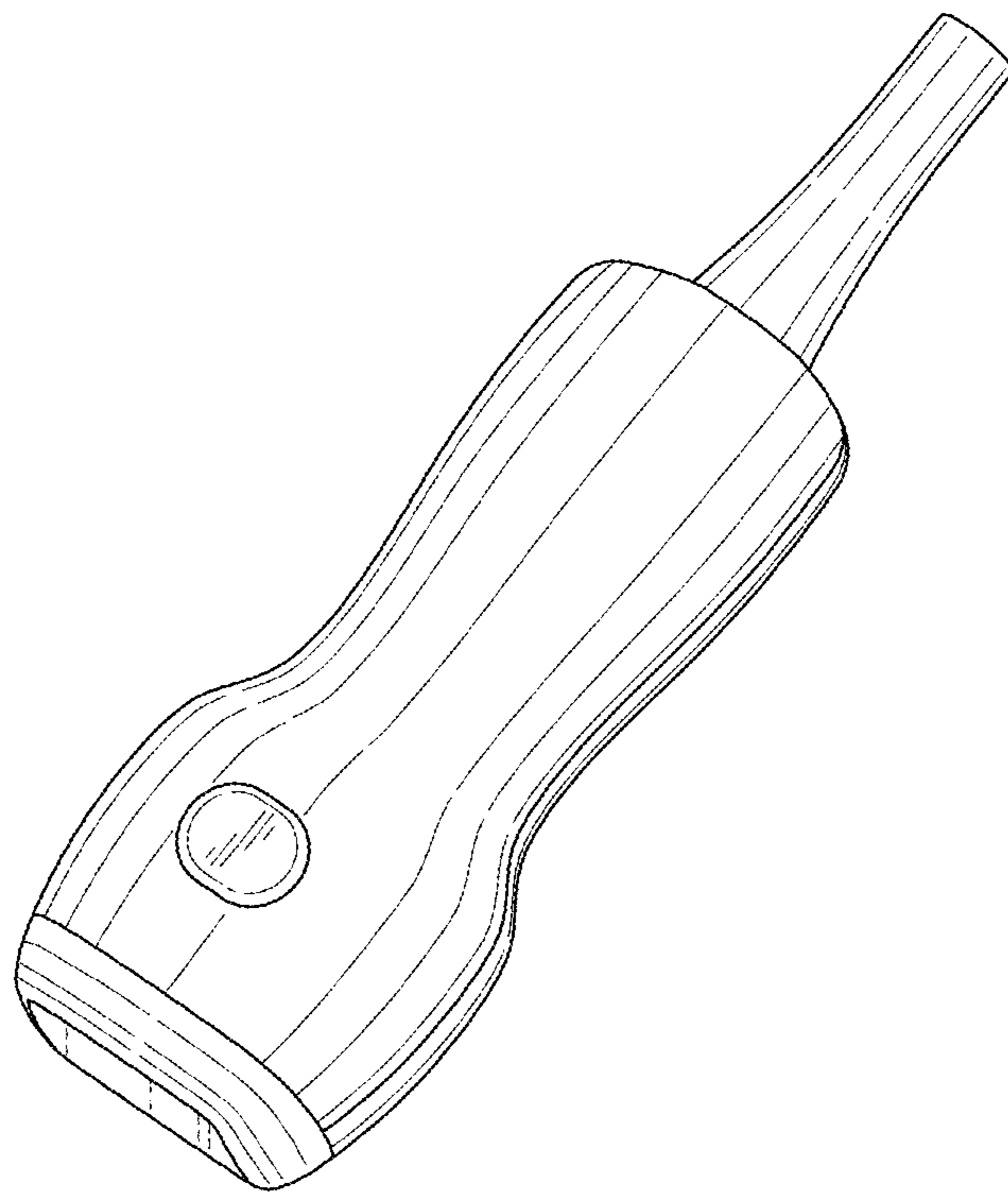

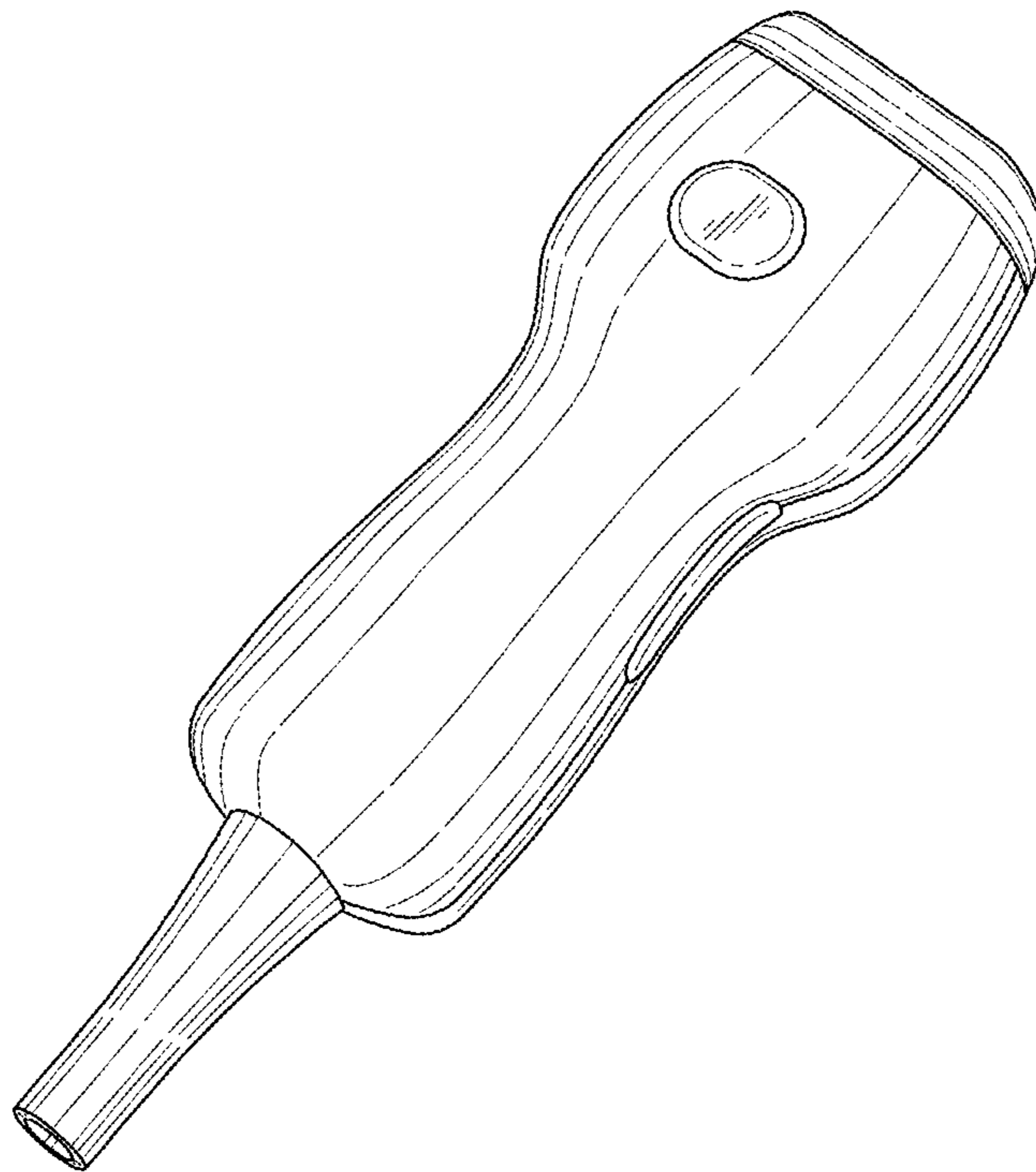

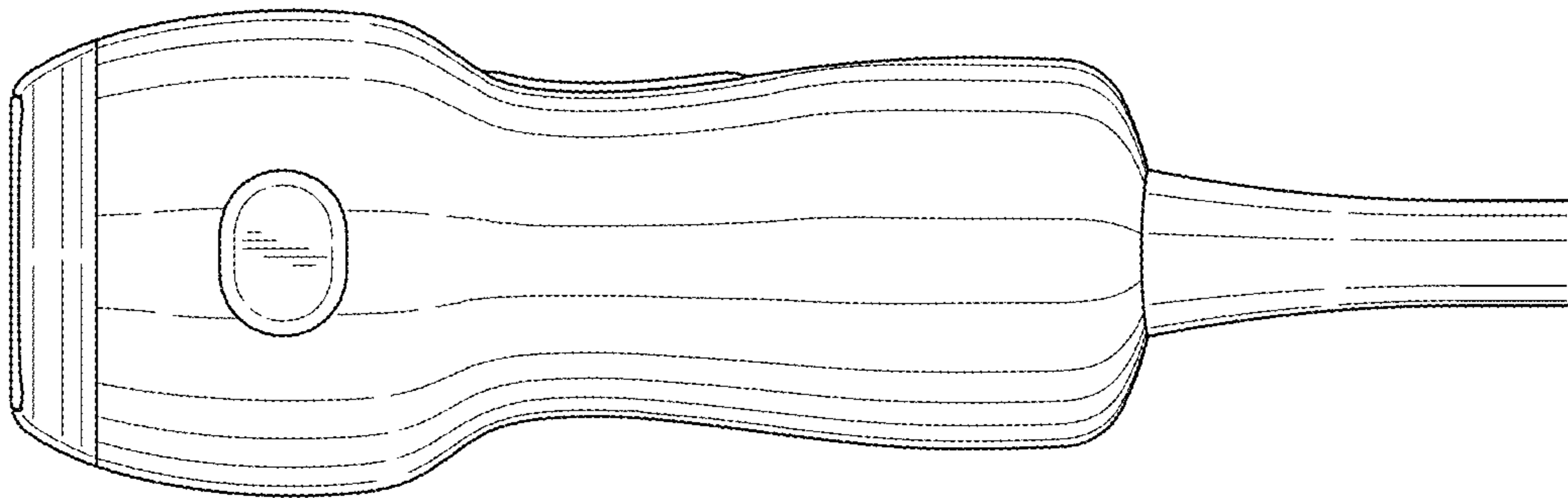

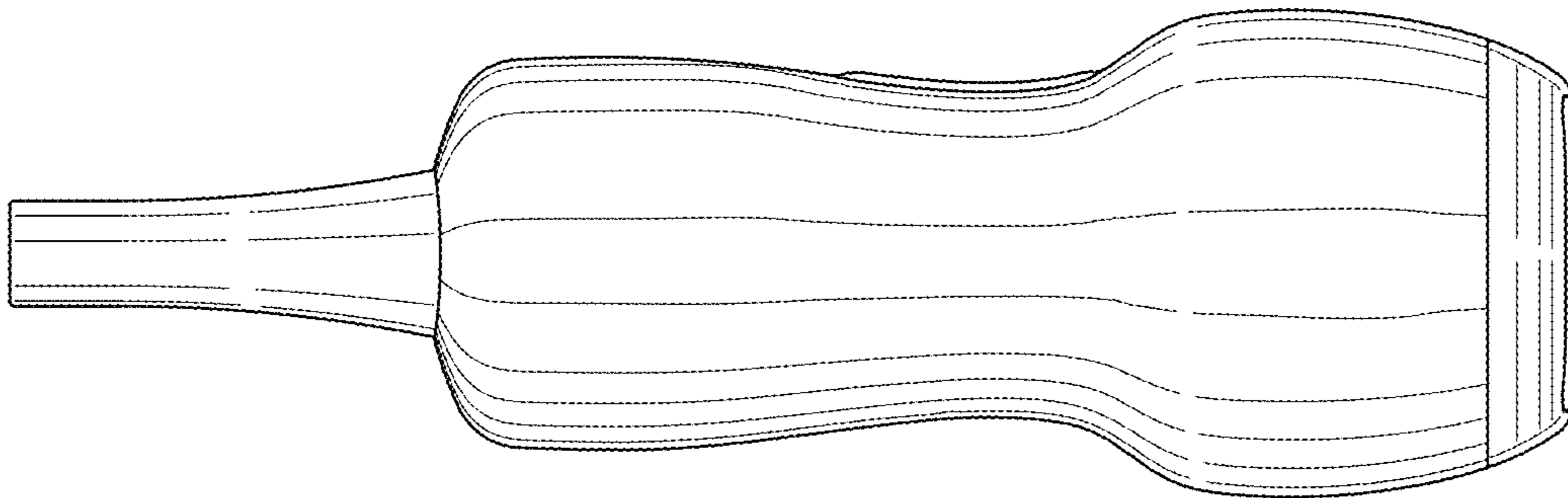

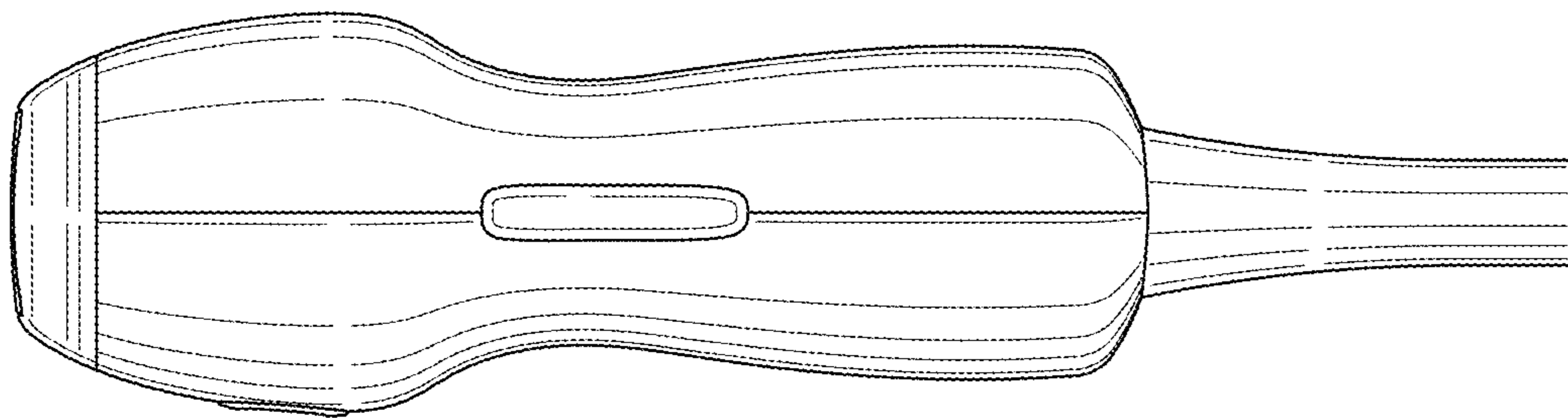

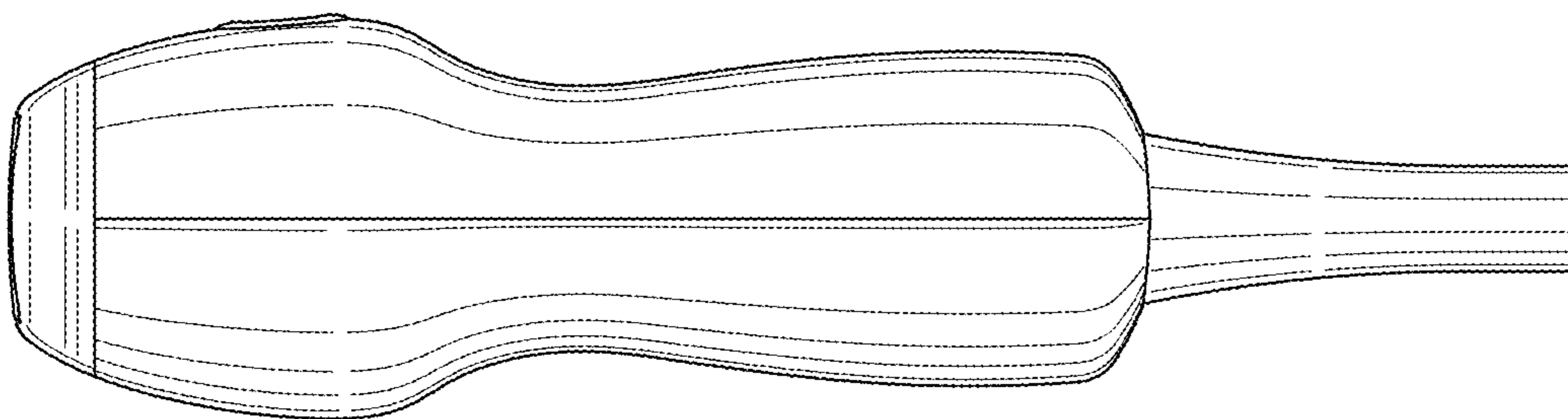

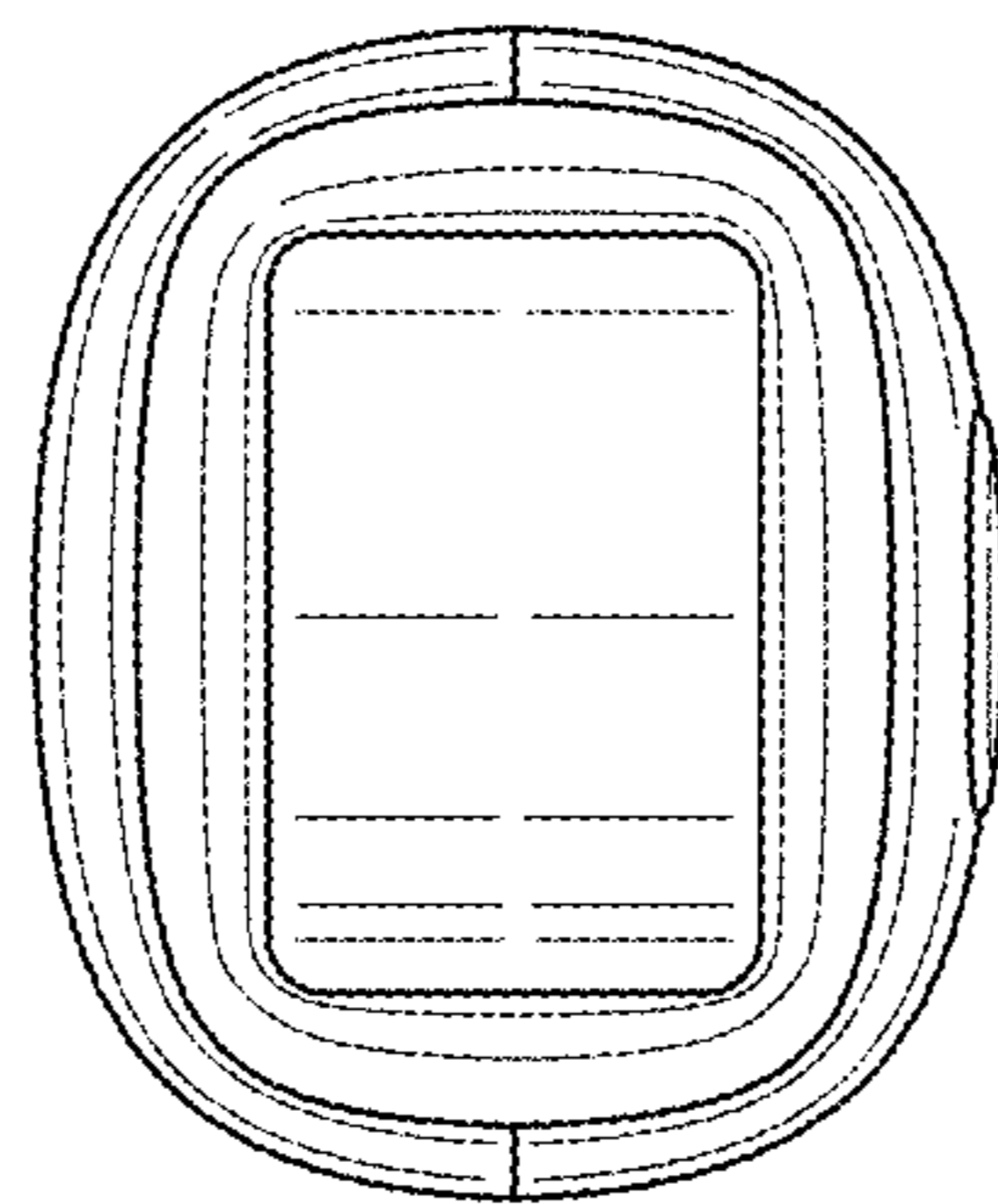
