FIG. 4 is a rear elevation view.

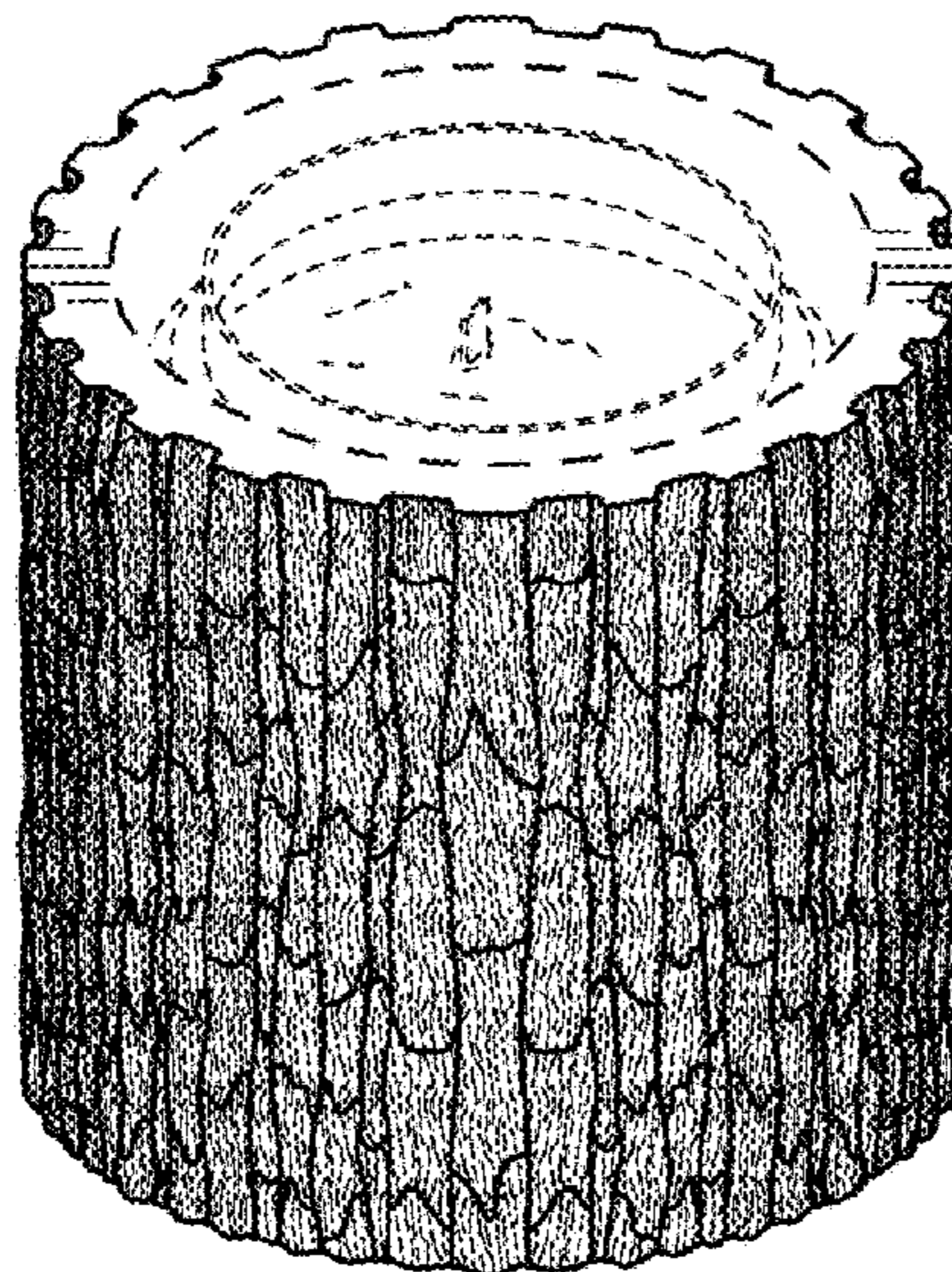
FIG. 5 is a right elevation view.

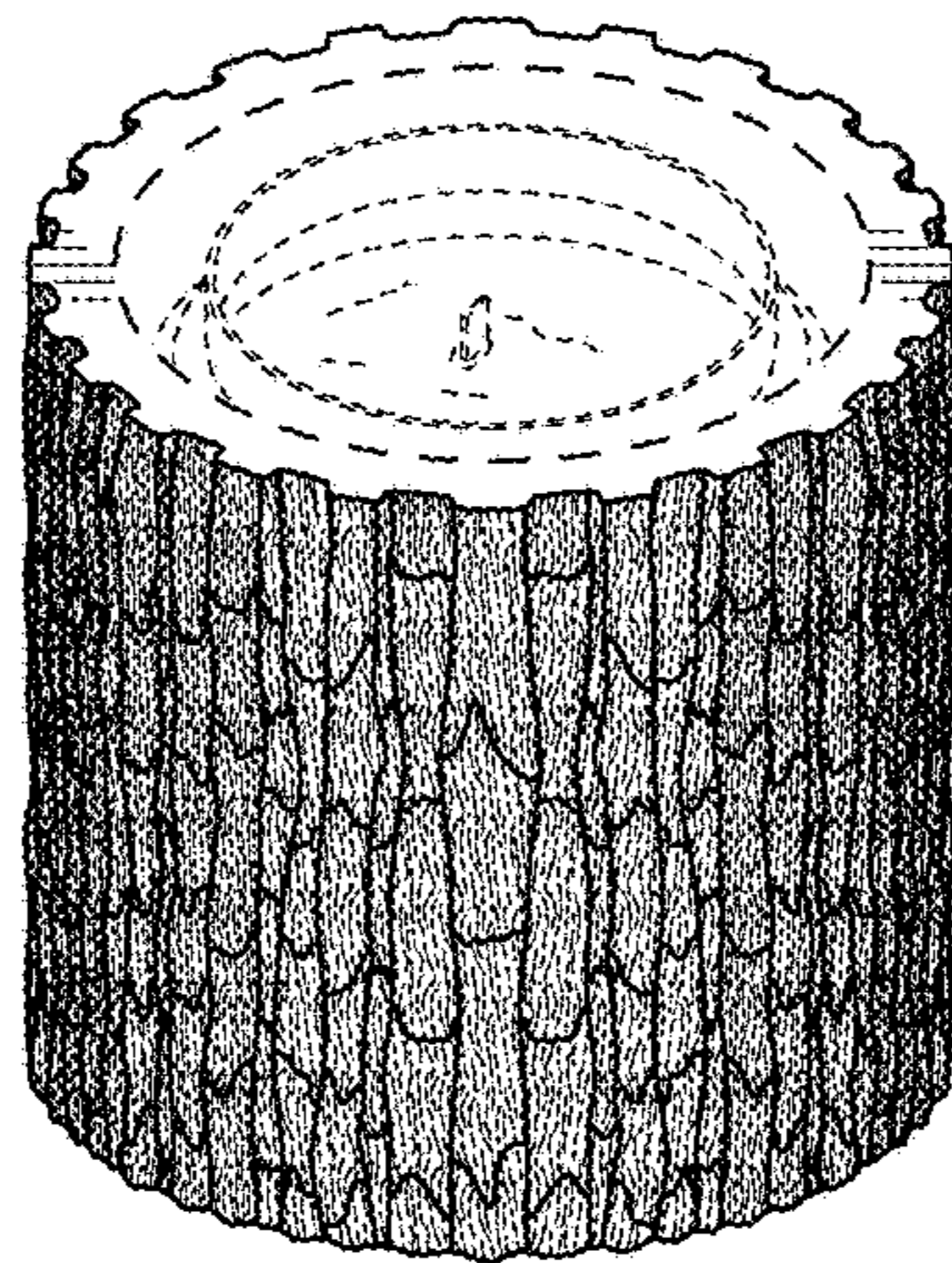

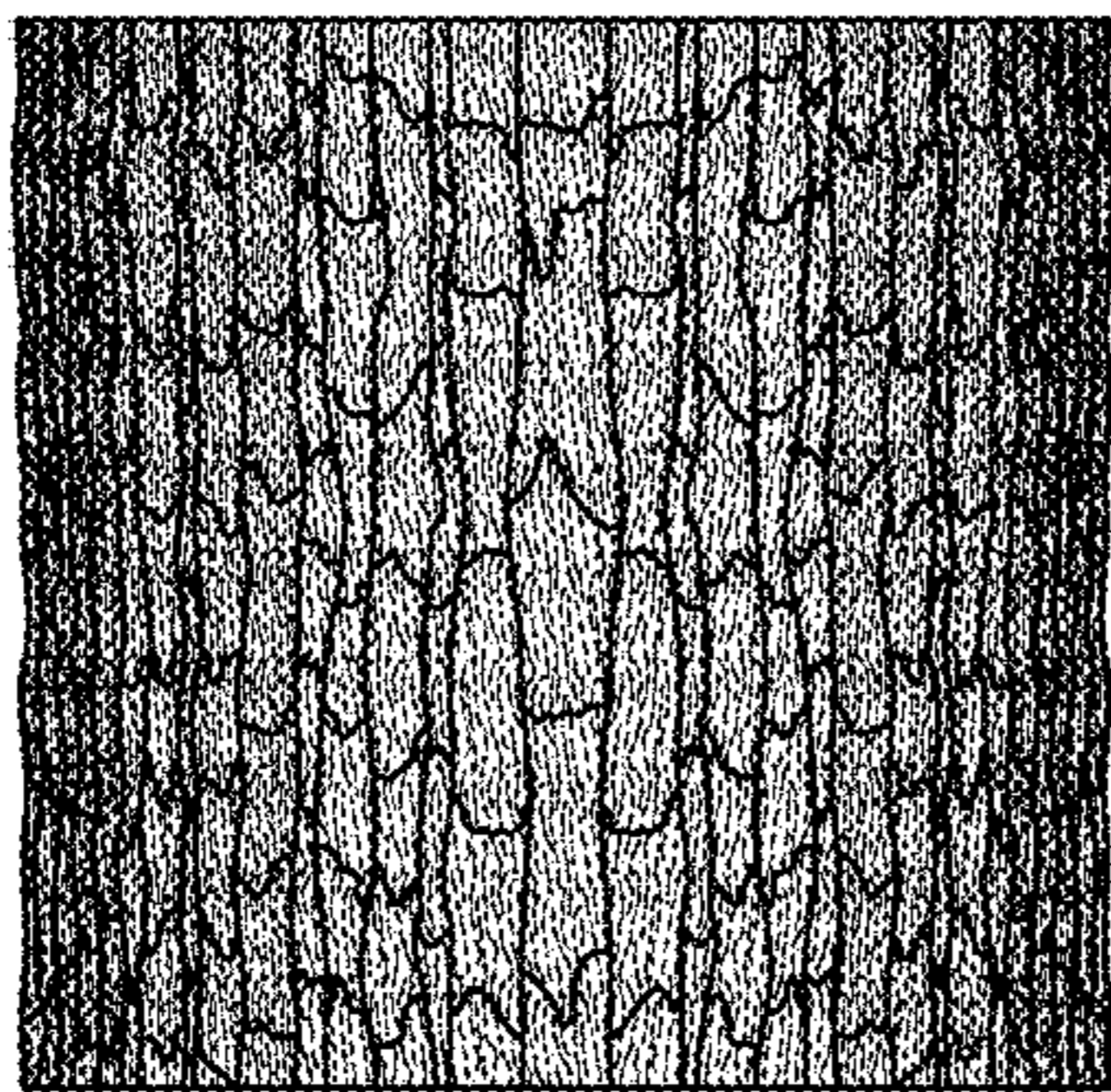

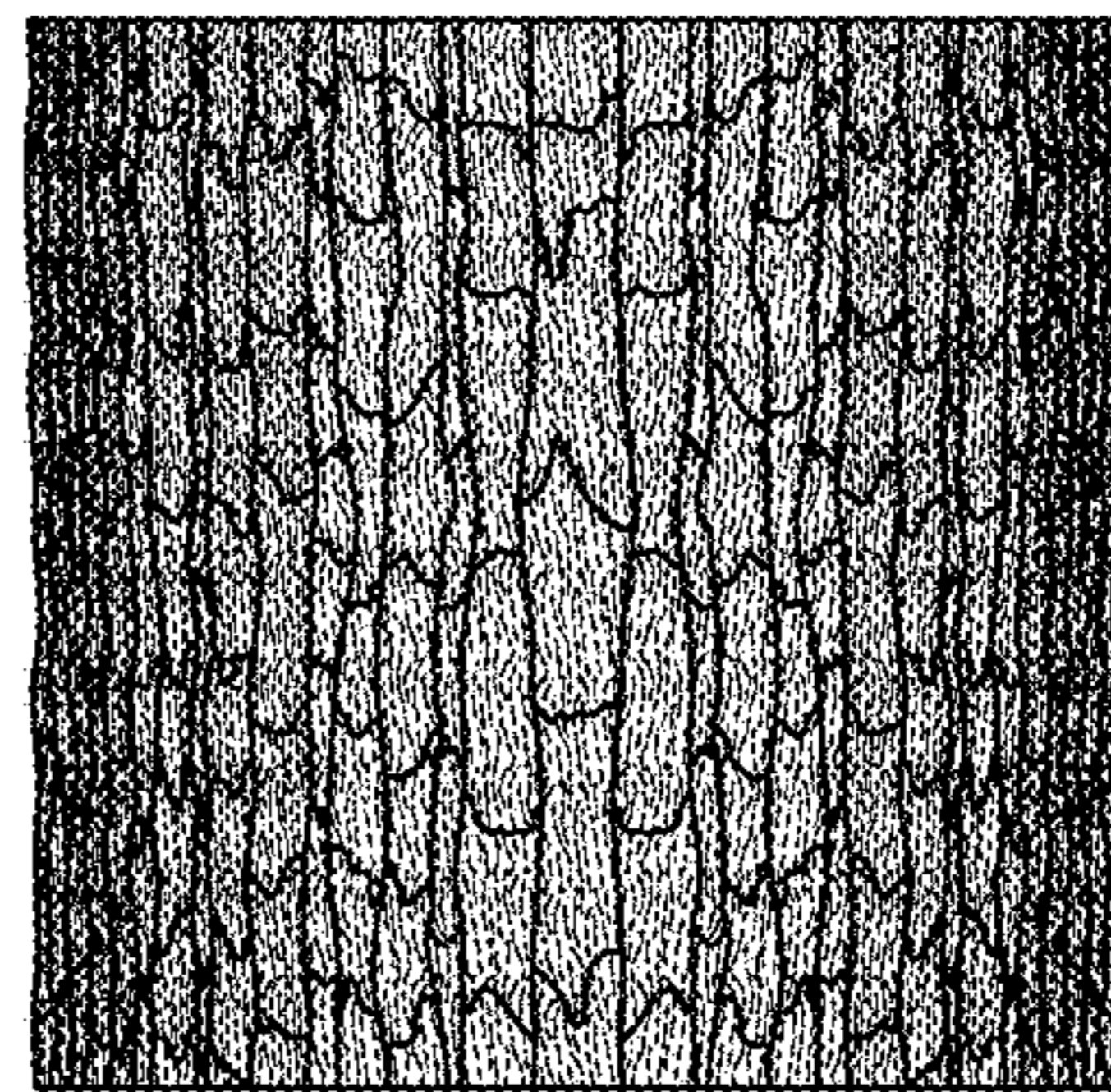

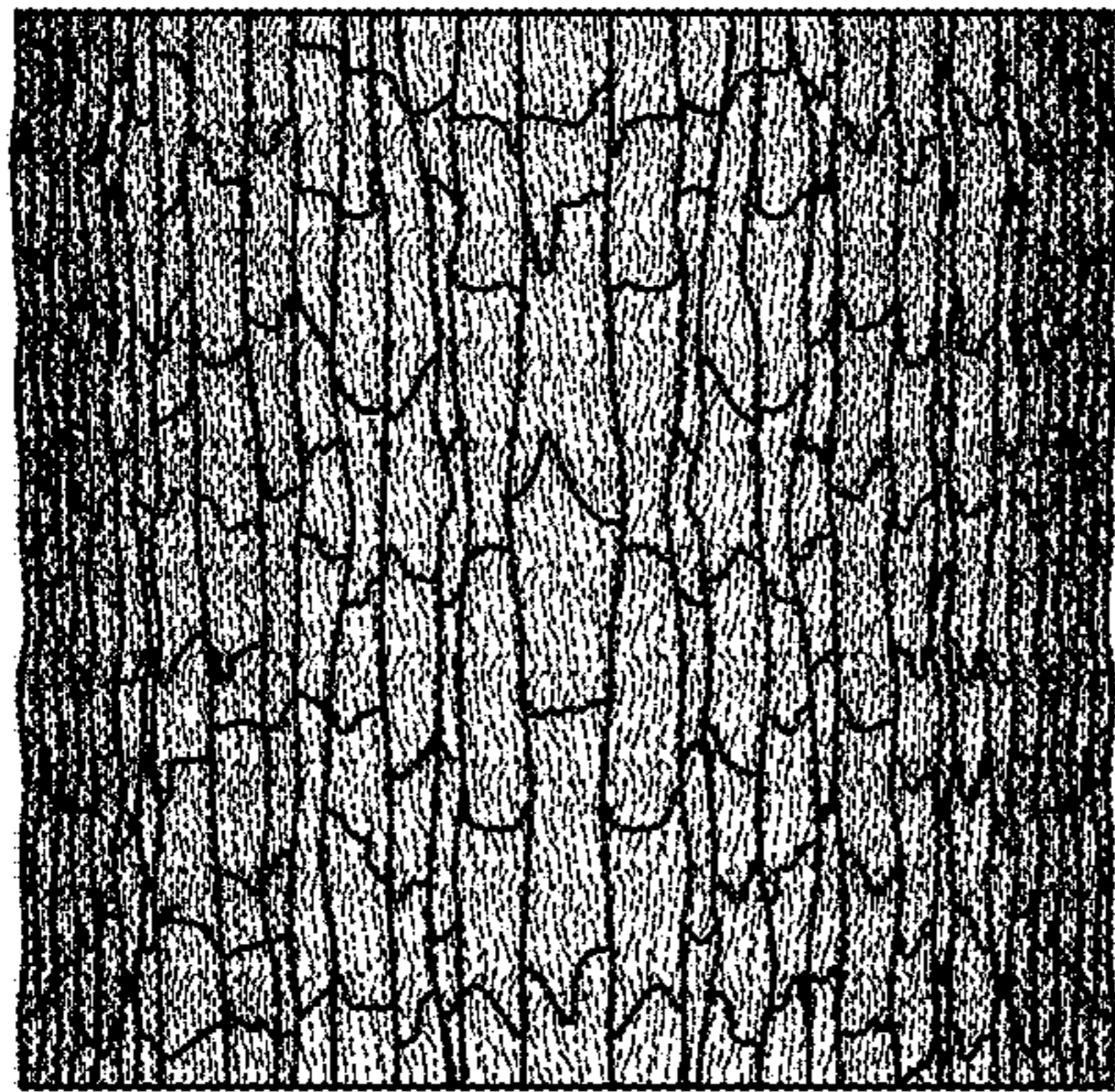

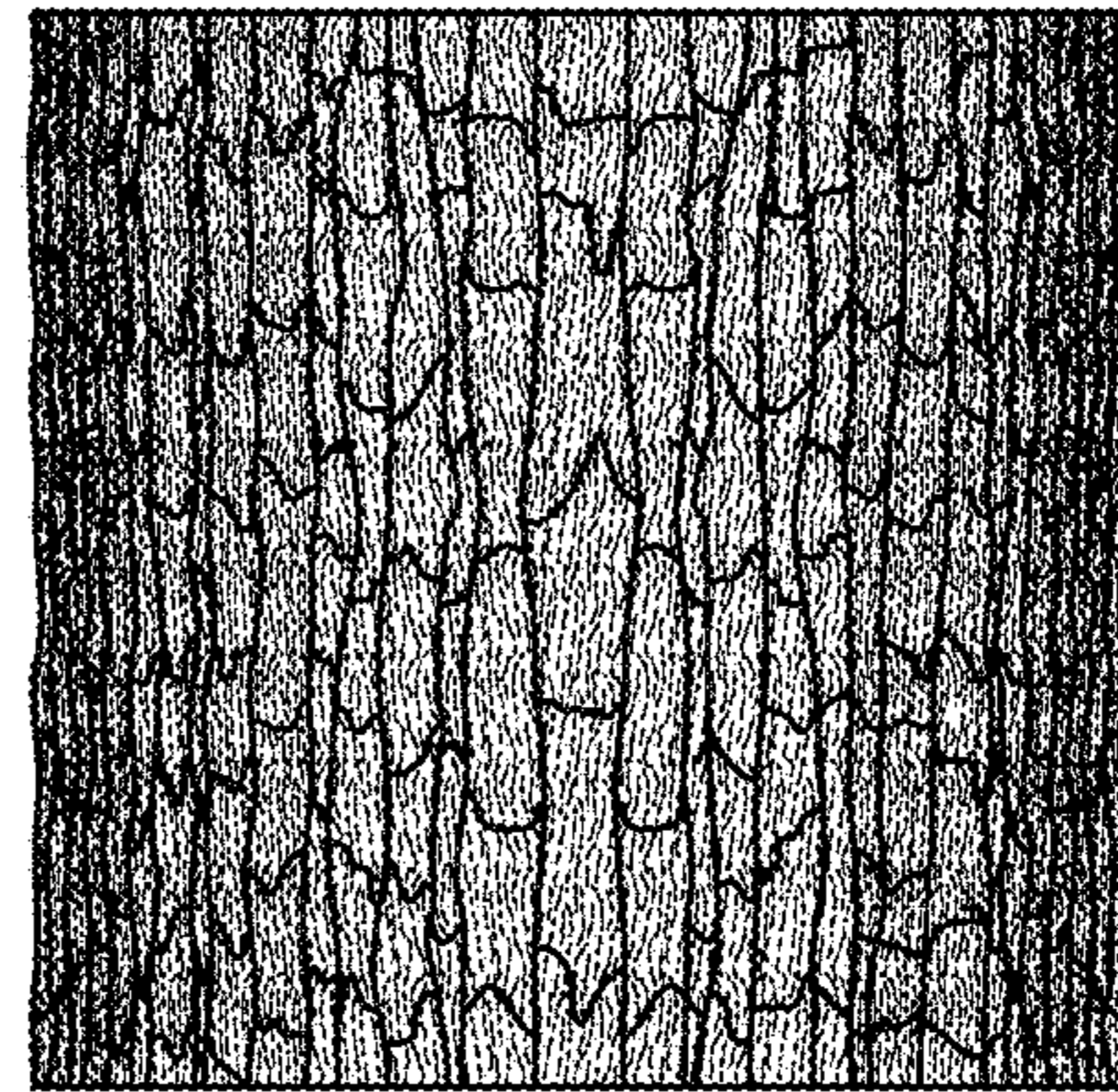

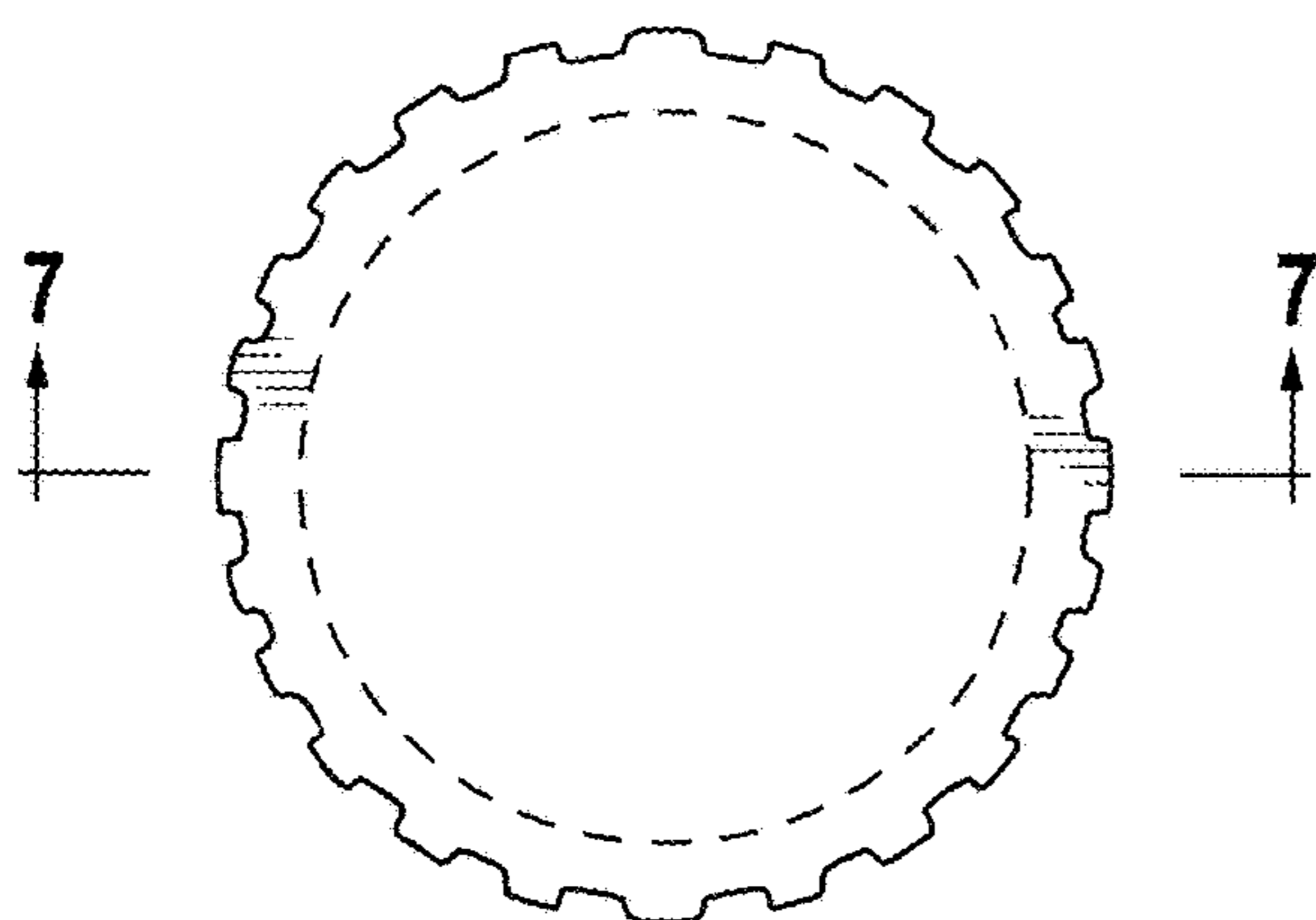

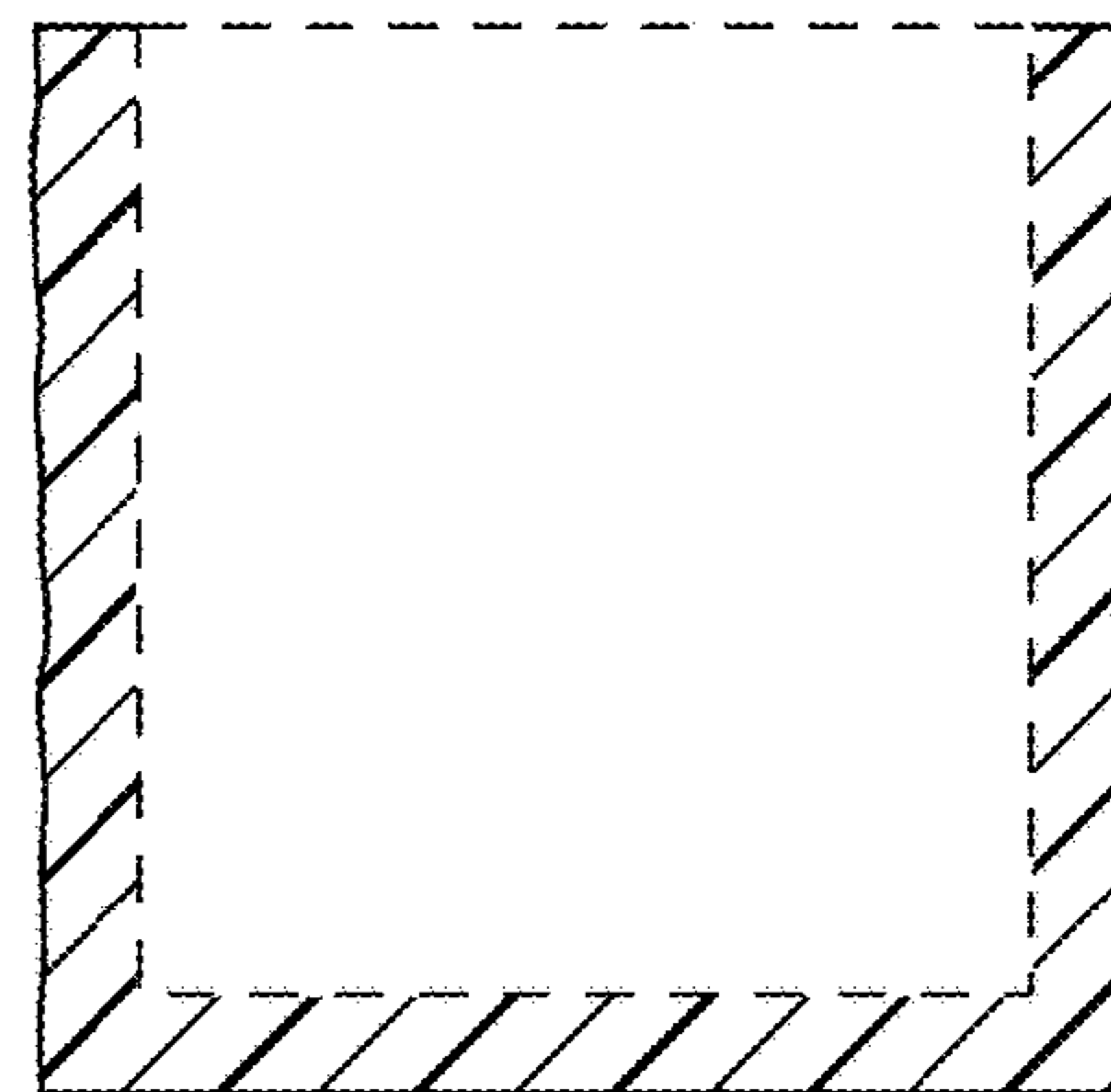
