The ornamental design for a set of nail clippers with integrated nippers, as shown and described.

DESCRIPTION

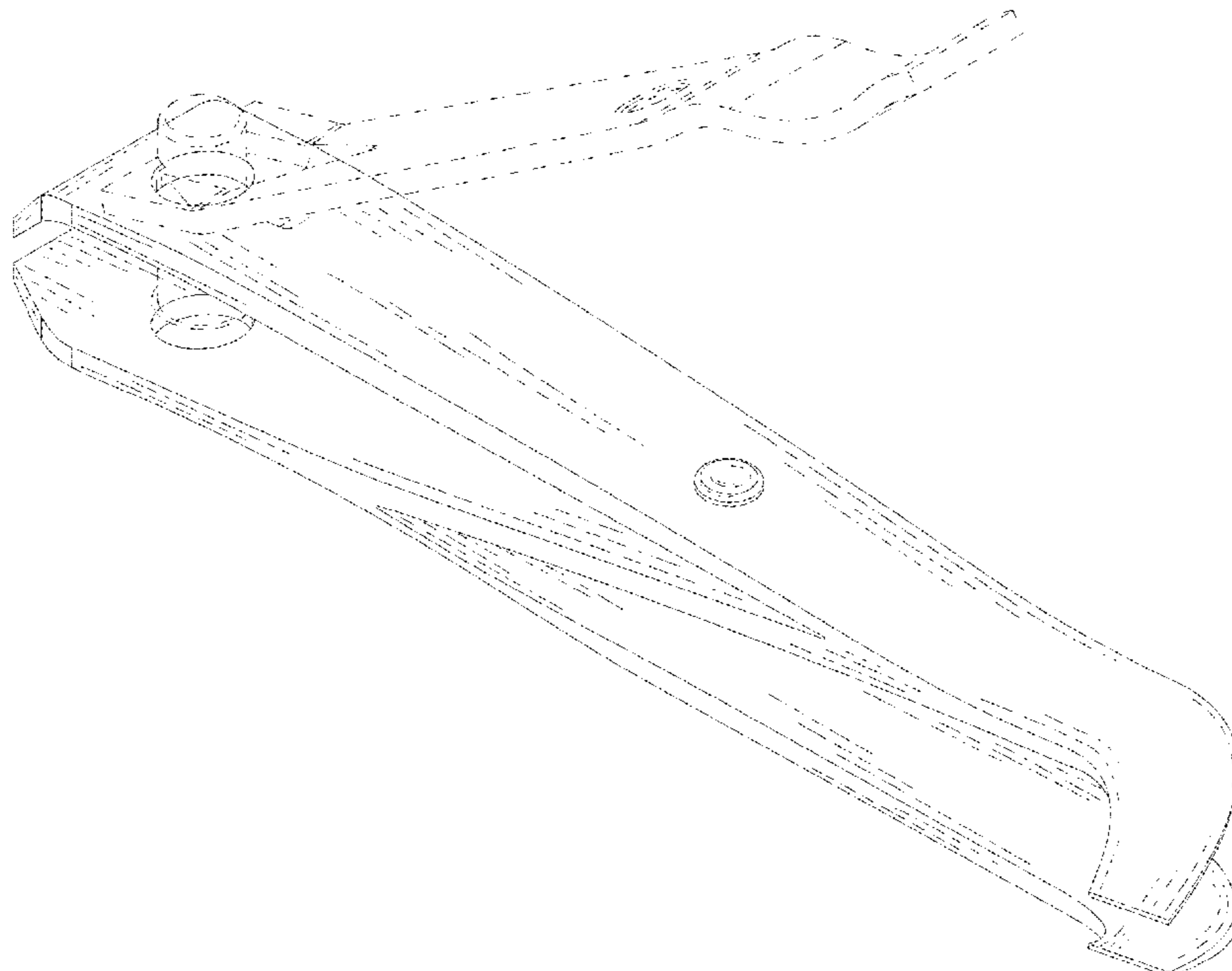
FIG. 1 is a top perspective view of a set of nail clippers with integrated nippers showing my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a top perspective view thereof showing the lever in an upwards position; and, FIG. 10 is a top perspective view thereof showing the lever in a downwards position. The broken line showing a lever in FIGS. 9-10 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

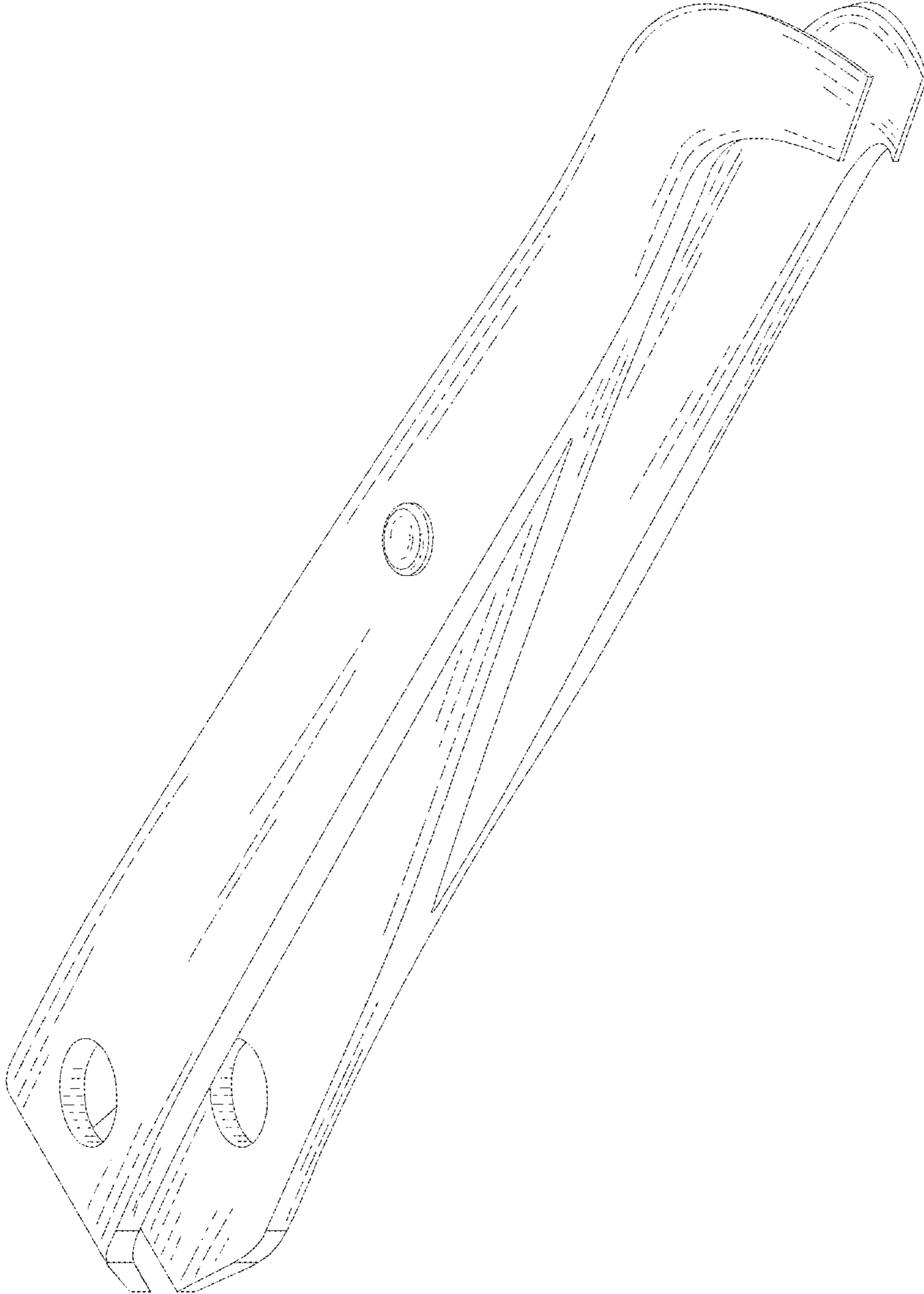

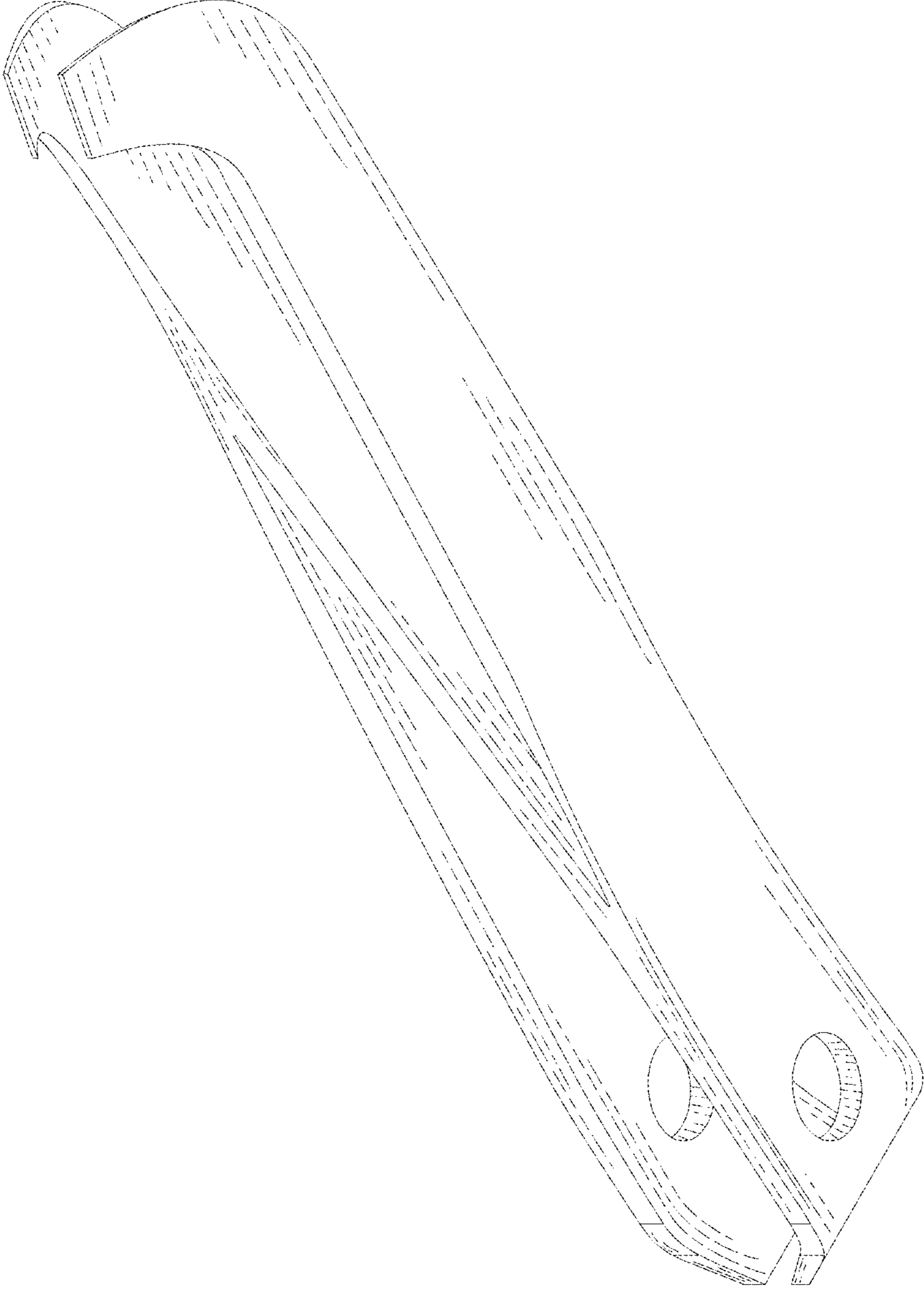

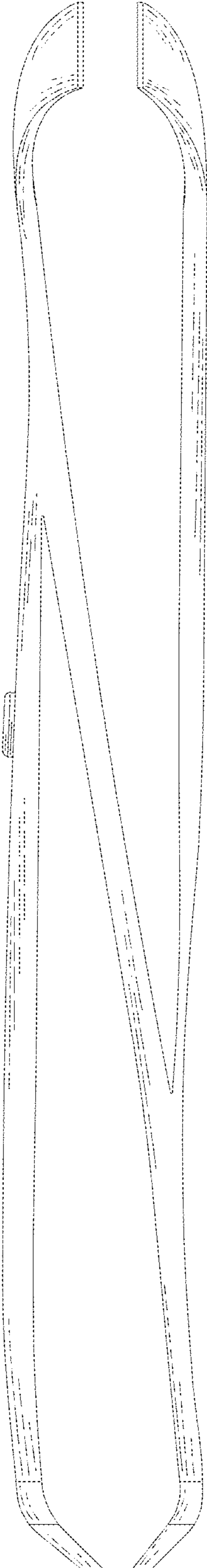

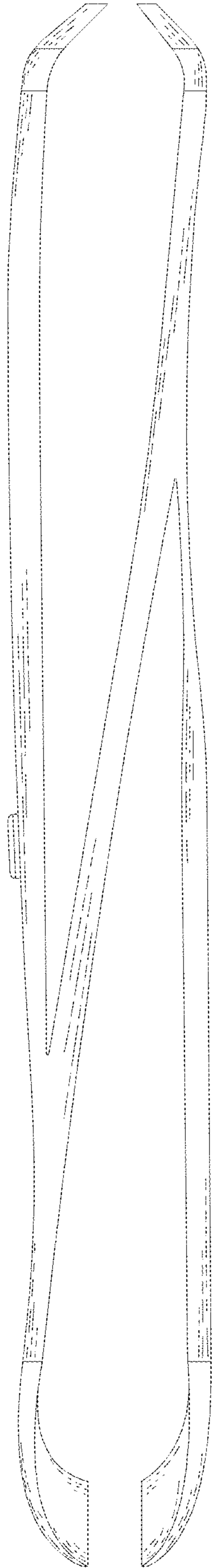

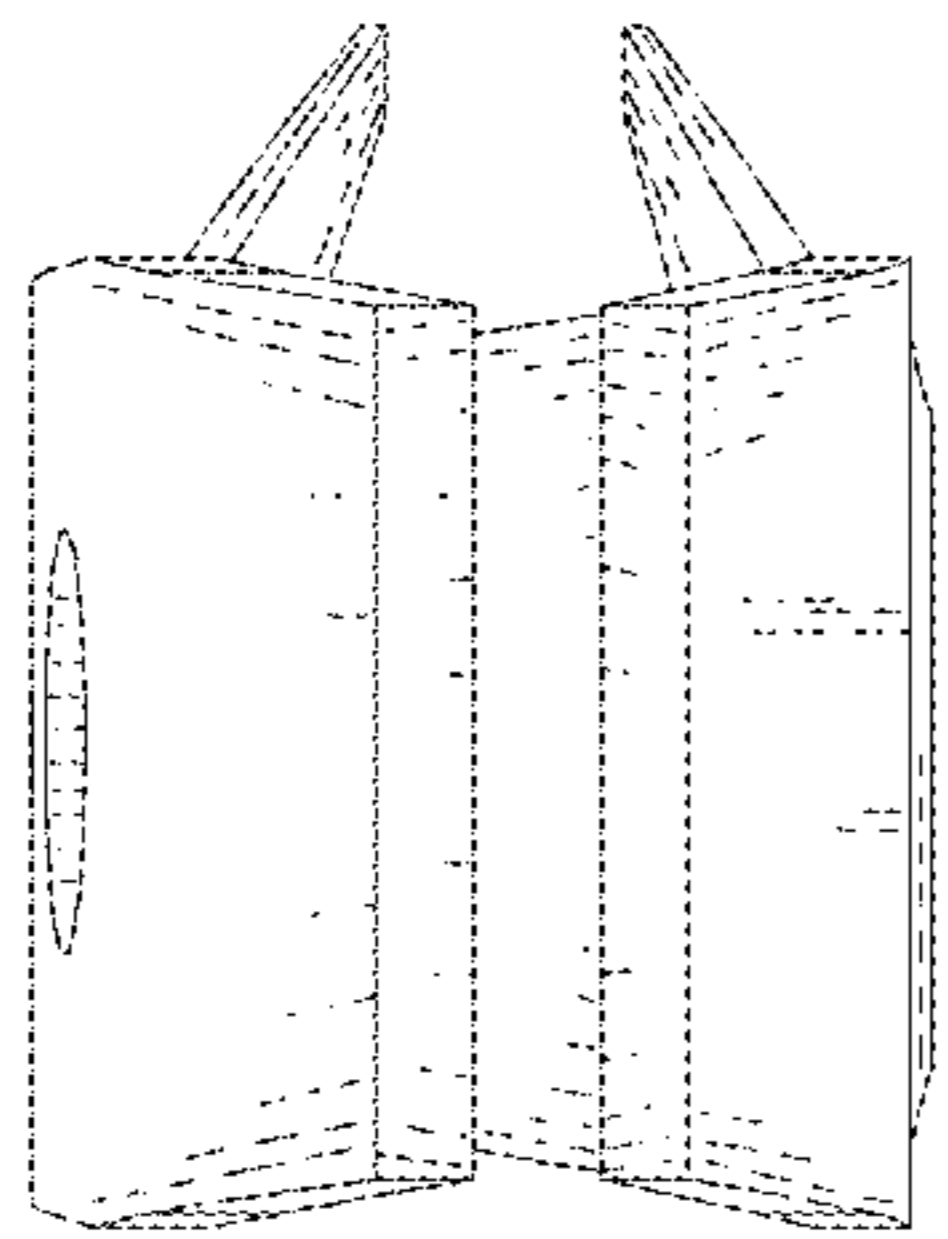

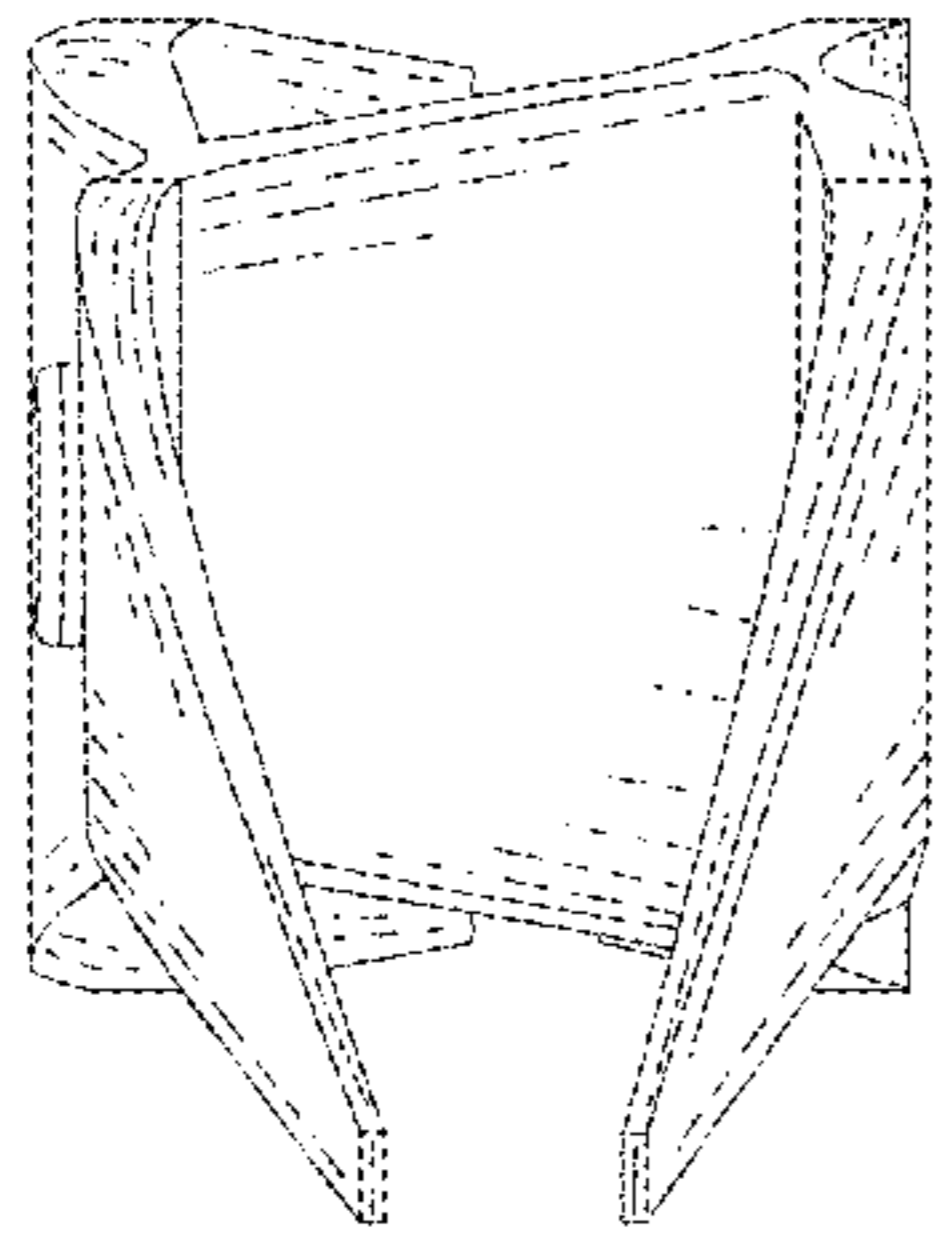

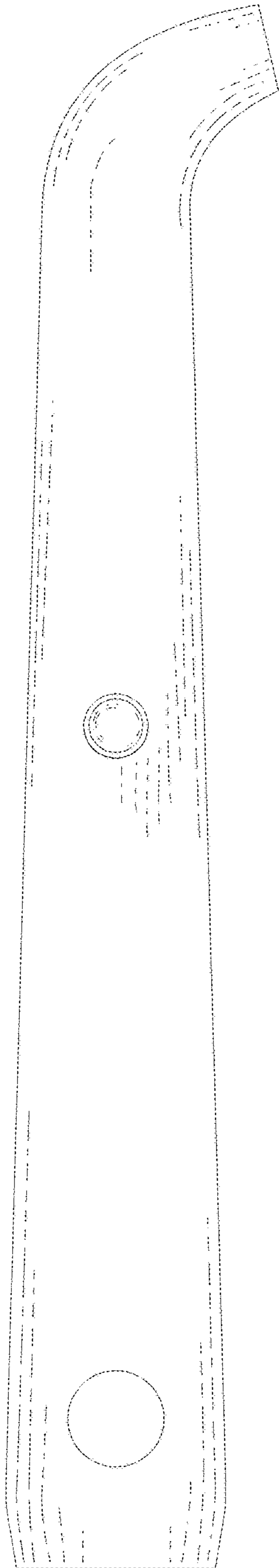

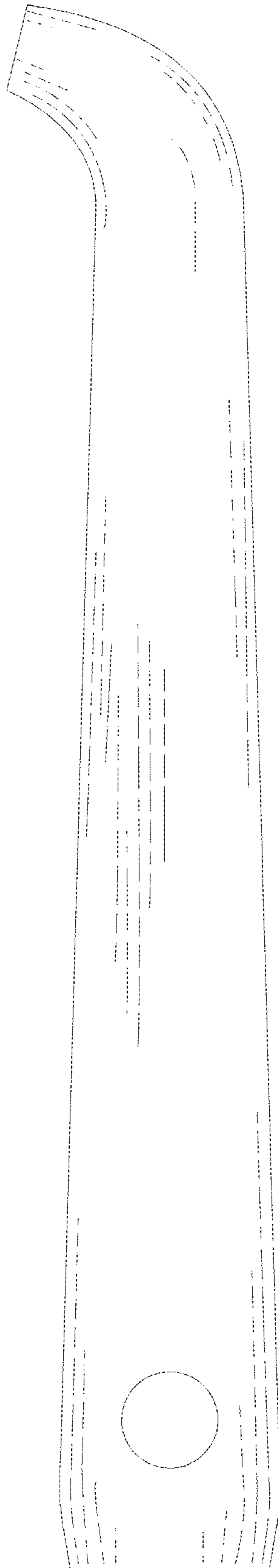

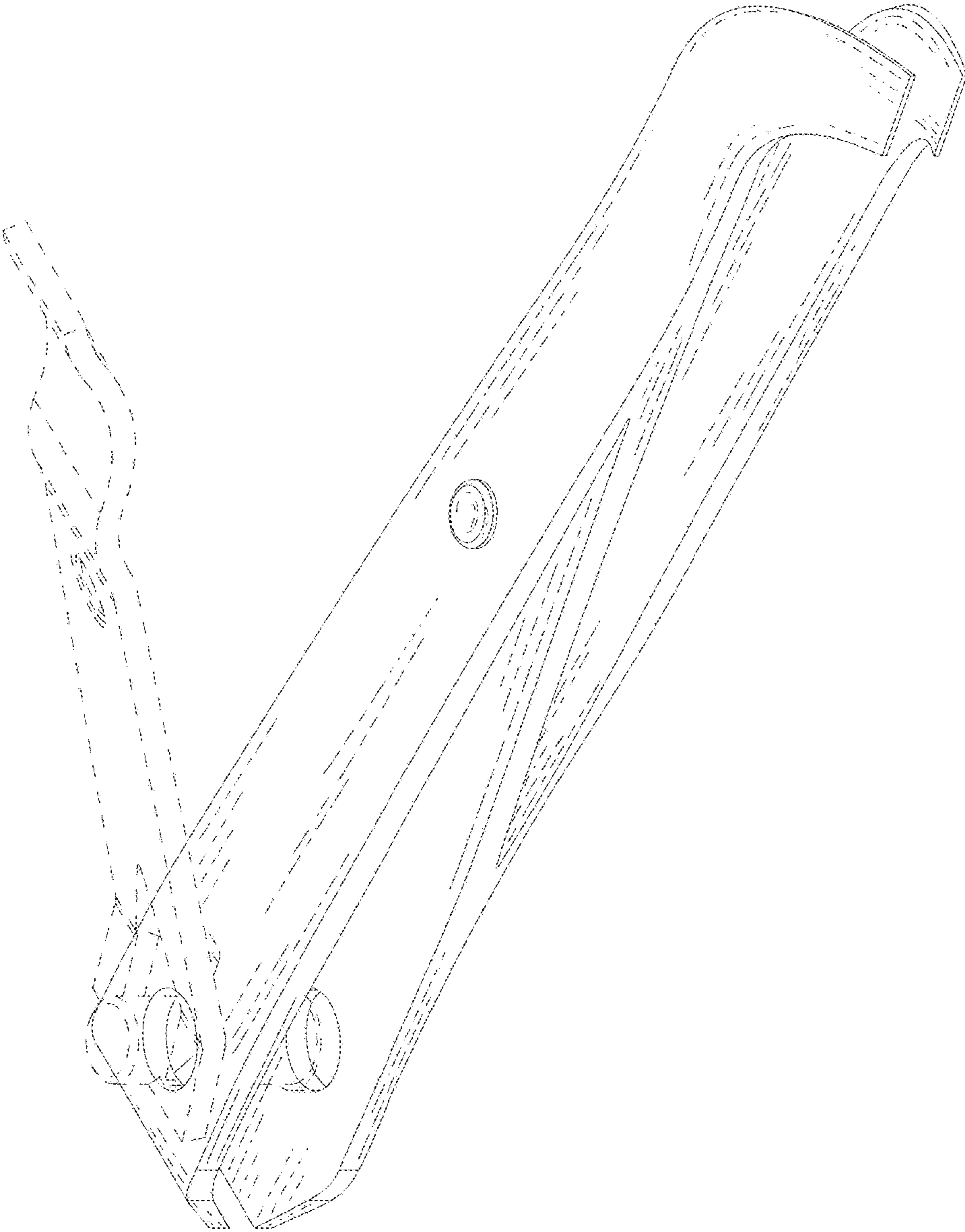

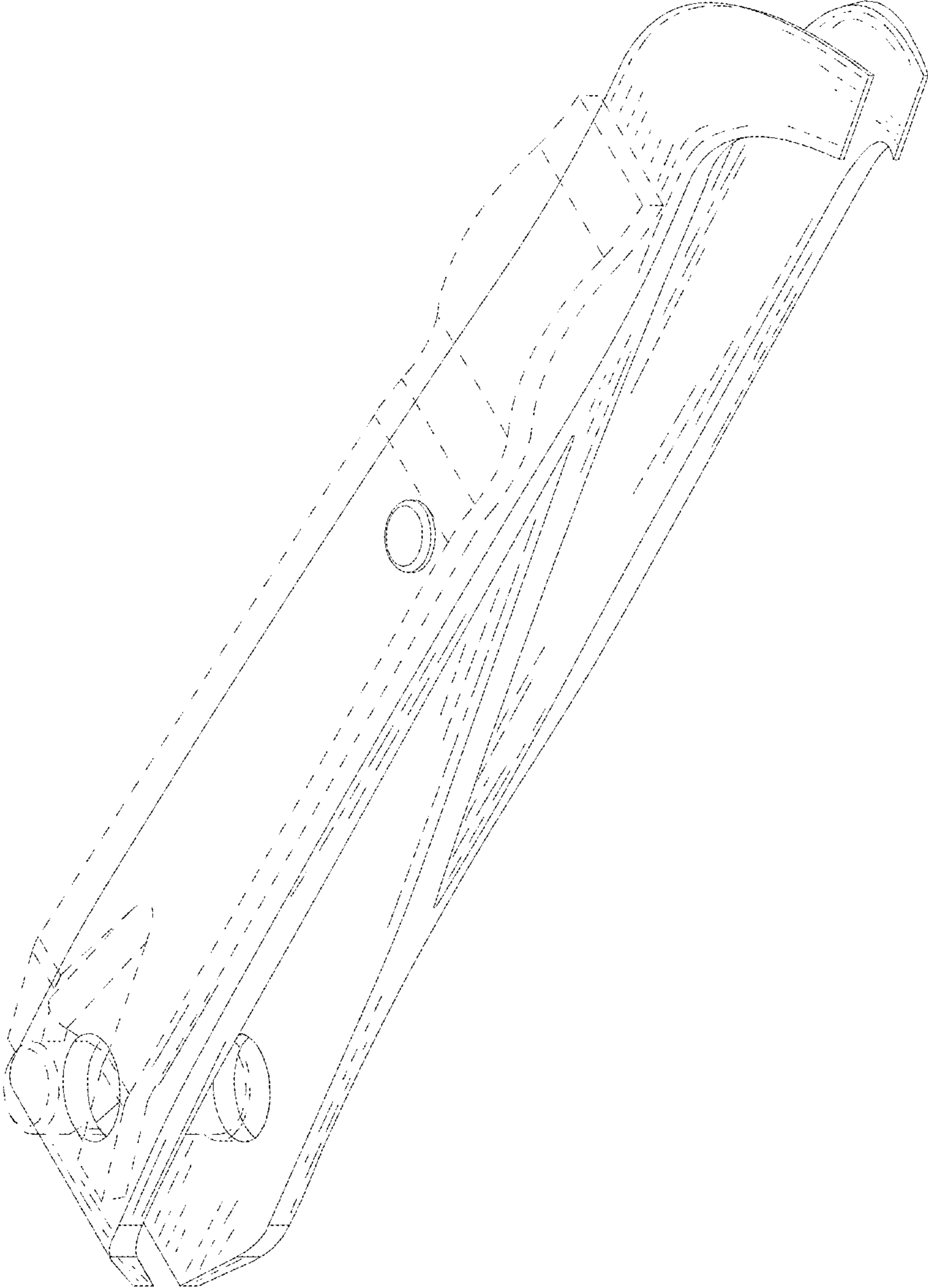
