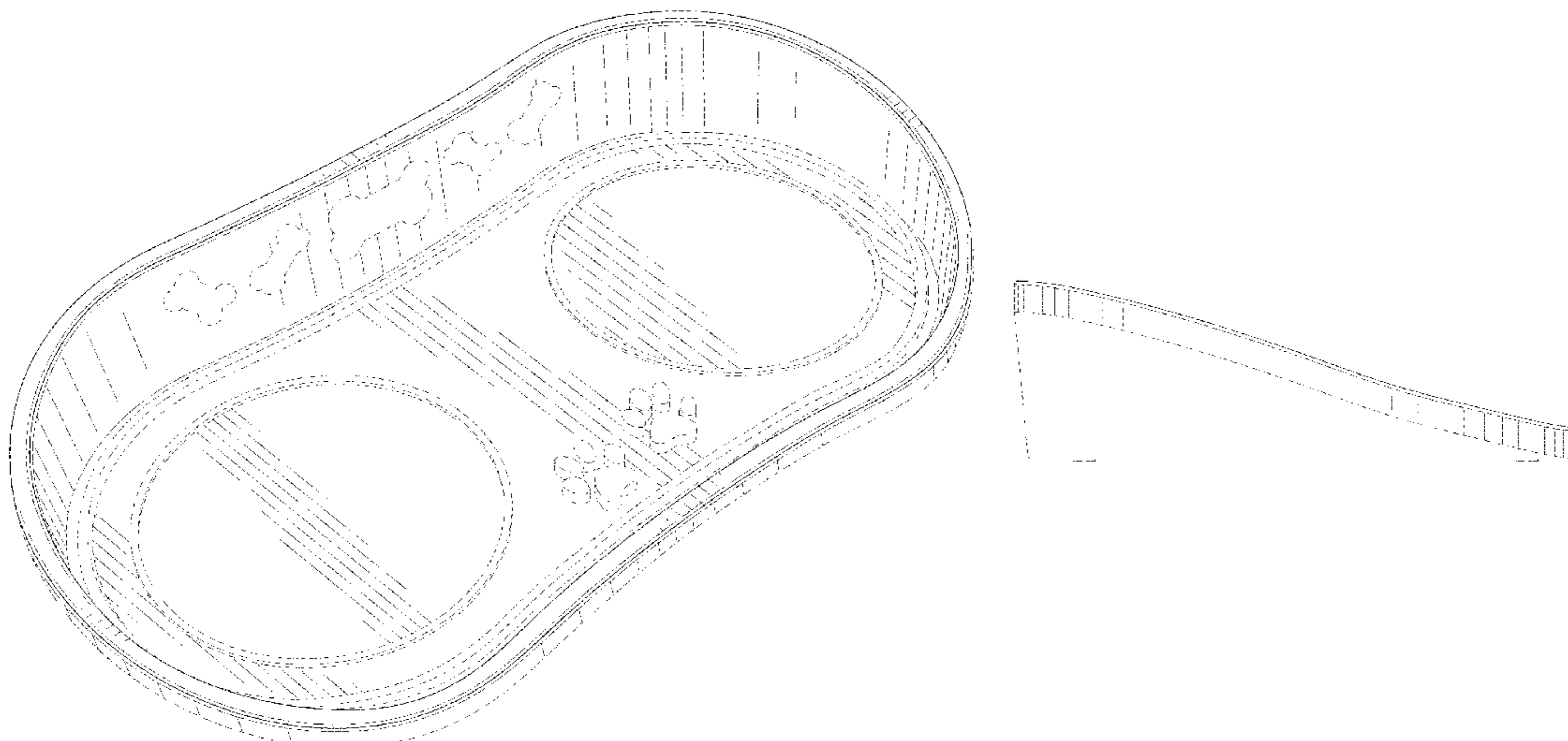
(57) **CLAIM**

The ornamental design for a bowl holder, as shown and

DESCRIPTION

FIG. 1 is a perspective view of a bowl holder design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a left side view thereof.
The broken lines shown represent unclaimed subject matter
and form no part of the claimed design.
The track of gutter surface situated immediately next to the
vertical side walls of the bowl holder also represent
unclaimed subject matter that forms no part of the design
claim.

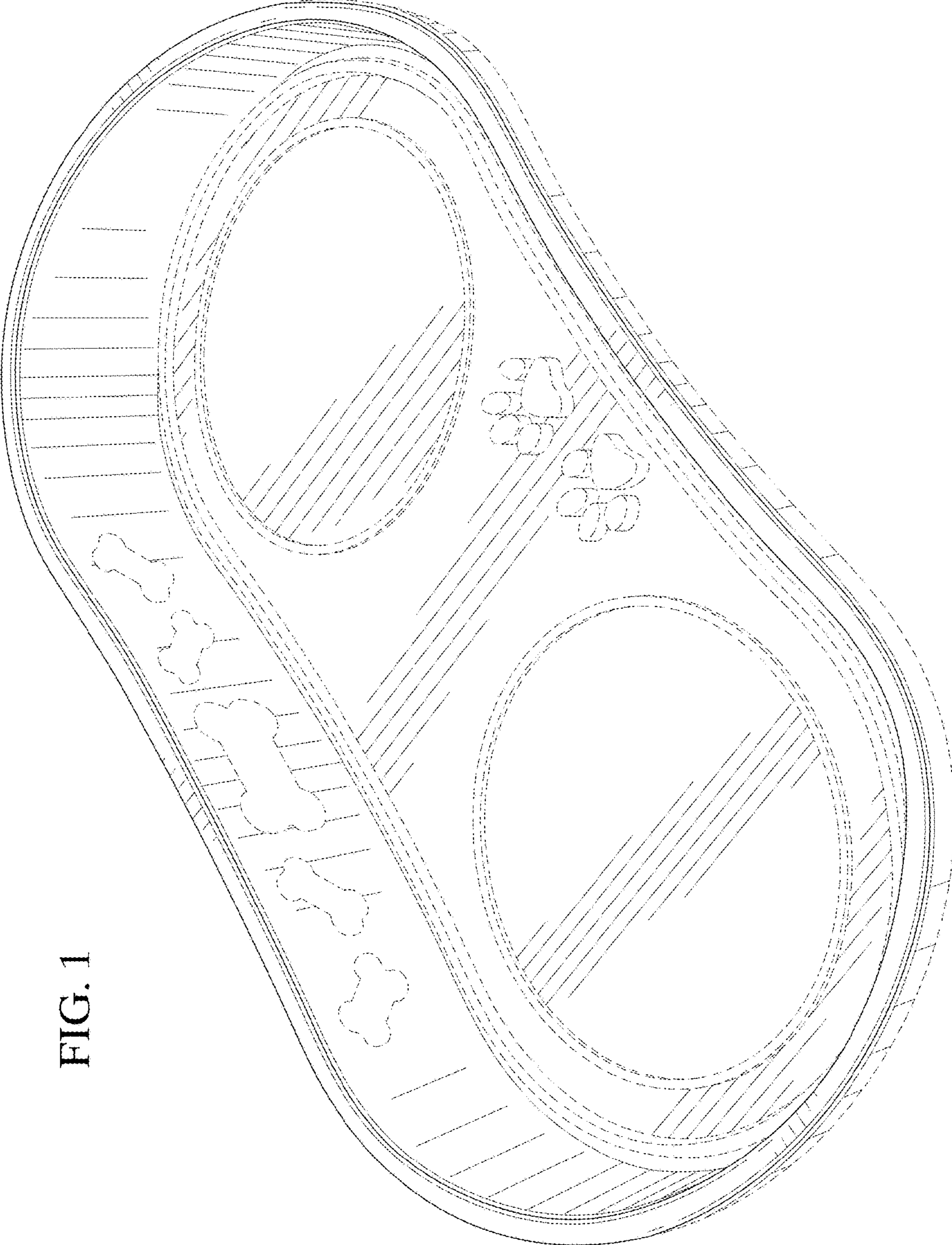

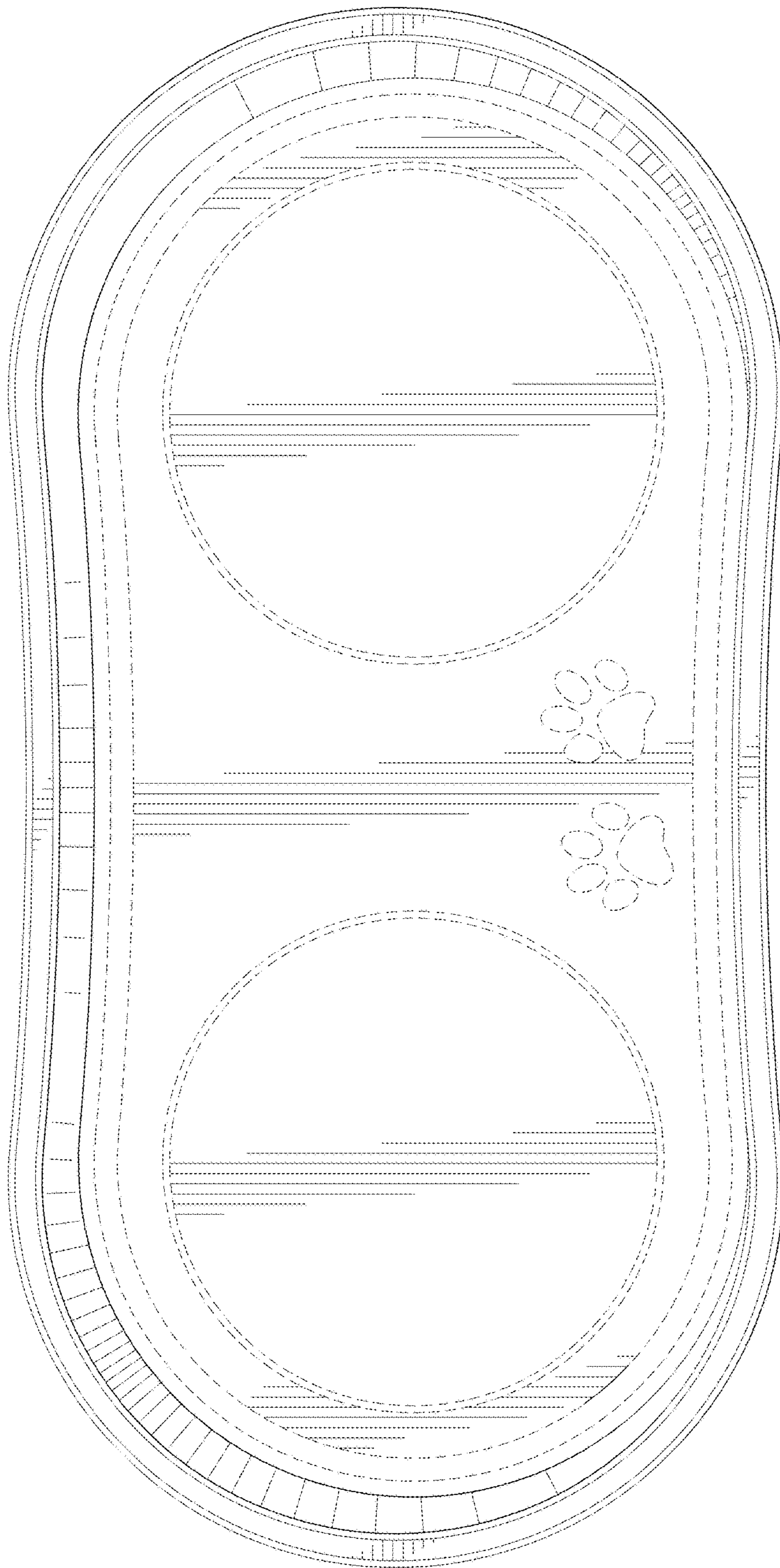

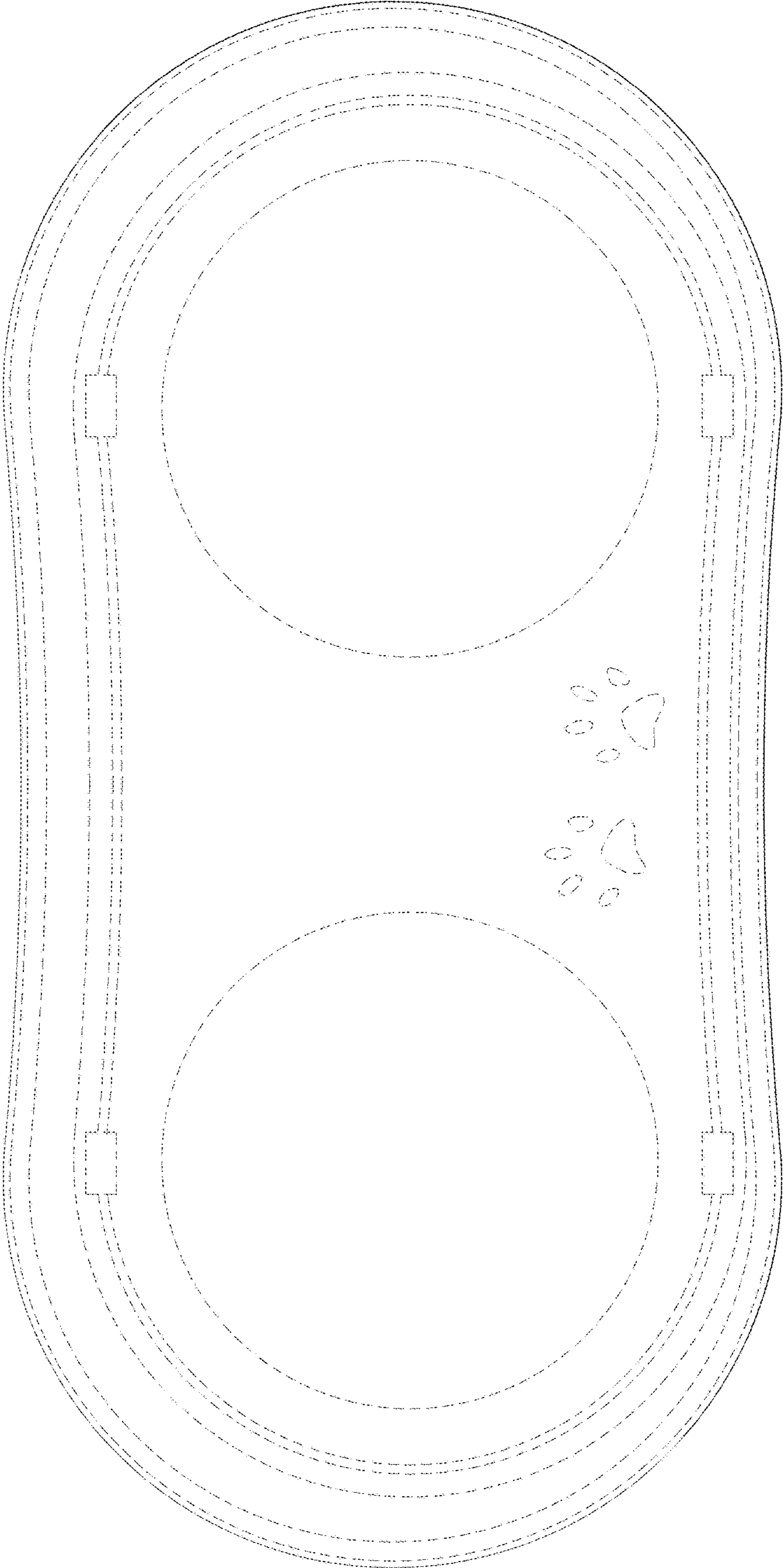

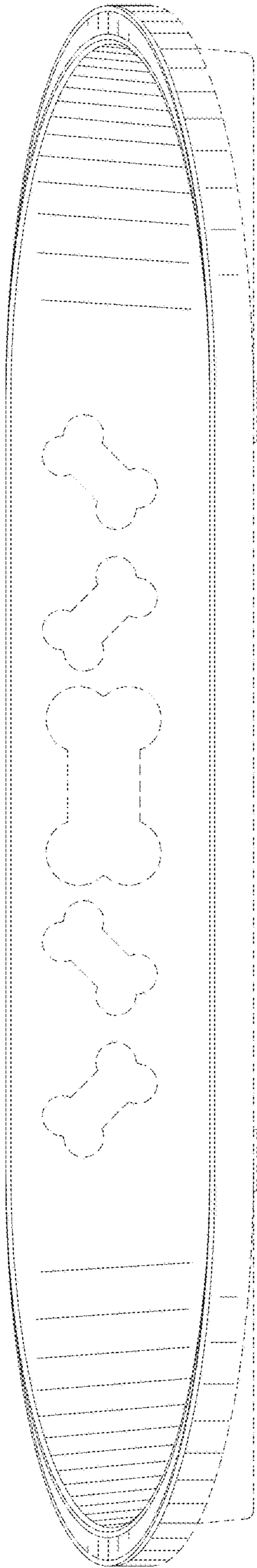

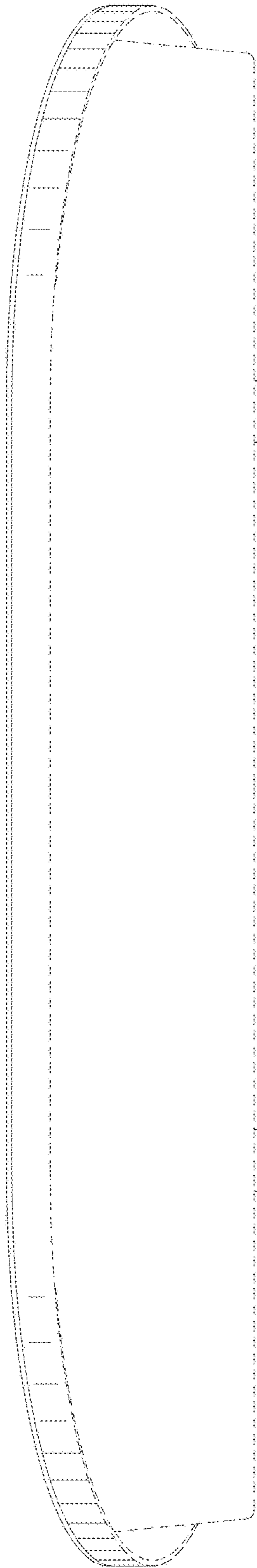

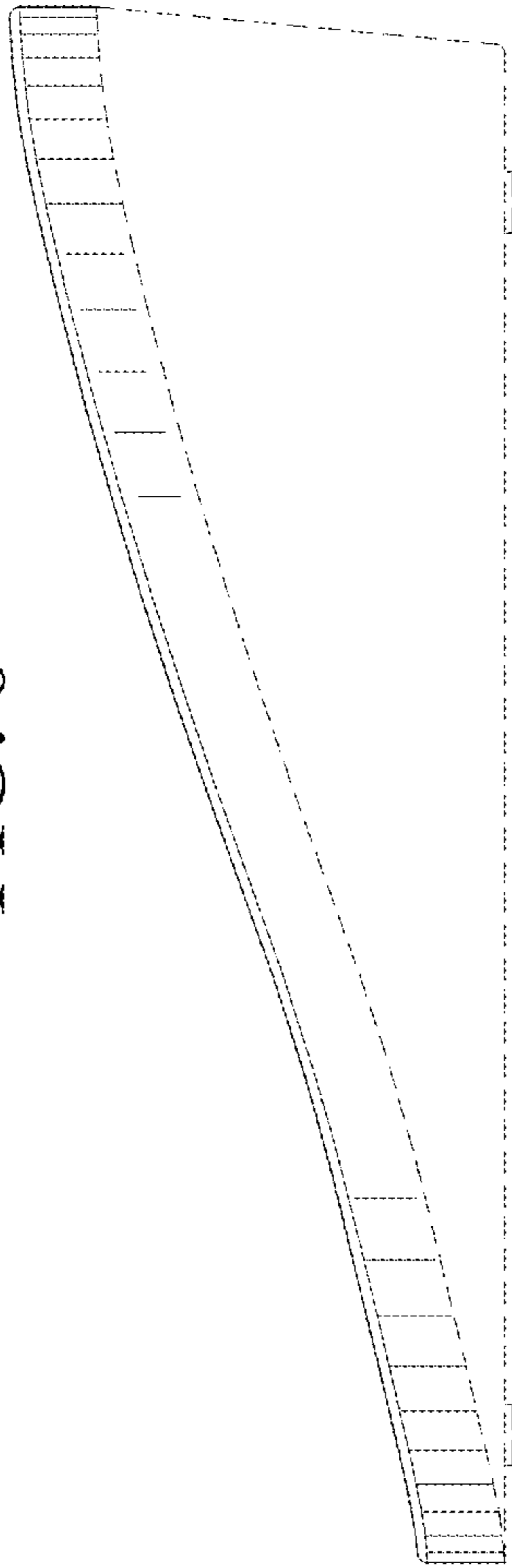
