DESCRIPTION

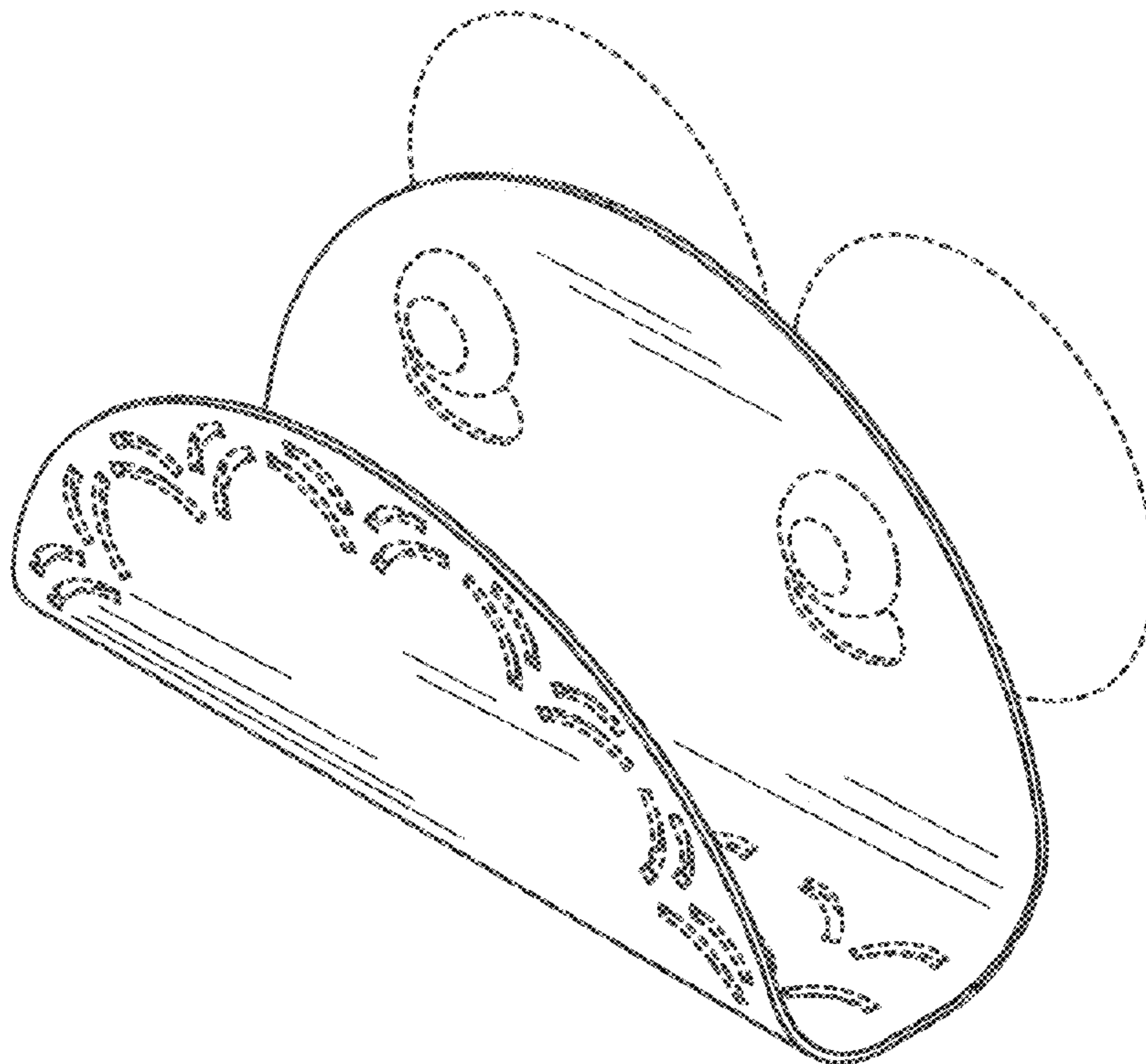
FIG. 1 is a perspective view of a sink cradle showing our new design.

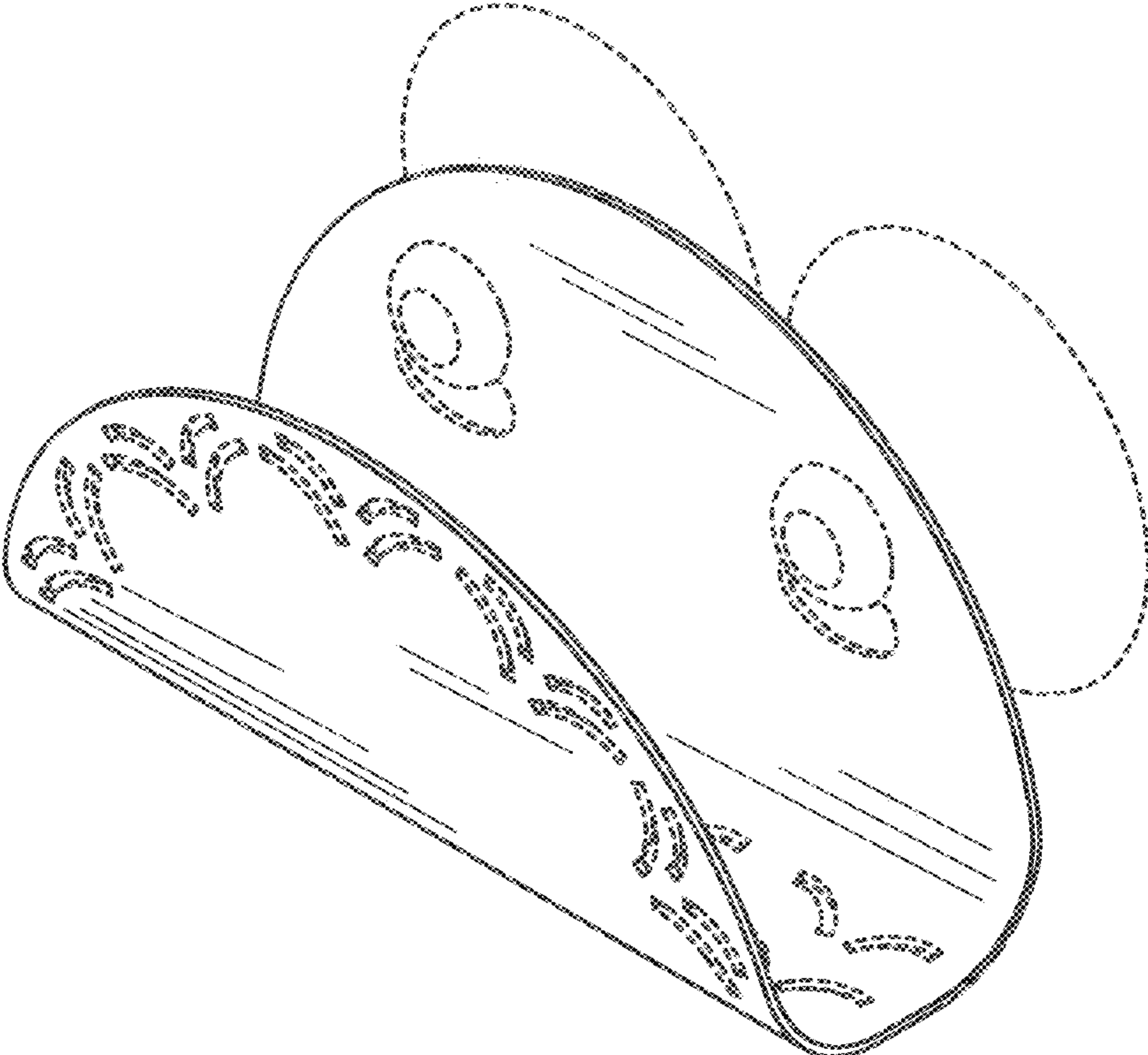

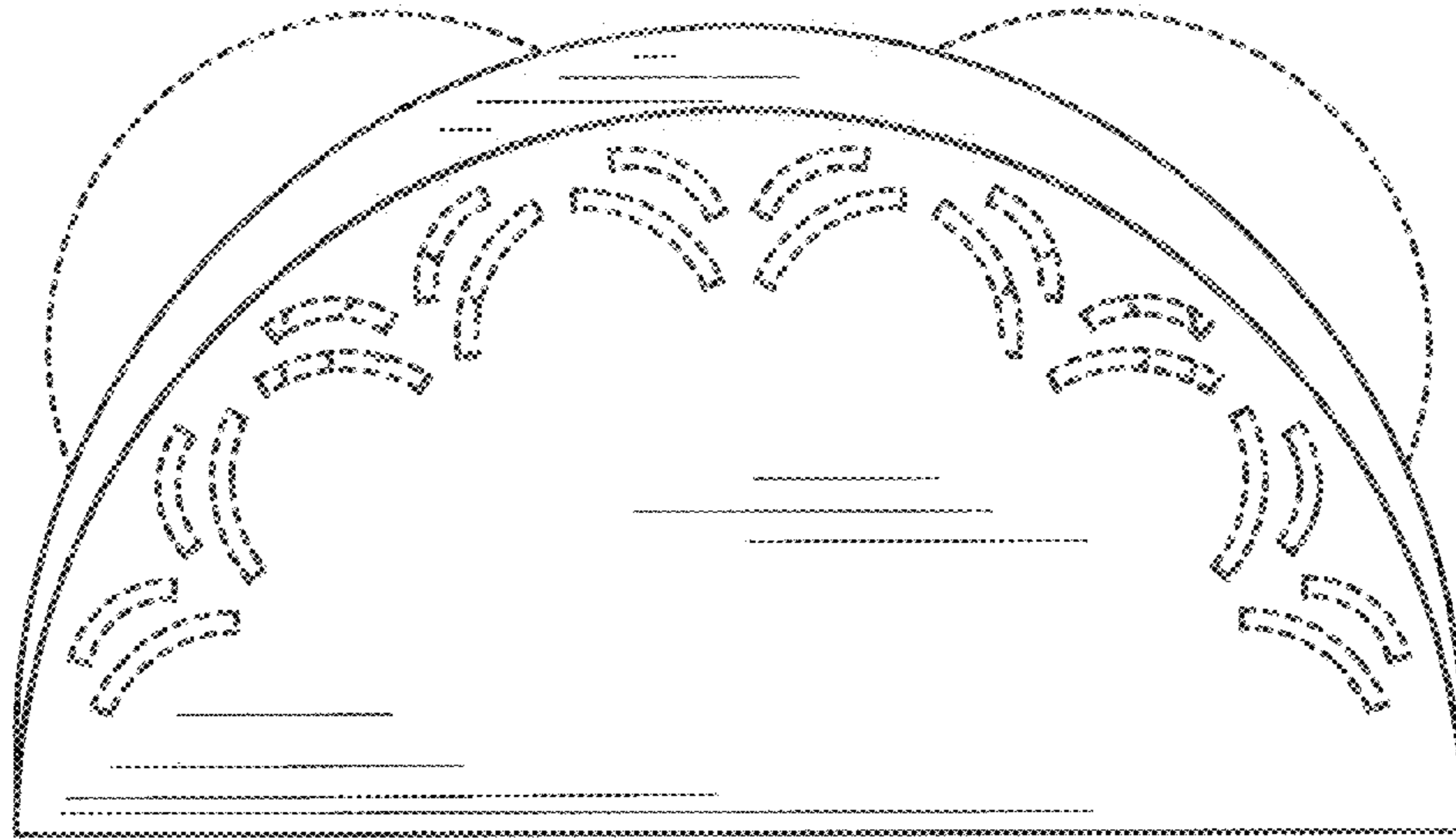

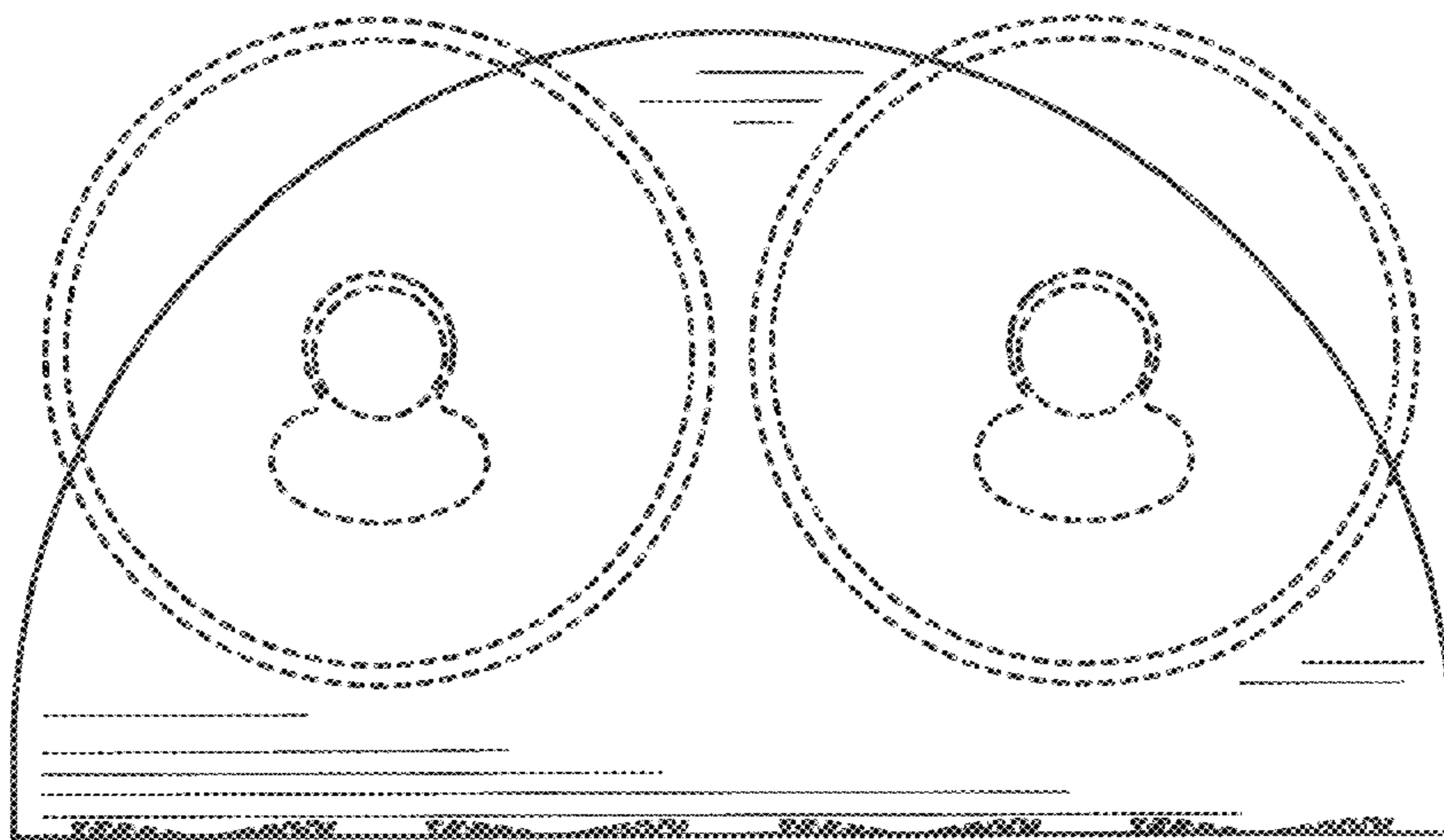

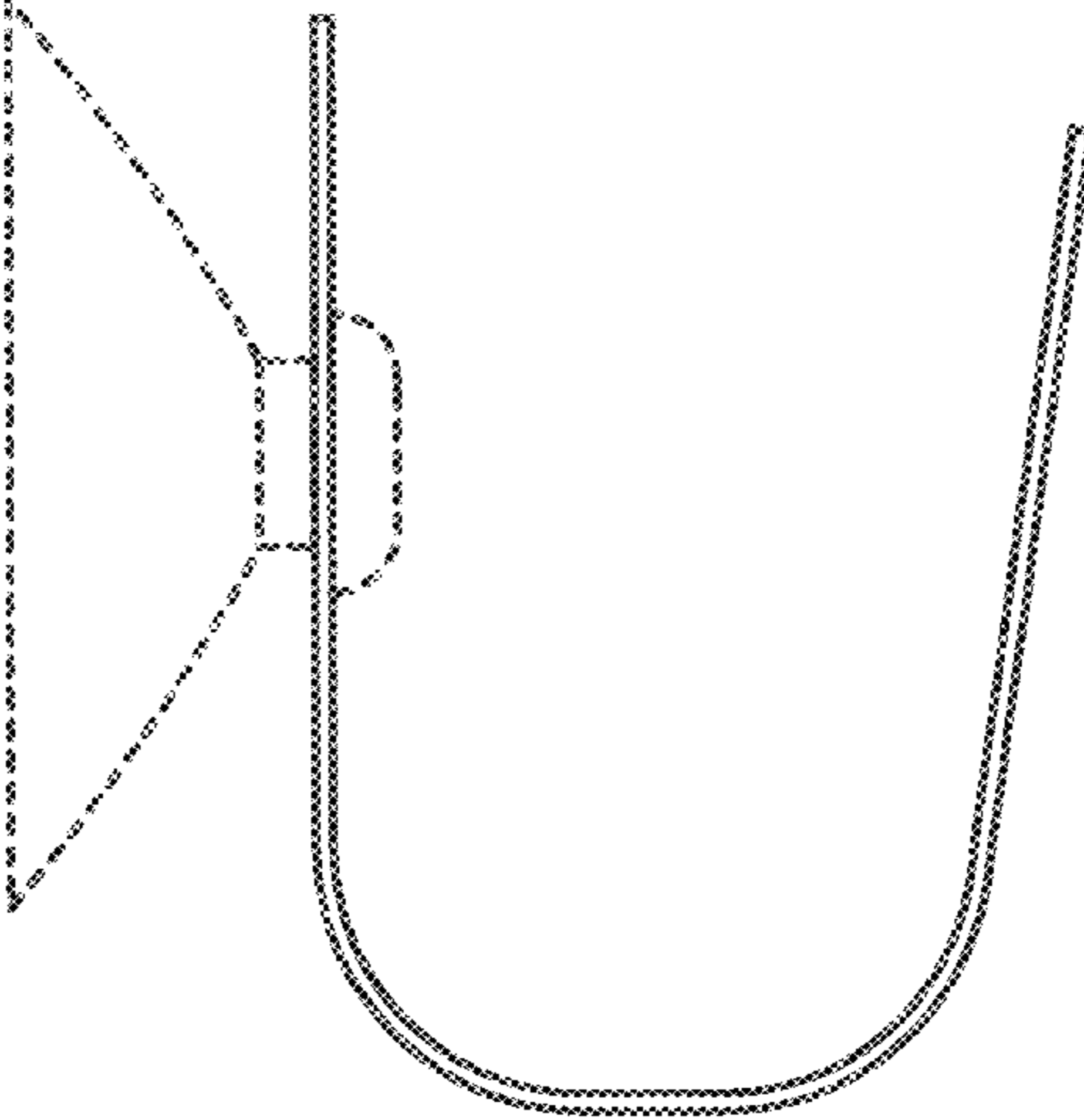

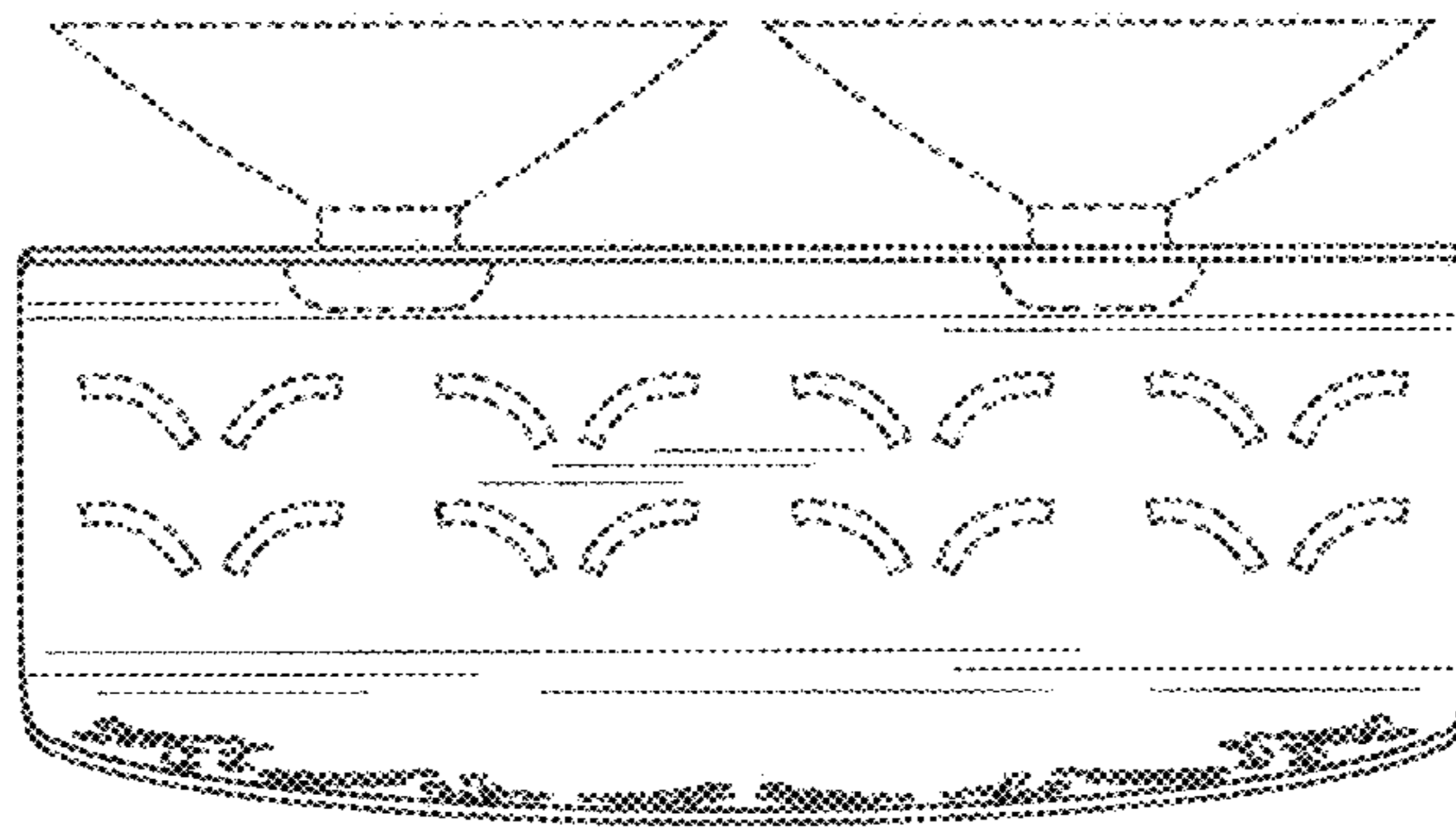

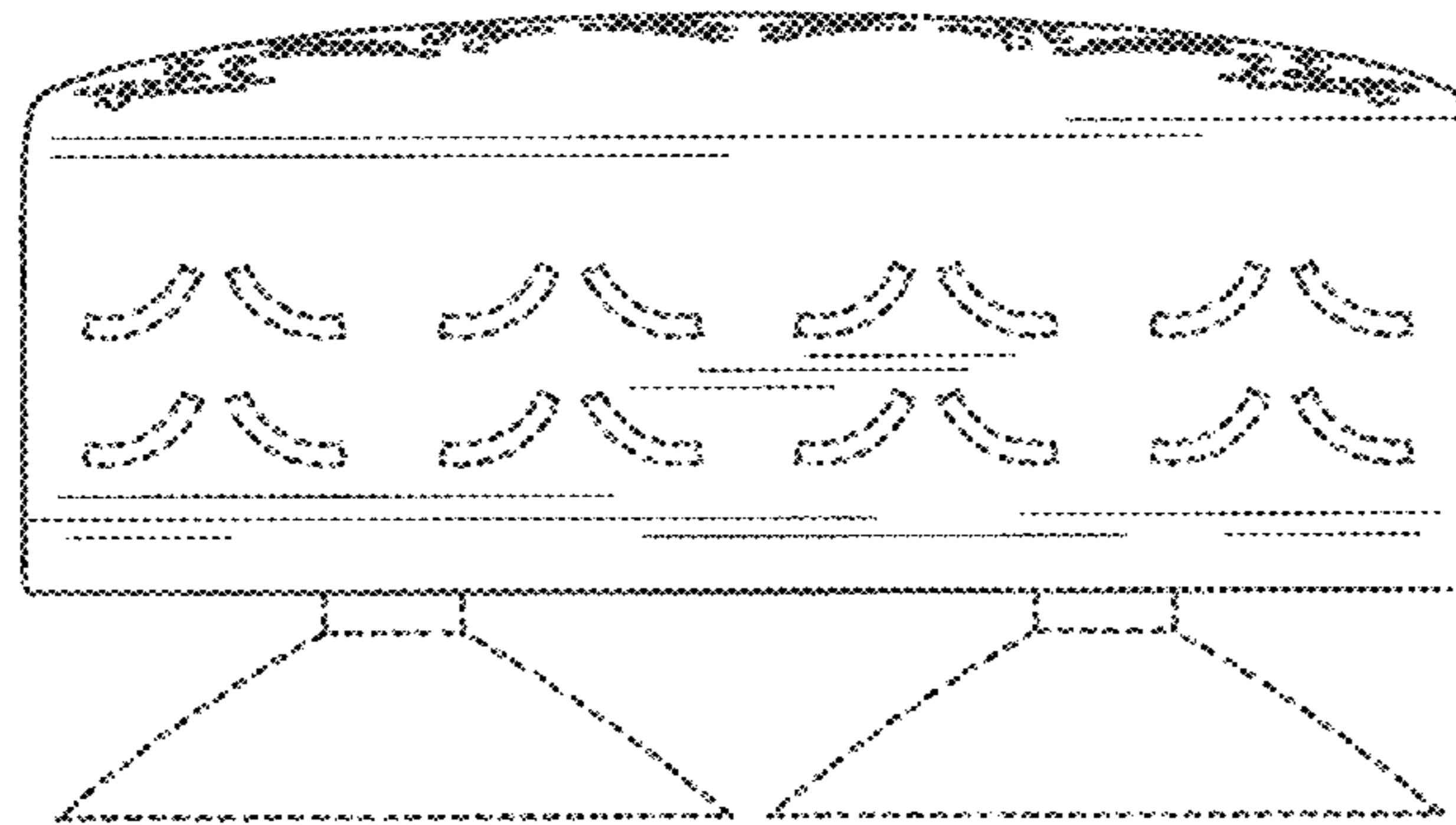
