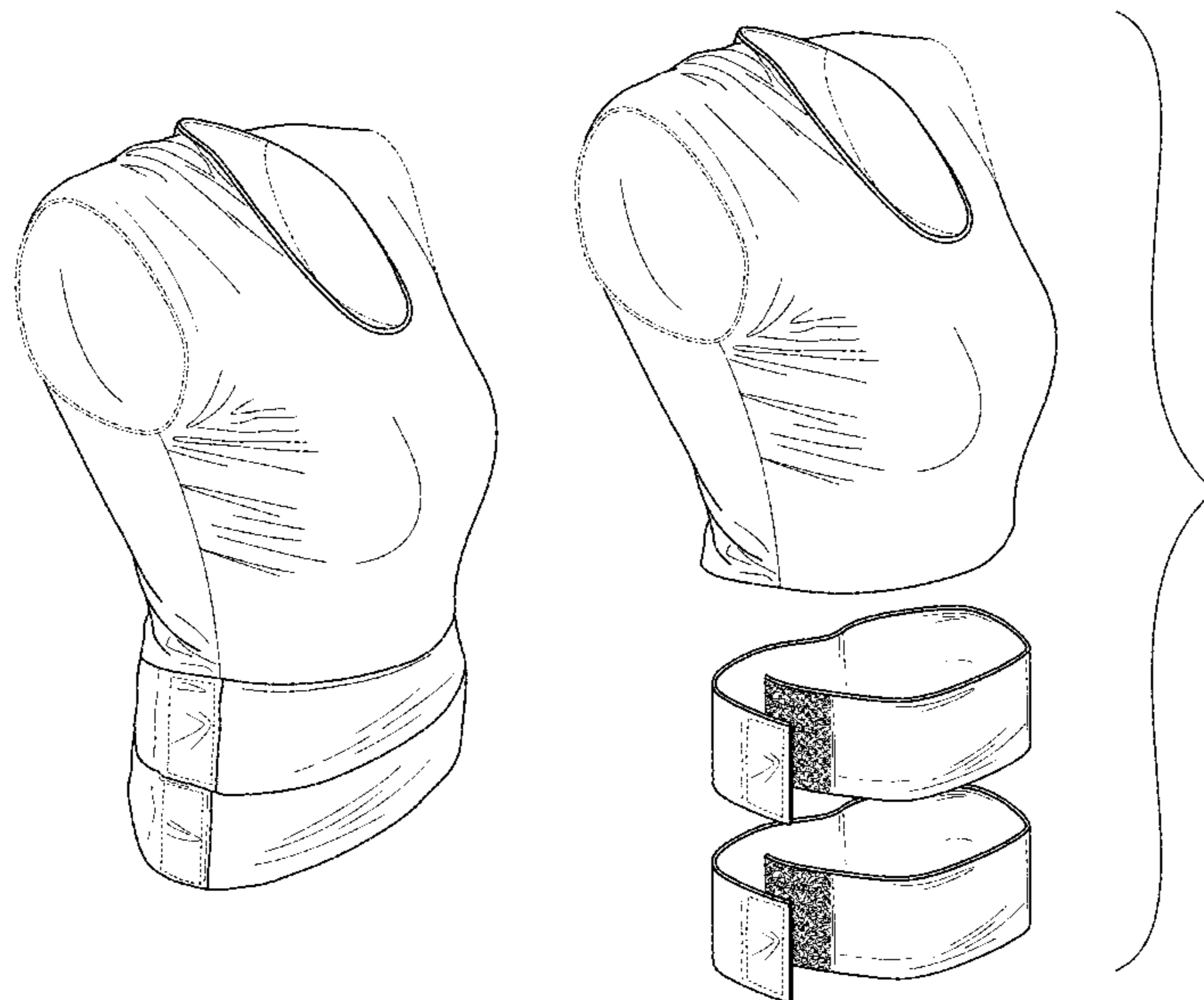
(57) **CLAIM**

I claim the ornamental design for a shirt with adjustable straps, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shirt with adjustable straps, showing a first embodiment of my new design;  
 FIG. 2 is an exploded perspective view of FIG. 1;  
 FIG. 3 is a front elevational view of FIG. 1;  
 FIG. 4 is a rear elevational view of FIG. 1;  
 FIG. 5 is a left-side elevational view of FIG. 1;  
 FIG. 6 is a right-side elevational view of FIG. 1;  
 FIG. 7 is a top plan view of FIG. 1;  
 FIG. 8 is a bottom plan view of FIG. 1;  
 FIG. 9 is a front elevational view of one of the adjustable straps thereof, the shirt and additional adjustable strap omitted for clarity of design;  
 FIG. 10 is a rear elevational view of FIG. 9;  
 FIG. 11 is a top plan view of FIG. 9, the bottom plan view being a mirror image thereof;  
 FIG. 12 is a perspective view of a second embodiment thereof; and  
 FIG. 13 is an exploded perspective view of FIG. 12.  
 FIG. 14 is a front elevational view of FIG. 12;  
 FIG. 15 is a rear elevational view of FIG. 12;  
 FIG. 16 is a left-side elevational view of FIG. 12;  
 FIG. 17 is a right-side elevational view of FIG. 12;  
 FIG. 18 is a top plan view of FIG. 12;  
 FIG. 19 is a bottom plan view of FIG. 12;  
 FIG. 20 is a perspective view of a third embodiment thereof;  
 FIG. 21 is an exploded perspective view of FIG. 20;  
 FIG. 22 is a front elevational view of FIG. 20;  
 FIG. 23 is a rear elevational view of FIG. 20;  
 FIG. 24 is a left-side elevational view of FIG. 20; and  
 FIG. 25 is a right-side elevational view of FIG. 20.  
 FIG. 26 is a top plan view of FIG. 20; and,  
 FIG. 27 is a bottom plan view of FIG. 20.  
 The dot-dash broken lines in the figures represent a boundary of the claimed design. The remaining broken lines represent stitching, and are part of the claimed design.

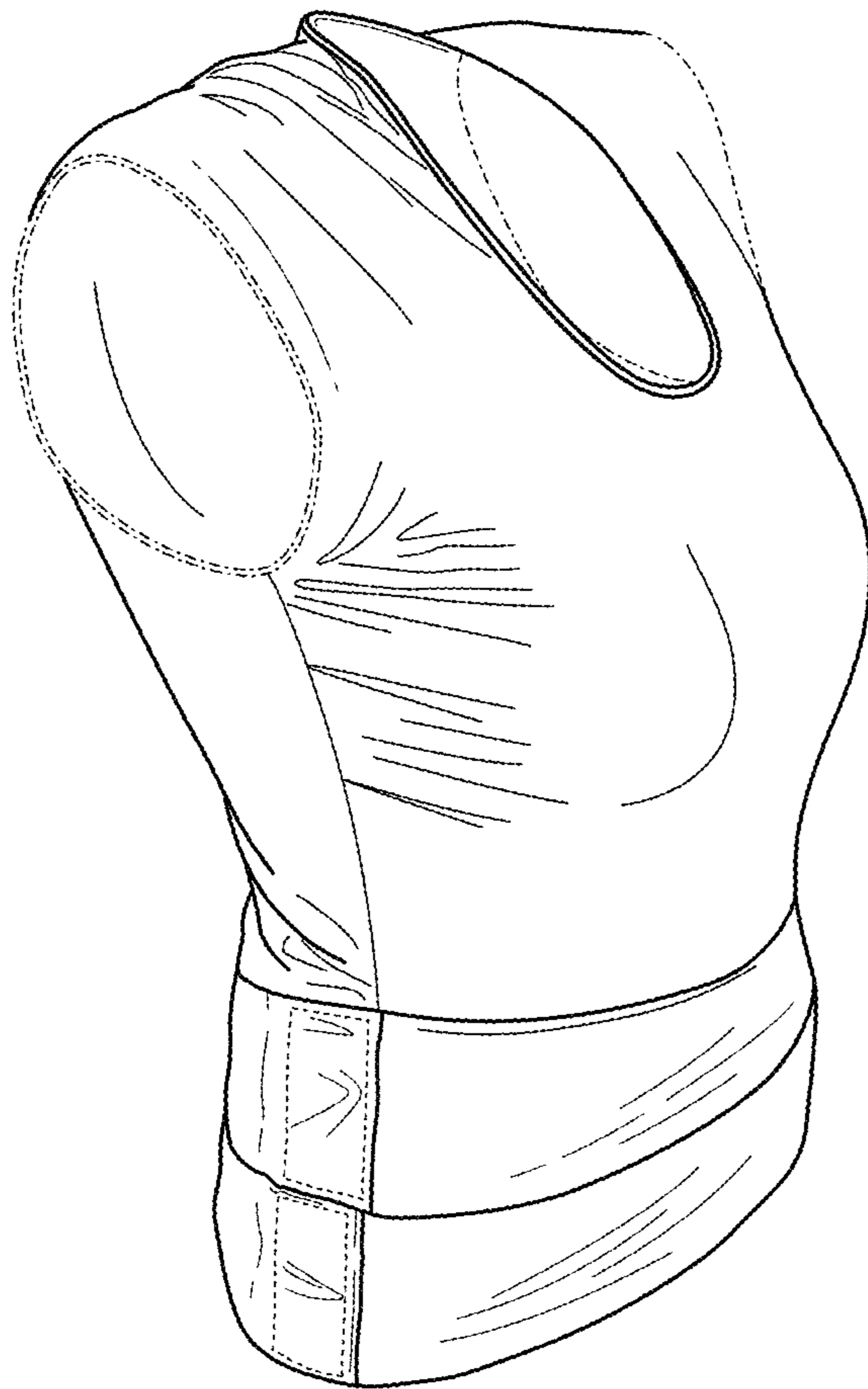

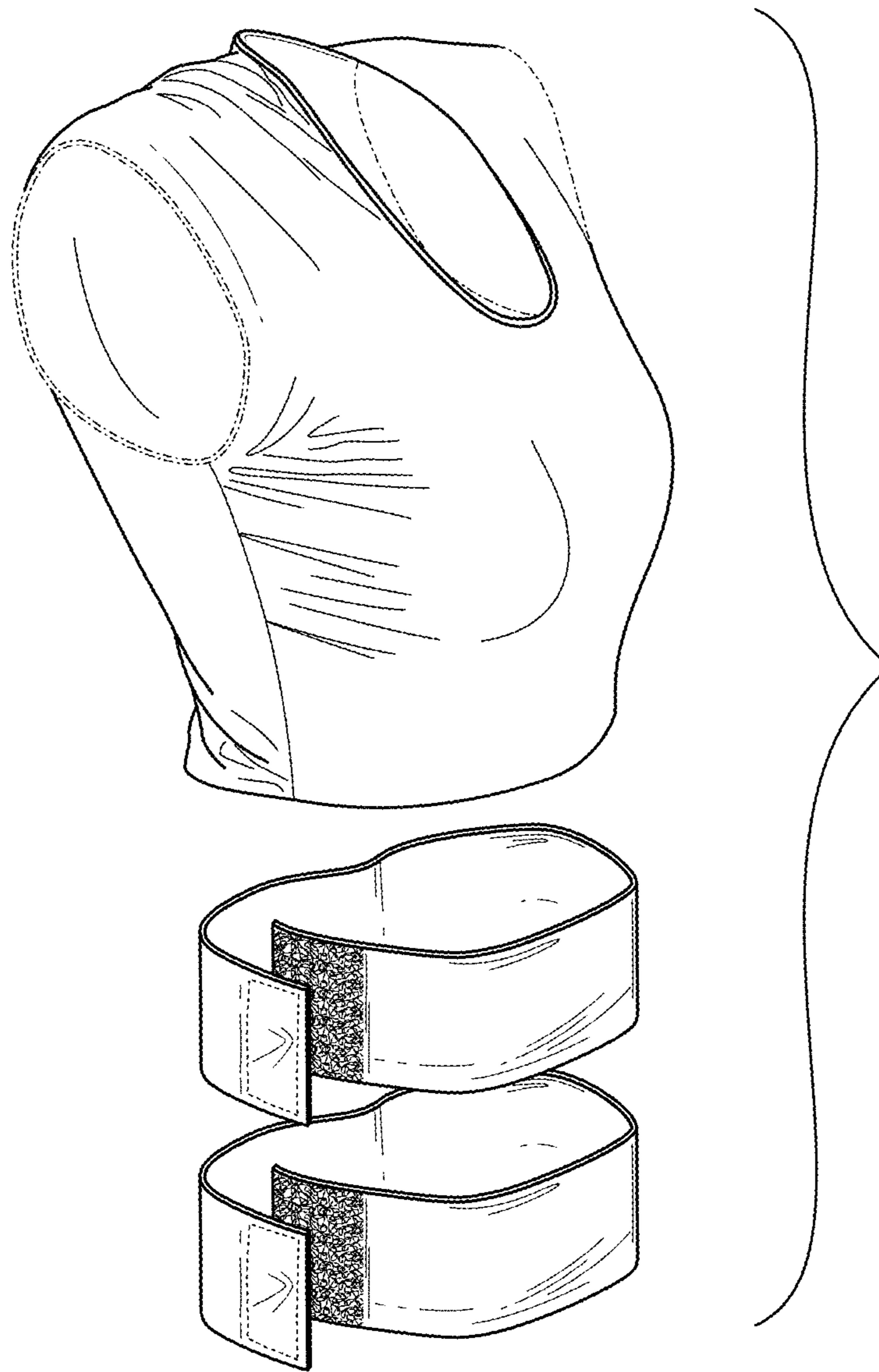

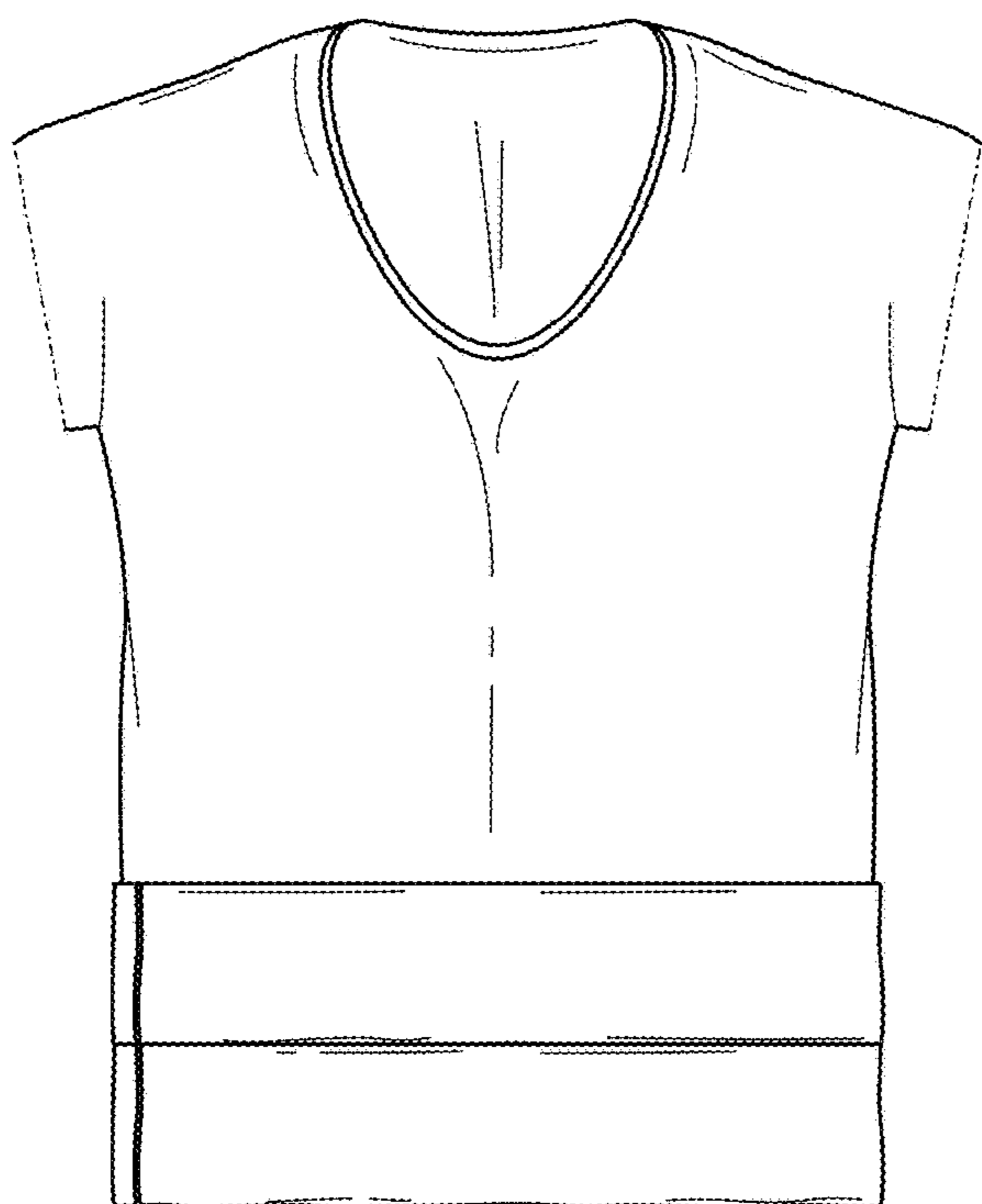

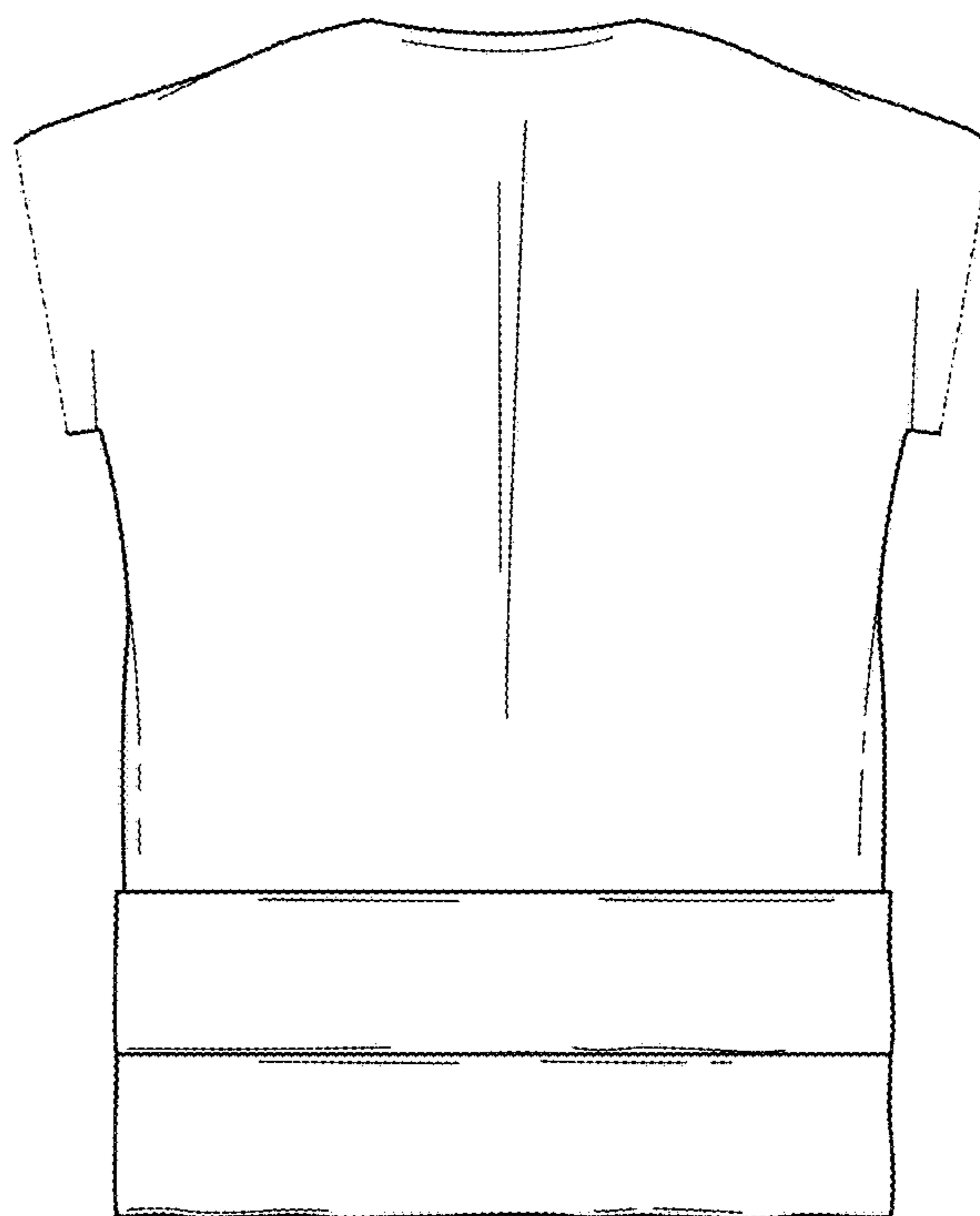

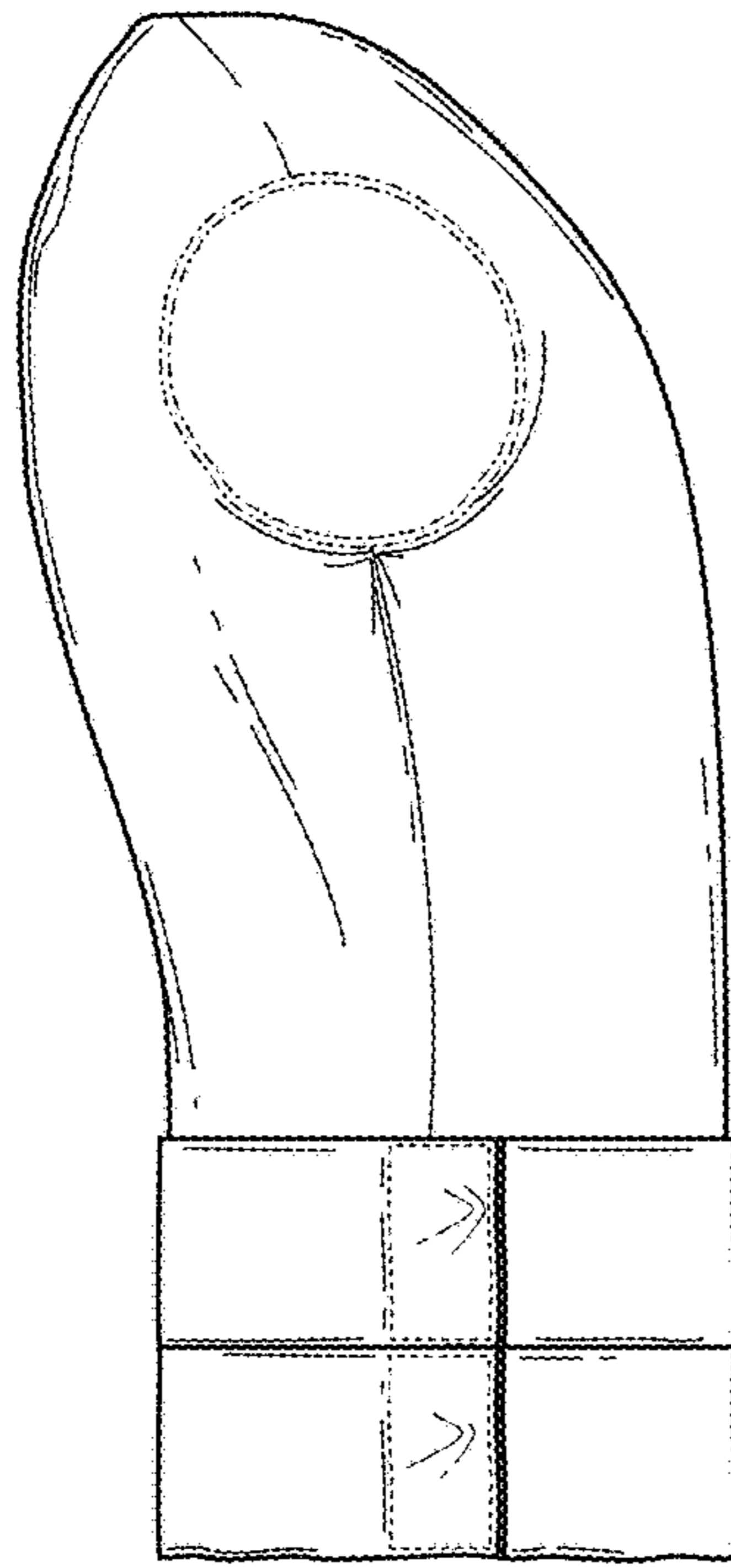

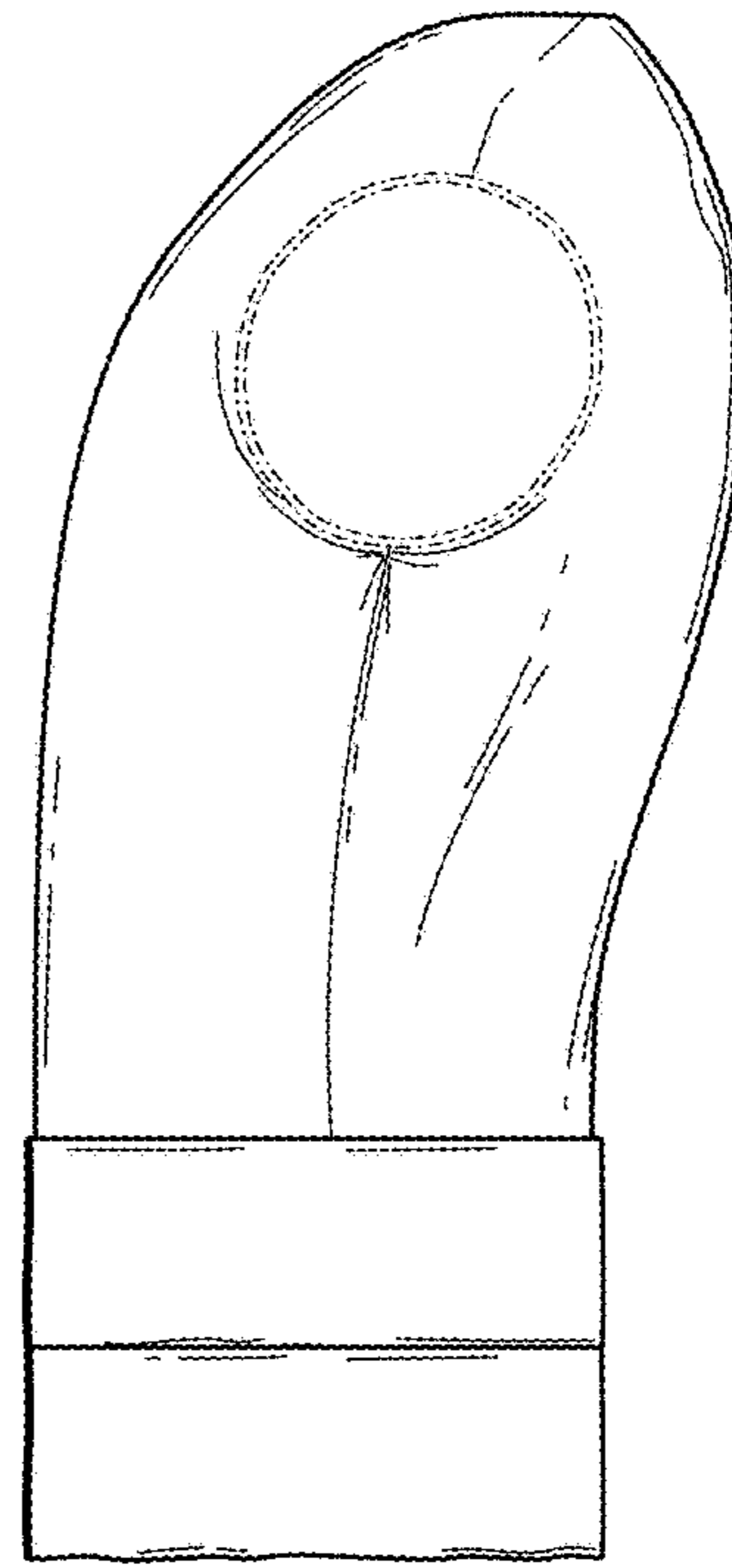

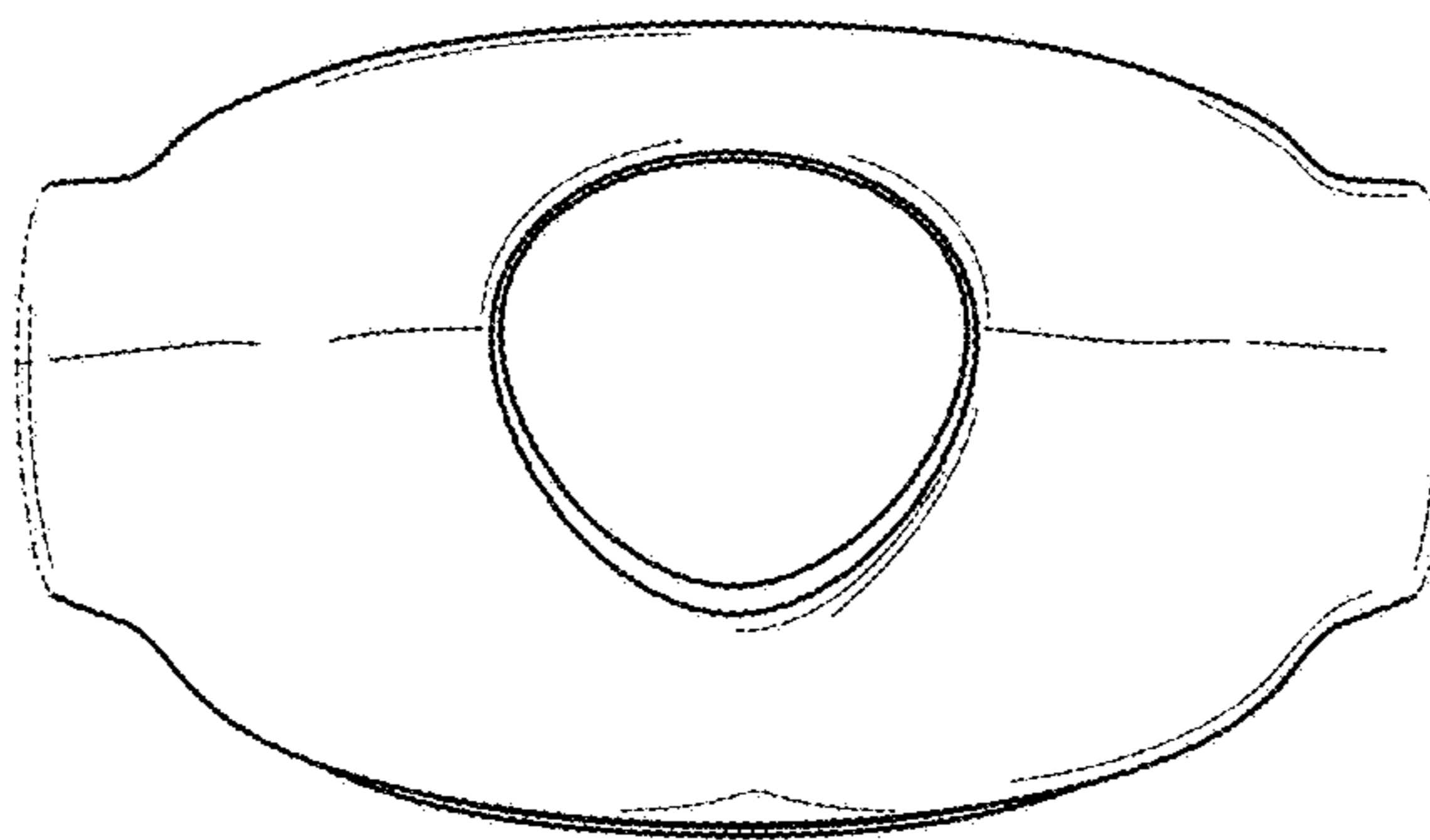

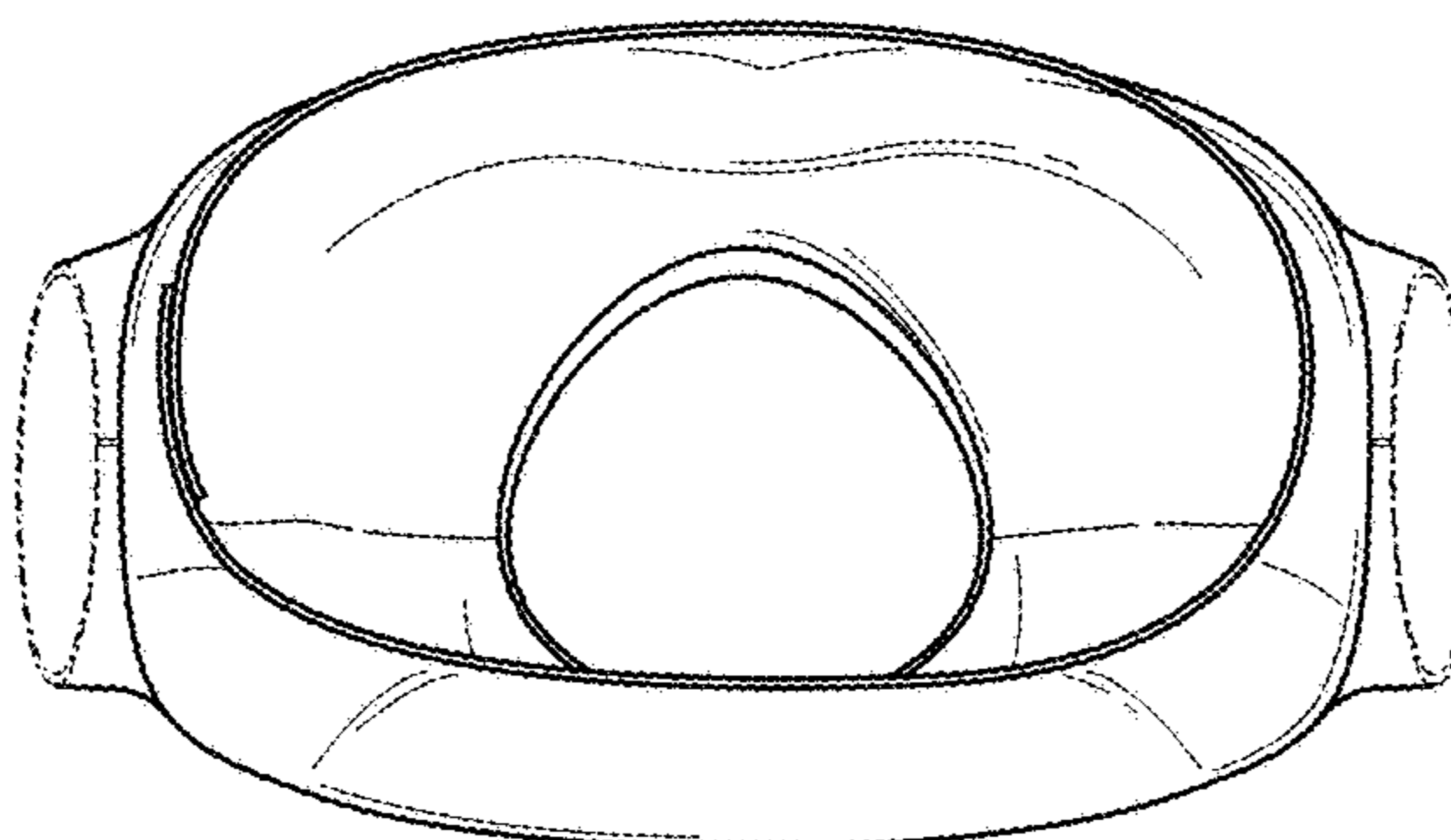

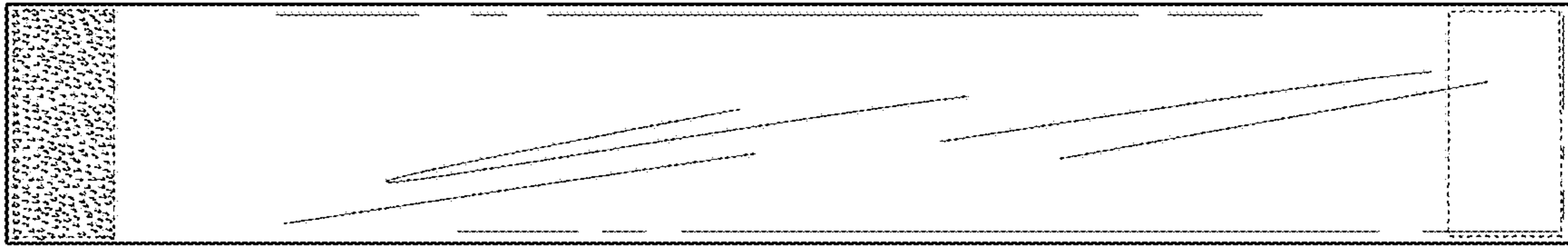

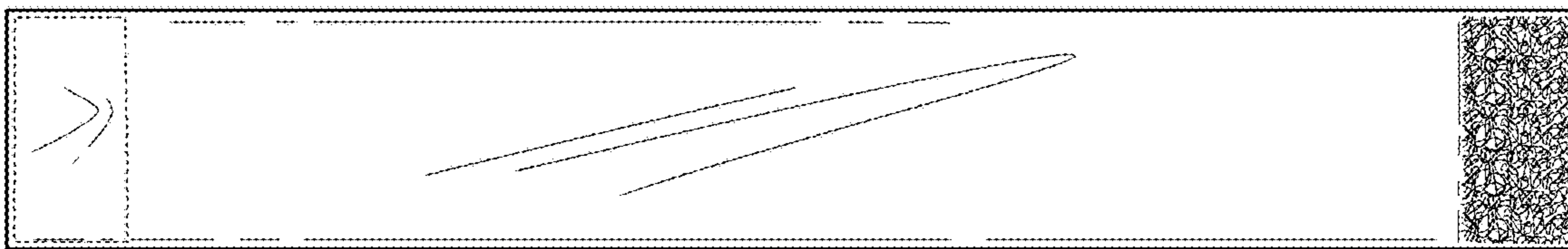

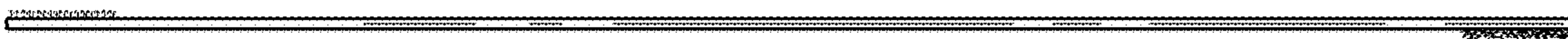

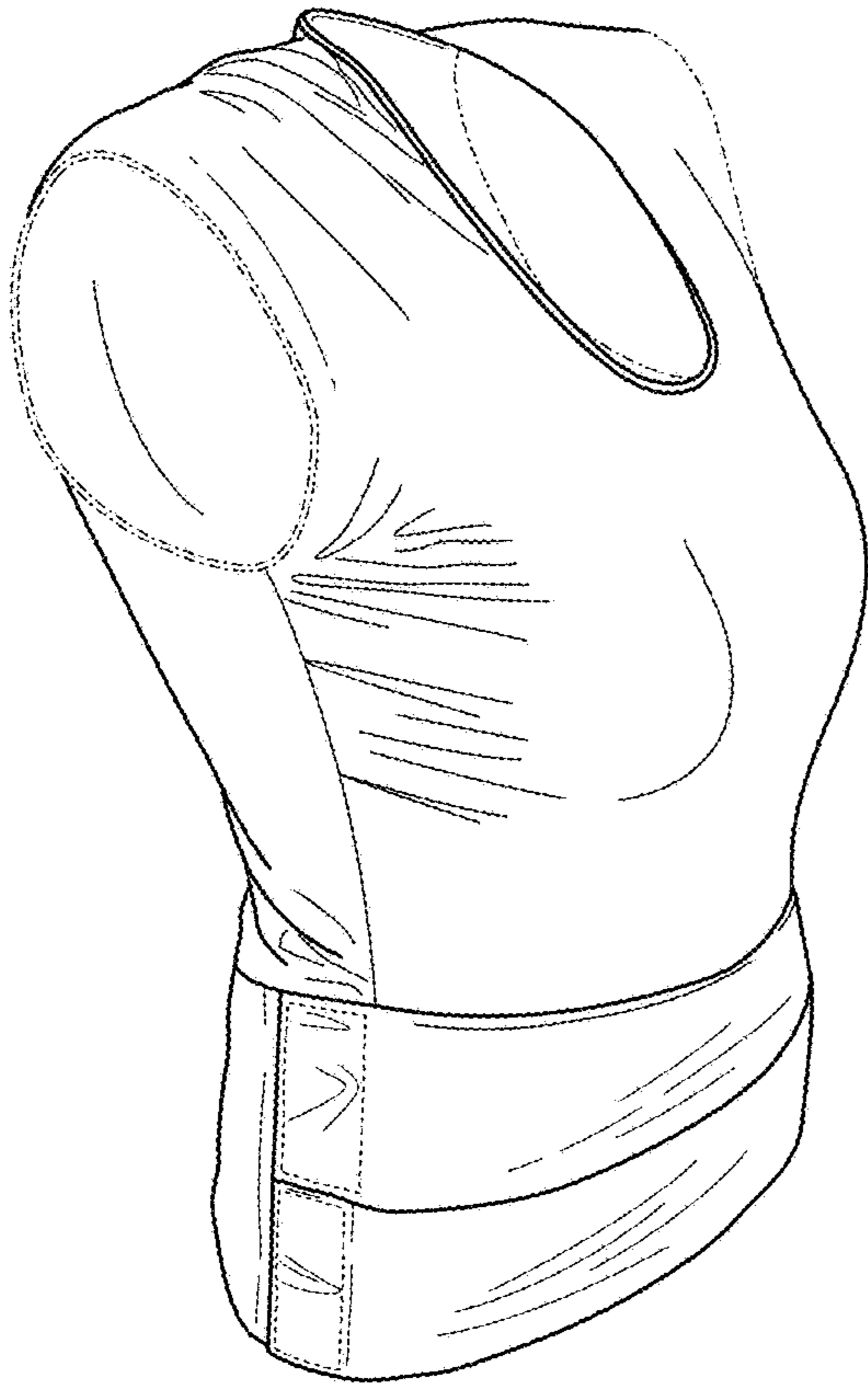

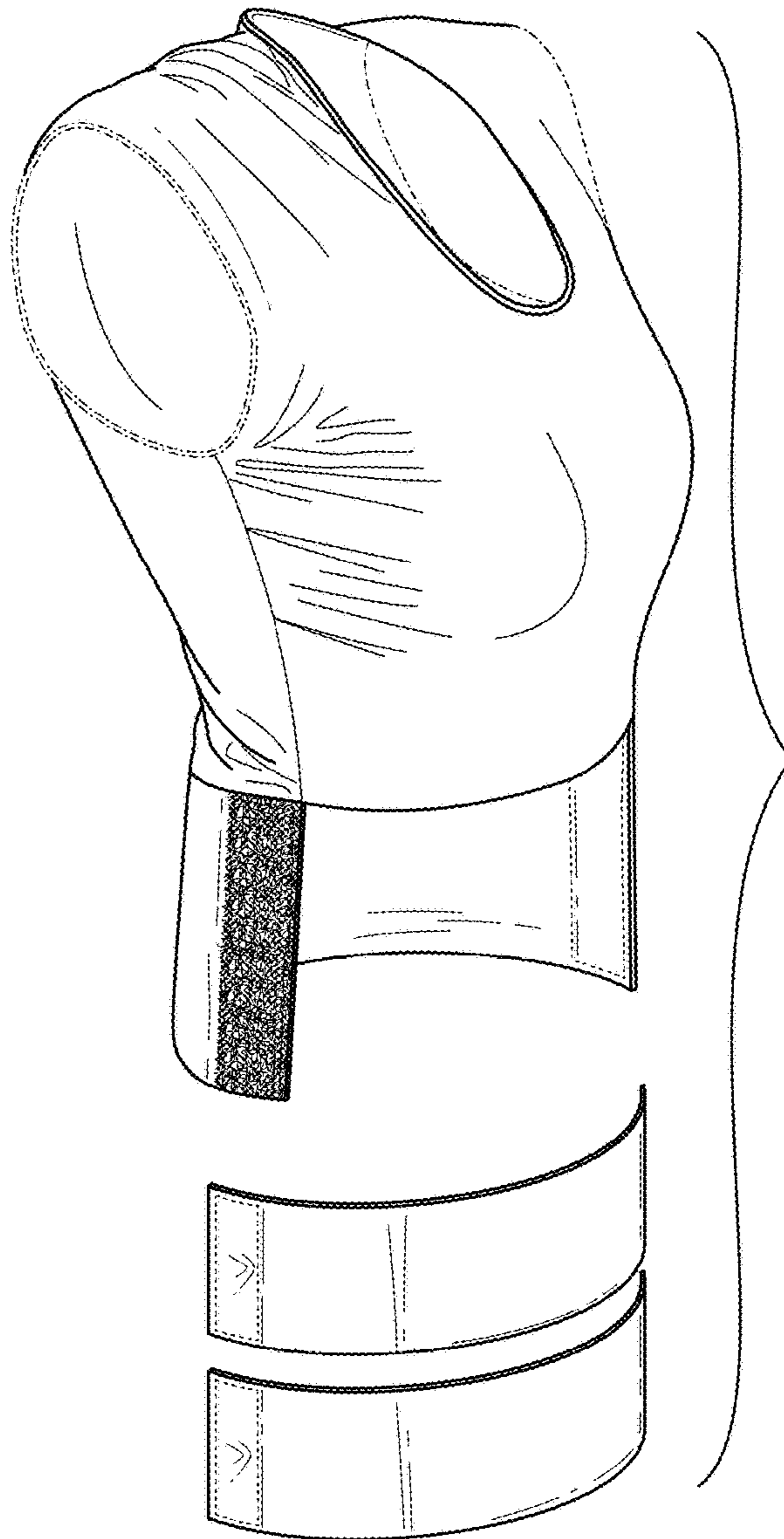

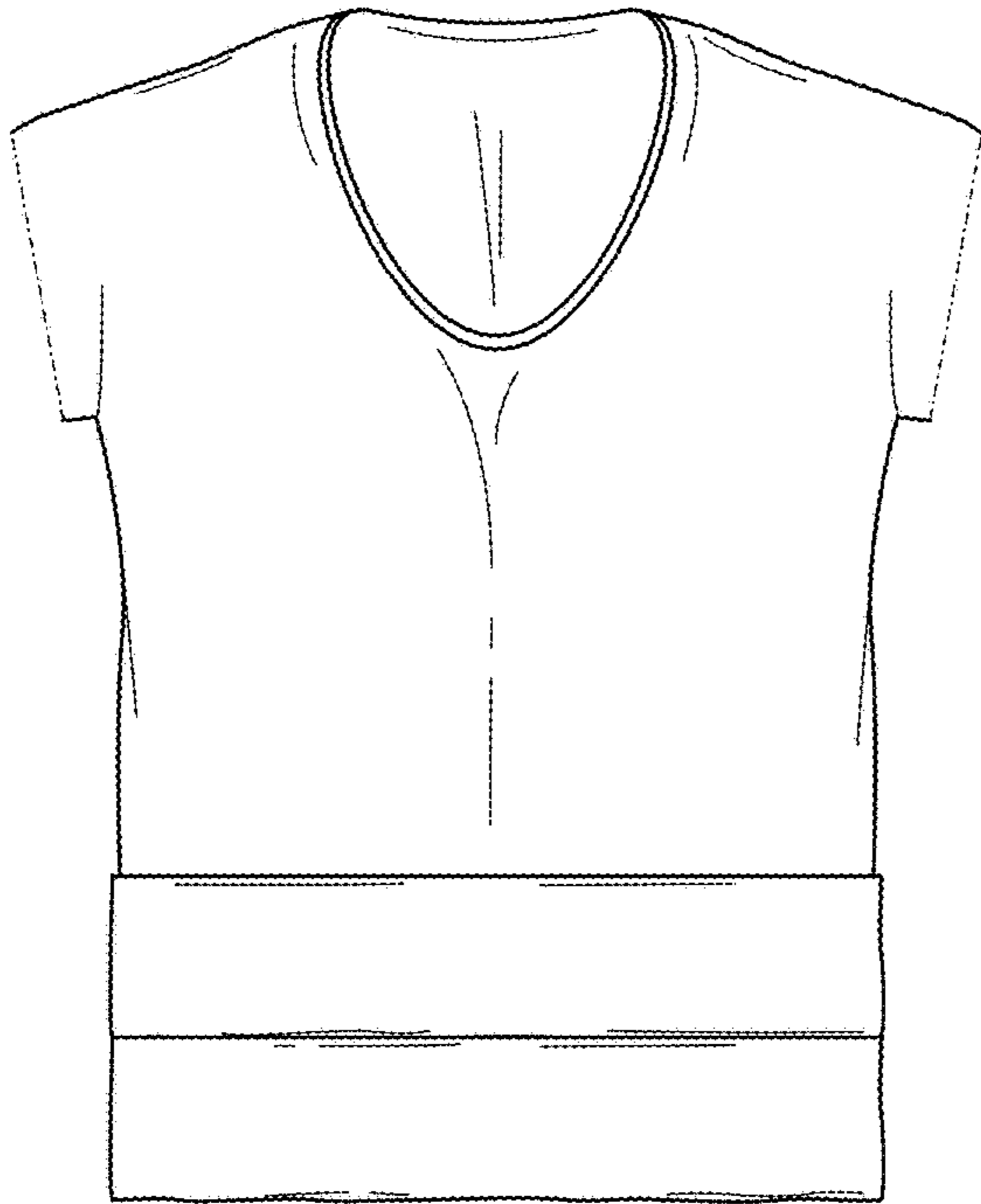

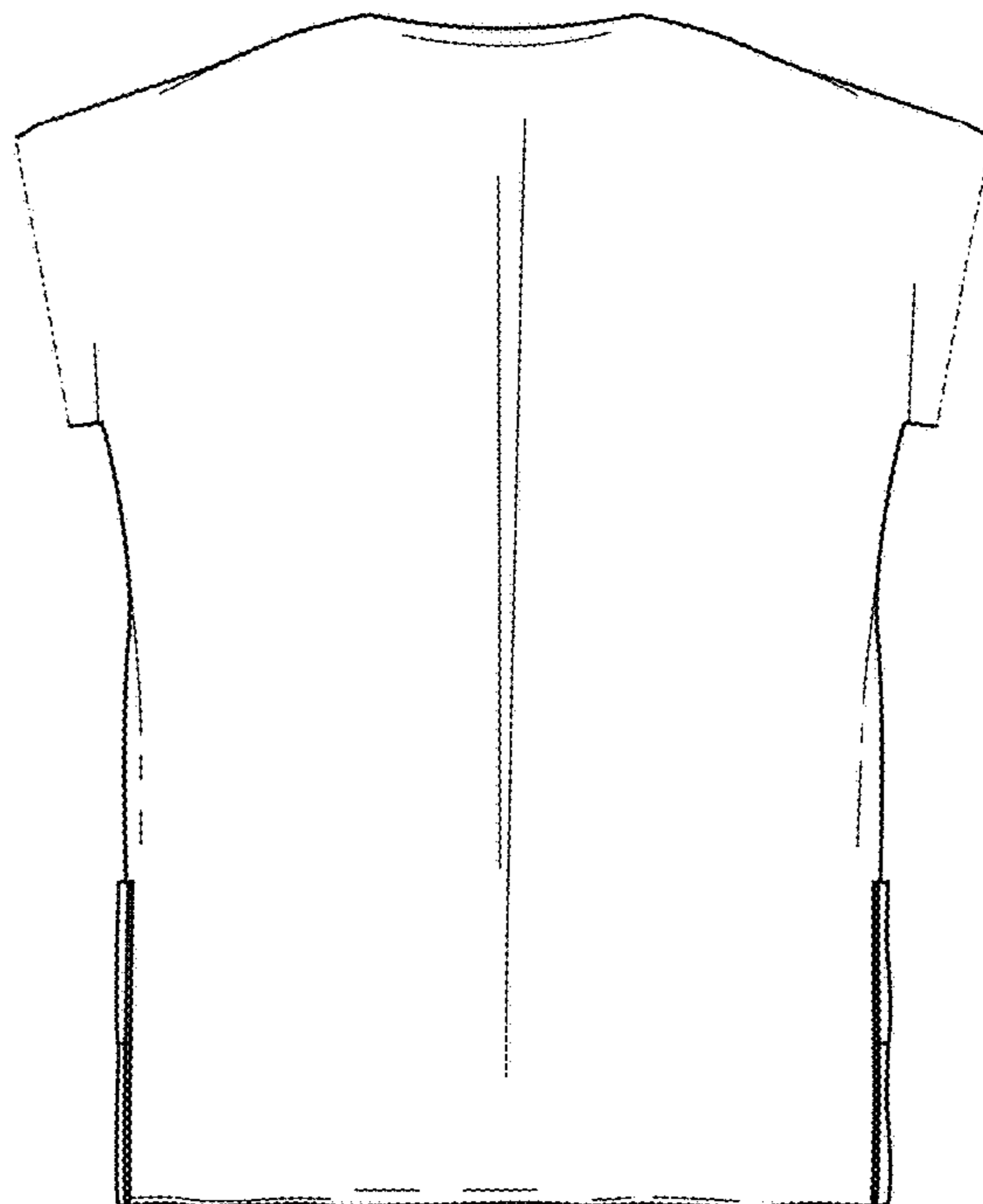

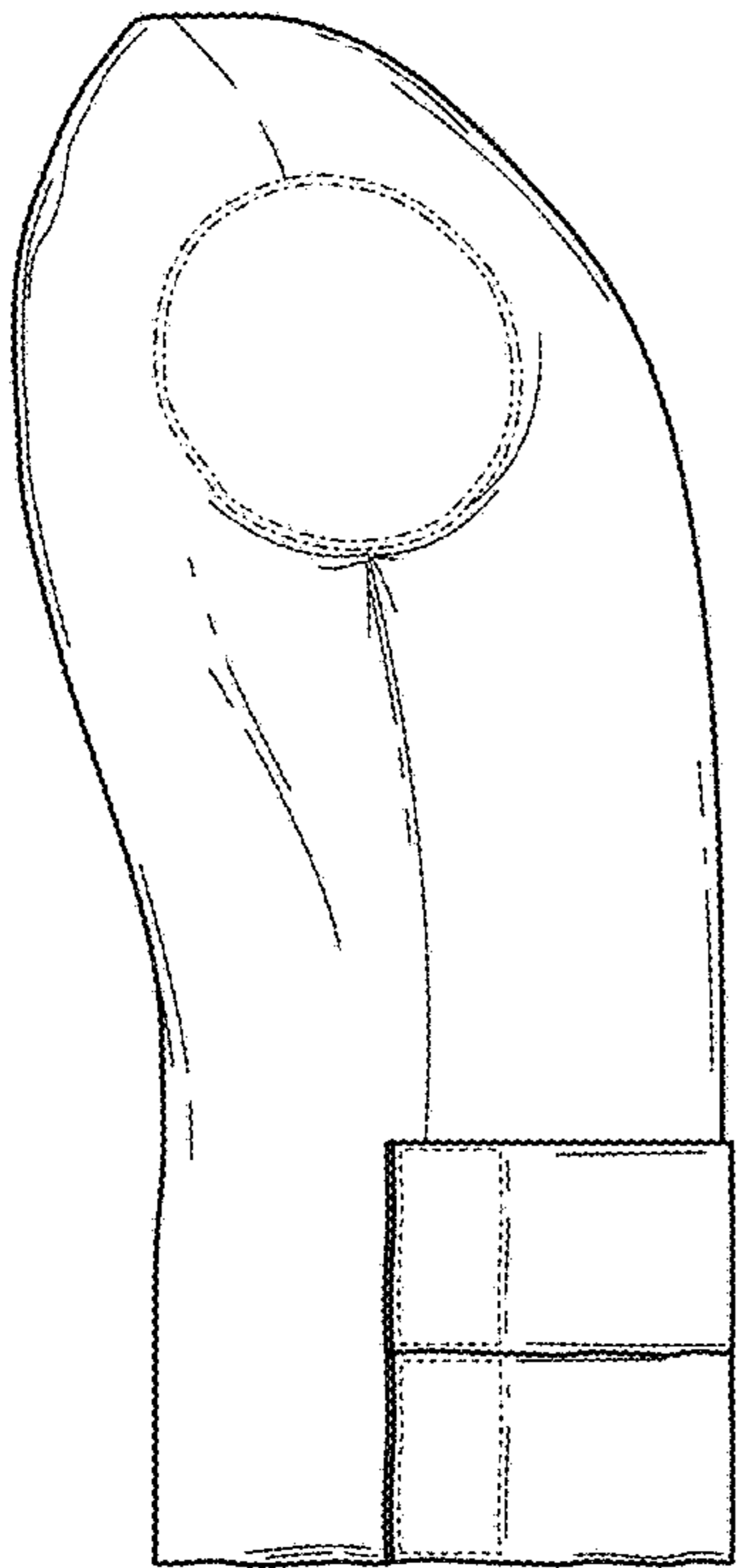

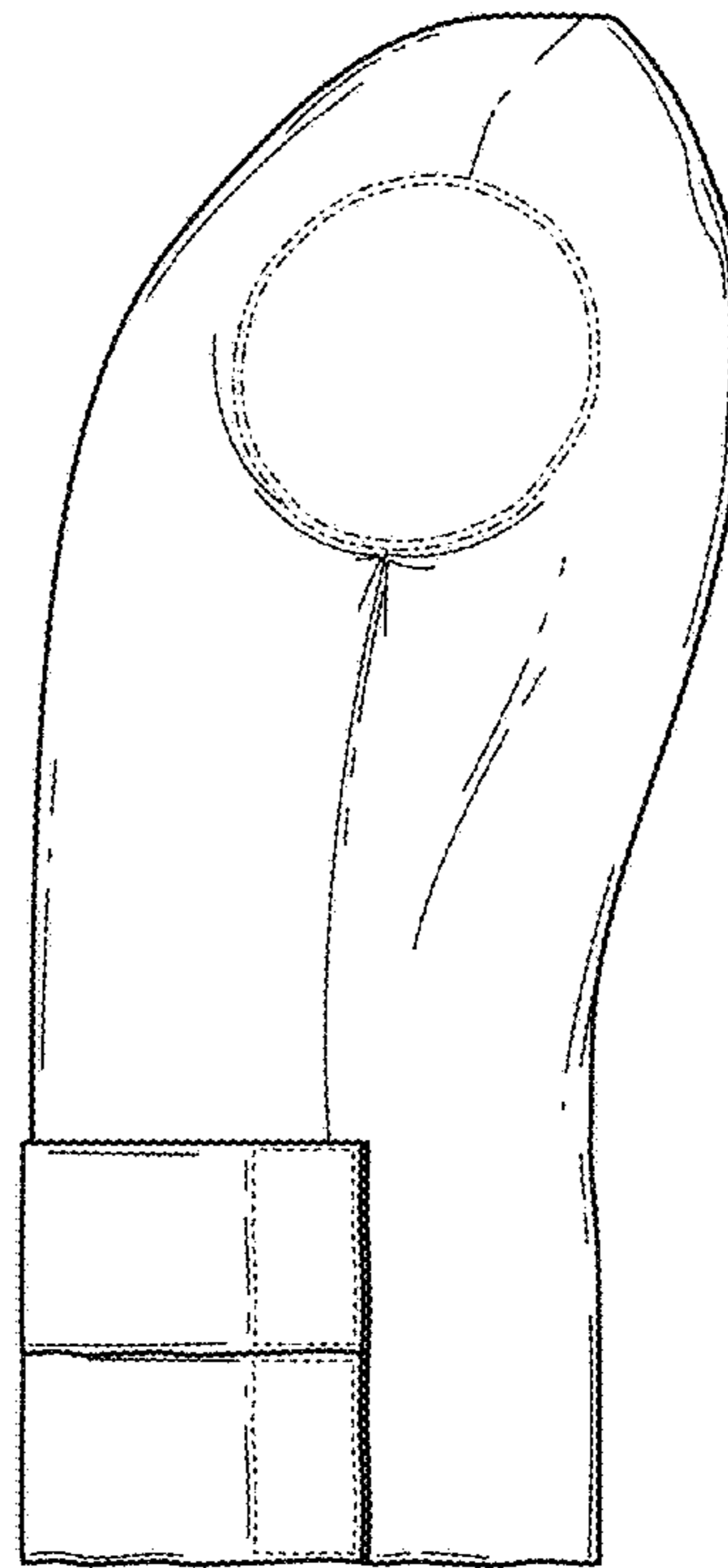

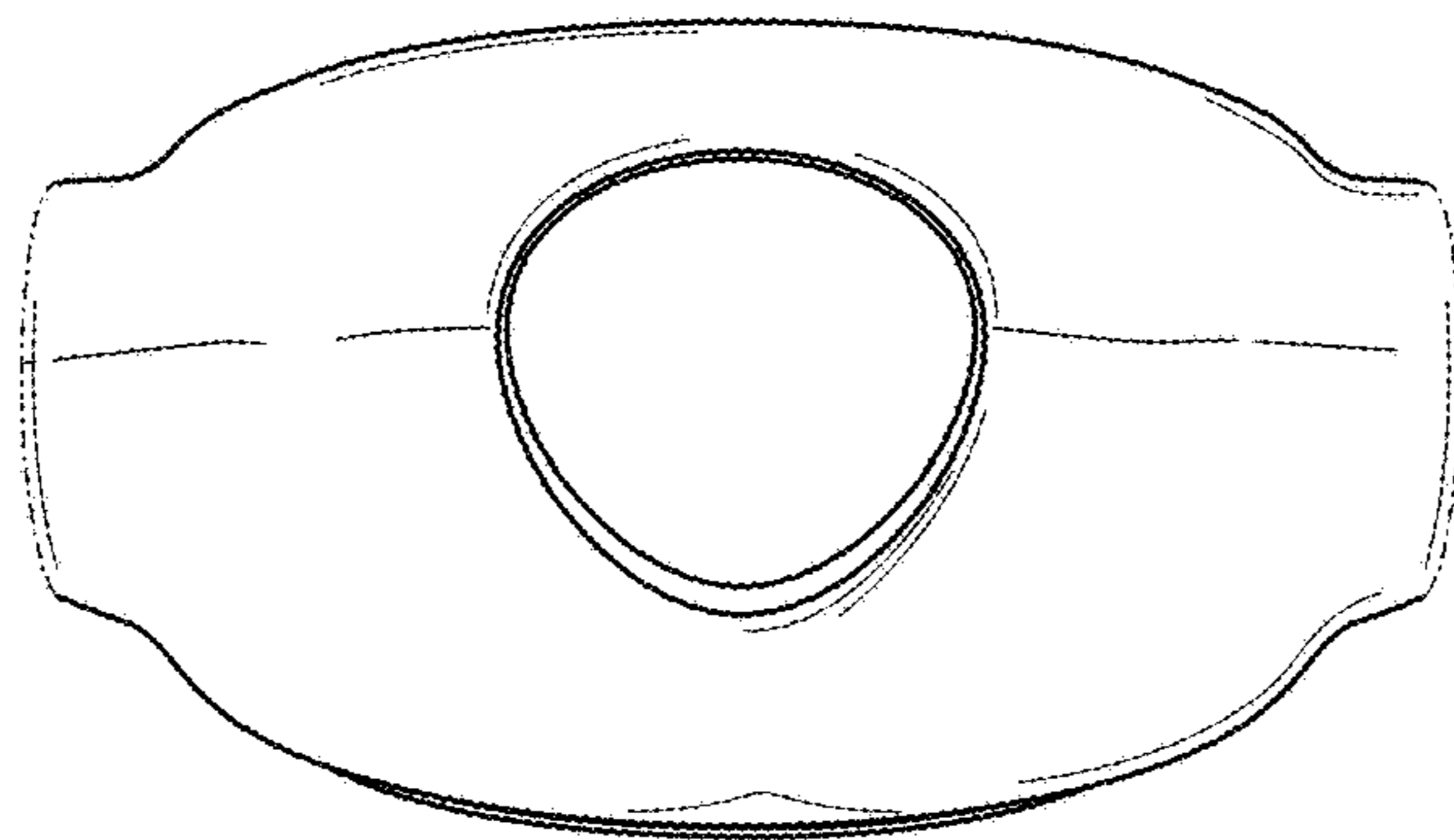

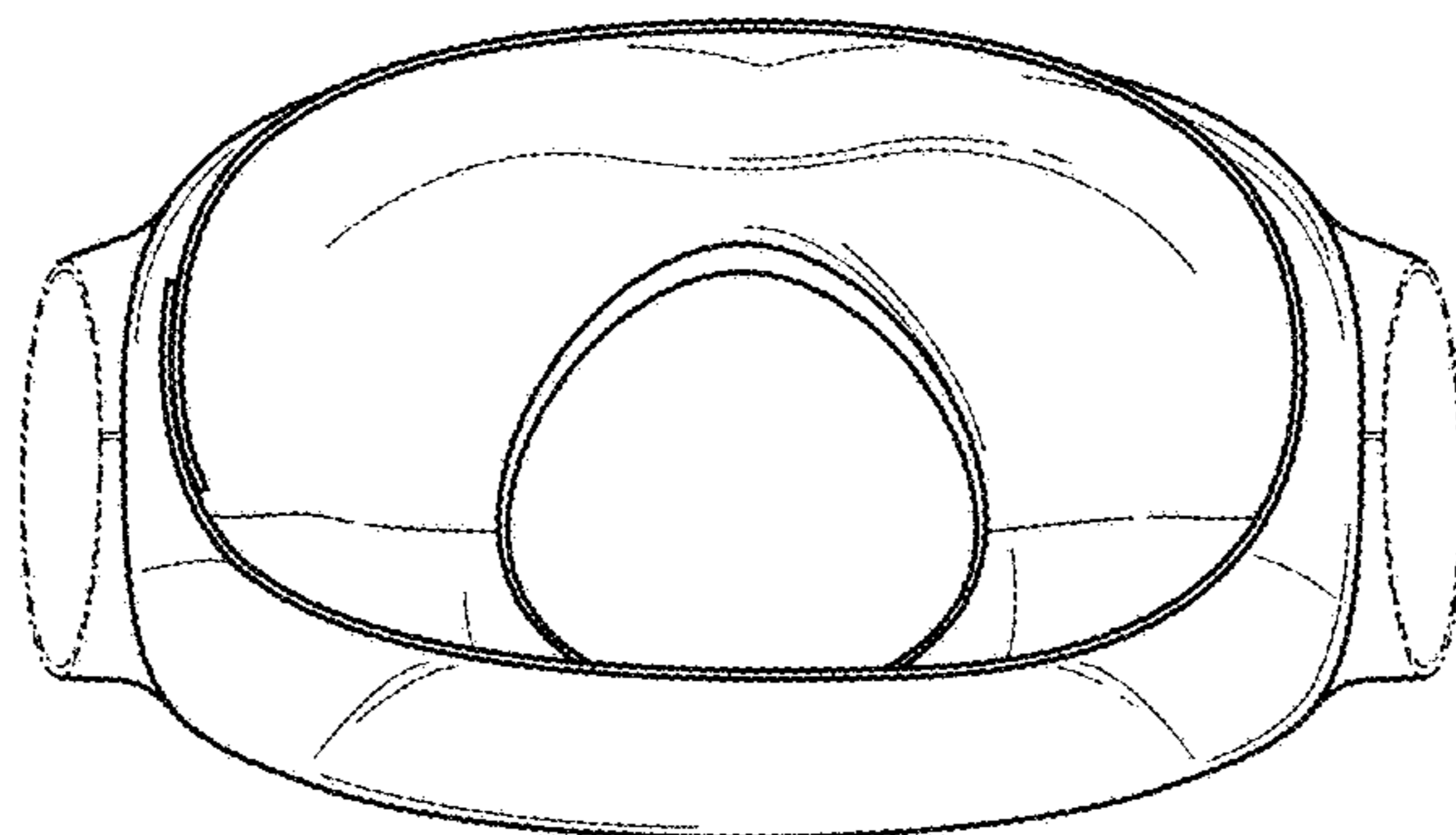

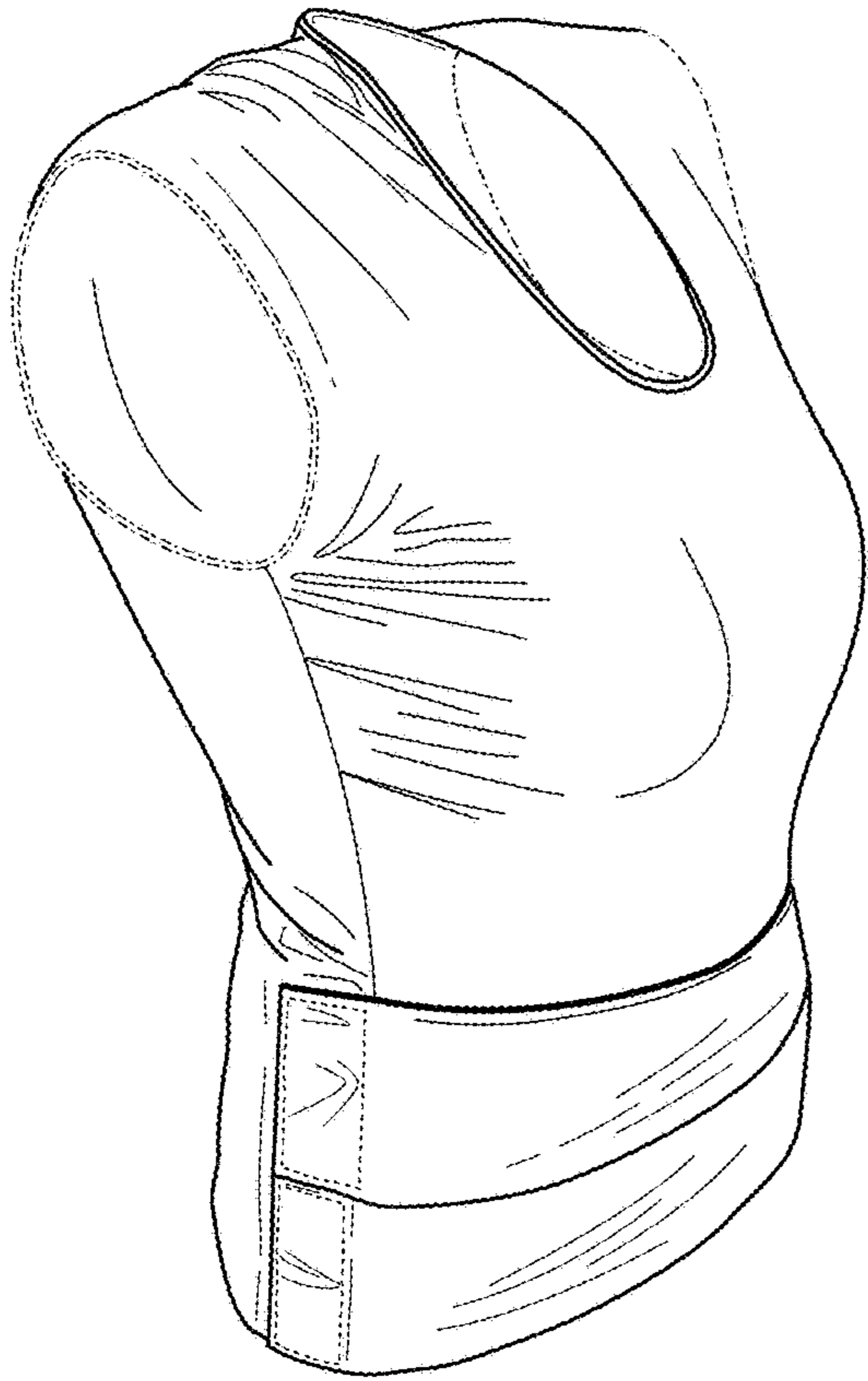

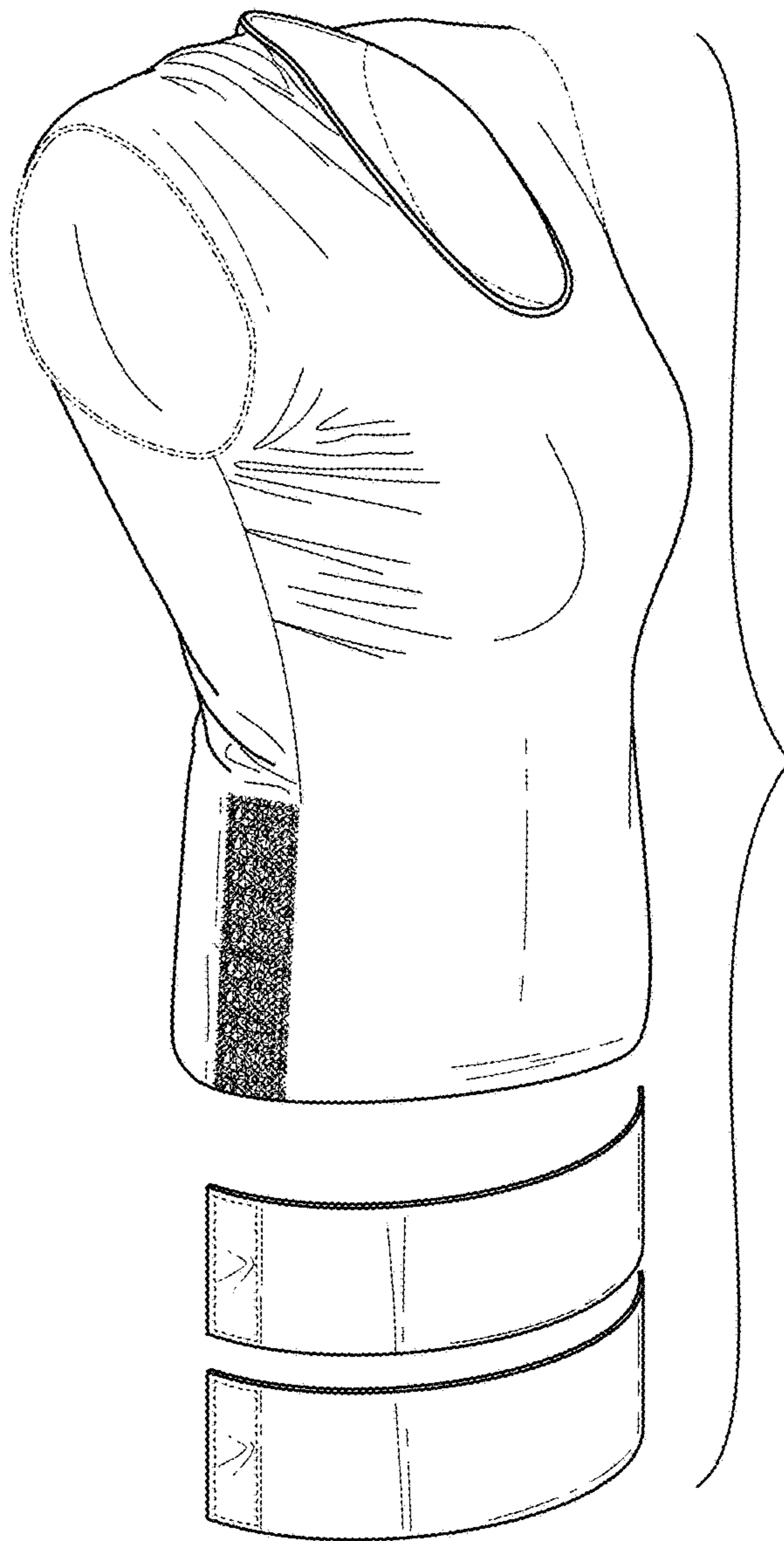

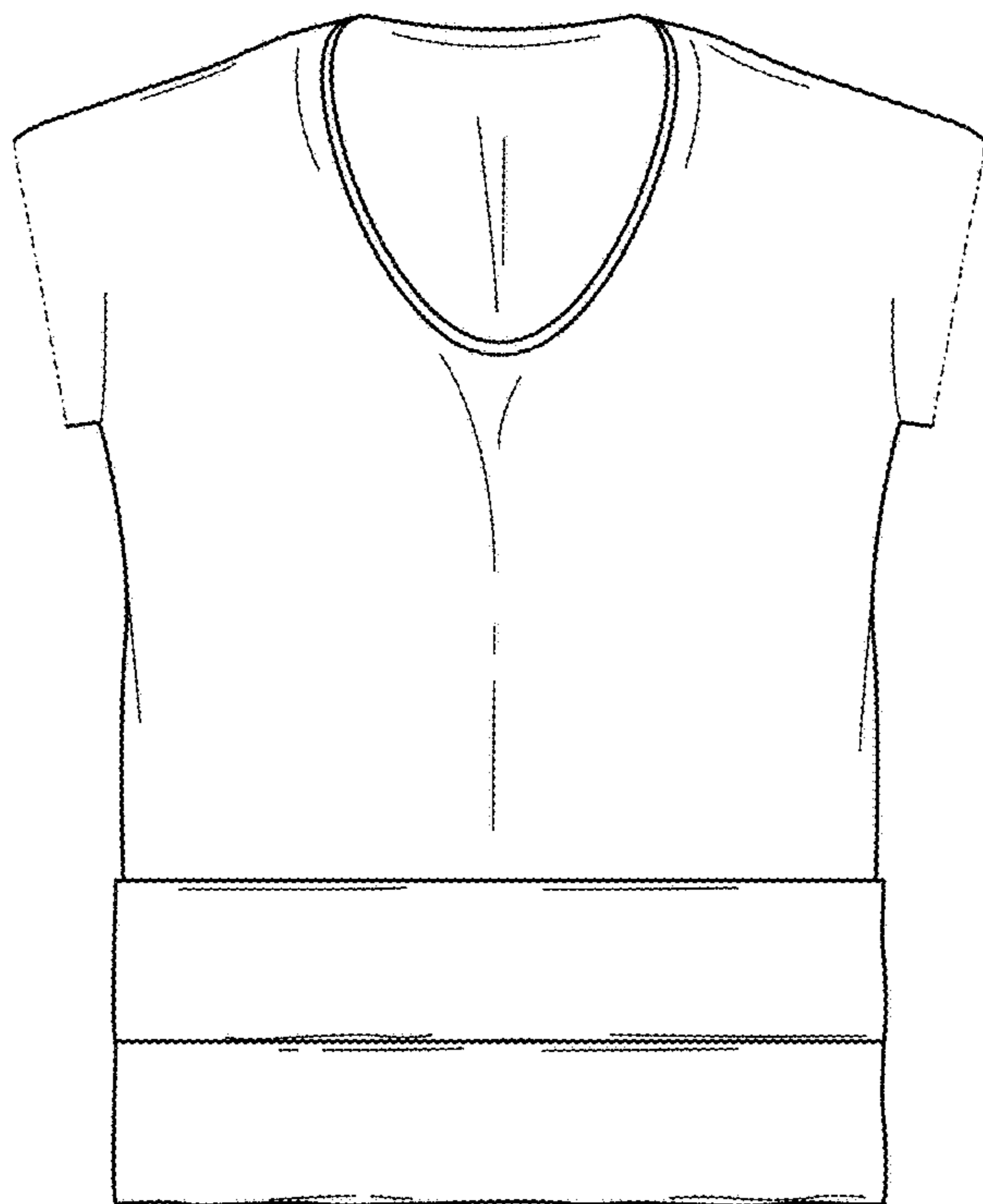

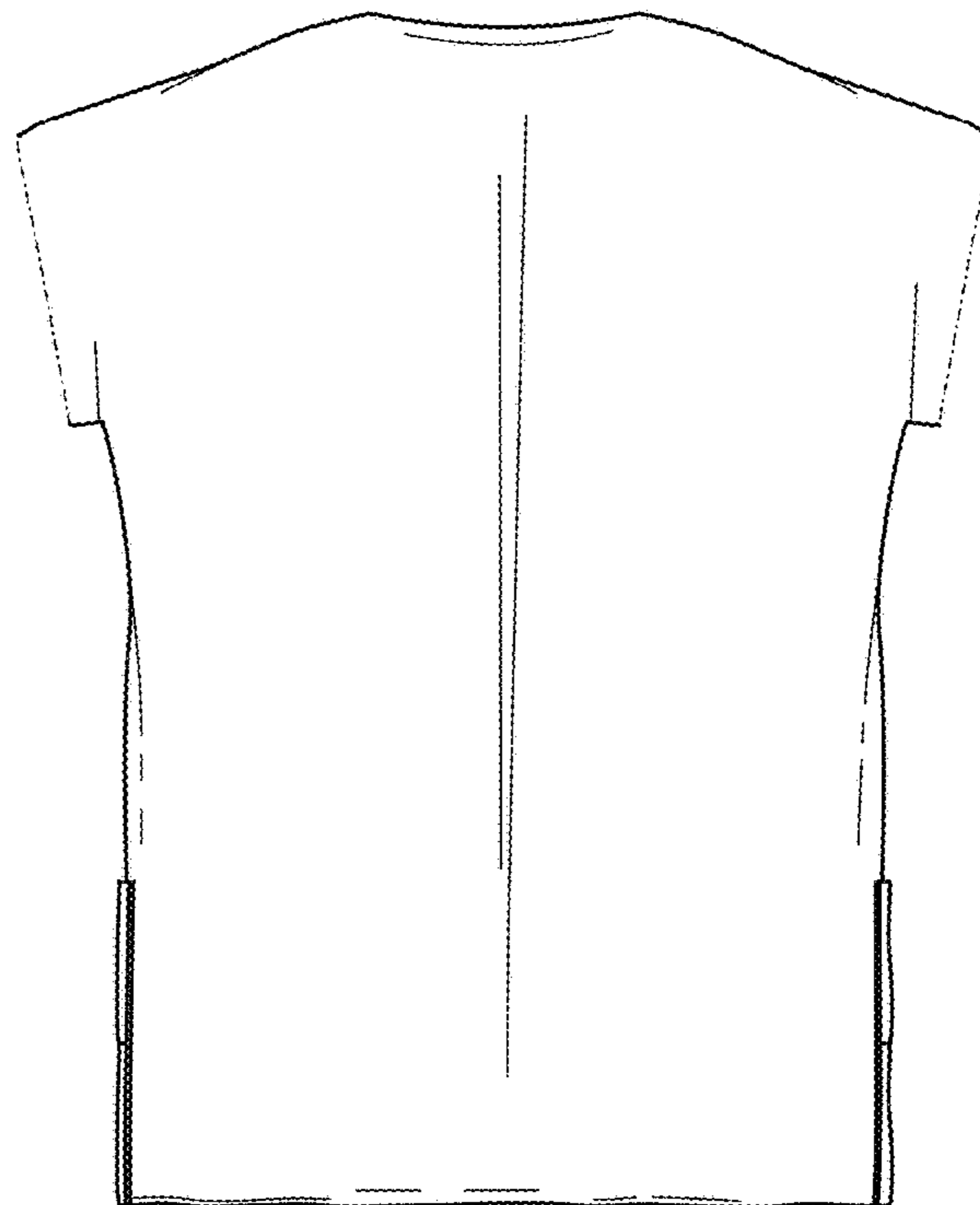

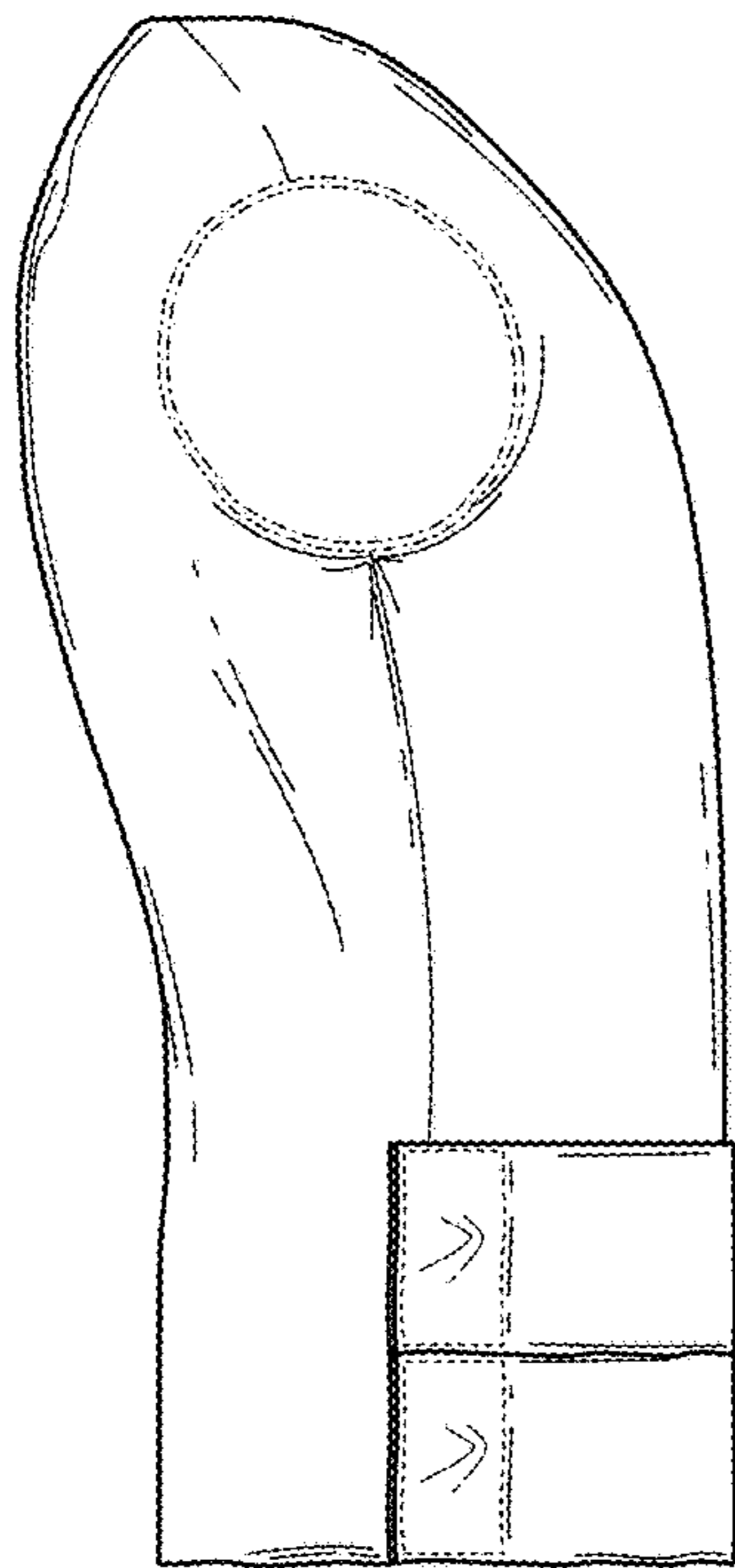

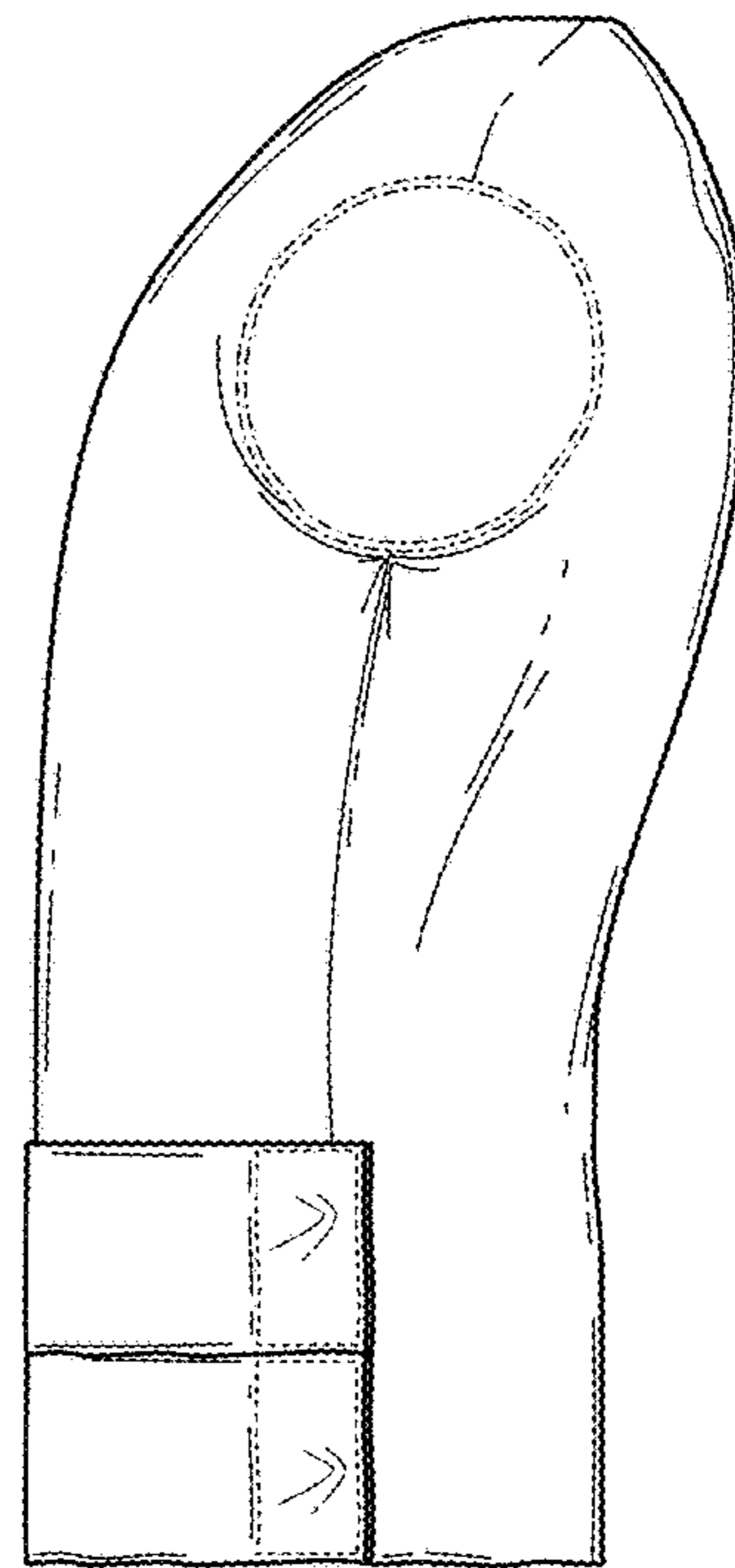

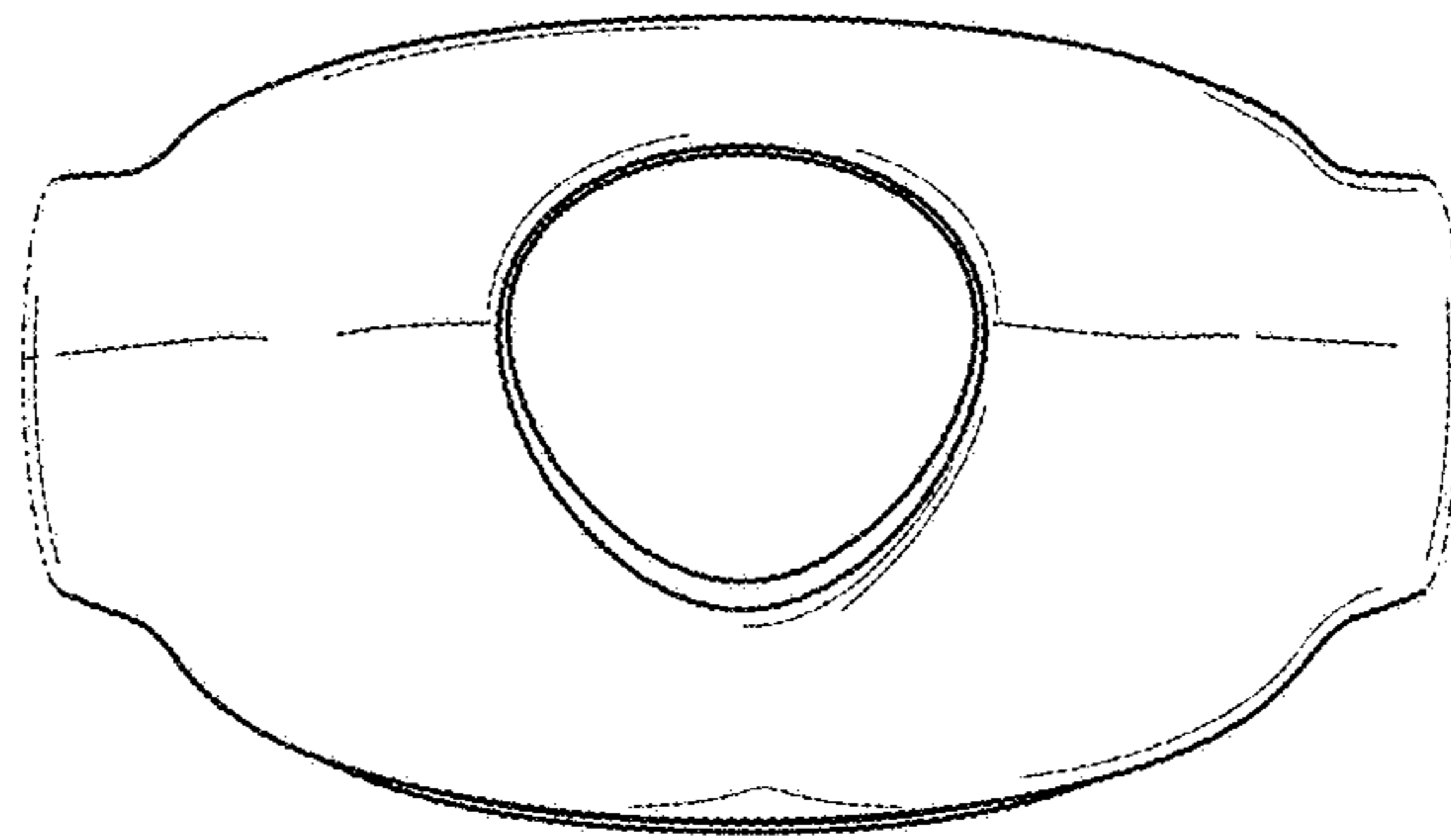

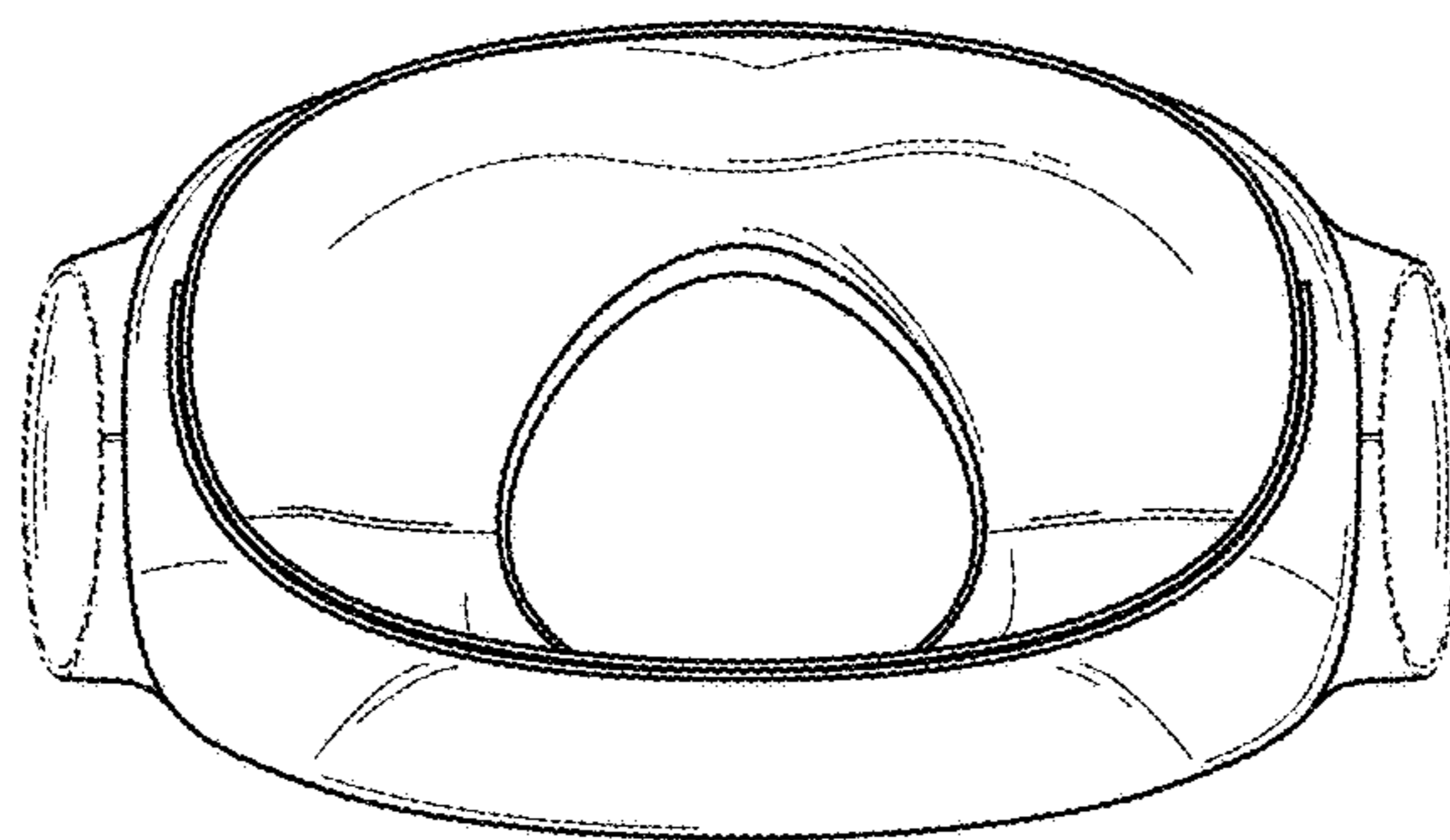
