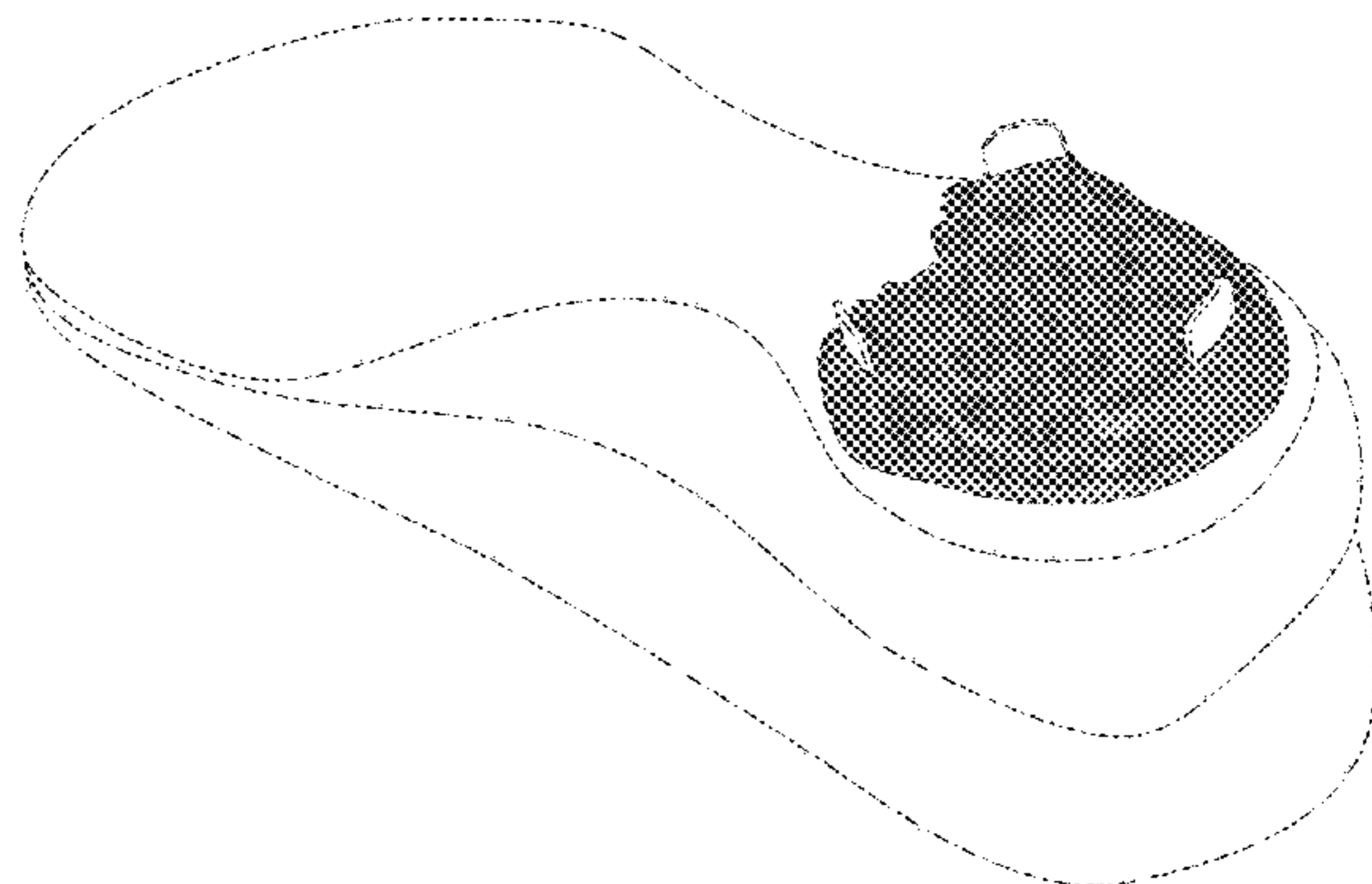
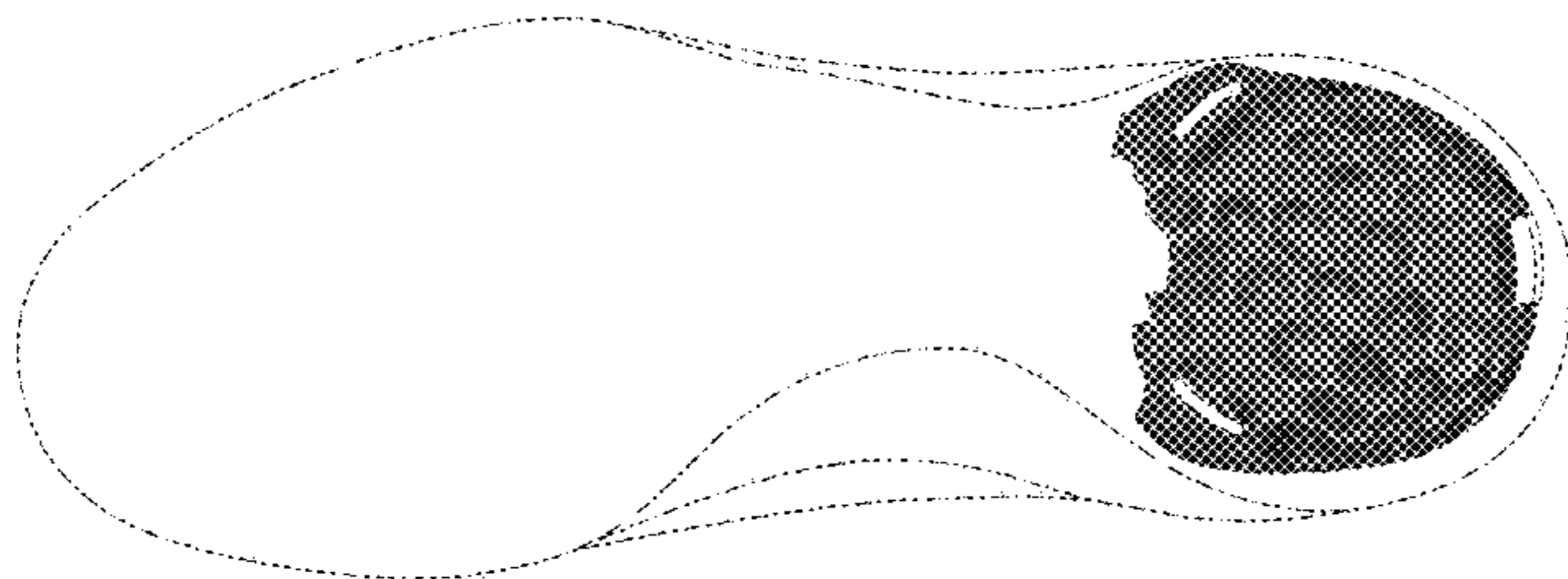
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom view of a shoe outsole showing my new design;

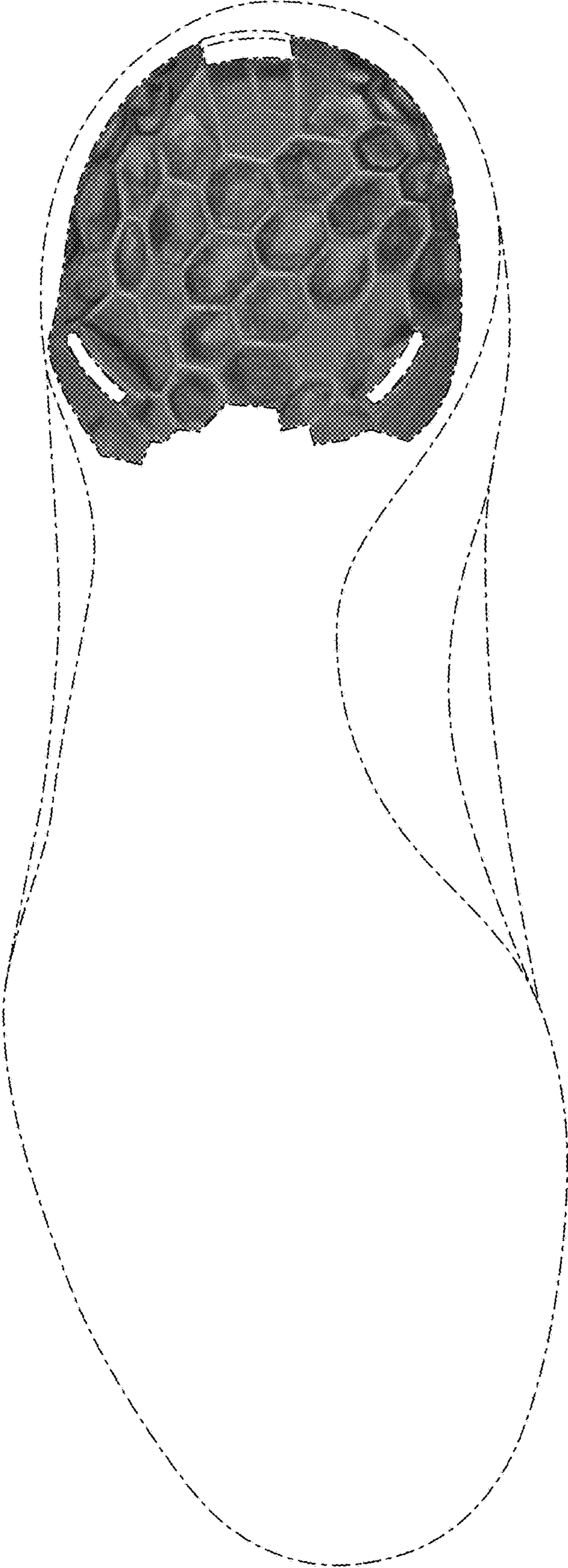

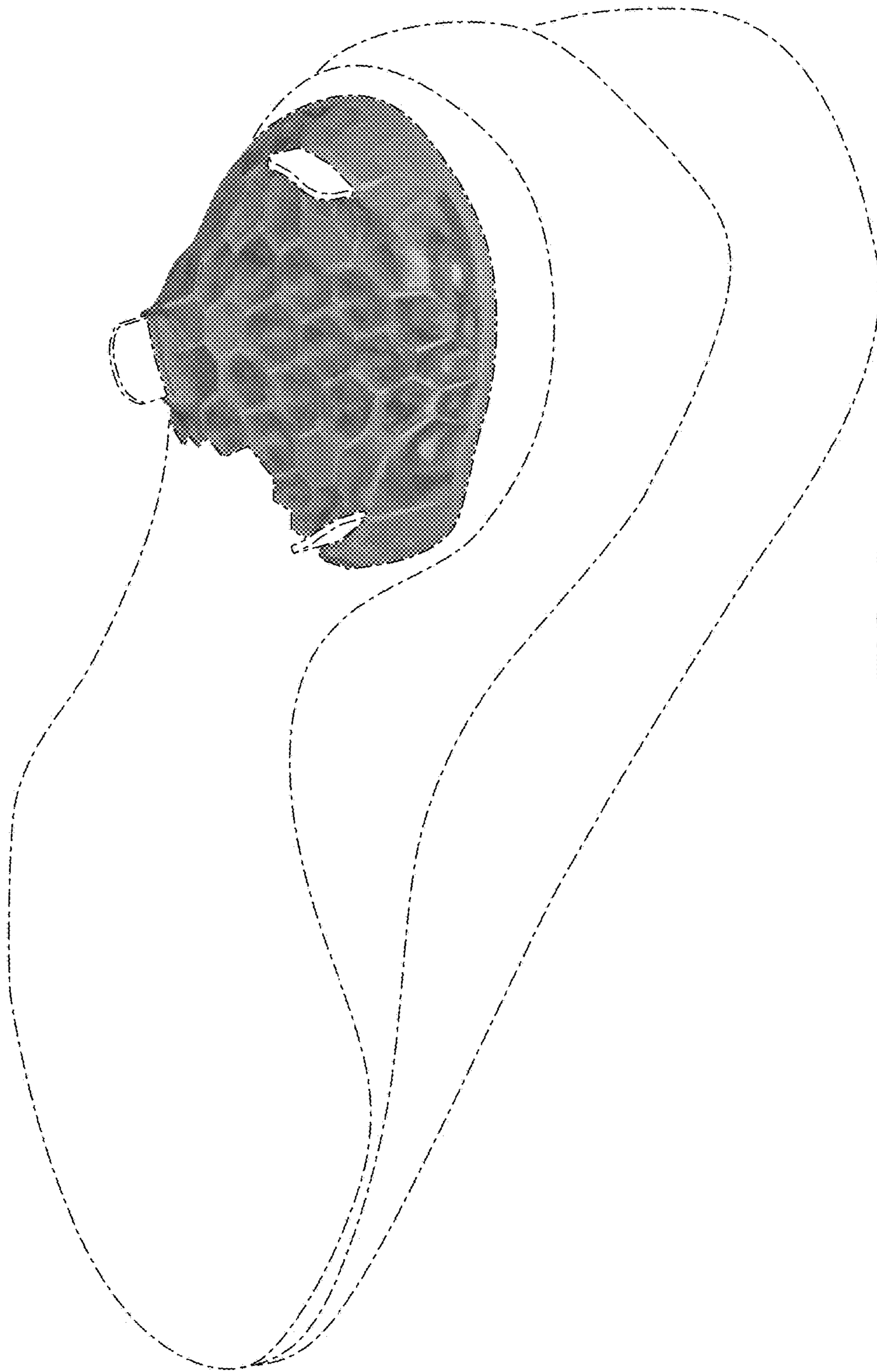

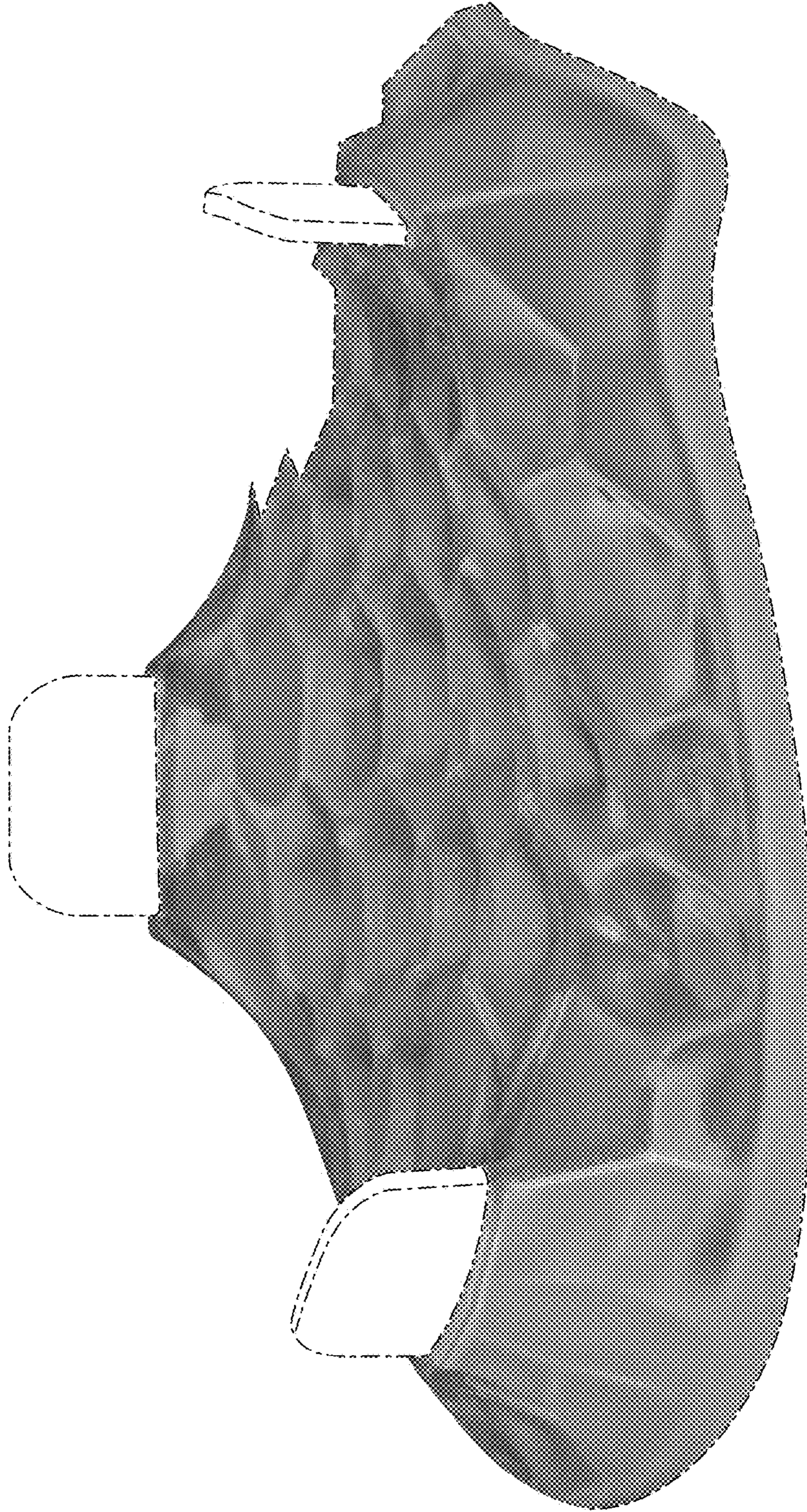

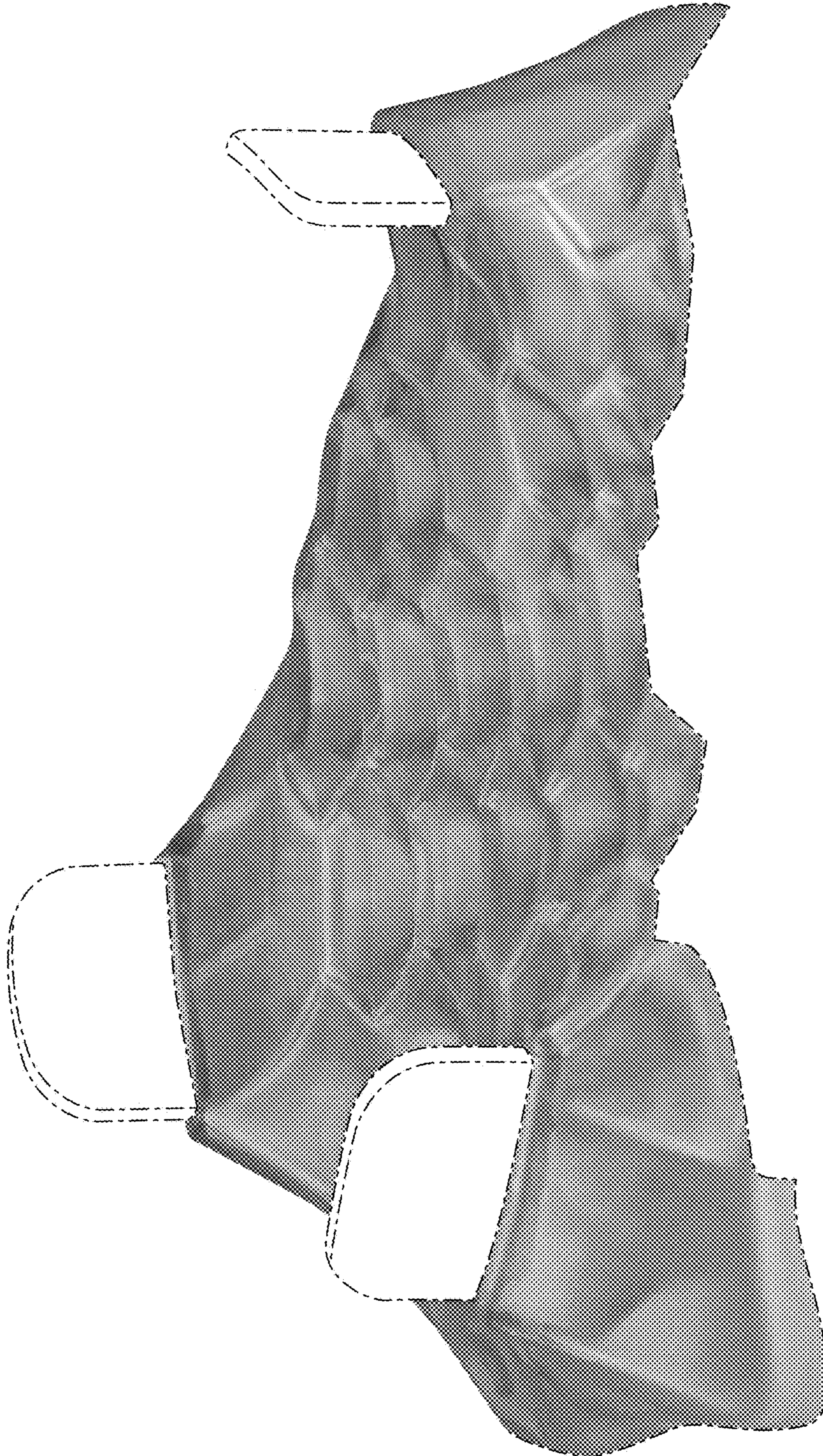
