FIG. 1 is a lateral side view in perspective of a knitted upper for an article of footwear showing my new design; FIG. 2 is a front and medial side view in perspective of the knitted upper of FIG. 1; FIG. 3 is a top and medial side view in perspective of the knitted upper of FIG. 1; FIG. 4 is a perspective medial side view of the knitted upper of FIG. 1; FIG. 5 is a perspective lateral side view of the knitted upper of FIG. 1; FIG. 6 is a top perspective view of the knitted upper of FIG. 1; FIG. 7 is a bottom perspective view of the knitted upper of FIG. 1; FIG. 8 is a rear perspective view of the knitted upper of FIG. 1; FIG. 9 is a front perspective view the knitted upper of FIG. 1; and, FIG. 10 is a cross-sectional lateral perspective side view of the knitted upper of FIG. 1, taken in the direction of line 10-10 in FIG. 7.

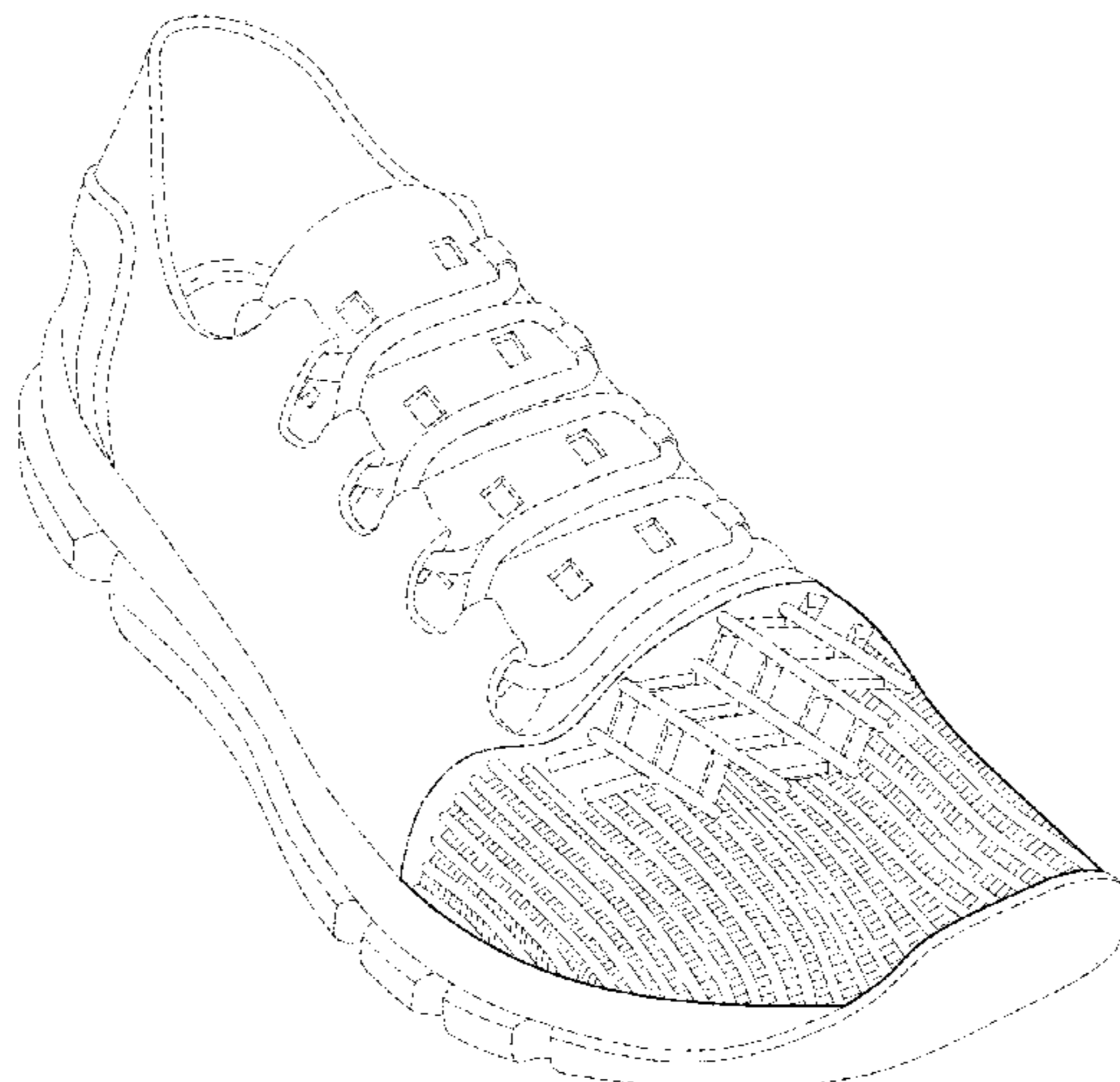

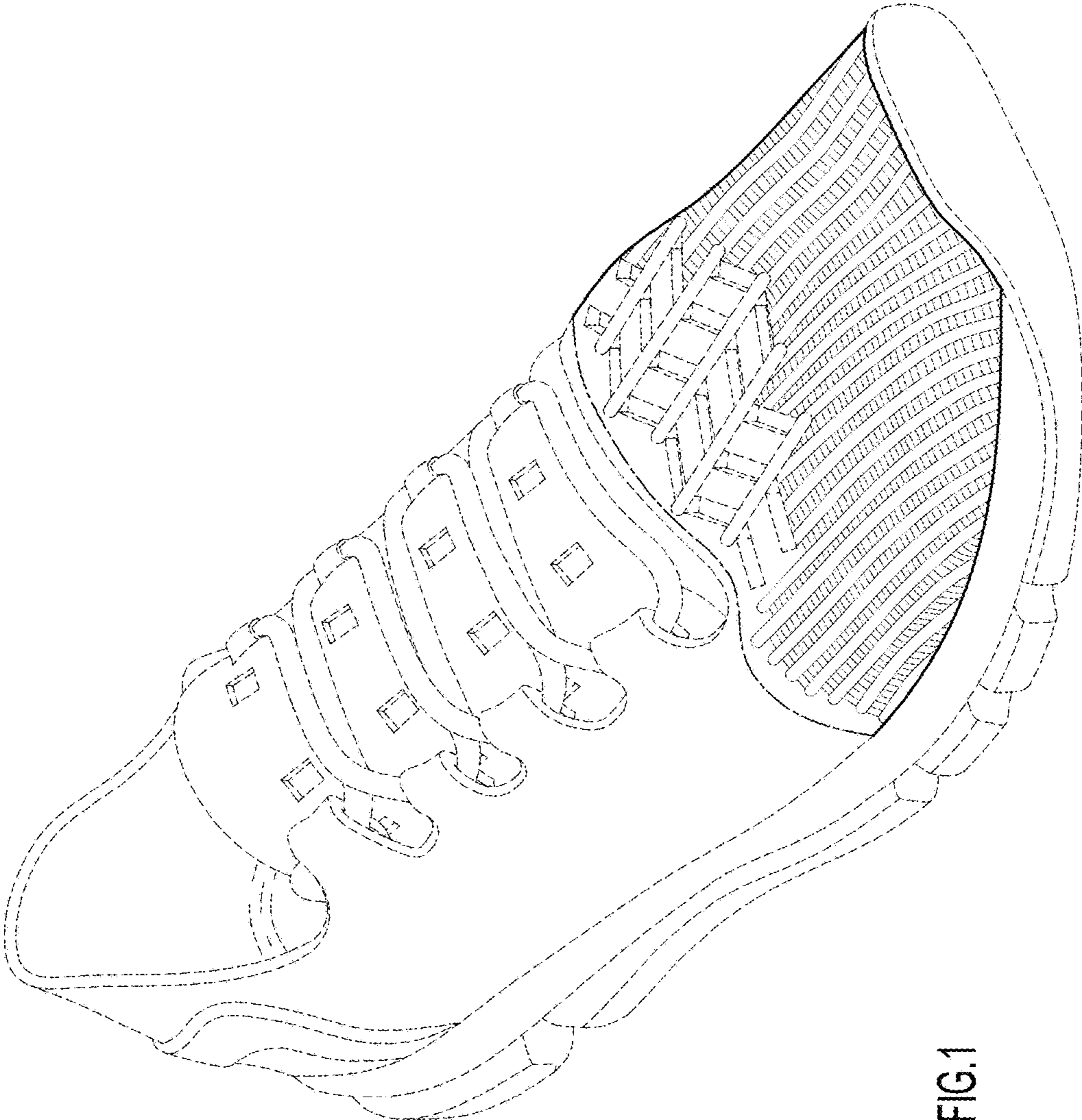

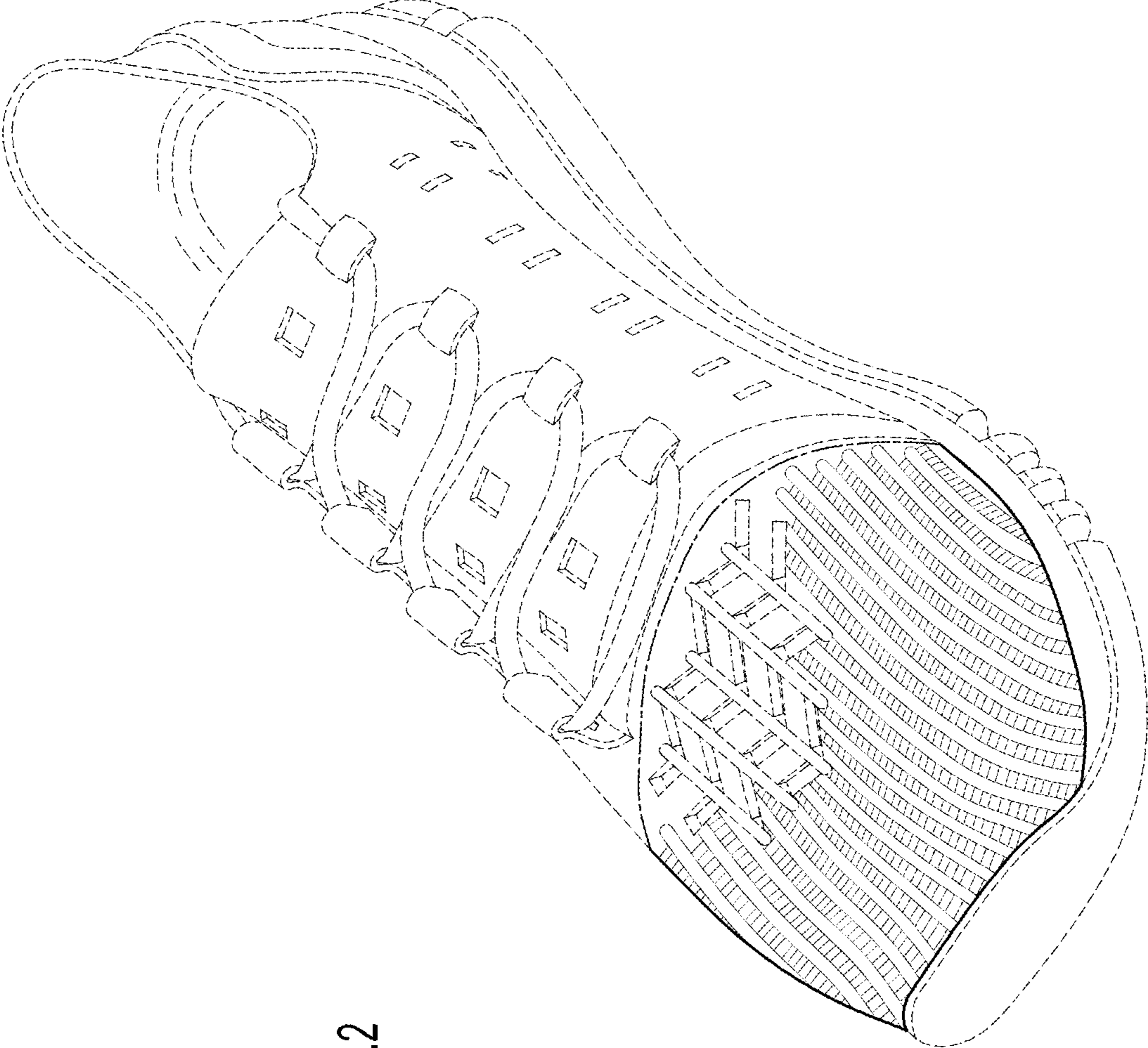

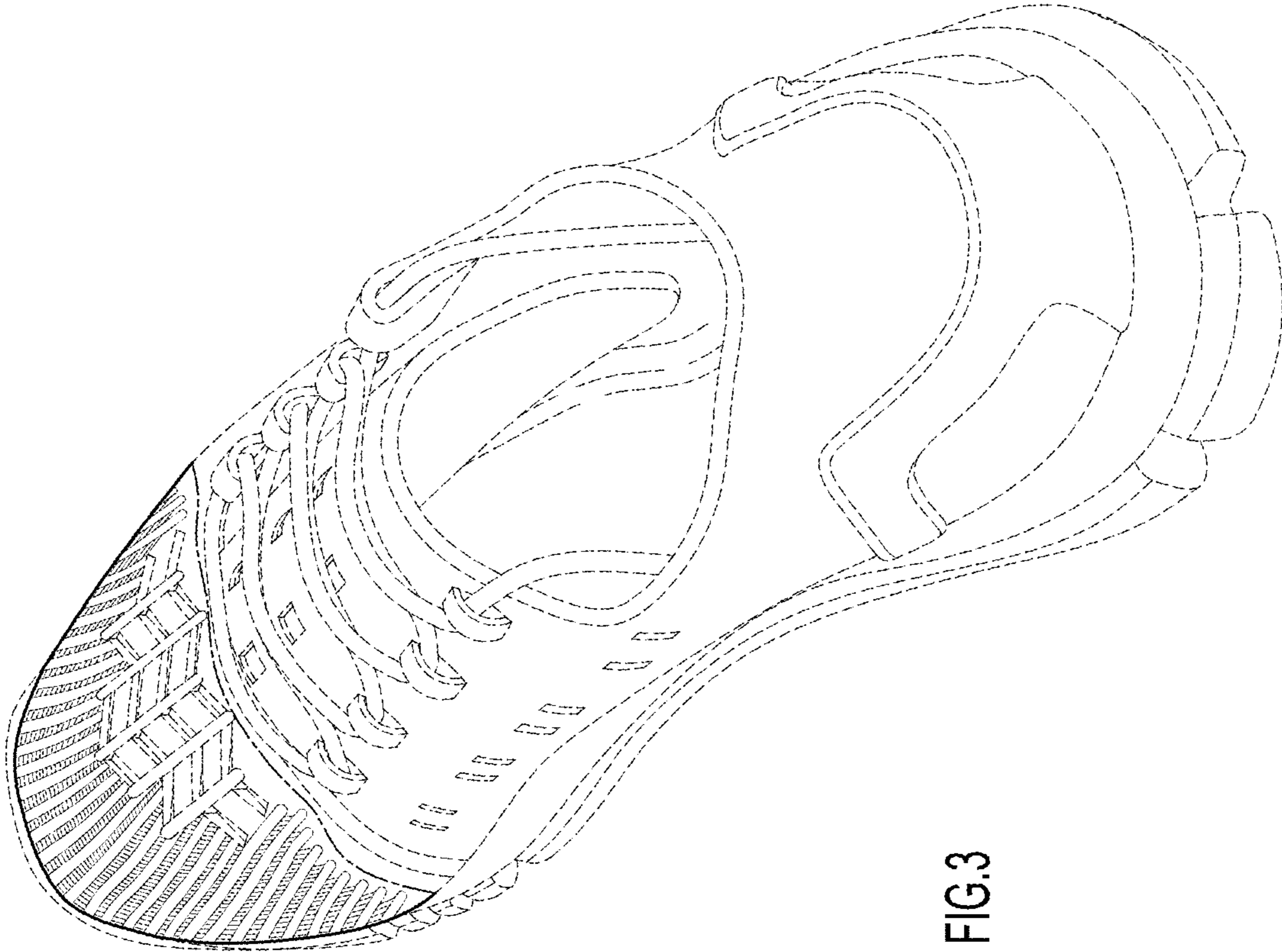

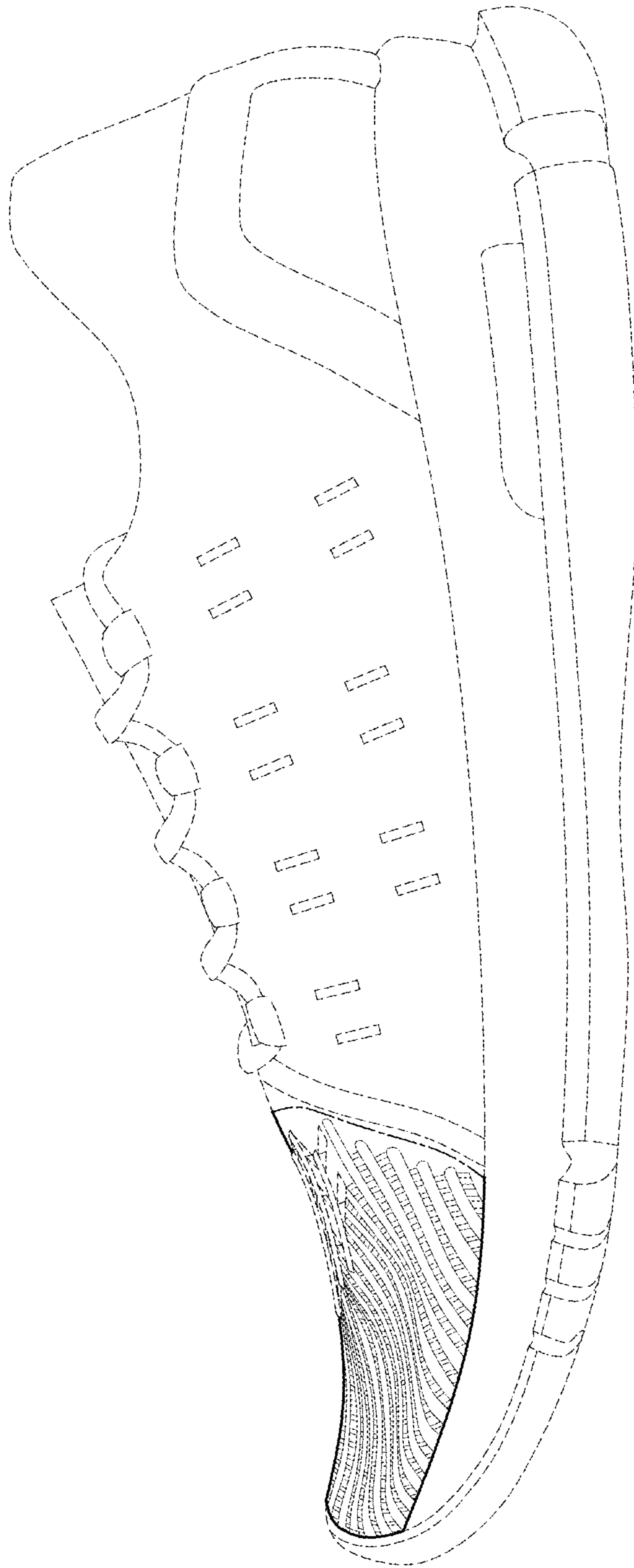

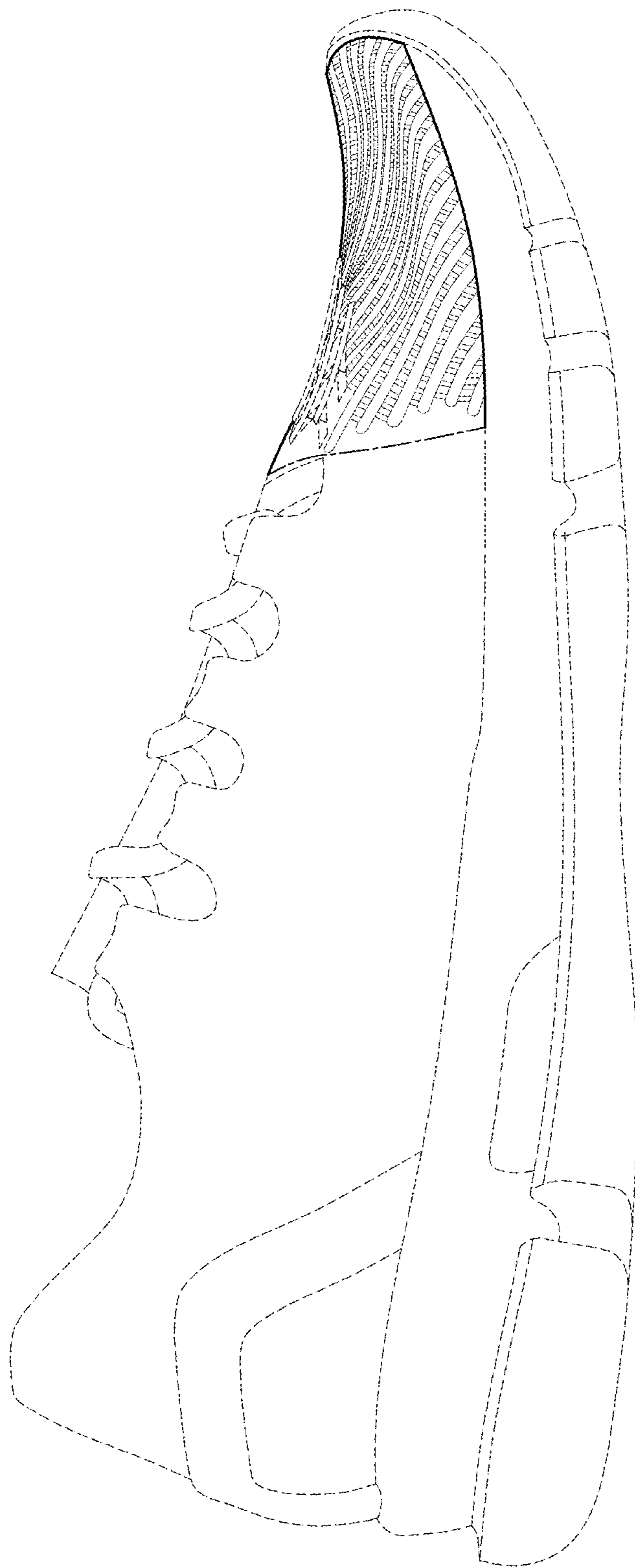

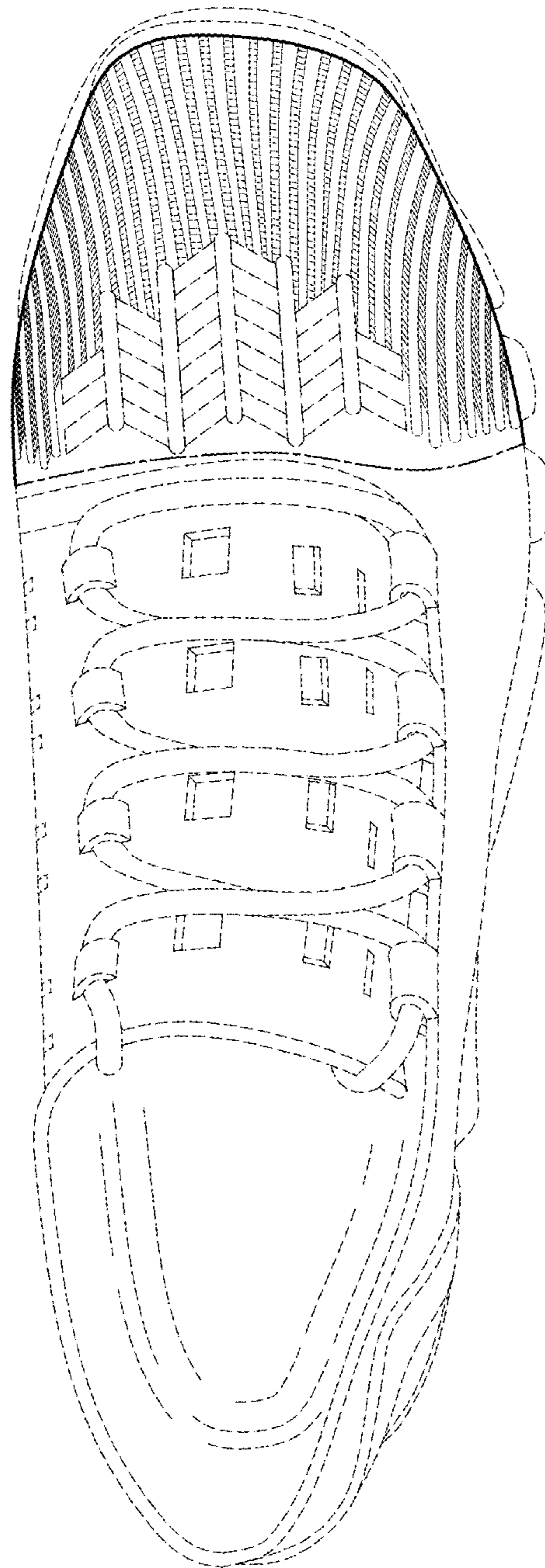

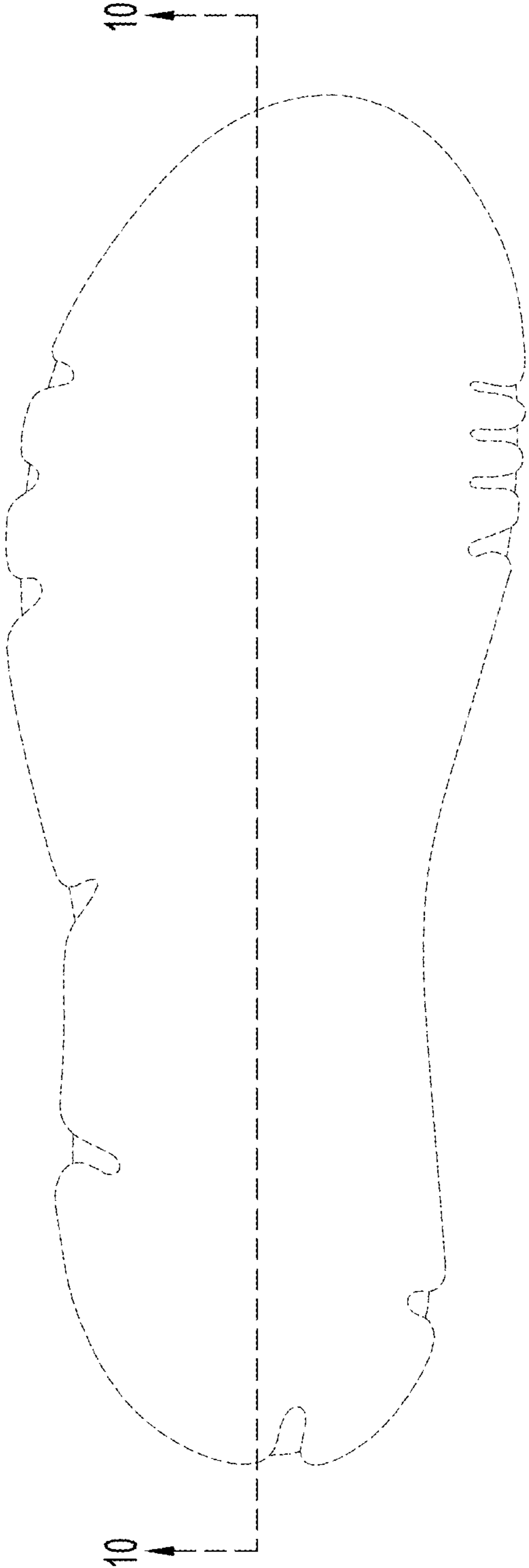

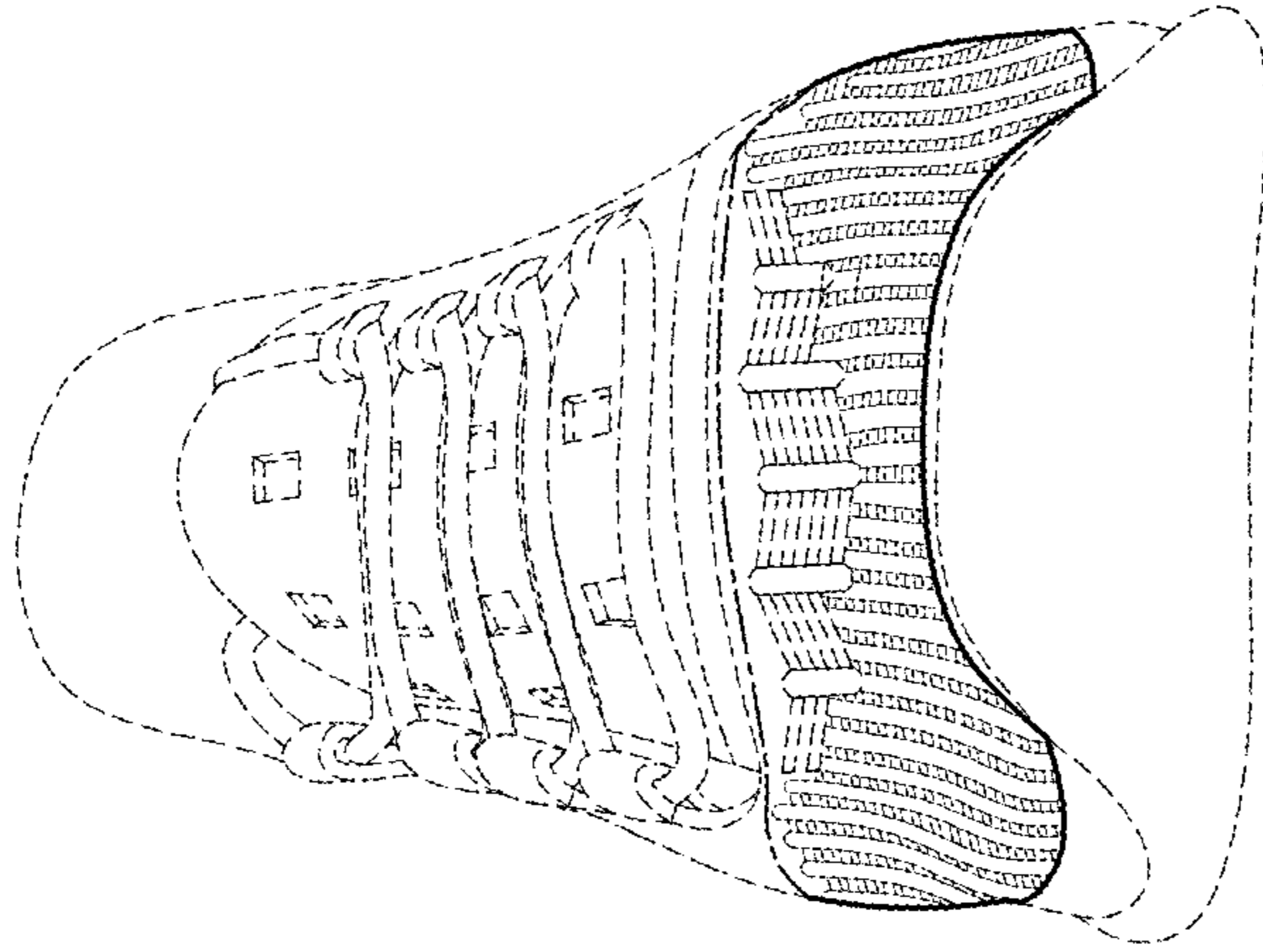

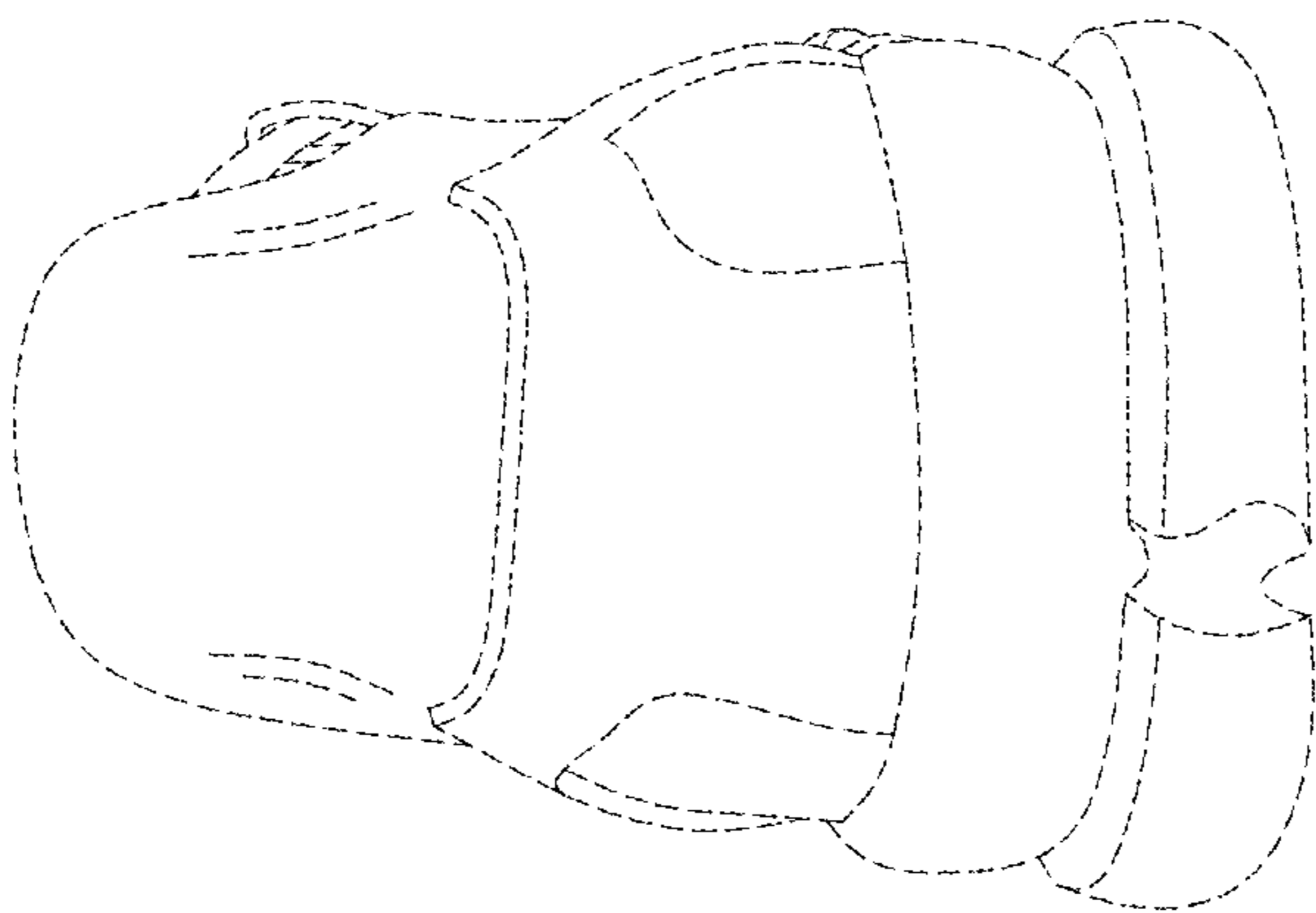

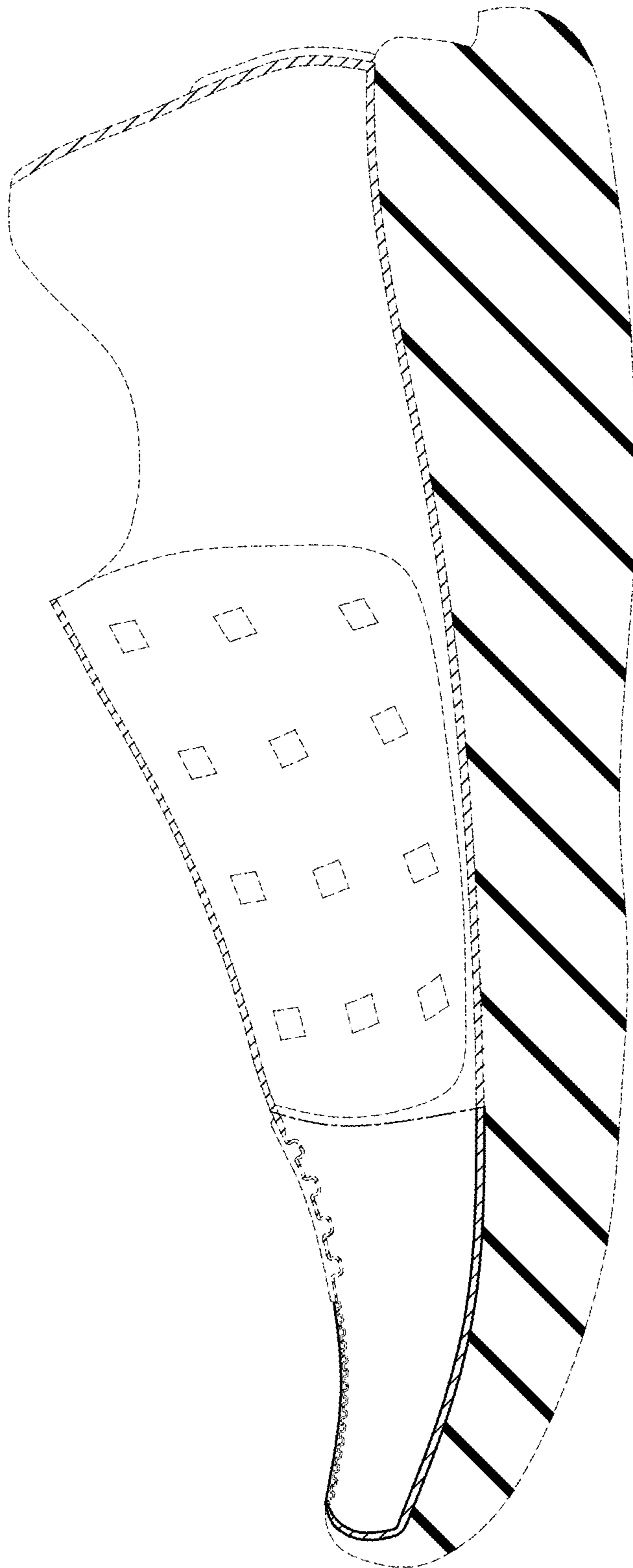
