The ornamental design for a shoe upper, as shown and described.

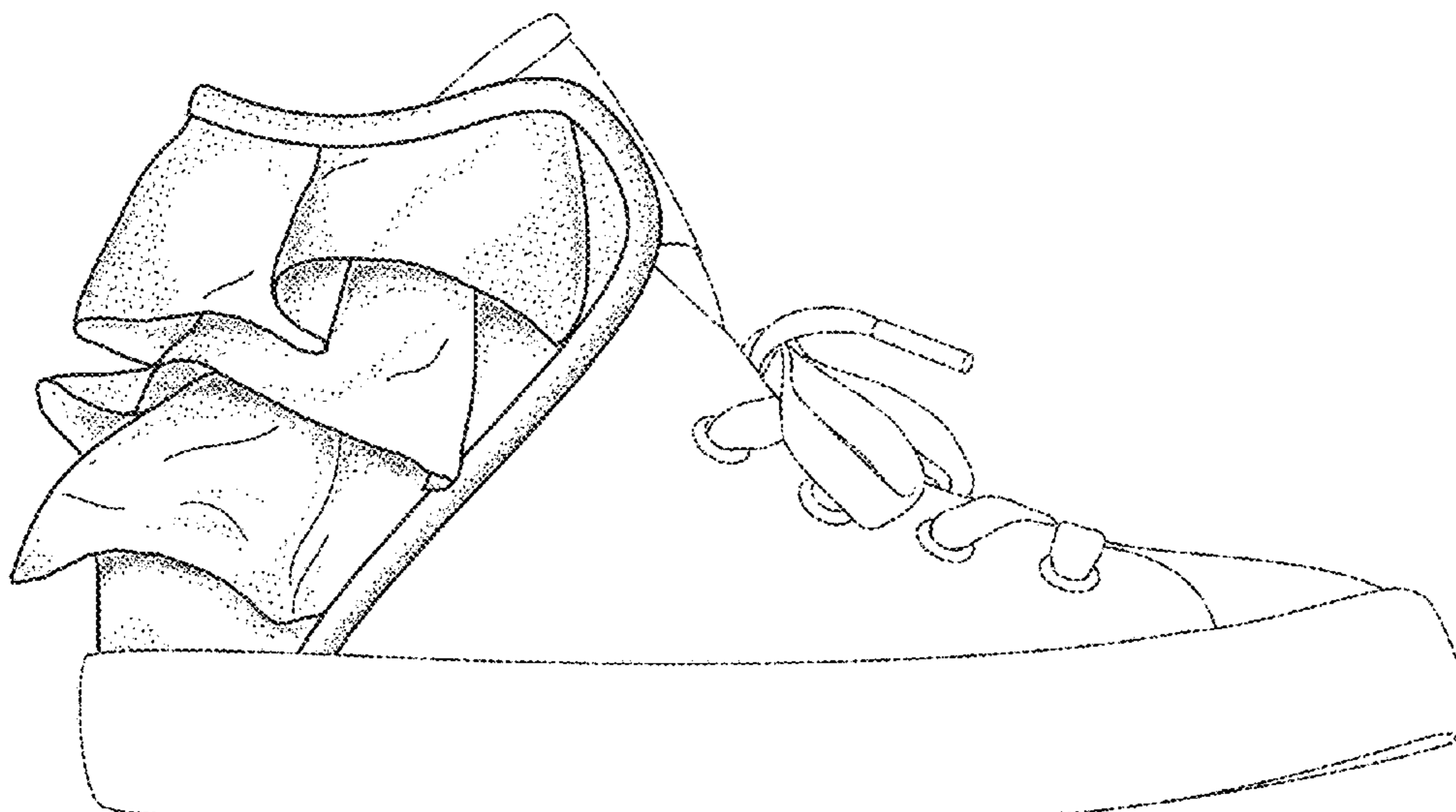
**DESCRIPTION**

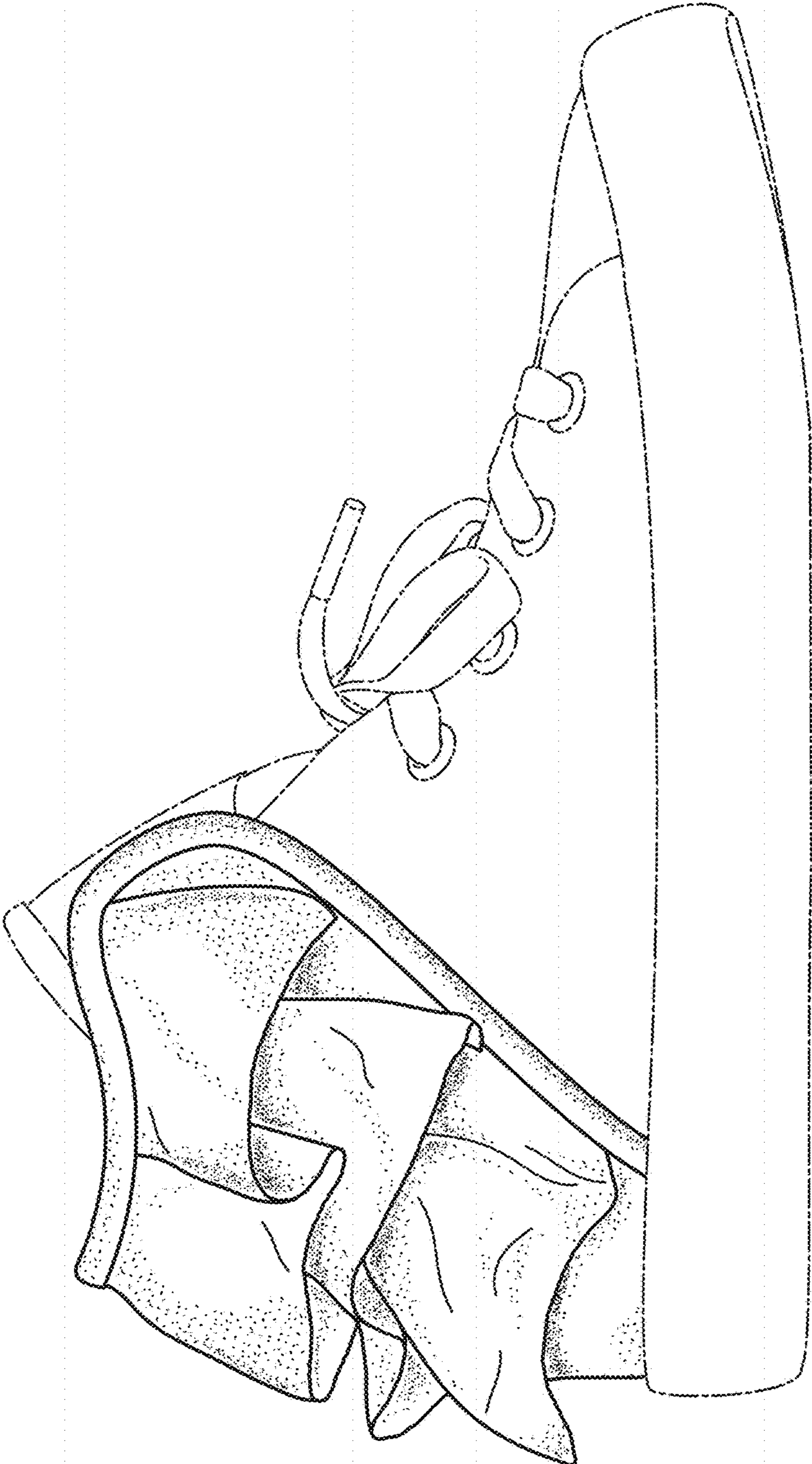

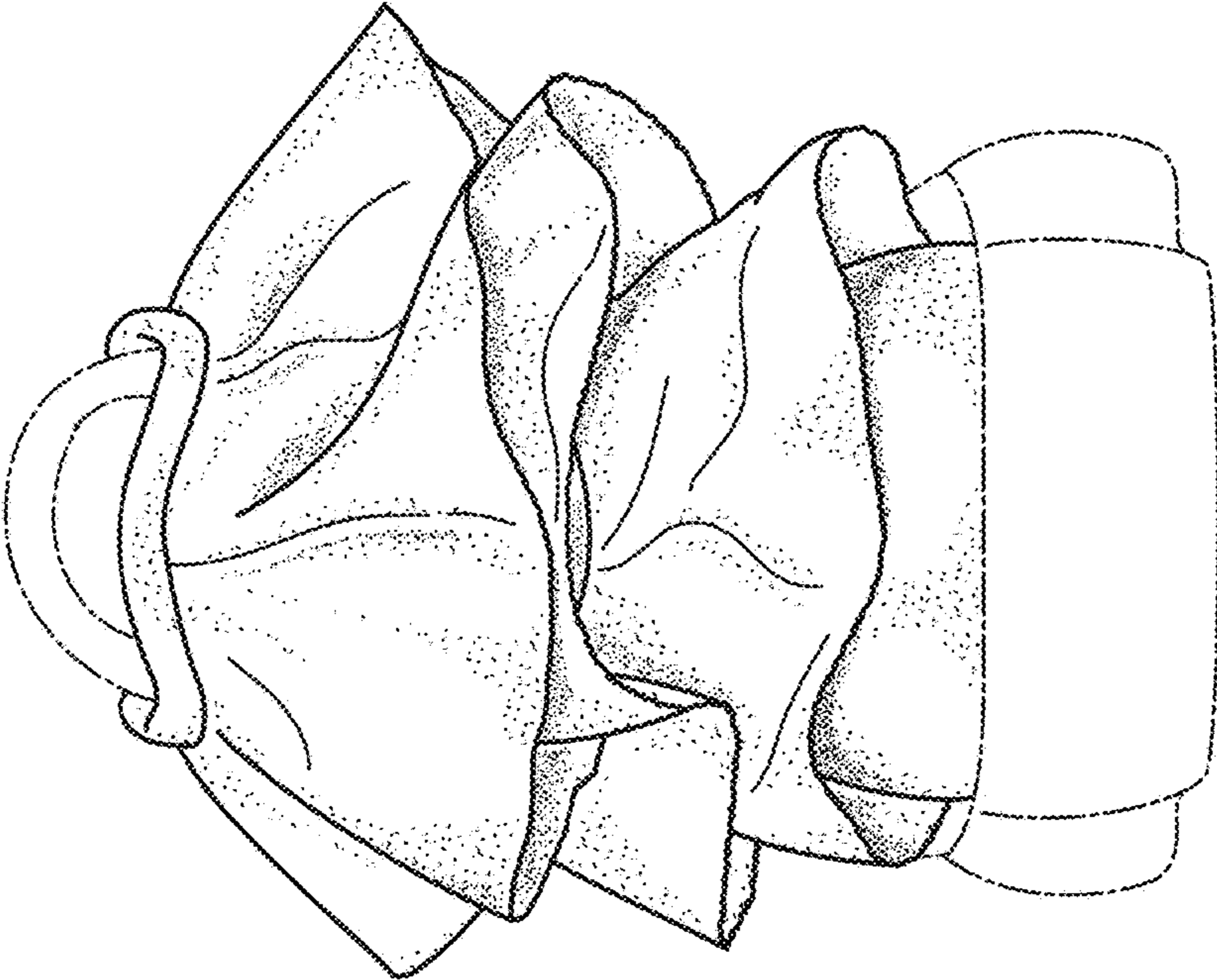

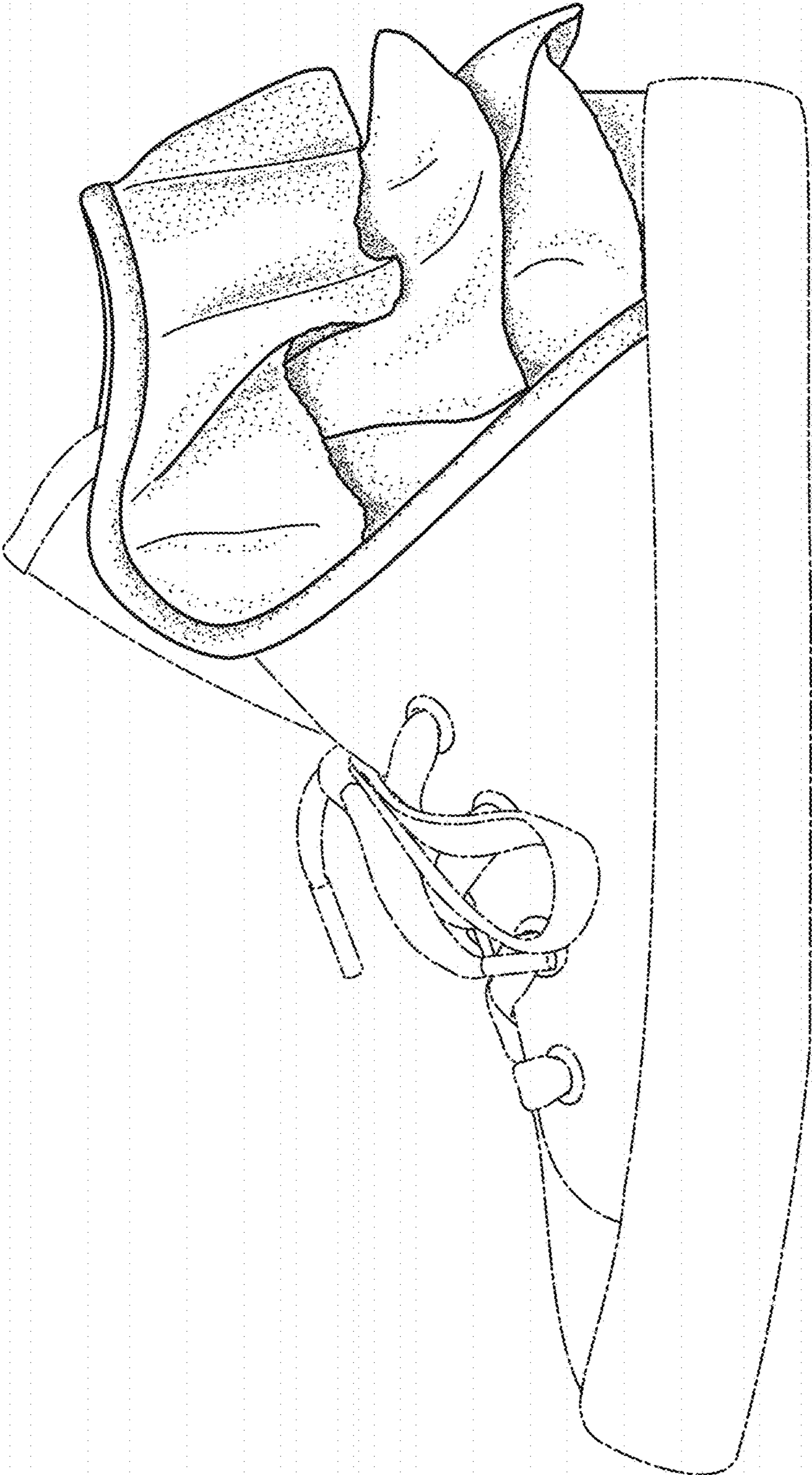
