The ornamental design for a personal carrying bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a personal carrying bag, showing my ornamental design thereof;  
FIG. 2 is a rear view thereof, with a back strap unattached;  
FIG. 3 is a rear view thereof, with a back strap attached; and,  
FIG. 4 is a front side perspective view thereof in an alternate configuration.

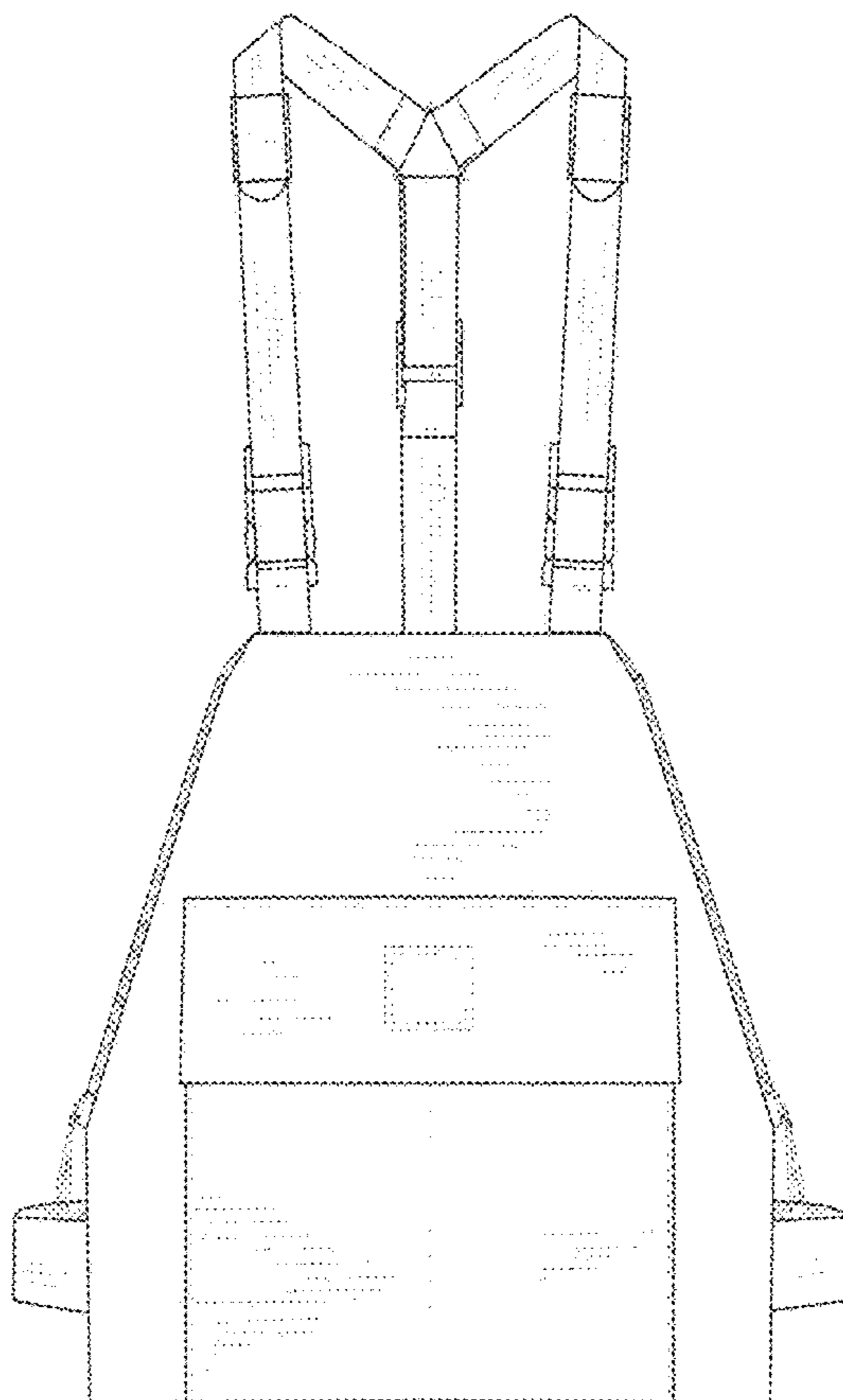

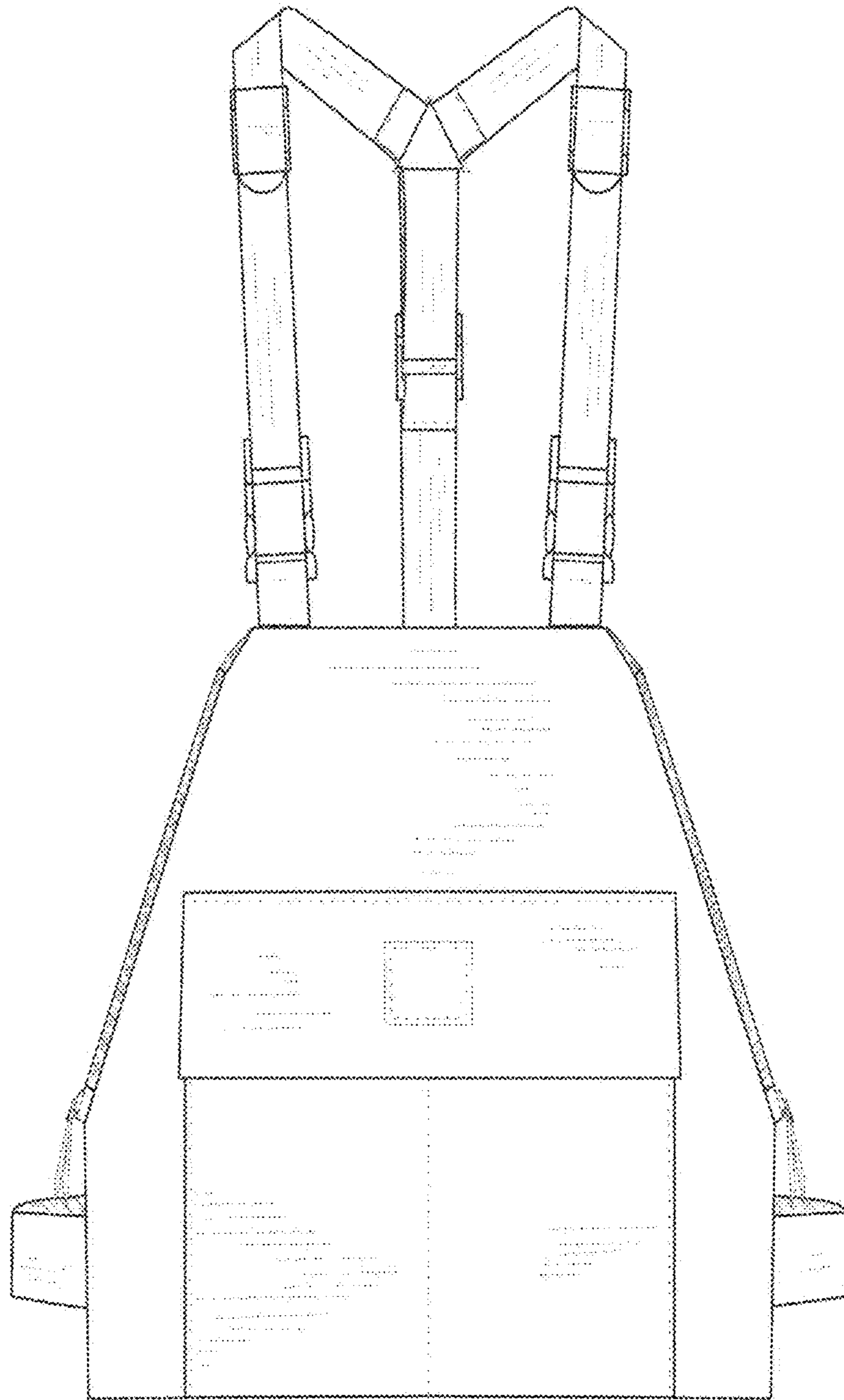

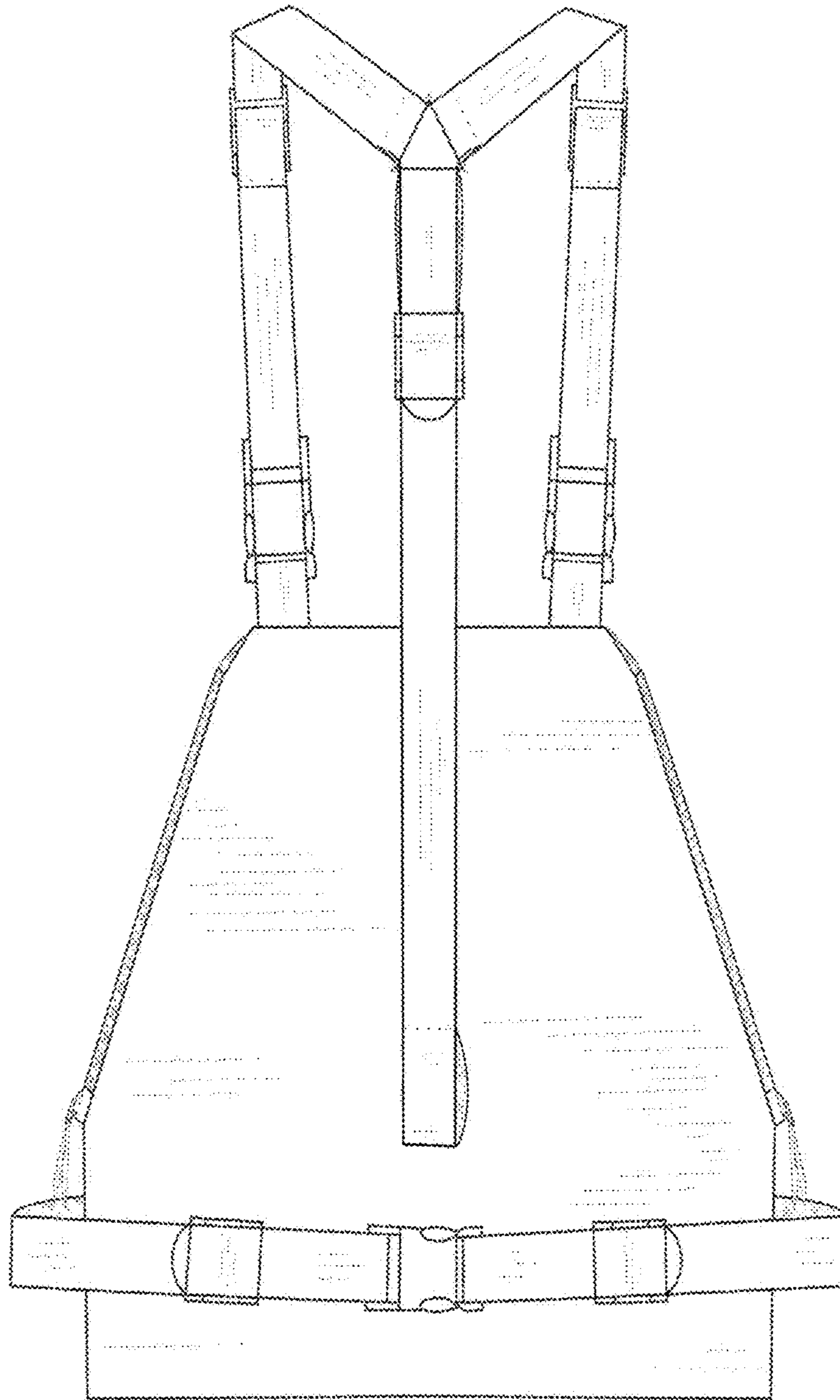
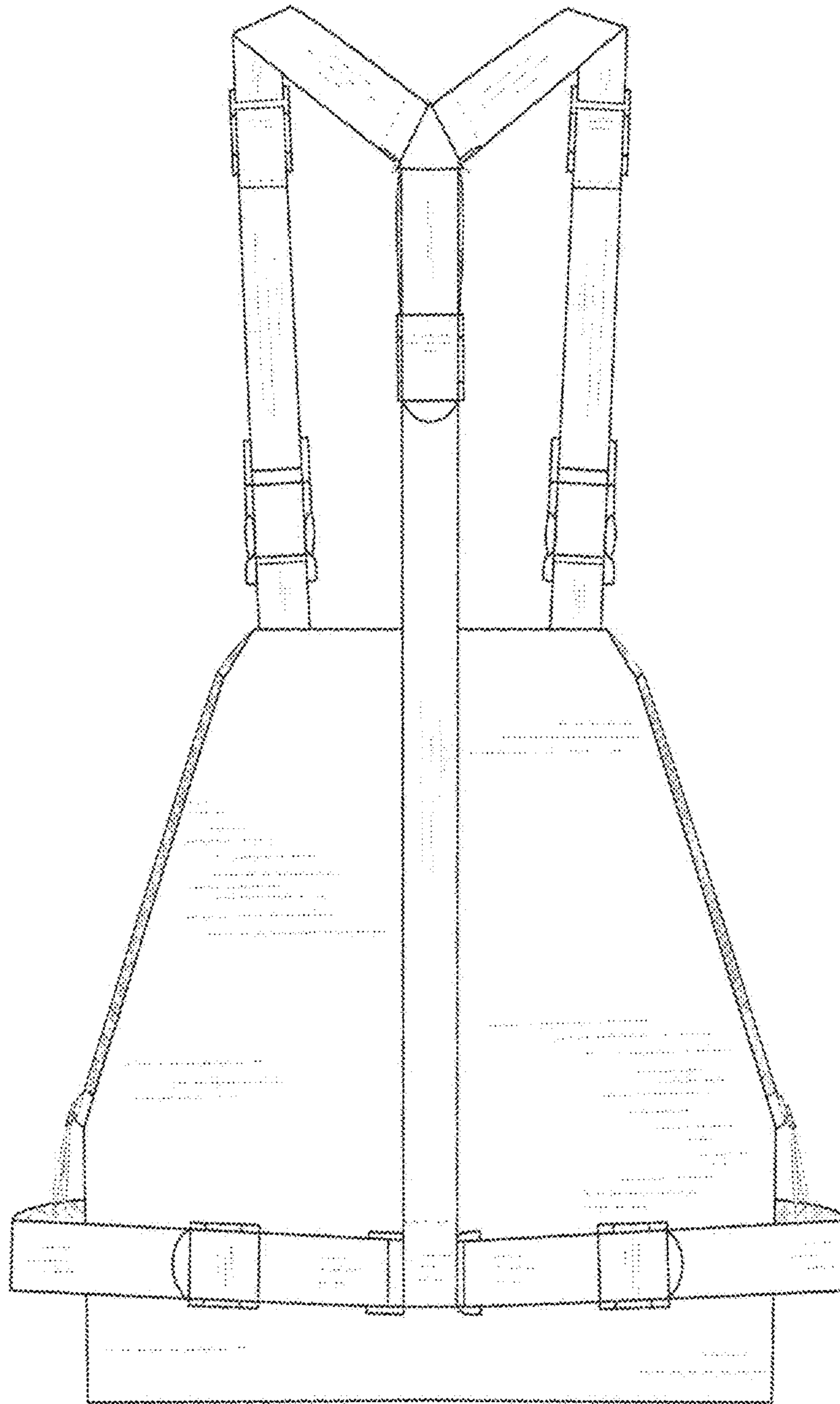

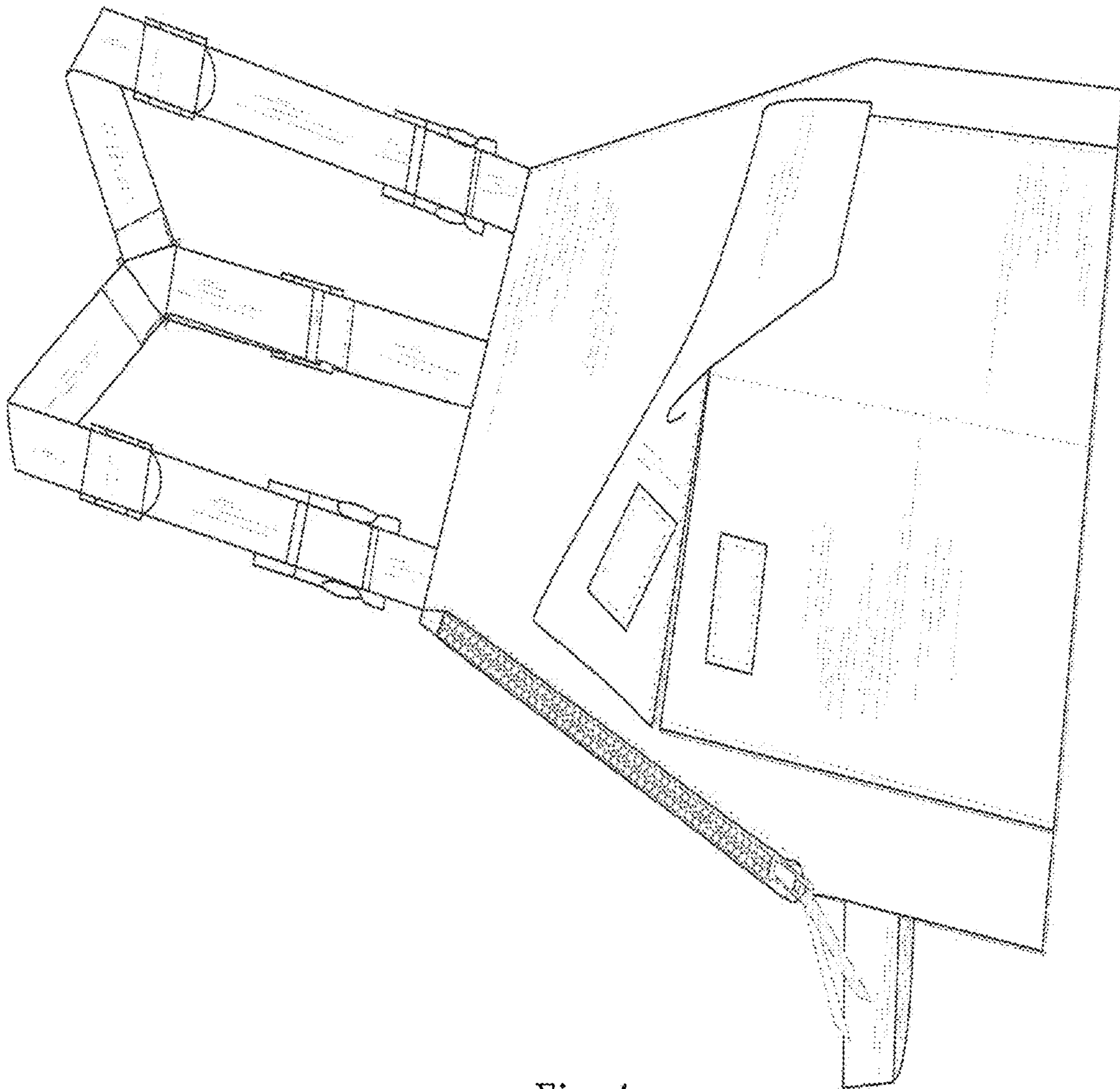
