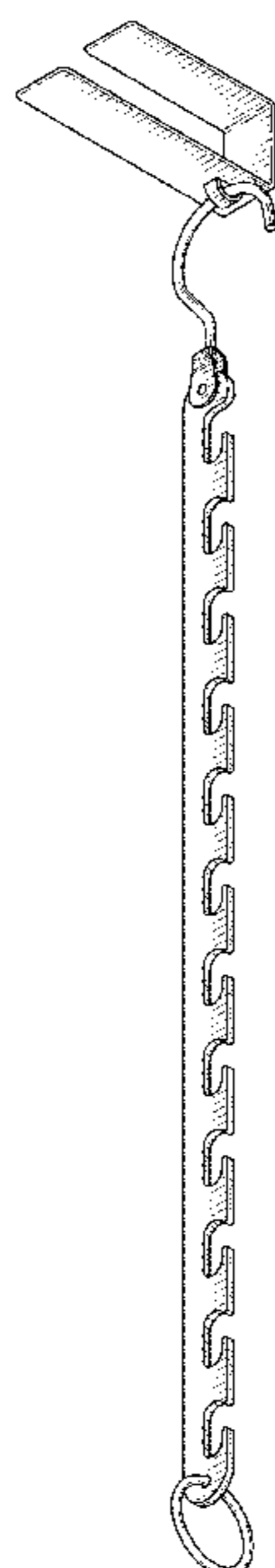
(57) **CLAIM**

The ornamental design for a vertical drop hanger with over the door hook, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vertical drop hanger with over the door hook, showing my new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a second side view thereof;  
FIG. 6 is a front view thereof; and,  
FIG. 7 is a rear view thereof.  
The shade lines in the Figures show contour and not surface ornamentation.

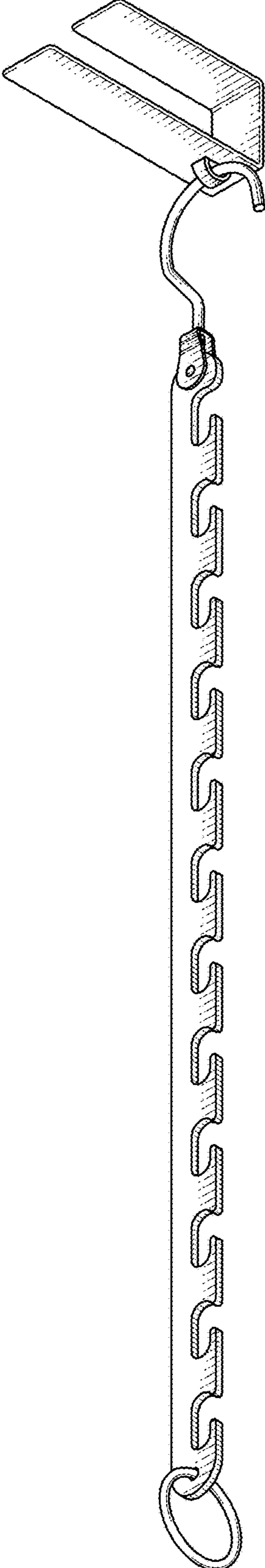

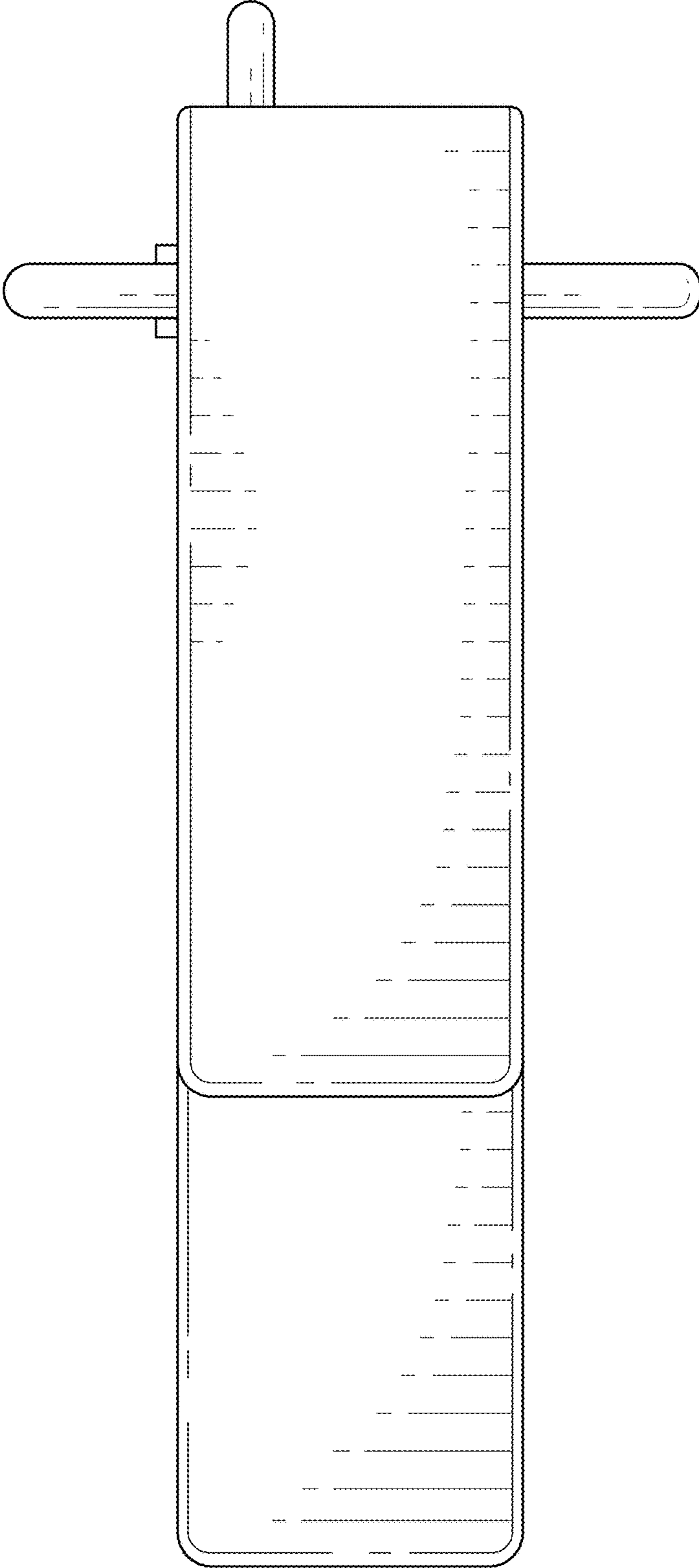

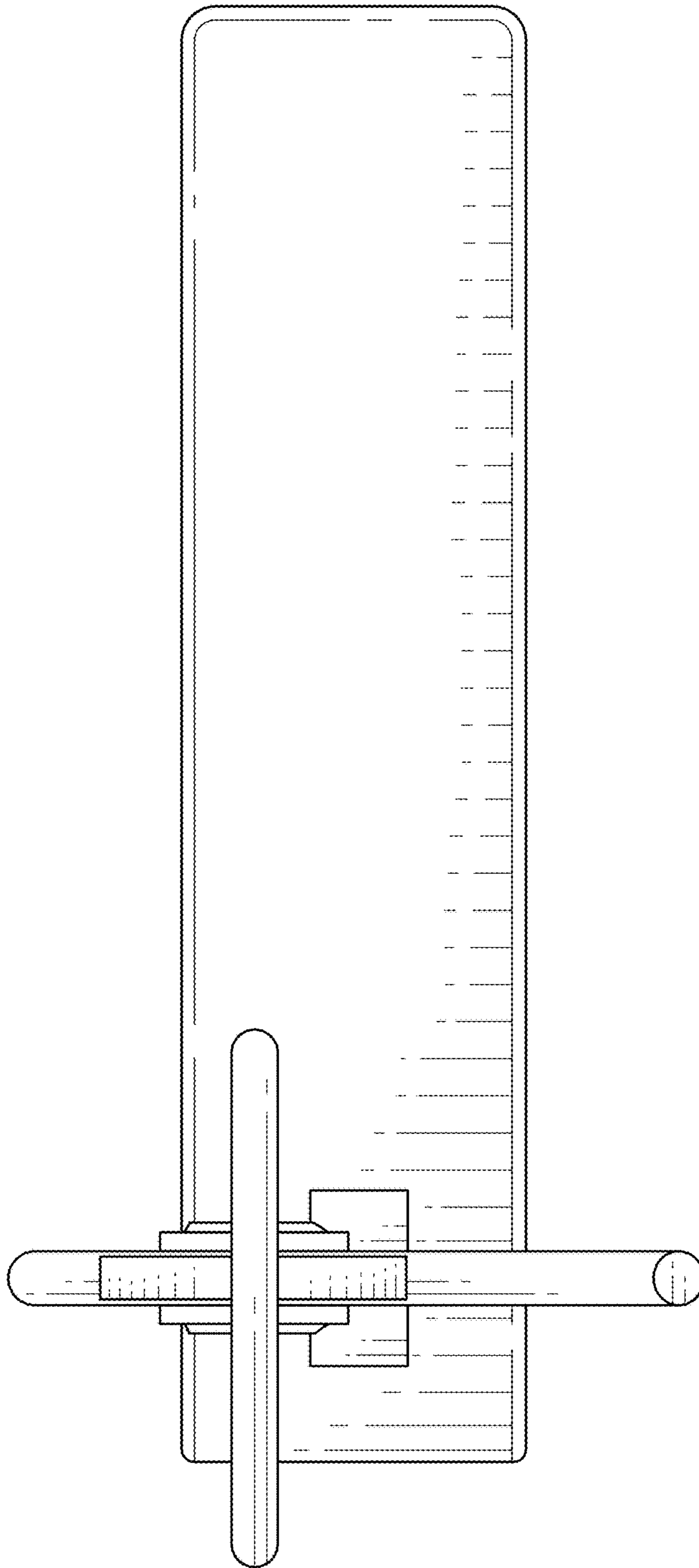

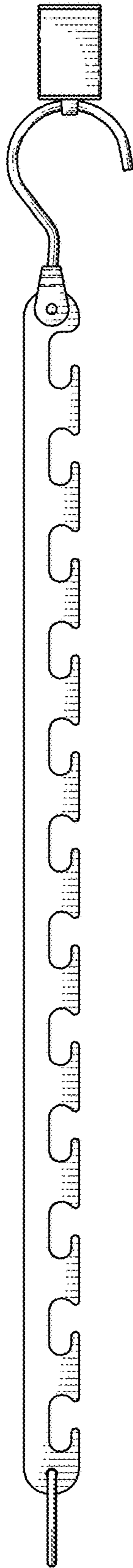

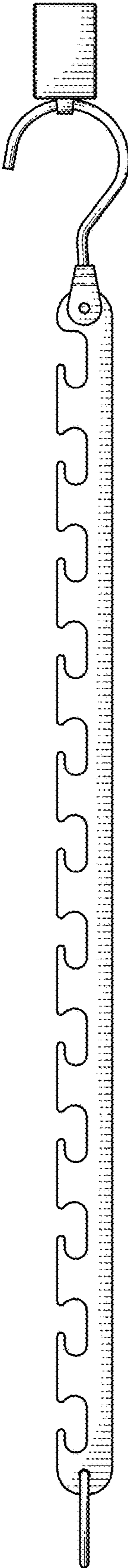

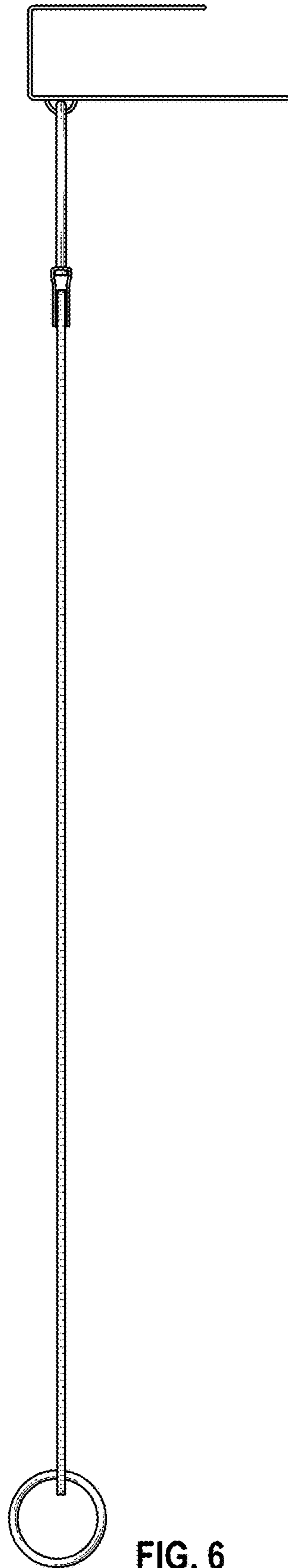

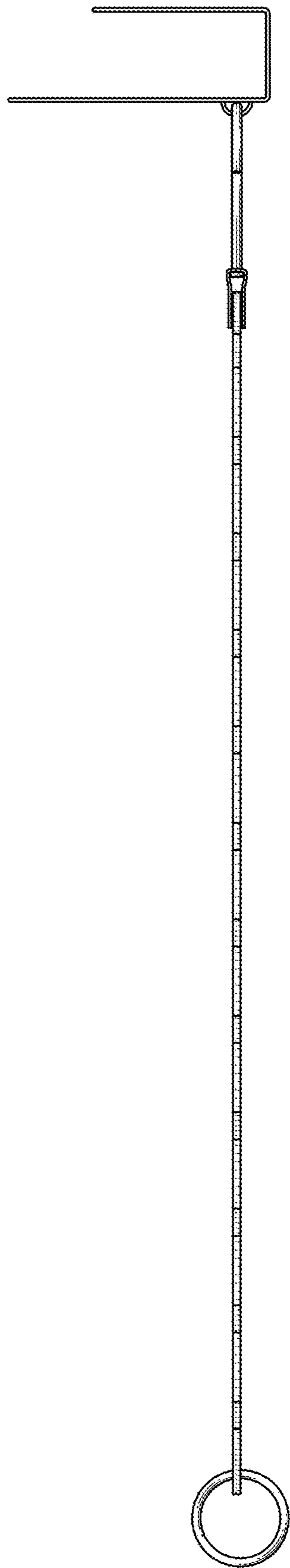
