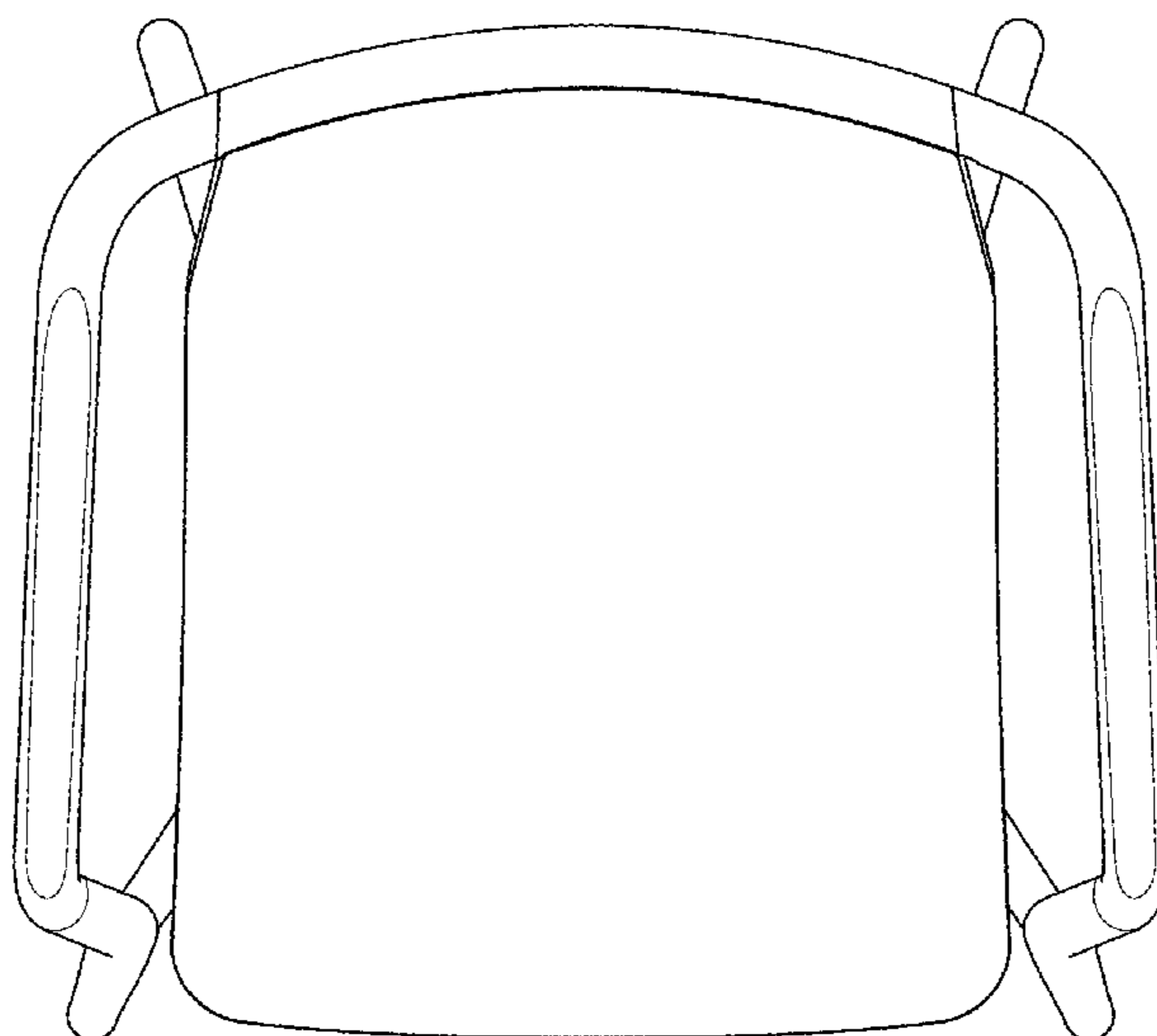
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a chair showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front perspective view thereof; and,
FIG. 7 is a rear perspective view thereof.
The right side elevation view has not been shown as it is a
mirror image of the left side.

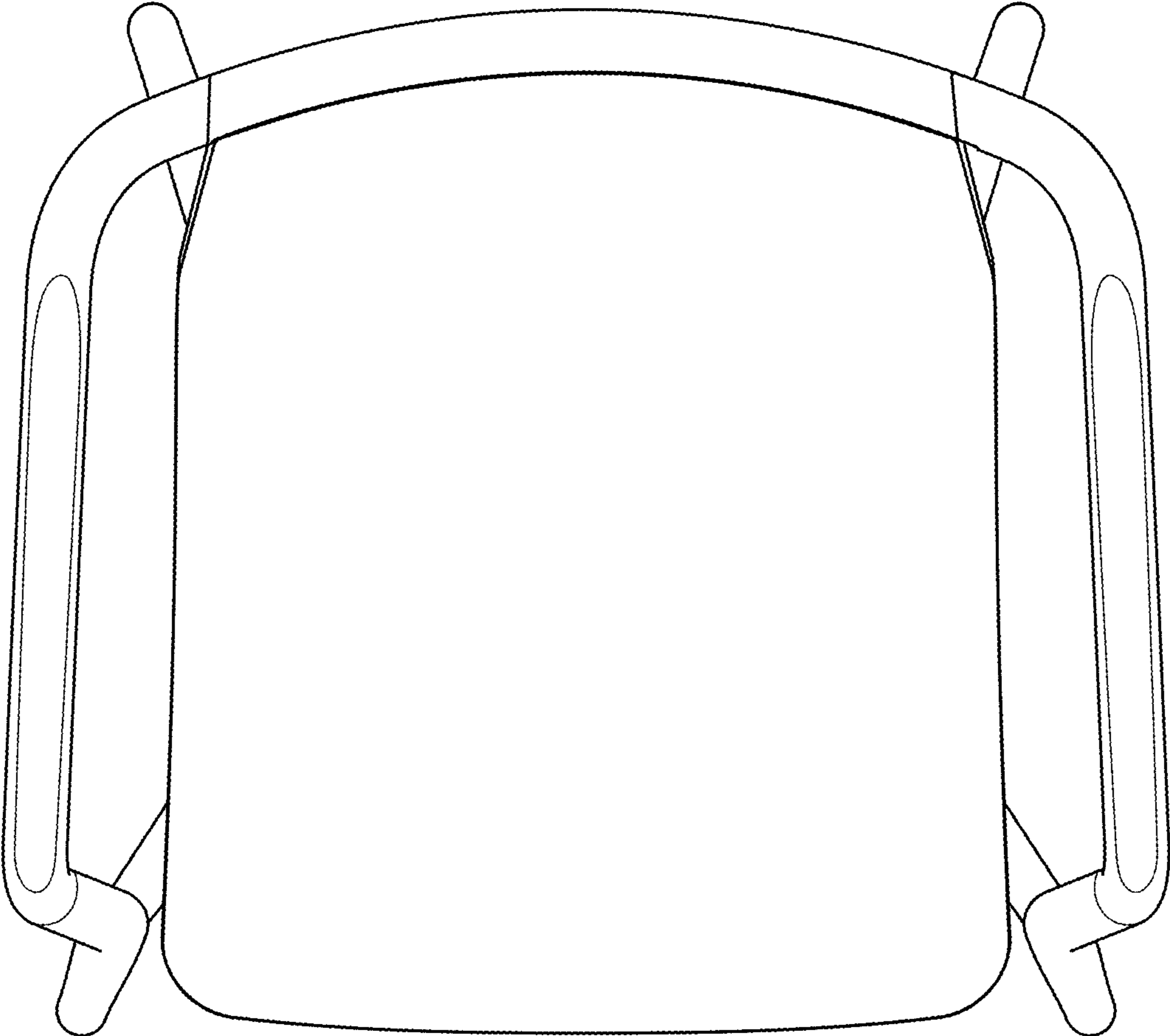

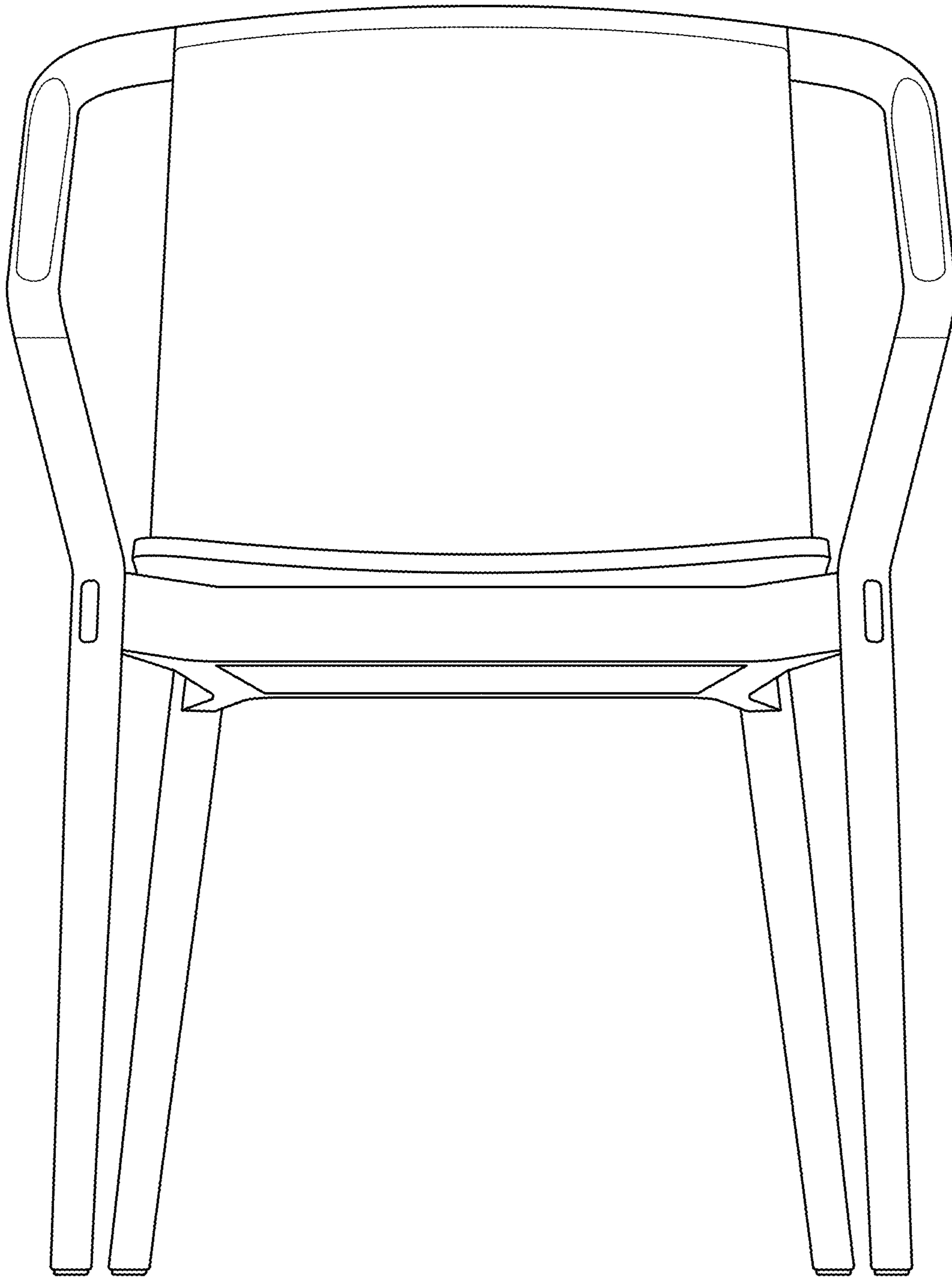

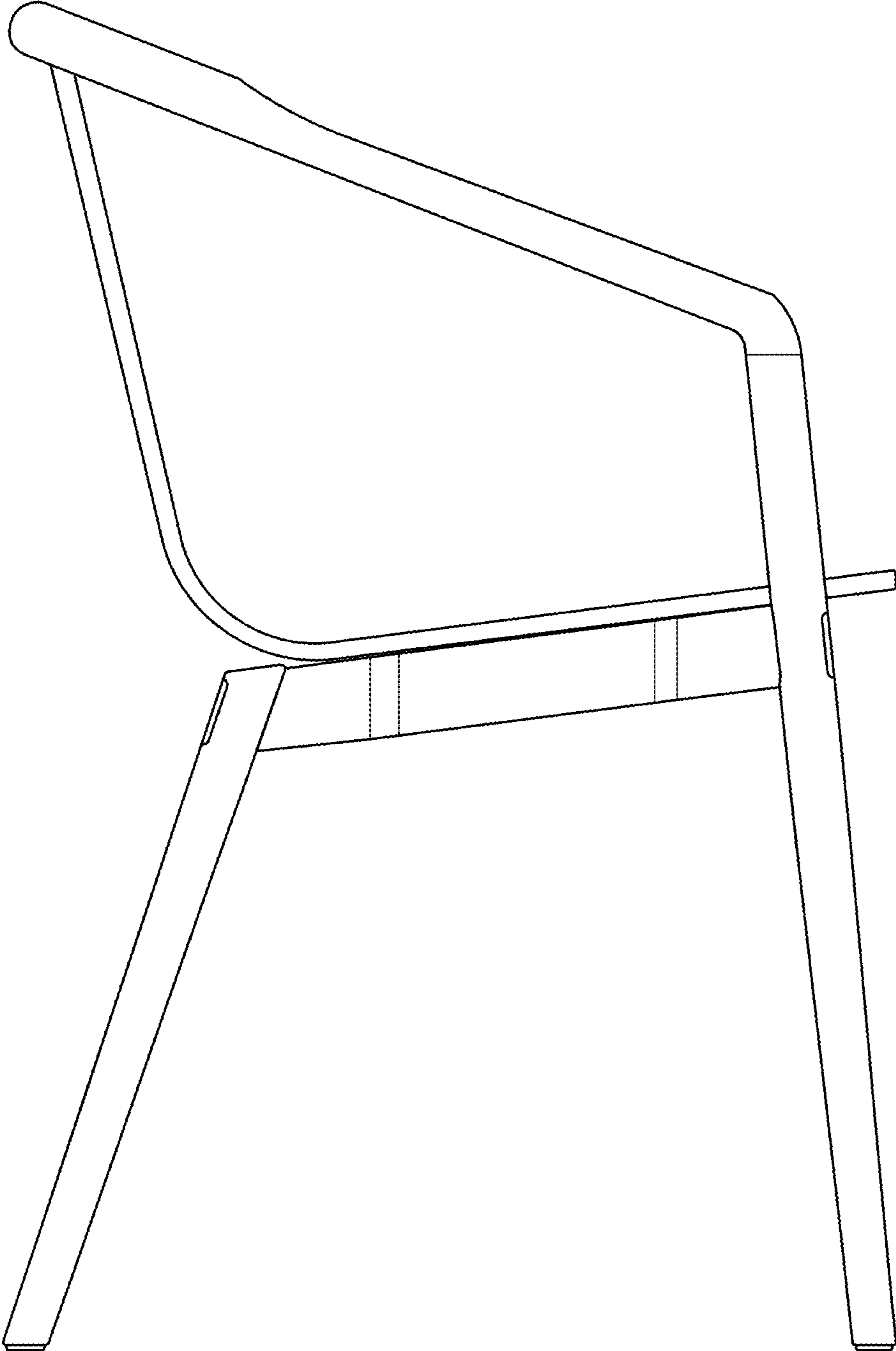

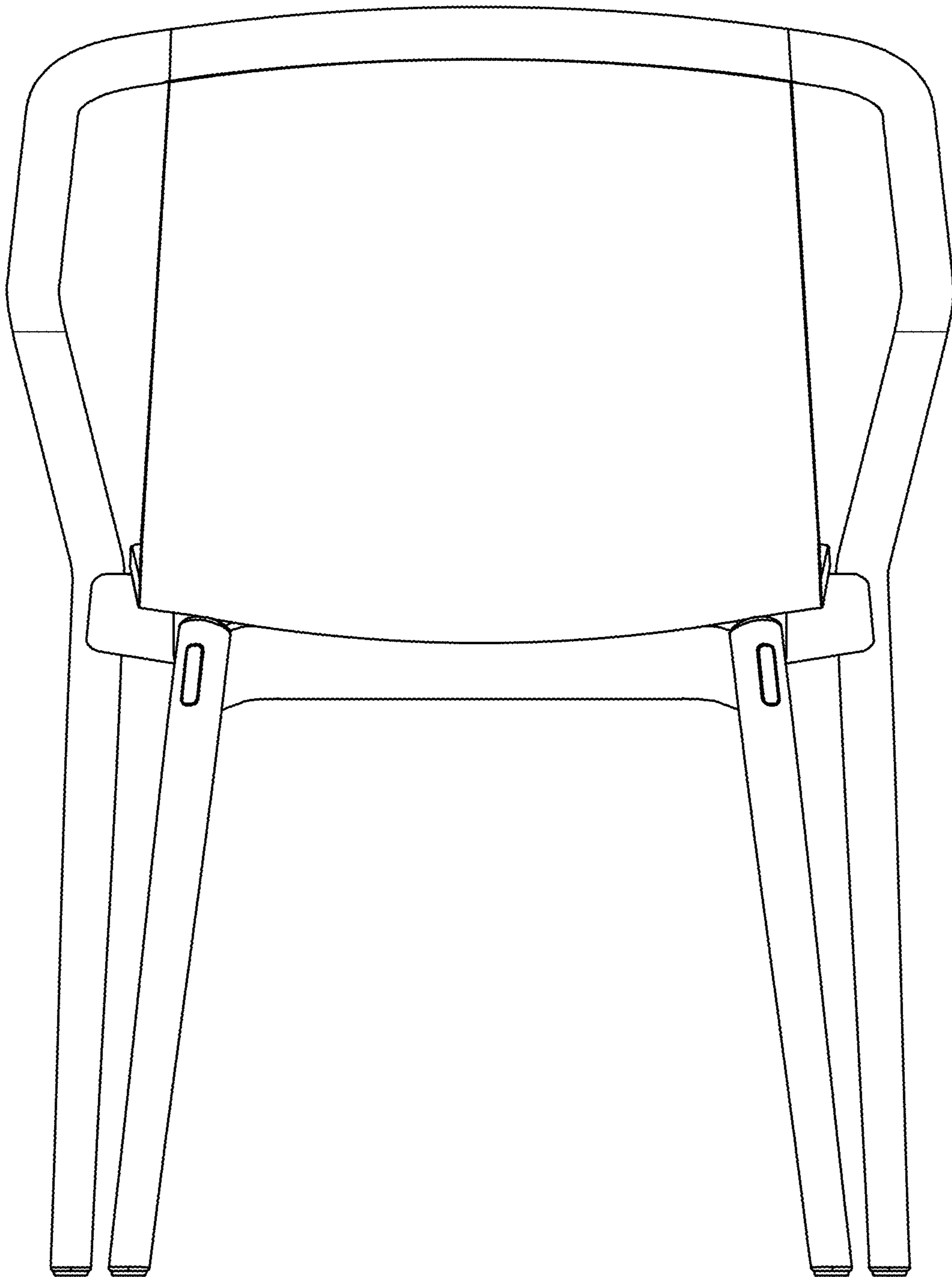

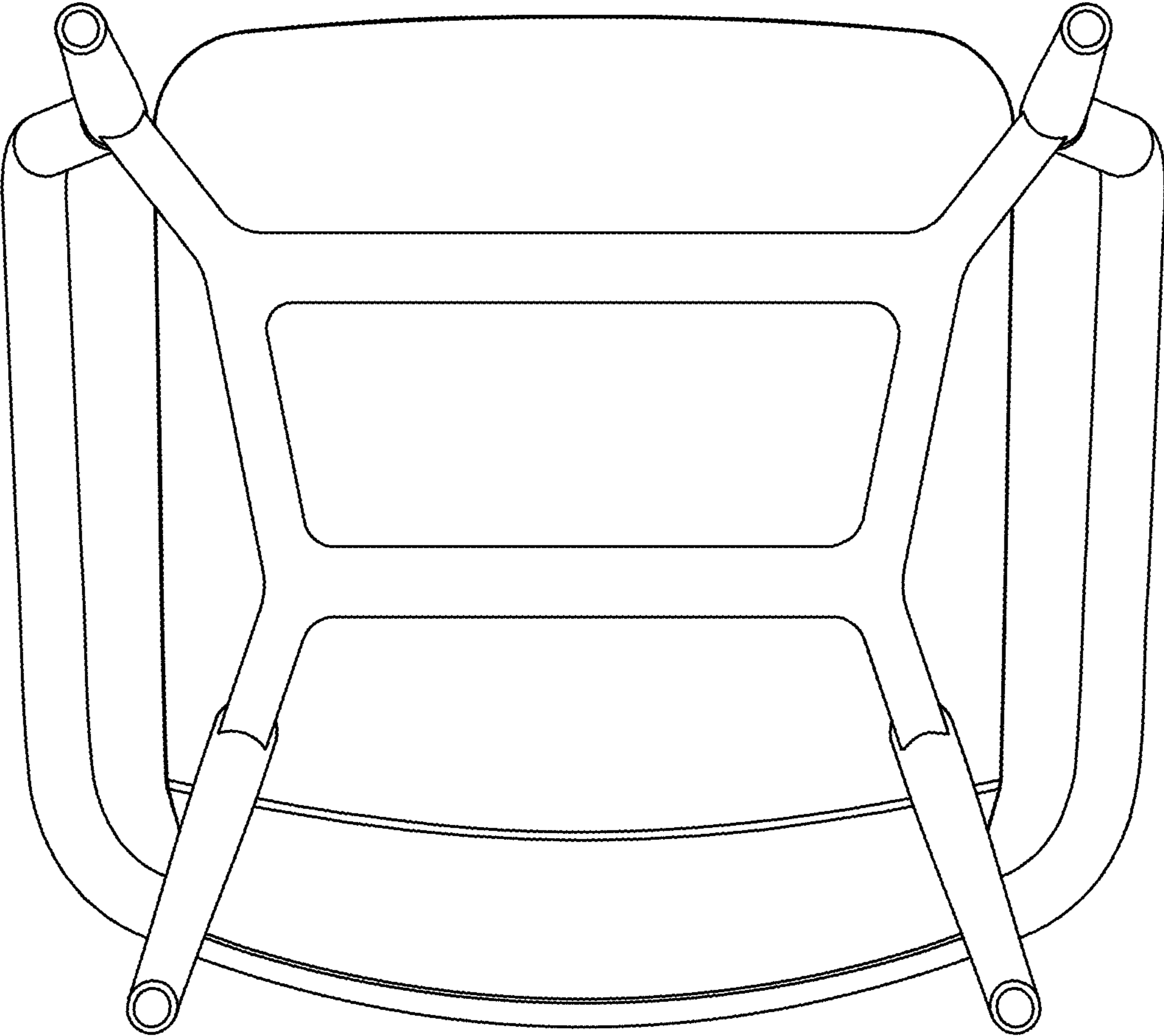

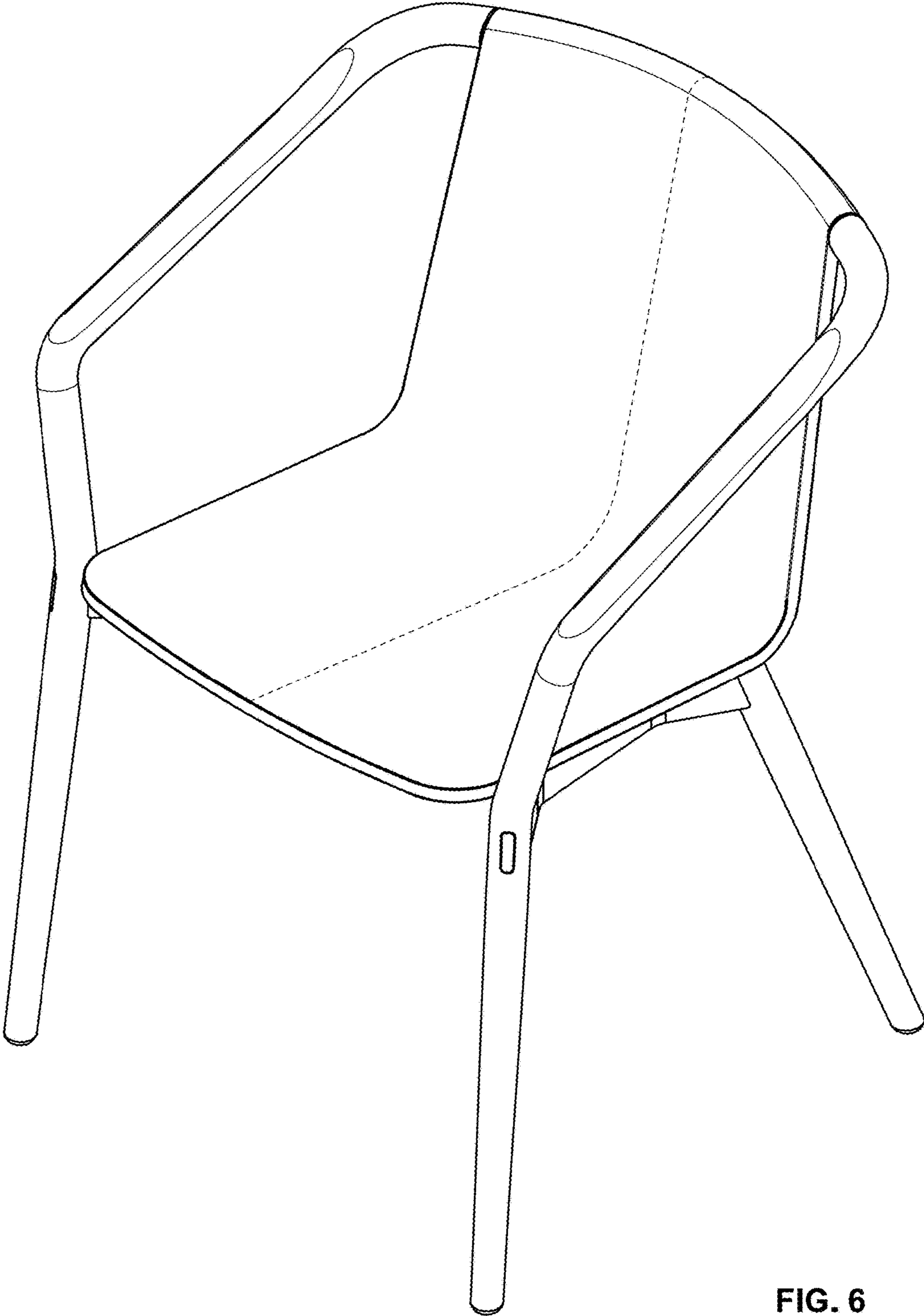

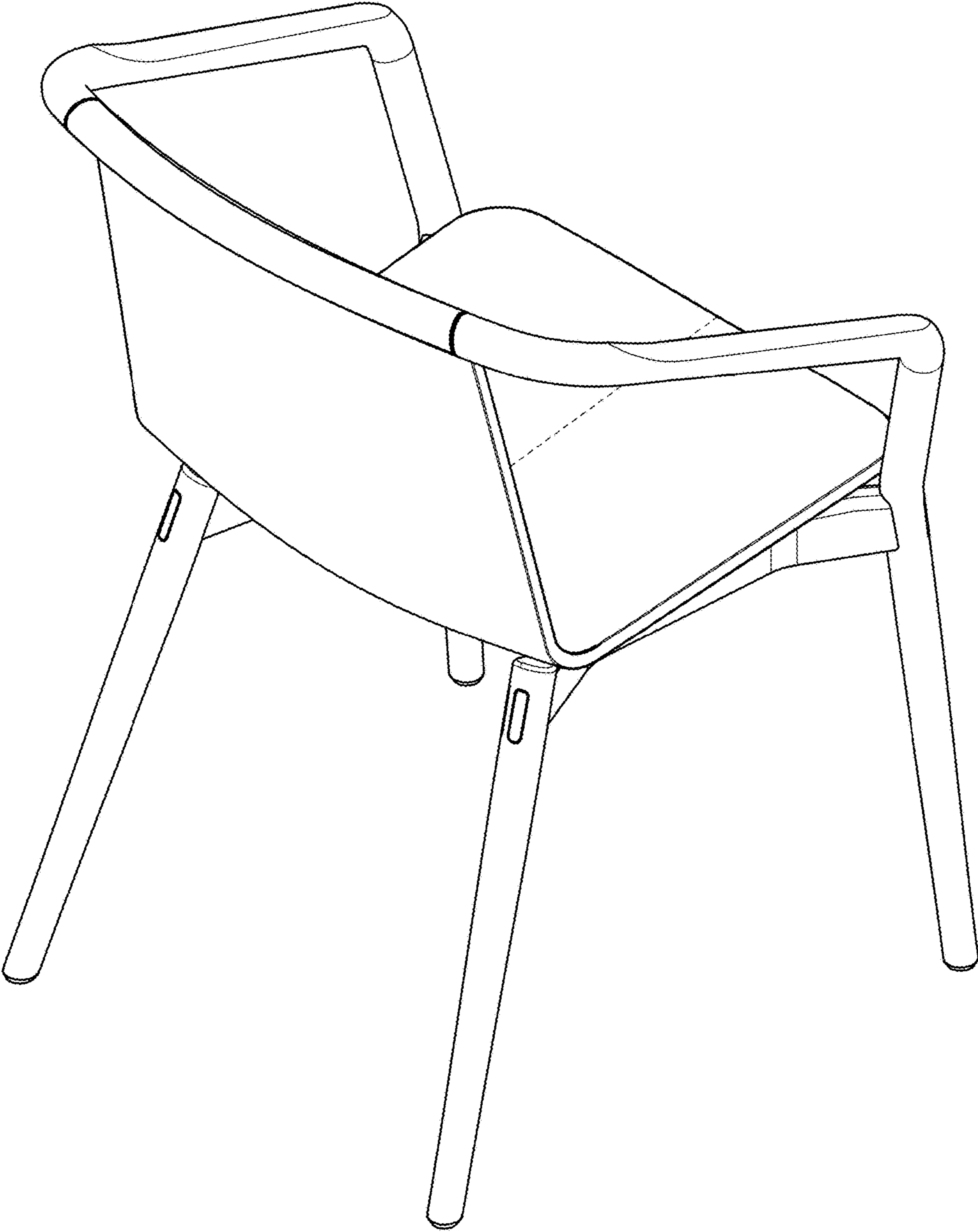
