DESCRIPTION

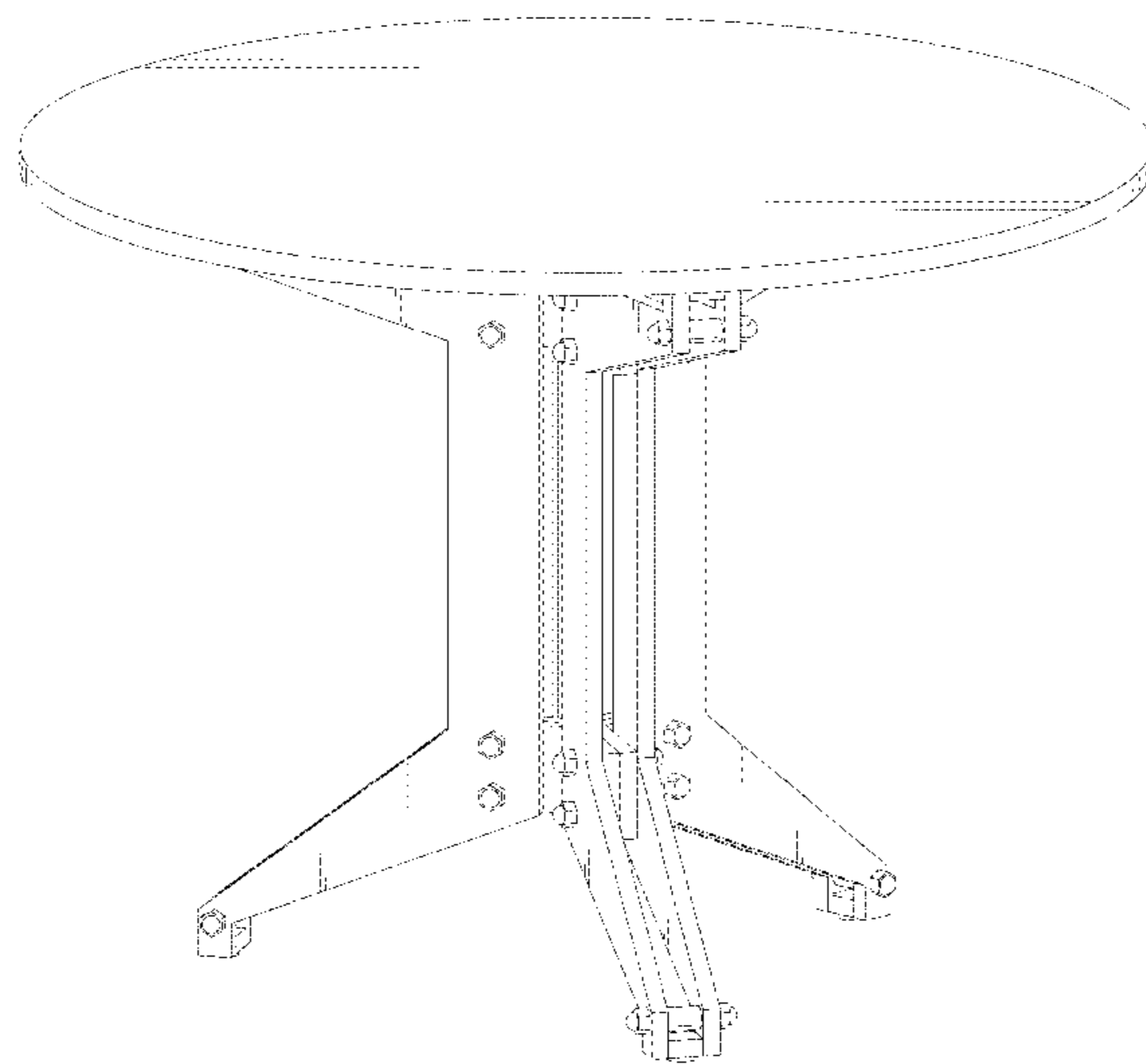
FIG. 1 is a front perspective view of the side table with a round top;

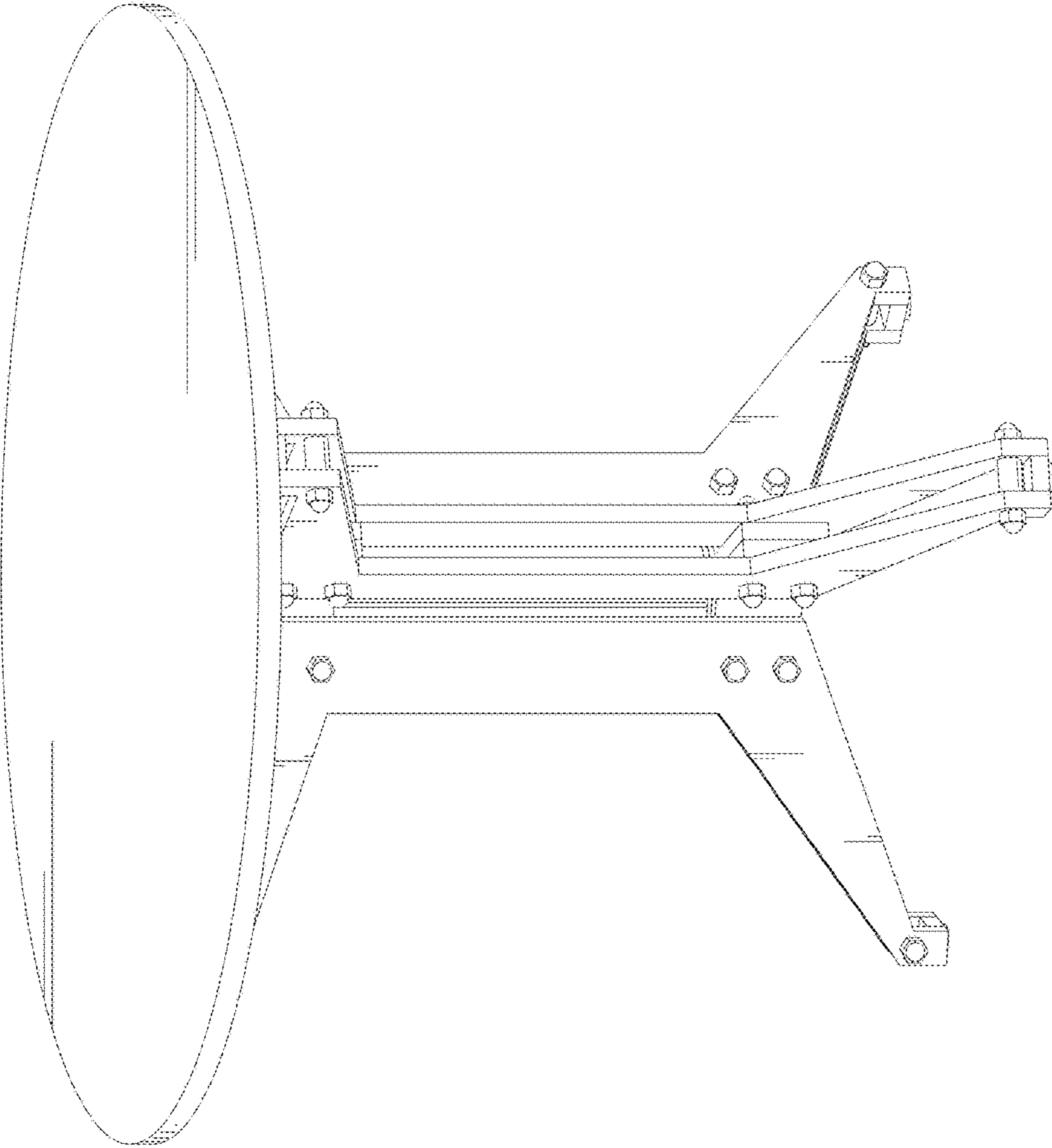

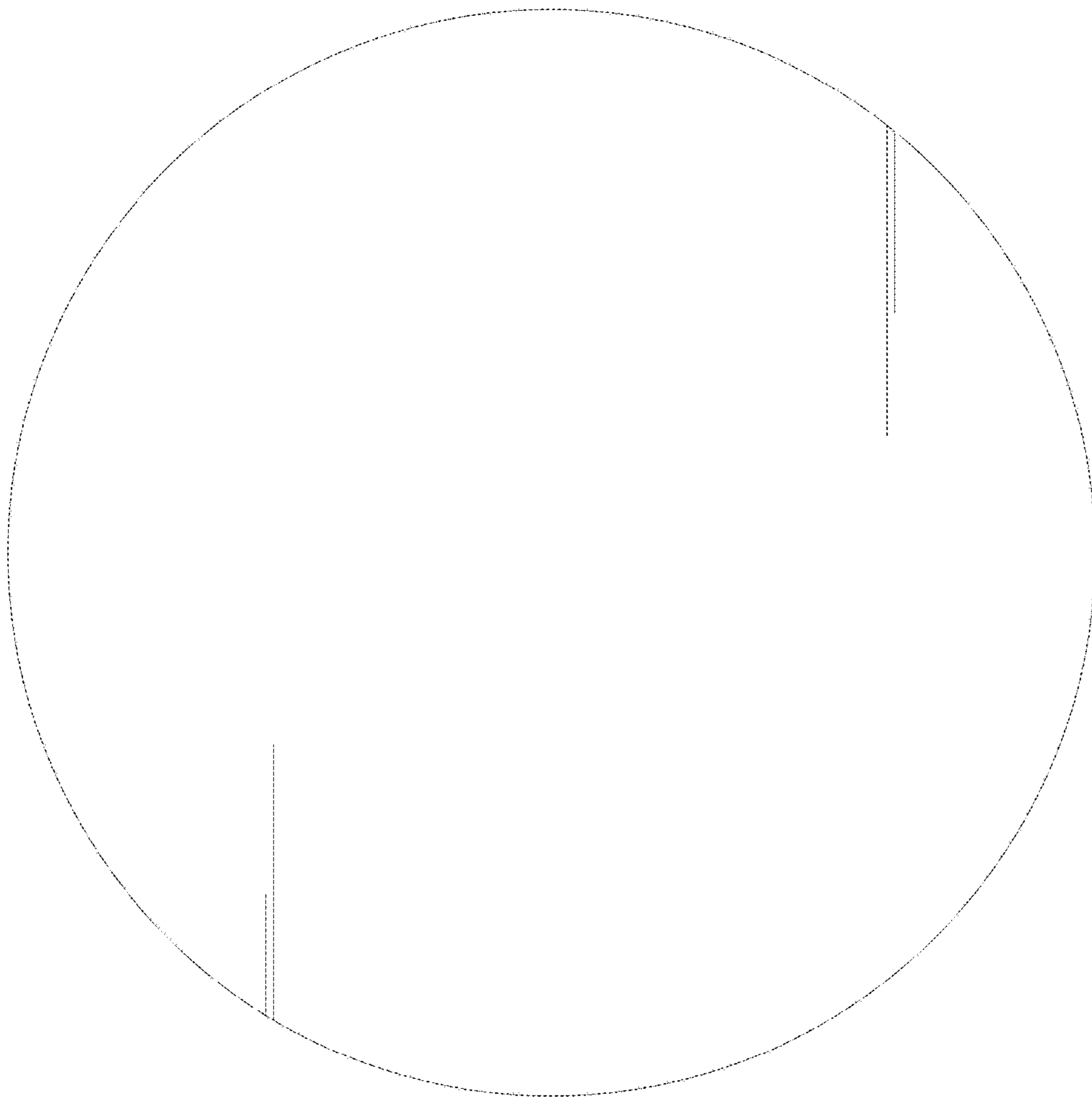

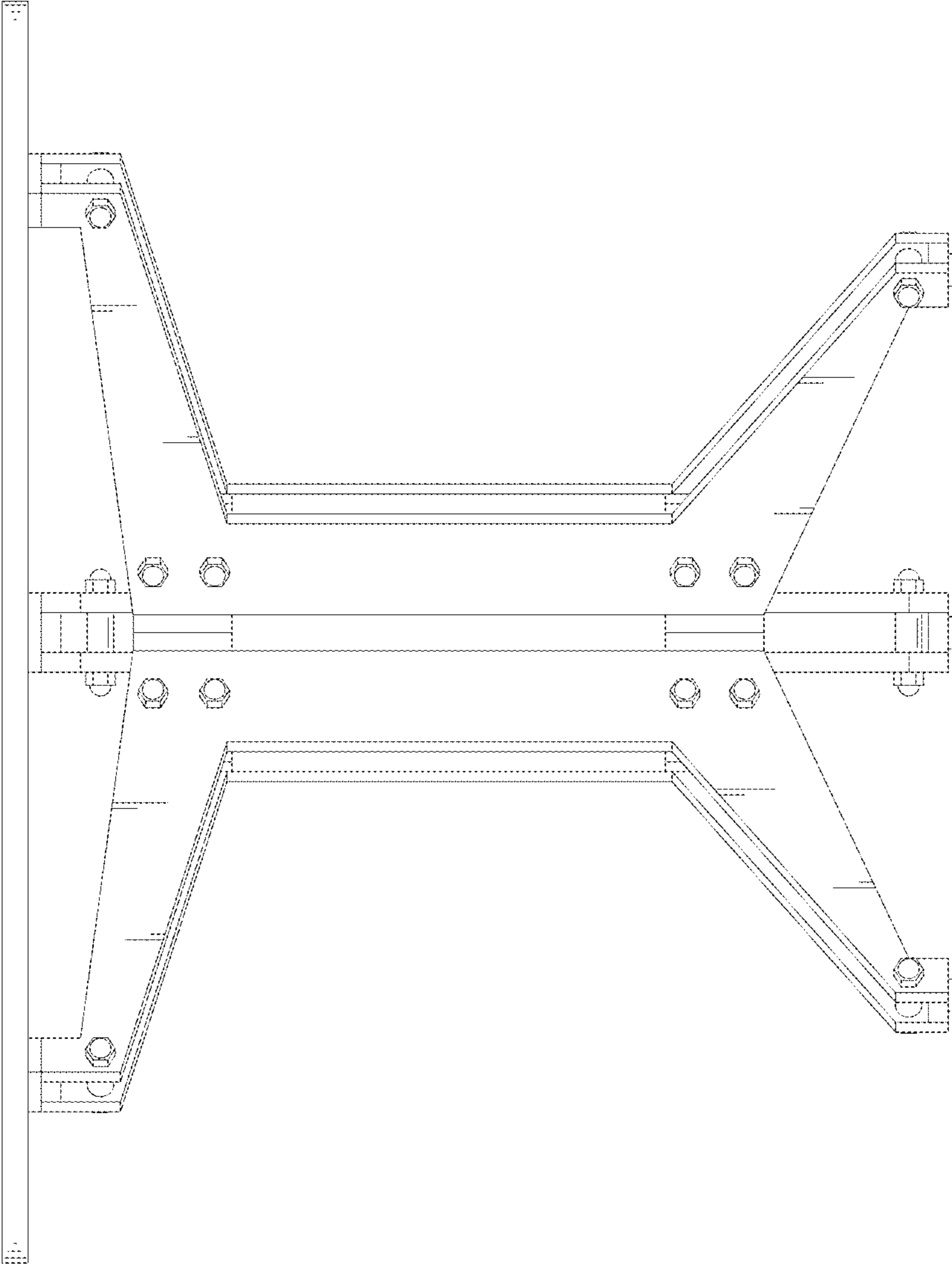

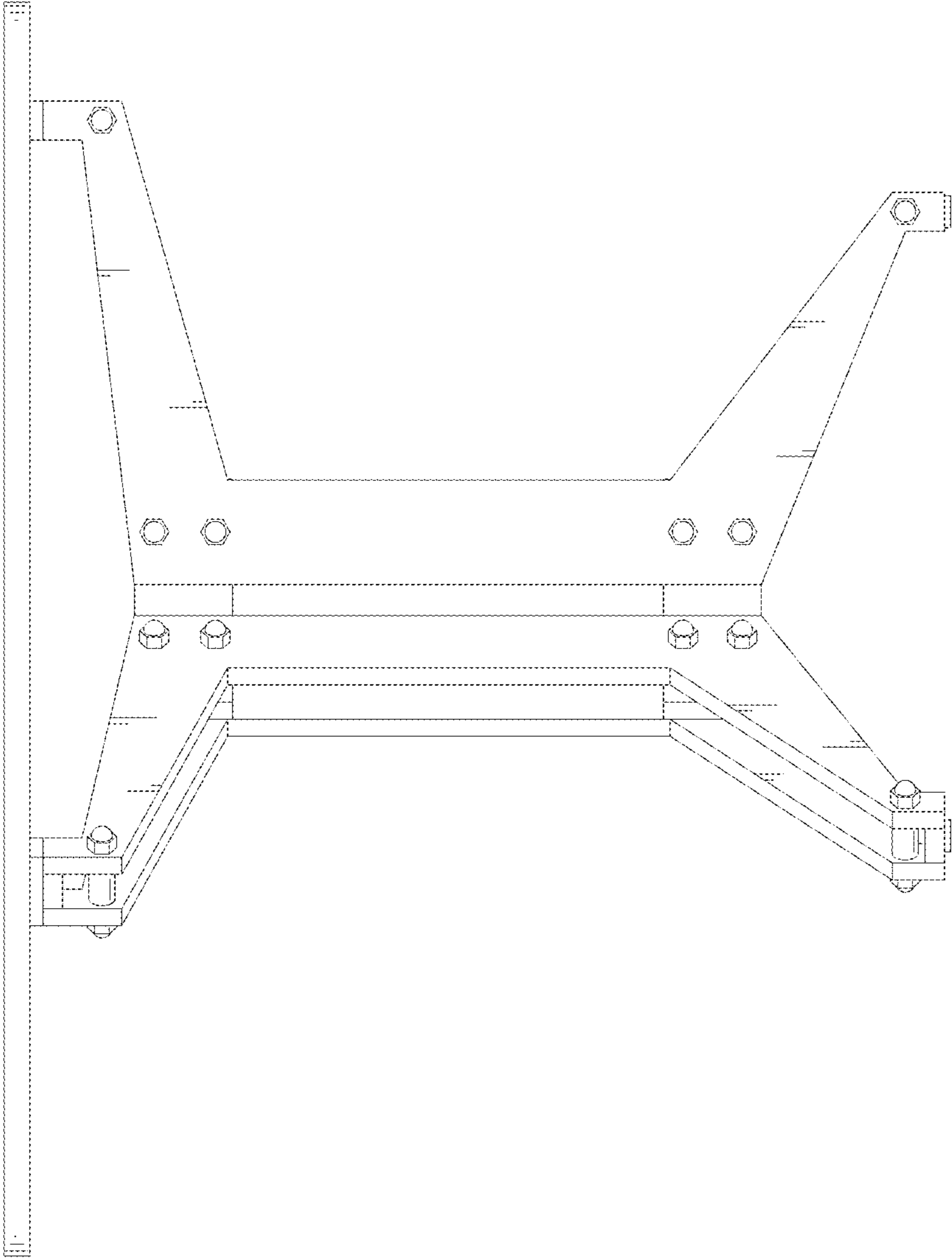

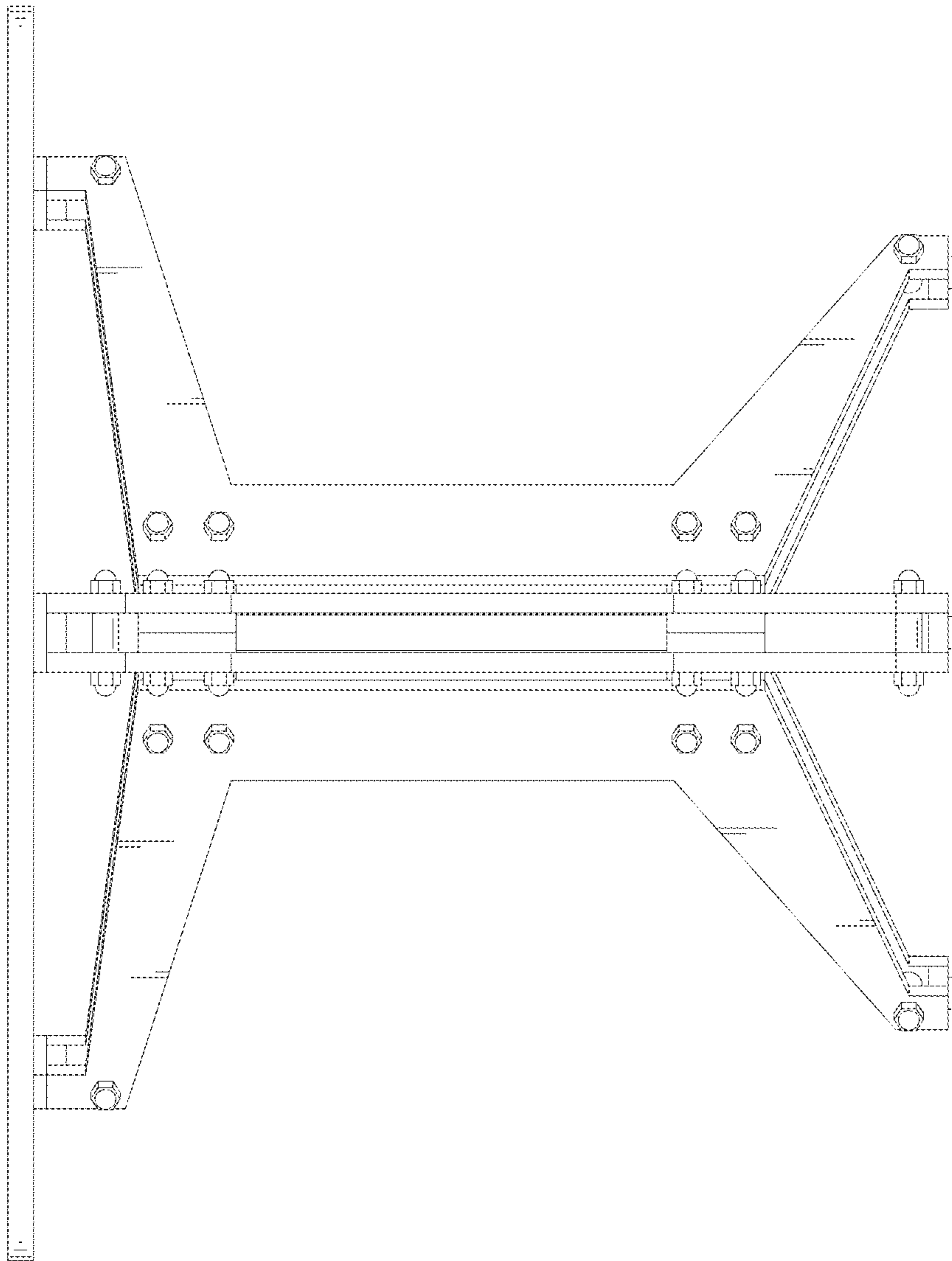

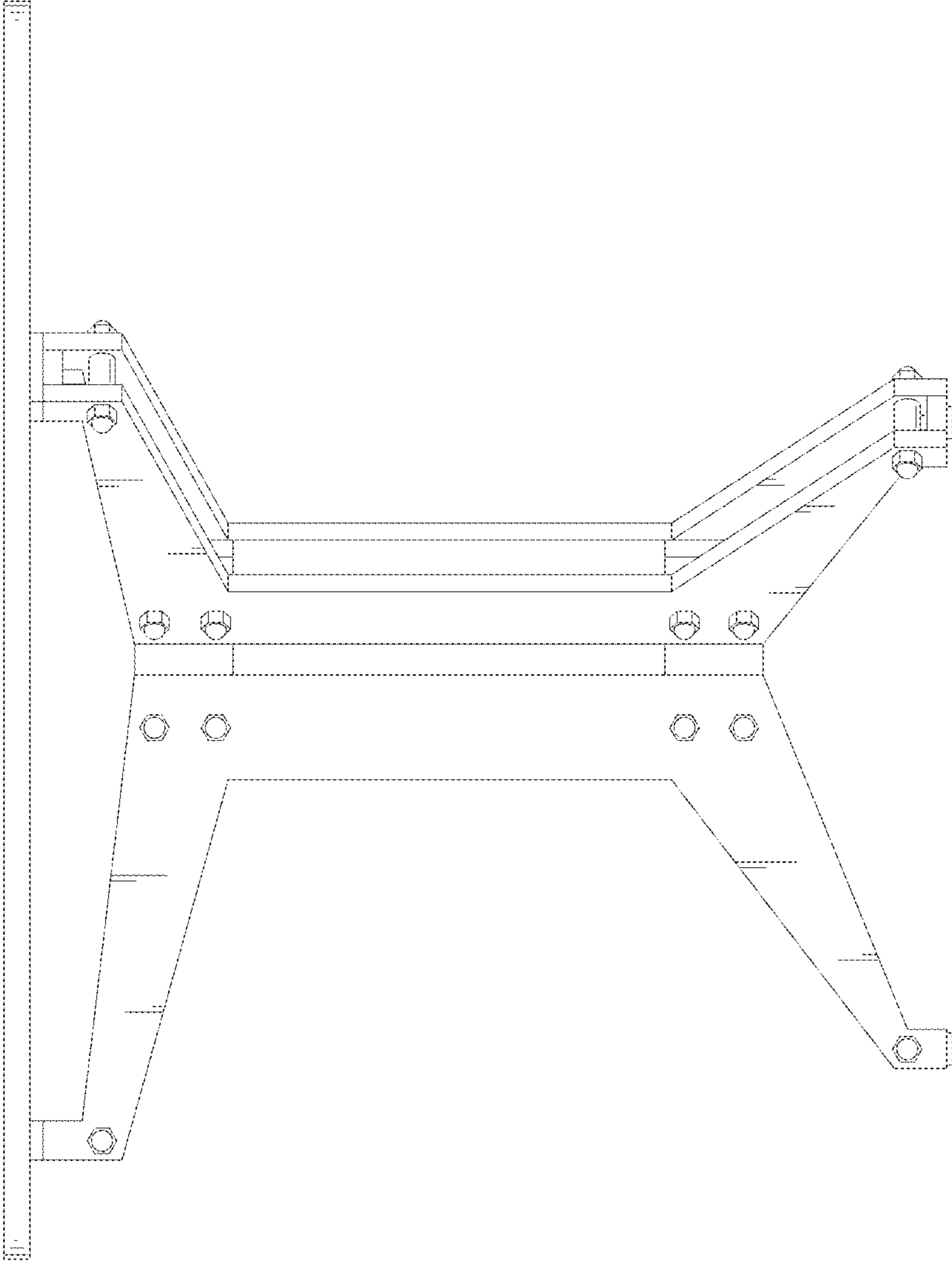

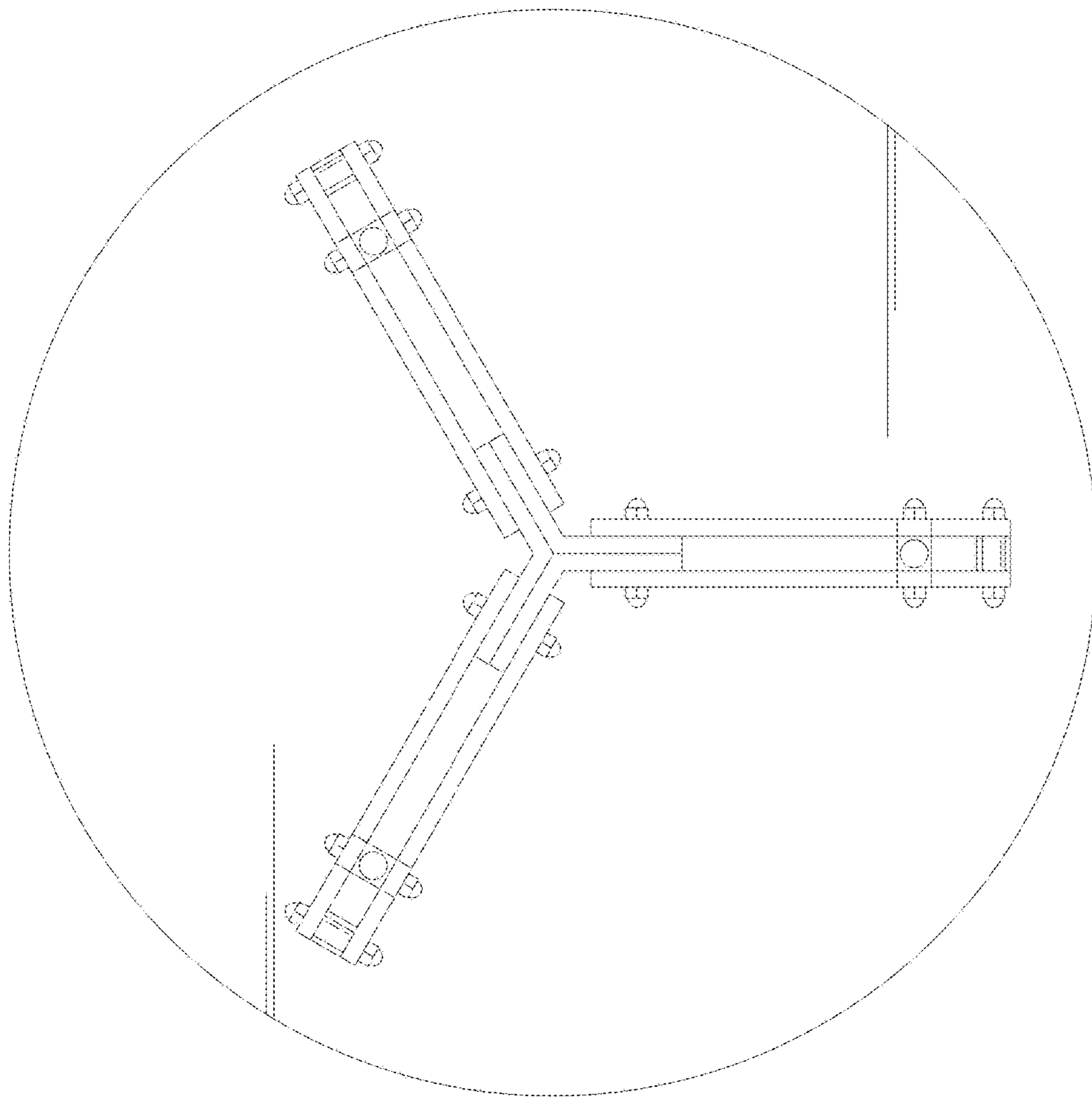

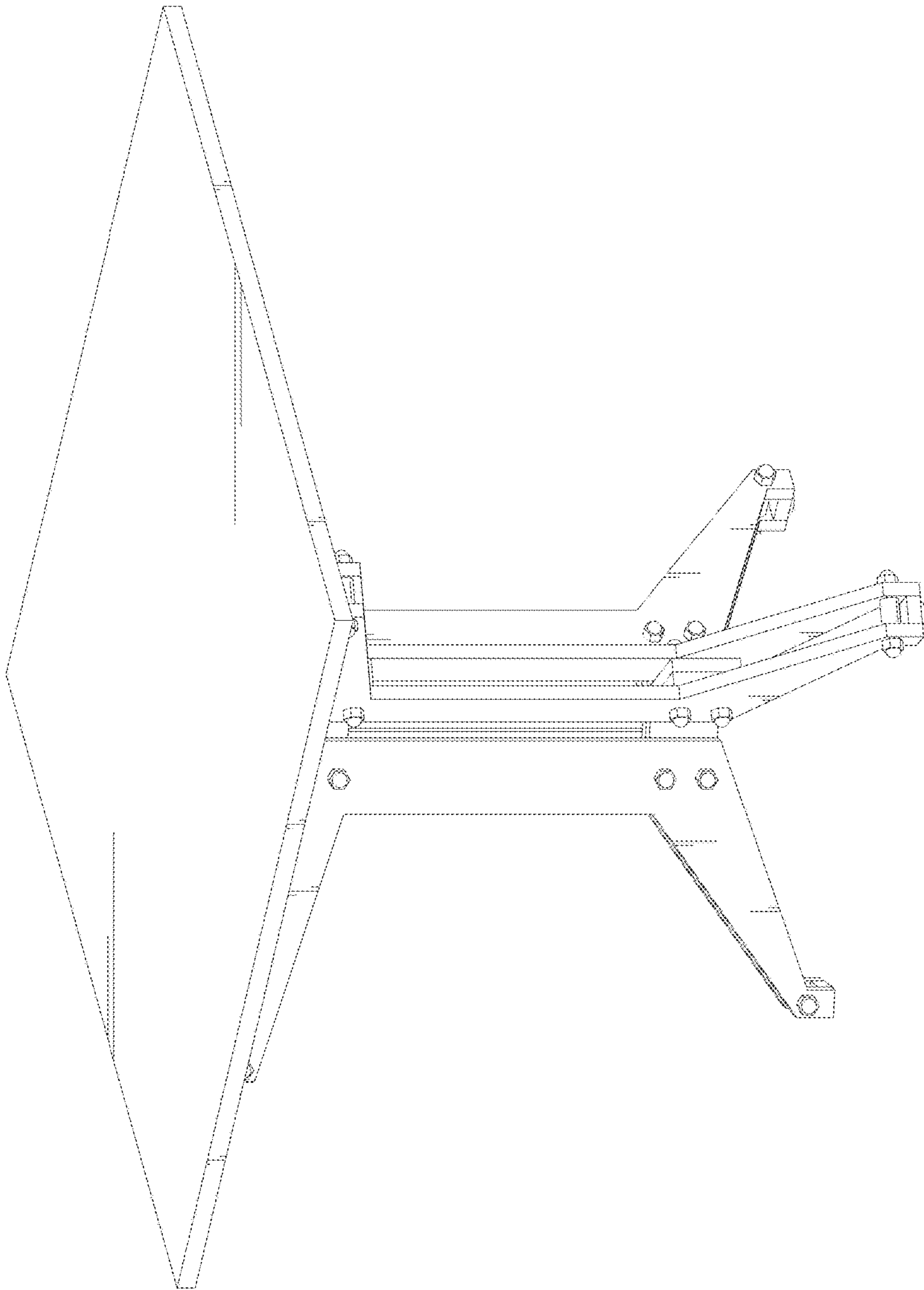

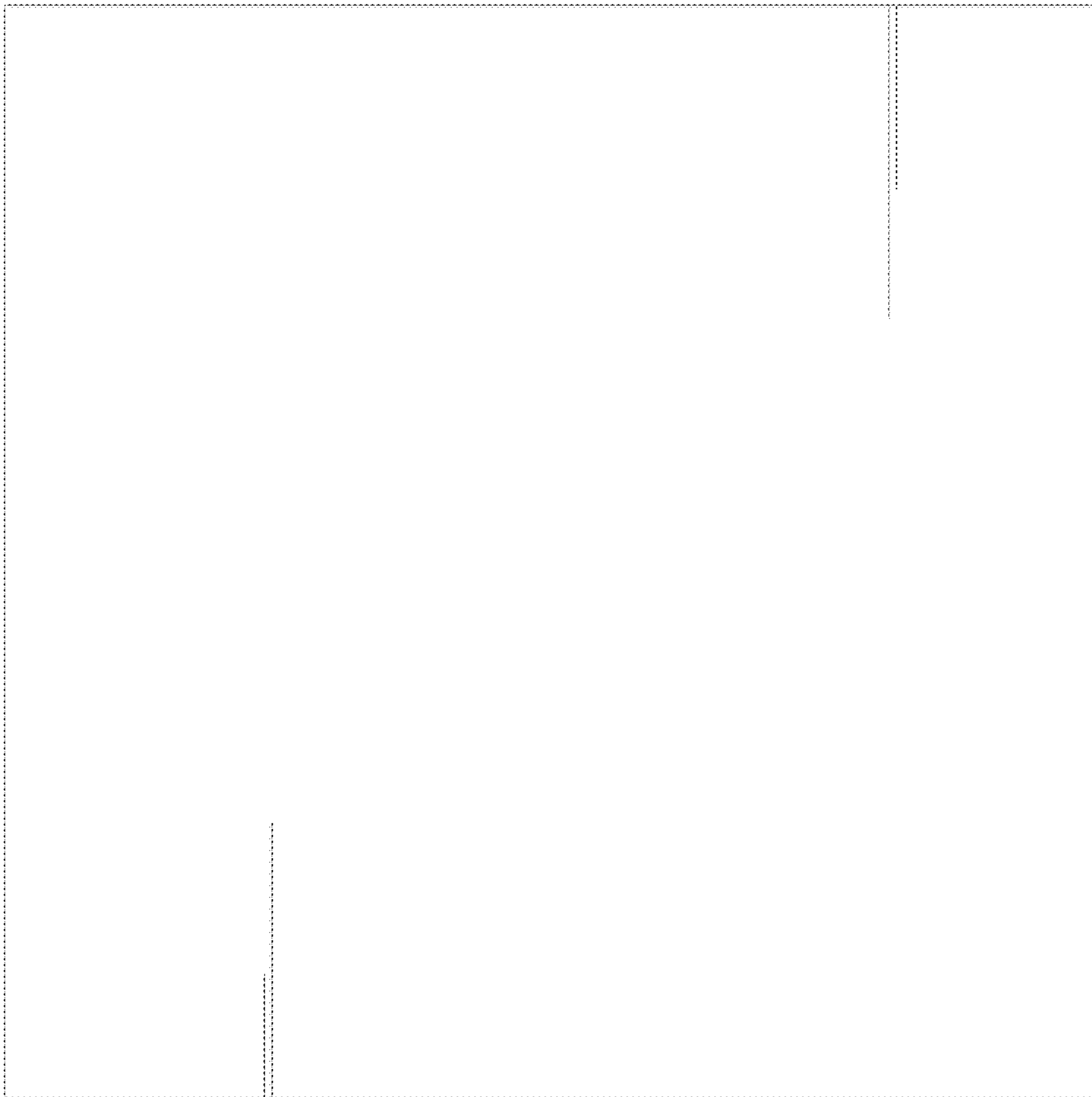

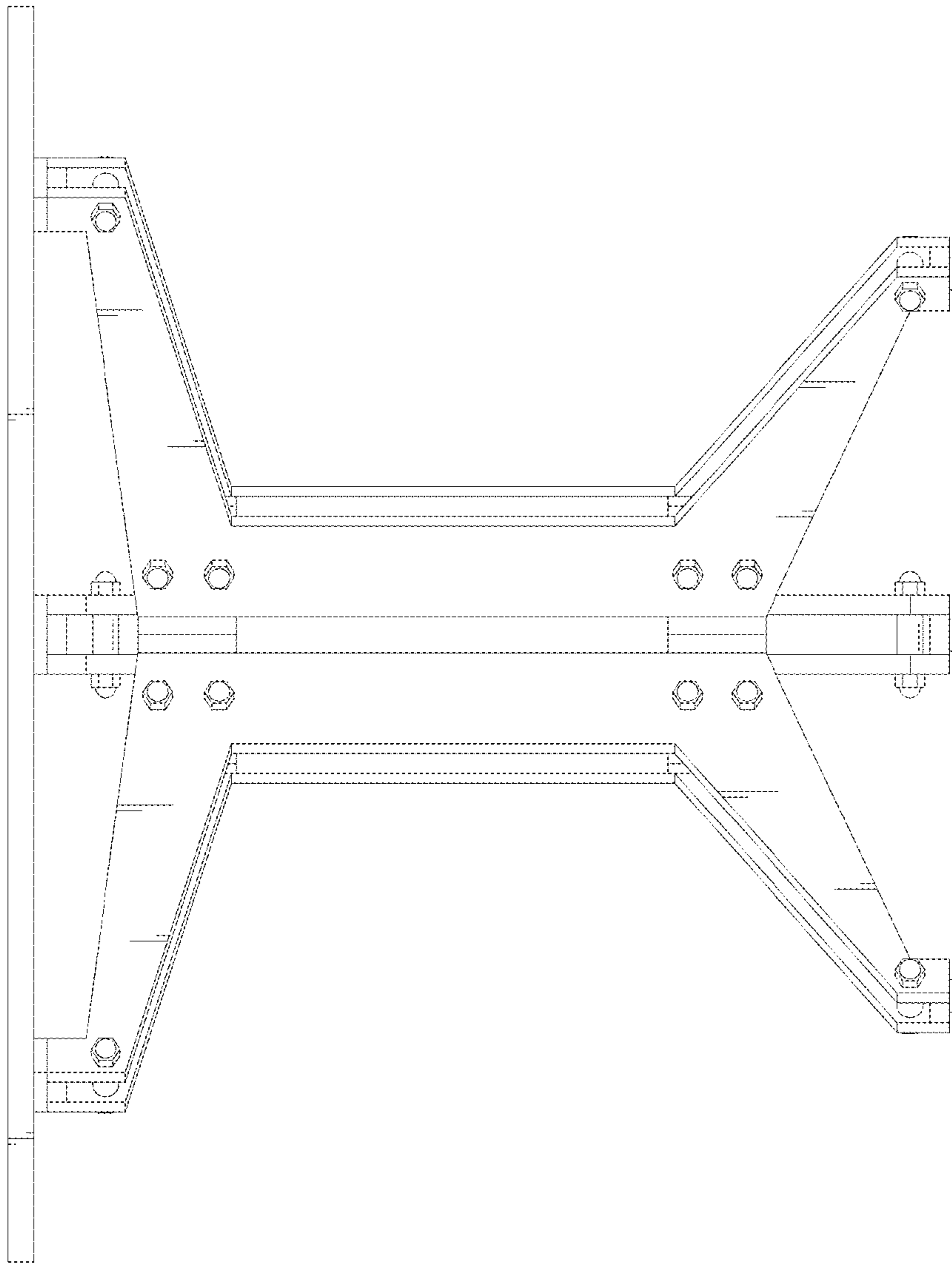

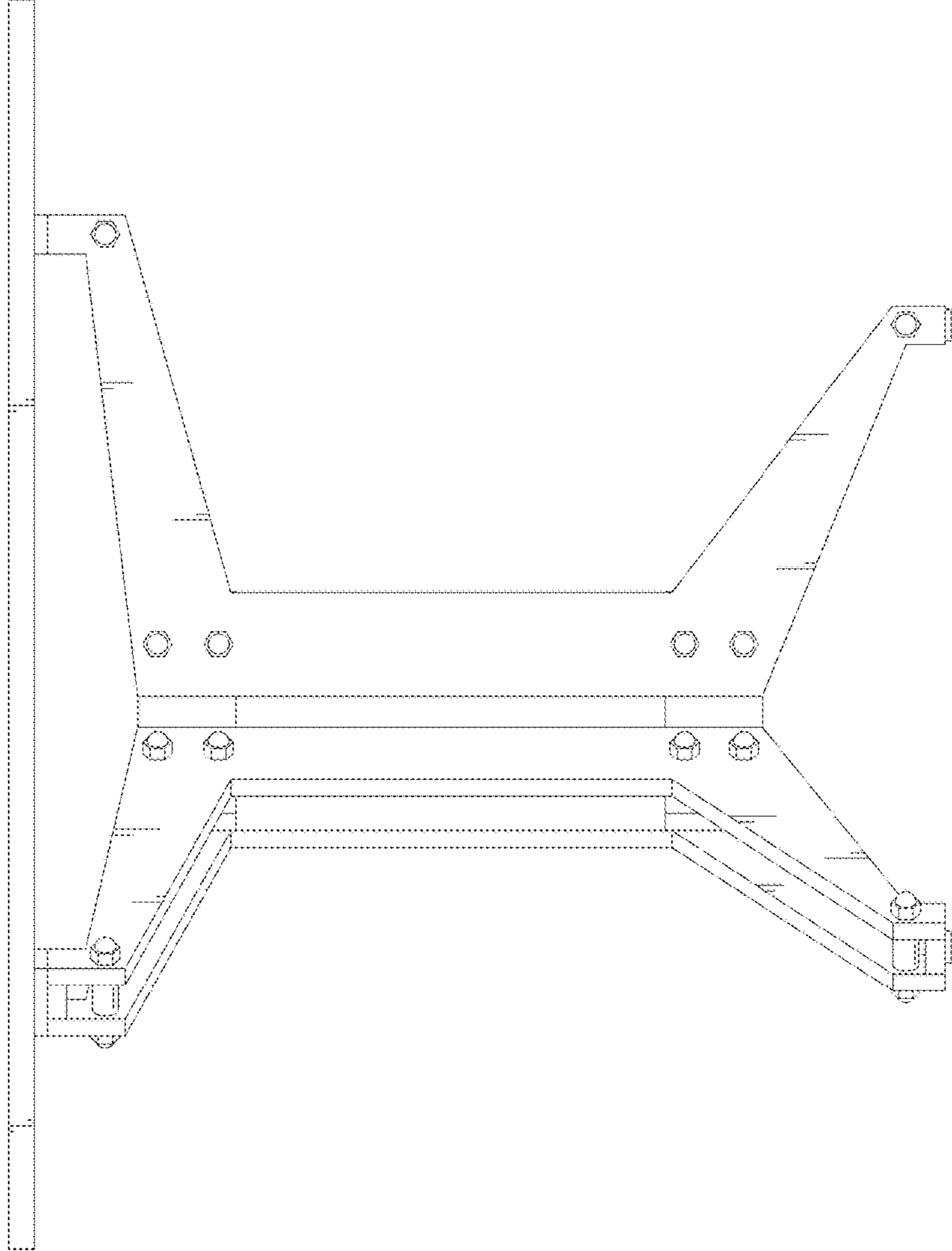

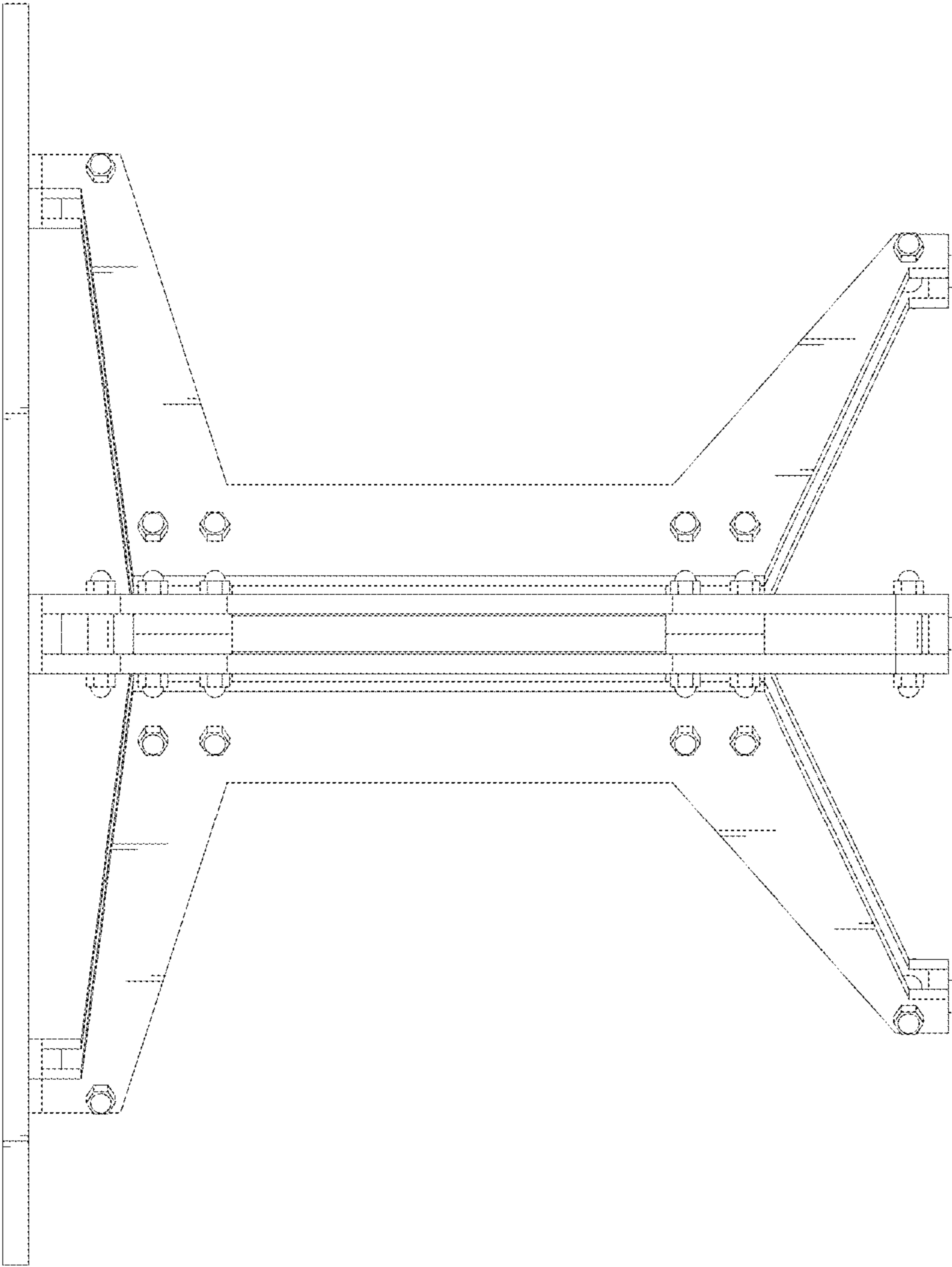

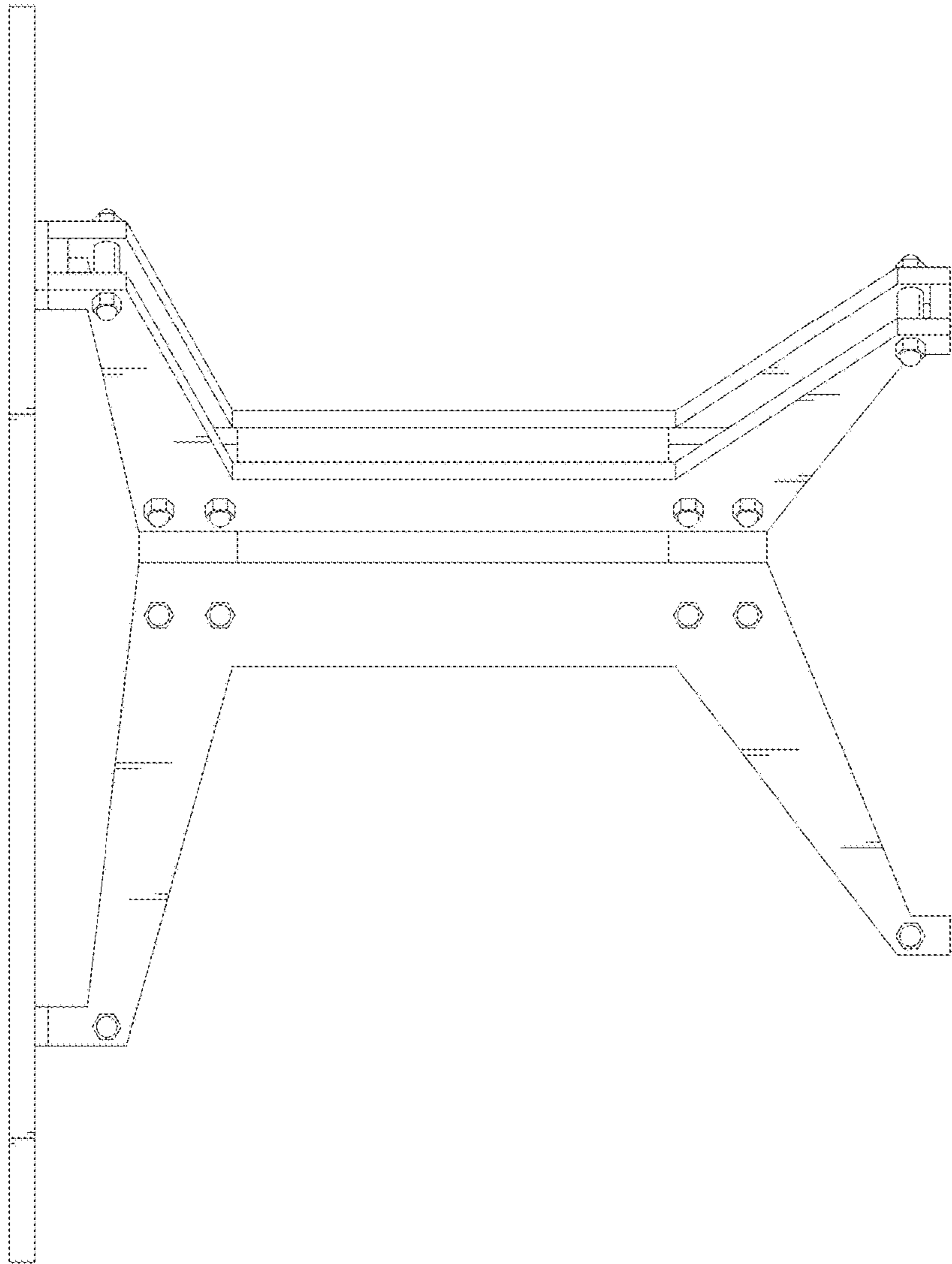

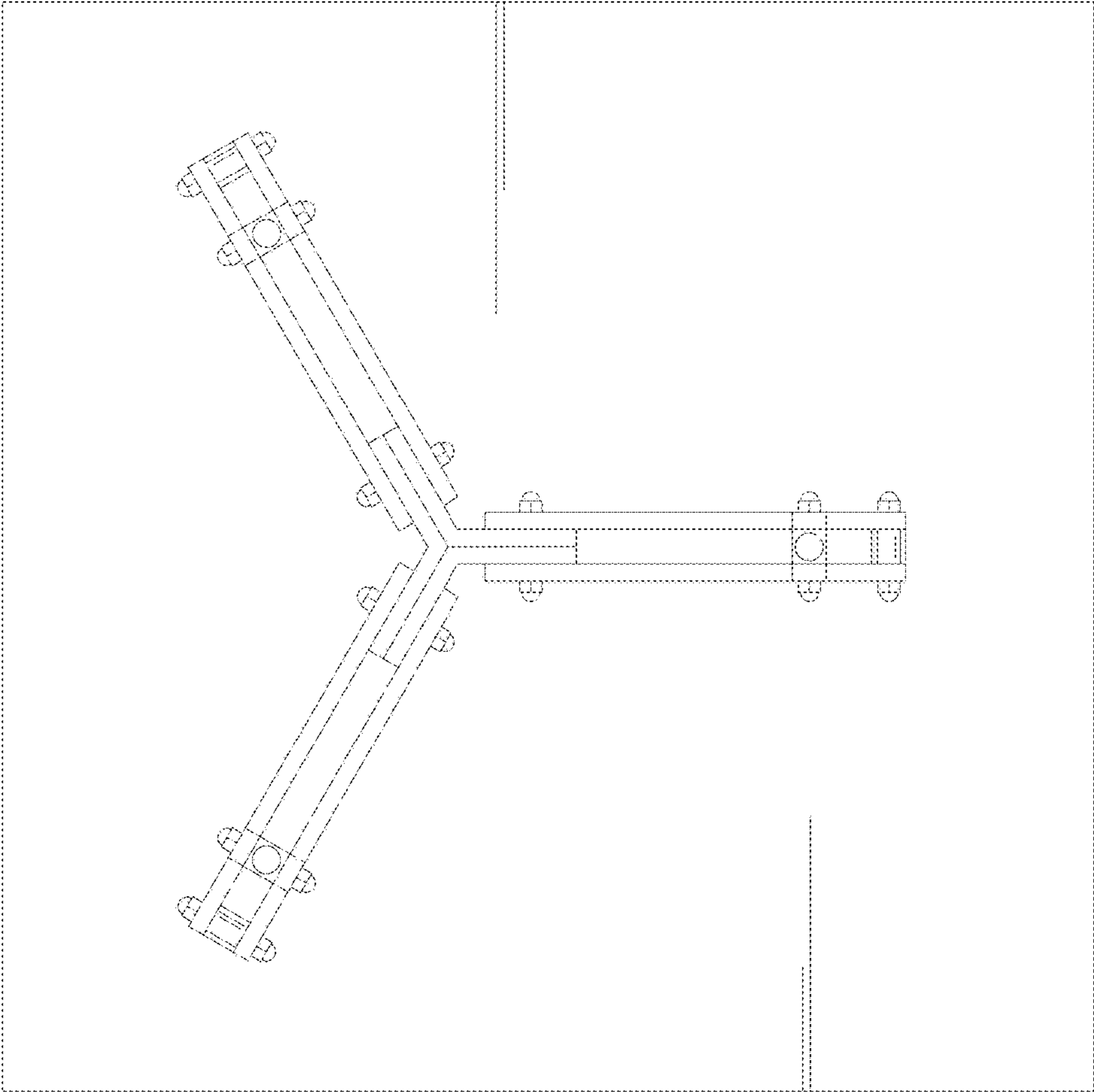
