DESCRIPTION

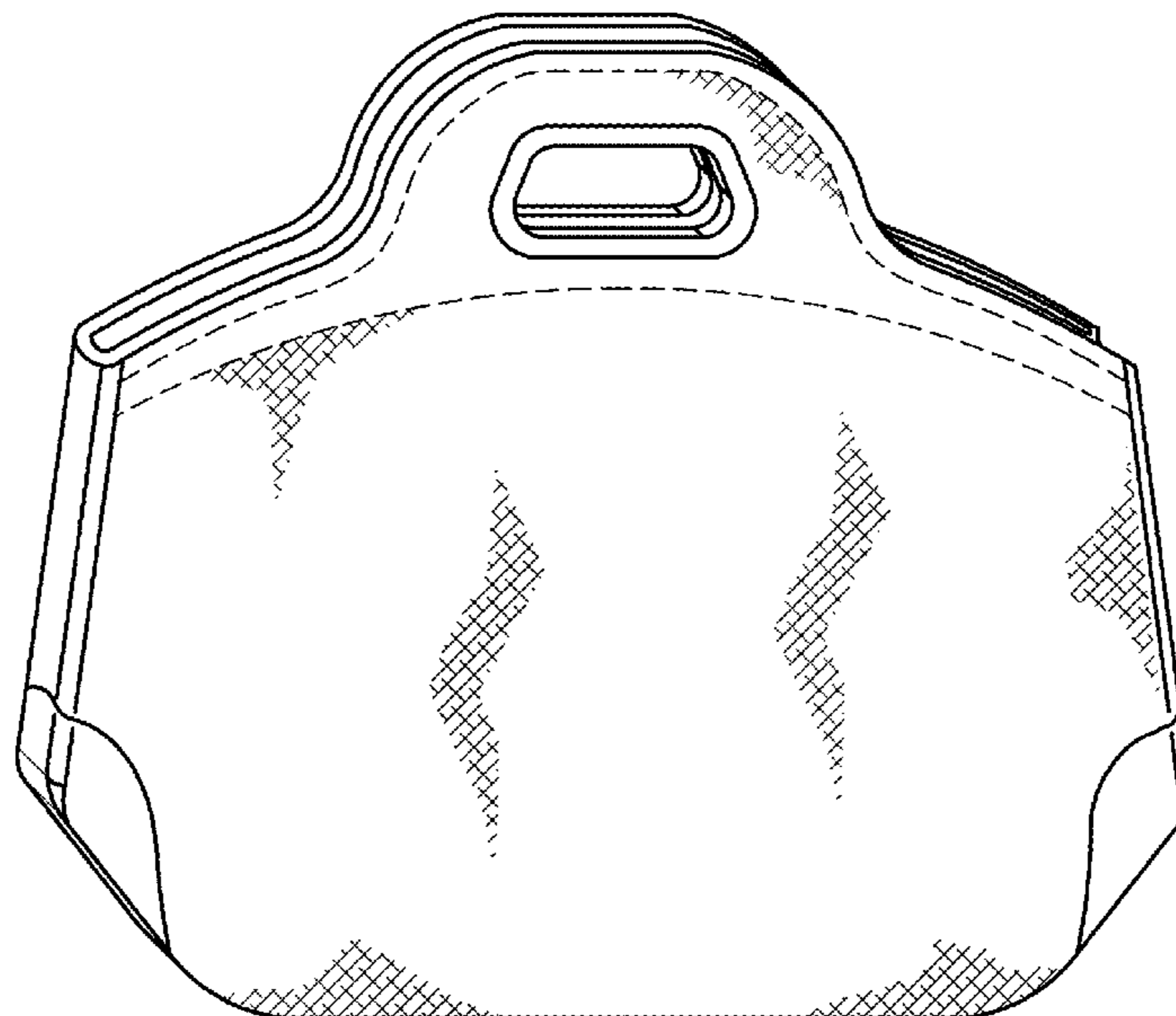
FIG. 1 is a perspective view of the bag of the present invention;

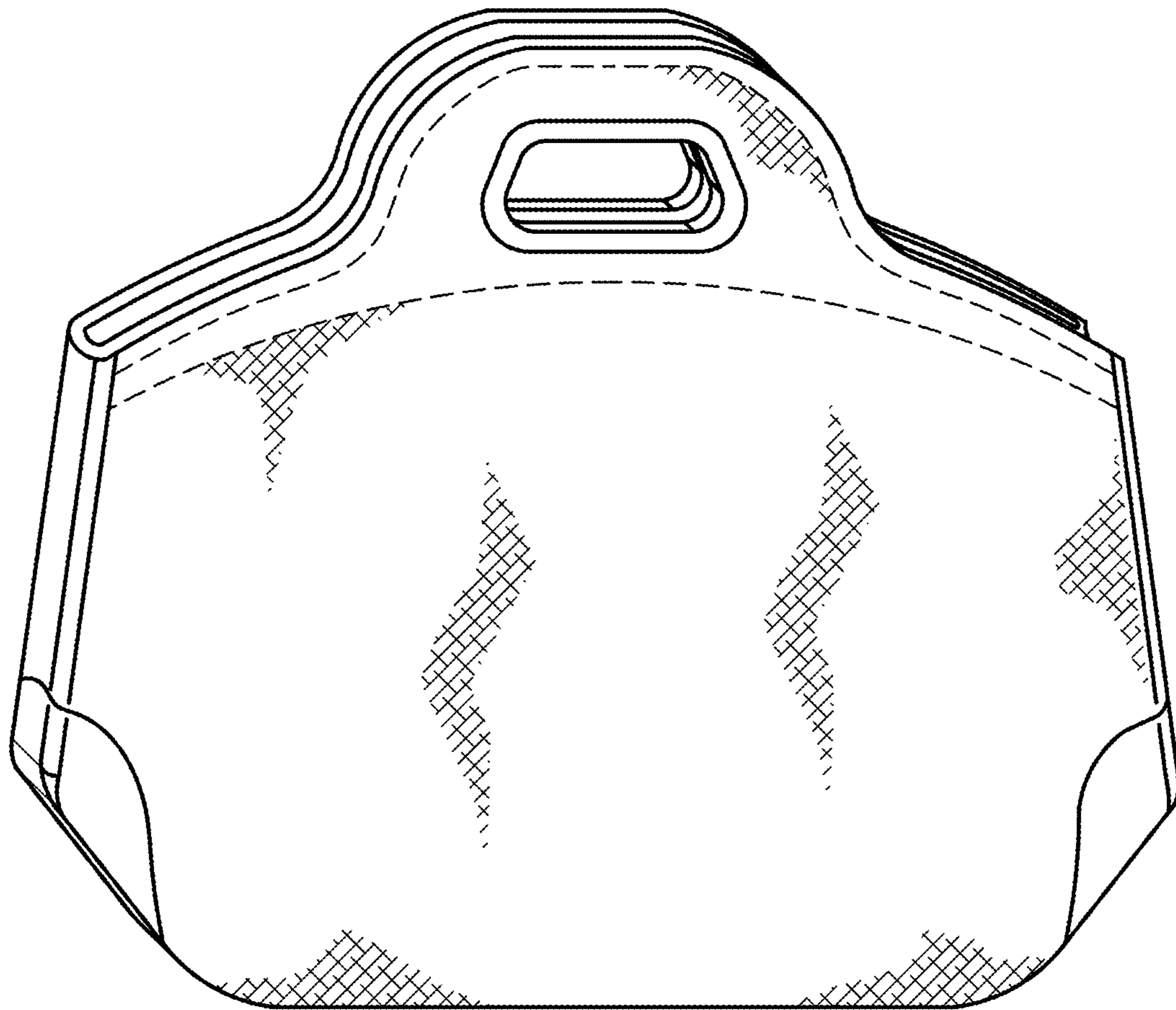

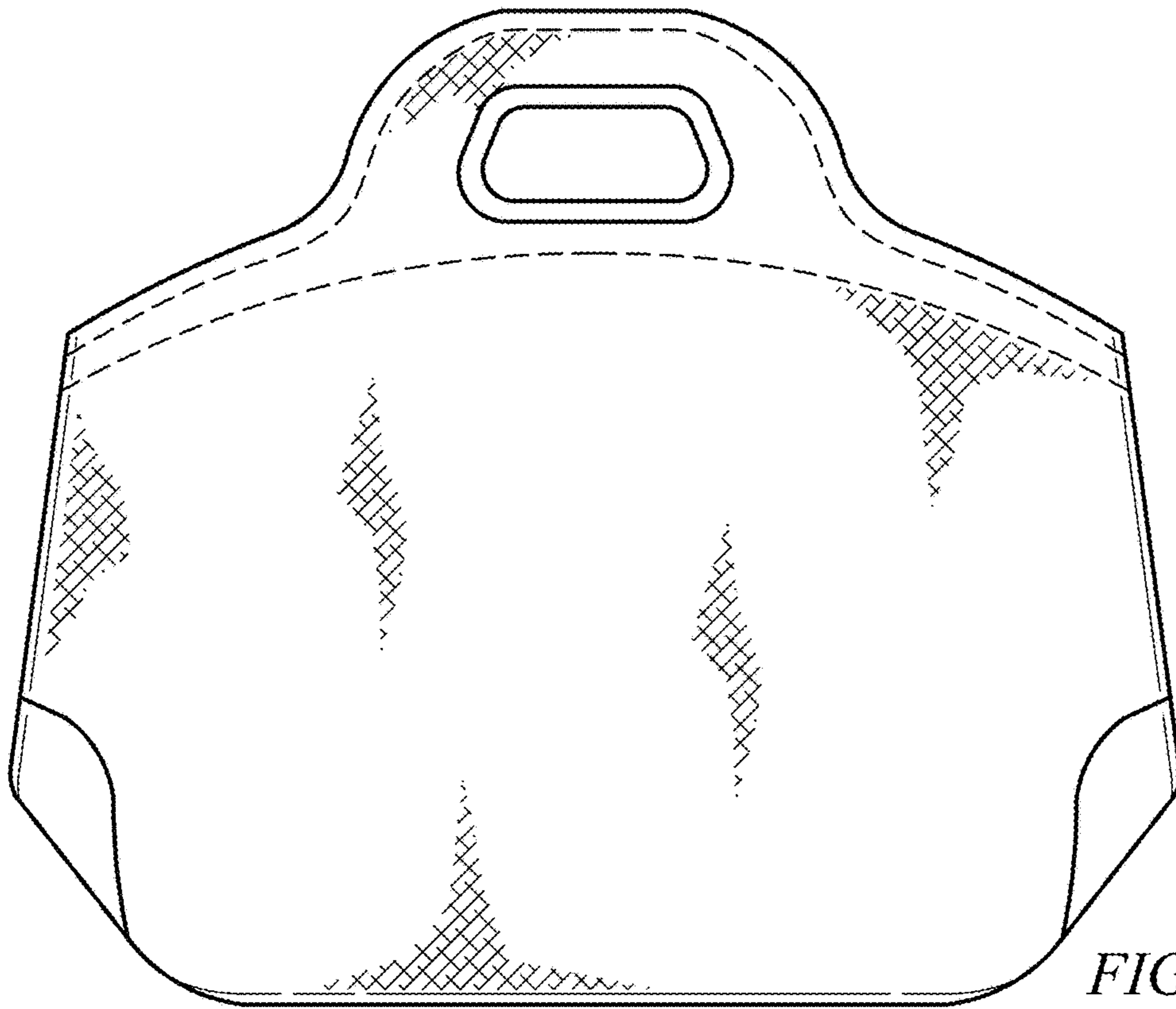

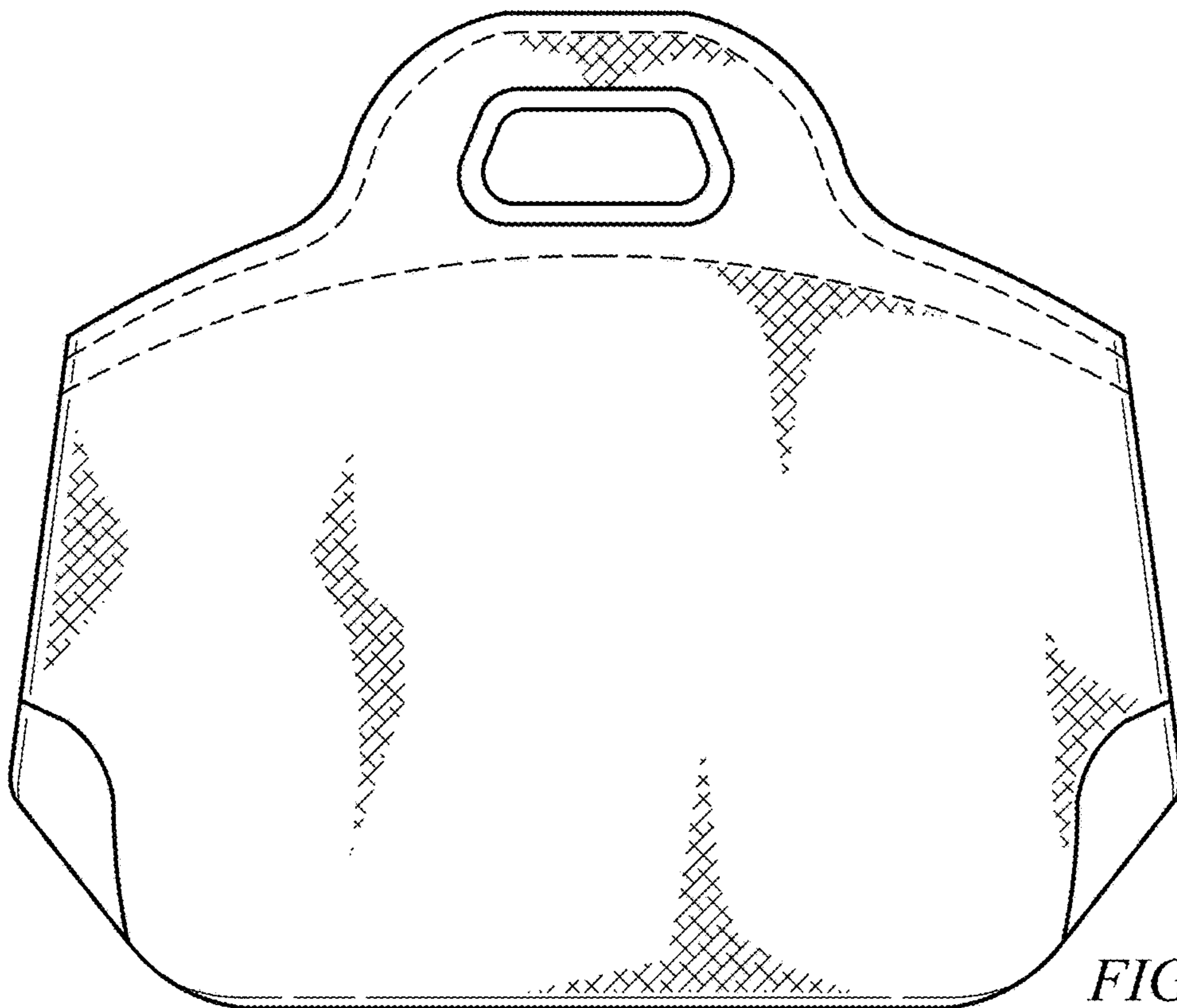

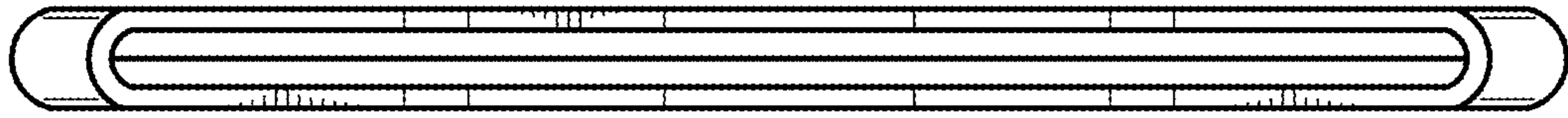

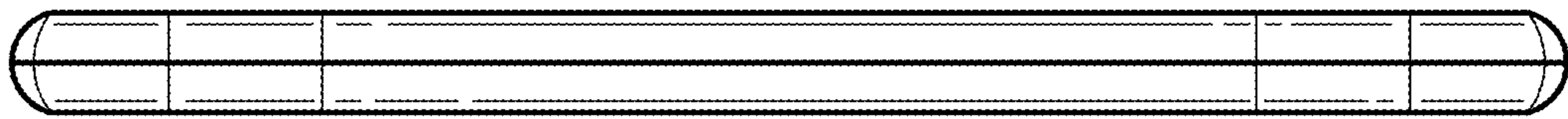

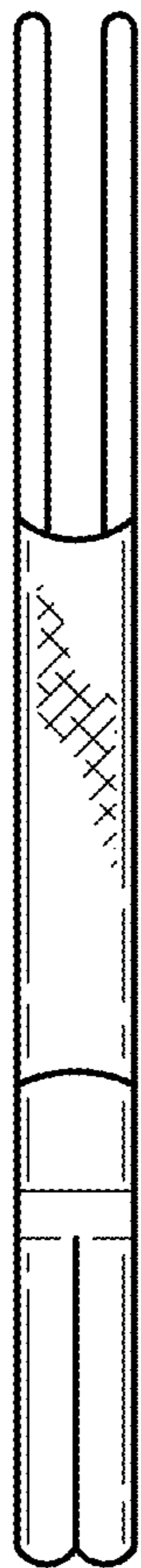

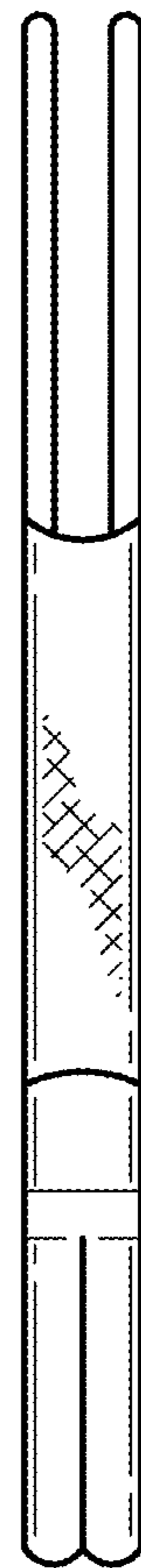
