(57) **CLAIM**

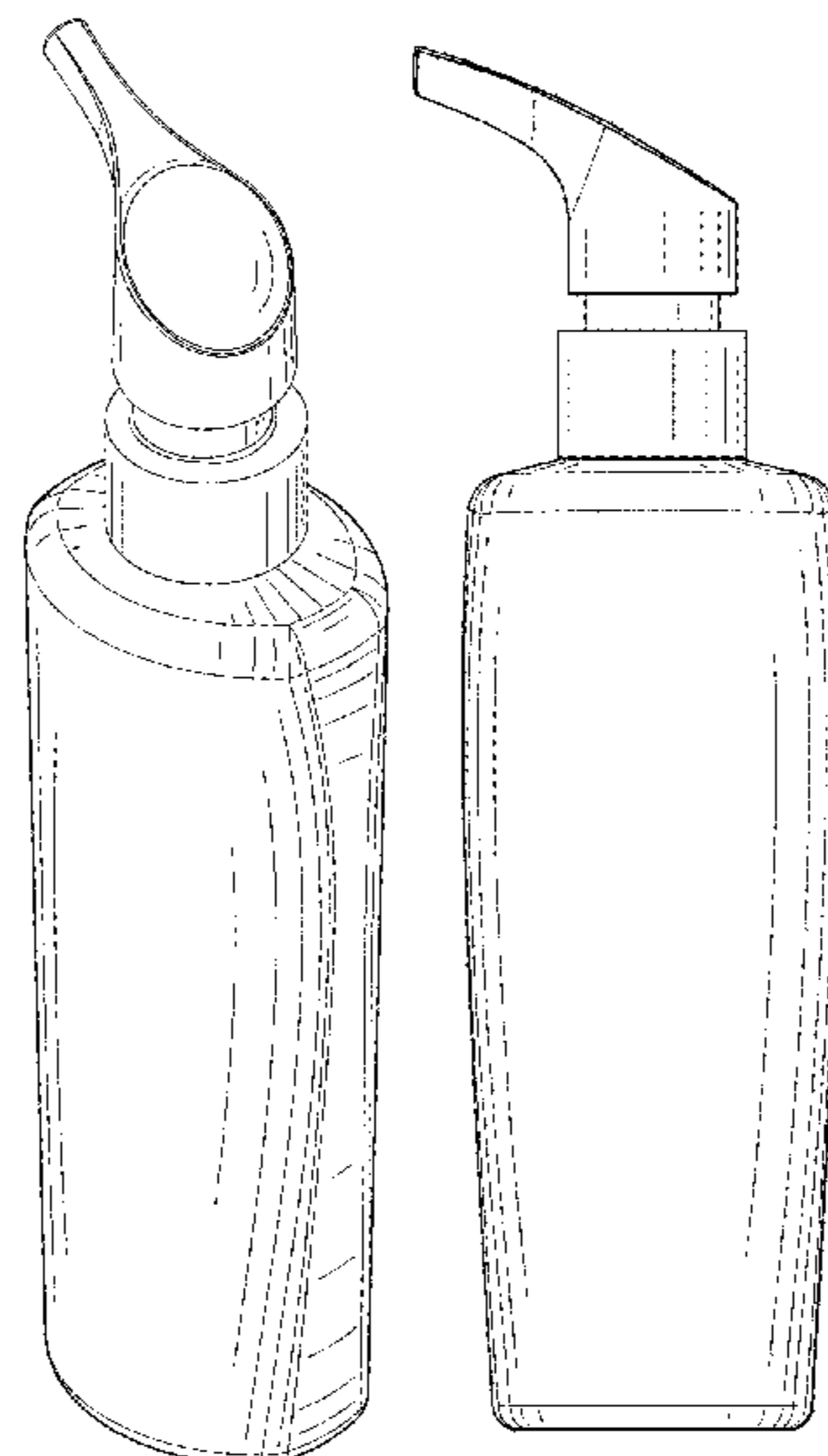
The ornamental design for a container with a pump dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container with a pump dispenser, embodying our new design; FIG. 2 is a first side view thereof; FIG. 3 is a second side view thereof; FIG. 4 is a third side view thereof; FIG. 5 is a fourth side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The dashed lines shown in FIG. 7 represent the central region of the bottom end that forms no part of the claimed design.

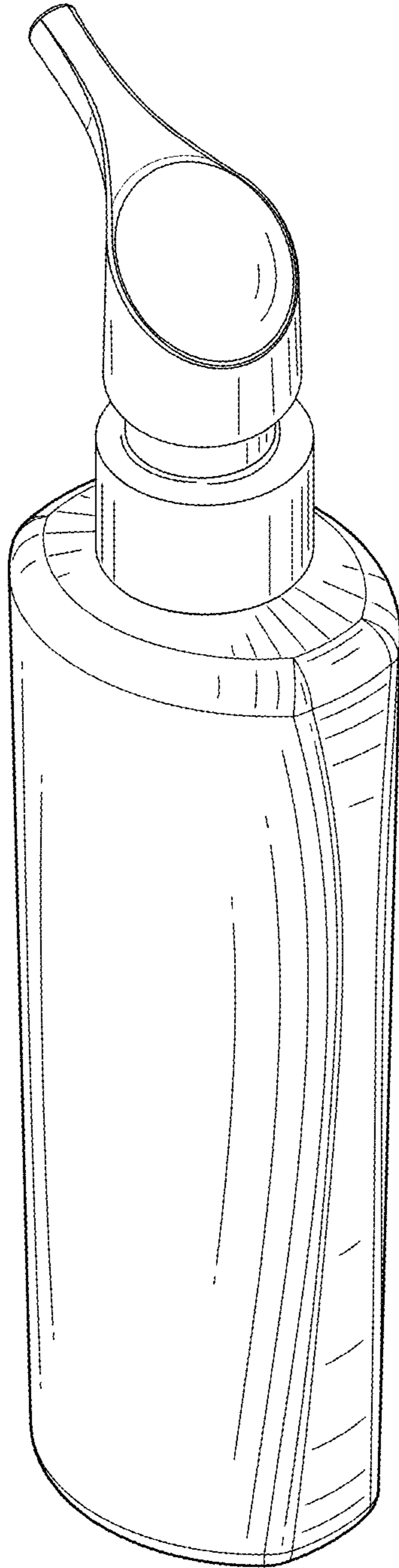

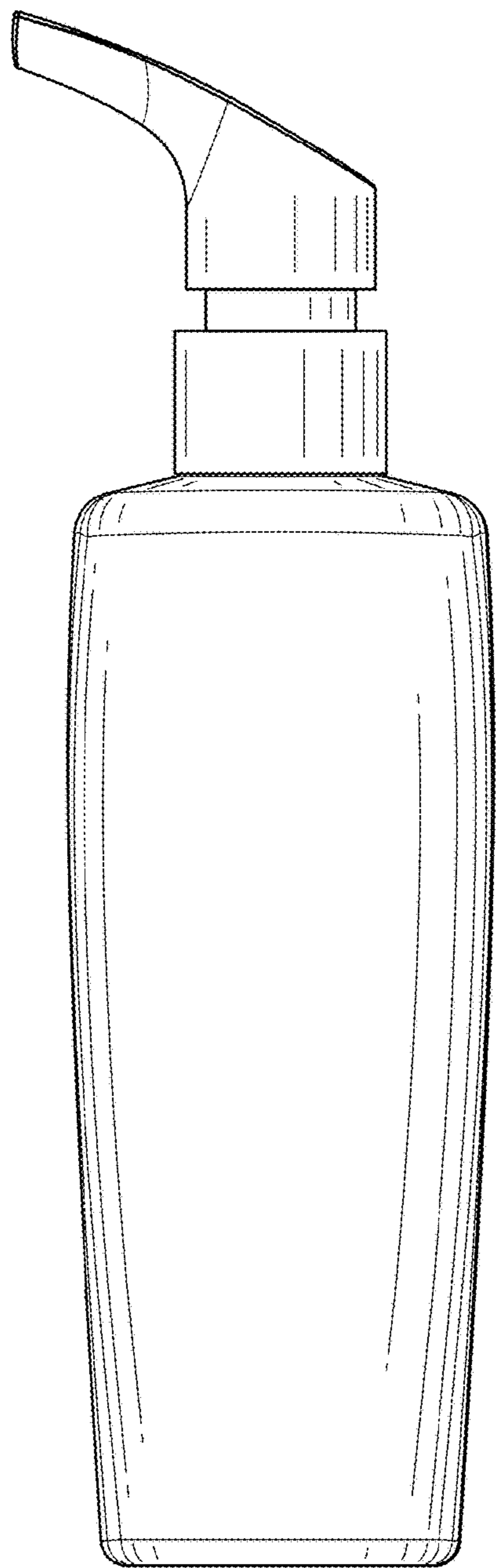

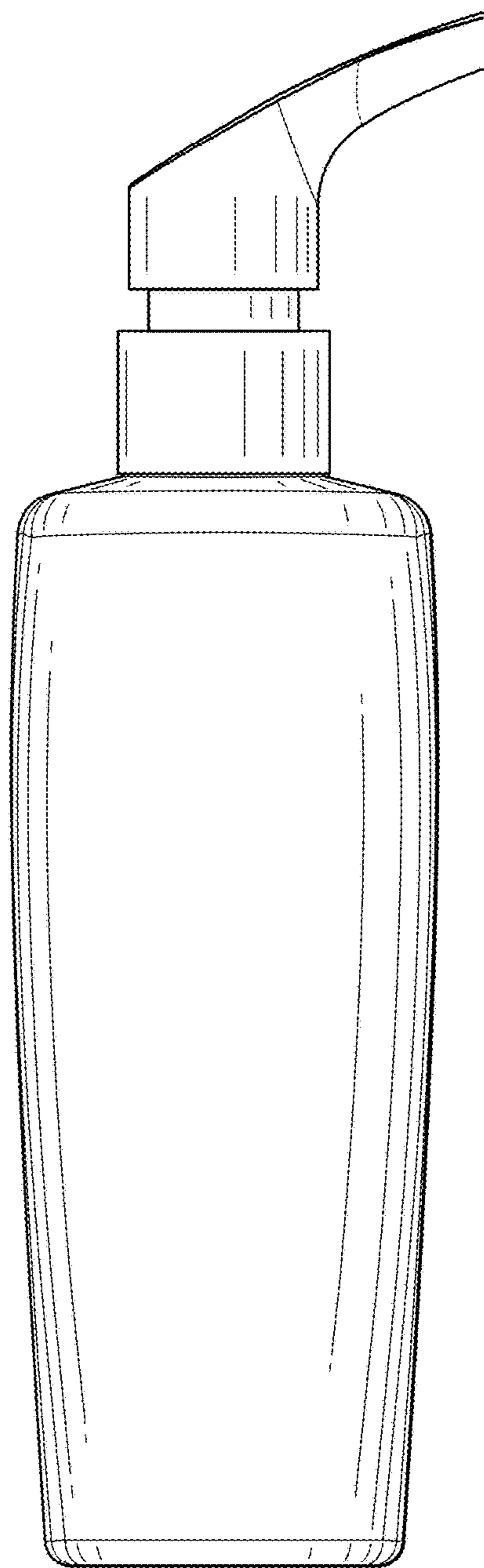

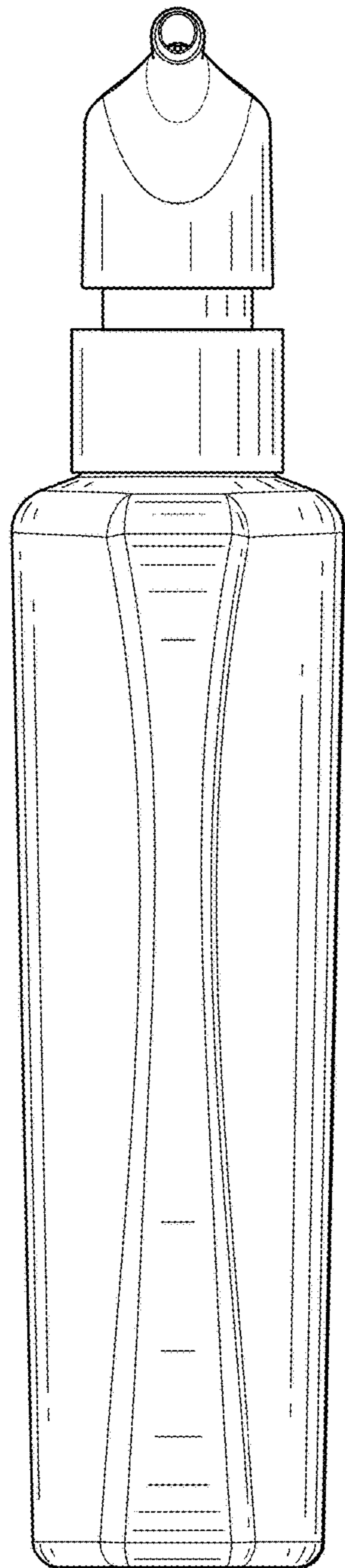

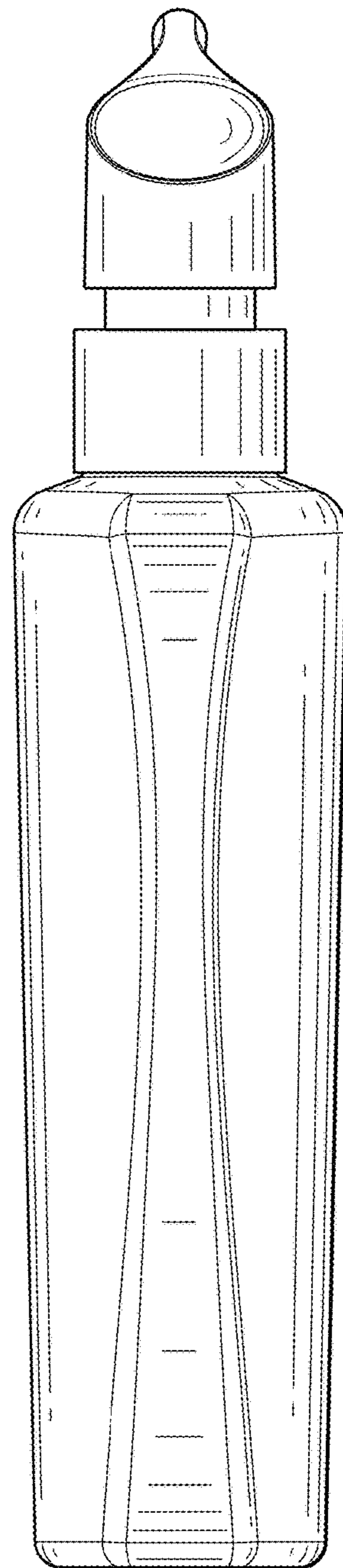

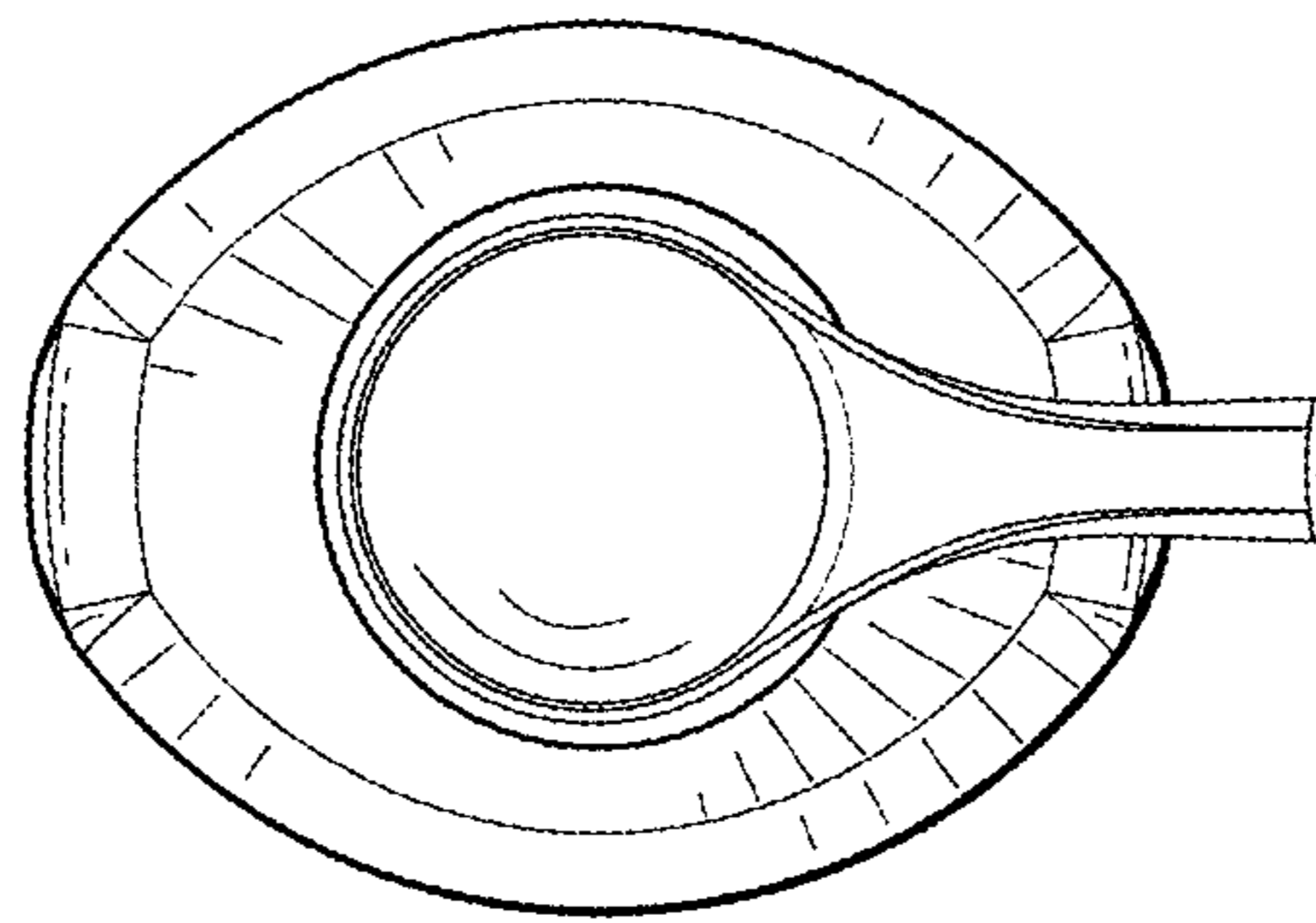

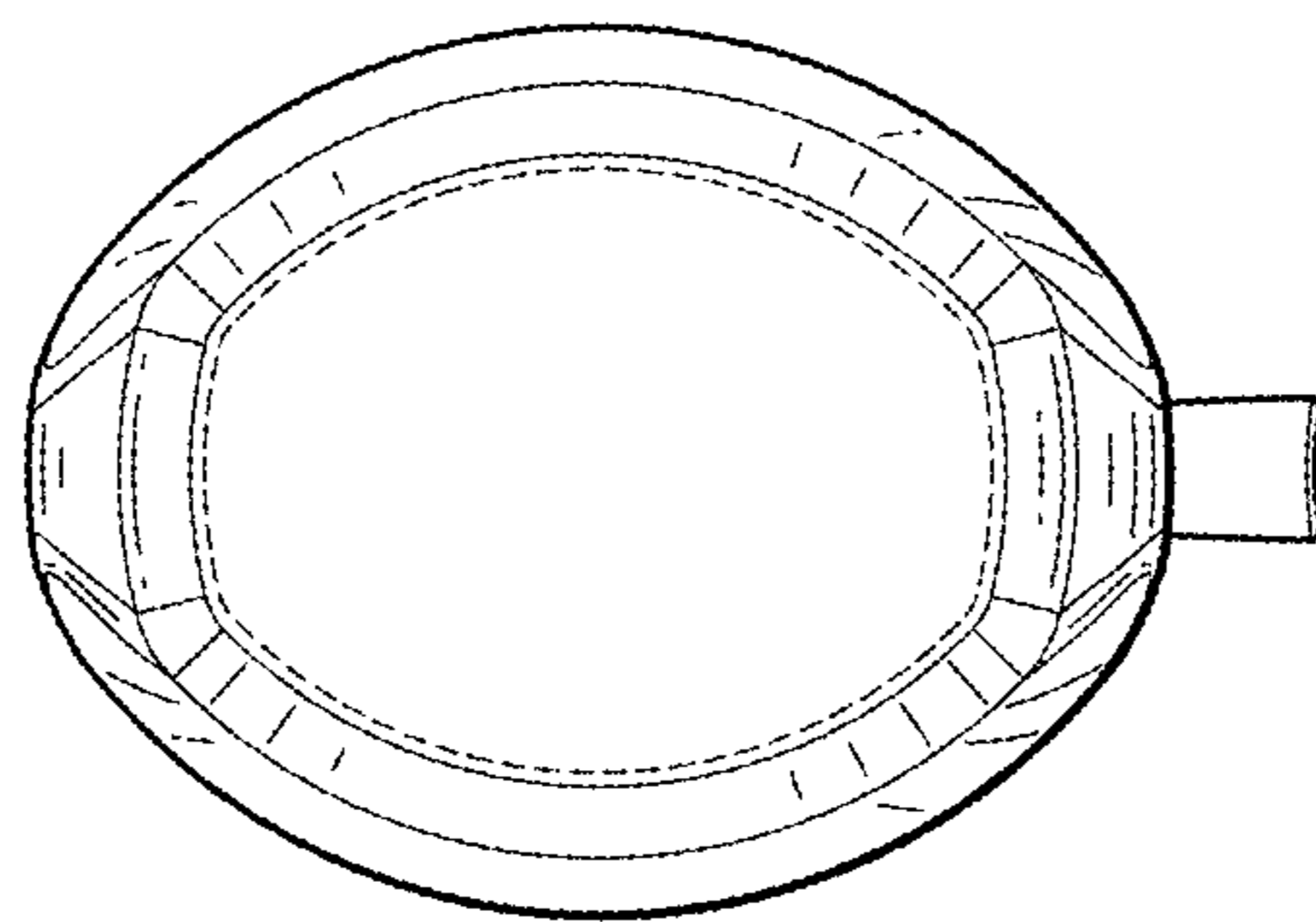
