**DESCRIPTION**

FIG. 3 is a side view of the vehicle side rail protector bar.

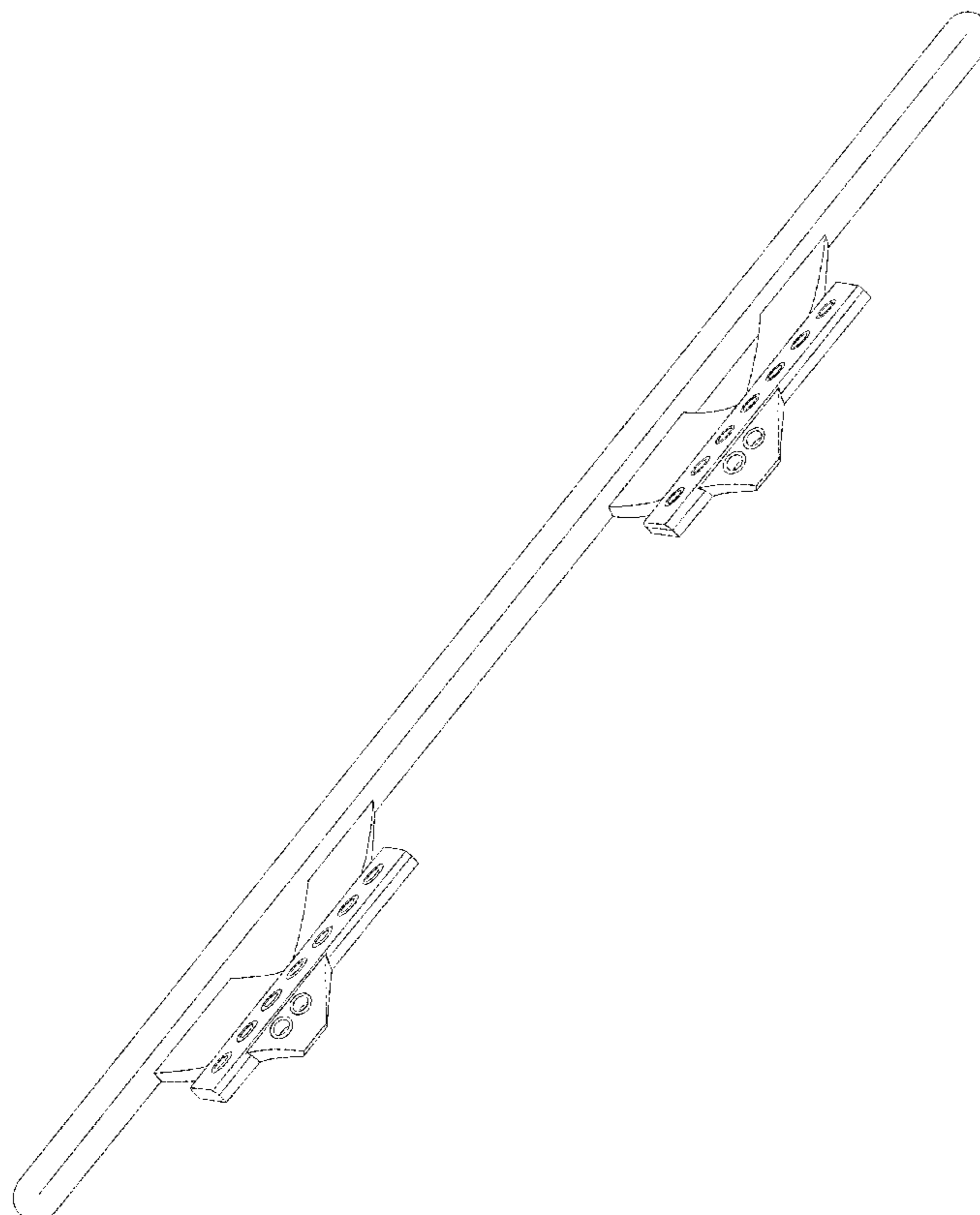

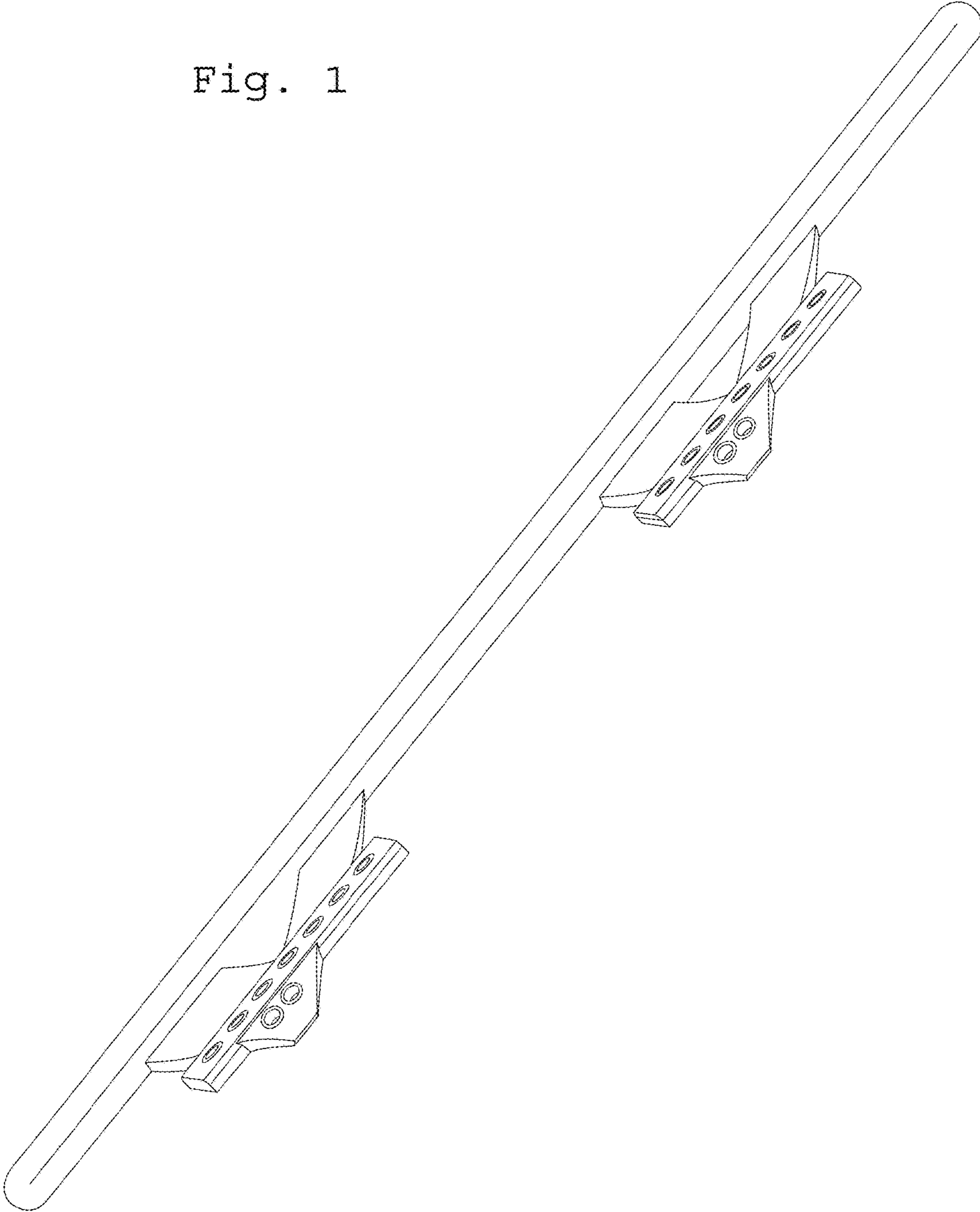

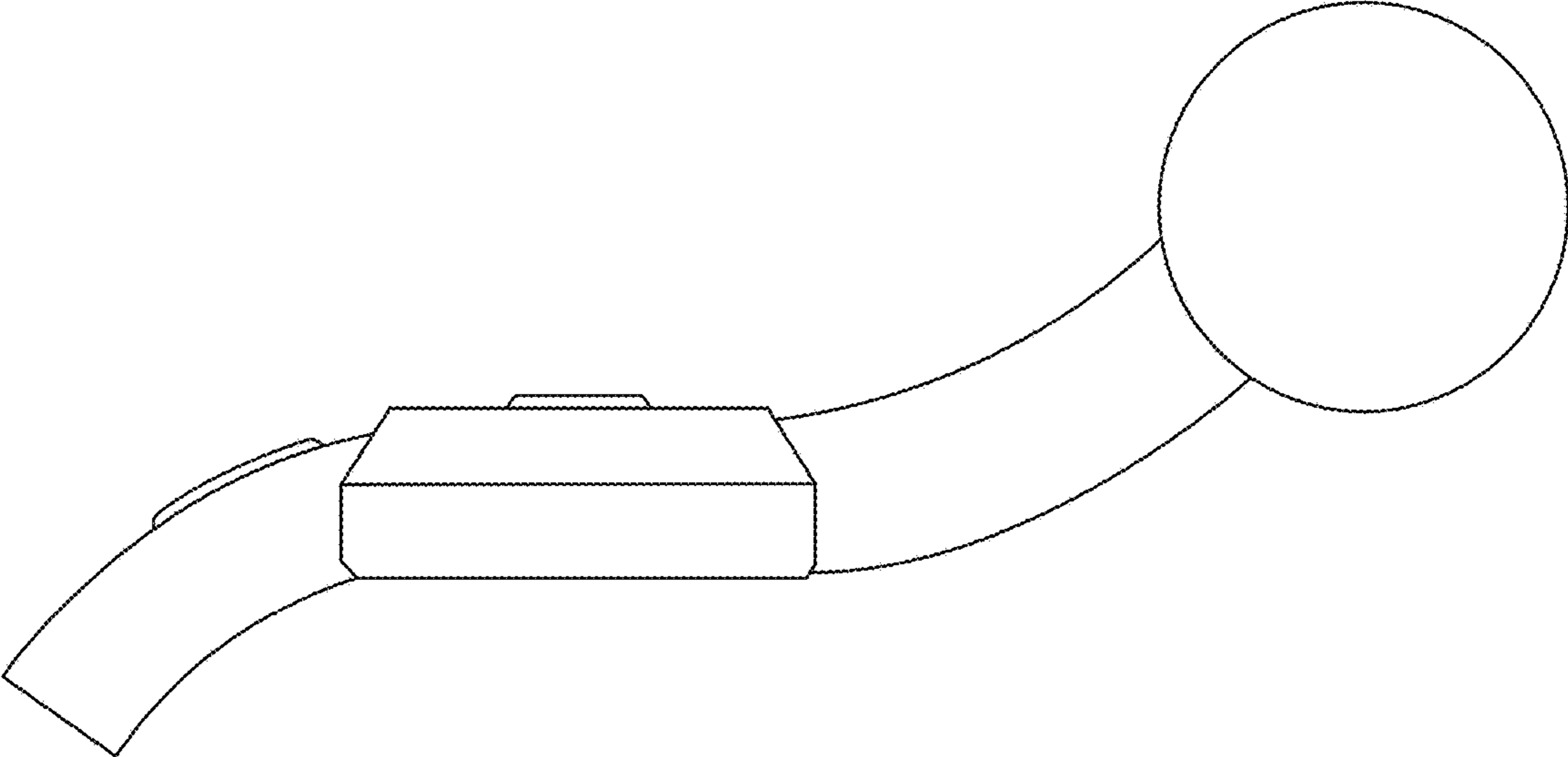

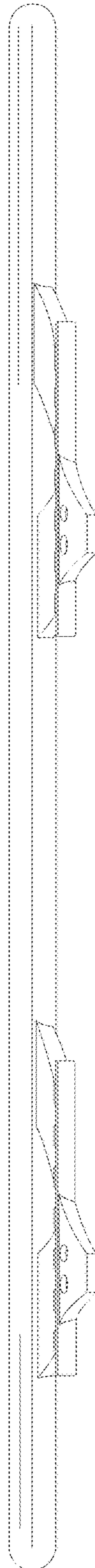

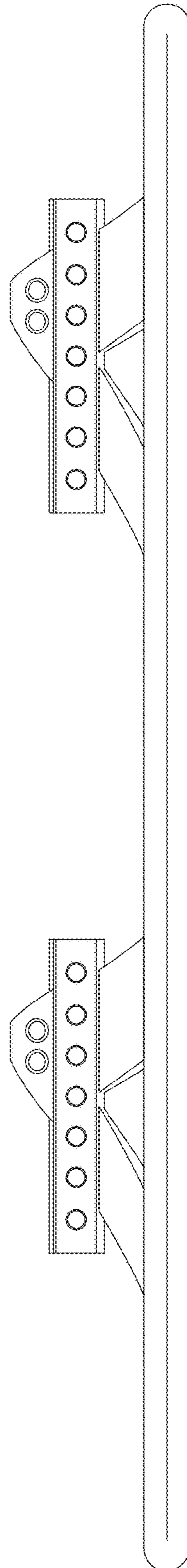
