The ornamental design for a wheel, as shown and described.

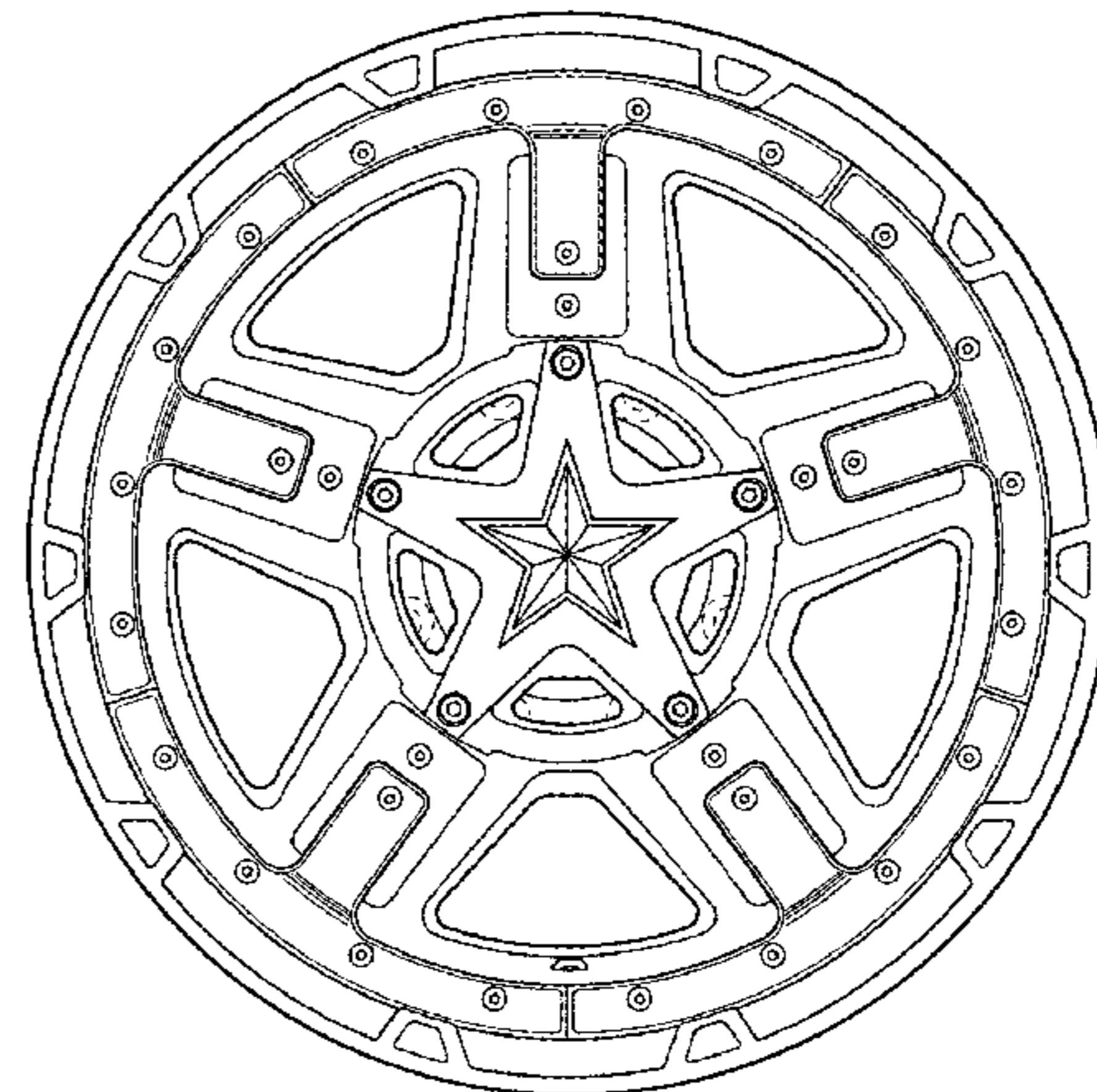
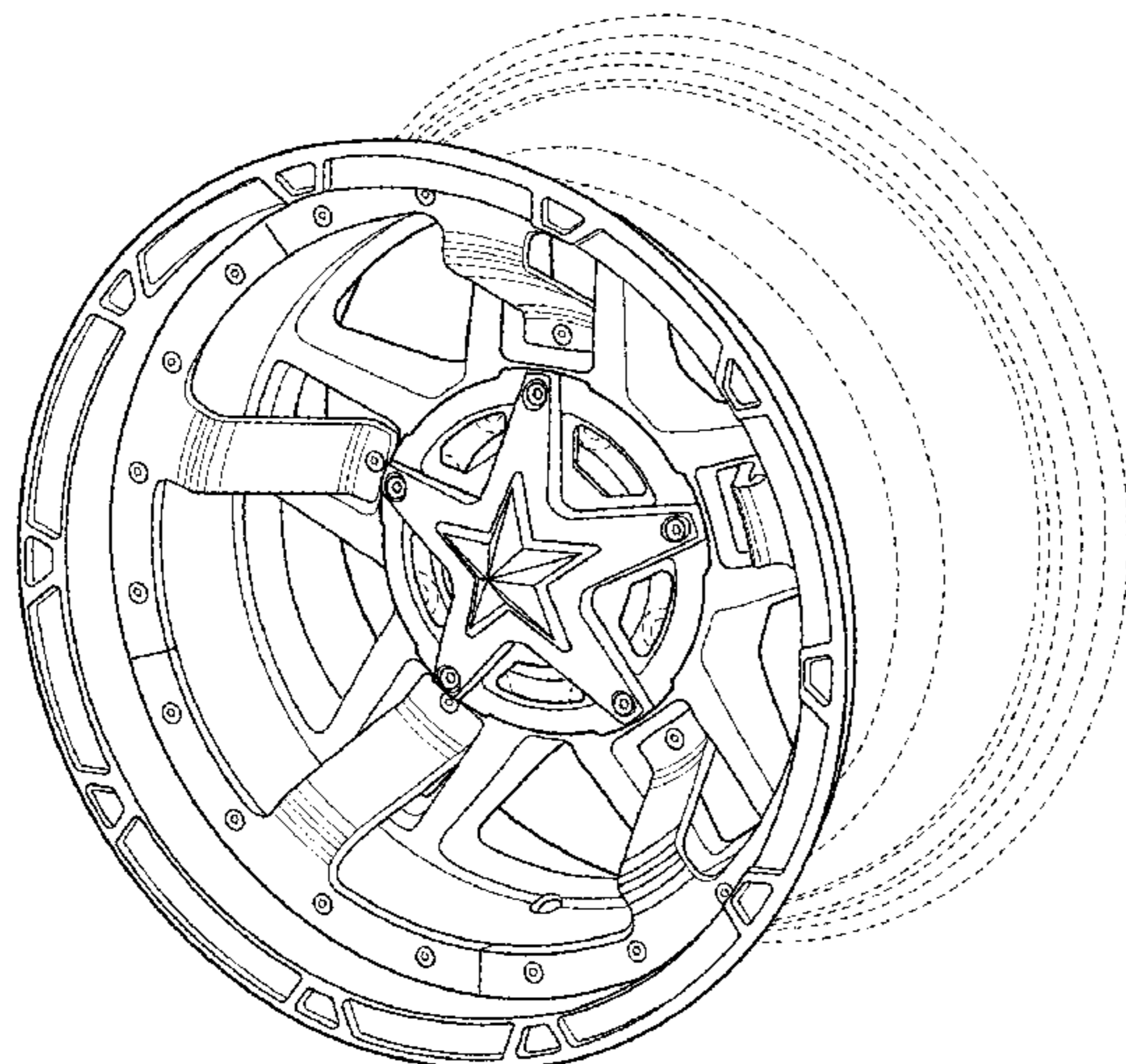
**DESCRIPTION**

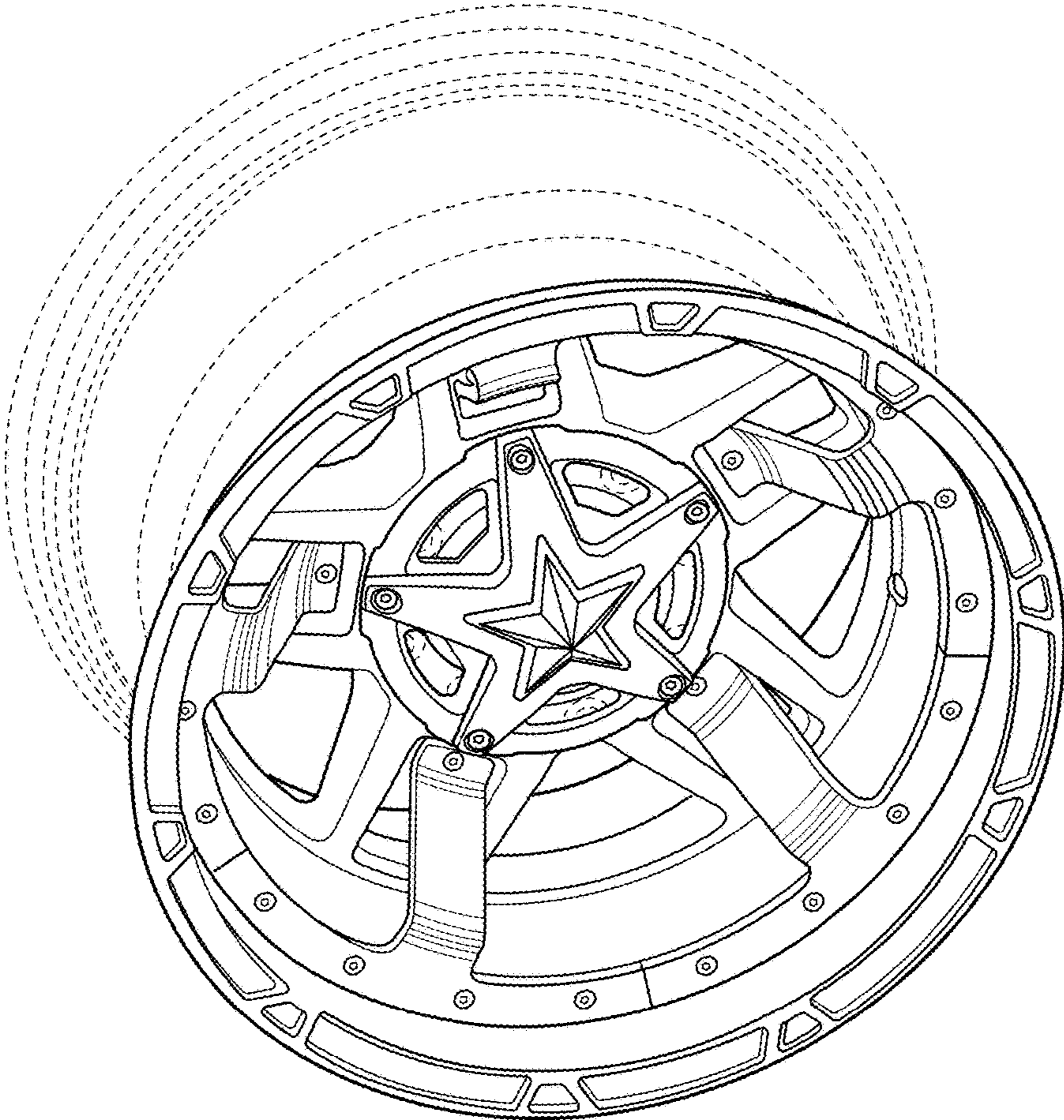

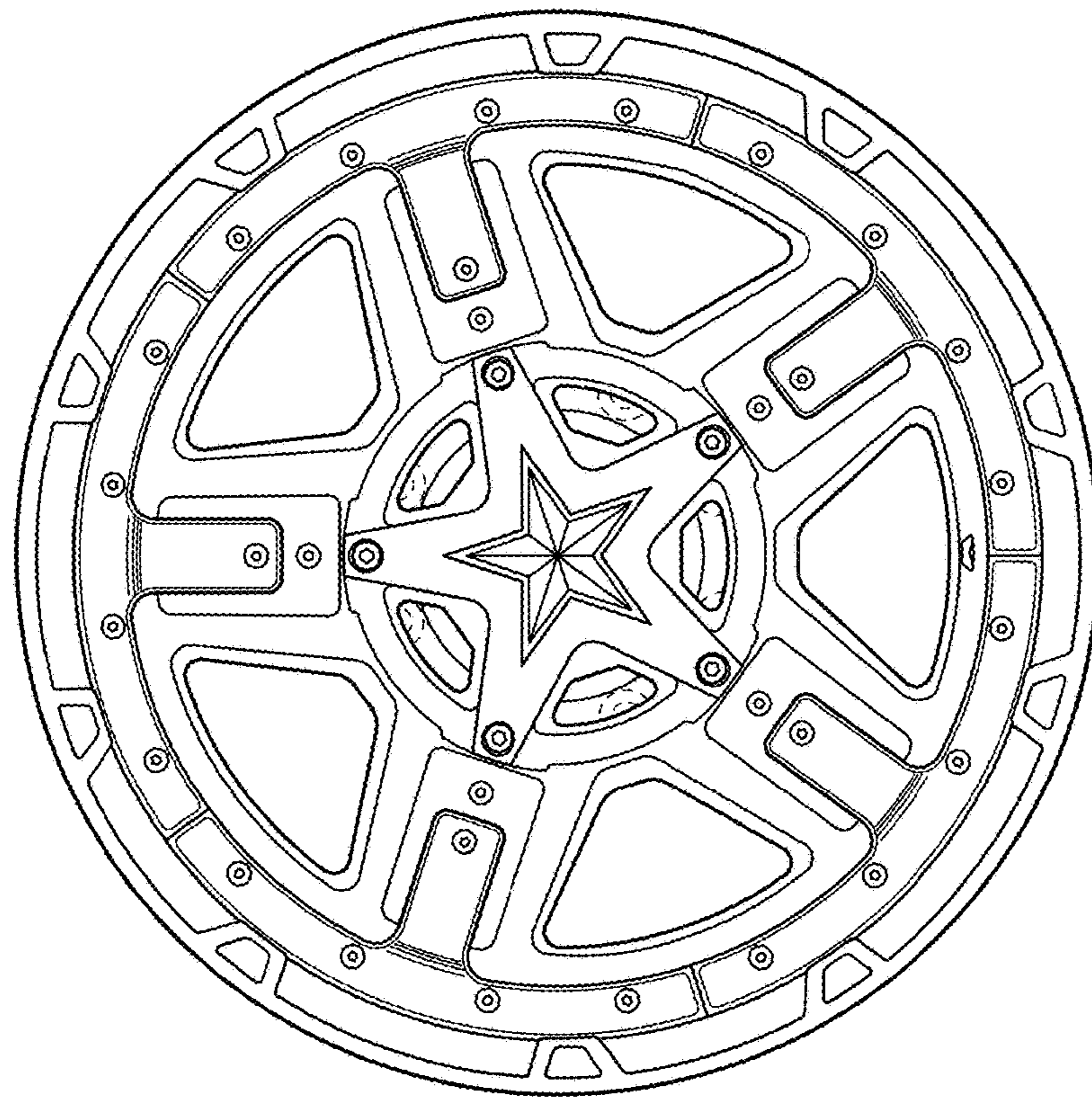
