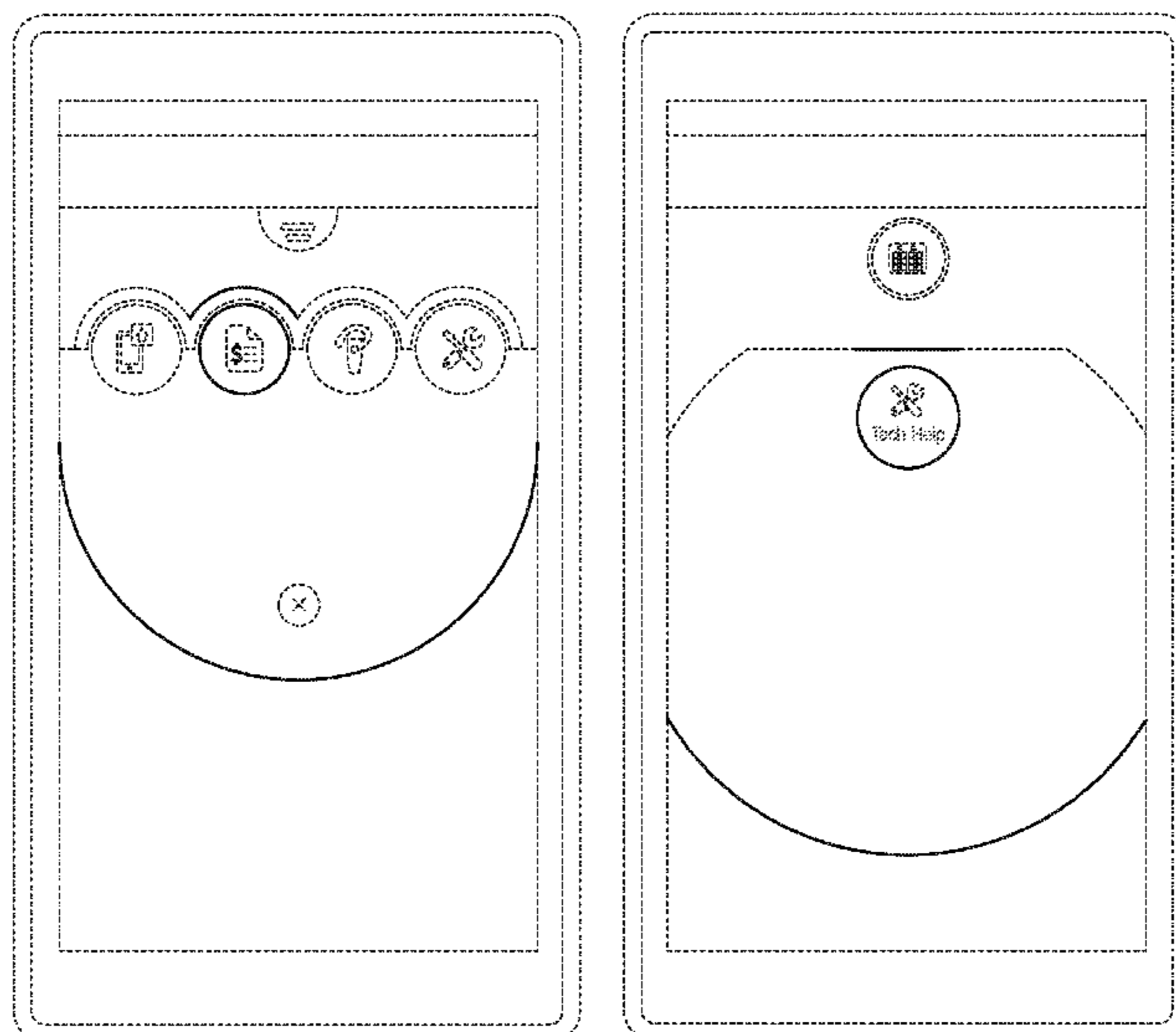
(57) **CLAIM**

The ornamental design for a display panel or screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display panel or screen with graphical user interface showing my new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; FIG. 5 is a front view of a fifth embodiment thereof; and, FIG. 6 is a front view of a sixth embodiment thereof. The broken line showing of an electronic device is for the purpose of illustrating environmental structure. The remaining broken lines illustrate the display panel or screen, and portions of the graphical user interface. None of the broken lines form part of the claimed design.

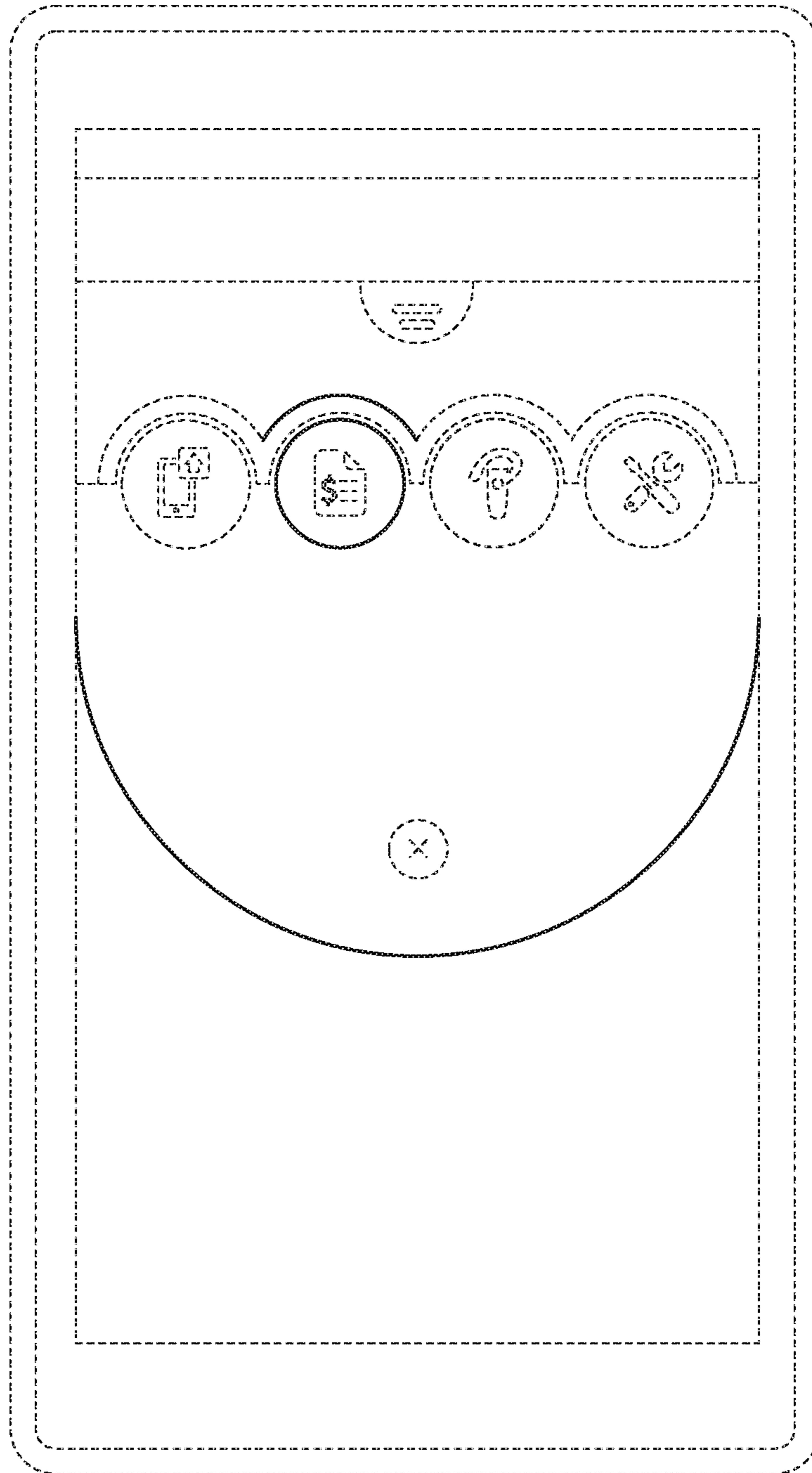

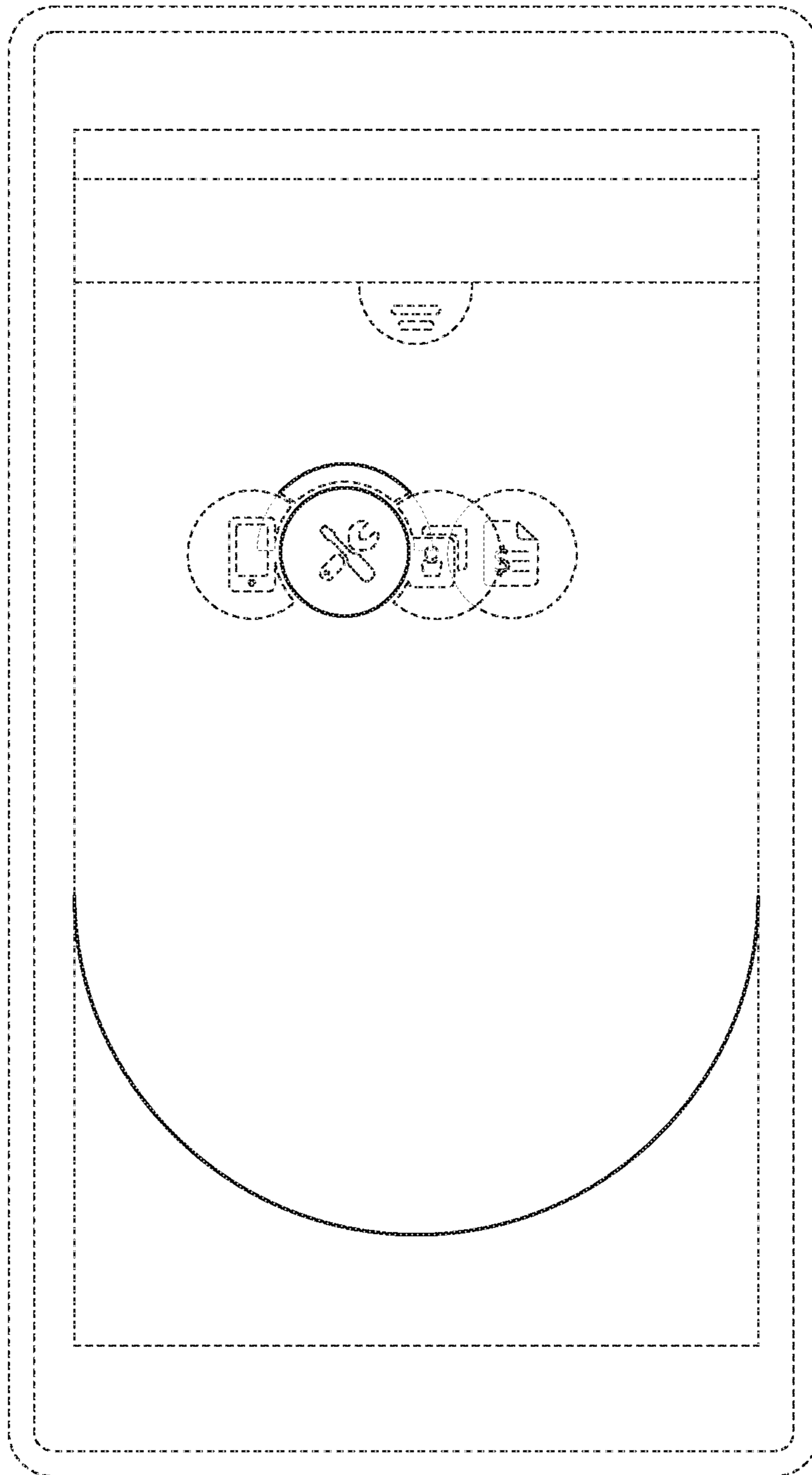

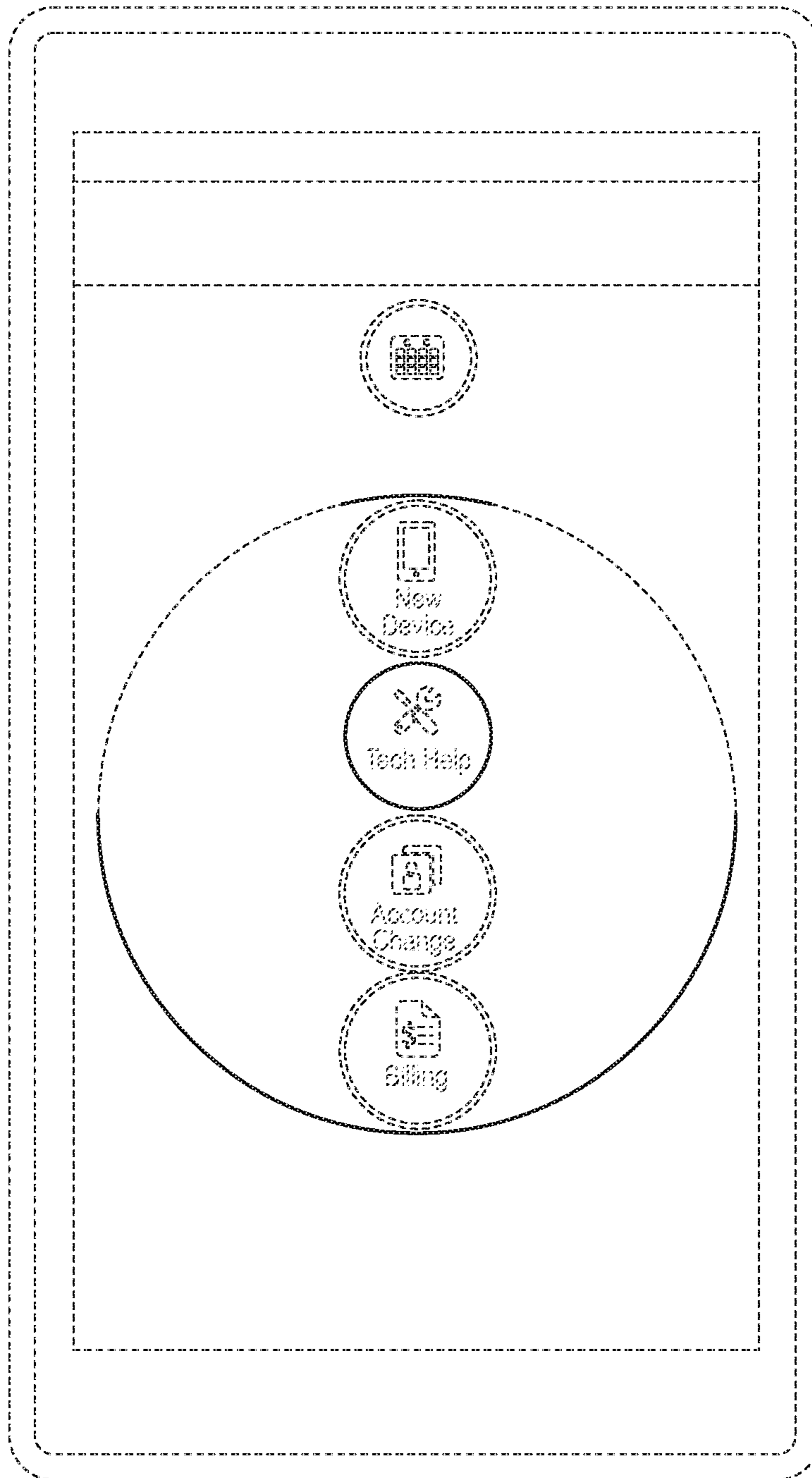

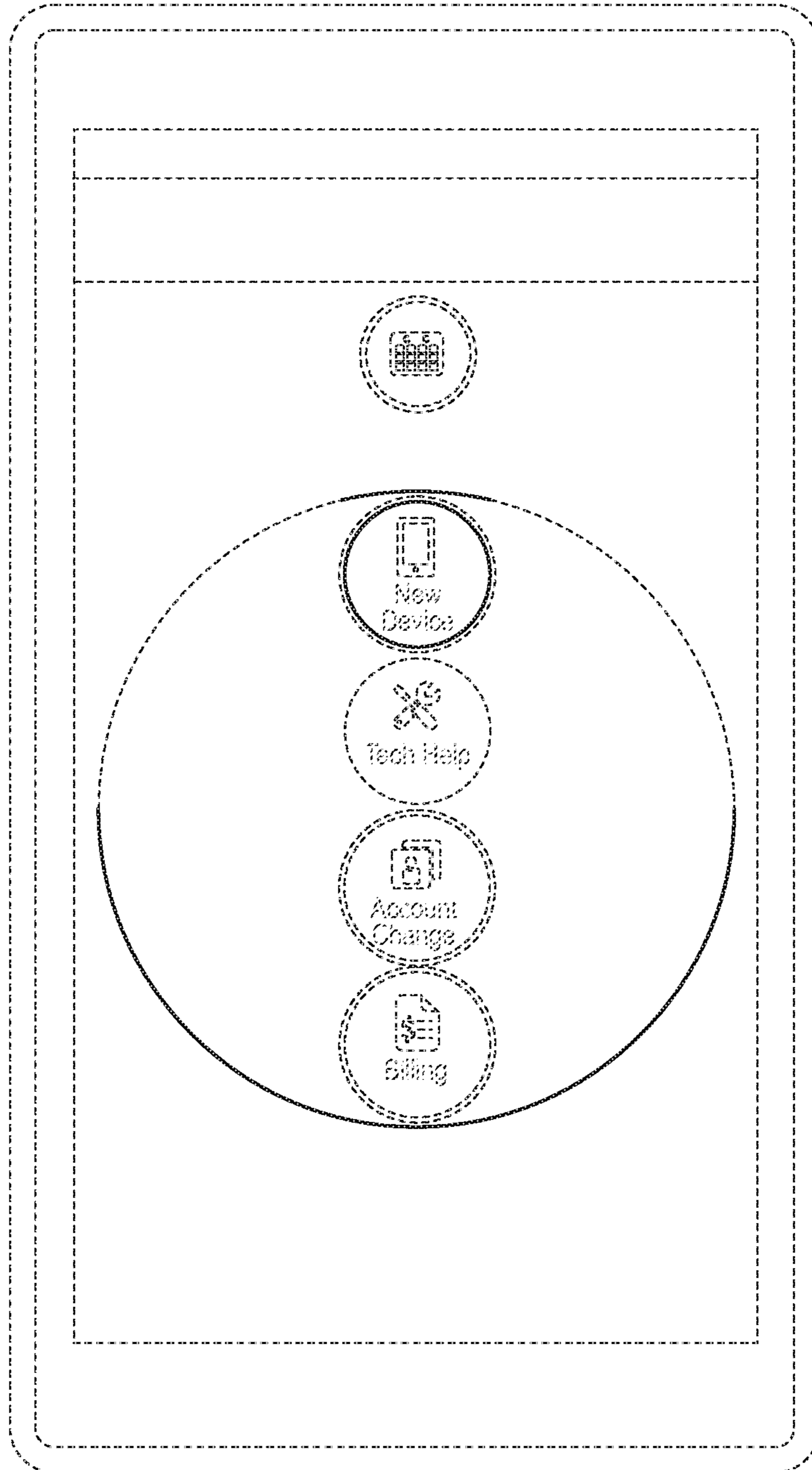

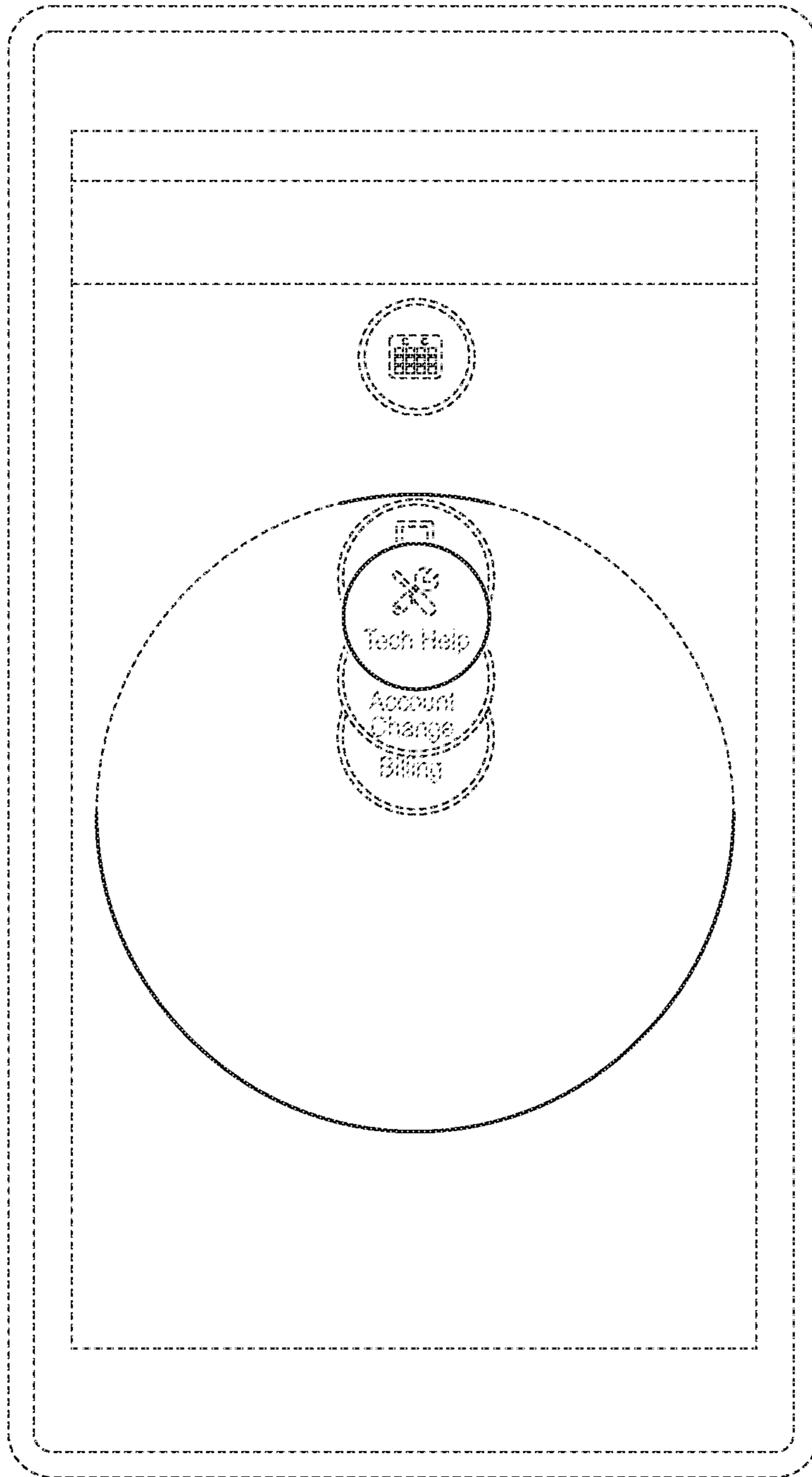

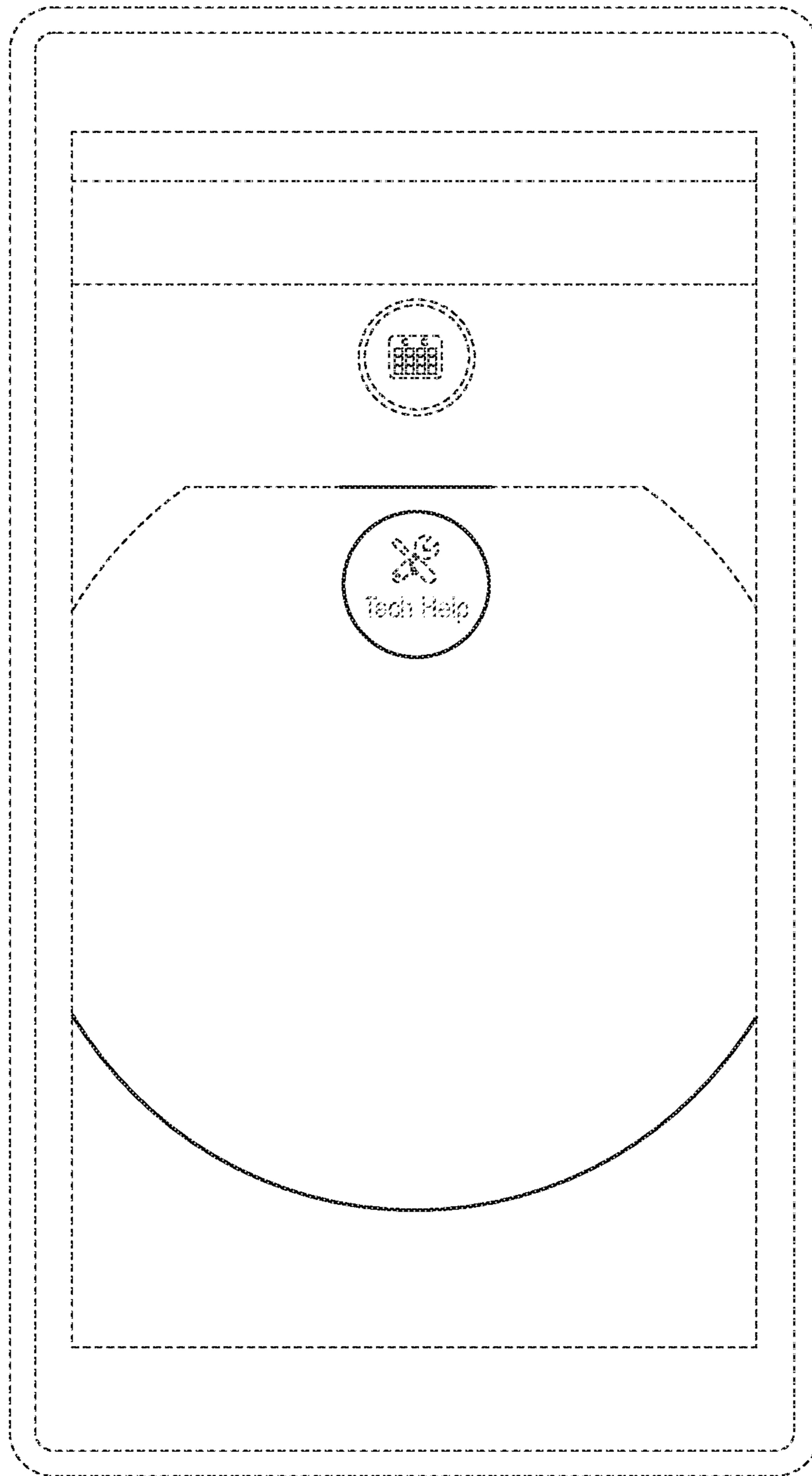
