(57) **CLAIM**

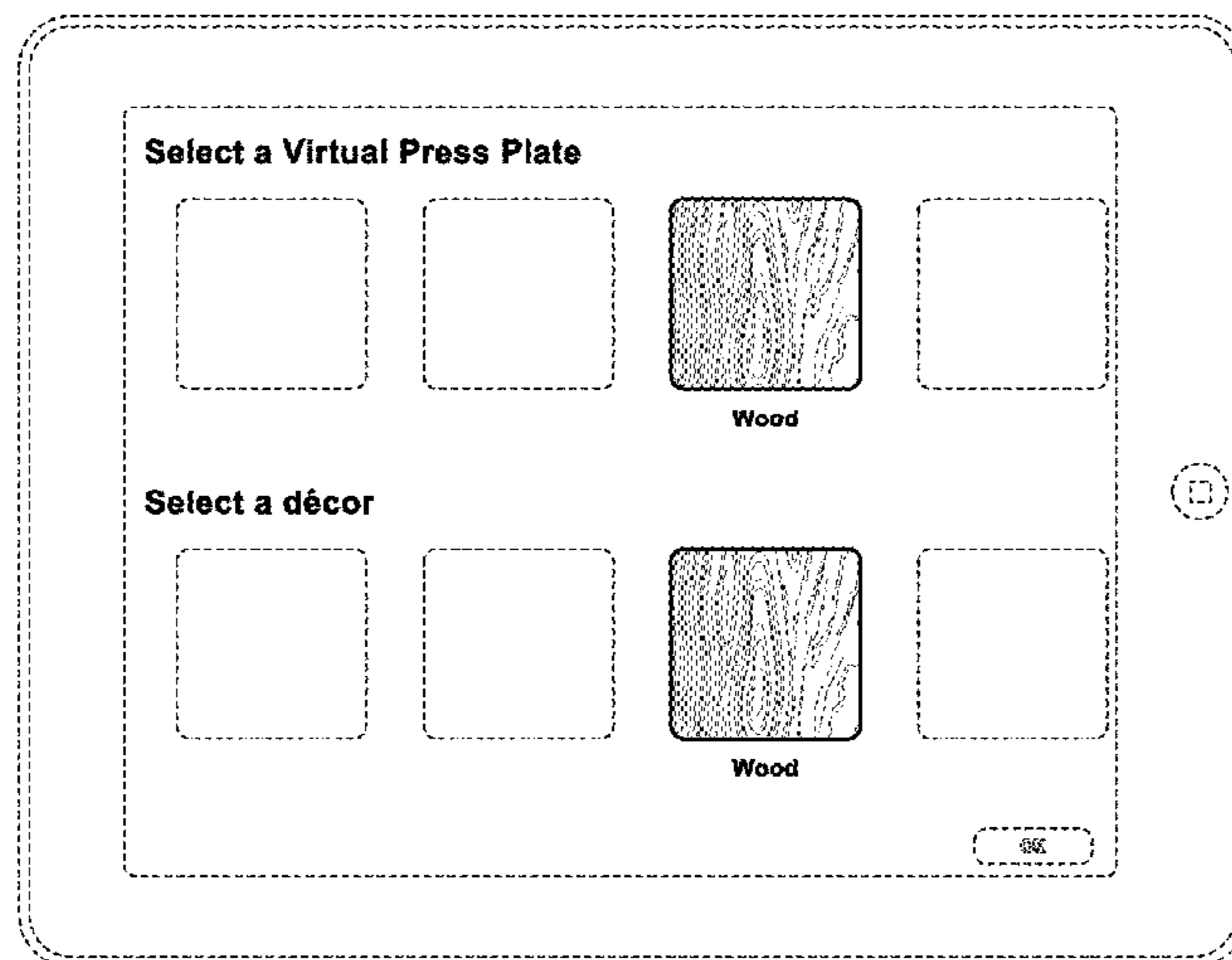
The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with a graphical user interface showing a selection screen for selecting a virtual press plate and a décor including a wood-style virtual press plate and a wood-style décor; and, FIG. 2 is a perspective view of the display screen or portion thereof with a graphical user interface of FIG. 1 showing a selection screen for selecting a virtual press plate and a décor including a wood-style virtual press plate and a wood-style décor.

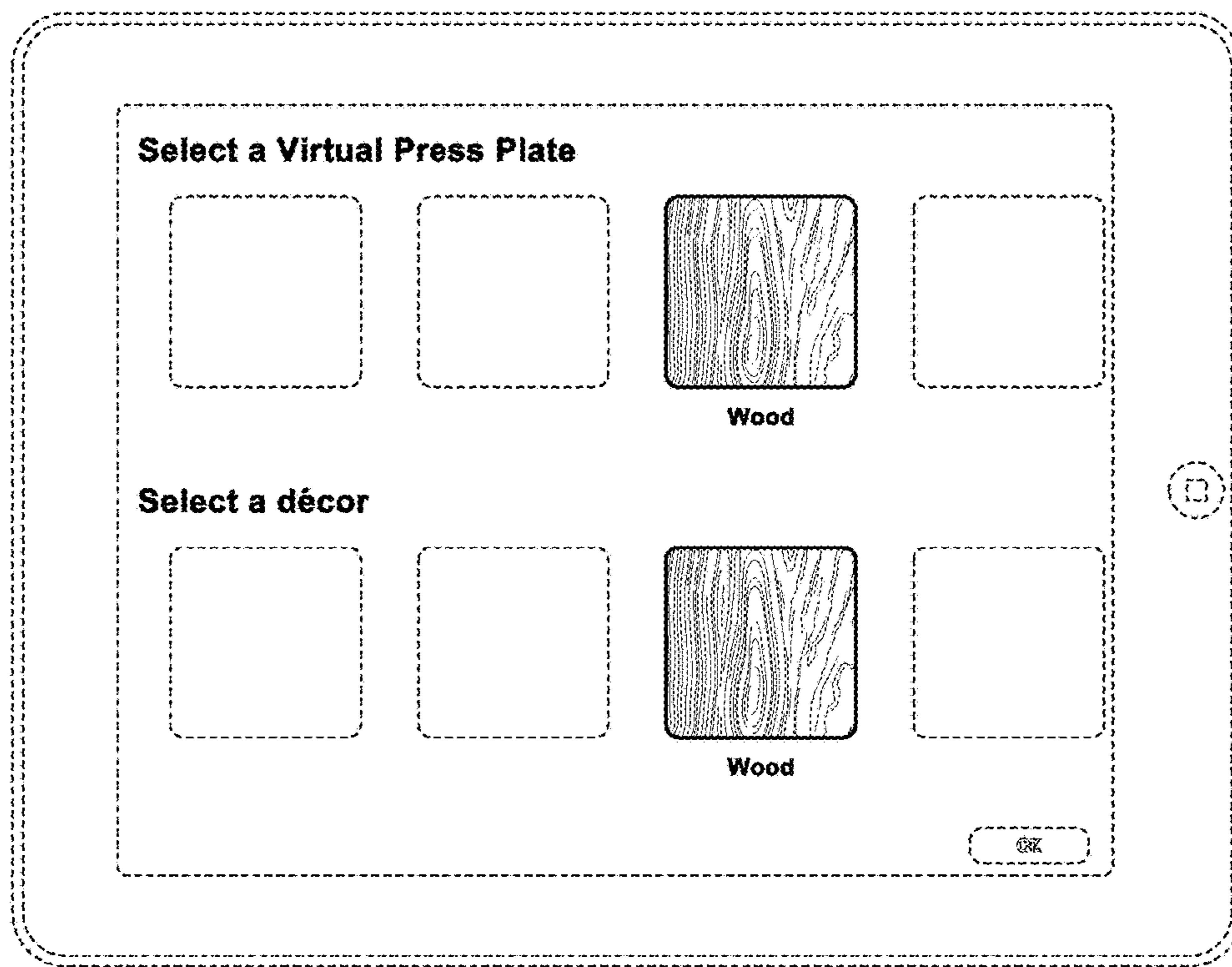

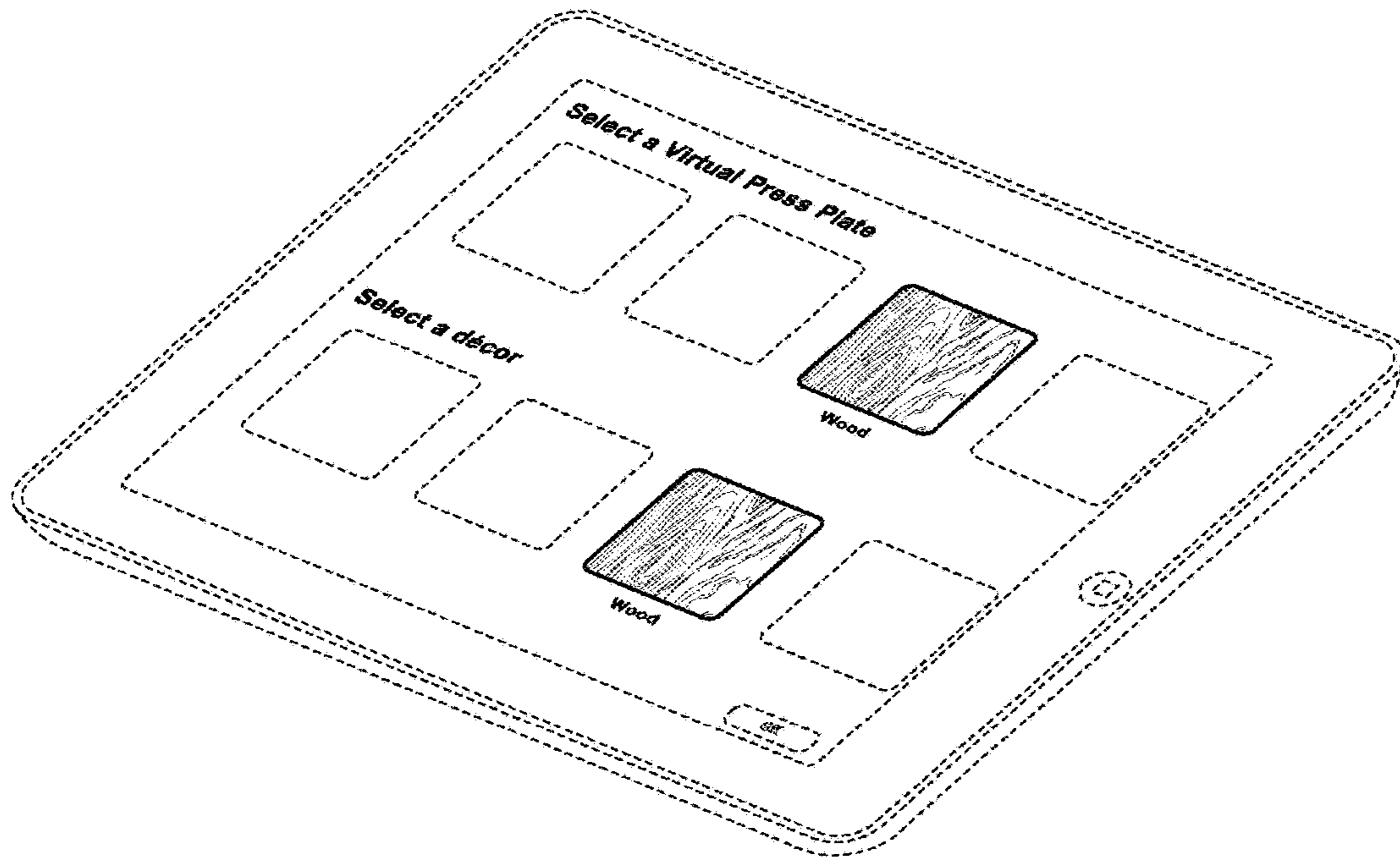
