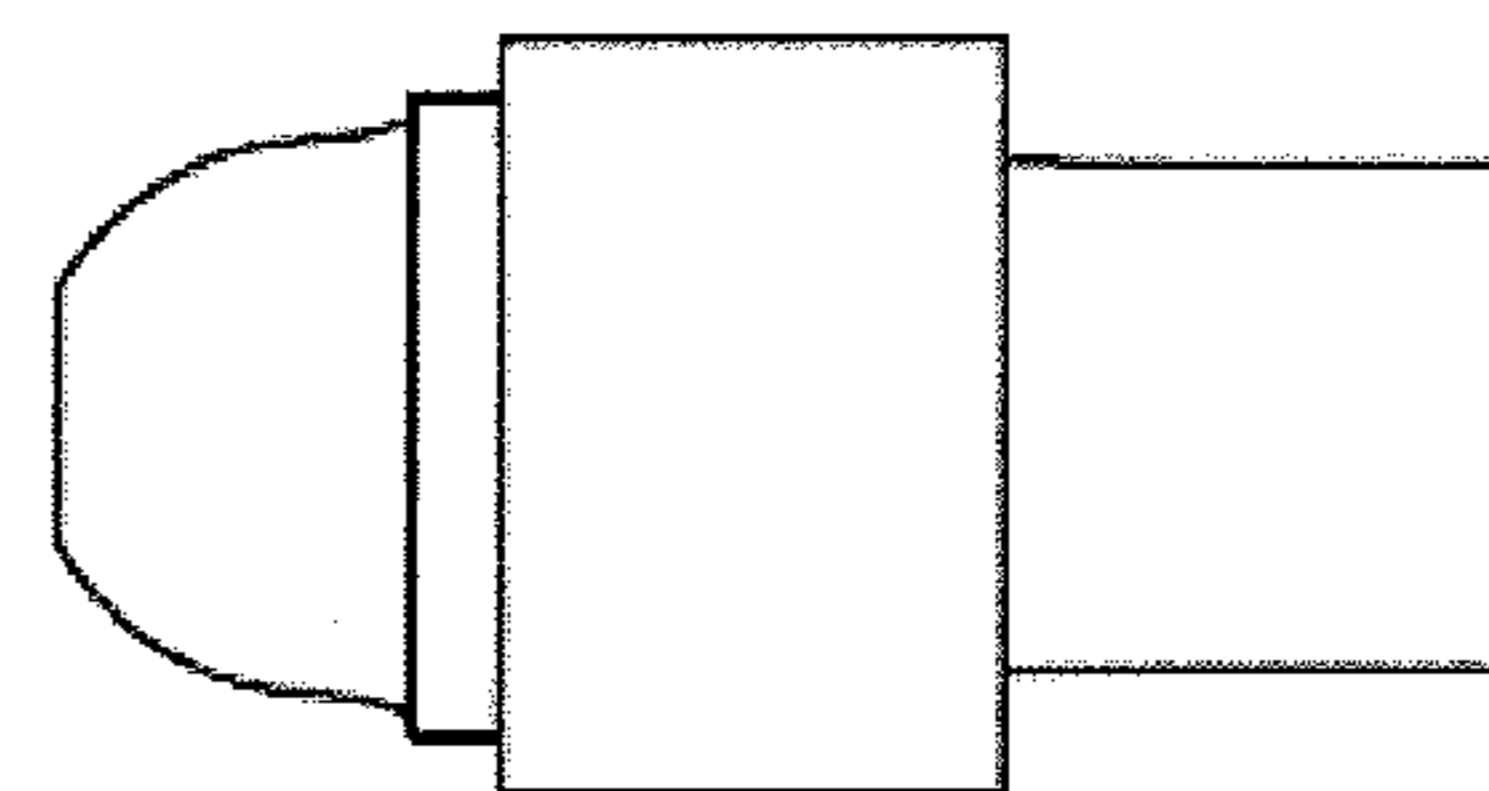
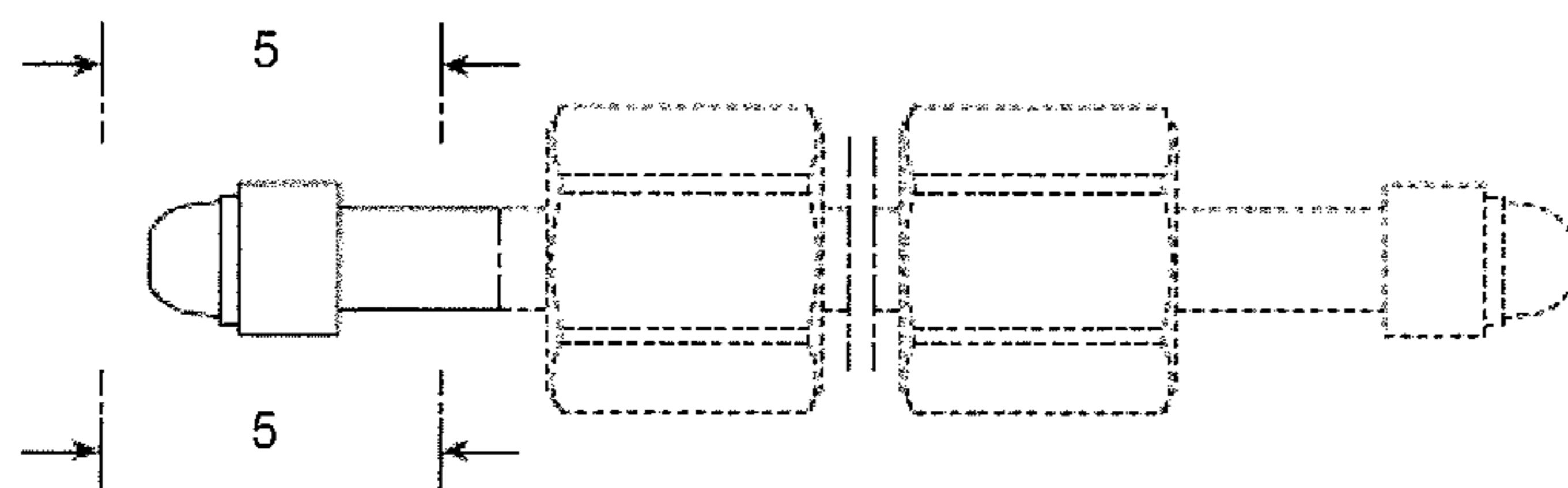
The ornamental design for a high pressure fuel injection pipe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a high pressure fuel injection pipe showing our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is an enlarged view along line 5-5 of FIG. 1;  
FIG. 6 is a cross-sectional view along line 6-6 of FIG. 2;  
FIG. 7 is an enlarged view along line 7-7 of FIG. 6;  
FIG. 8 is an enlarged view of FIG. 4; and,  
FIG. 9 is the enlarged view of FIG. 7 shown in a position of use.

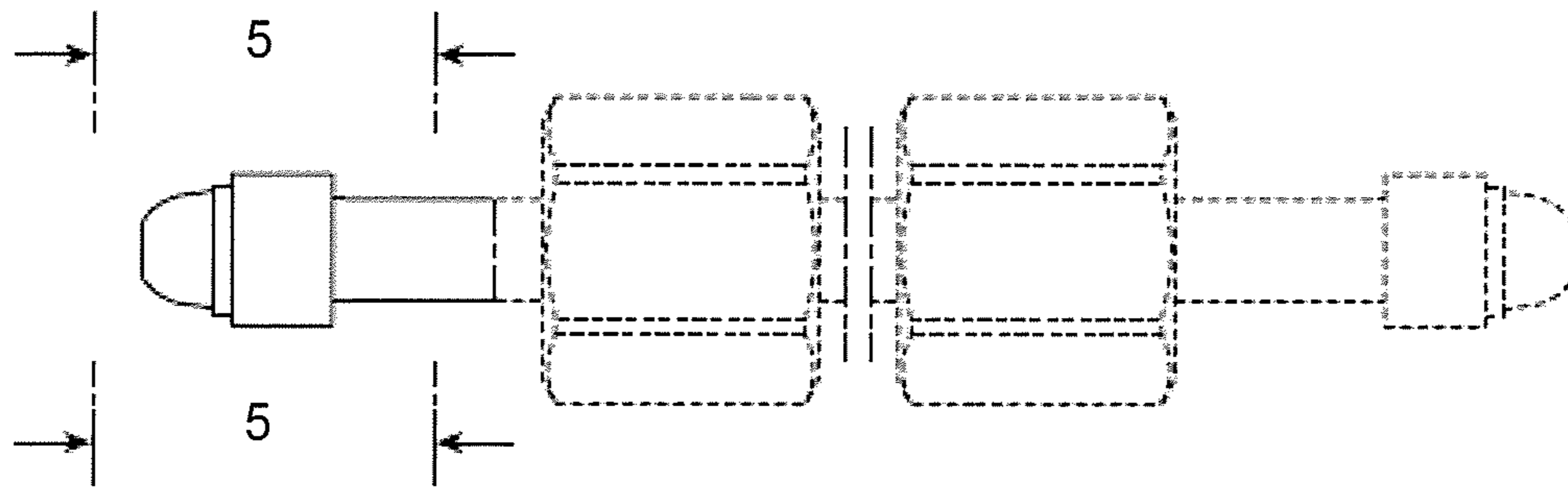

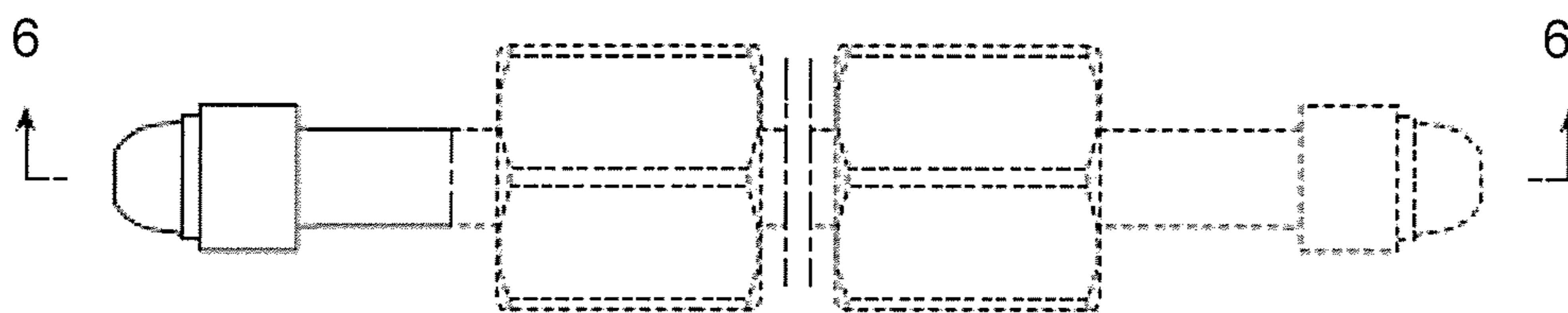

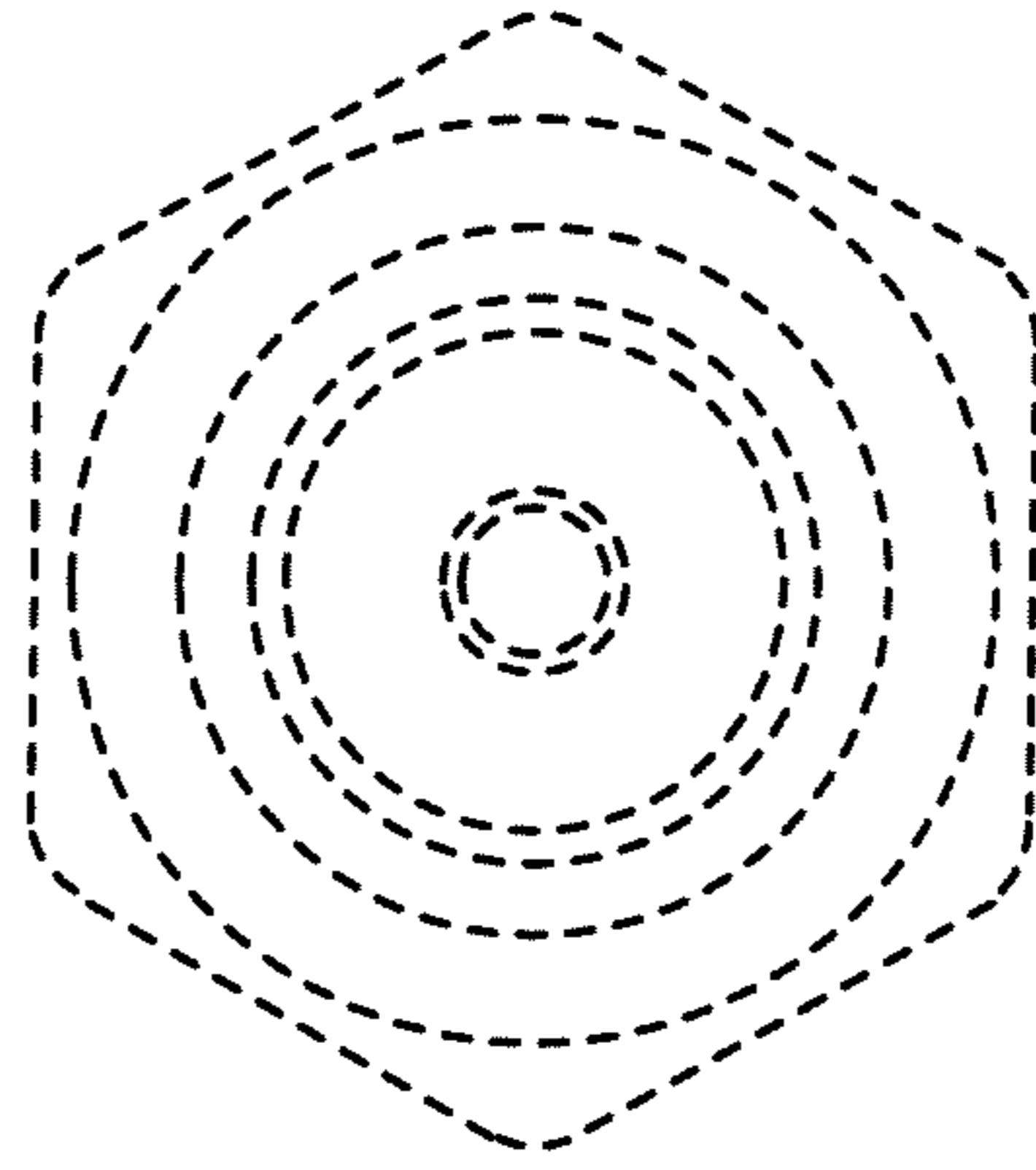

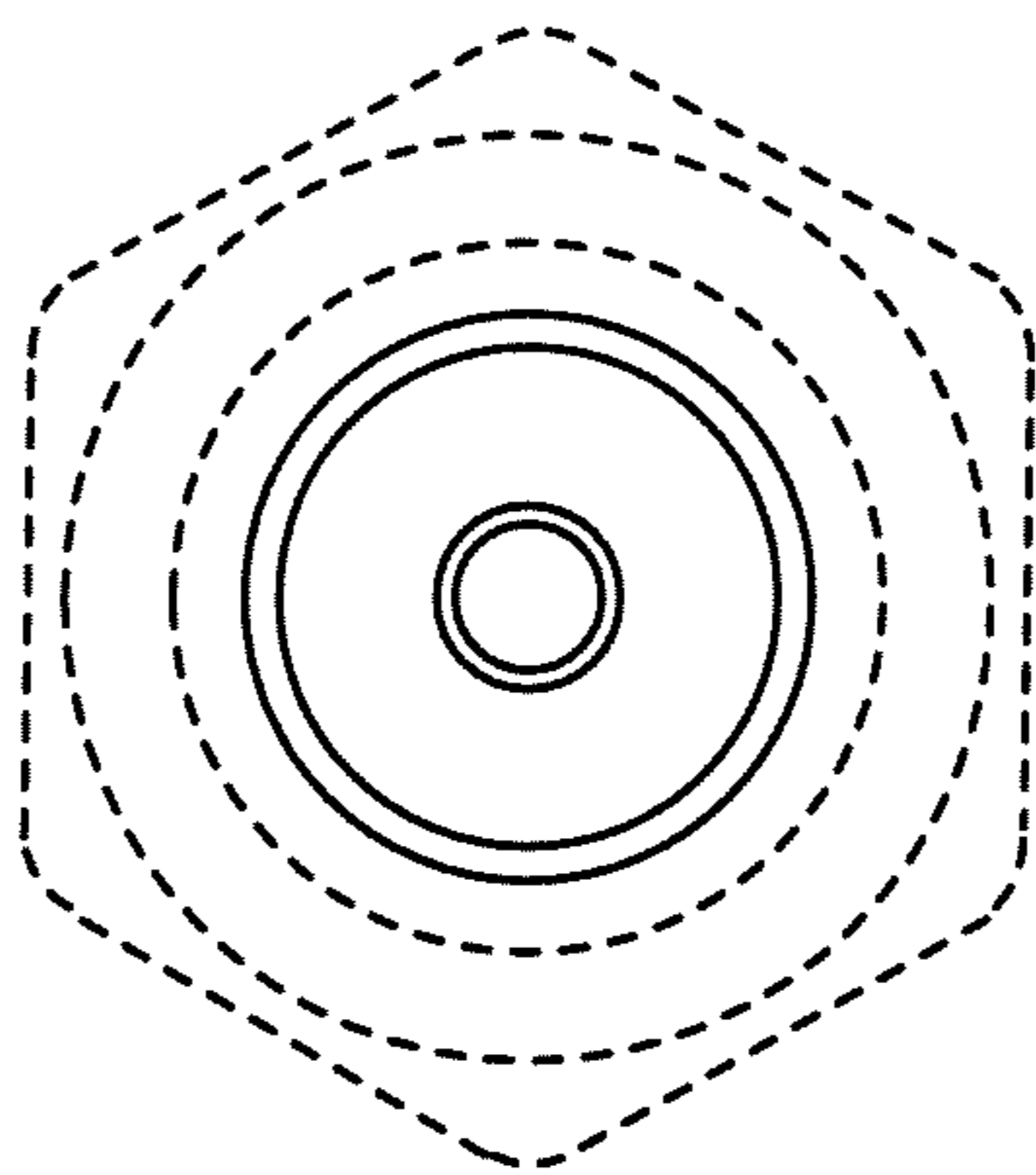

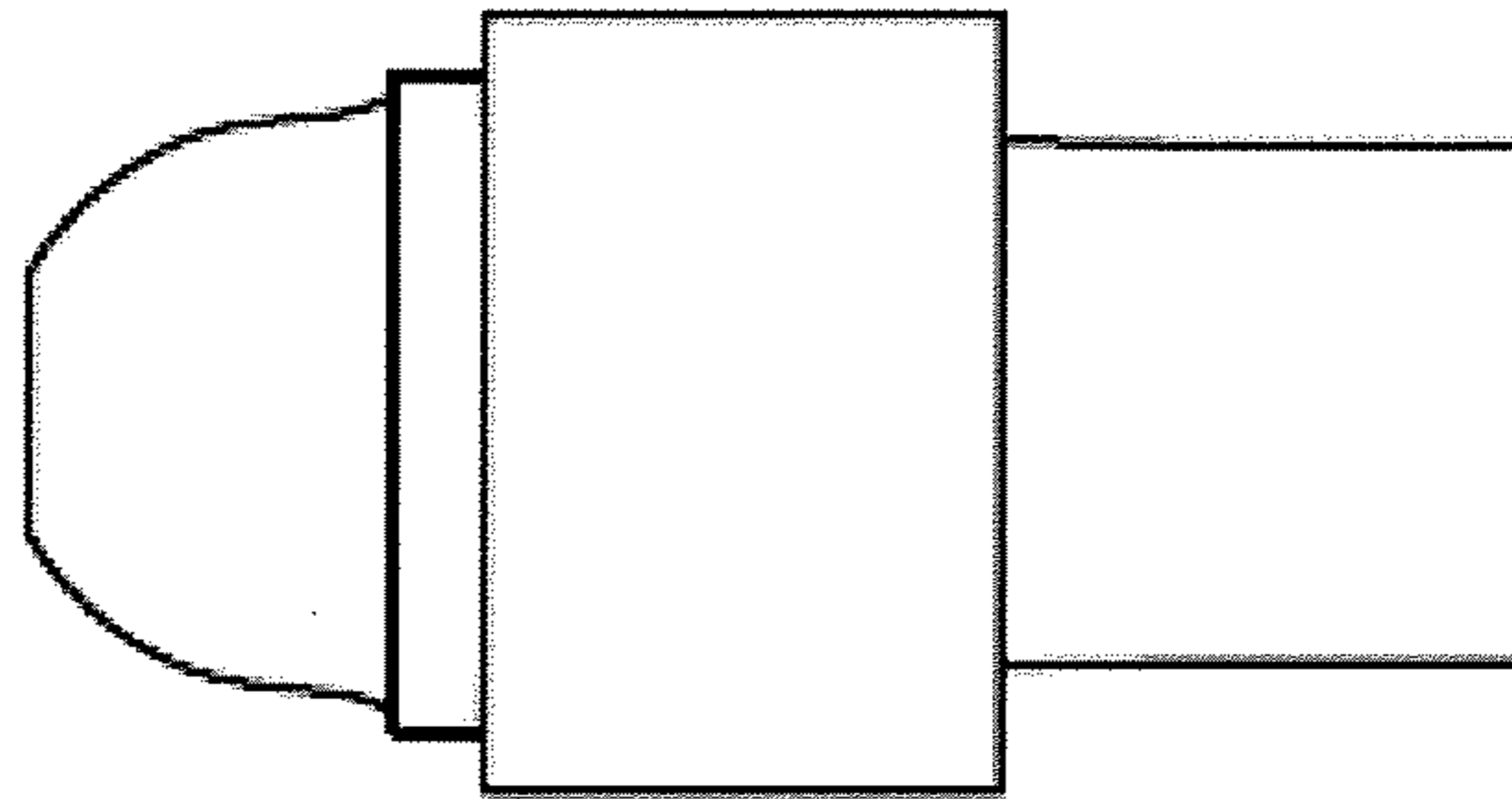

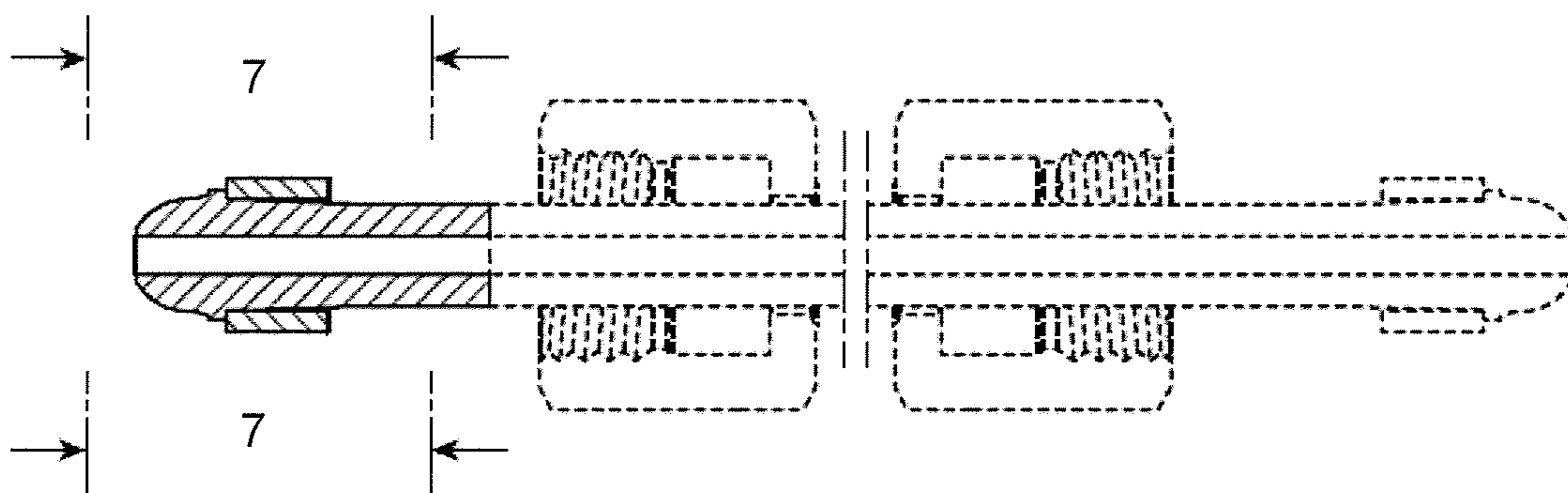

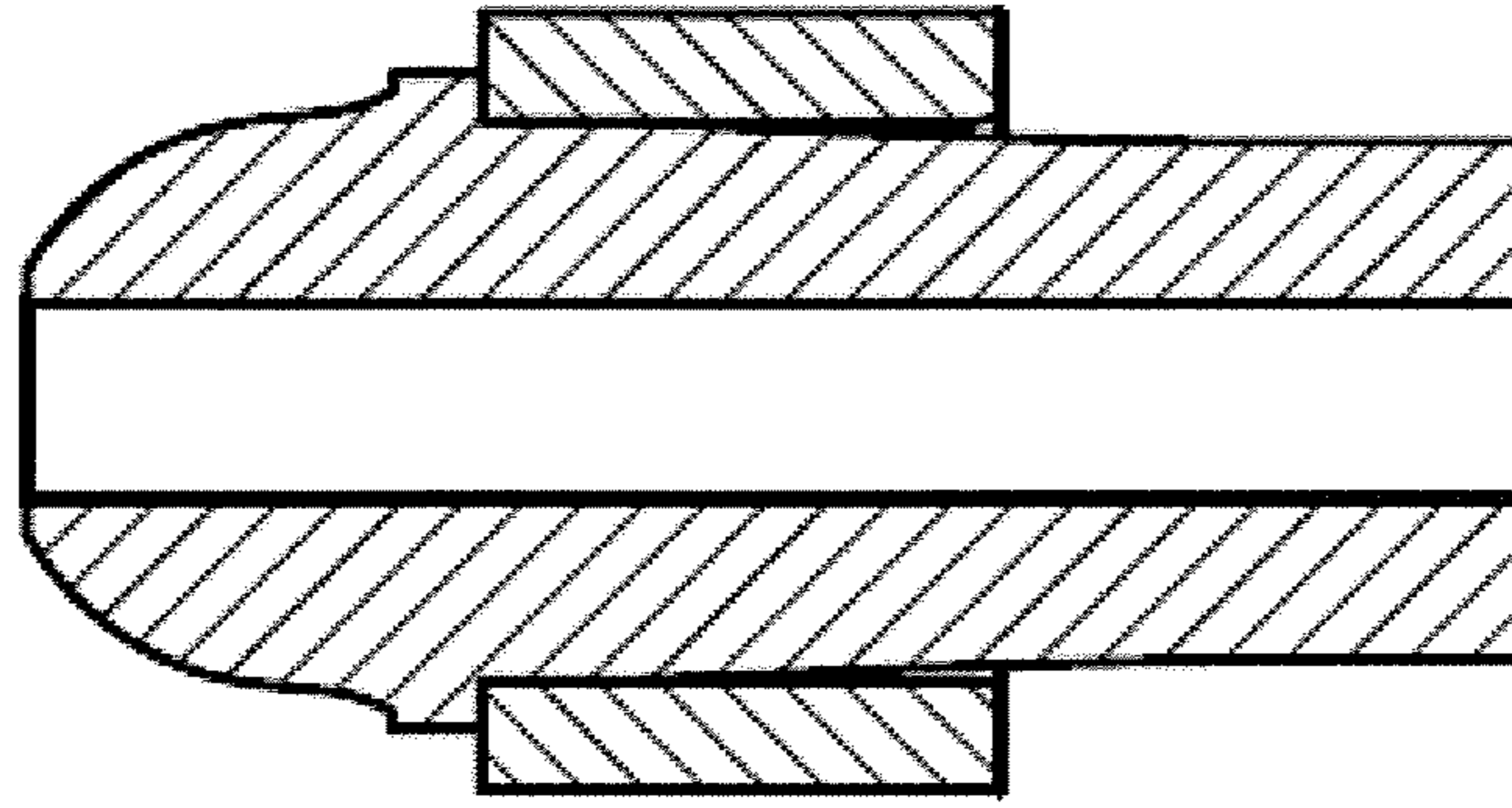

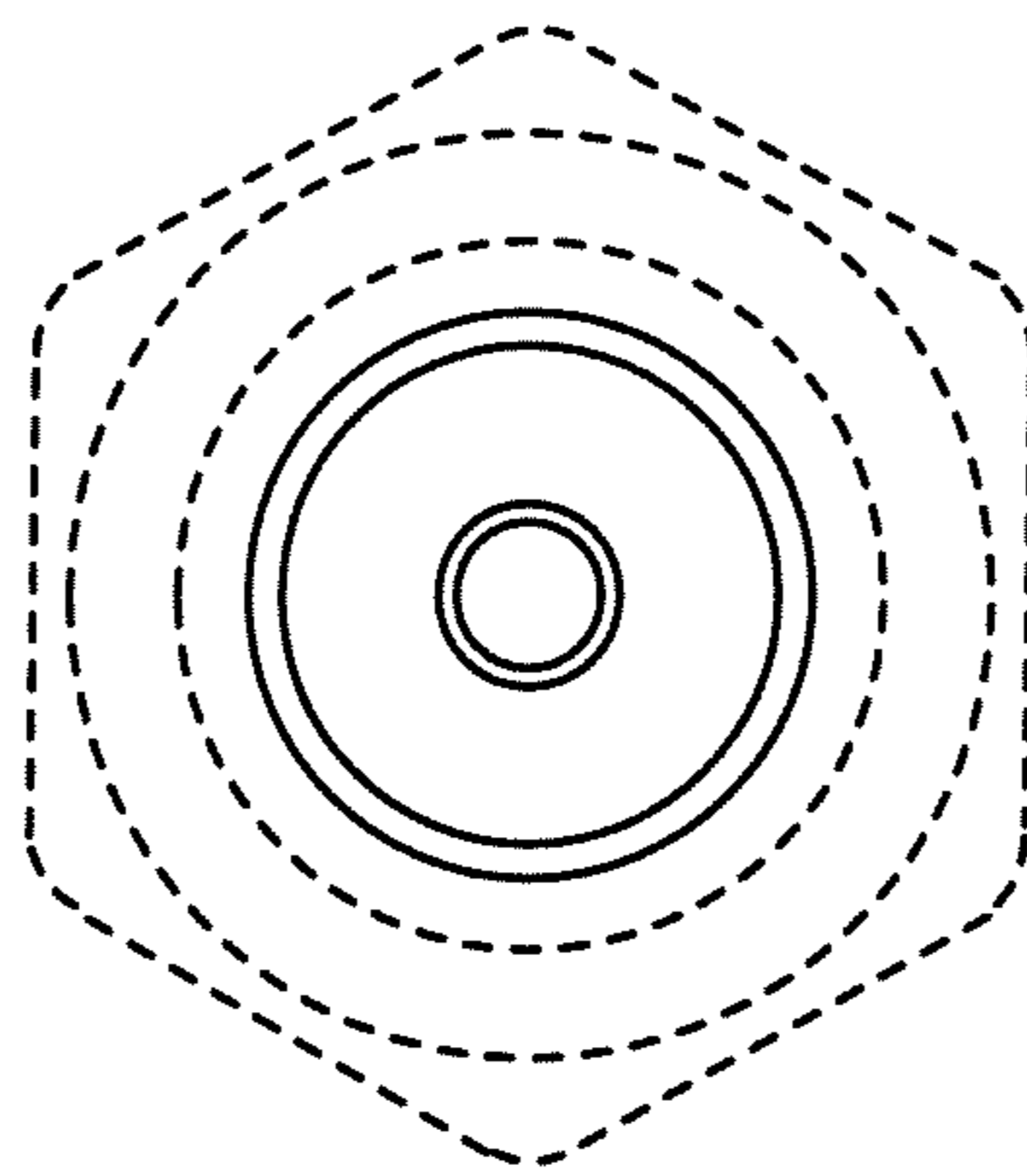

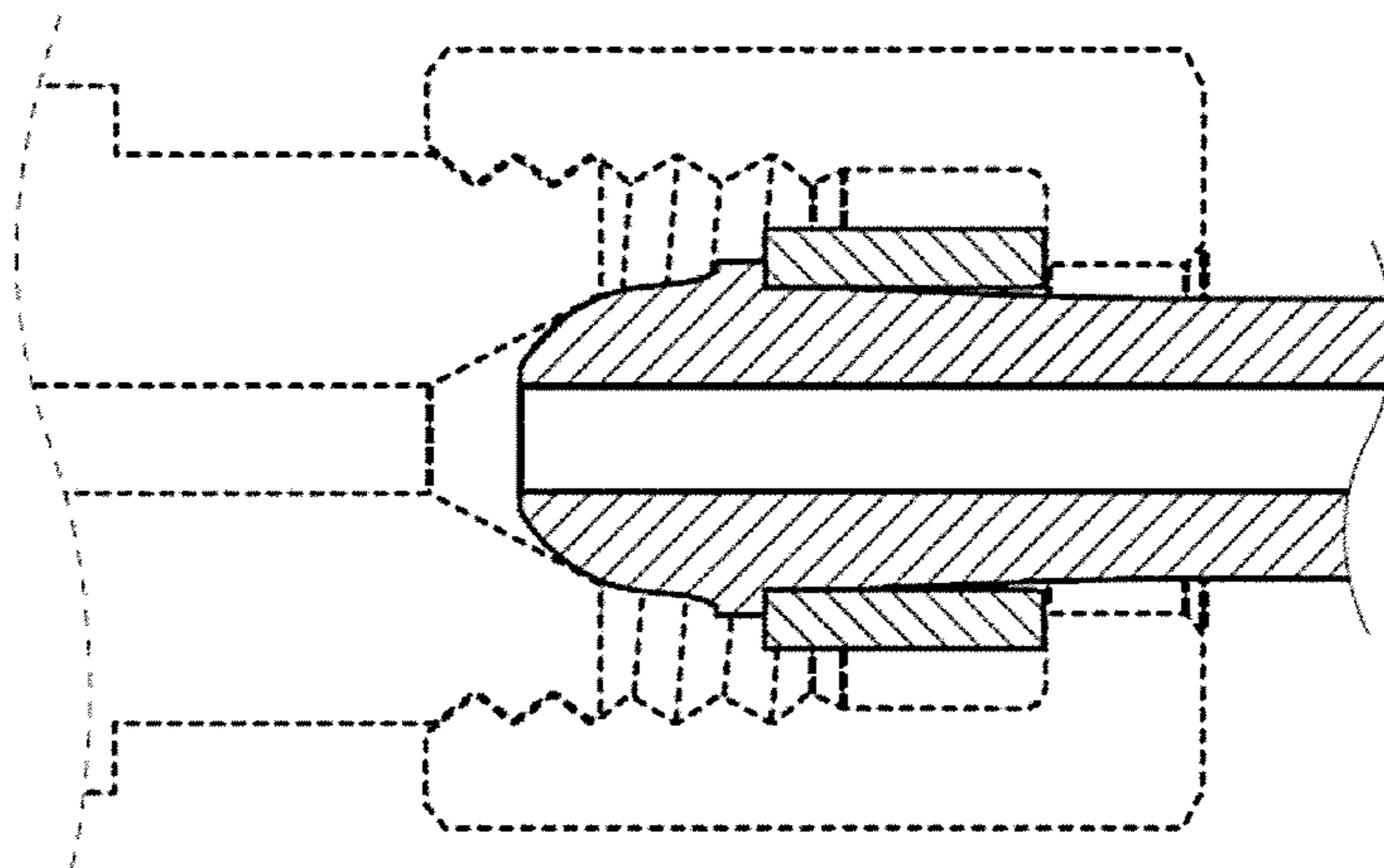
