The ornamental design for a popcorn light, as shown and described.

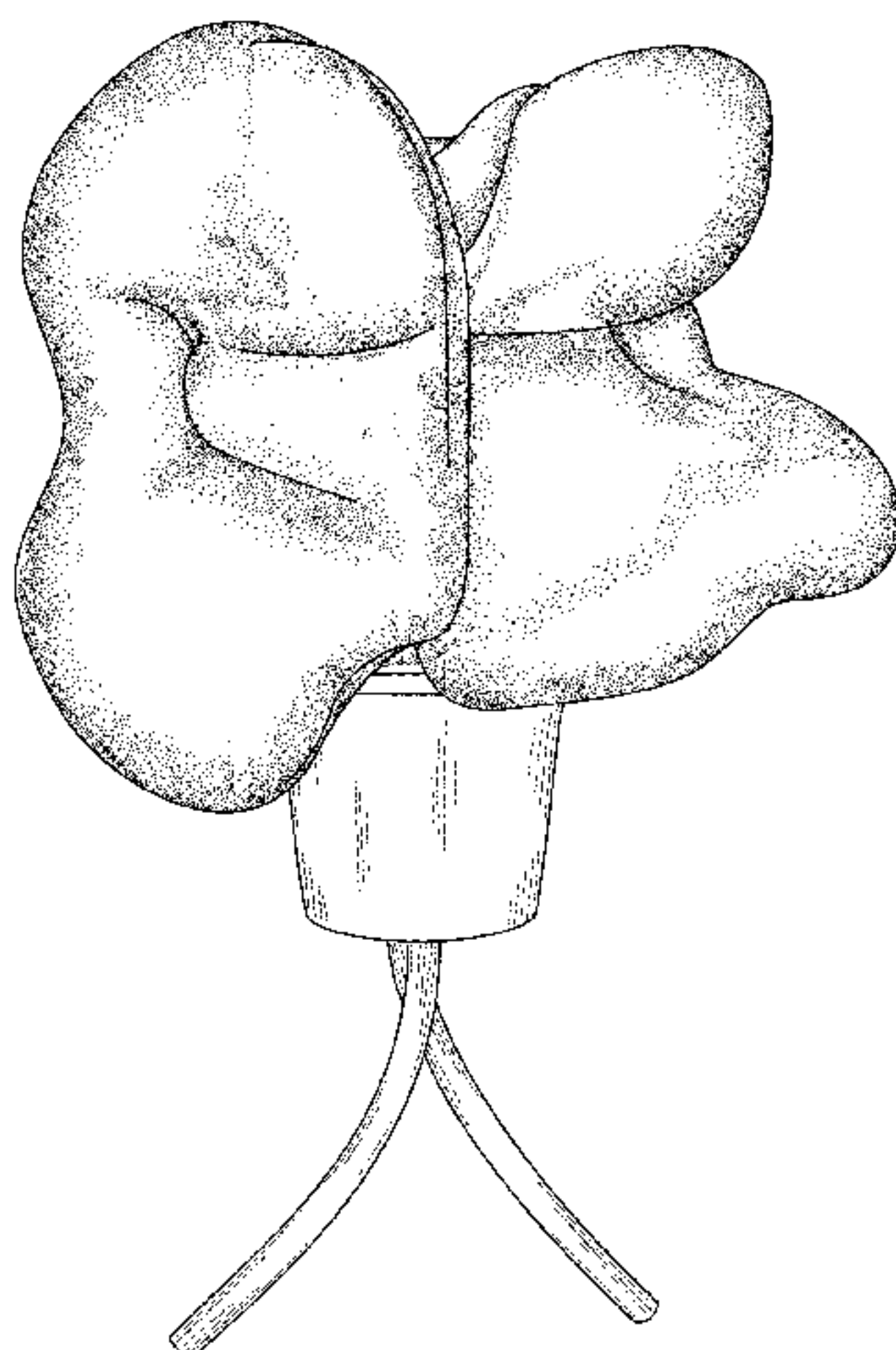
DESCRIPTION

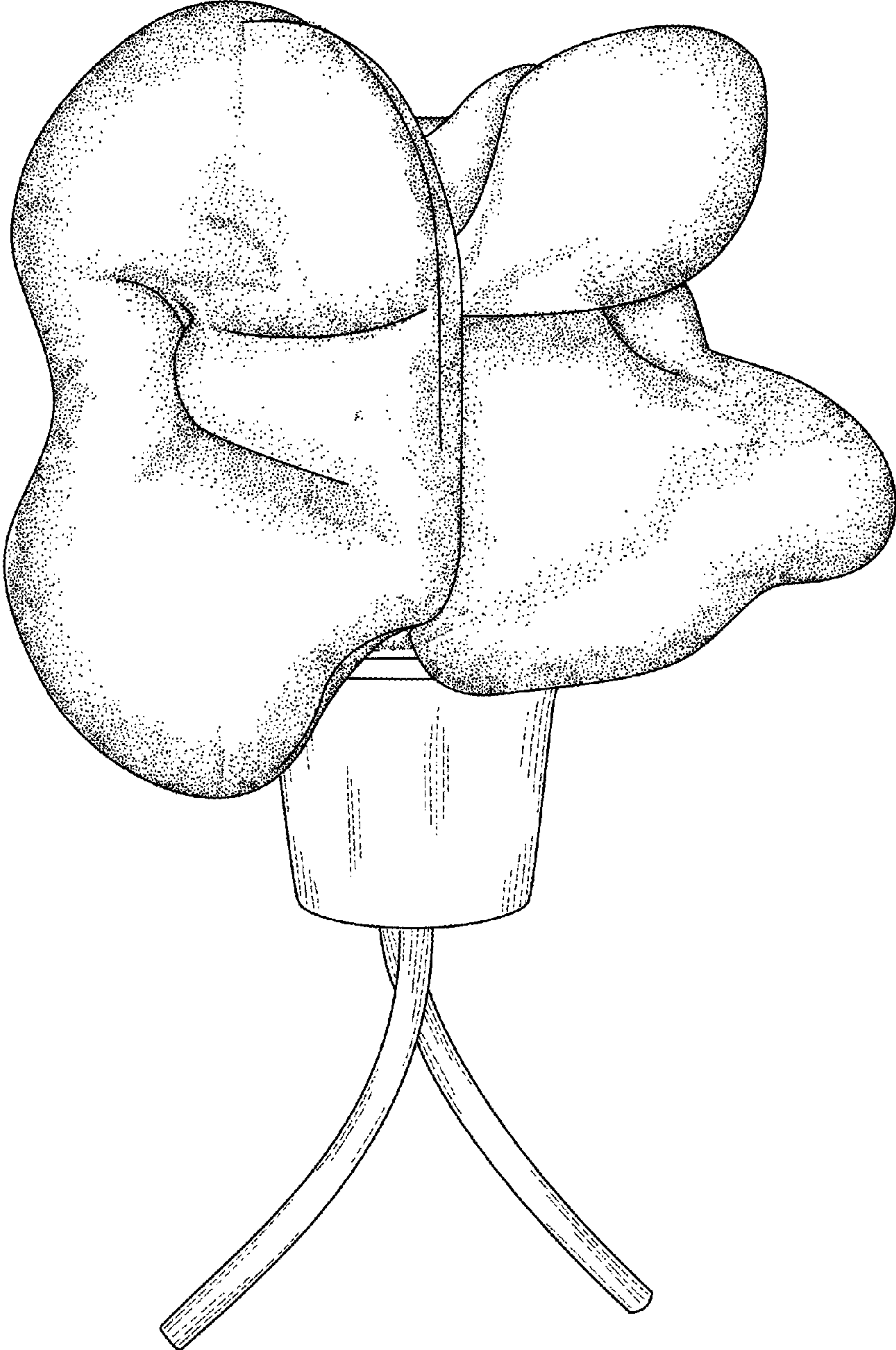

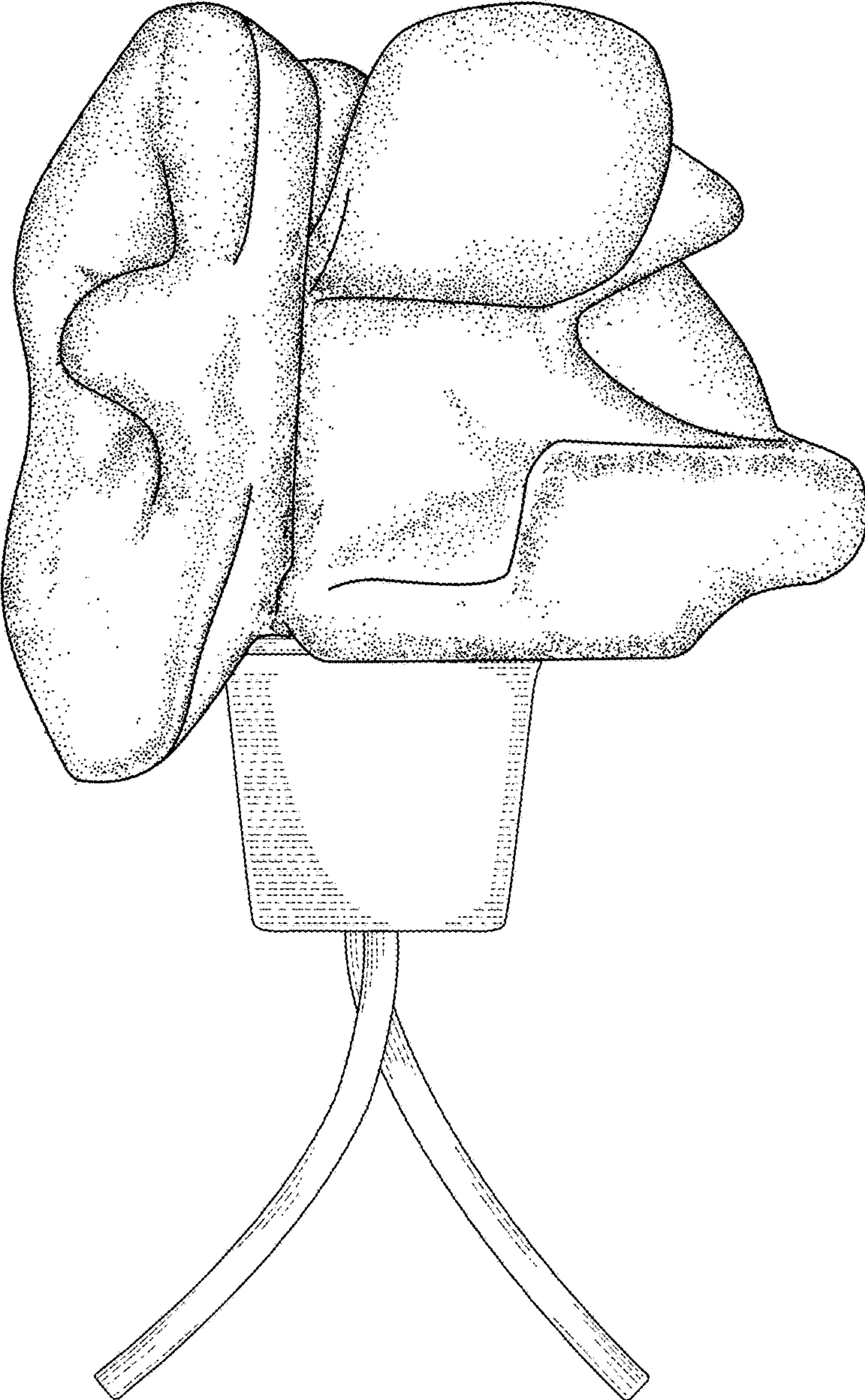

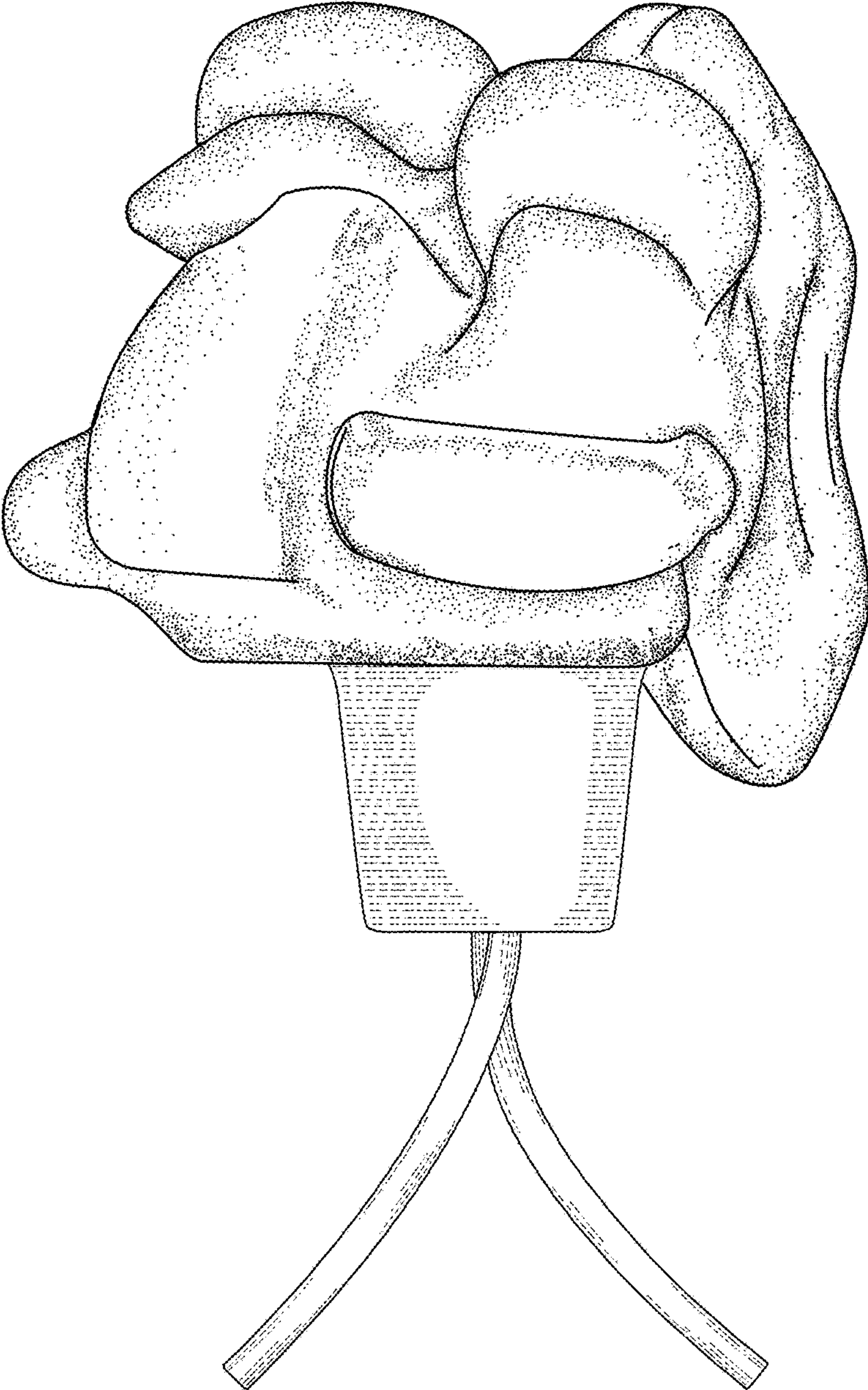

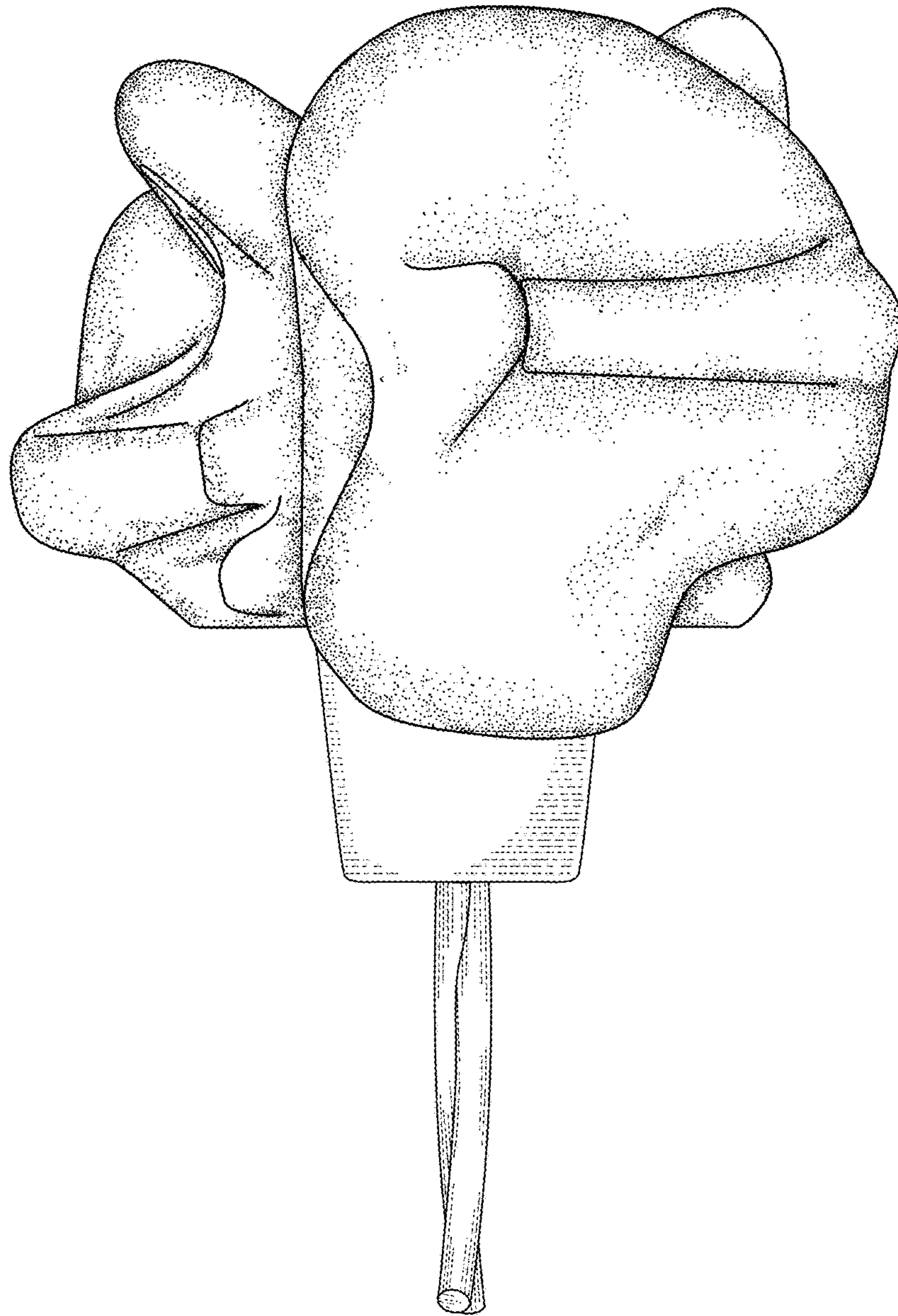

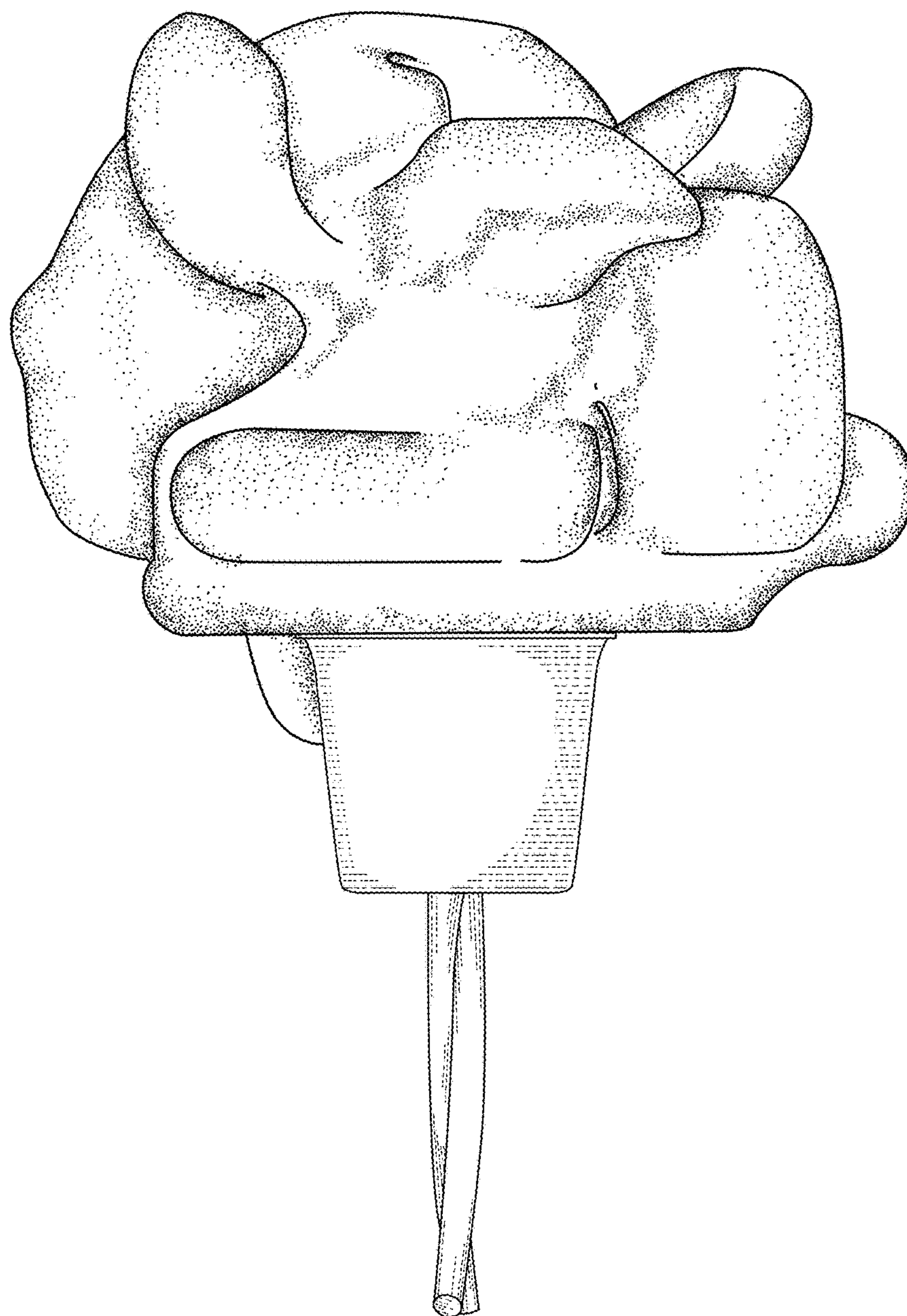

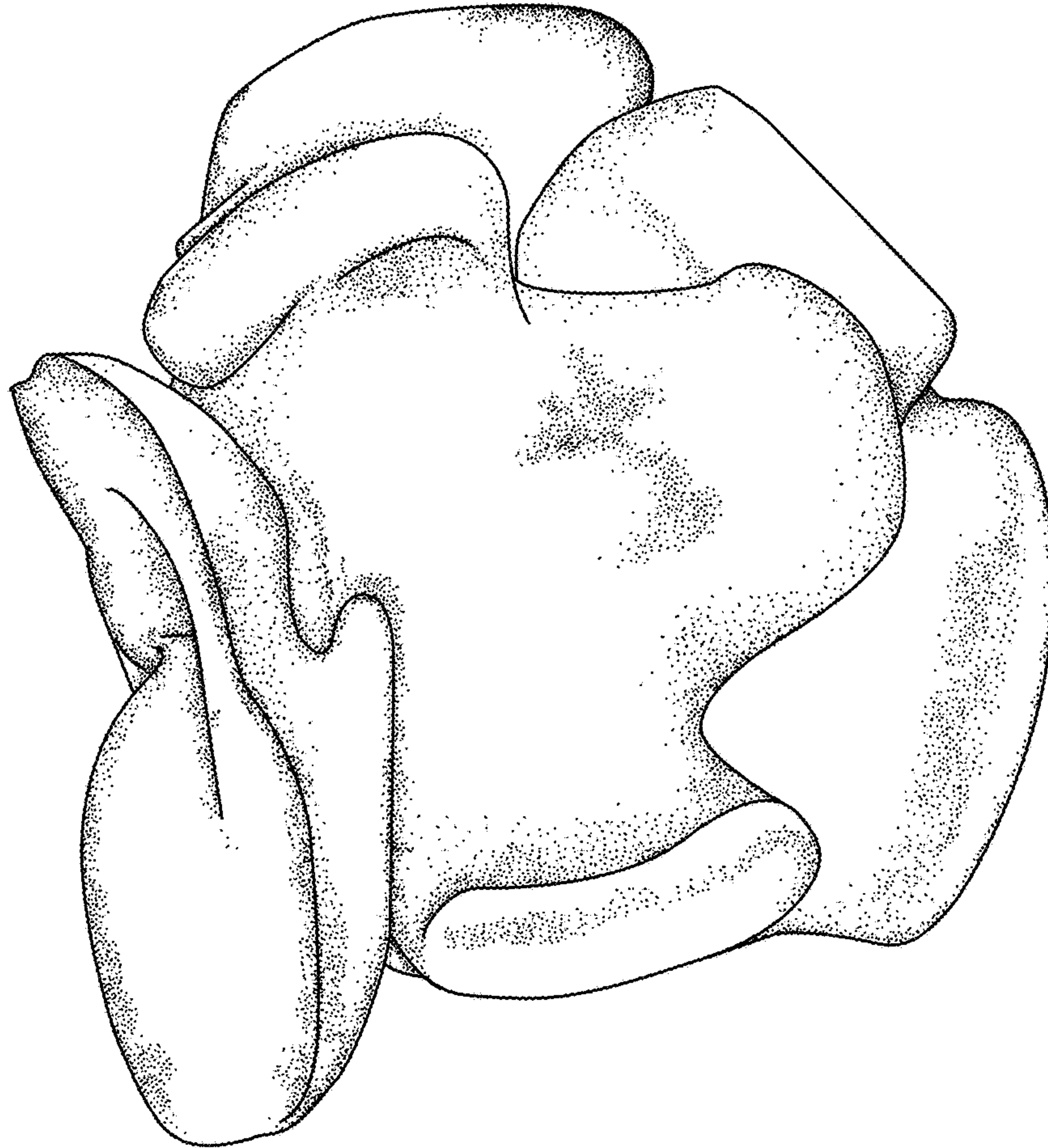

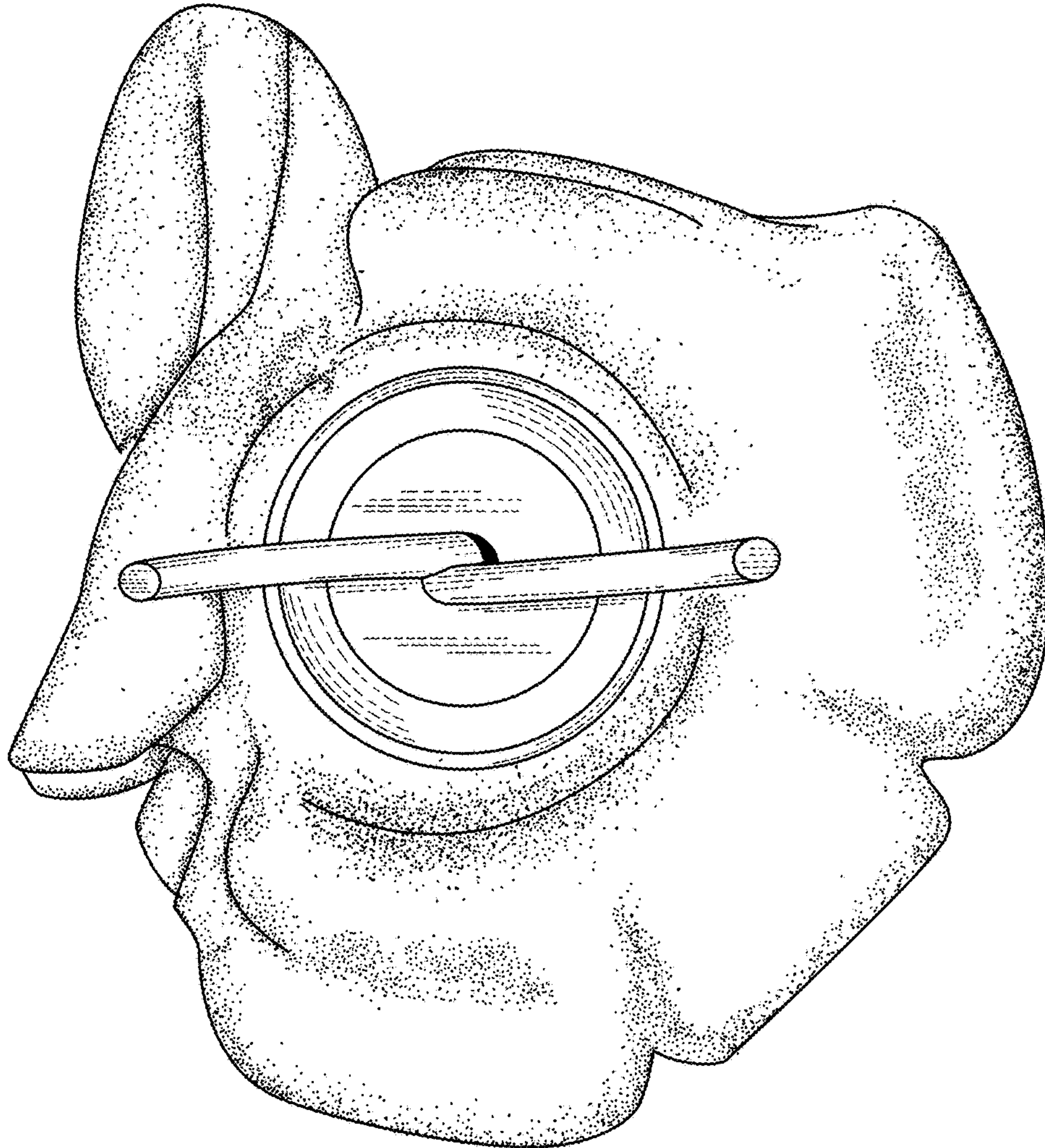
