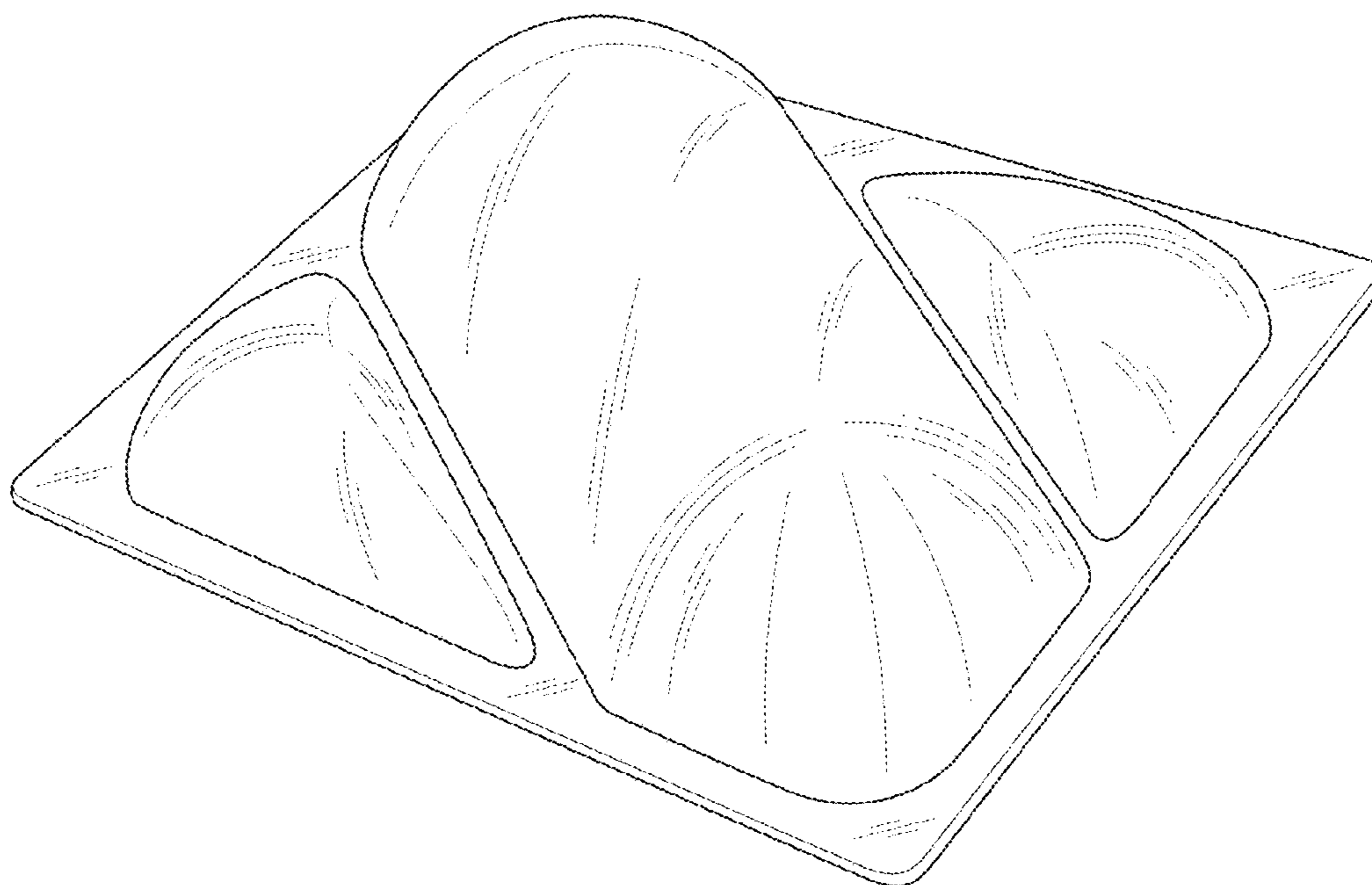

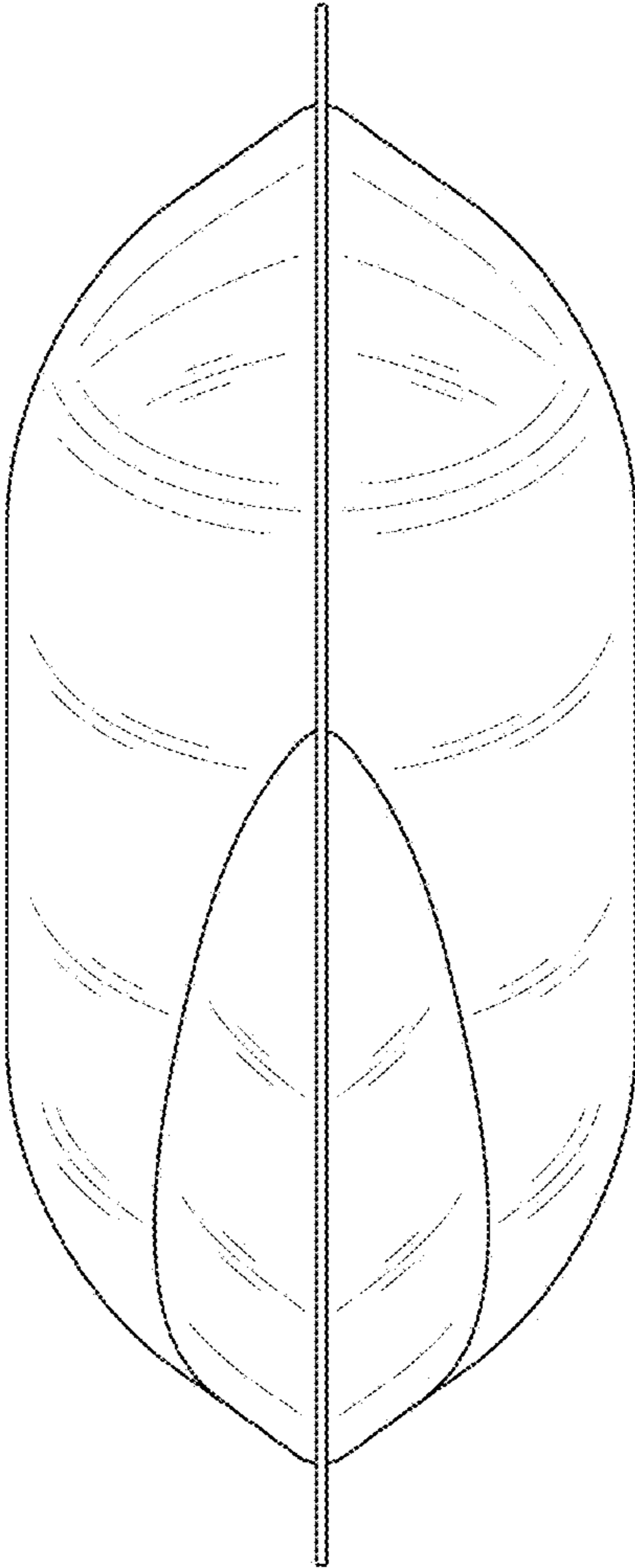
The ornamental design for a water-soluble detergent capsule, as shown and described.

**DESCRIPTION**

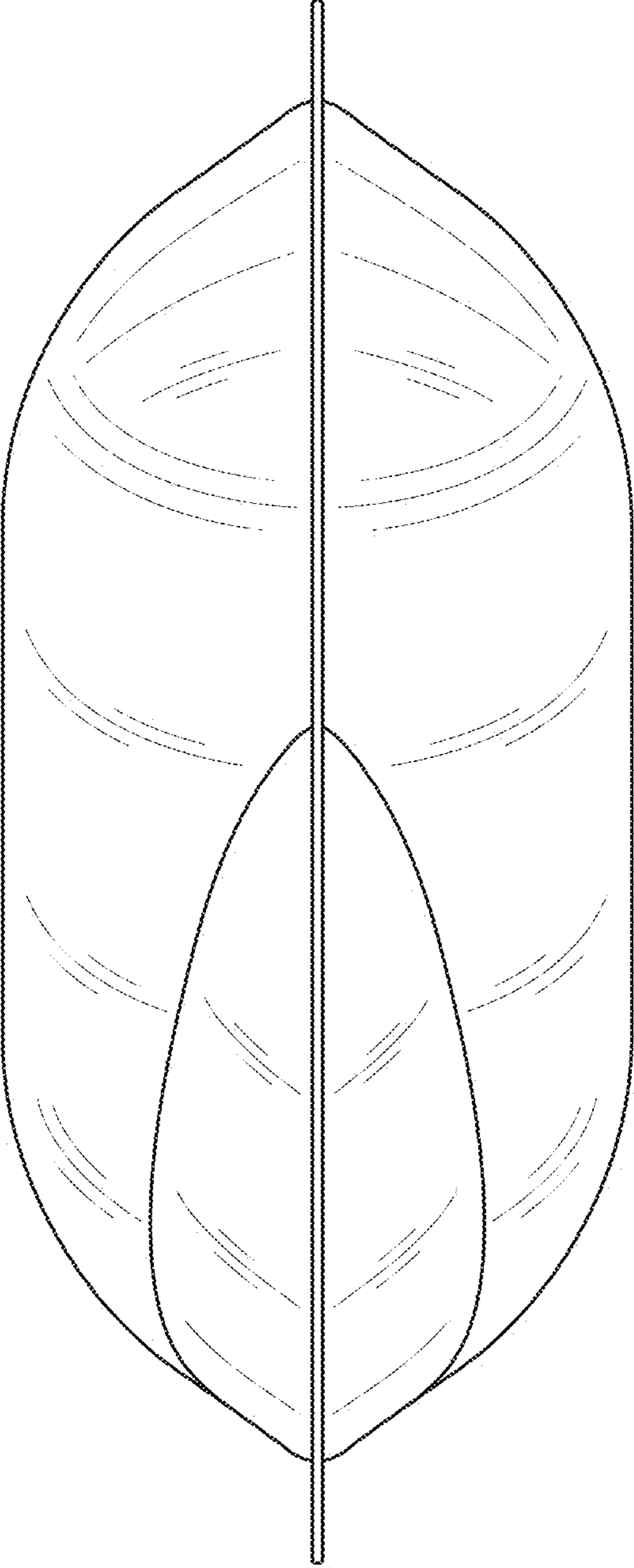
1. Water-soluble detergent capsule

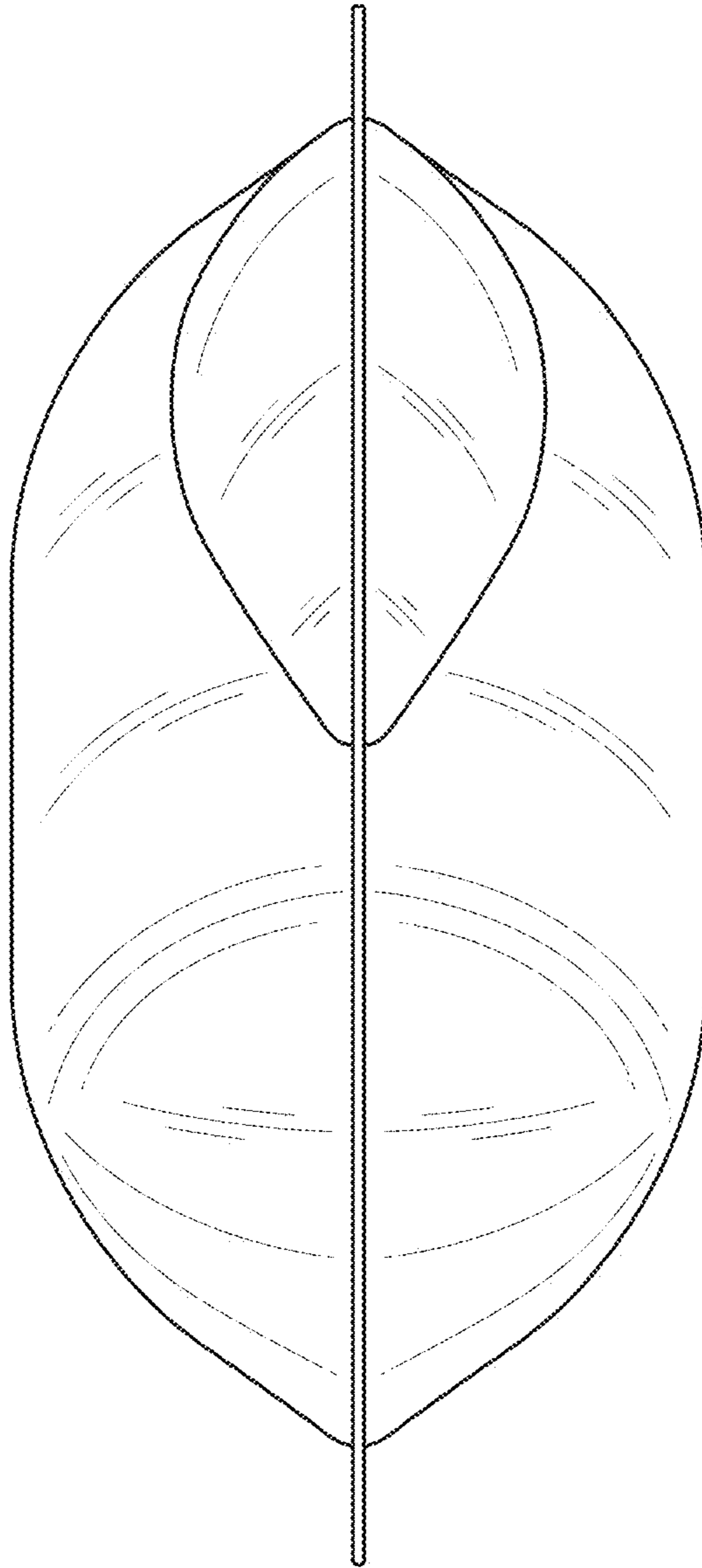




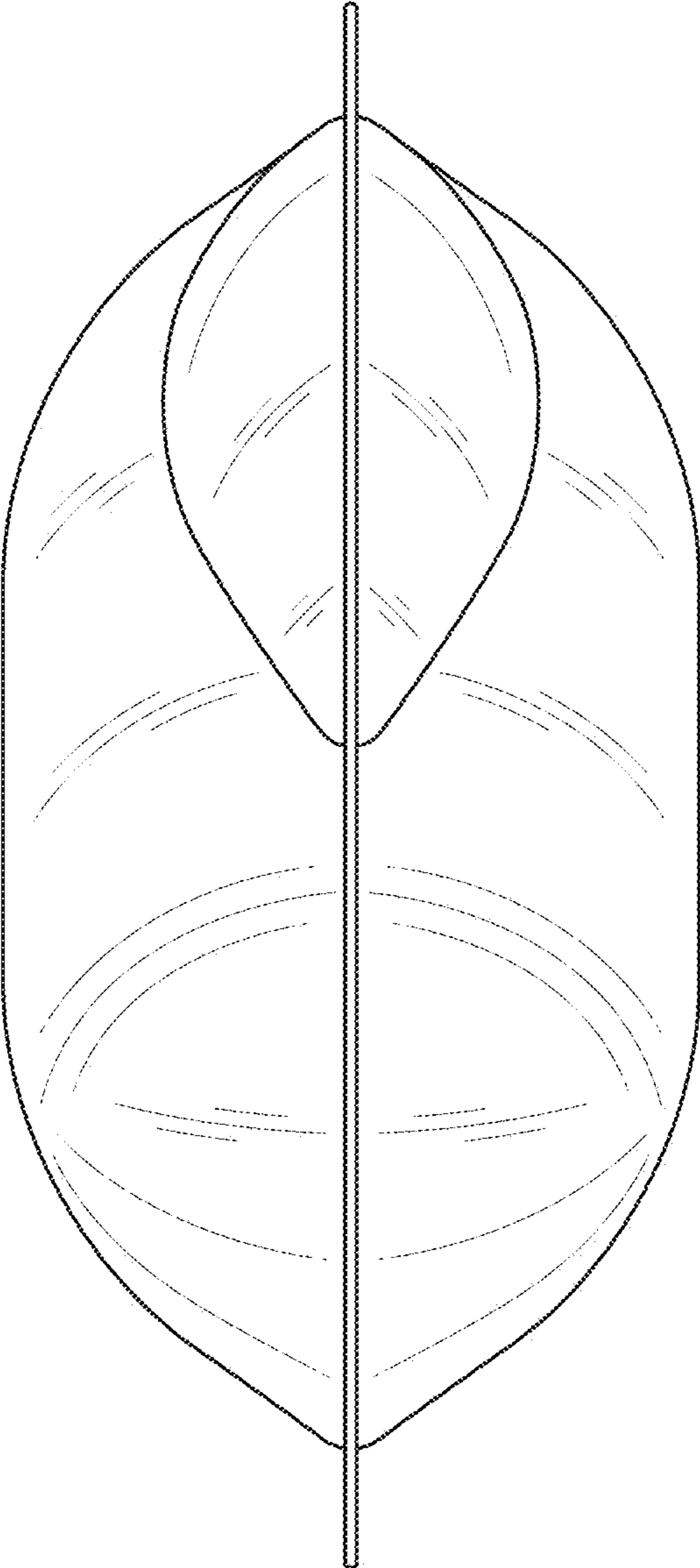

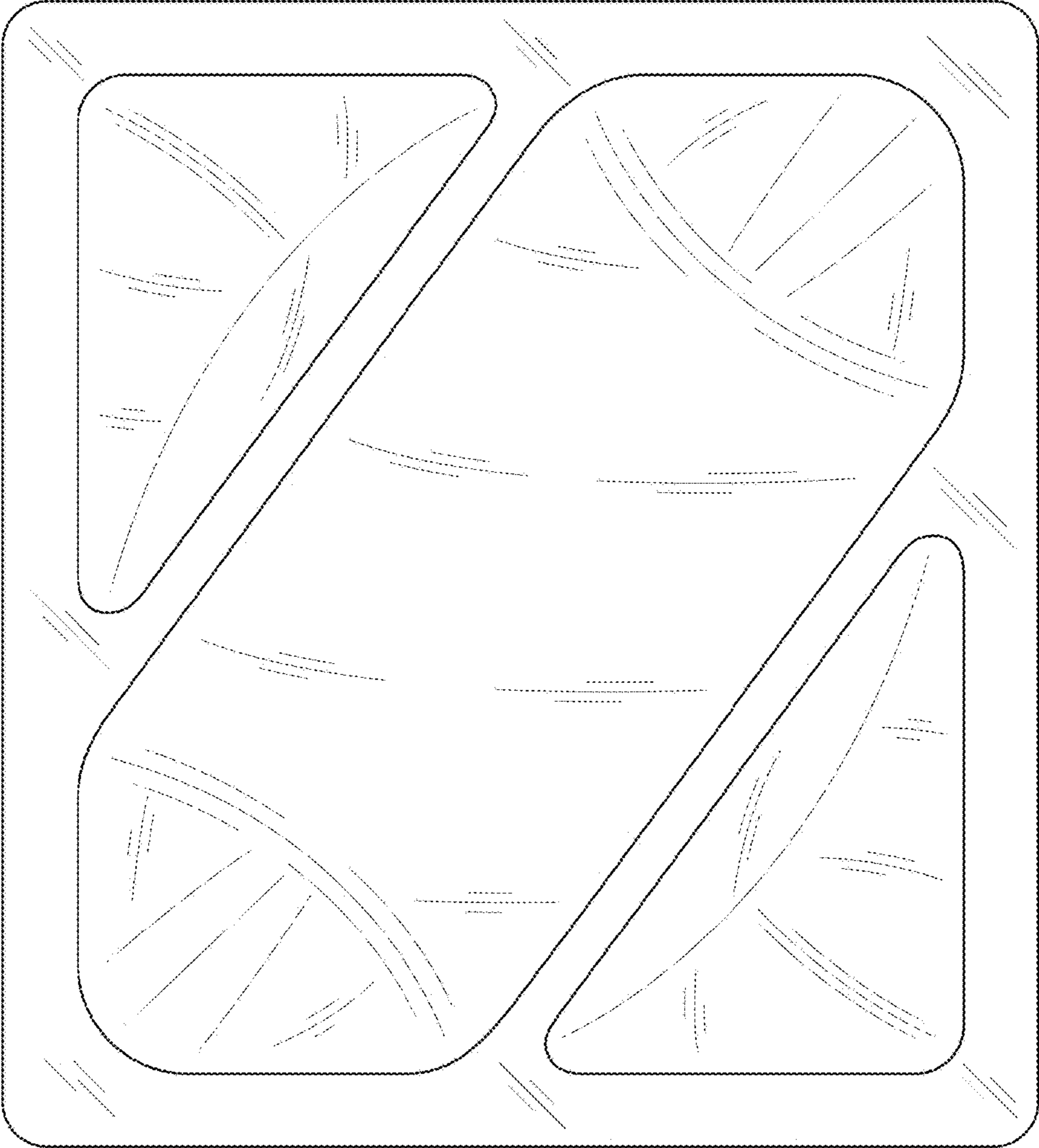

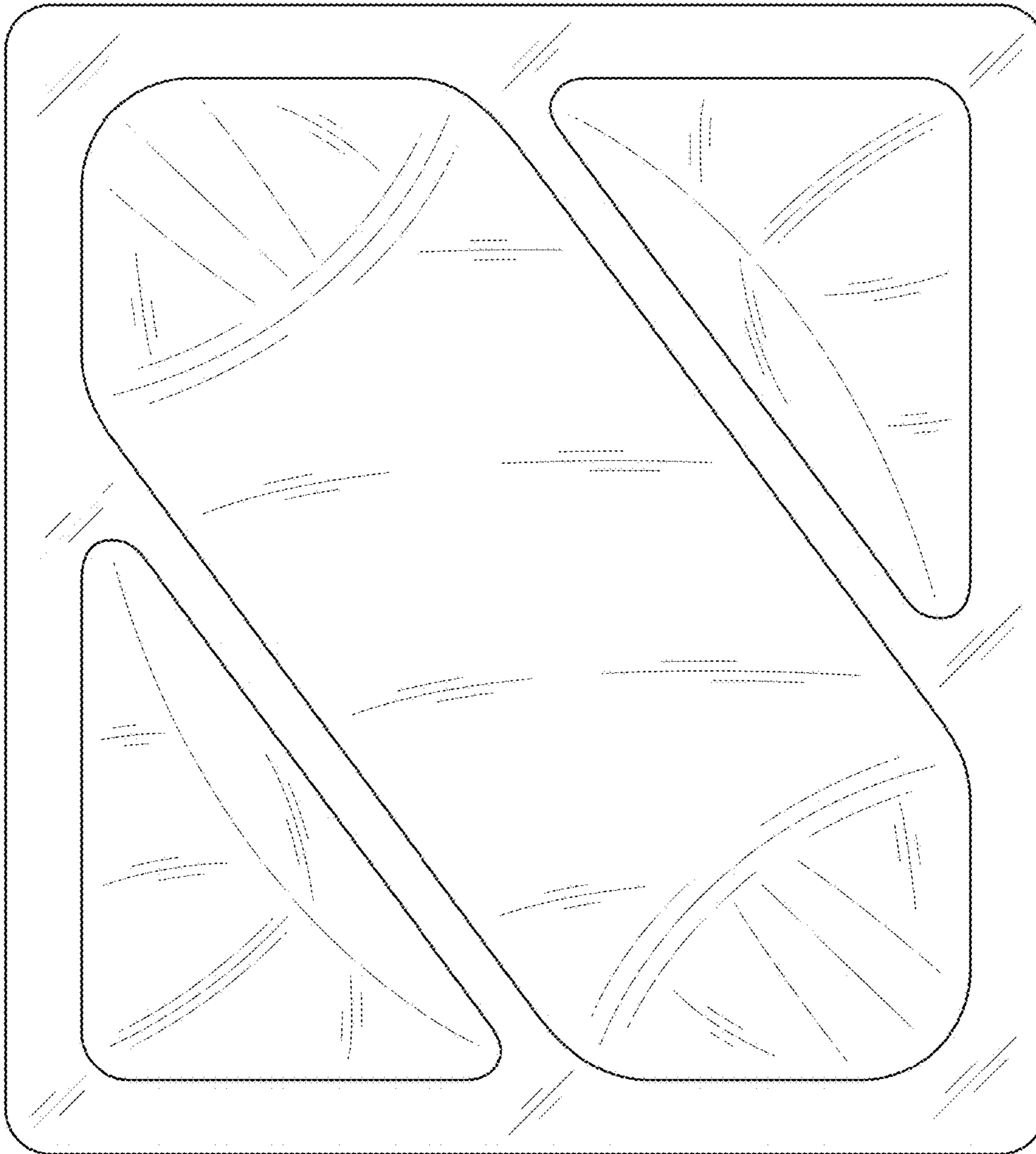
