DESCRIPTION

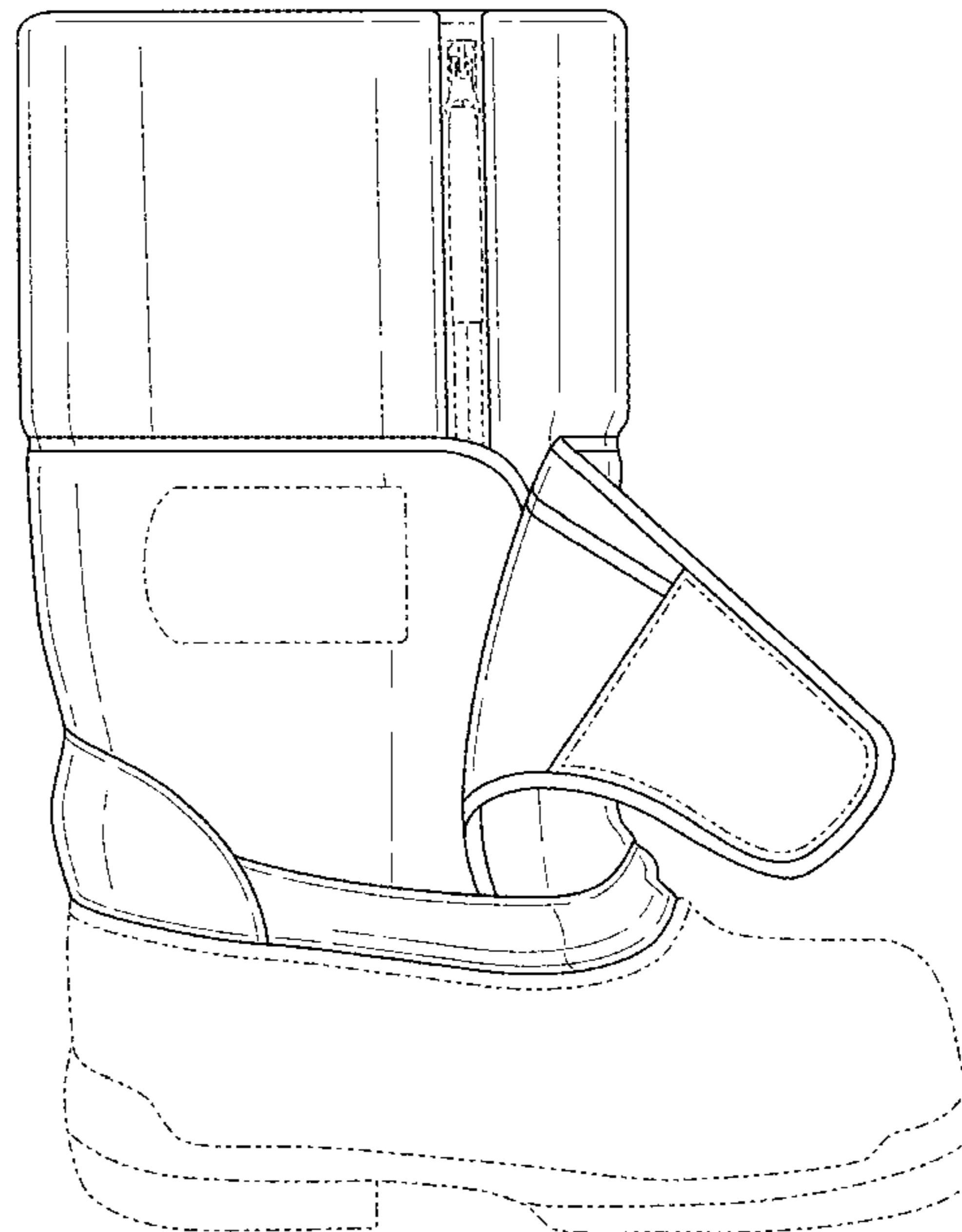
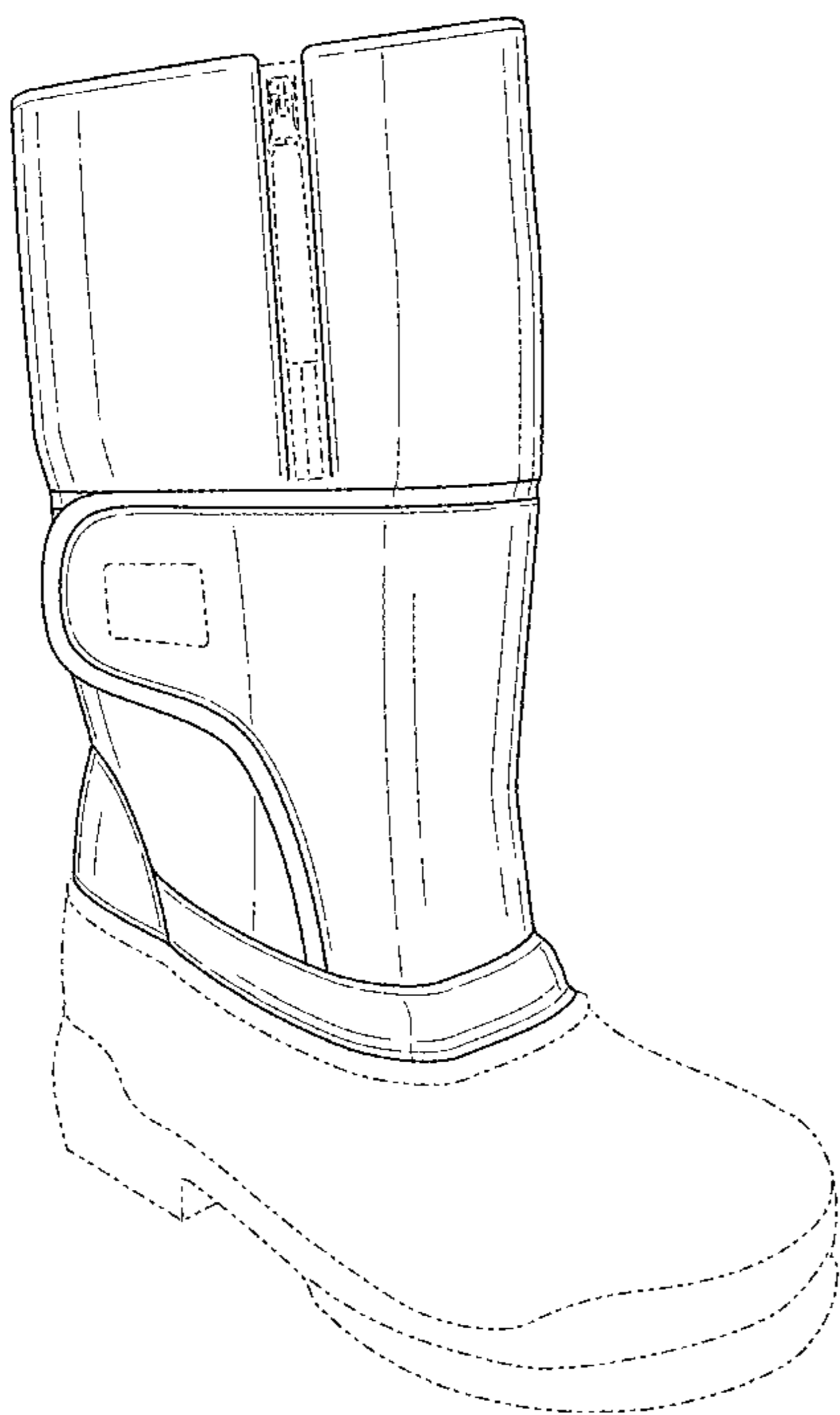
FIG. 1 is a front perspective view of a boot with a leg extension, showing the design;

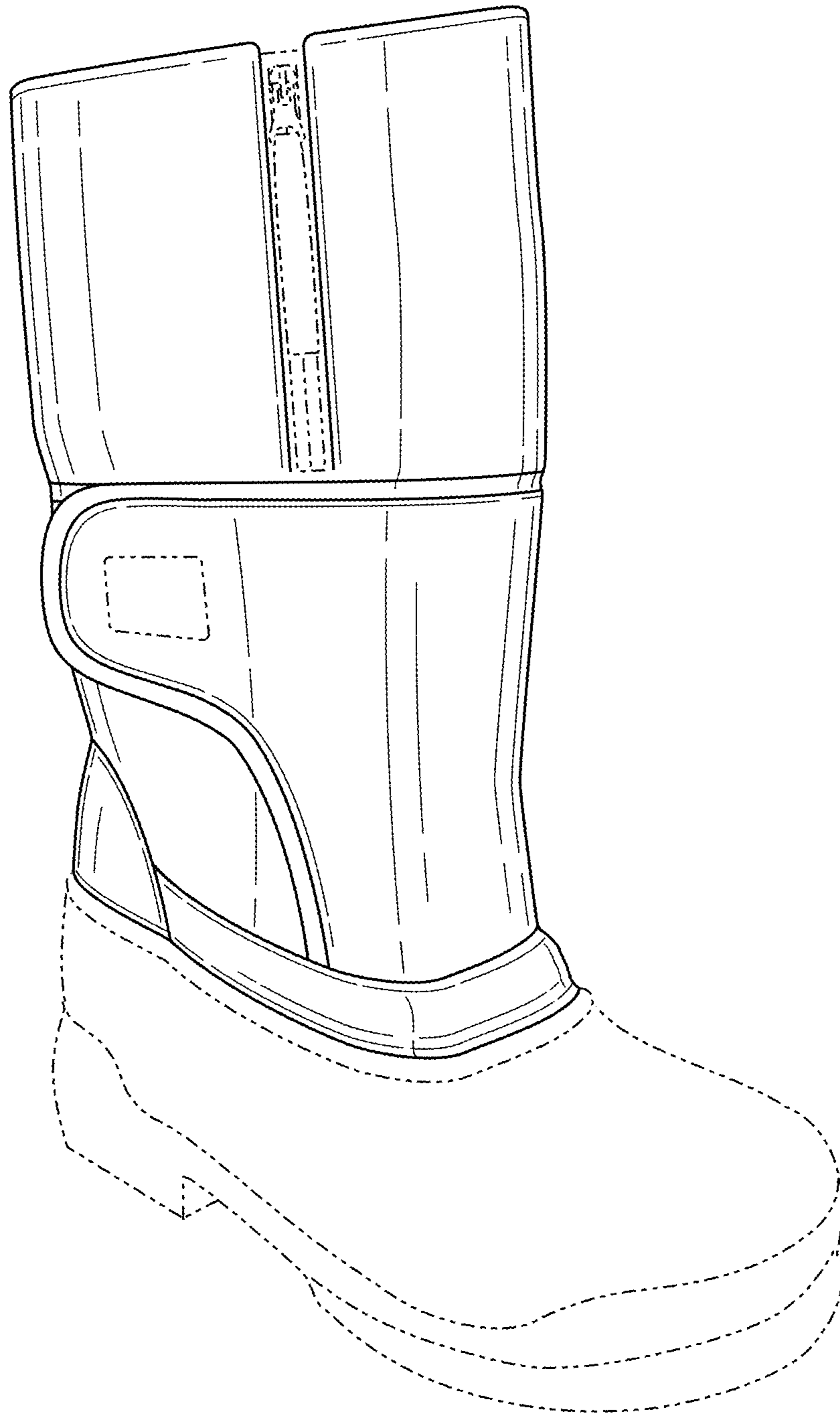

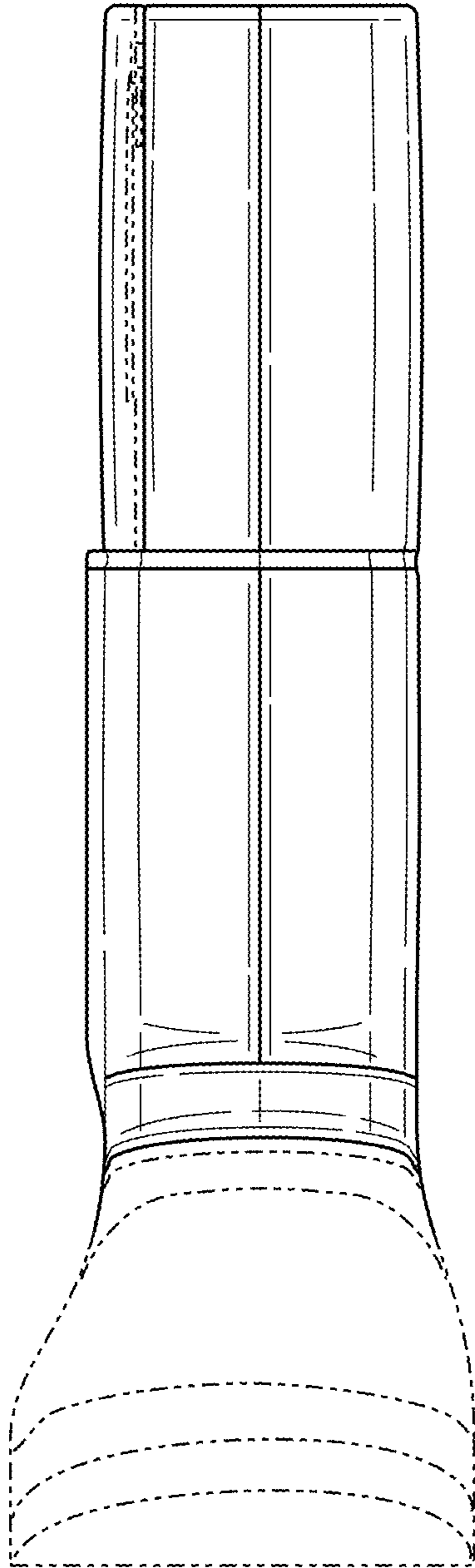

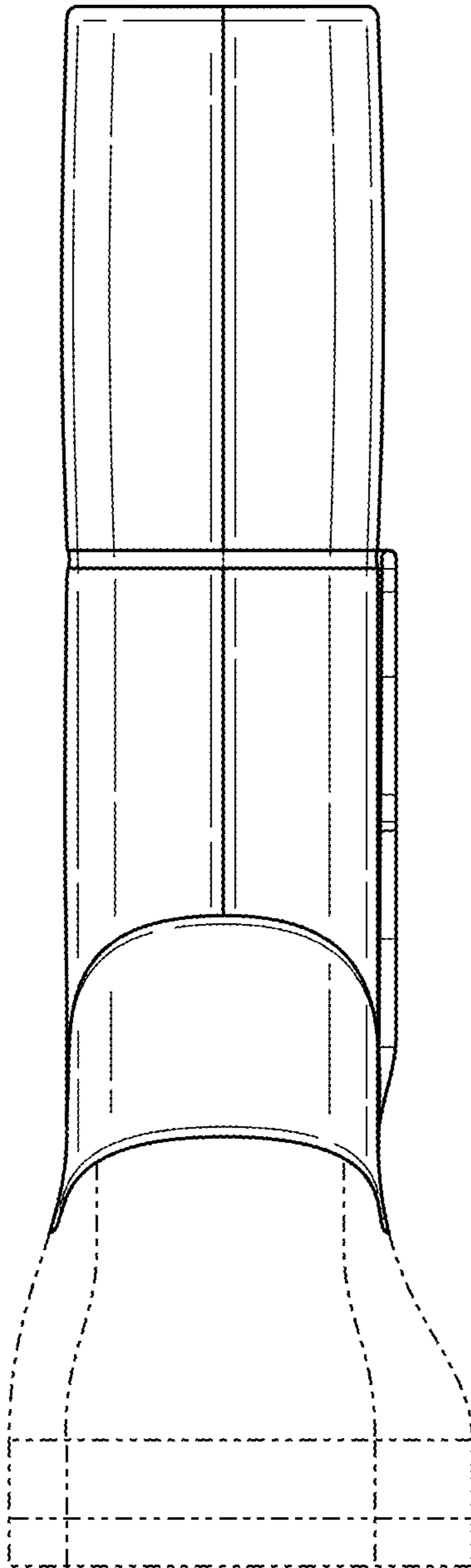

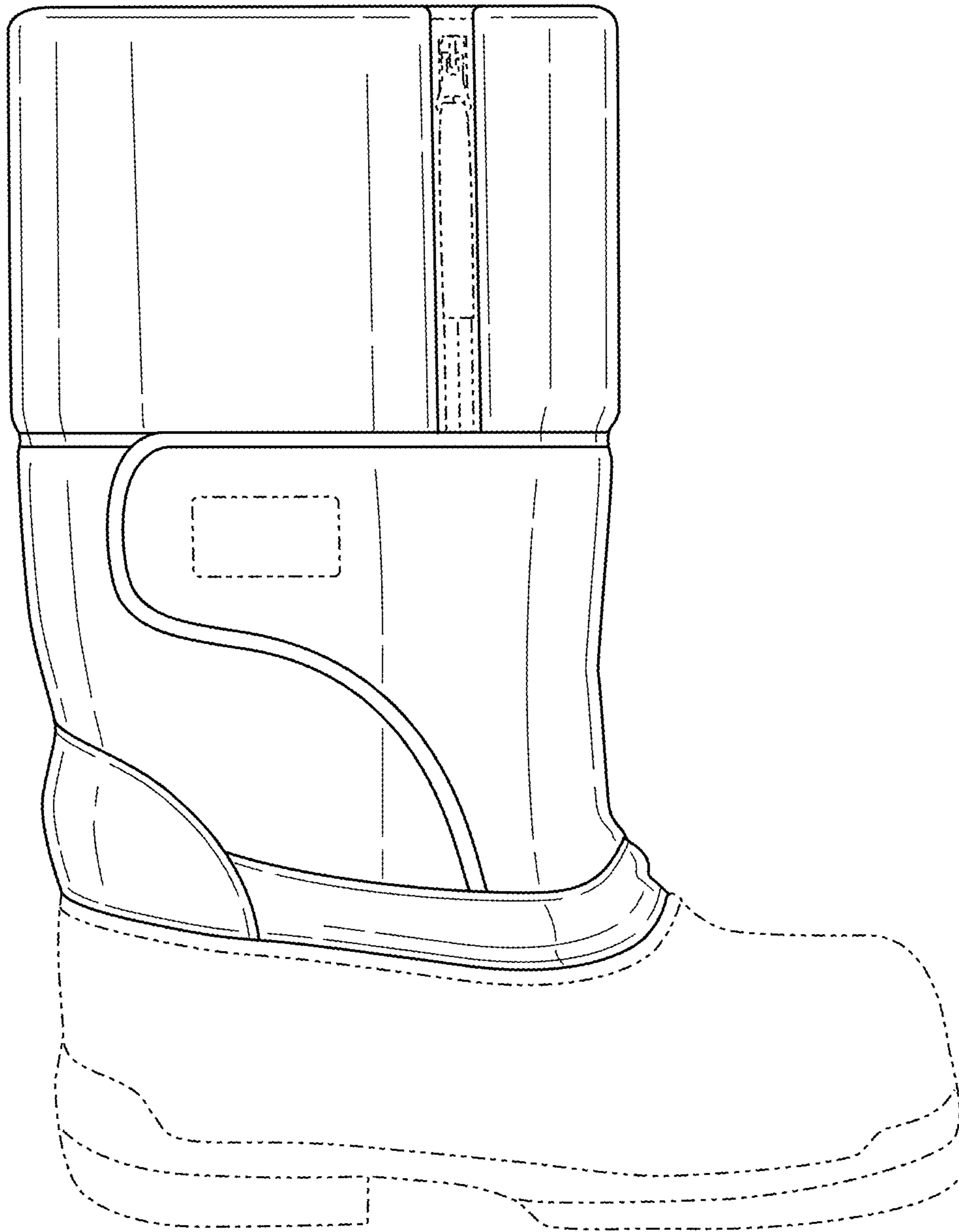

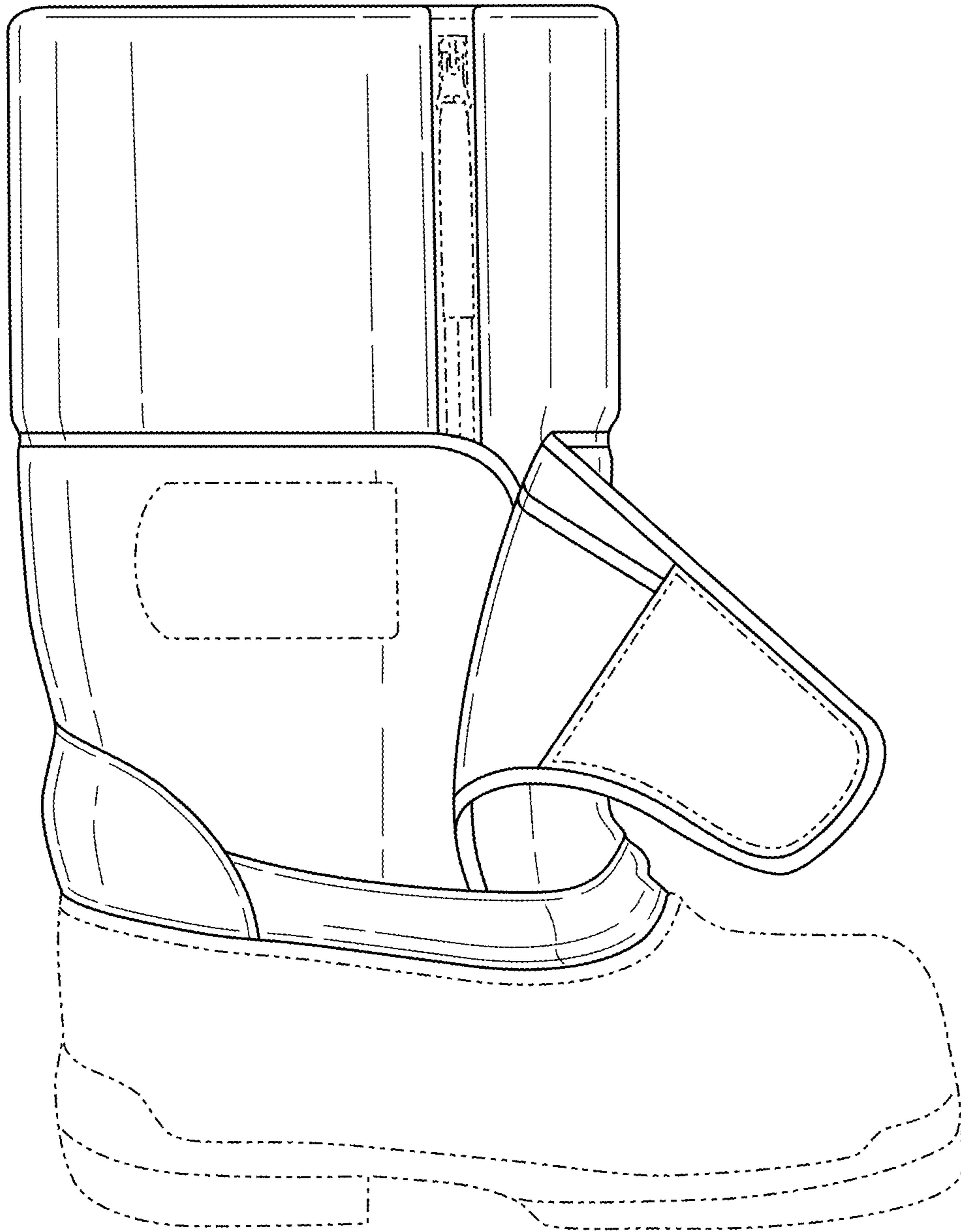

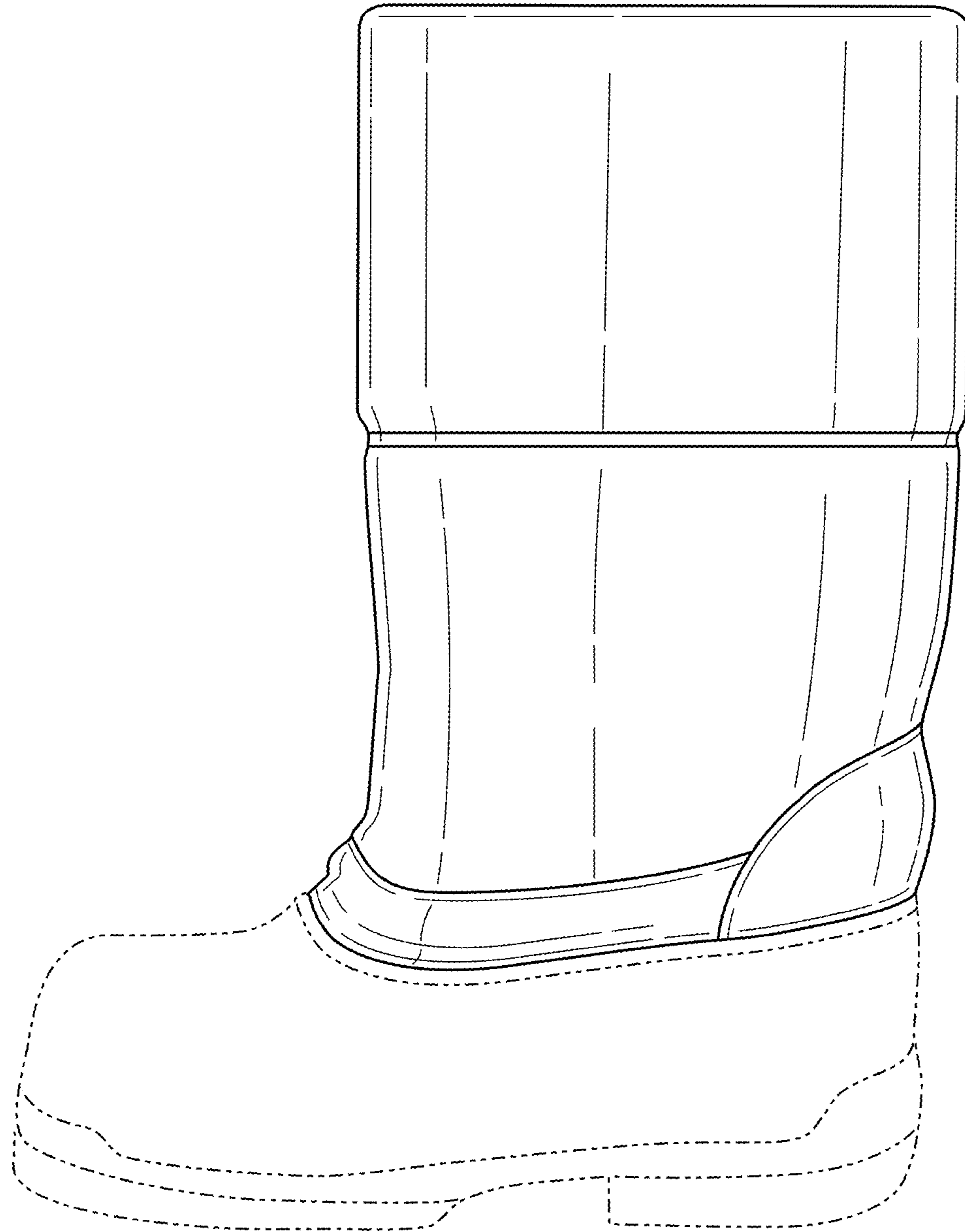

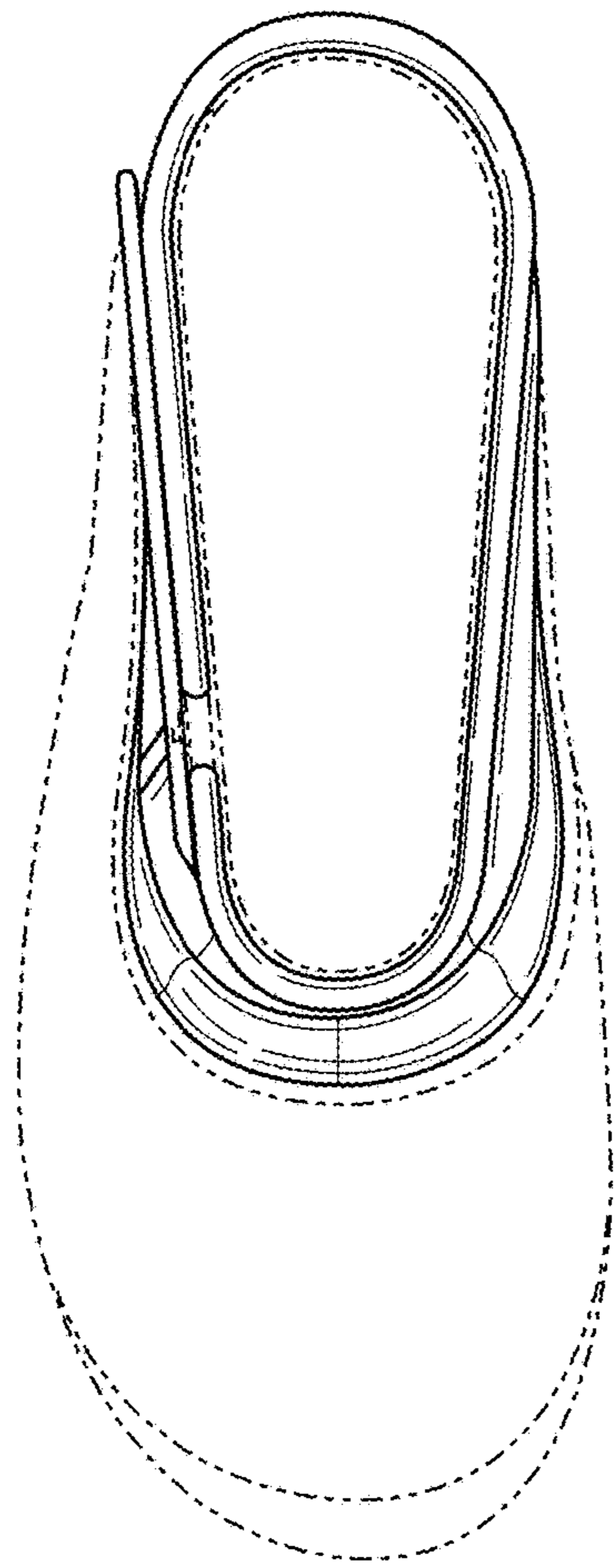

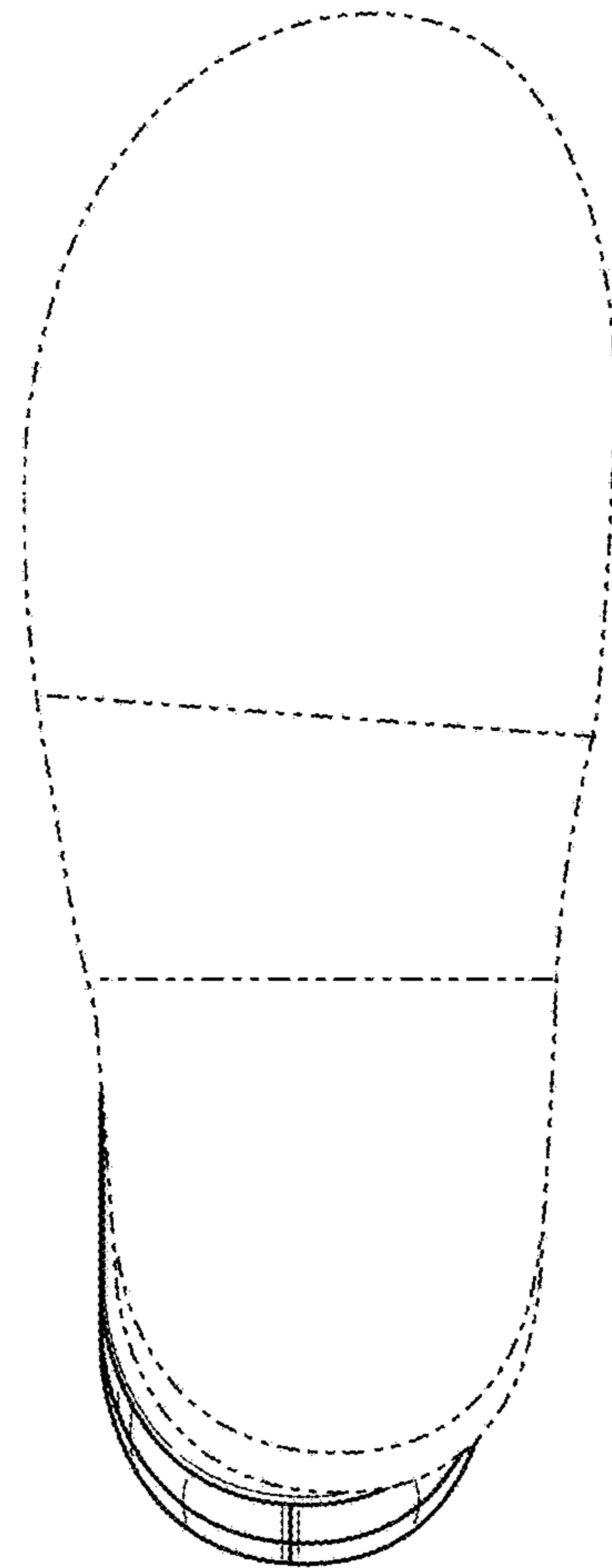
