DESCRIPTION

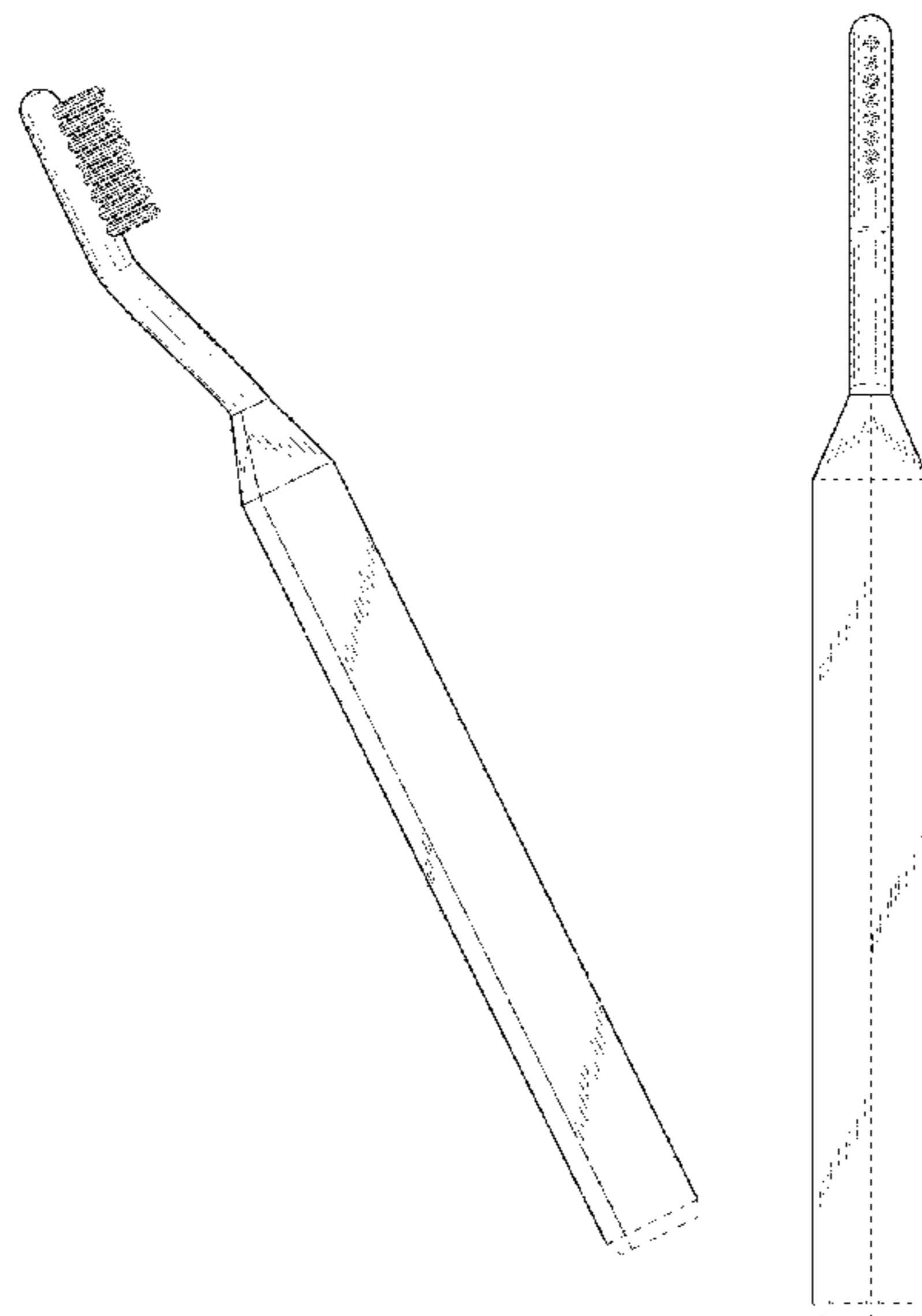
FIG. 1 is a top, left side, and front perspective view of a first embodiment of a toothbrush, showing my design;

FIG. 6 is a front and left side perspective view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

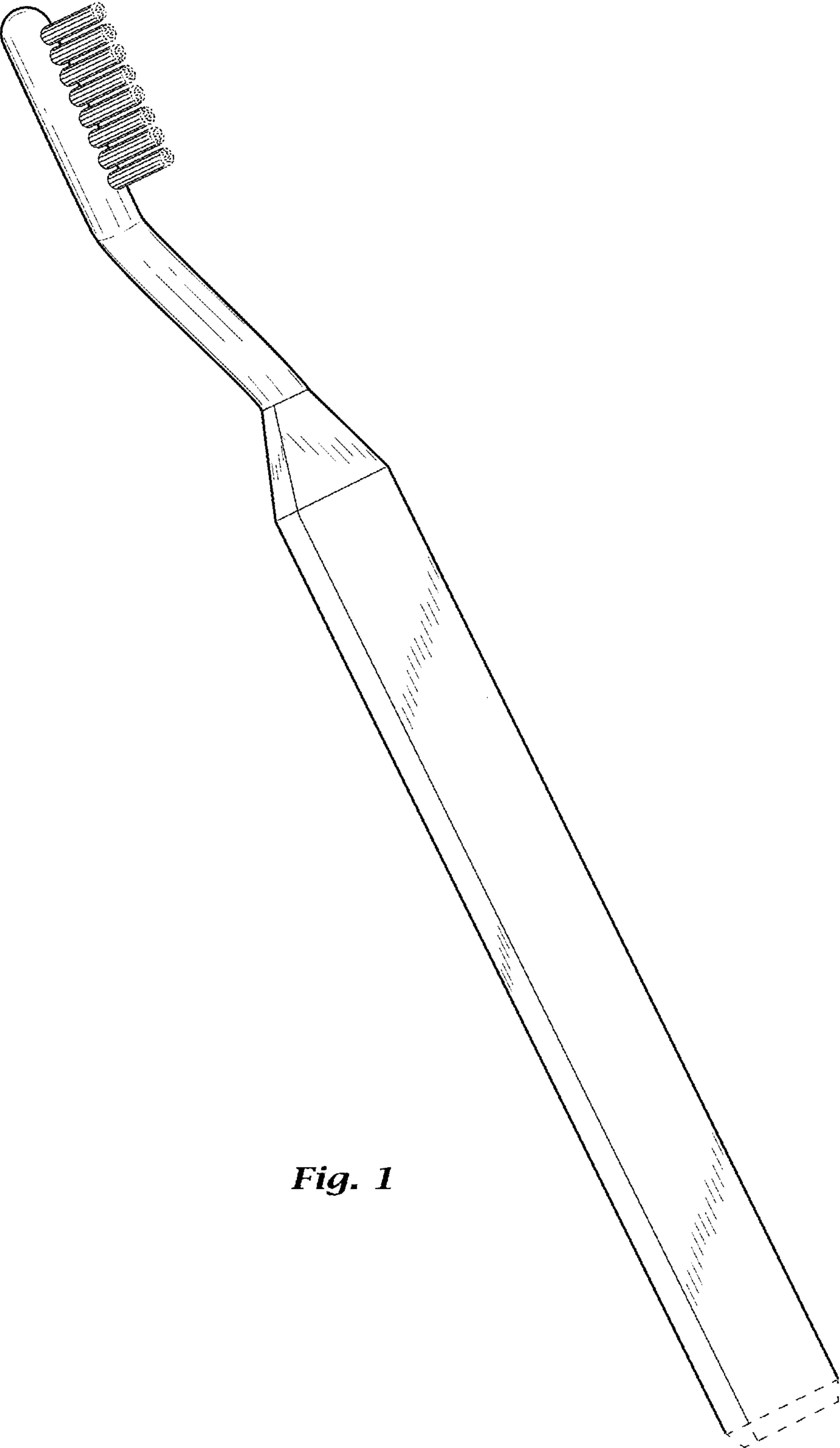

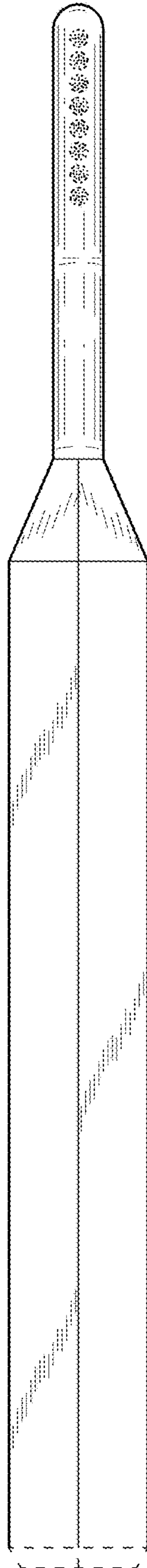

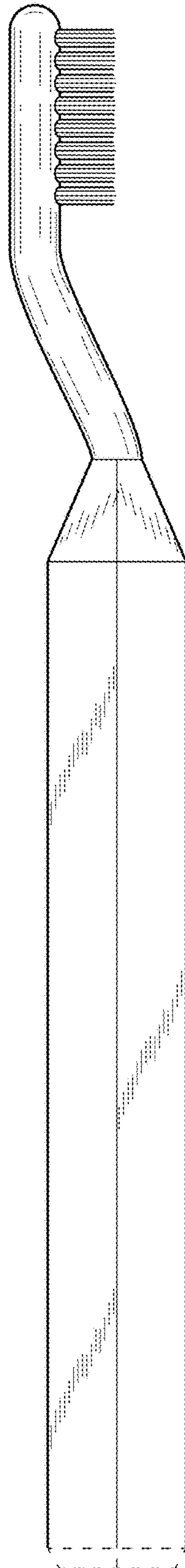

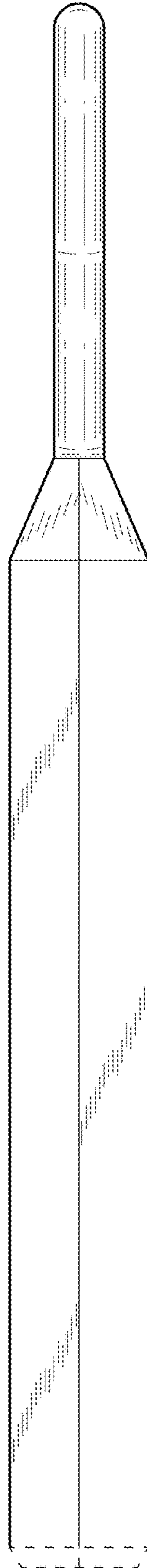

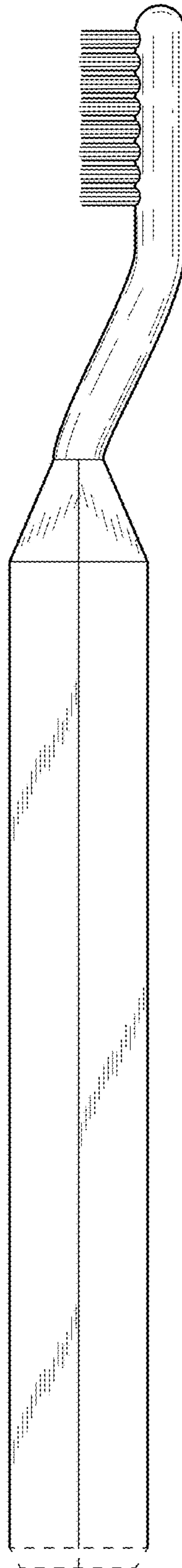

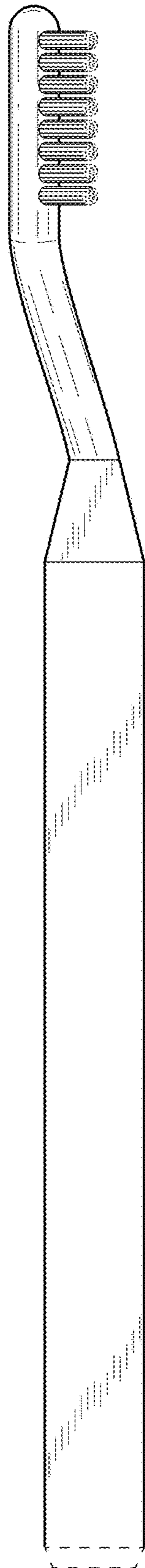

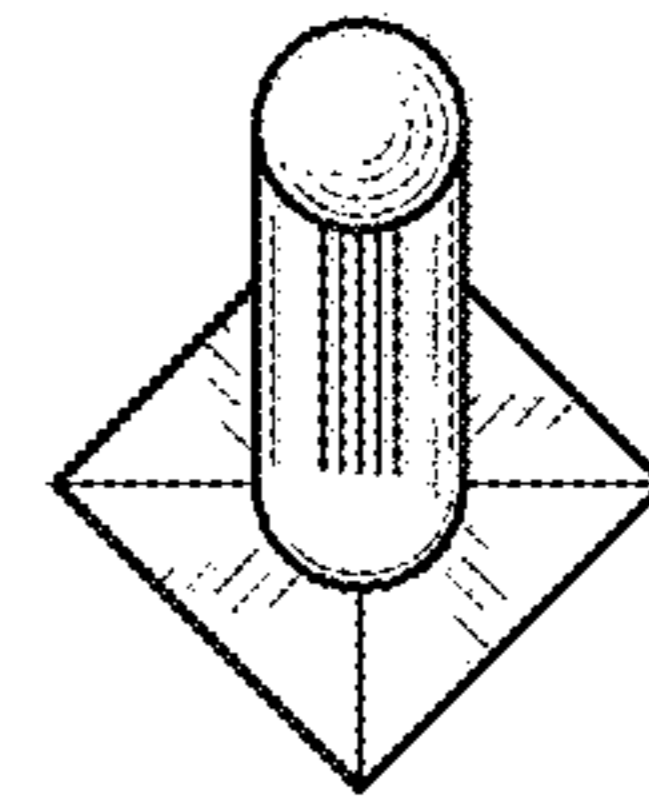

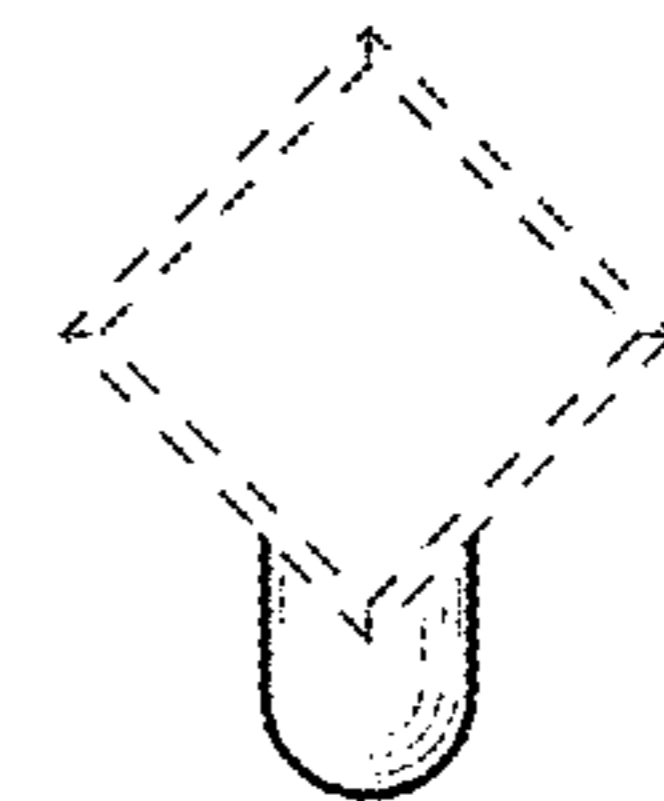
