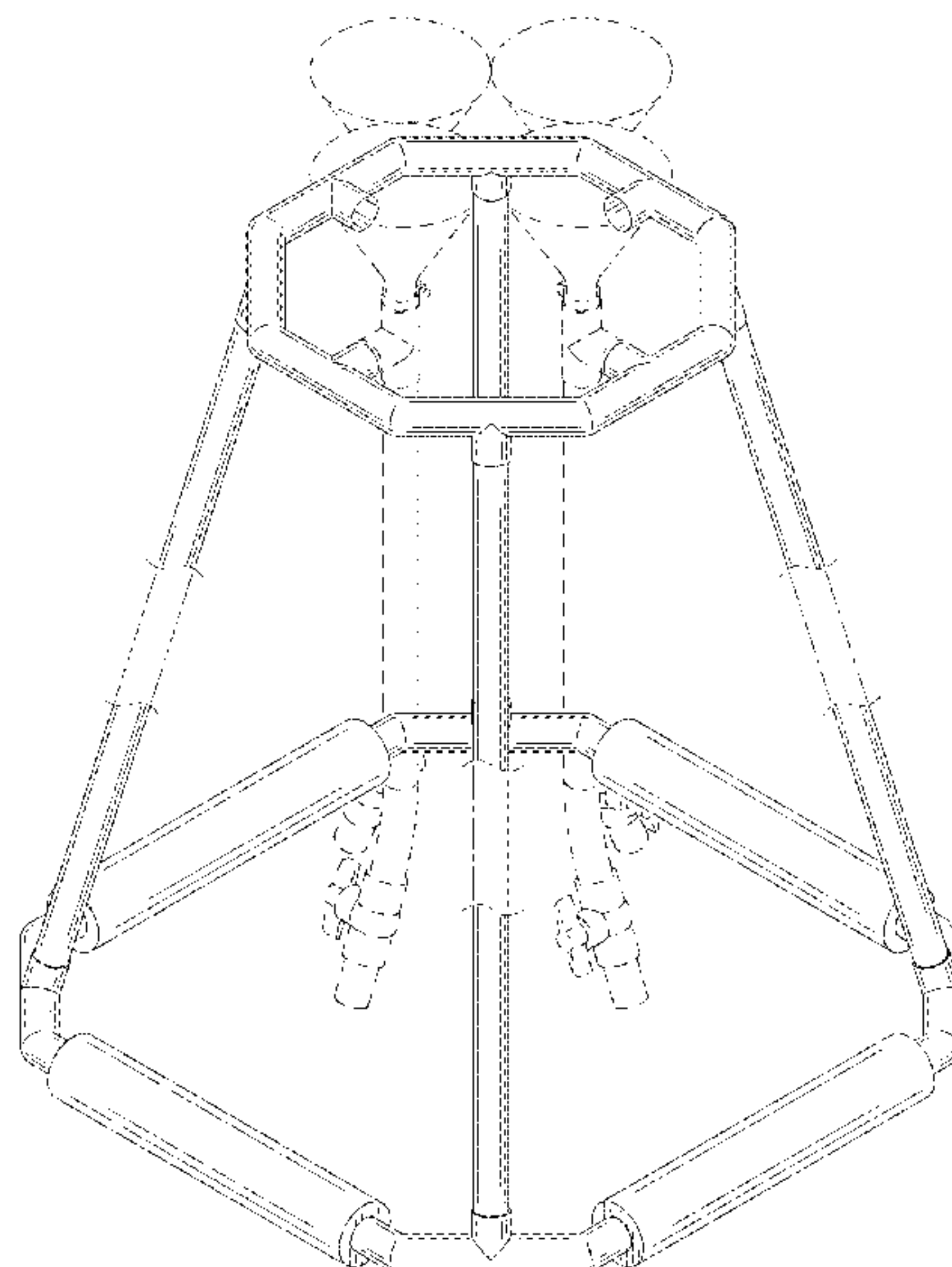
(57) **CLAIM**

The ornamental design for a floating fluid dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of the floating fluid dispenser showing our new design; FIG. 2 is a front elevation view of the floating fluid dispenser, with the rear, right, and left elevation views being a mirror image thereof; FIG. 3 is a top plan view thereof; and, FIG. 4 is a bottom plan view thereof. The broken lines shown in the drawings illustrate portions of the floating fluid dispenser that form no part of the claimed design. The floating fluid dispenser is shown with a symbolic break in its height. The appearance of any portion of the article between the break lines forms no part of the claimed design.

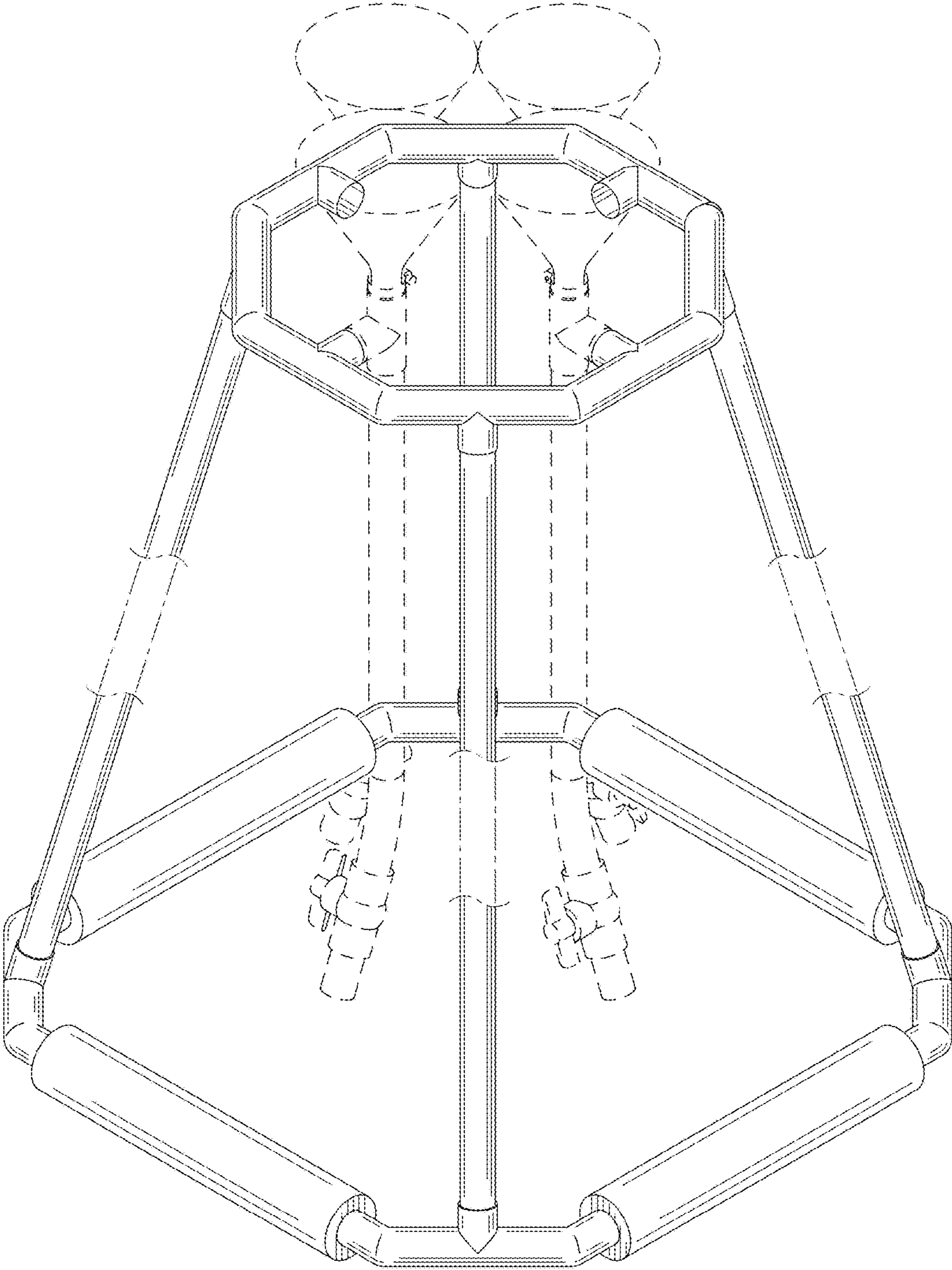

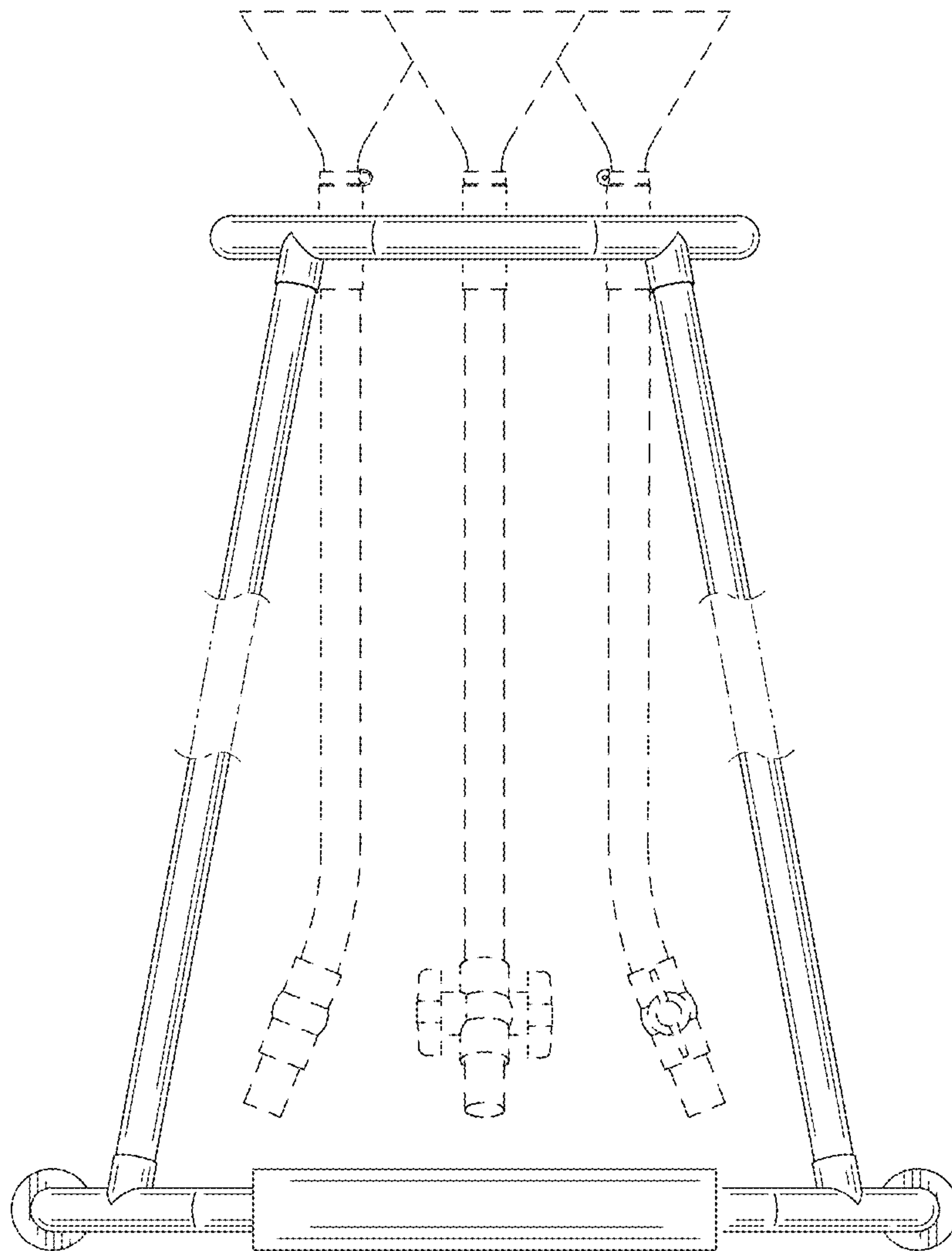

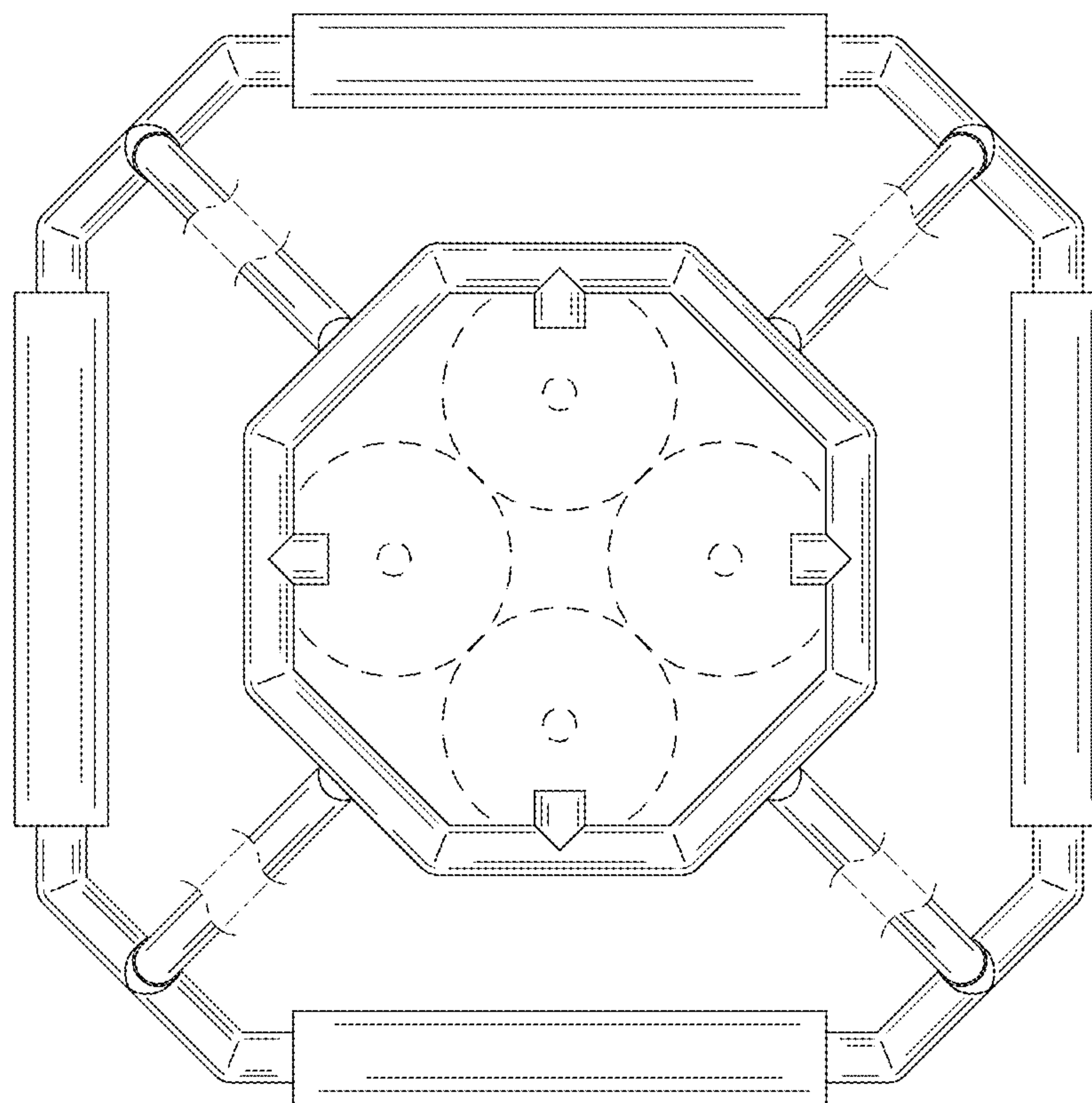

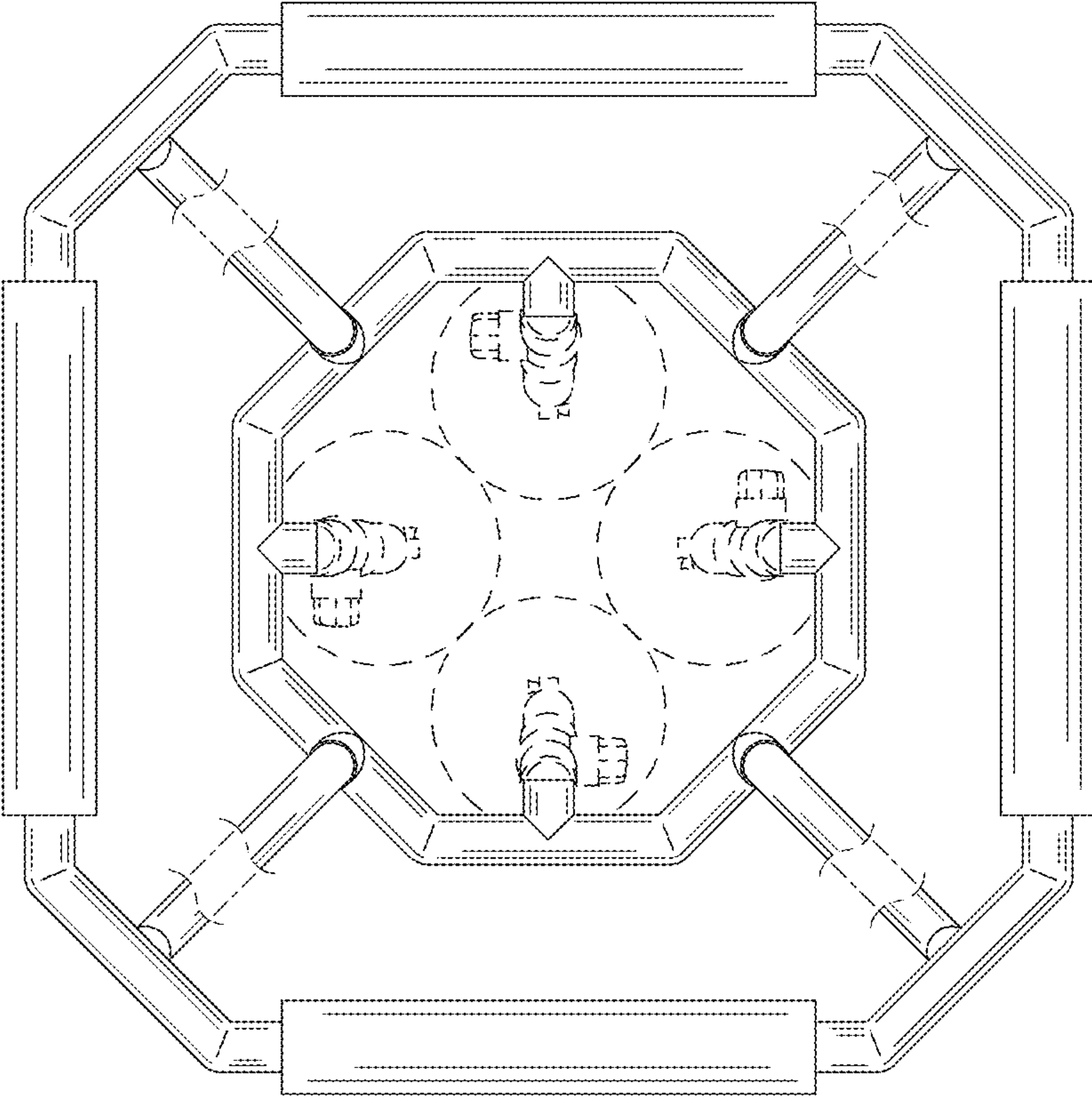
