(57) **CLAIM**

The ornamental design for a cutting element, as shown and described.

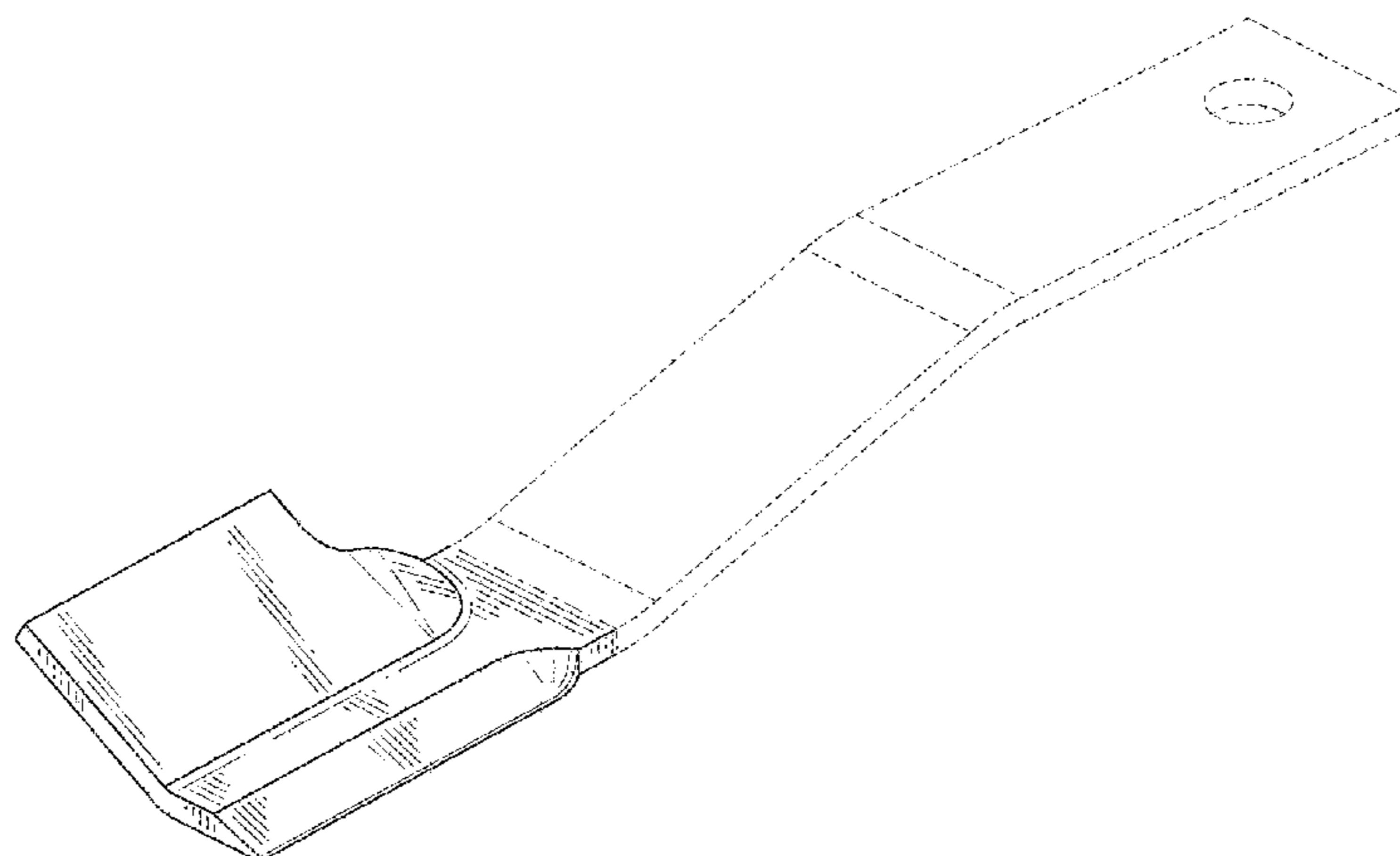
**DESCRIPTION**

FIG. 1 is a left, front, top perspective view of a cutting element according to our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left end view thereof; FIG. 5 is a right end view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The dot-dash line representations in the figures define boundary lines, and the dash line representations in the figures illustrate example environment. The boundary and environmental representations form no part of the claimed design.

The nature of the article is a cutting element, which may take the form of a rotary blade for use in powered agriculture and turf mowing equipment.

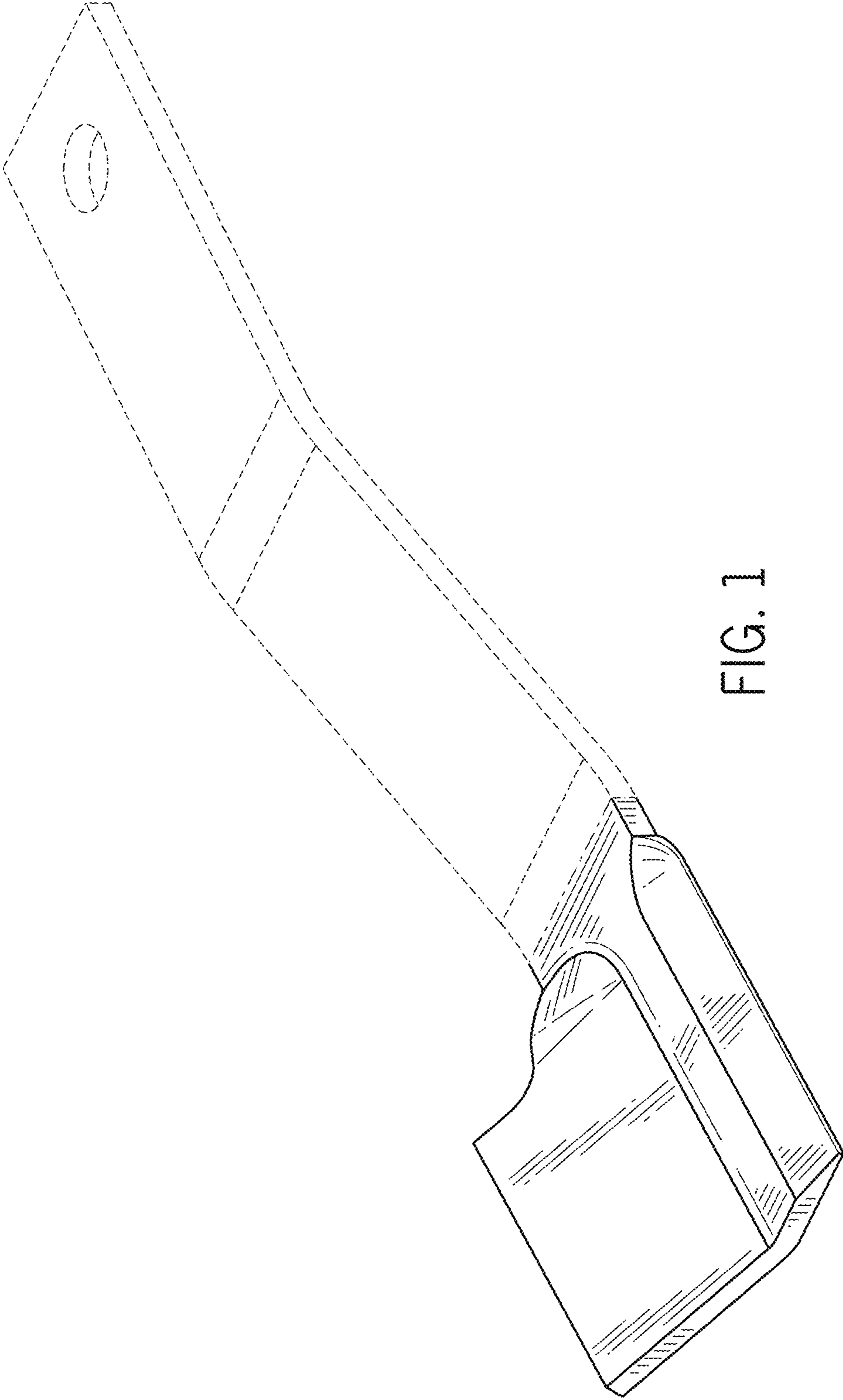

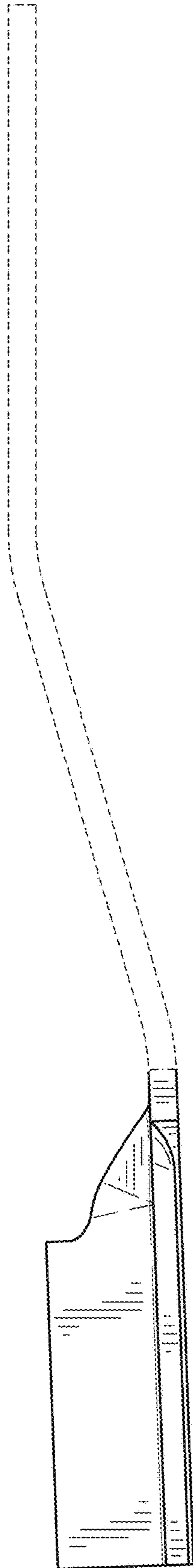

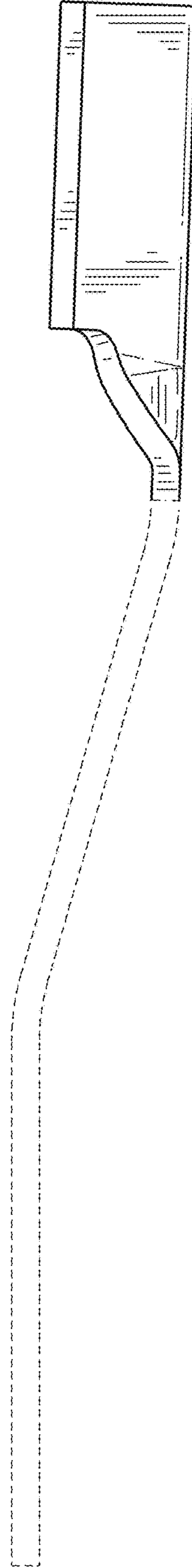

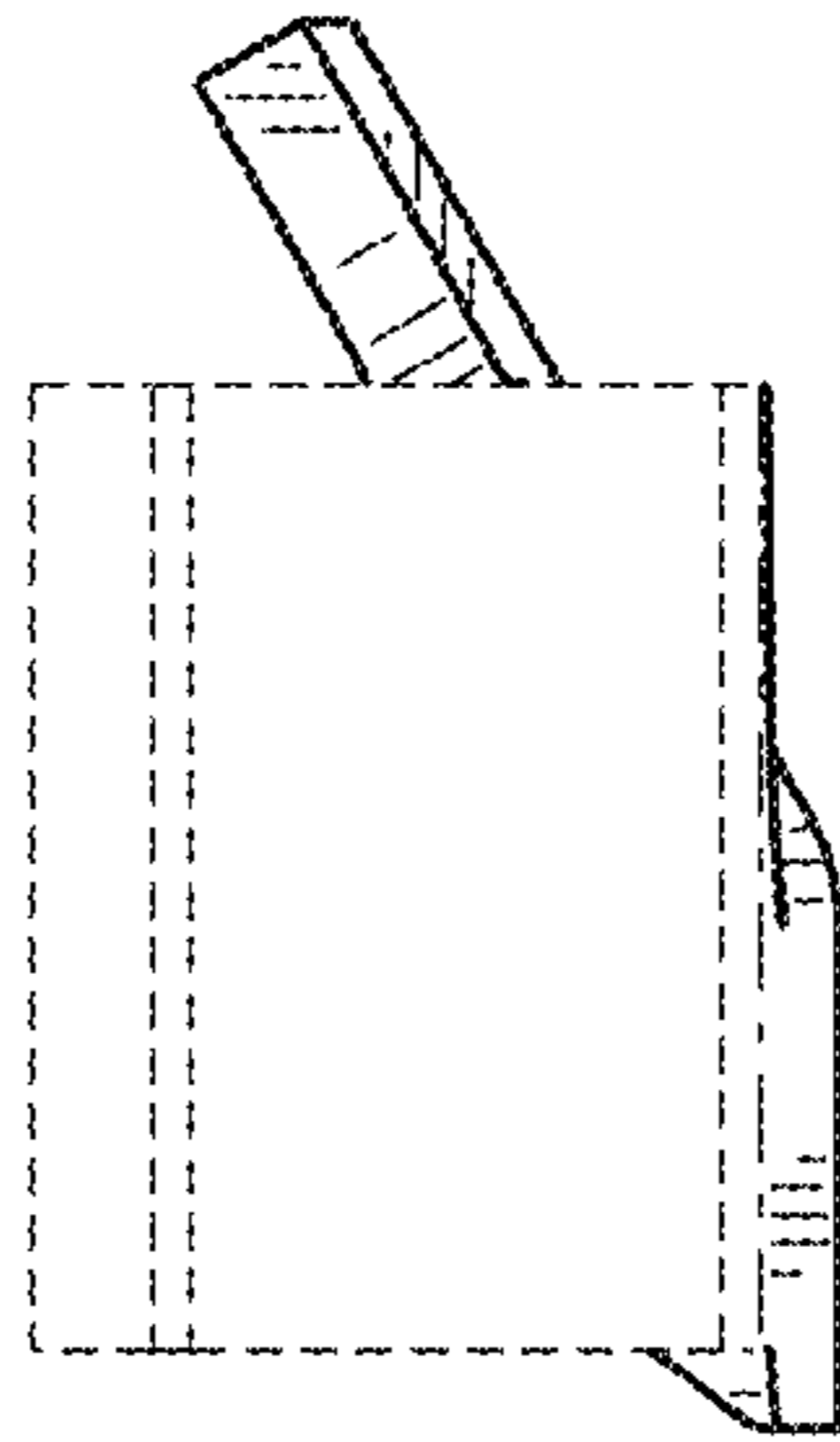

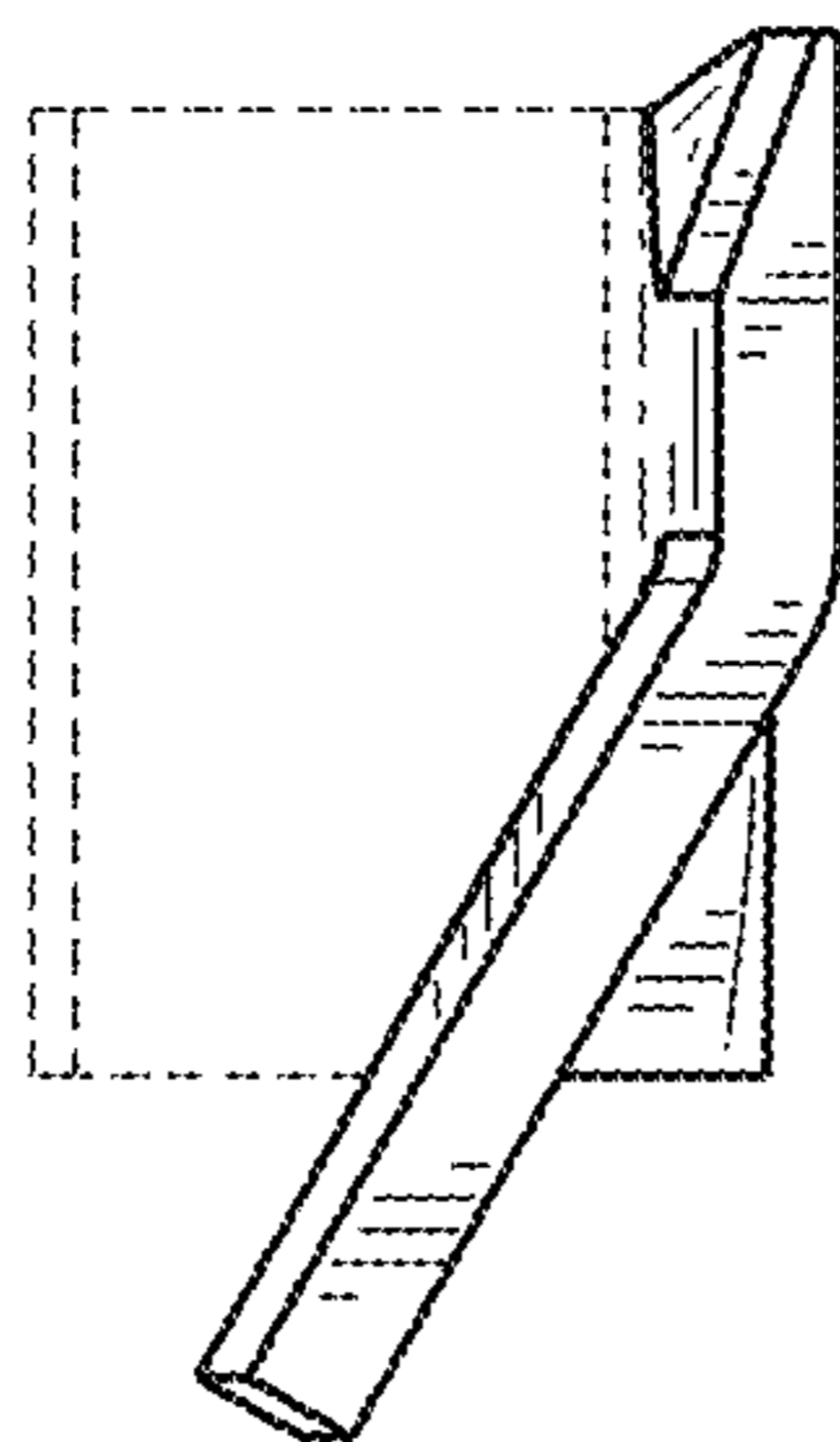

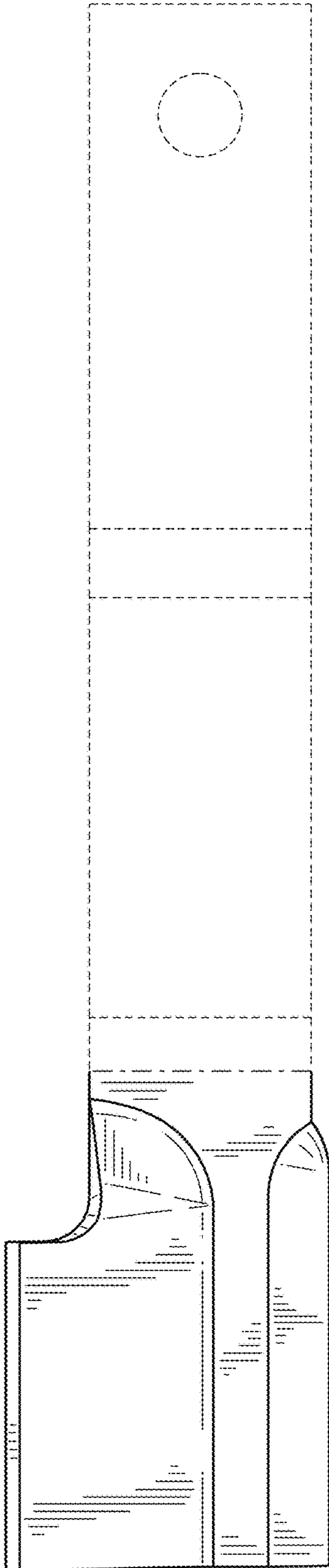

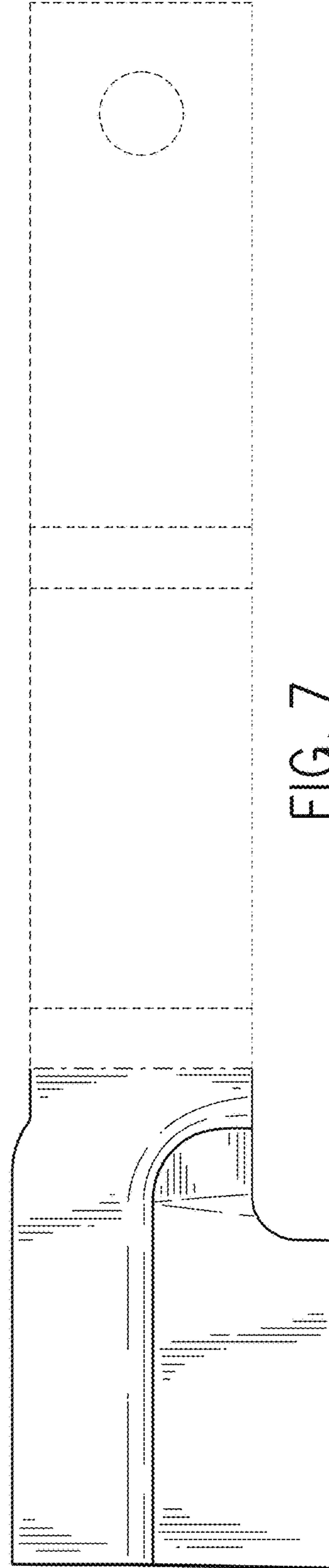
