(57) **CLAIM**

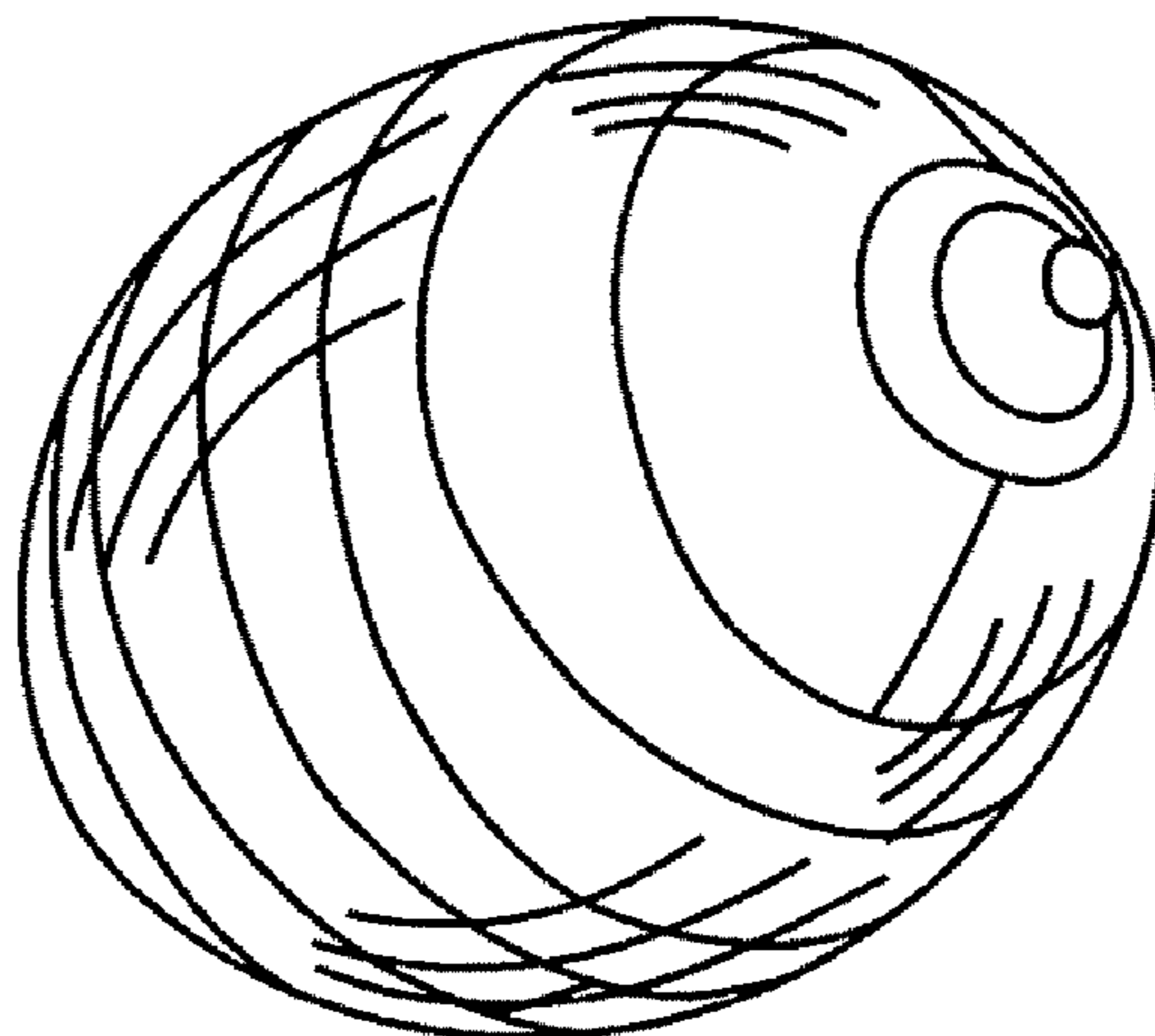
The ornamental design for a packaging for beauty product, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a packaging for beauty product showing my new design;

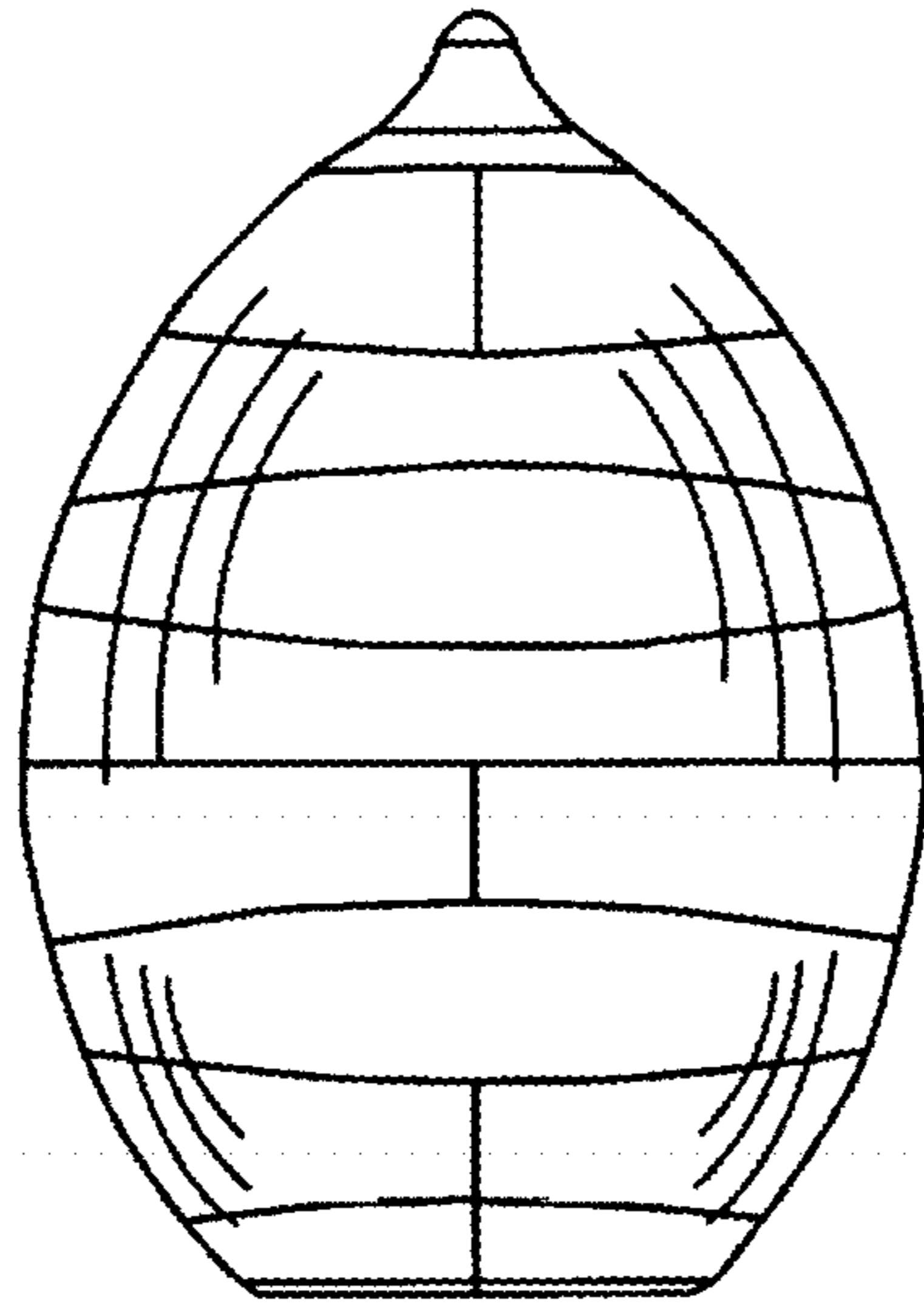

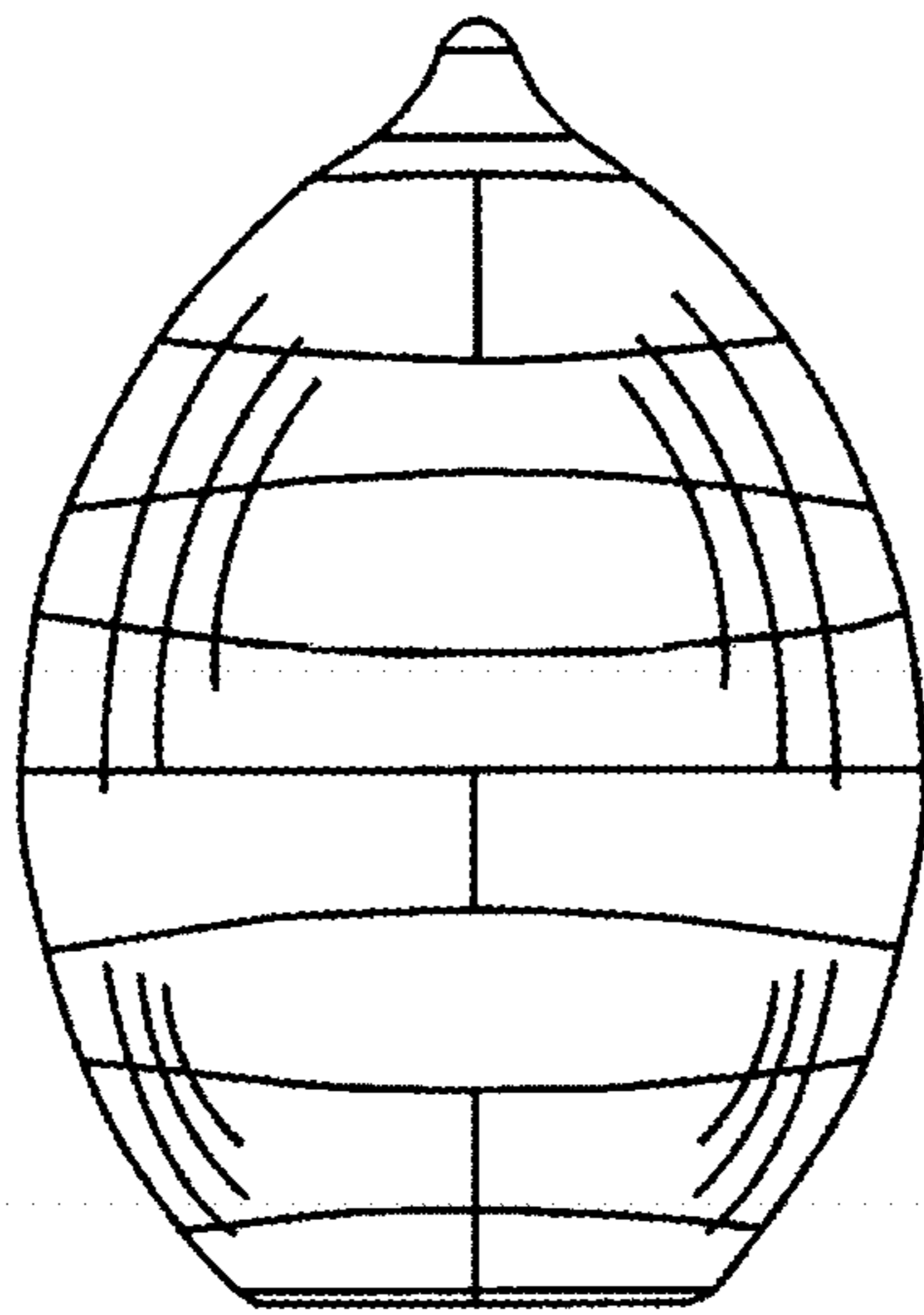

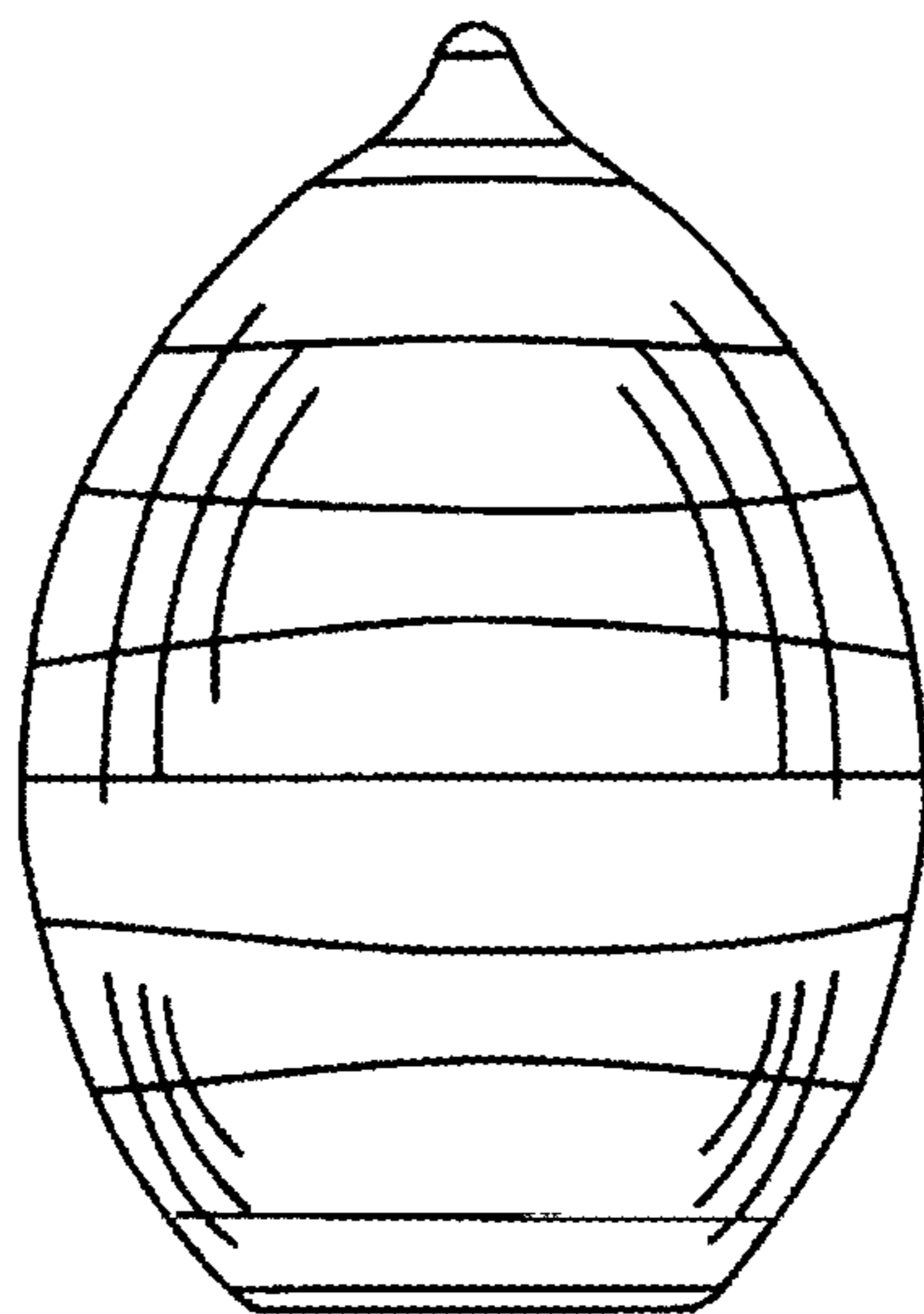

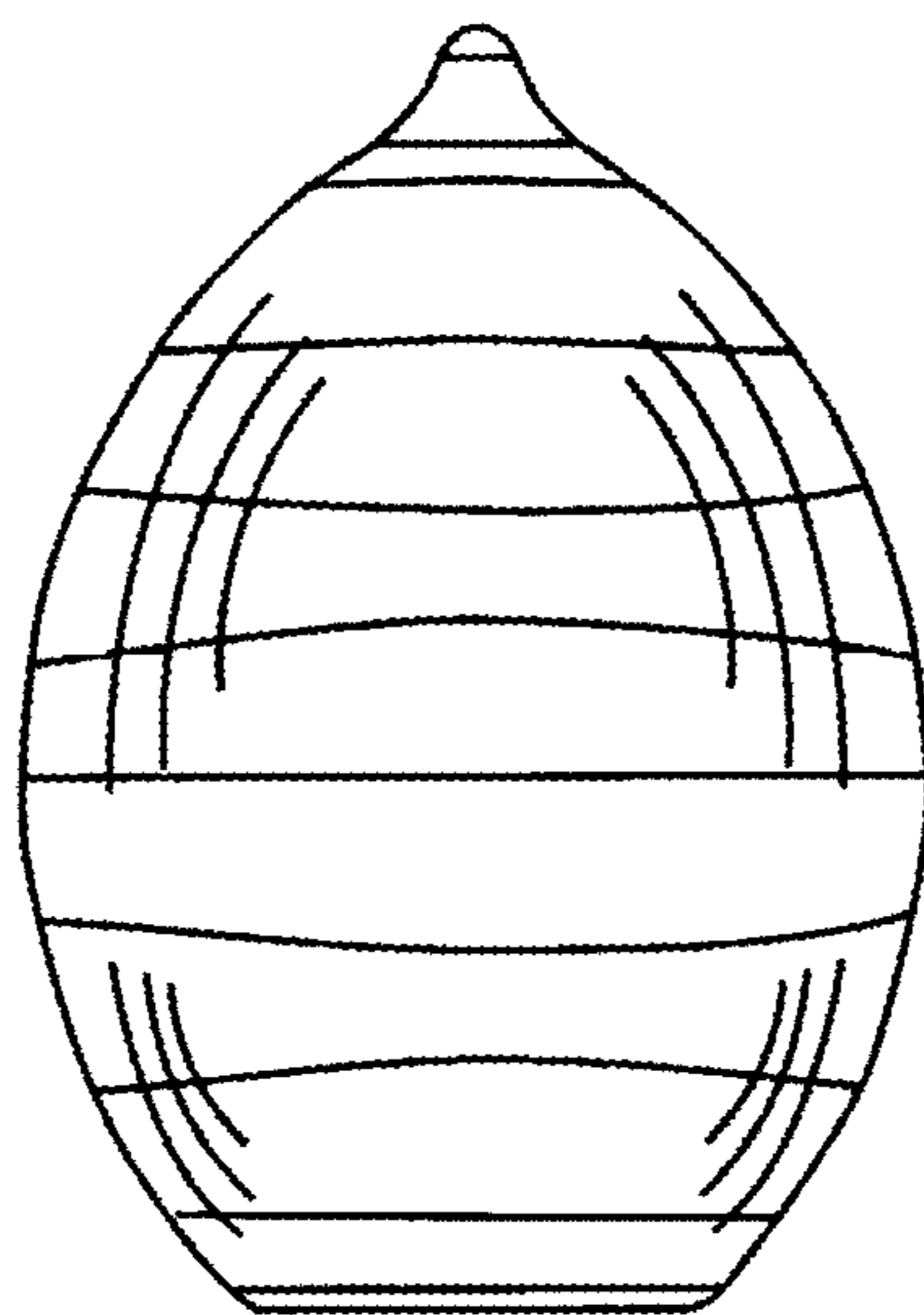

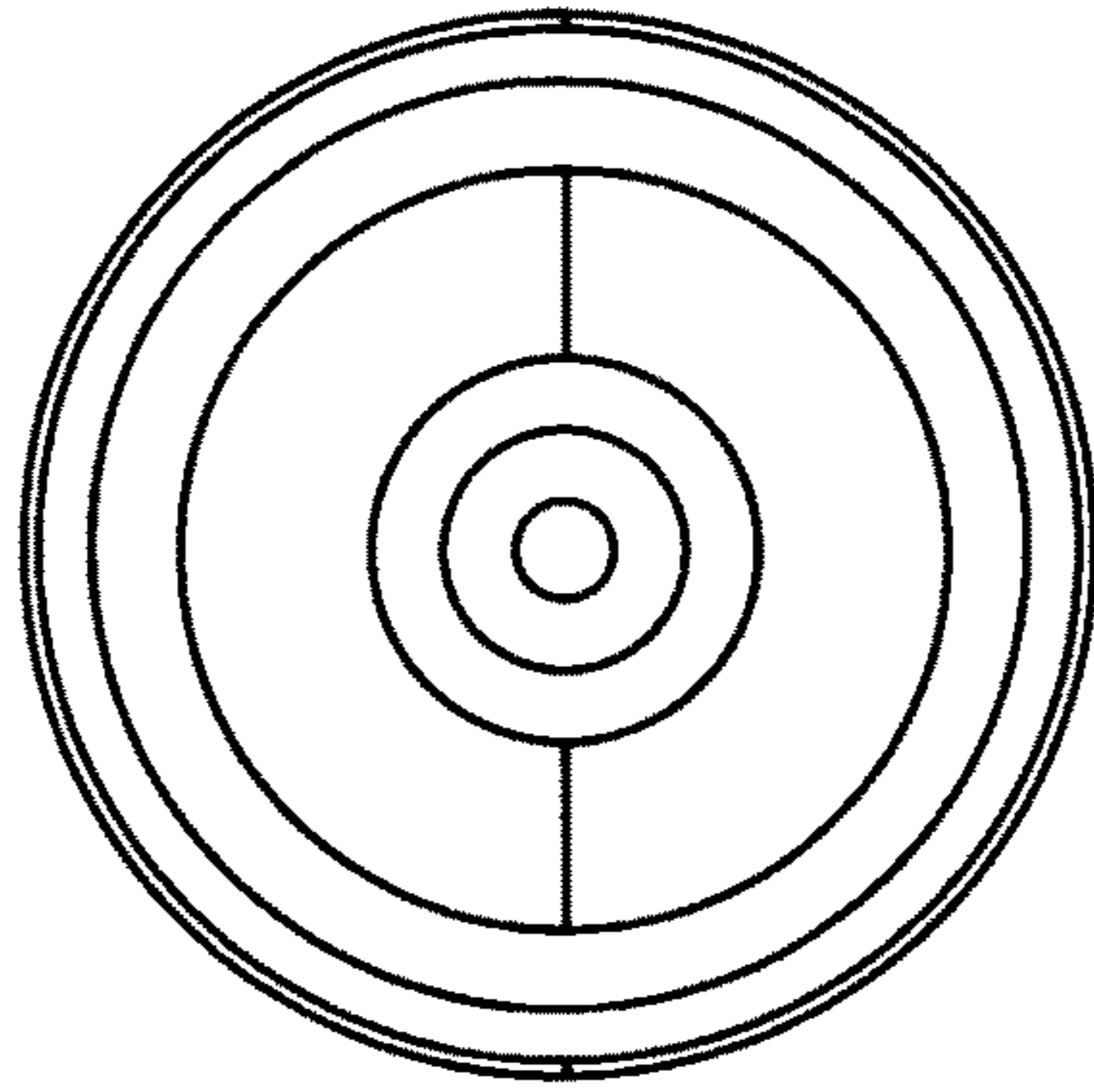

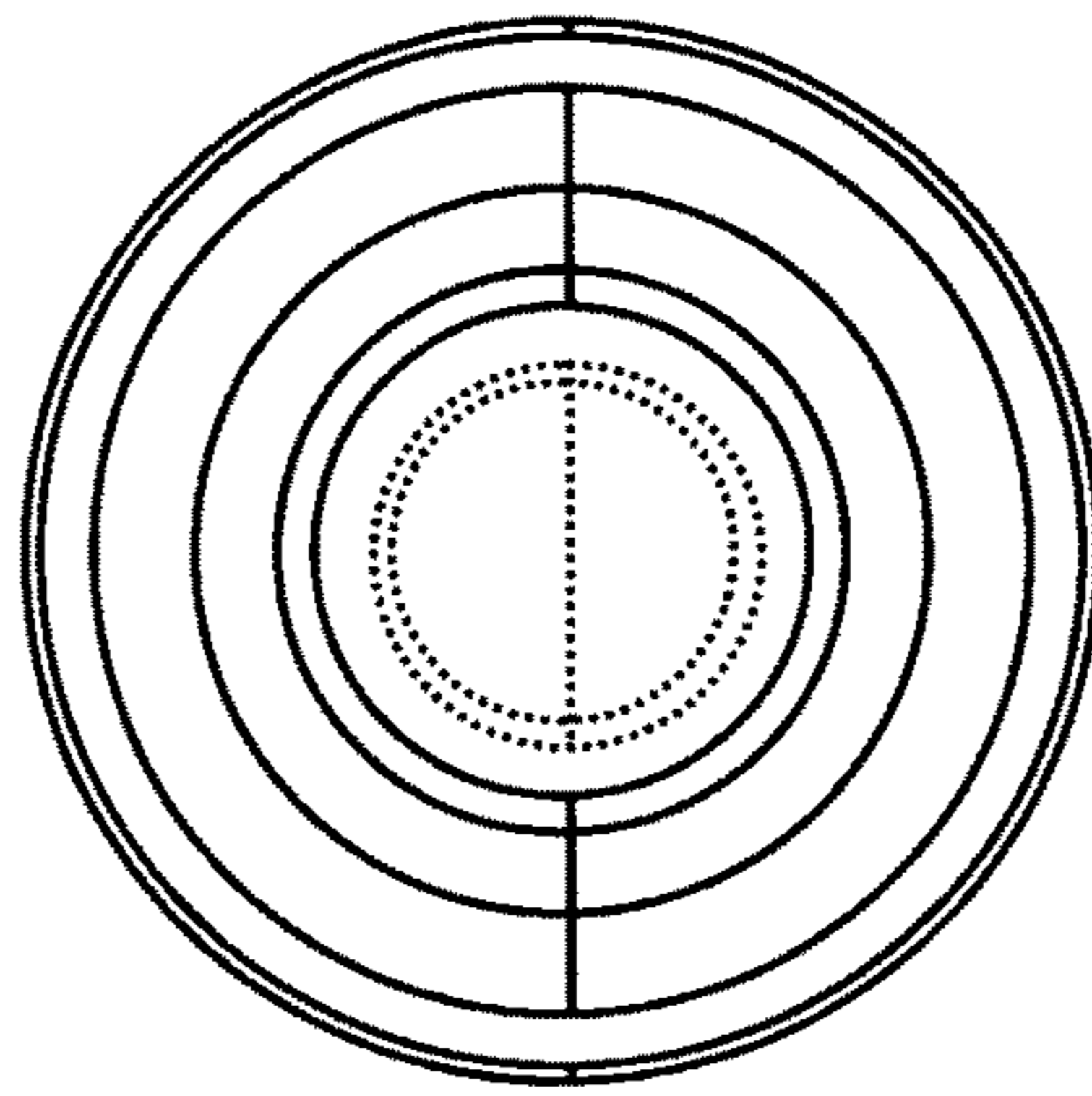

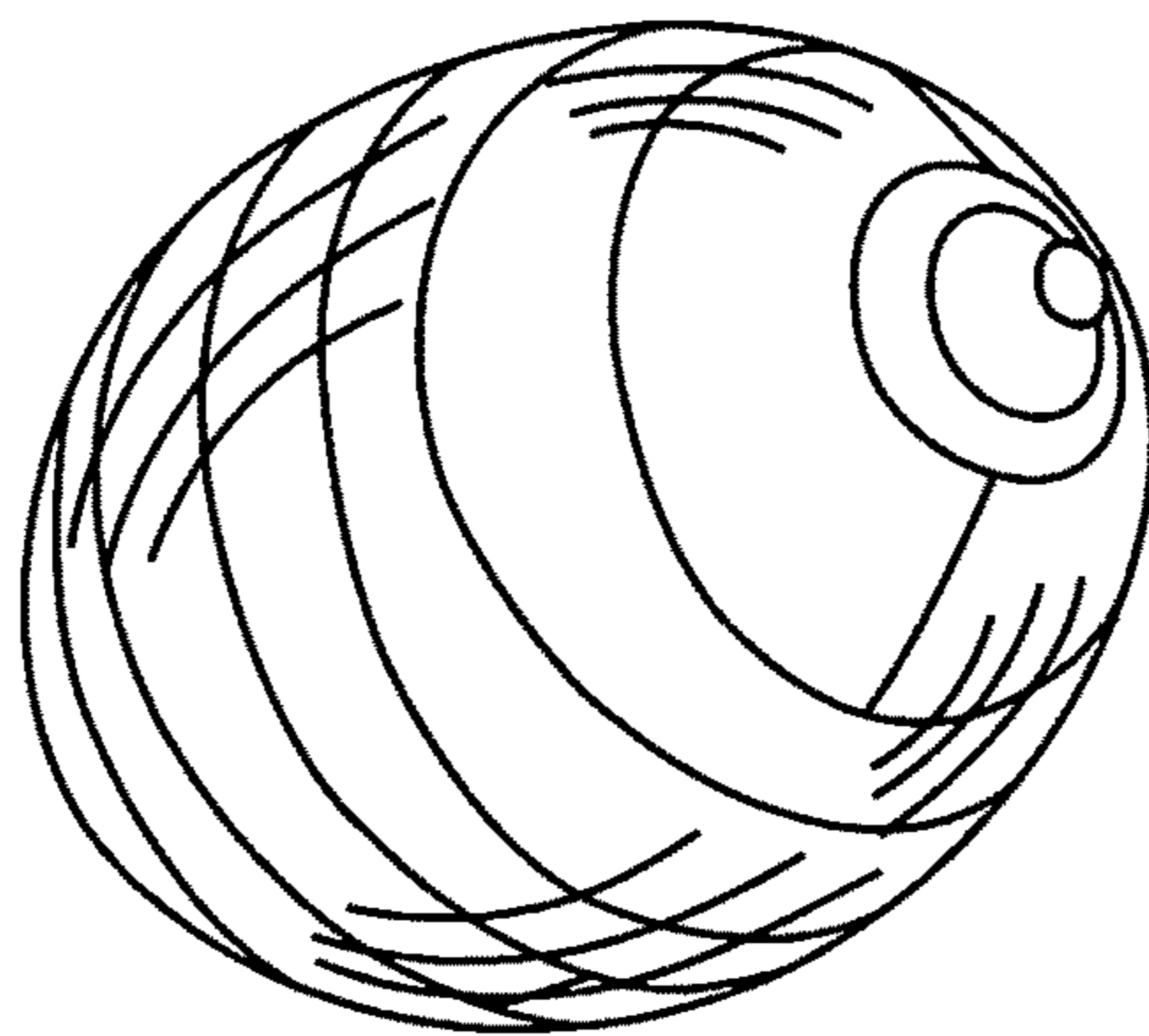
