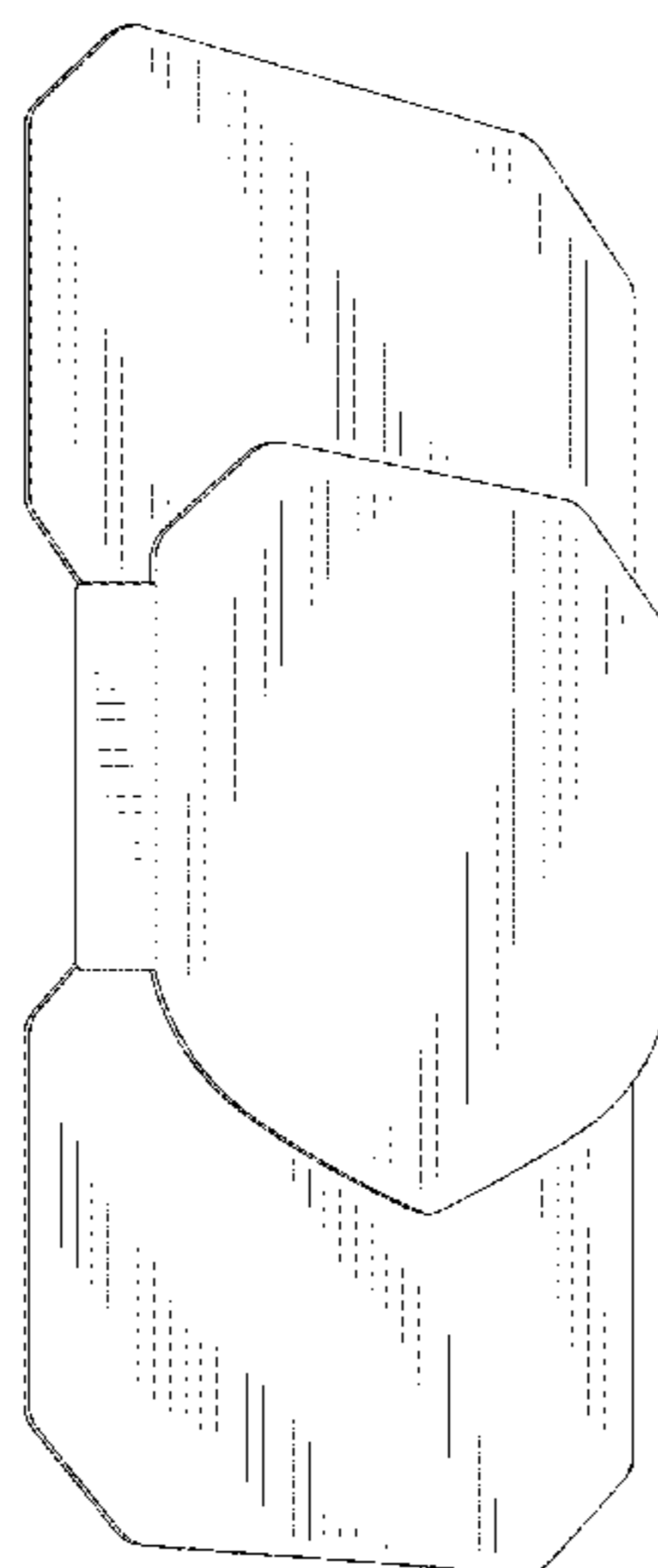
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a side perspective view of a packaging showing our new design;

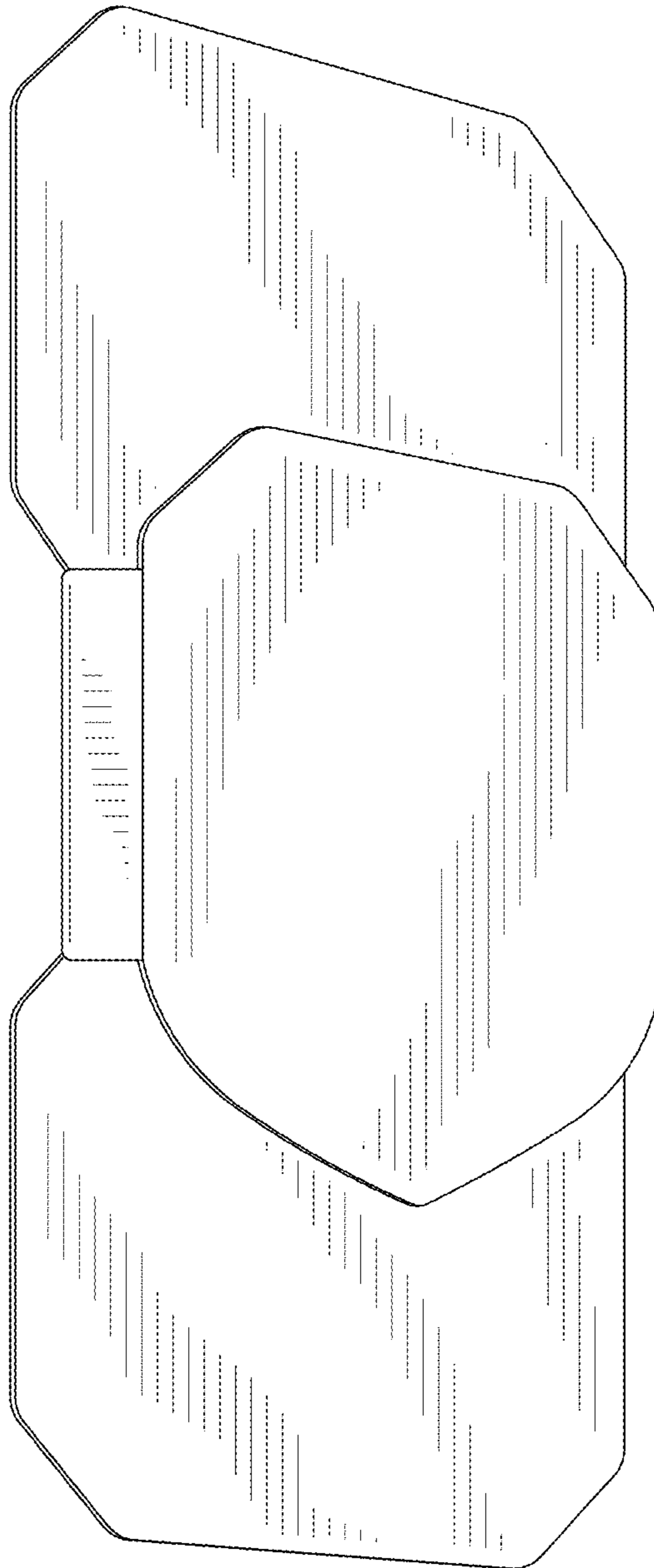

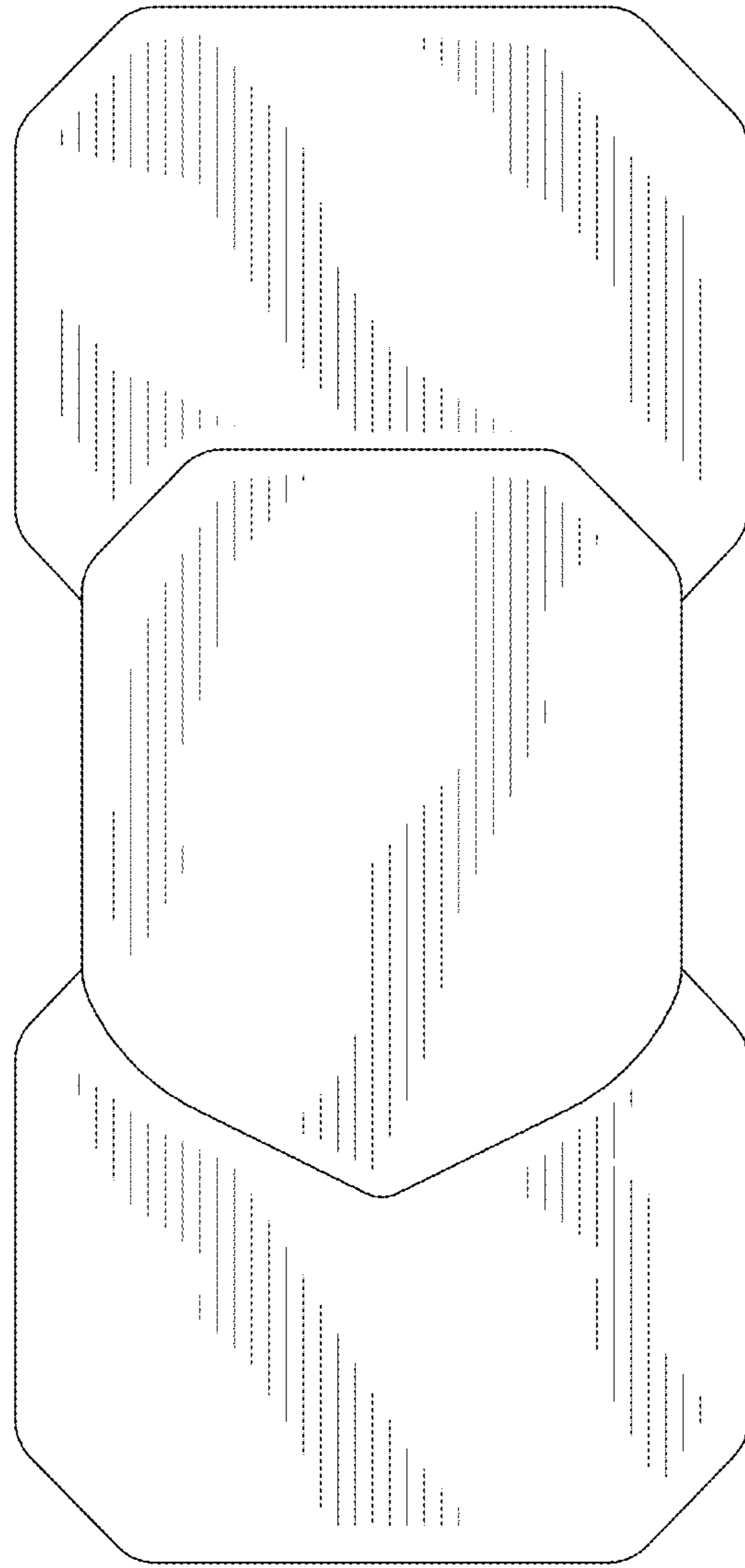

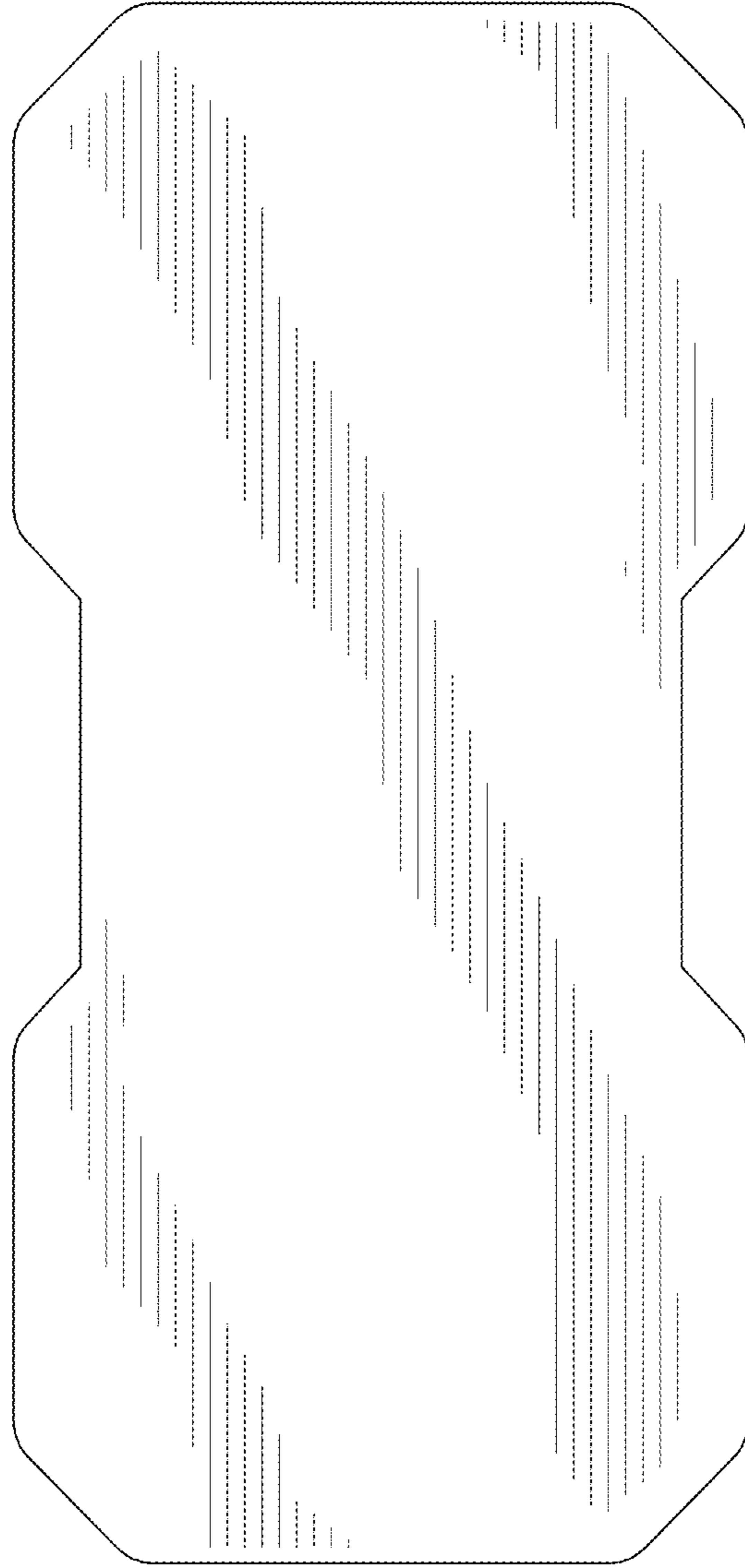

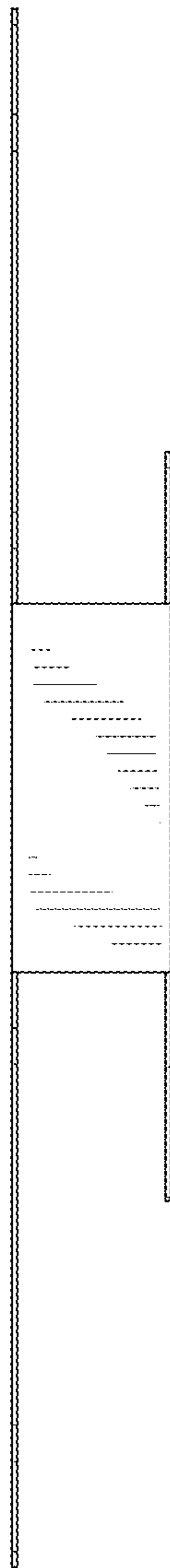

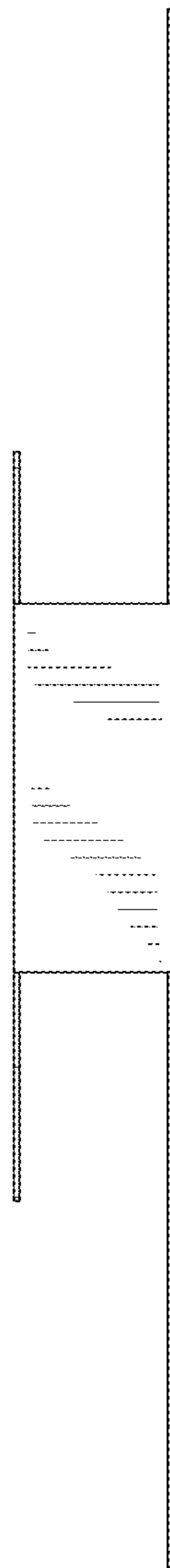

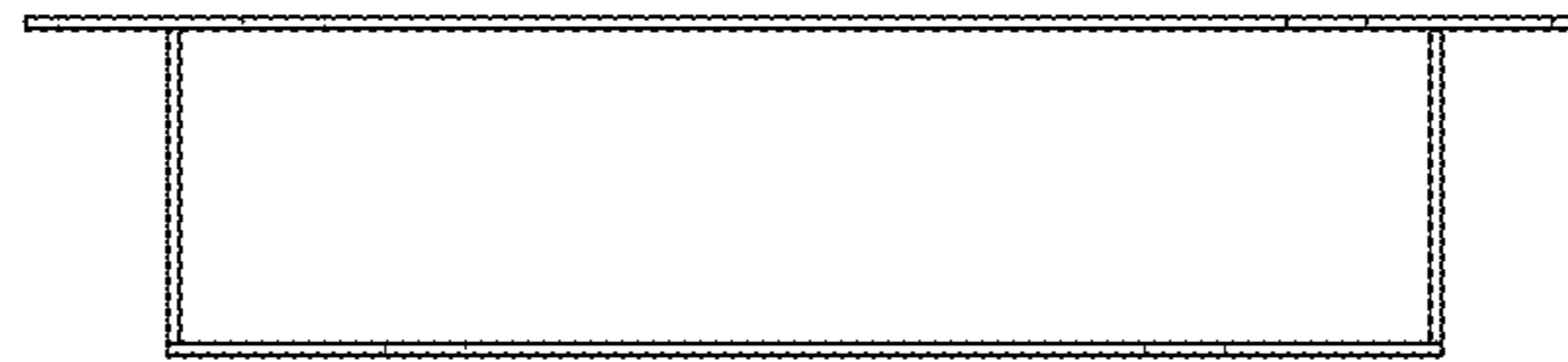
