The ornamental design for a watch dial, as shown and described.

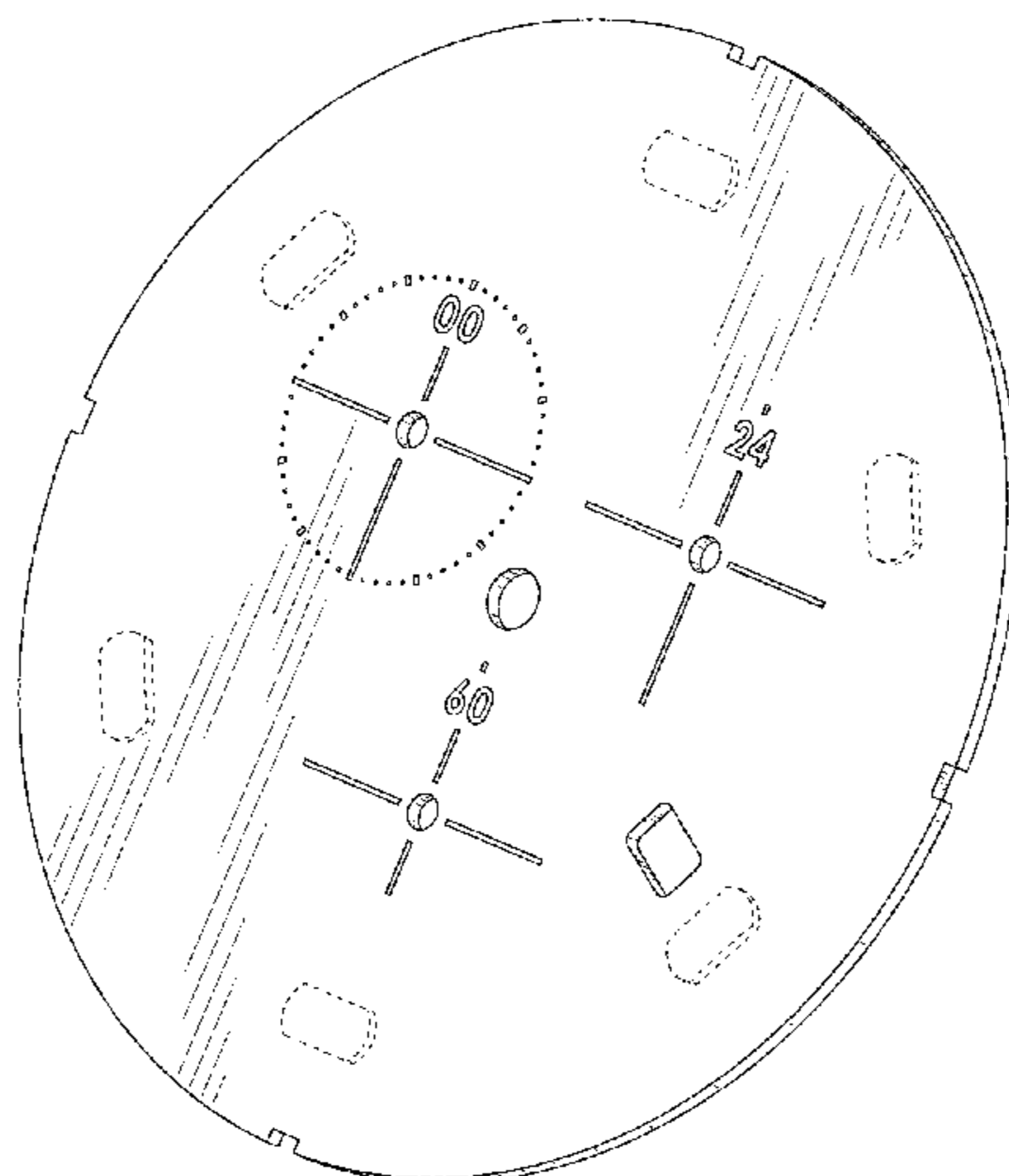
DESCRIPTION

FIG. 1 is an enlarged perspective view of a watch dial showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof; the left side elevational view is a mirror image of the right side elevational view;
FIG. 4 is a rear elevational view thereof; and,
FIG. 5 is a top plan view thereof; the bottom plan view is a mirror image of the top plan view.
The broken lines shown in FIGS. 1, 2, 3, and 5 show portions of the watch dial that form no part of the claimed design.

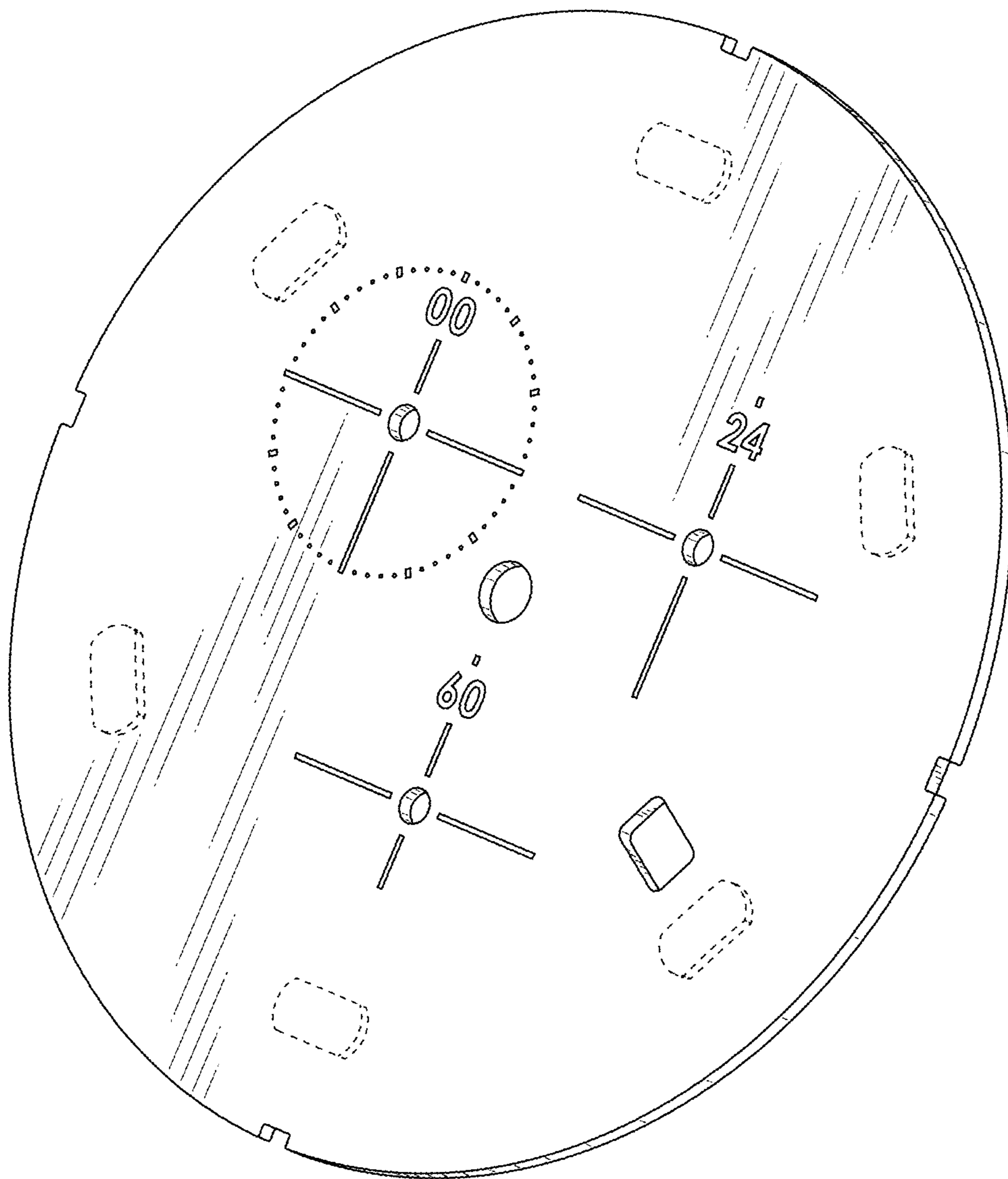

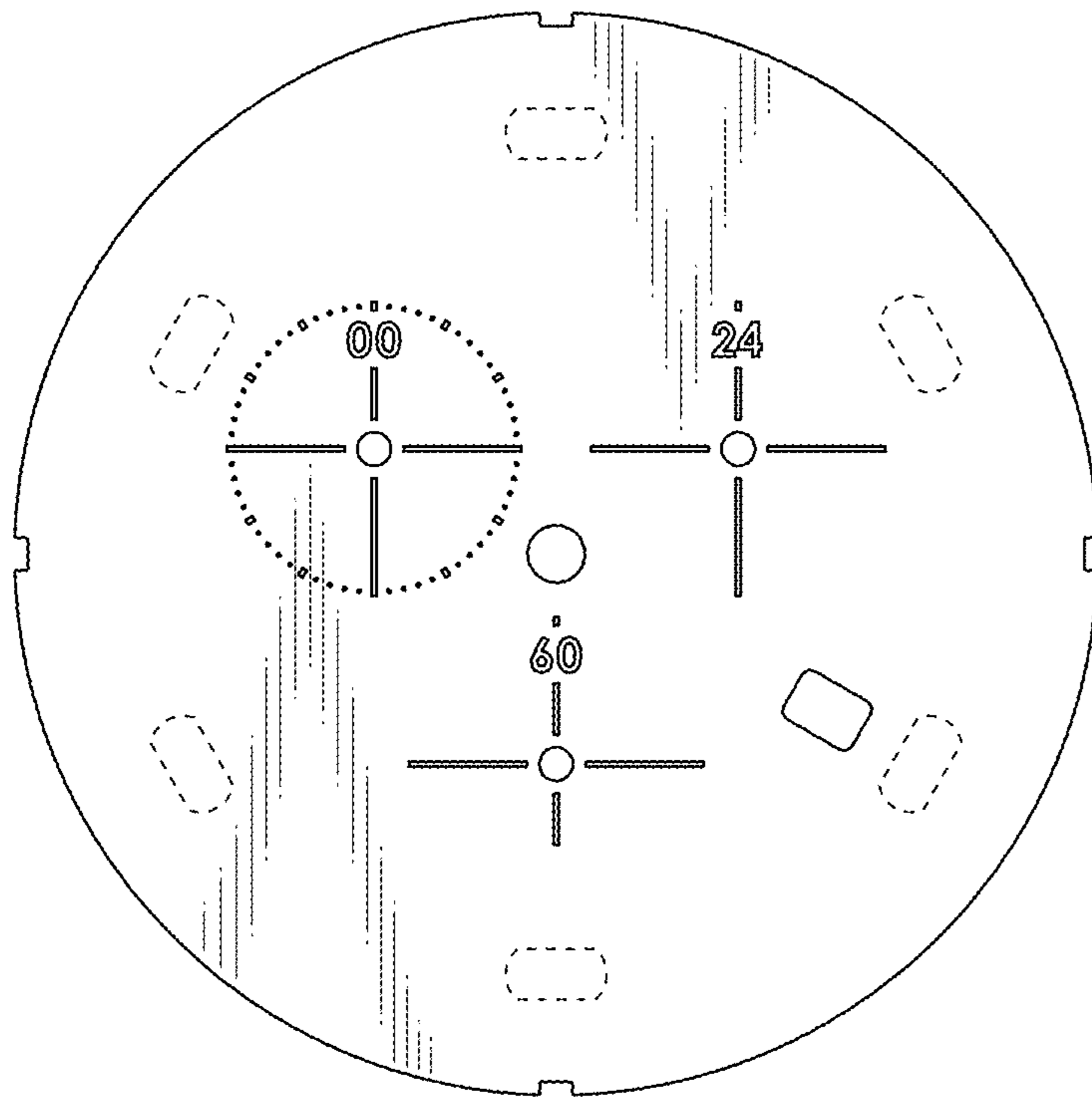

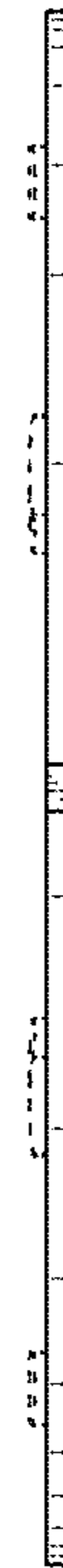

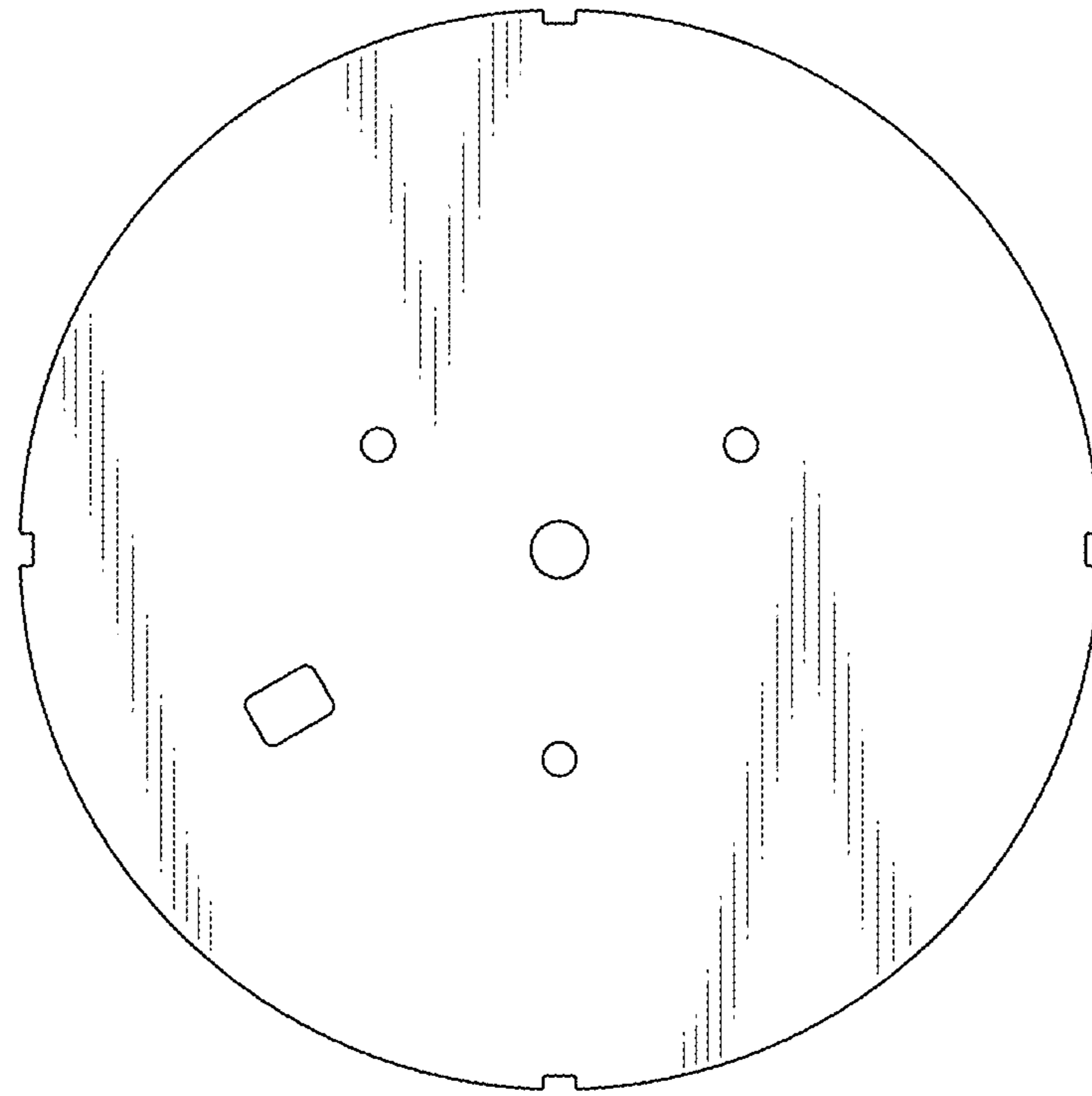
