(57) **CLAIM**

The ornamental design for a charger for electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a charger for electronic device showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof, shown in a position of use.

The broken lines depict portions of the charger for electronic device that form no part of the claimed design.

The dashed lines shown in the center of FIGS. 1-5 and 8 represent a symbolic break in length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

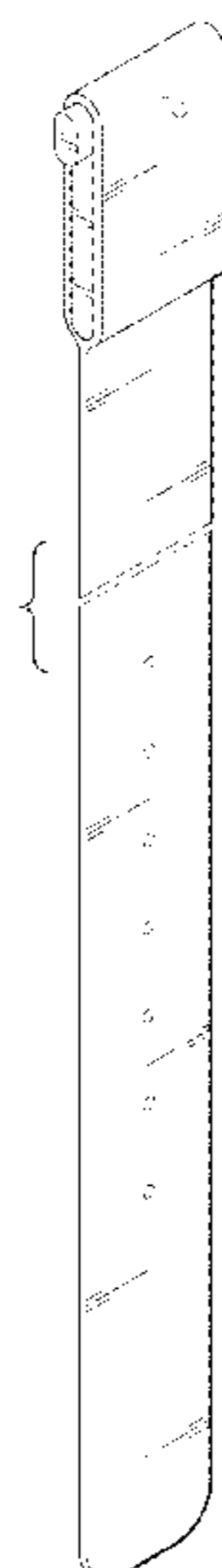

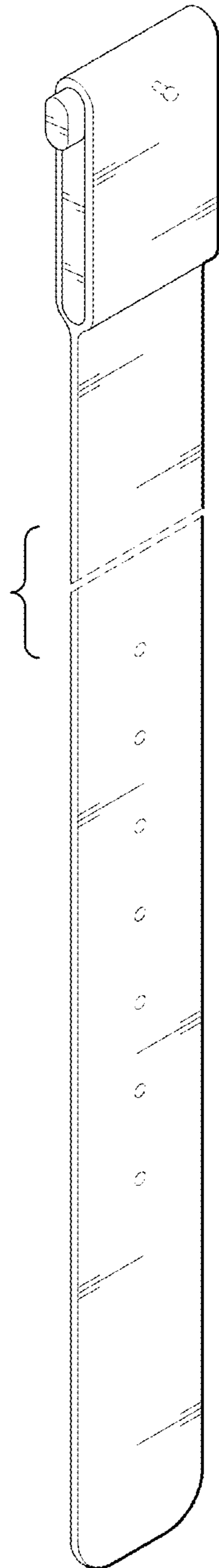

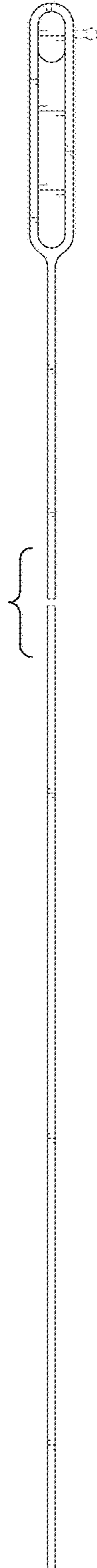

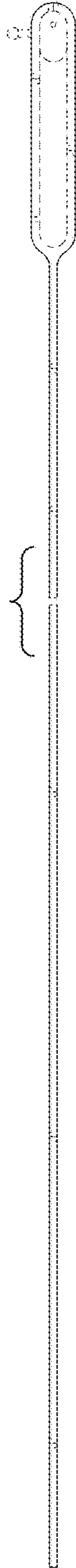

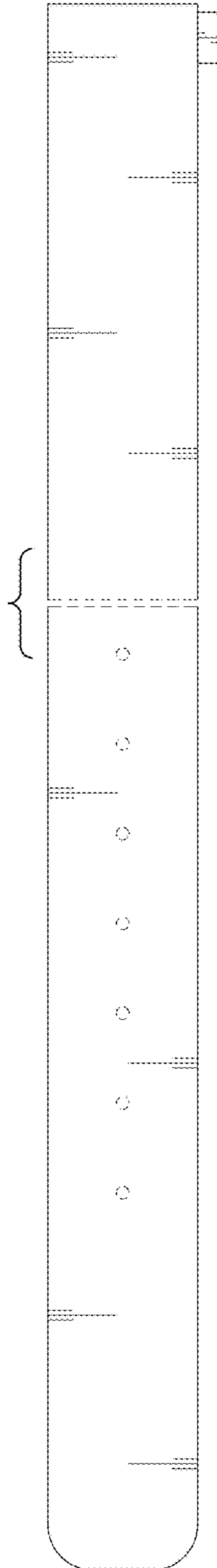

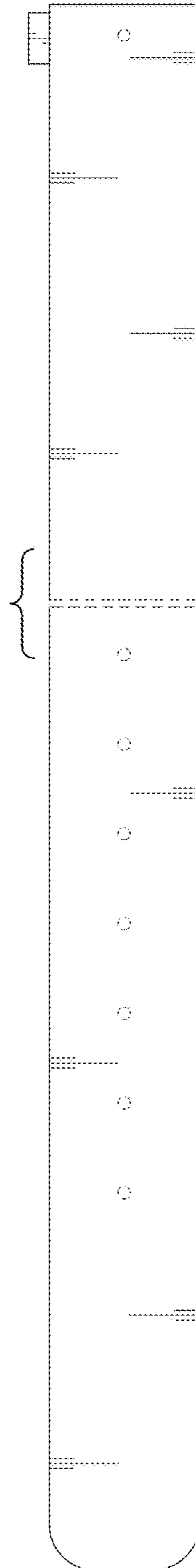

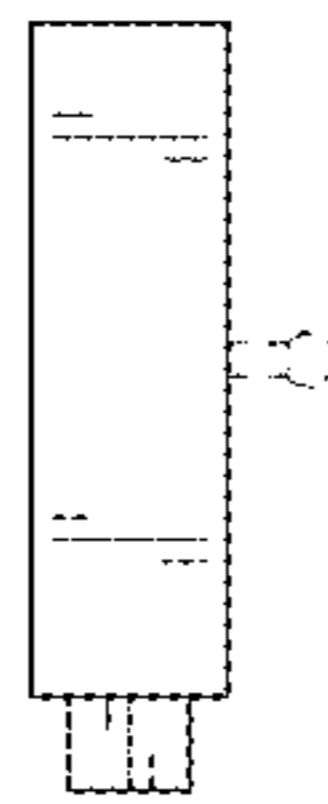

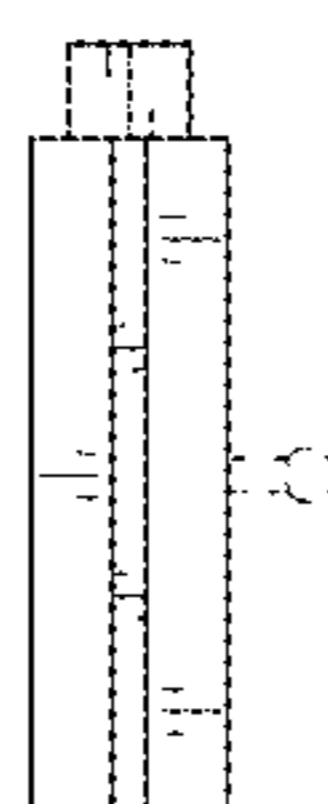
