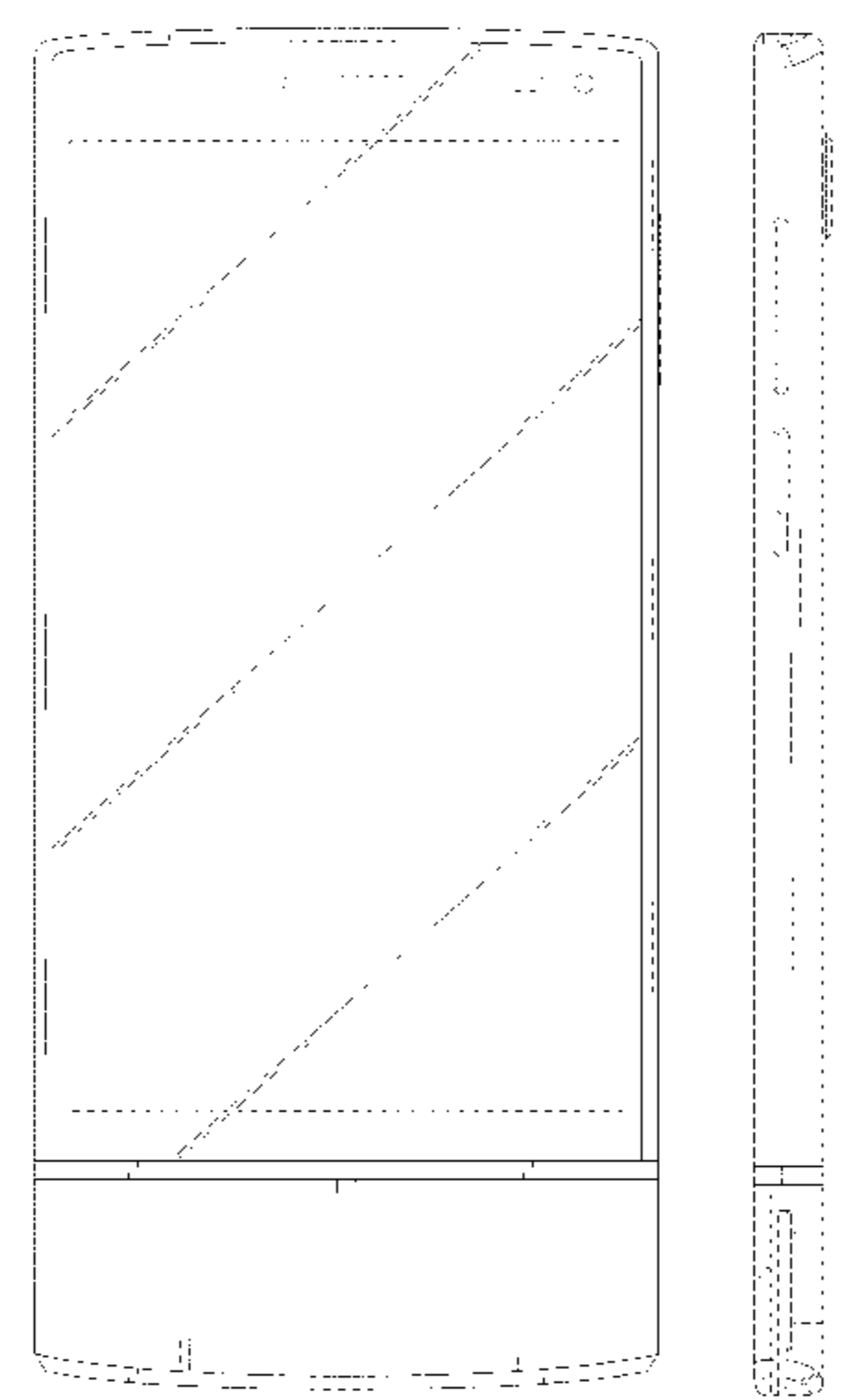
(57) **CLAIM**

The ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a rear perspective view thereof;
FIG. 9 is another front view thereof, showing the lower main body separated from the upper main body; and,
FIG. 10 is another front view thereof shown with environment.
The dot dash broken lines in FIG. 9 indicate the path along which the lower main body is separated from the upper main body and form no part of the claimed design. The broken lines consistently shown immediately adjacent to the claim, encompassing unshaded regions, represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

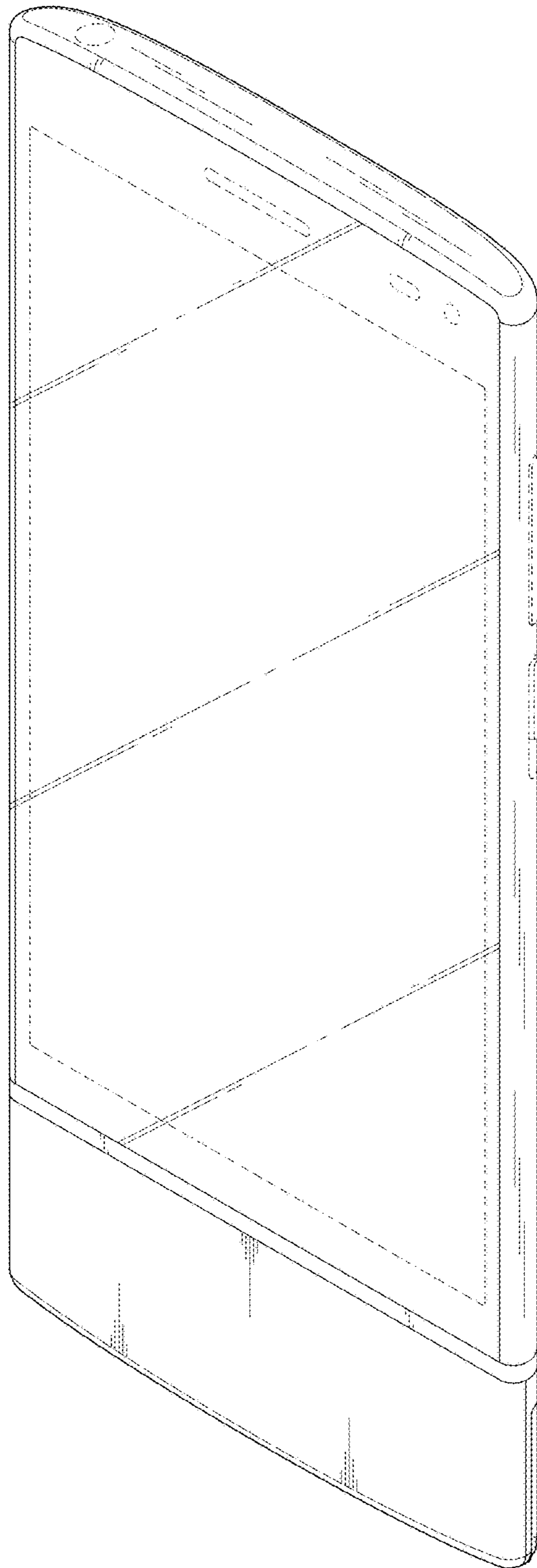

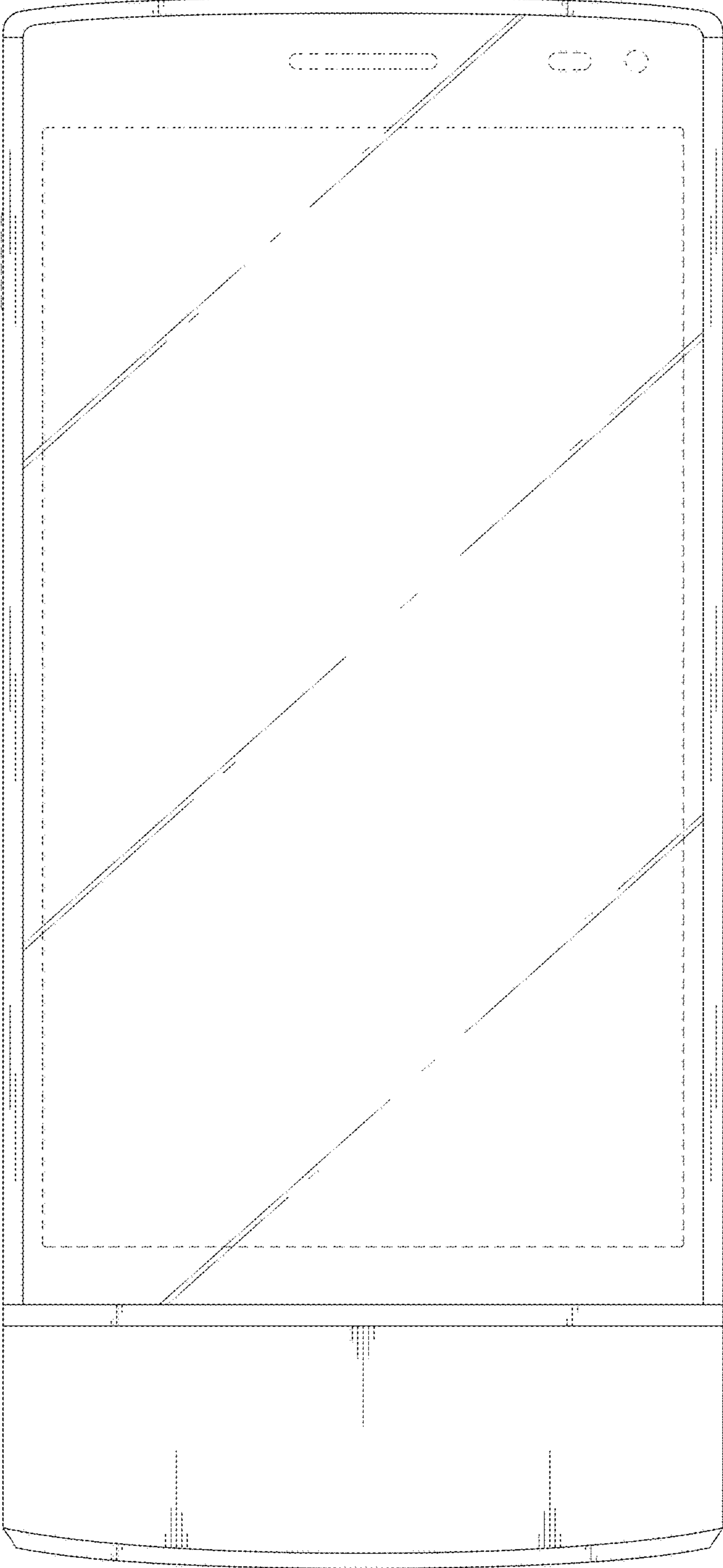

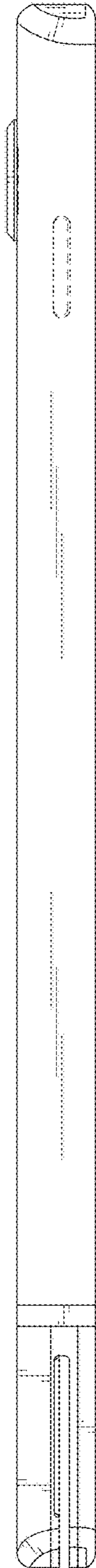

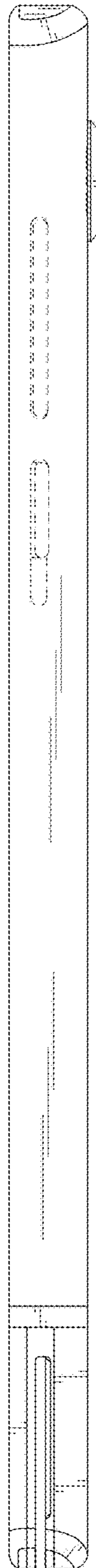

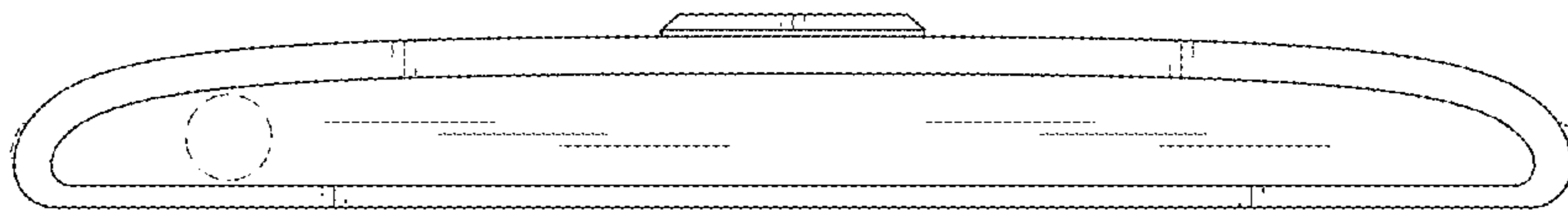

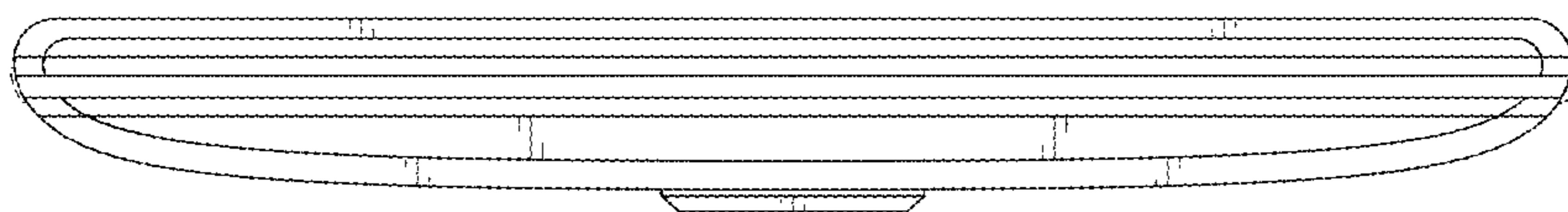

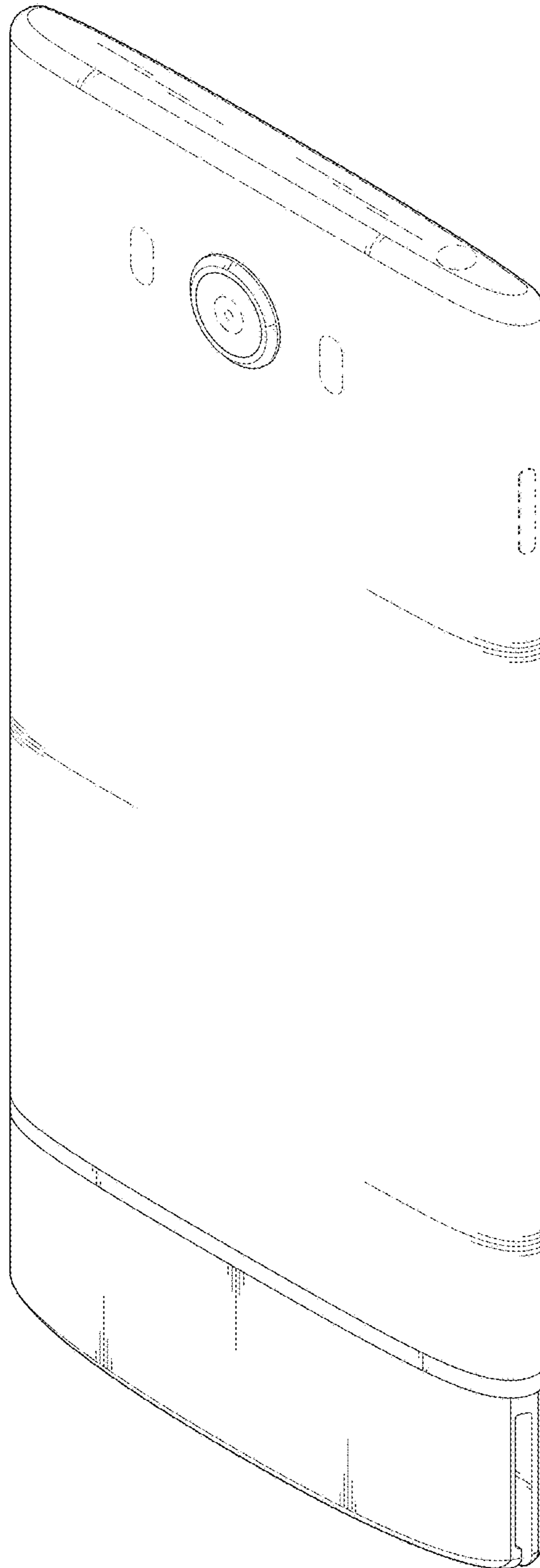

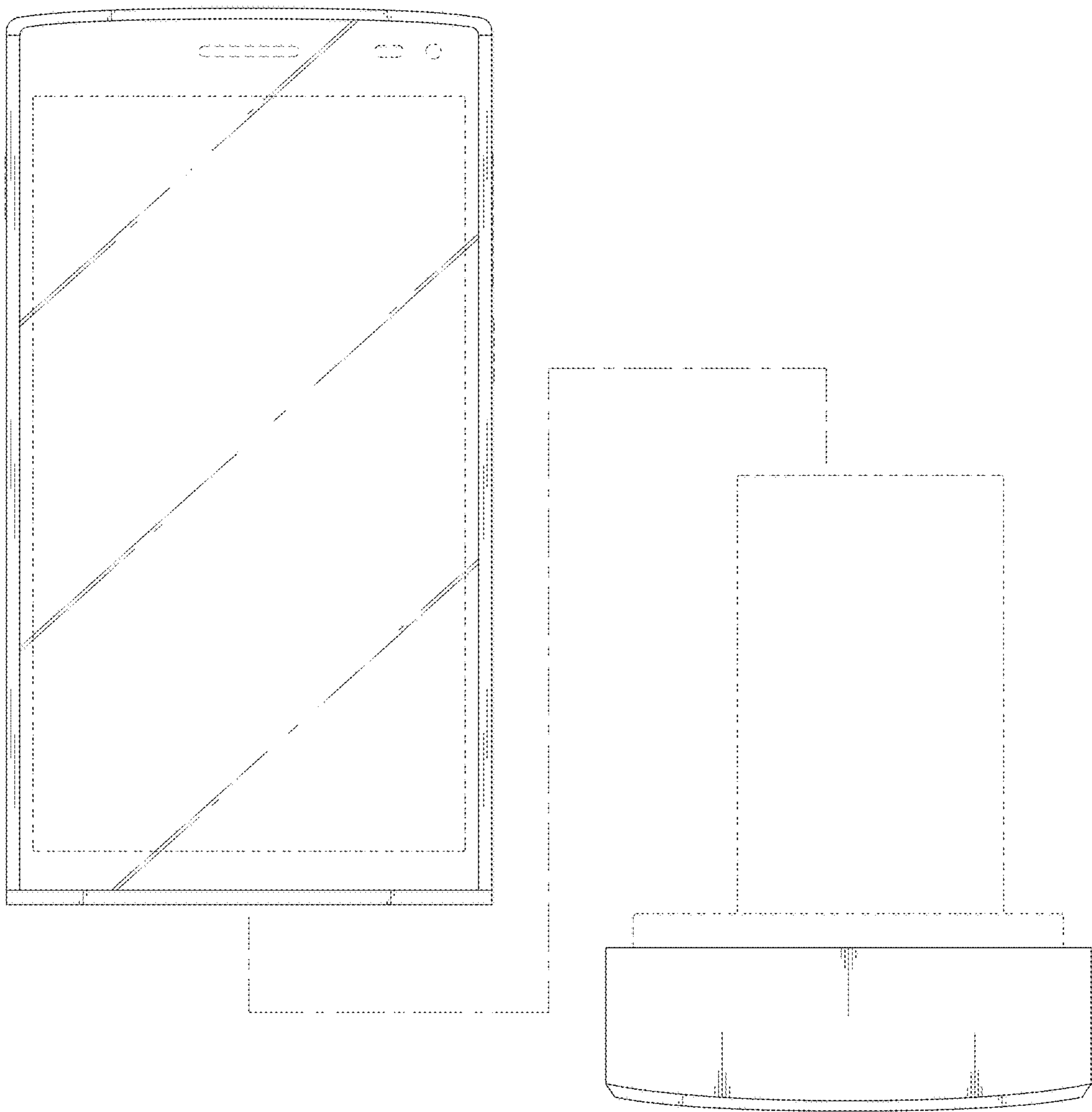
