(57) **CLAIM**

The ornamental design for a tablet case with shock resistant corners and grip side grooves, as shown and described.

DESCRIPTION

FIG. 1 is a front-left top perspective view of a keyboard-compatible tablet case with shock resistant corners and grip side grooves showing my new design;

FIG. 2 is a rear-right top perspective view of FIG. 1 thereof;

FIG. 3 is a front elevational view of FIG. 1 thereof;

FIG. 4 is a rear elevational view of FIG. 1 thereof;

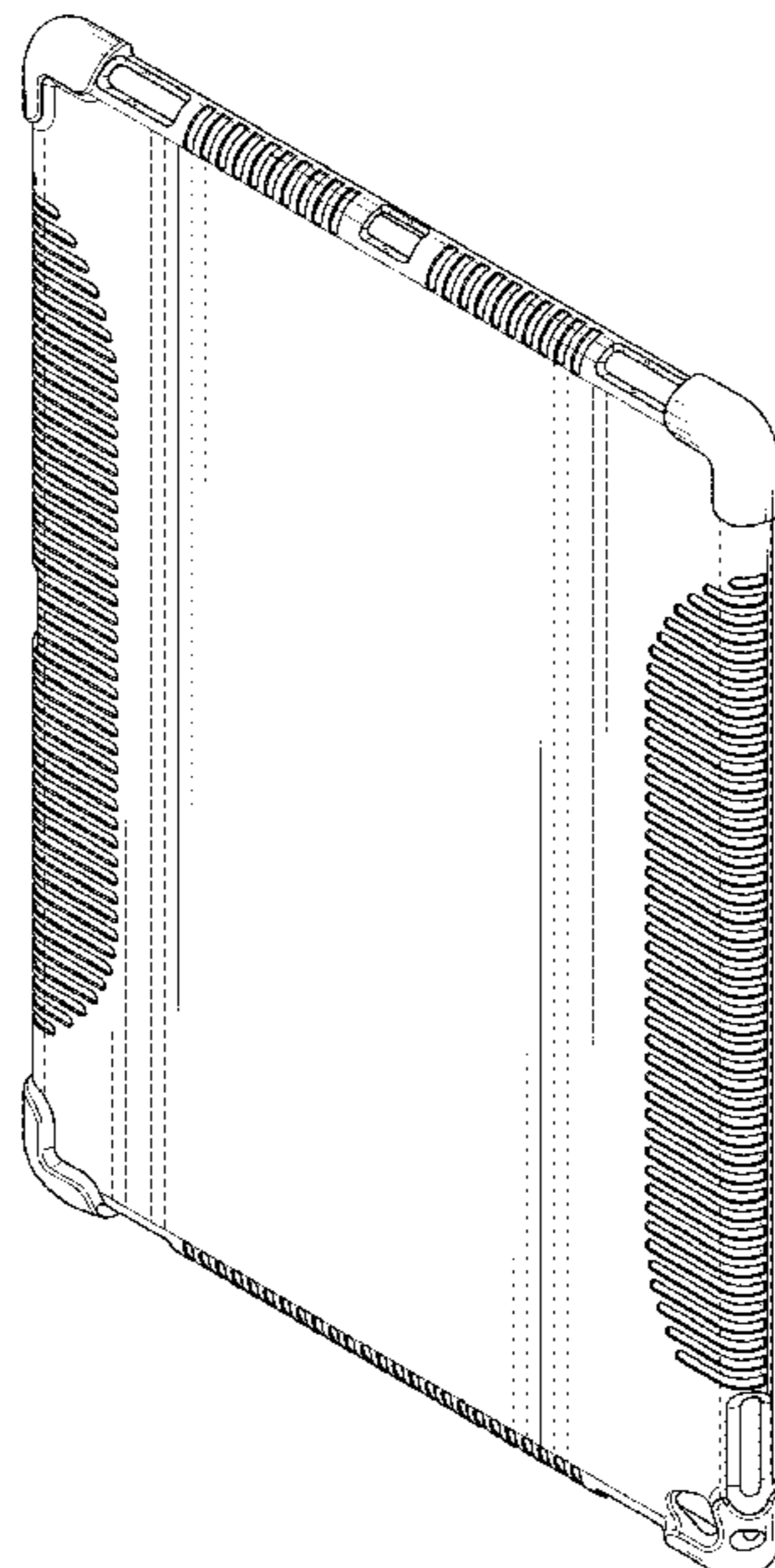
FIG. 5 is a left side elevational view of FIG. 1 thereof;

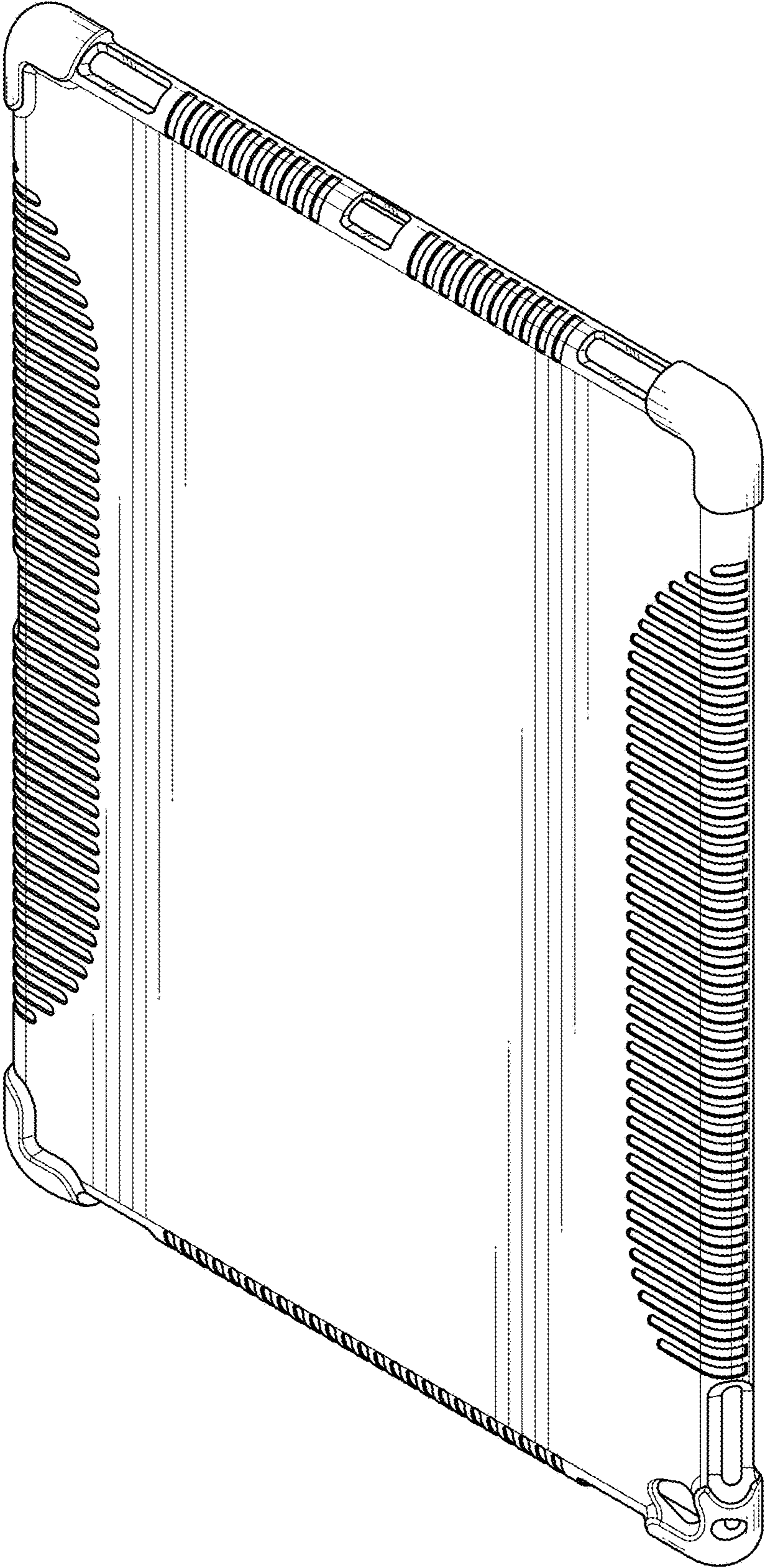

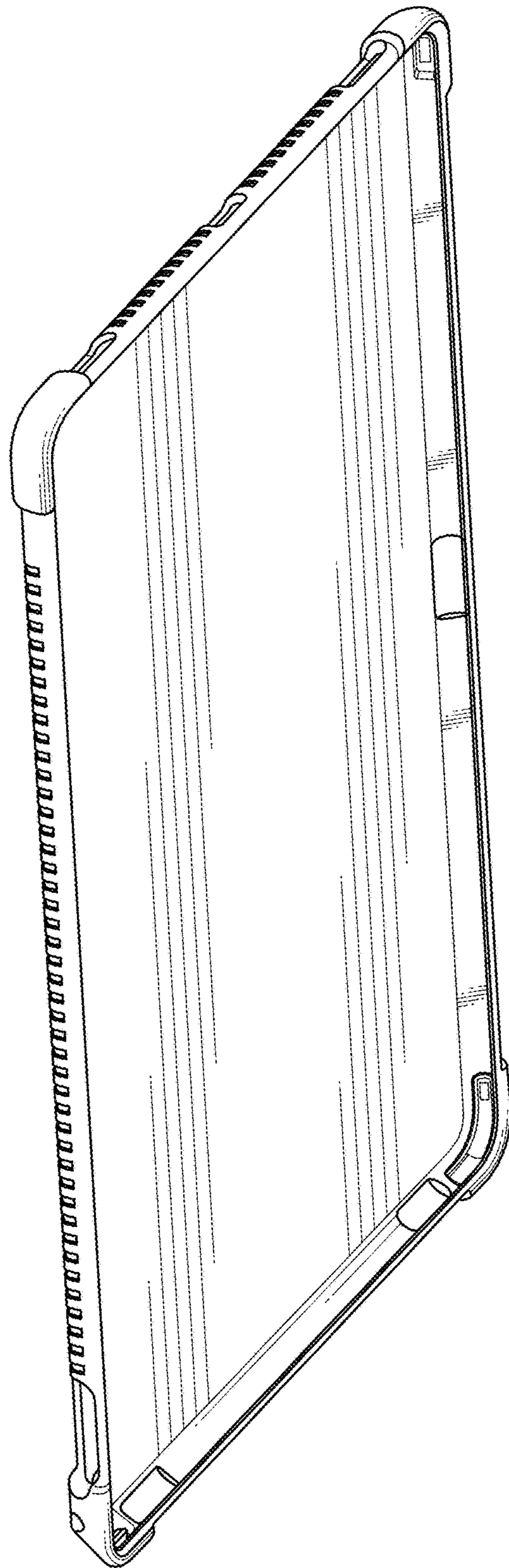

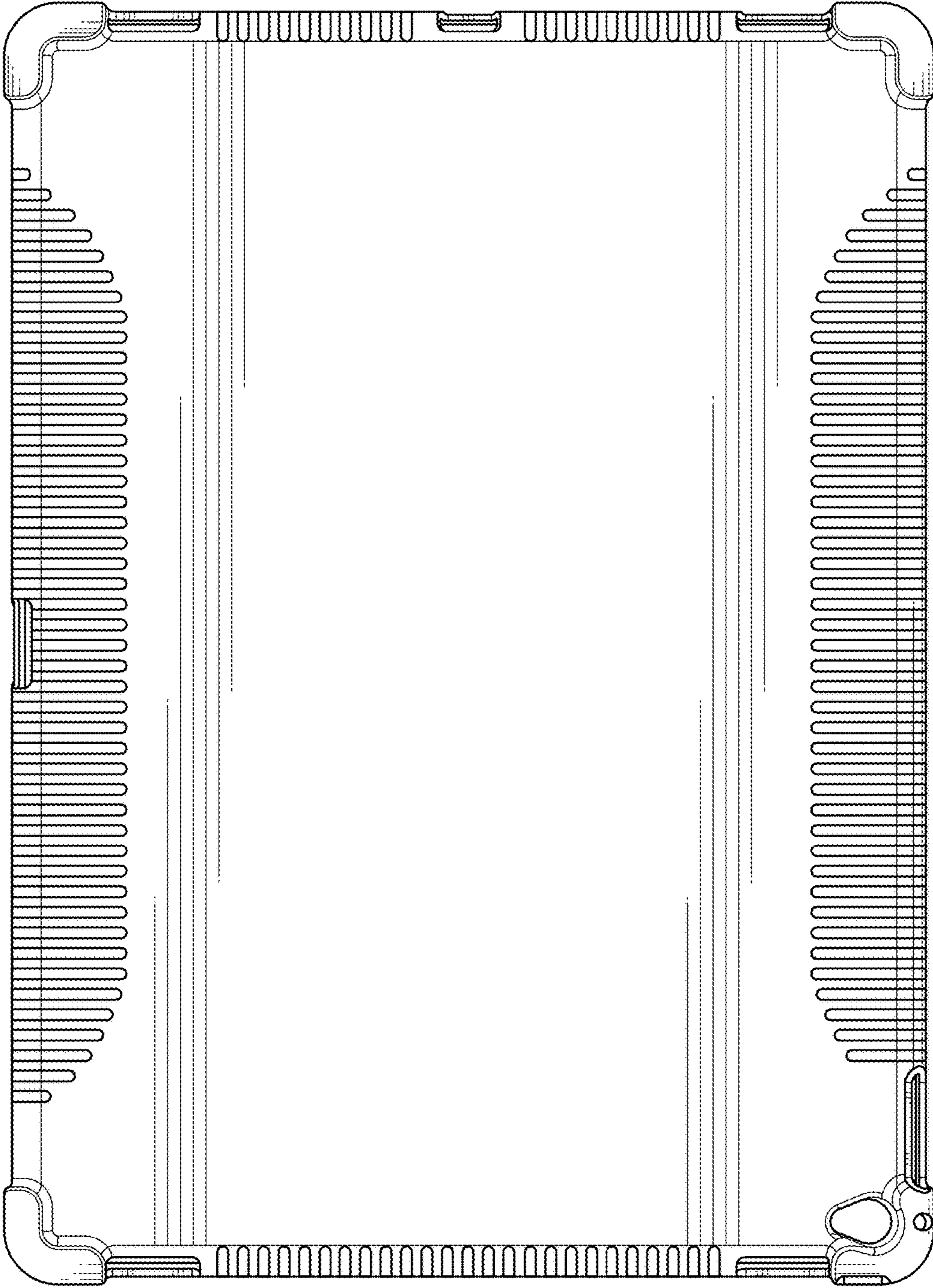

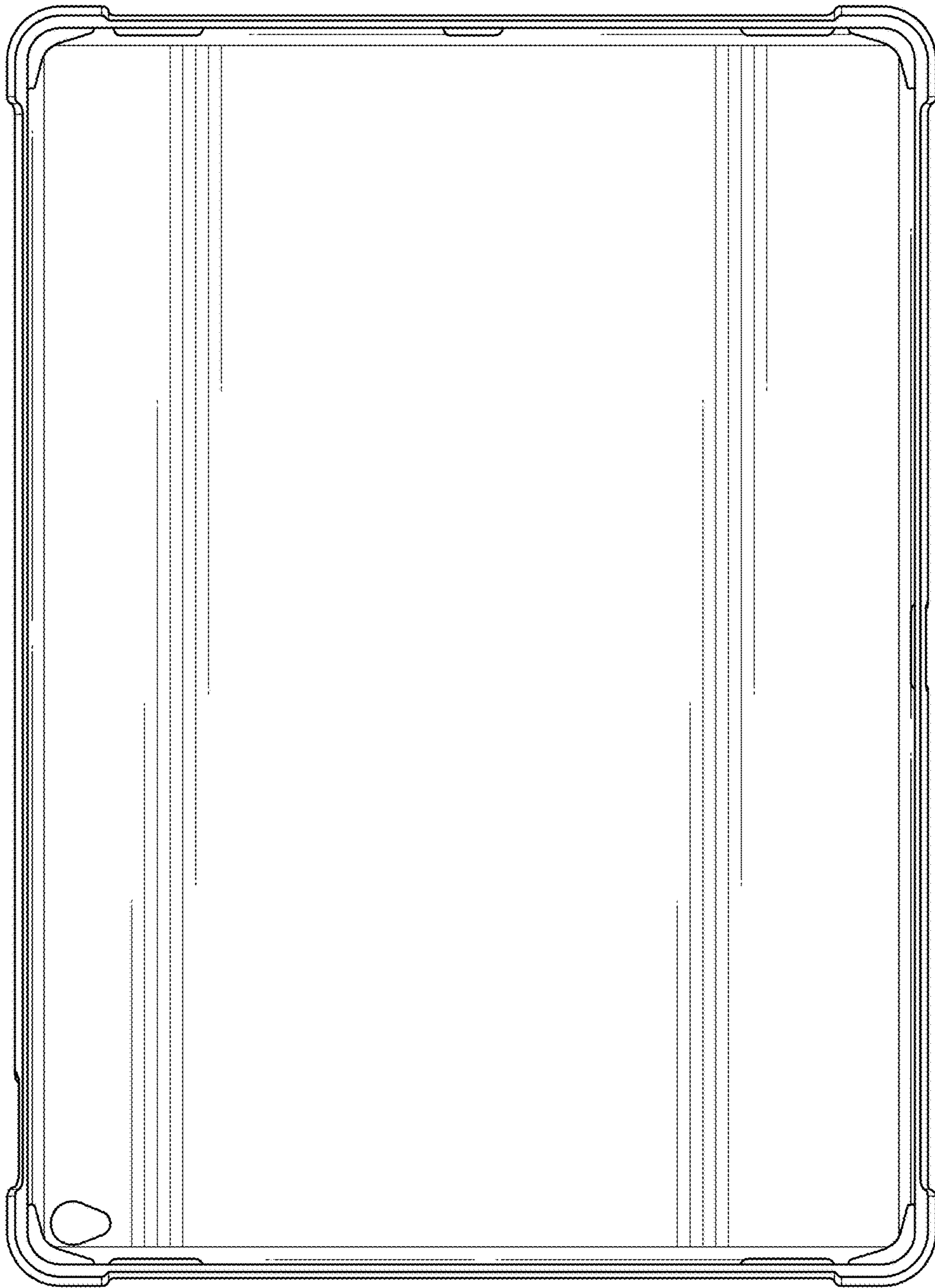

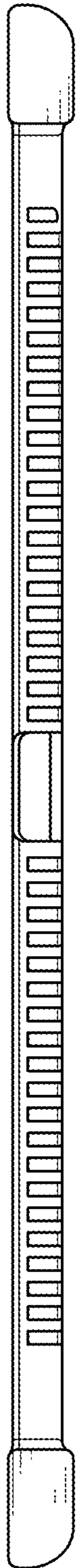

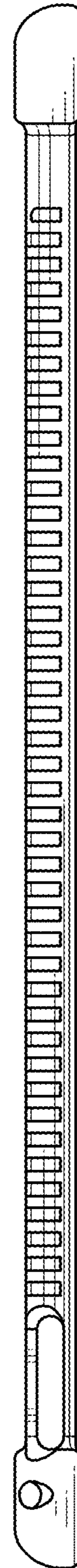

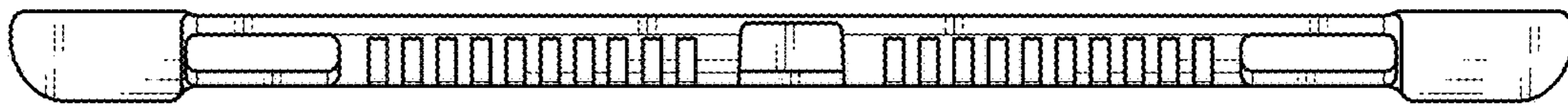

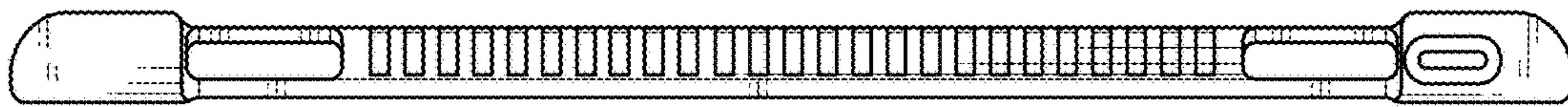
