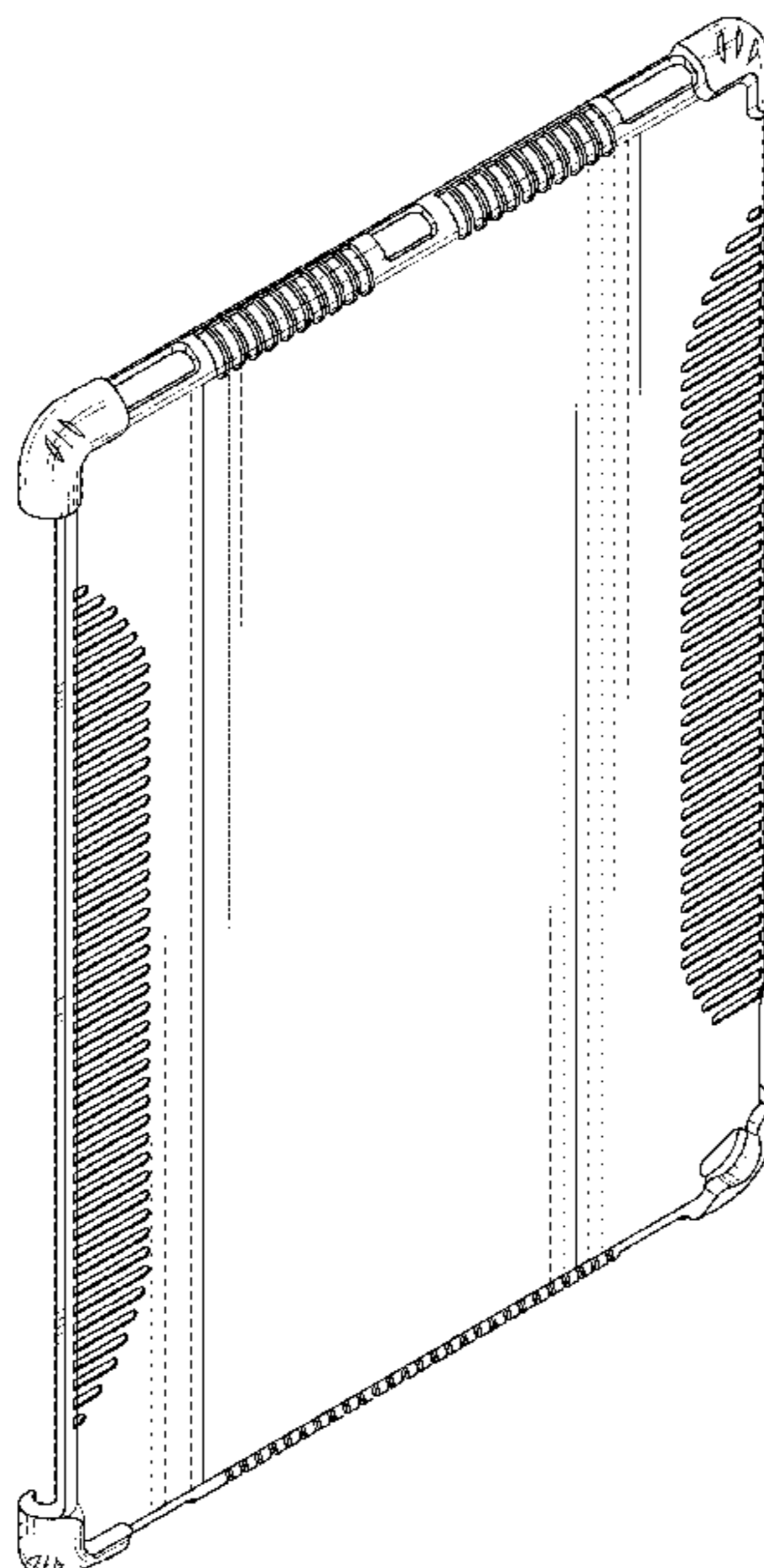
(57) **CLAIM**

The ornamental design for a keyboard-compatible tablet case with shock resistant corners and grip side grooves, as shown and described.

DESCRIPTION

FIG. 1 is a front-left top perspective view of a keyboard-compatible tablet case with shock resistant corners and grip side grooves showing my new design;

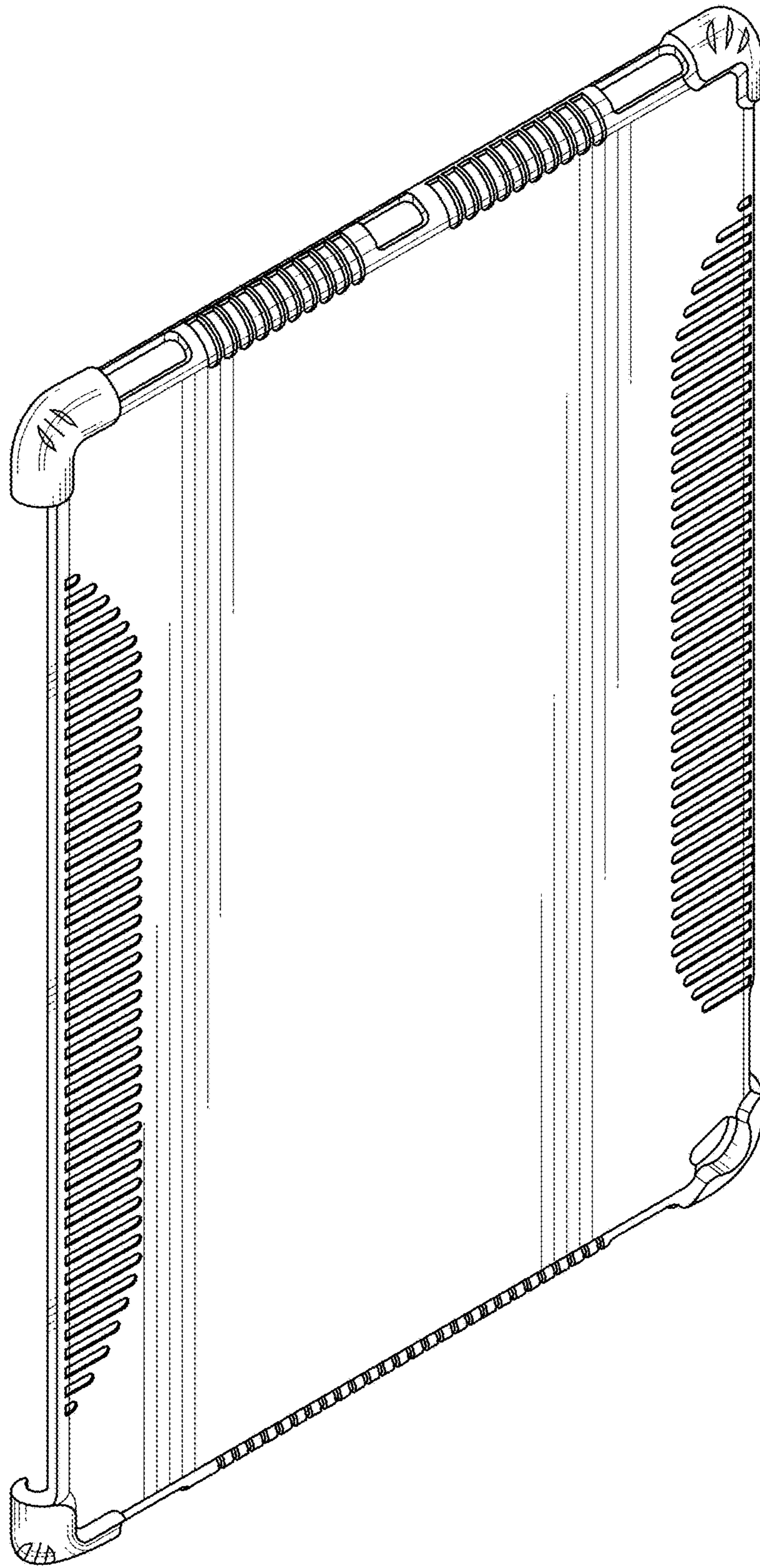

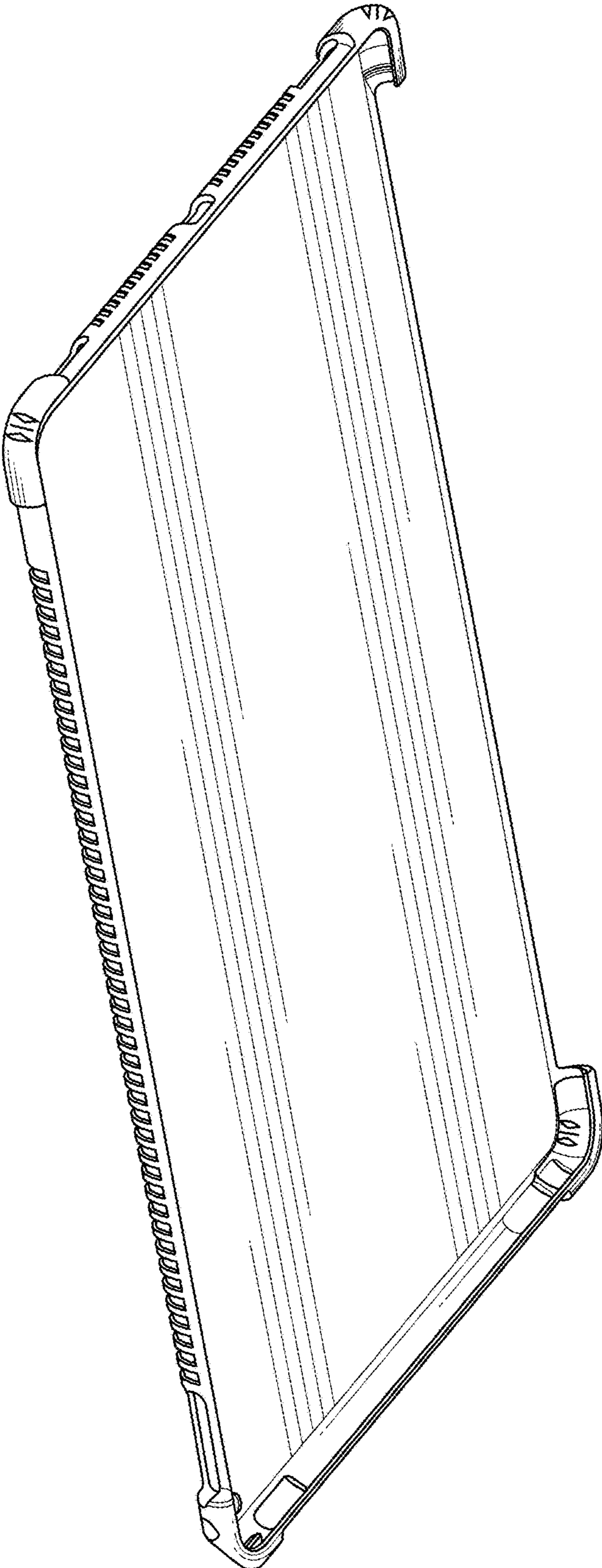

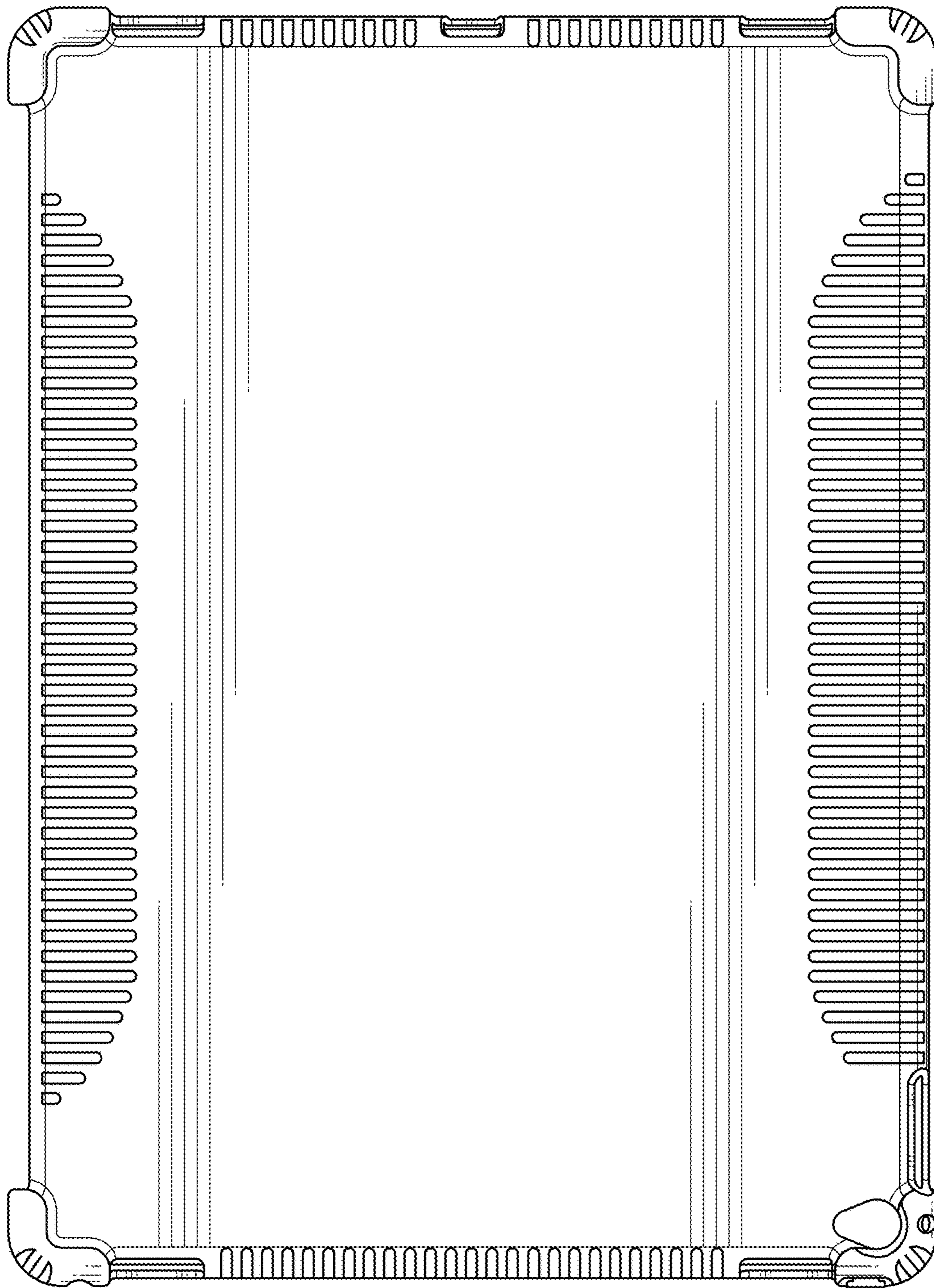

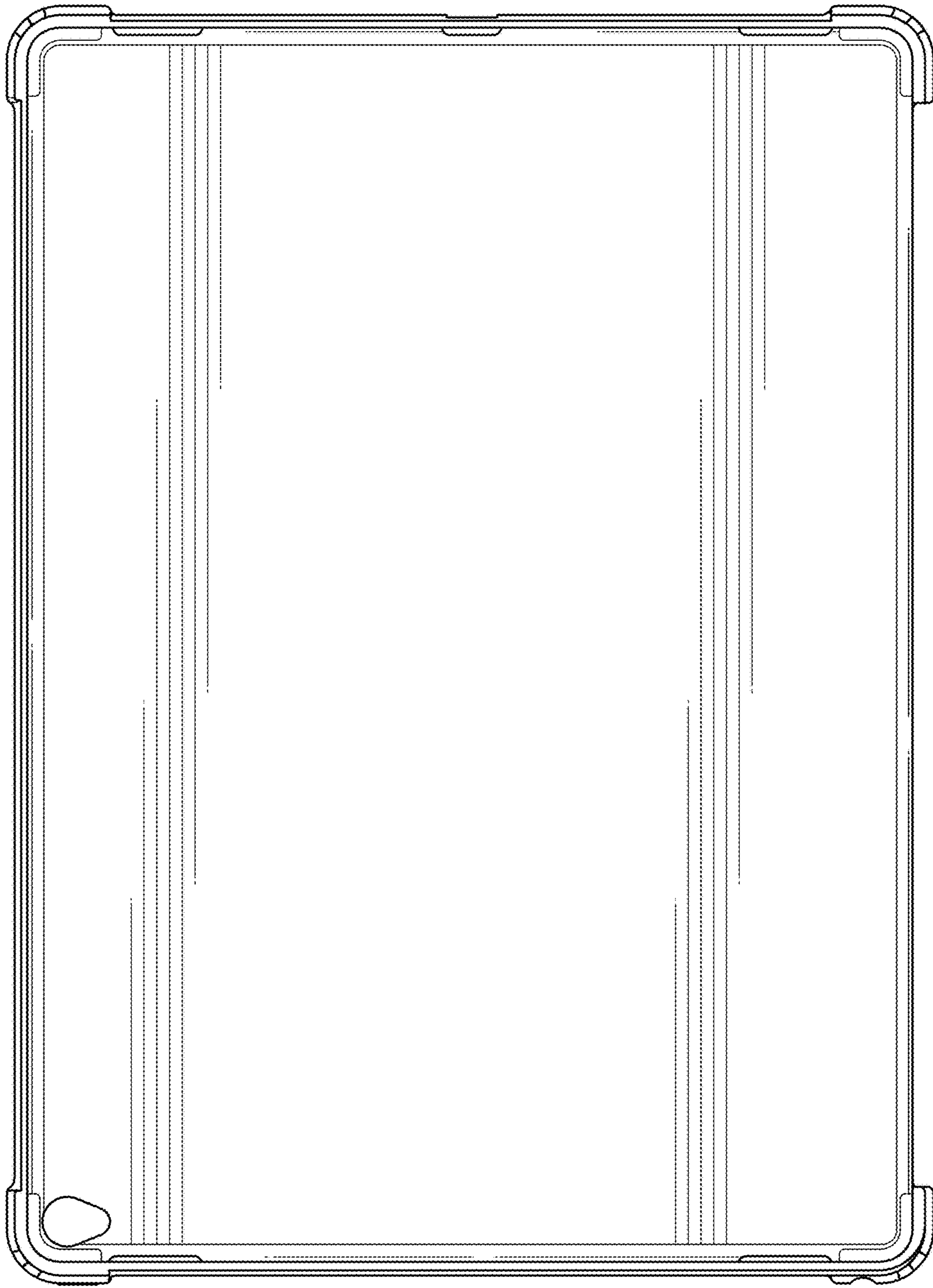

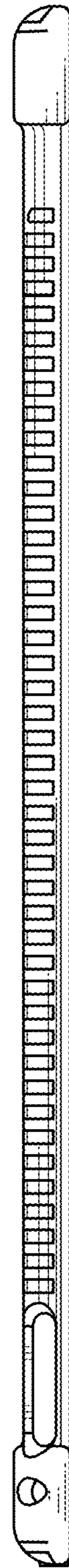

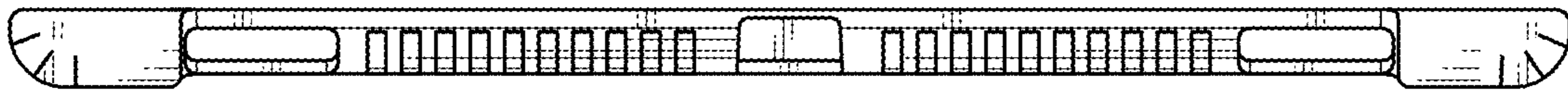

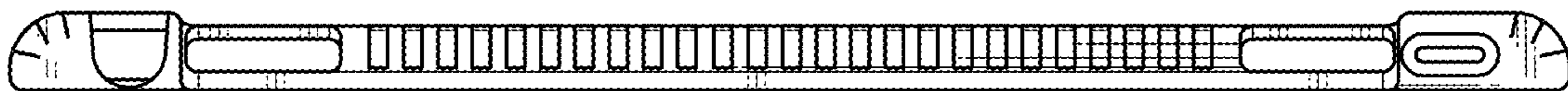
