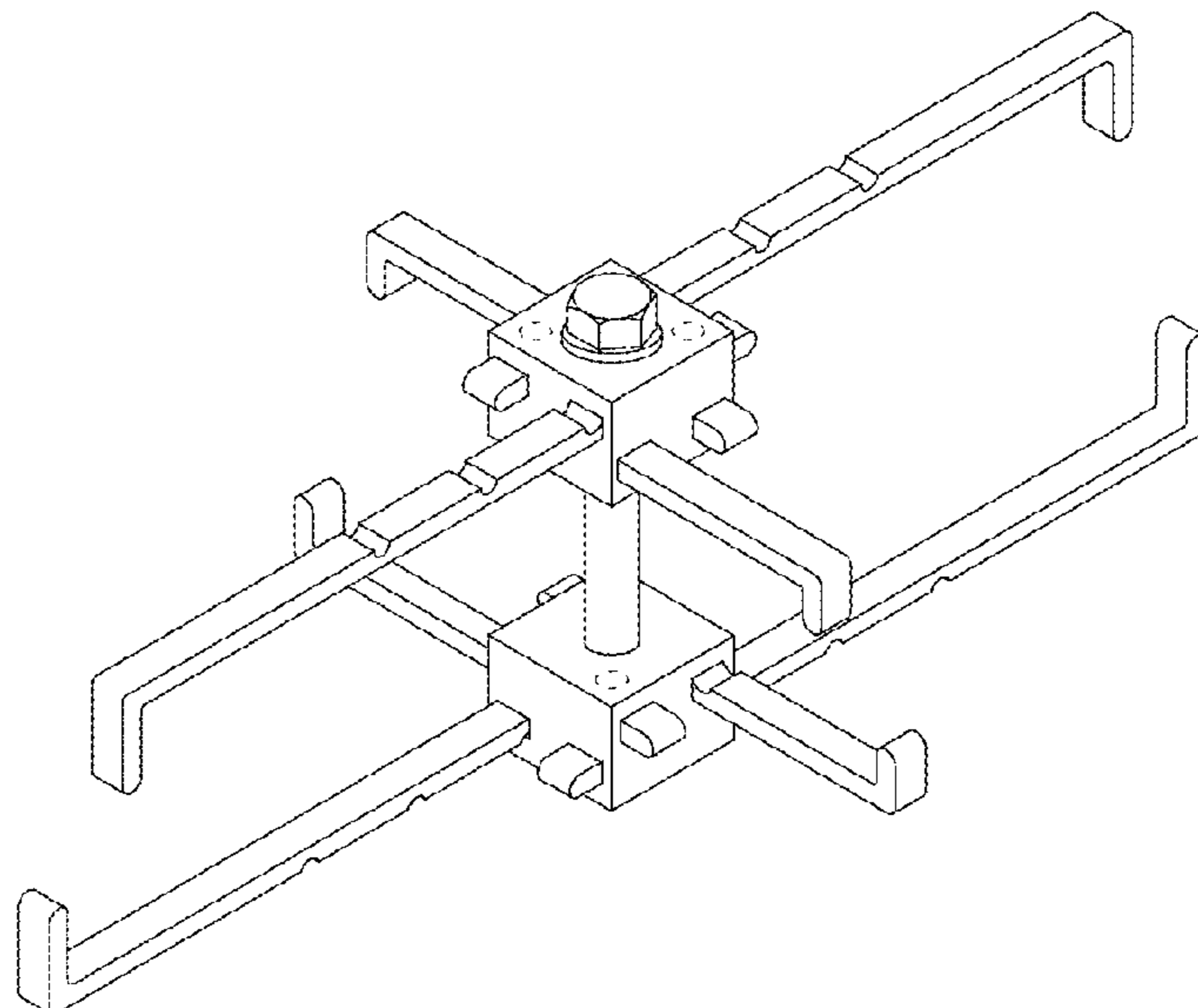
(57) **CLAIM**

The ornamental design for a welding fixture, as shown and described.

DESCRIPTION

FIG. 1 is a top and side perspective view of a welding fixture according to the present invention.
FIG. 2 is a first side view of the welding fixture according to FIG. 1;
FIG. 3 is a second side view of the welding fixture according to FIG. 1 from a direction opposite that of FIG. 2;
FIG. 4 is a side view of the welding fixture of FIG. 1;
FIG. 5 is a side view of the welding fixture of FIG. 1 from a direction opposite of that of FIG. 4;
FIG. 6 is a top view of the welding fixture of FIG. 1; and,
FIG. 7 is a bottom view of the welding fixture of FIG. 1.
The broken lines in the drawings depict unclaimed environmental subject matter.
The welding fixture can be used as a clamp for holding frame parts together during a welding process.

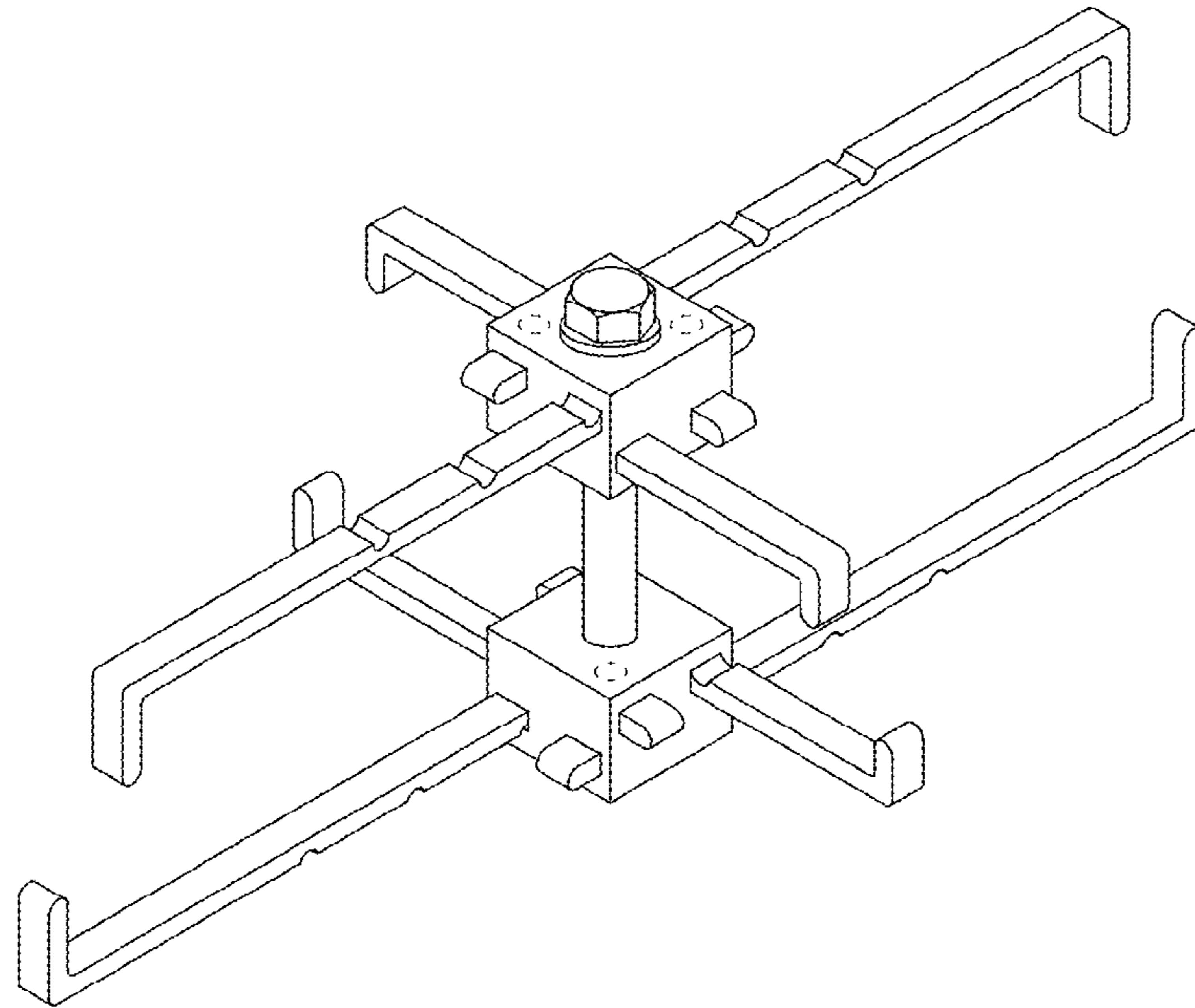

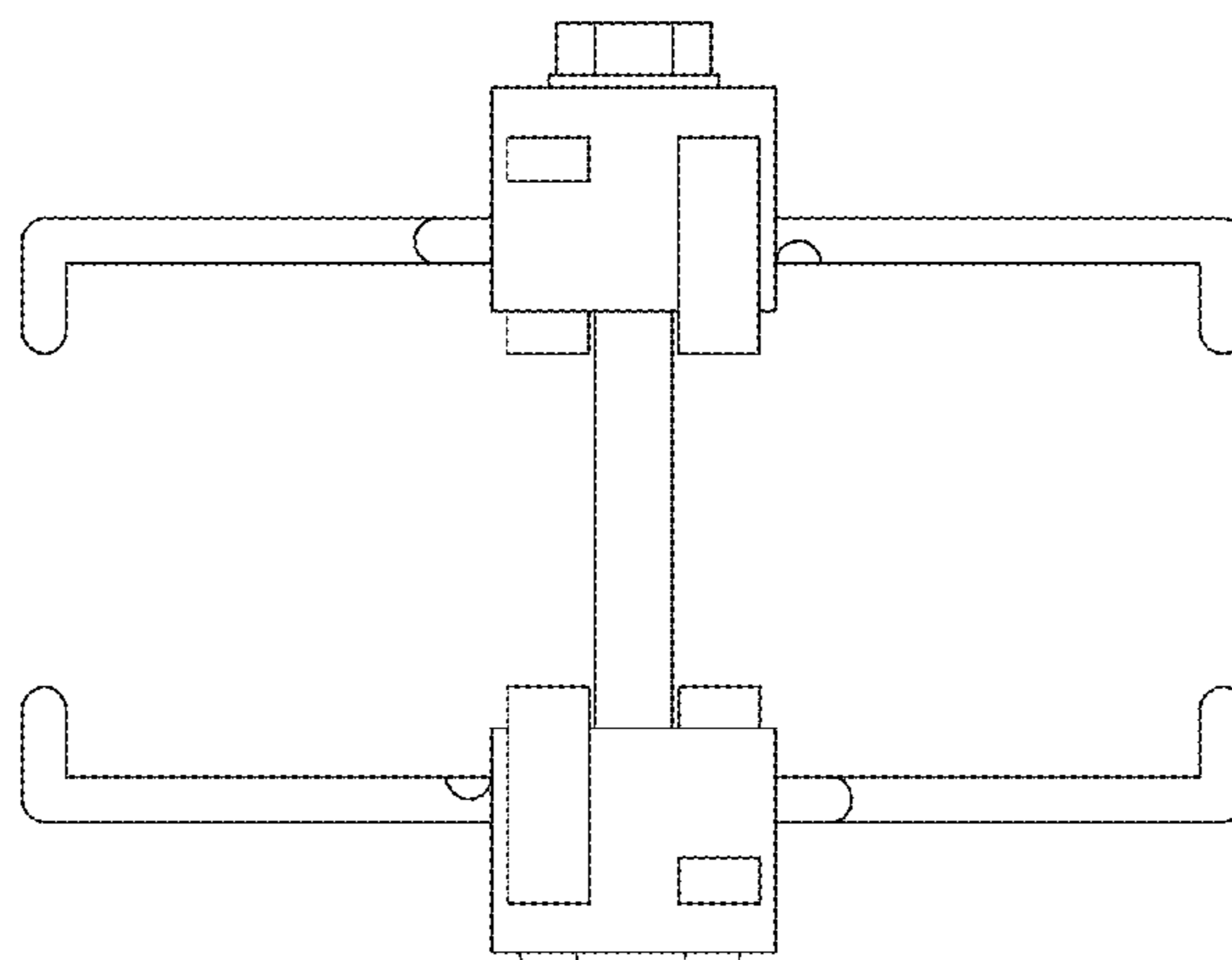

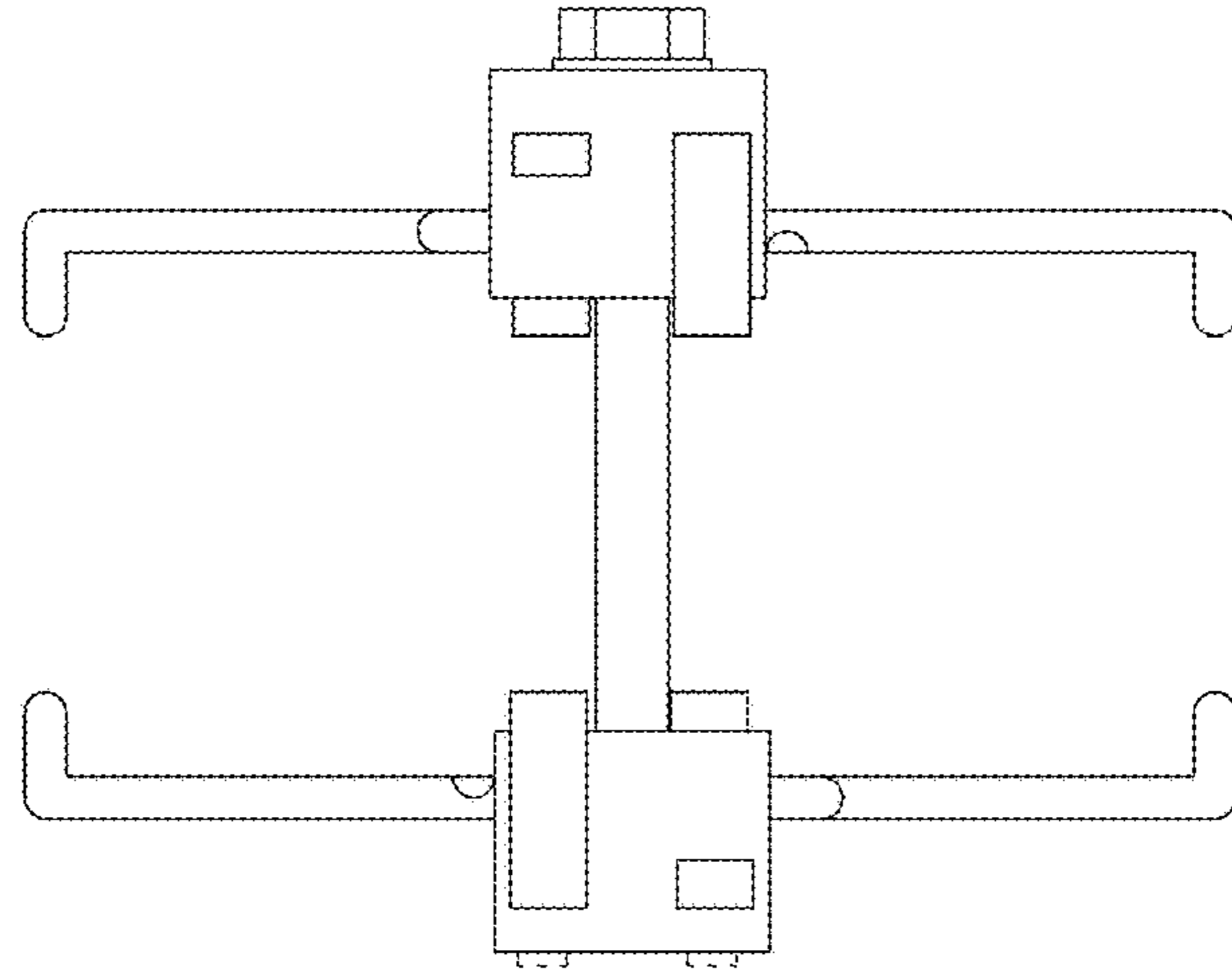

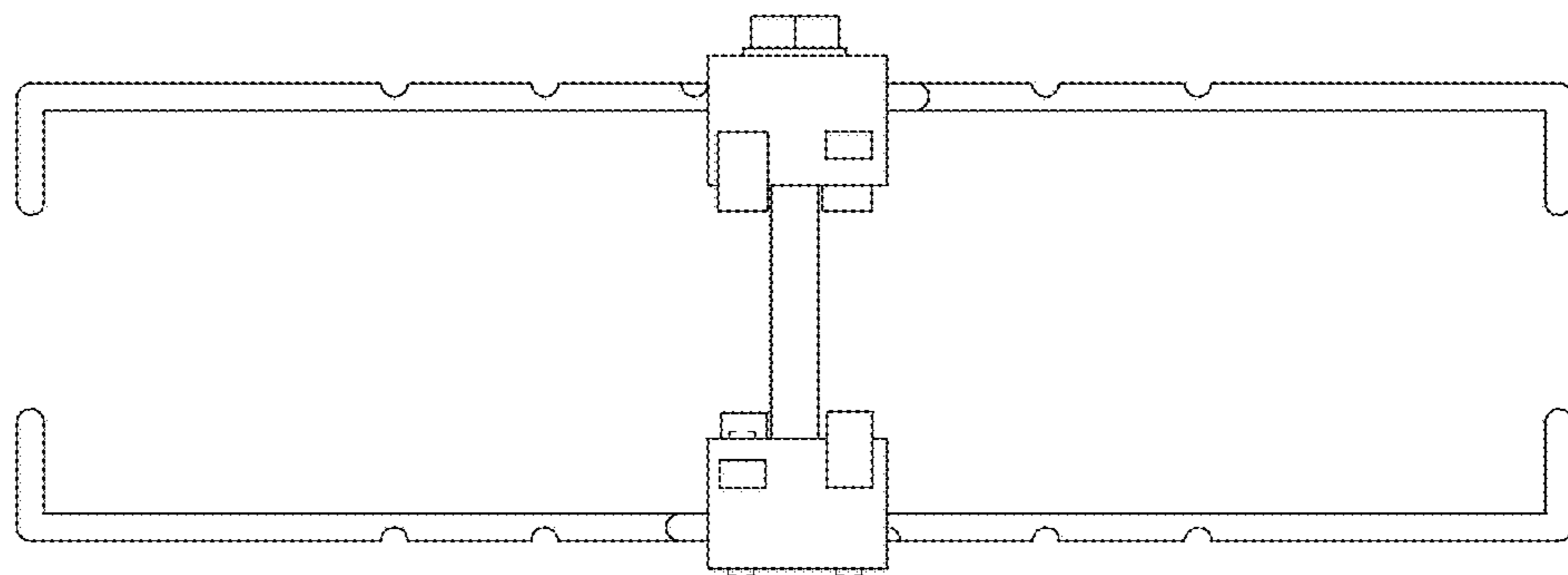

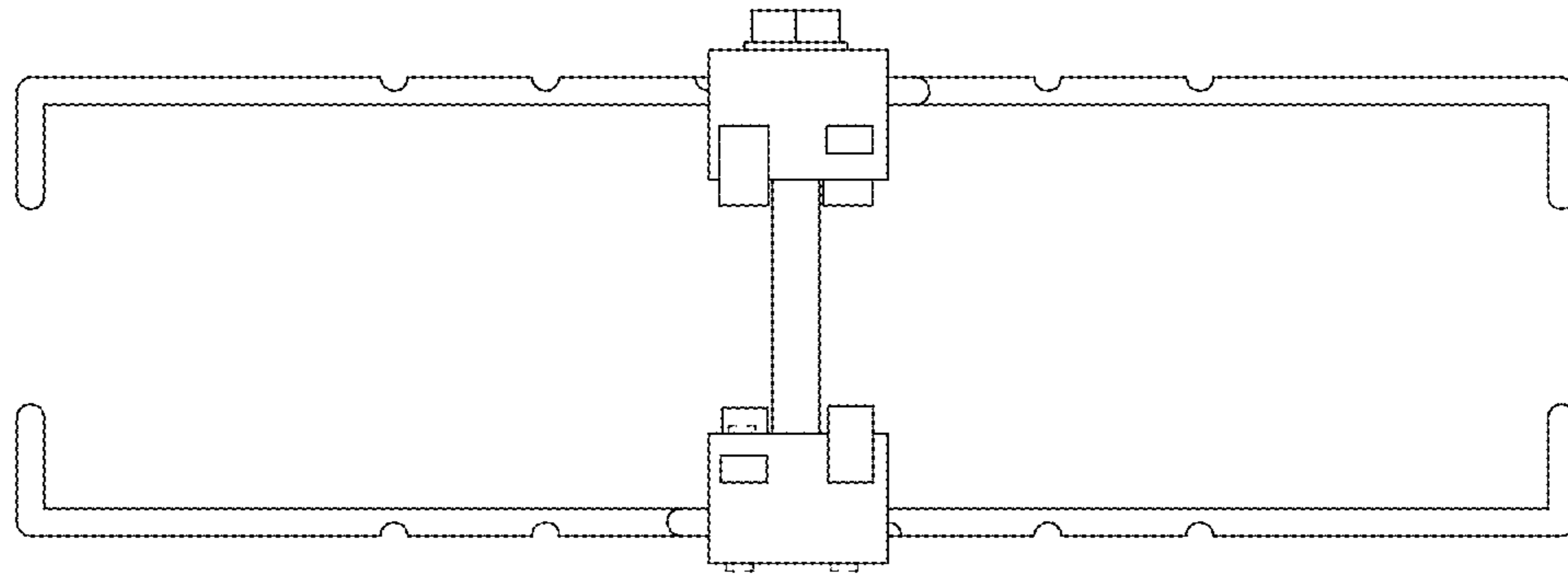

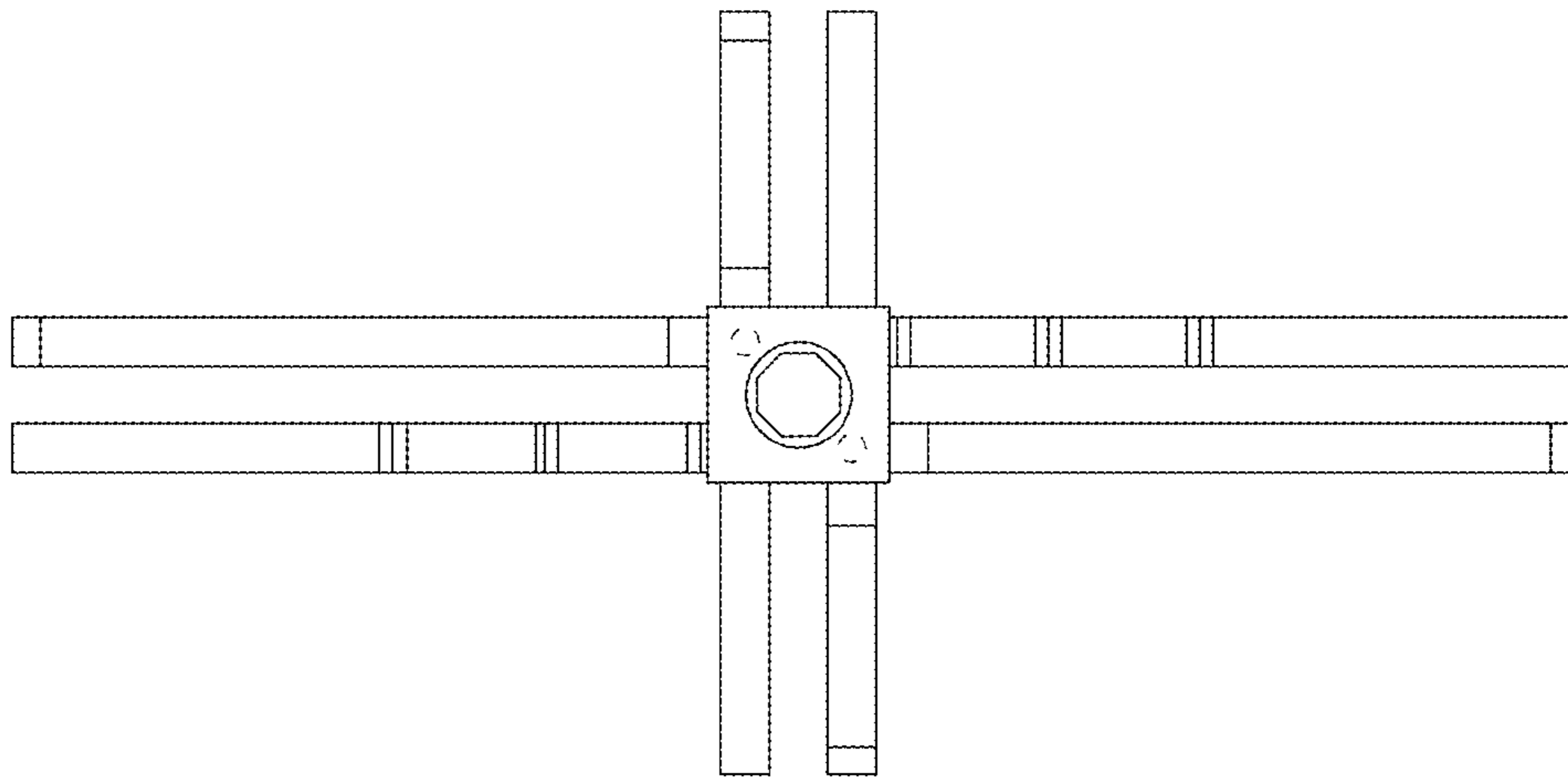
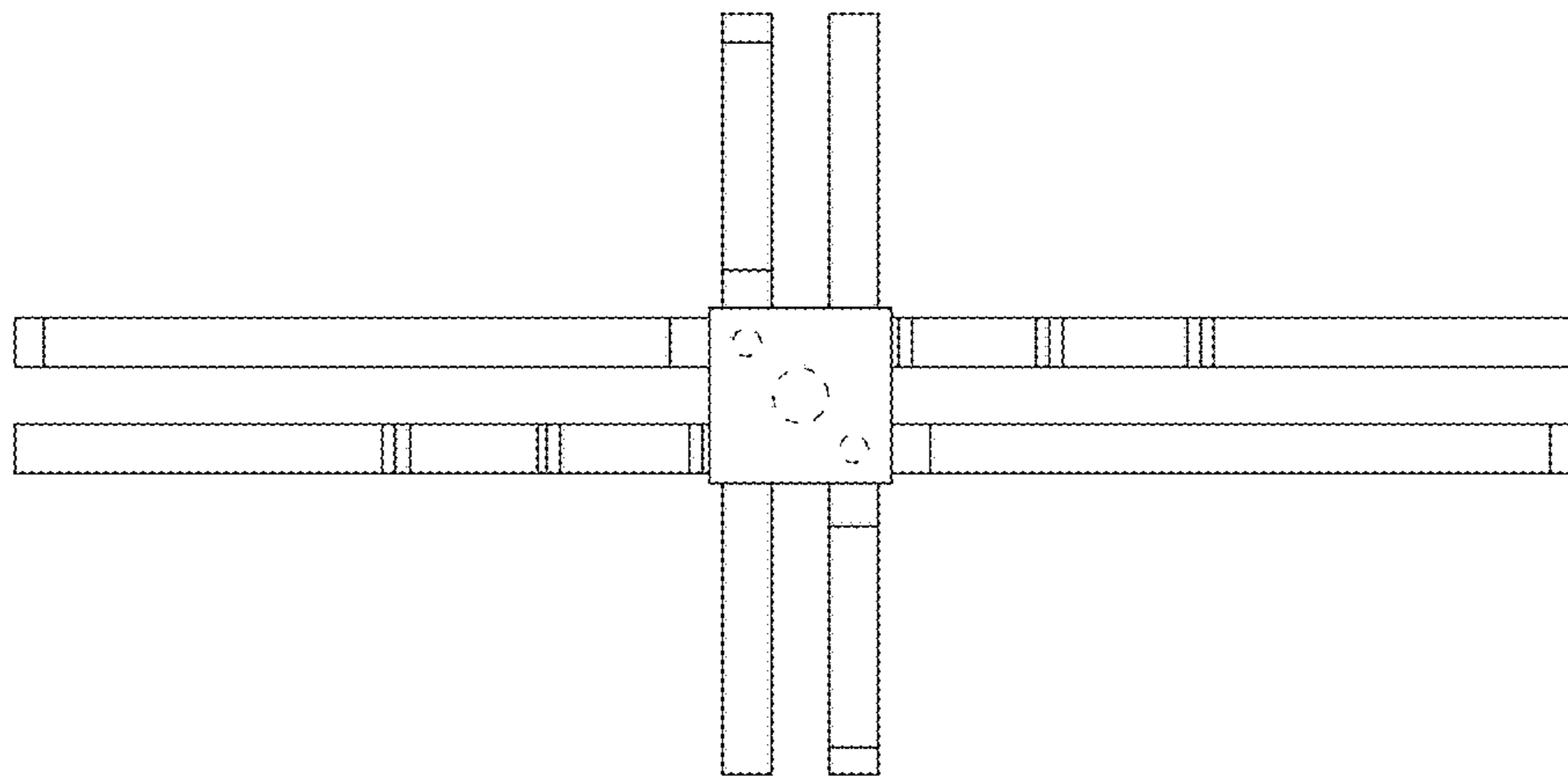

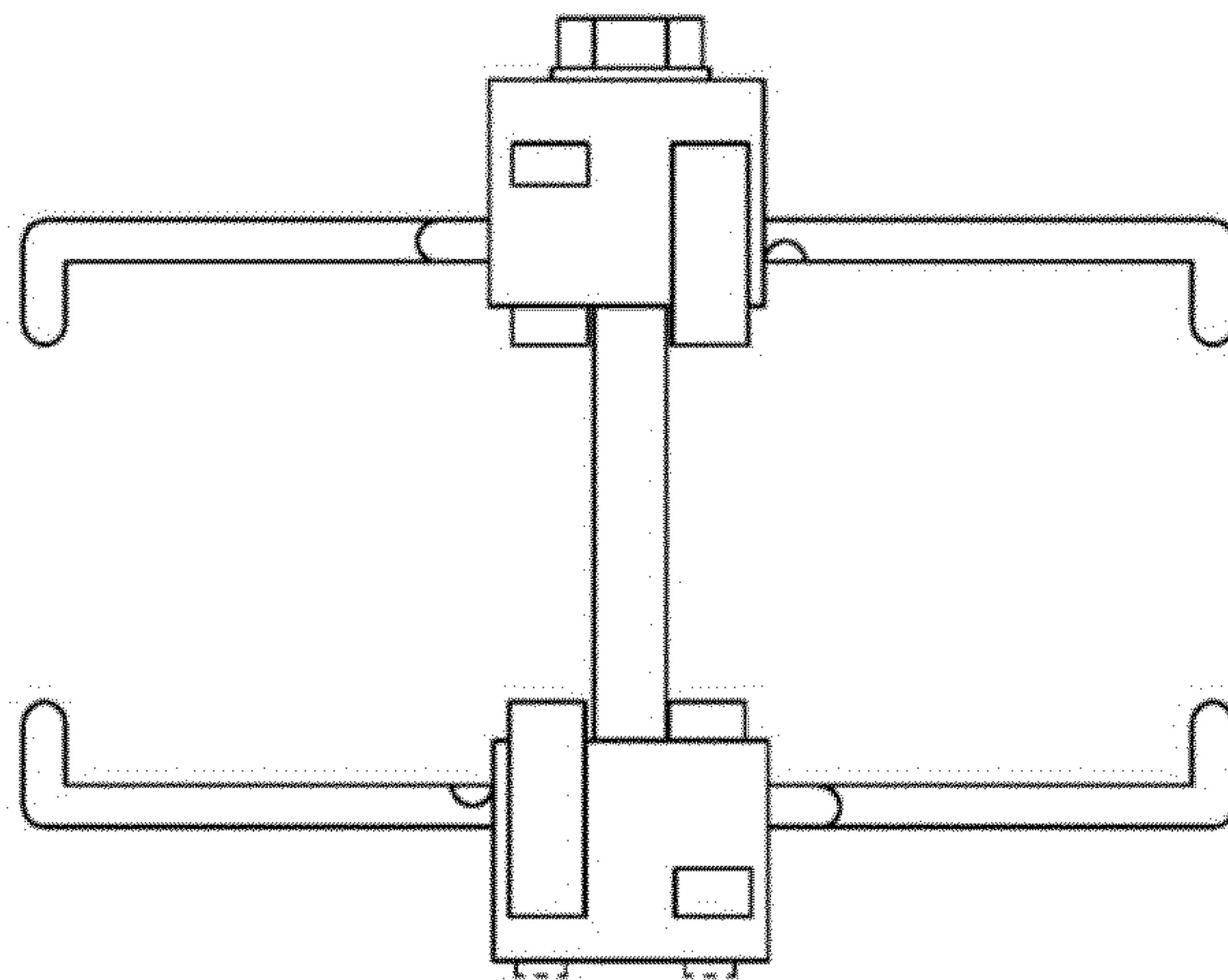

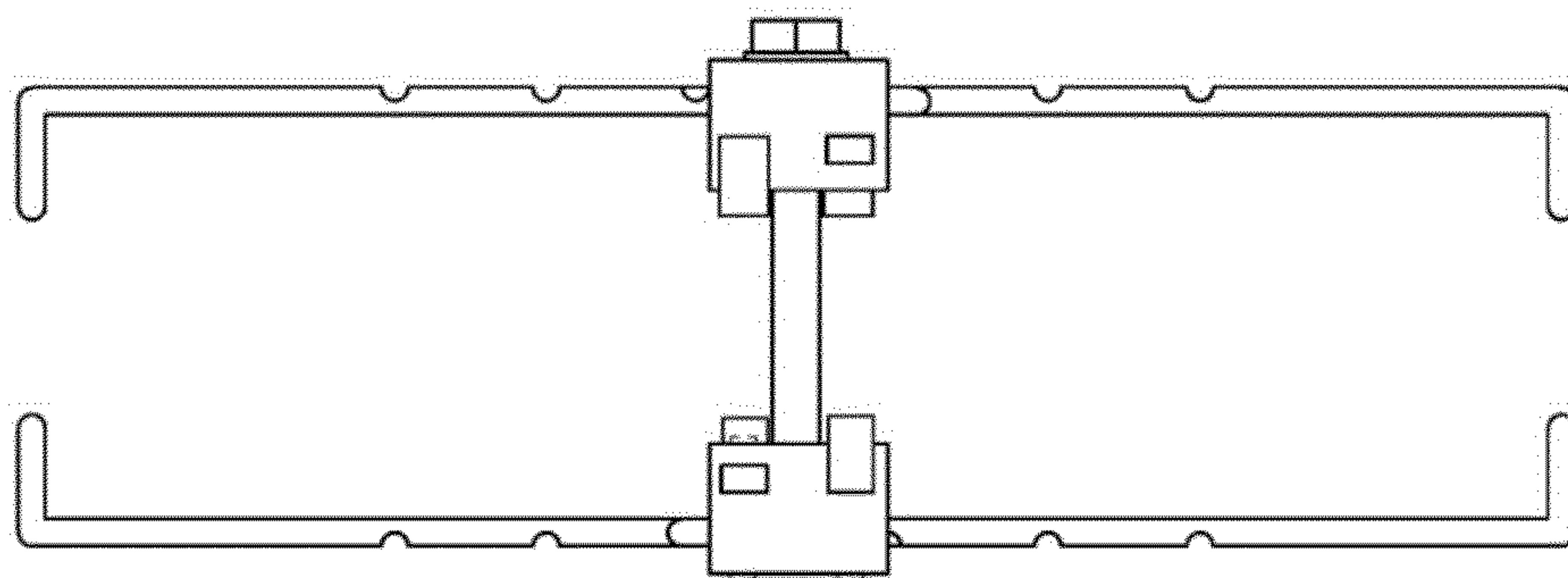

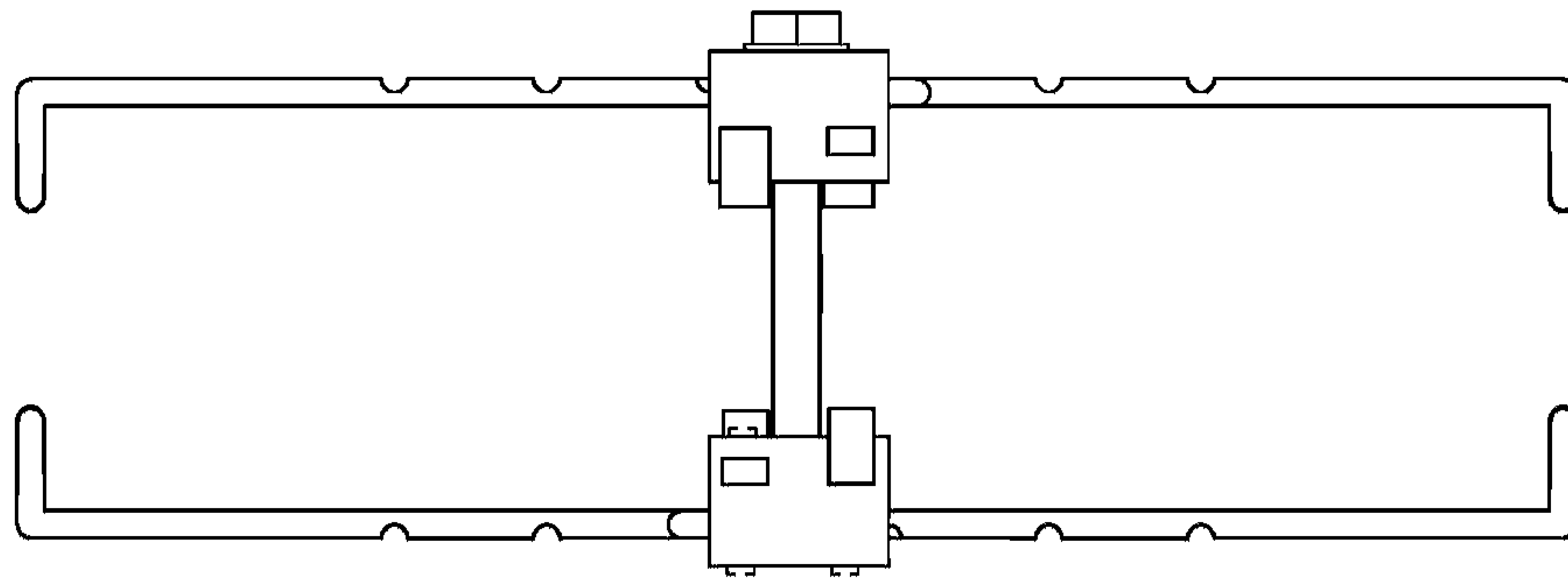
